FIG. 4 is an upper end view of FIG. 3.

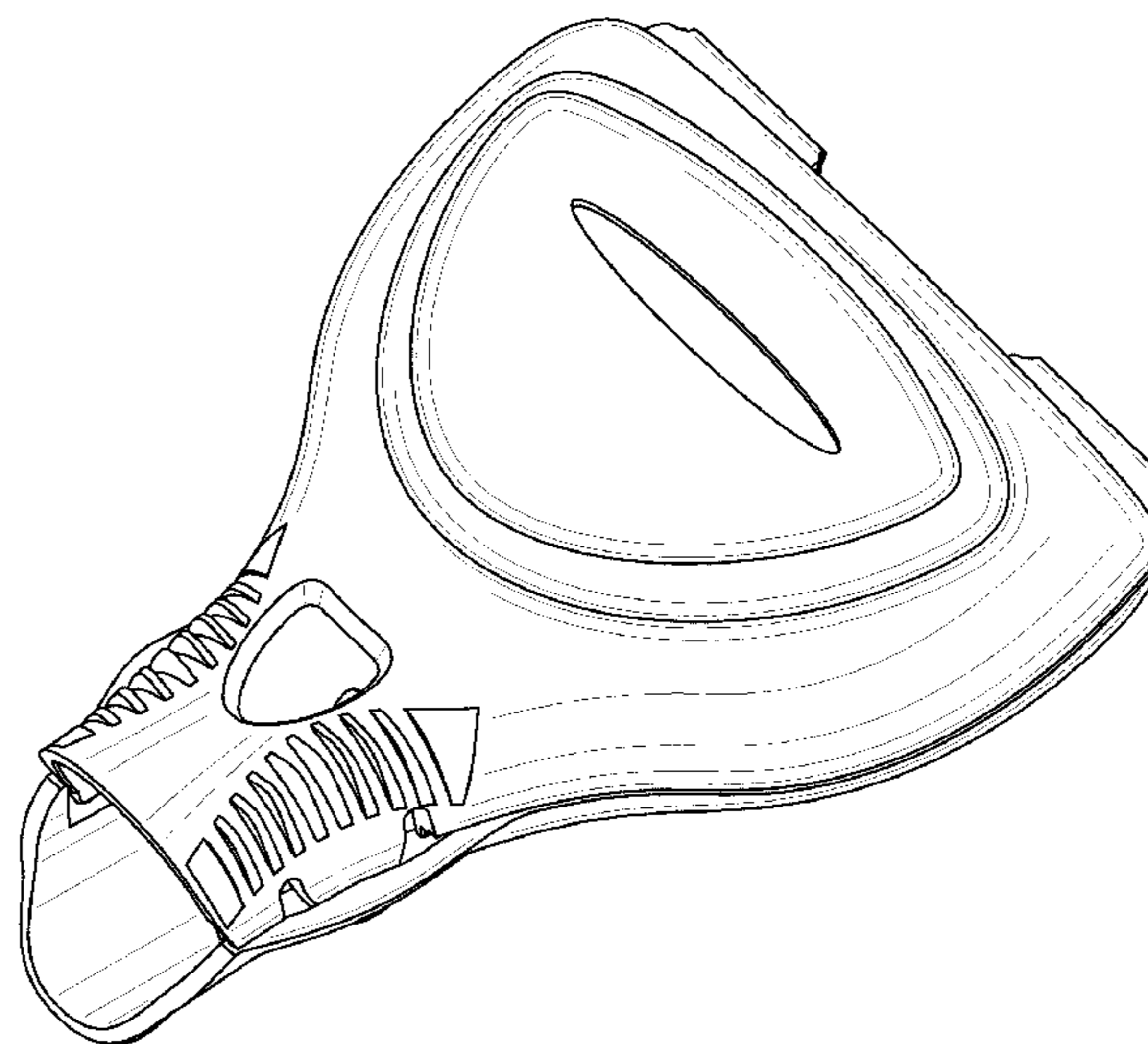
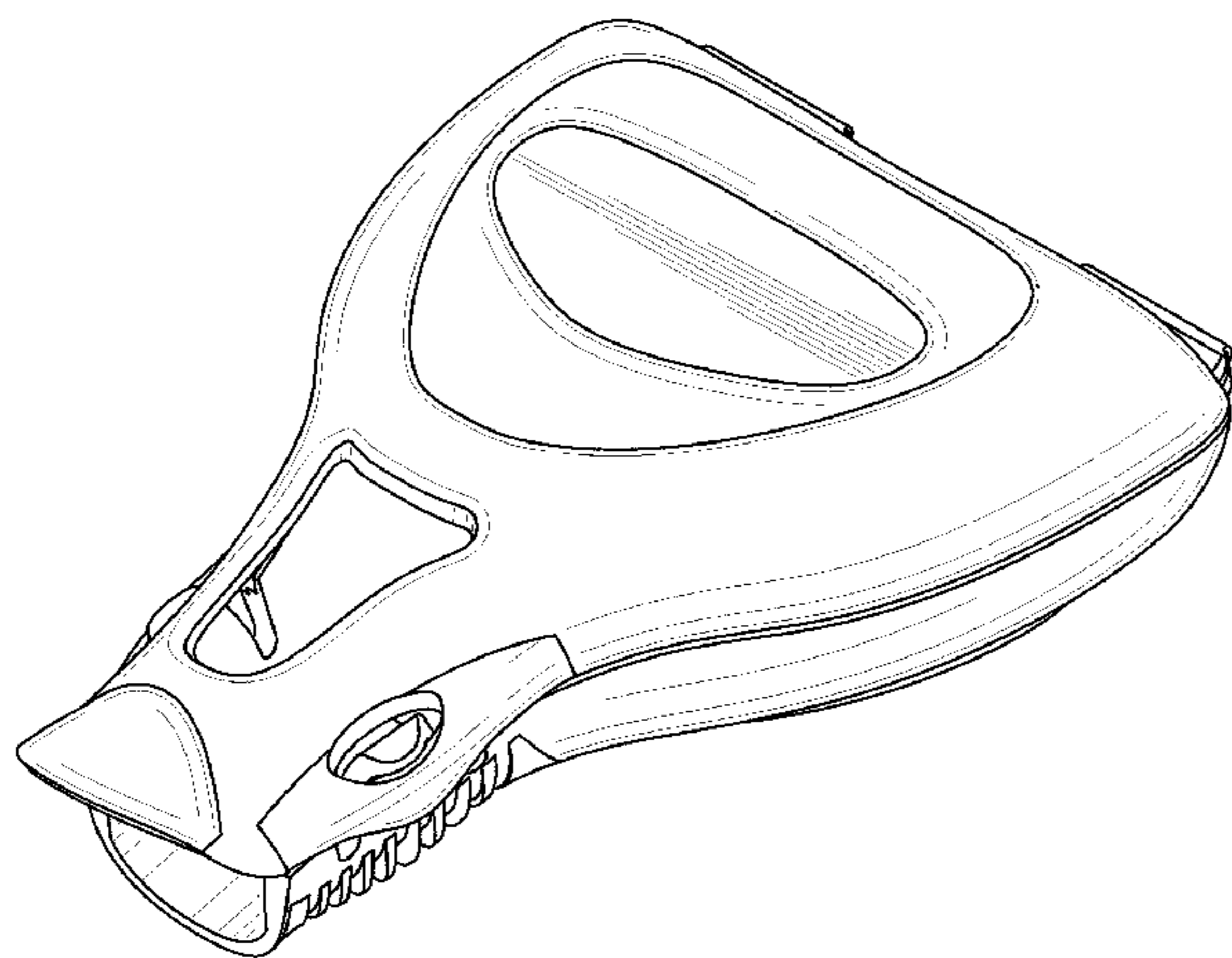
FIG. 5 is a bottom view thereof.

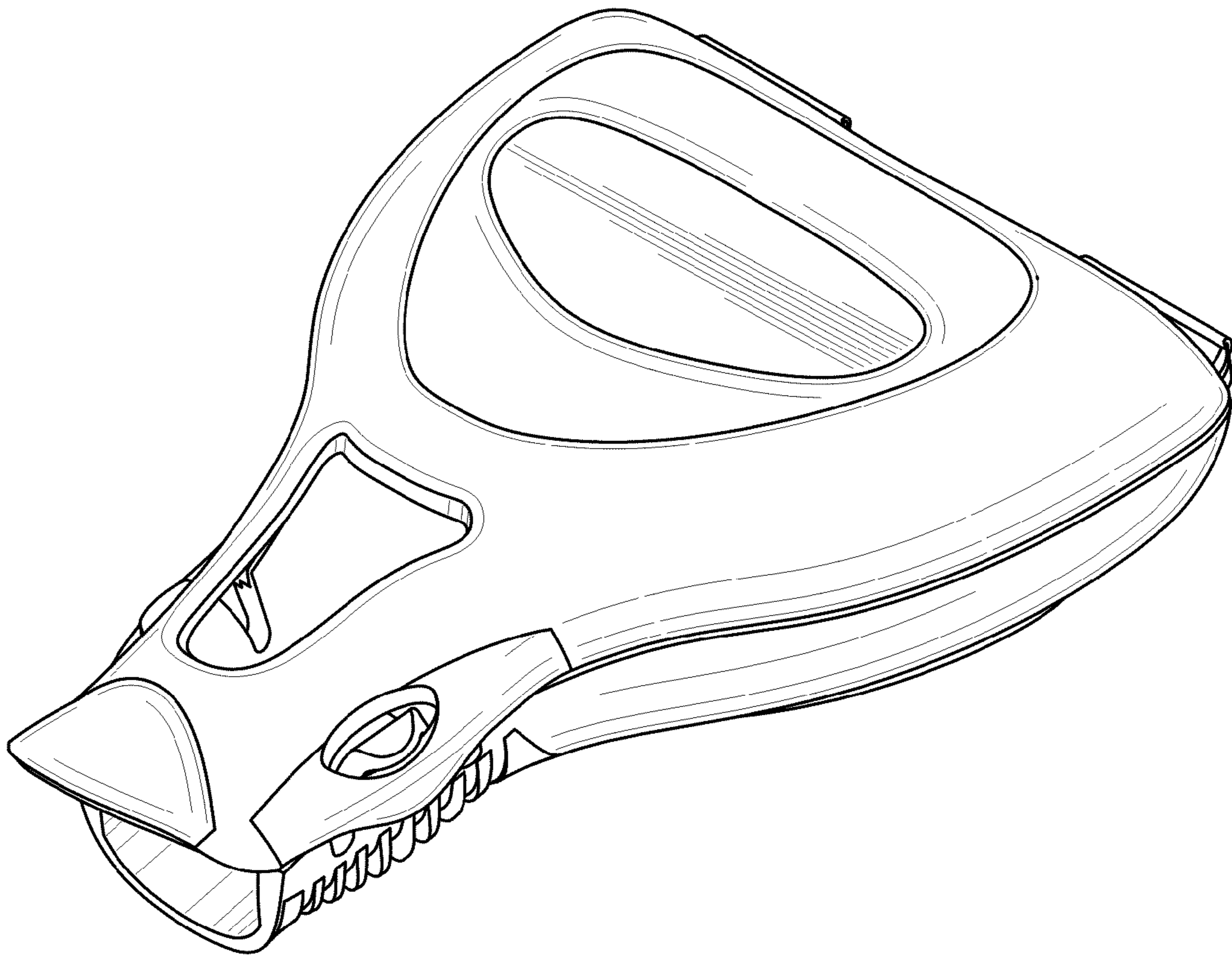

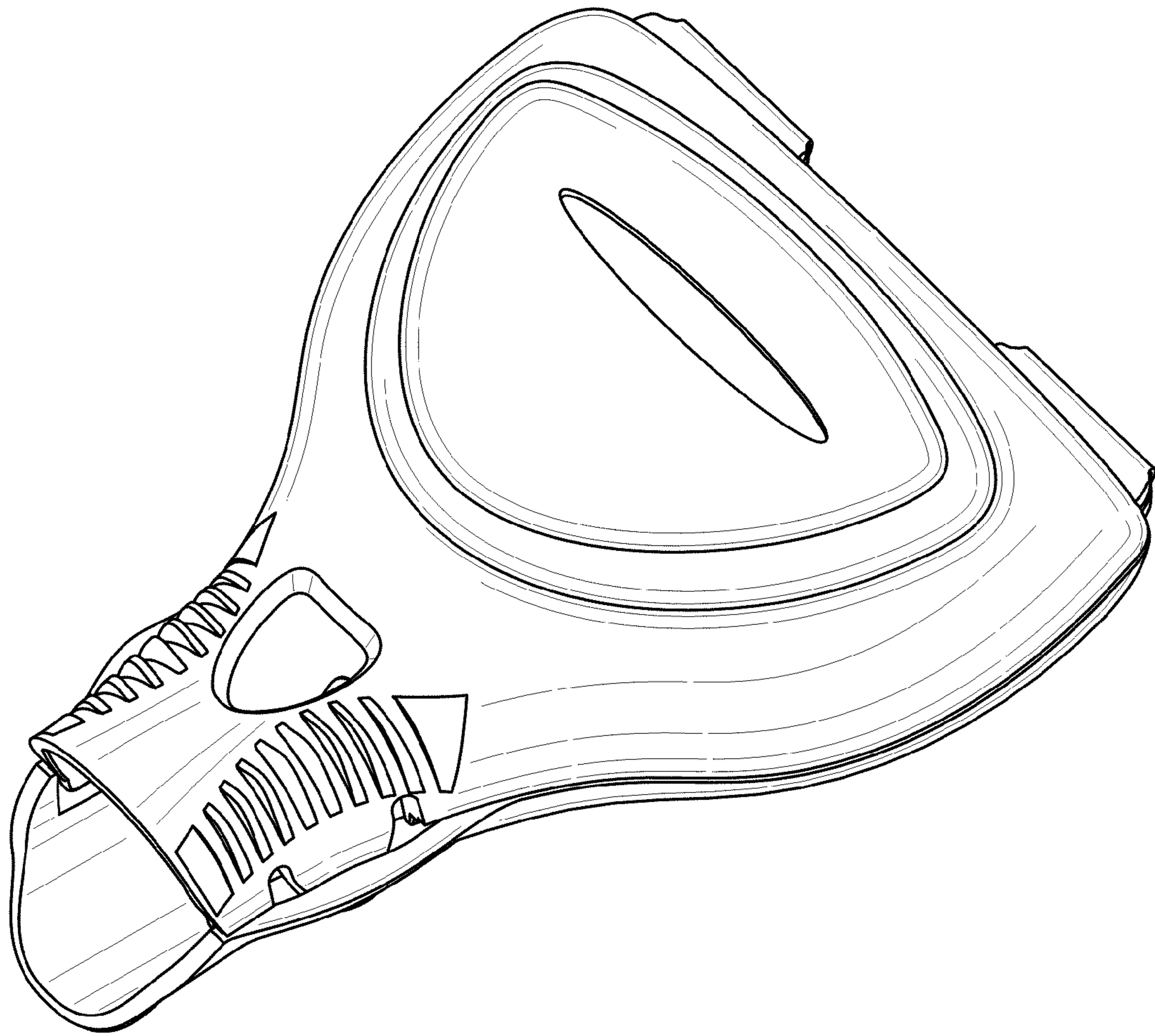

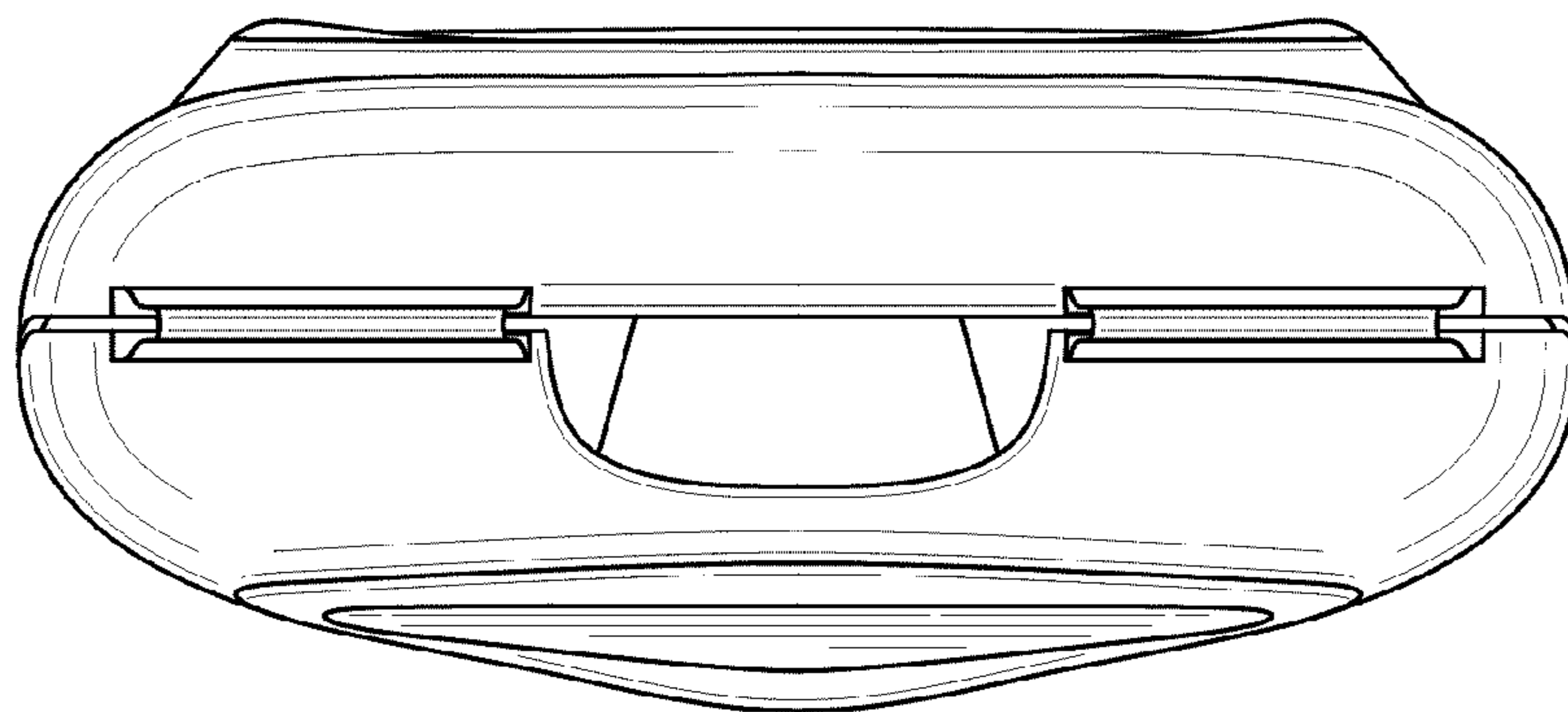

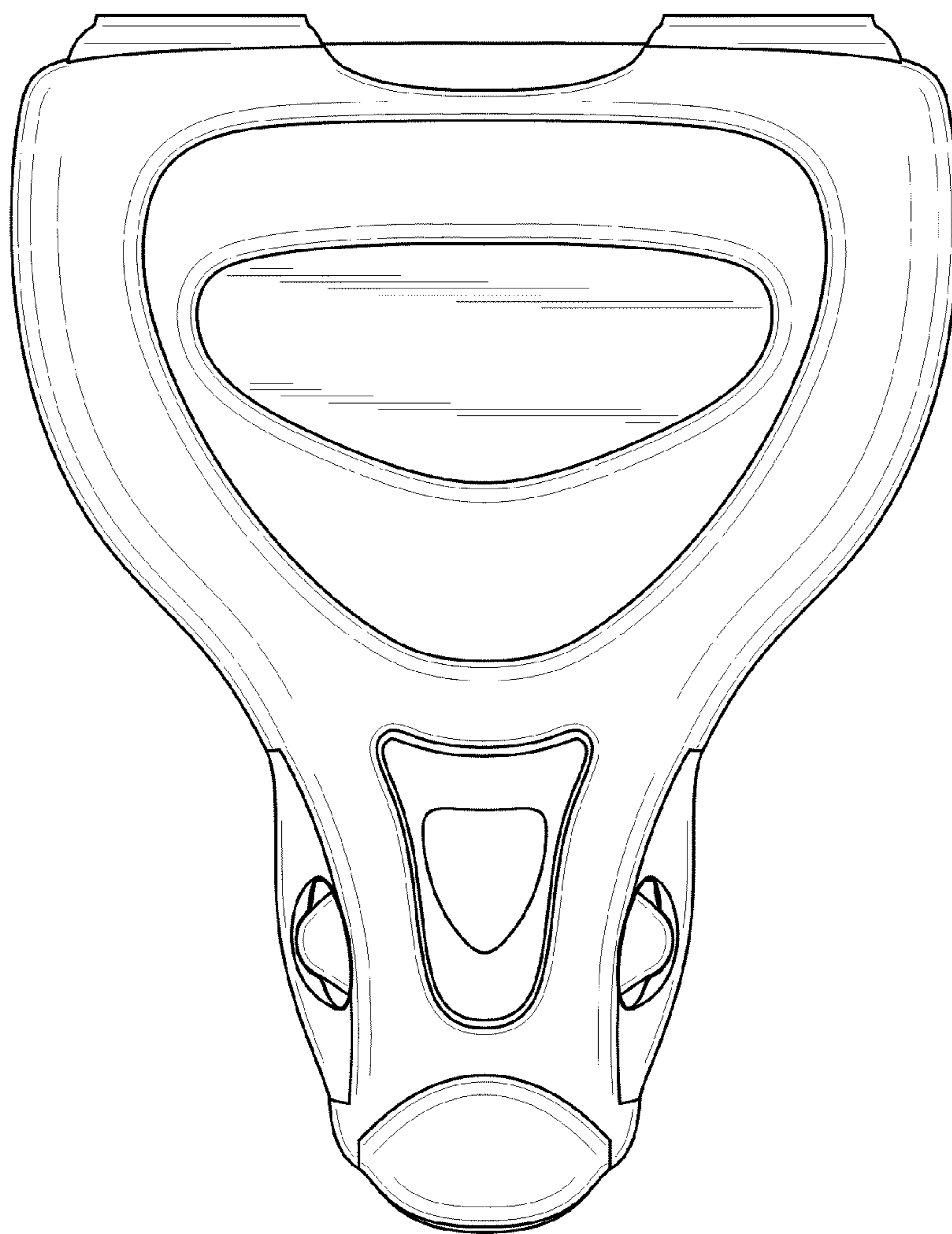

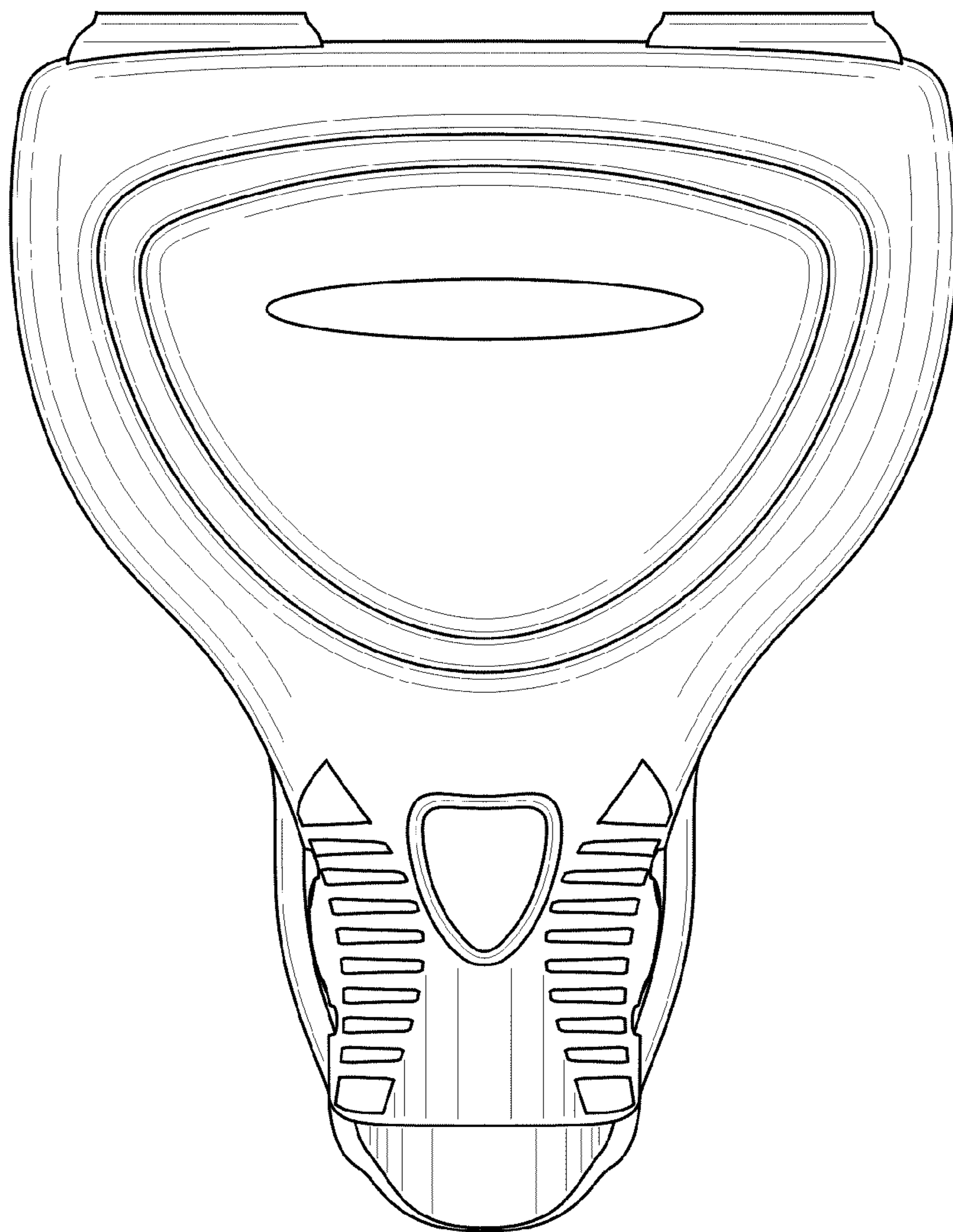

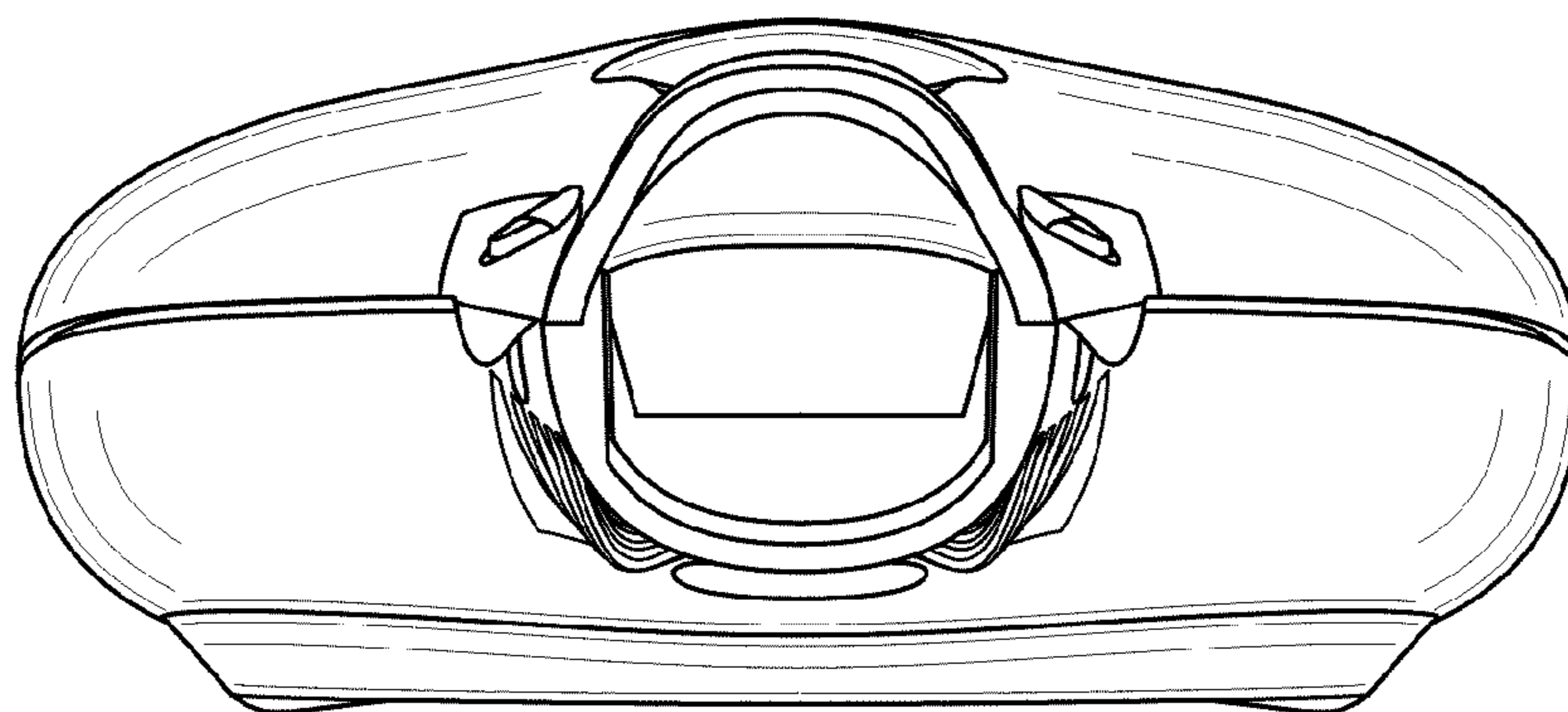

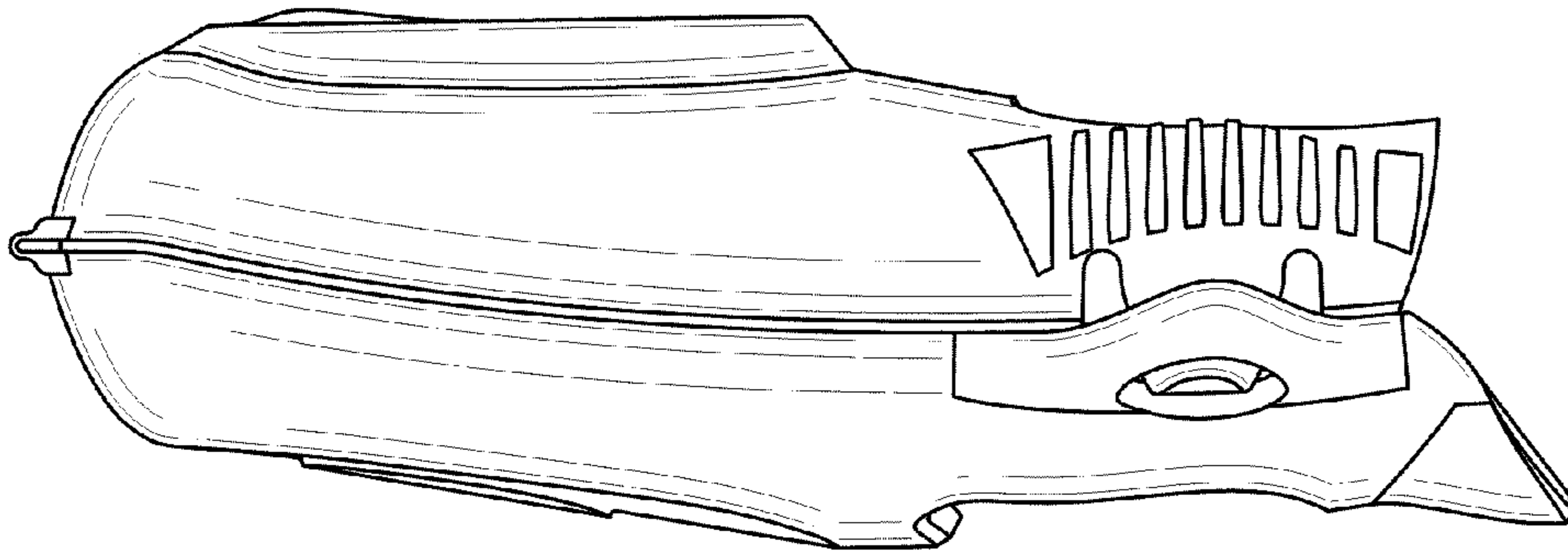

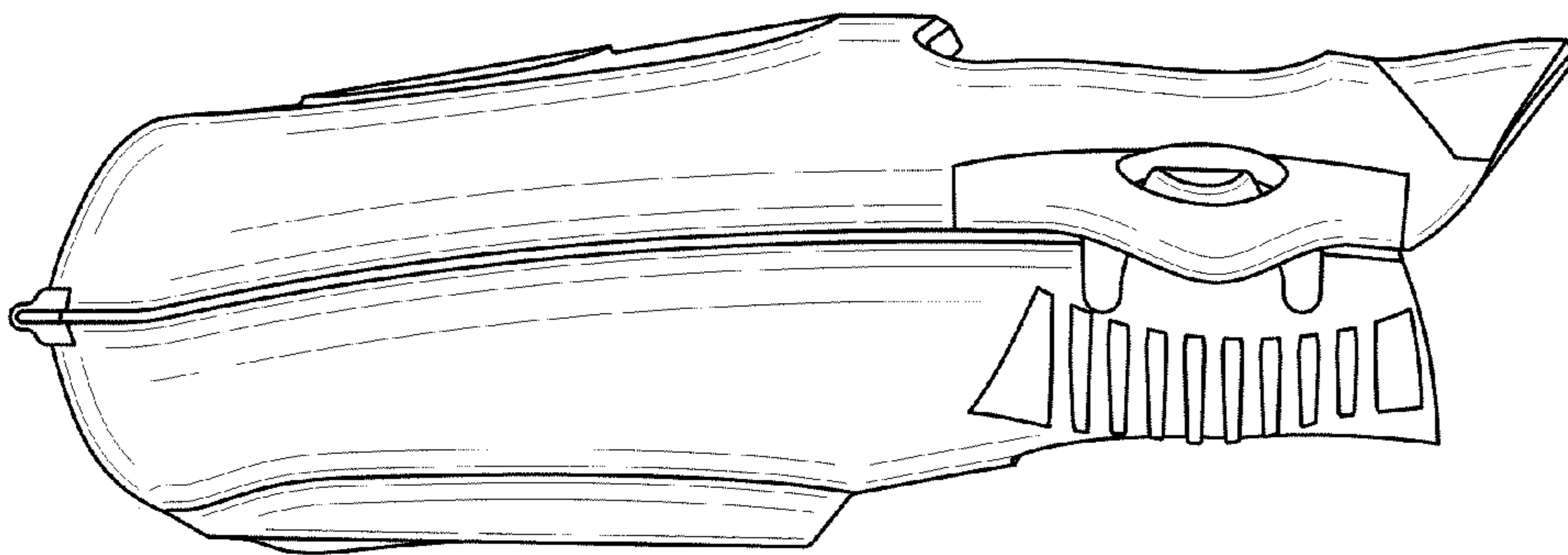
