**DESCRIPTION**

FIG. 10 is a front view of the left section.

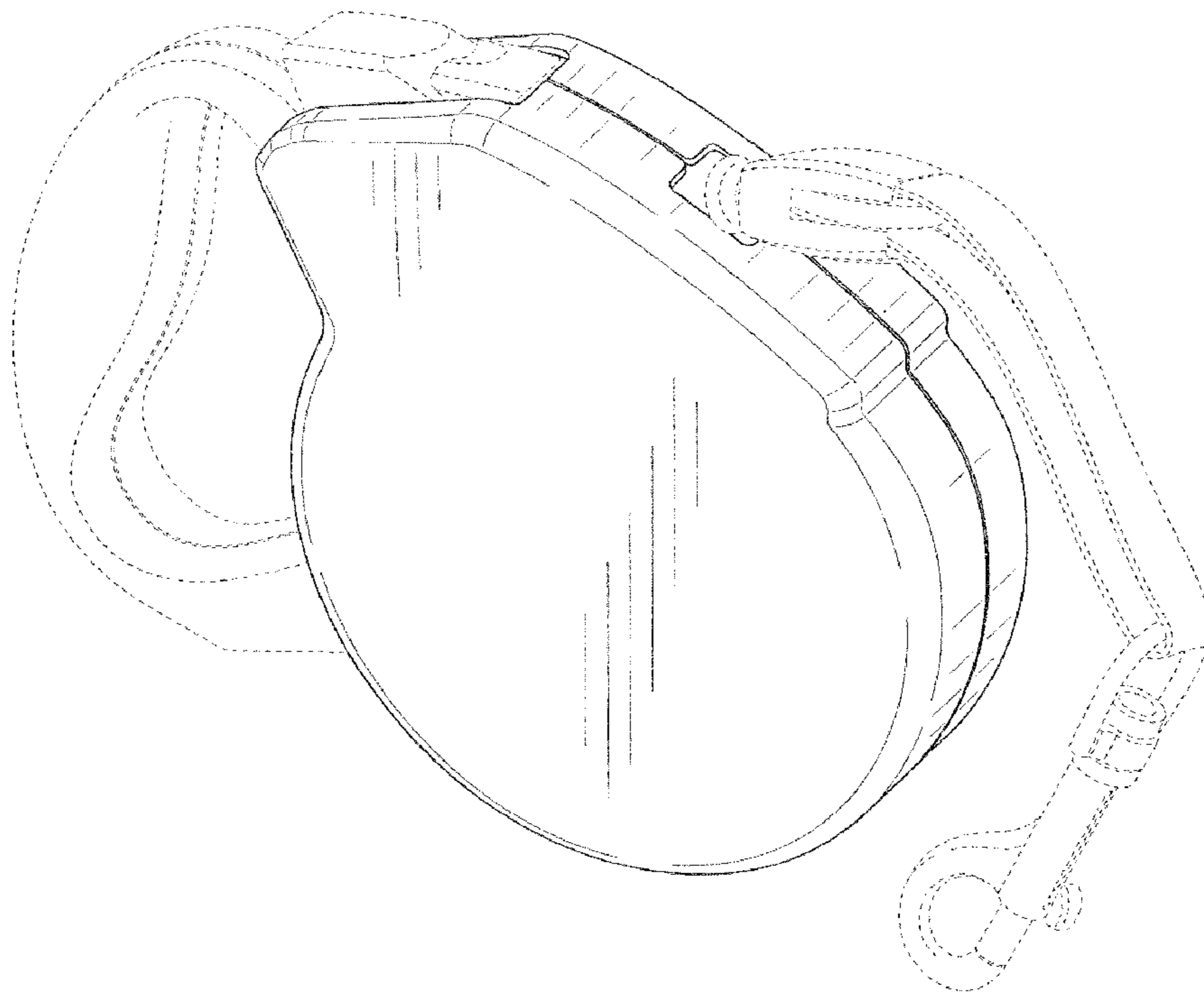
FIG. 11 is a rear view of the left section.

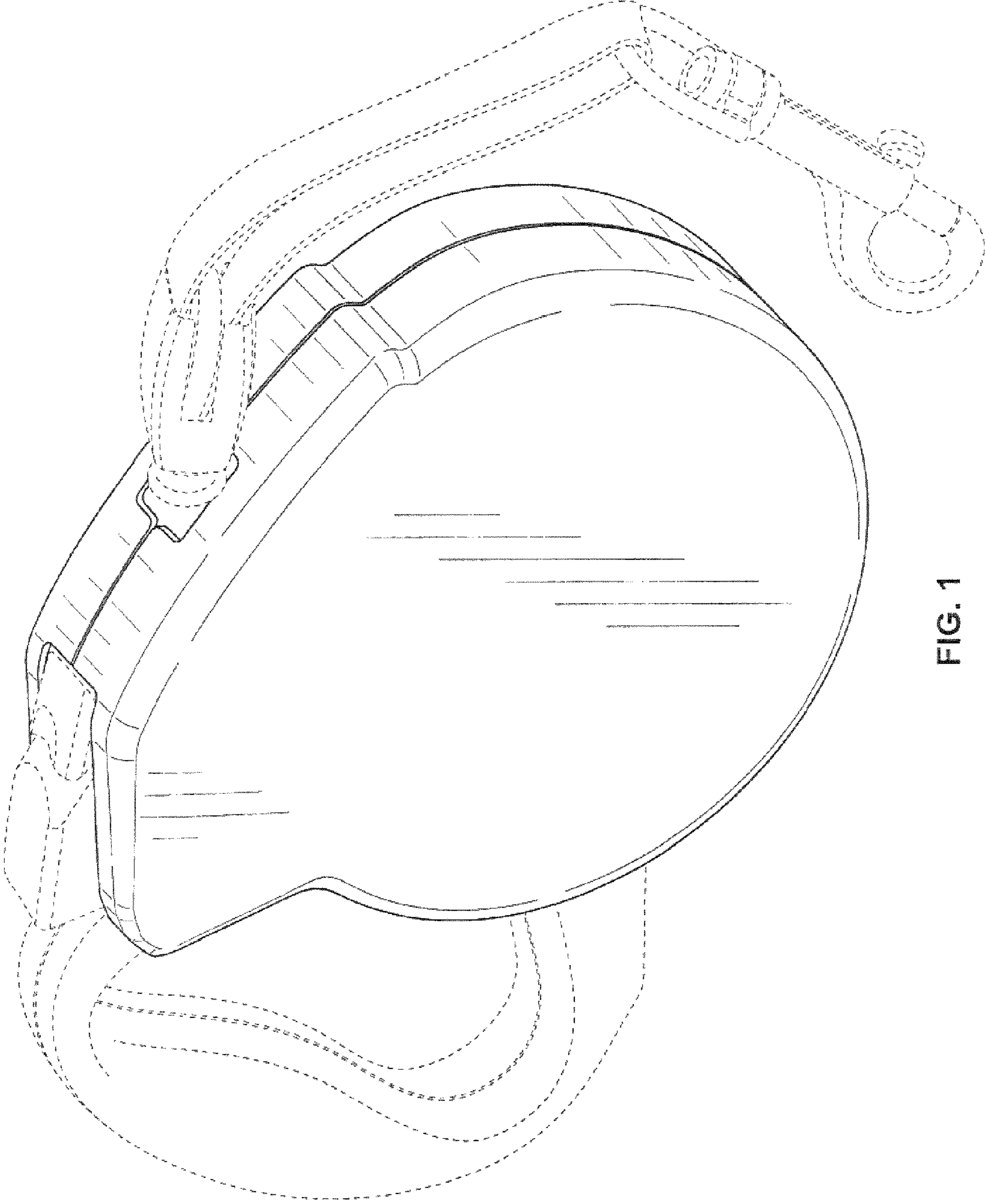

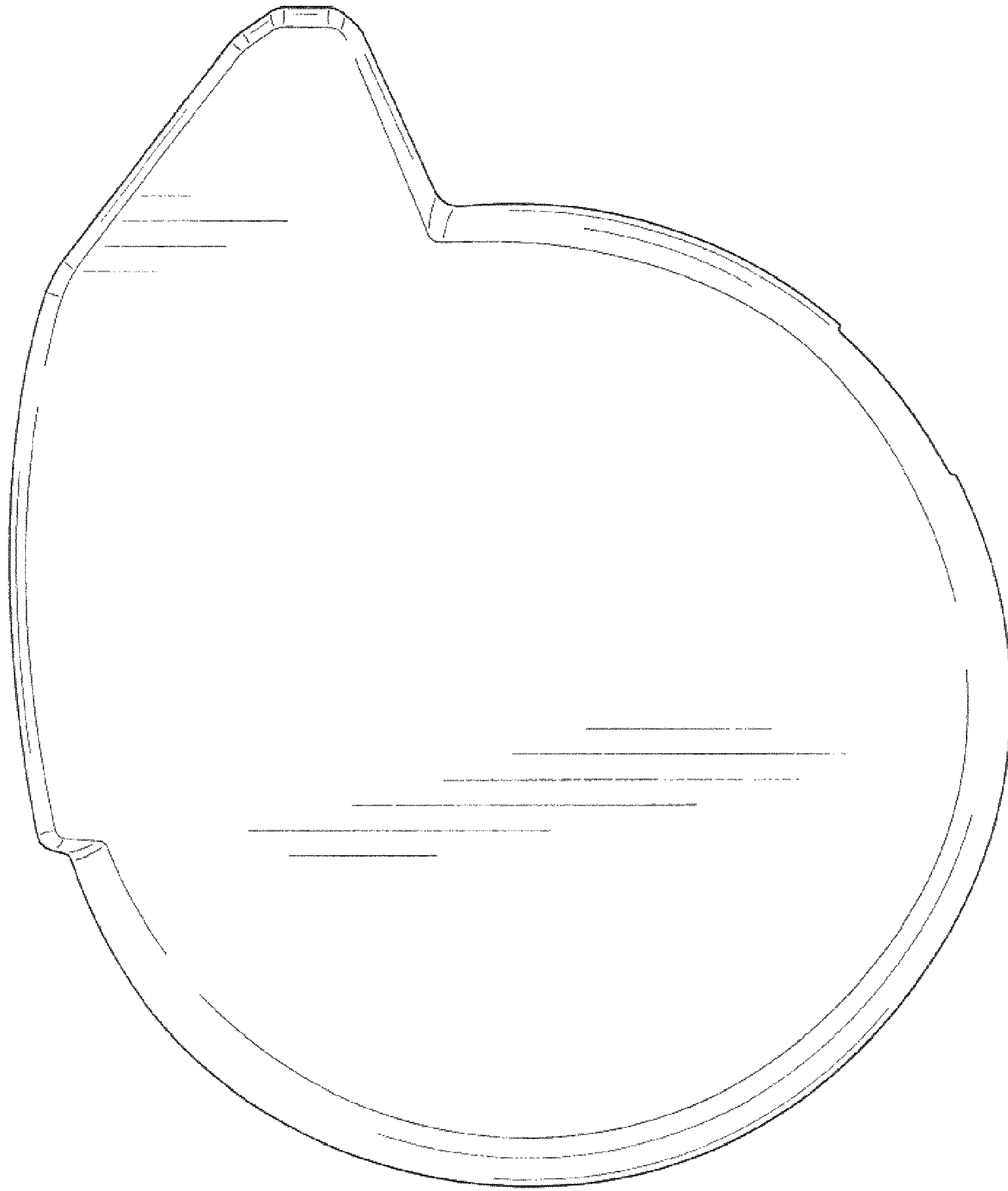

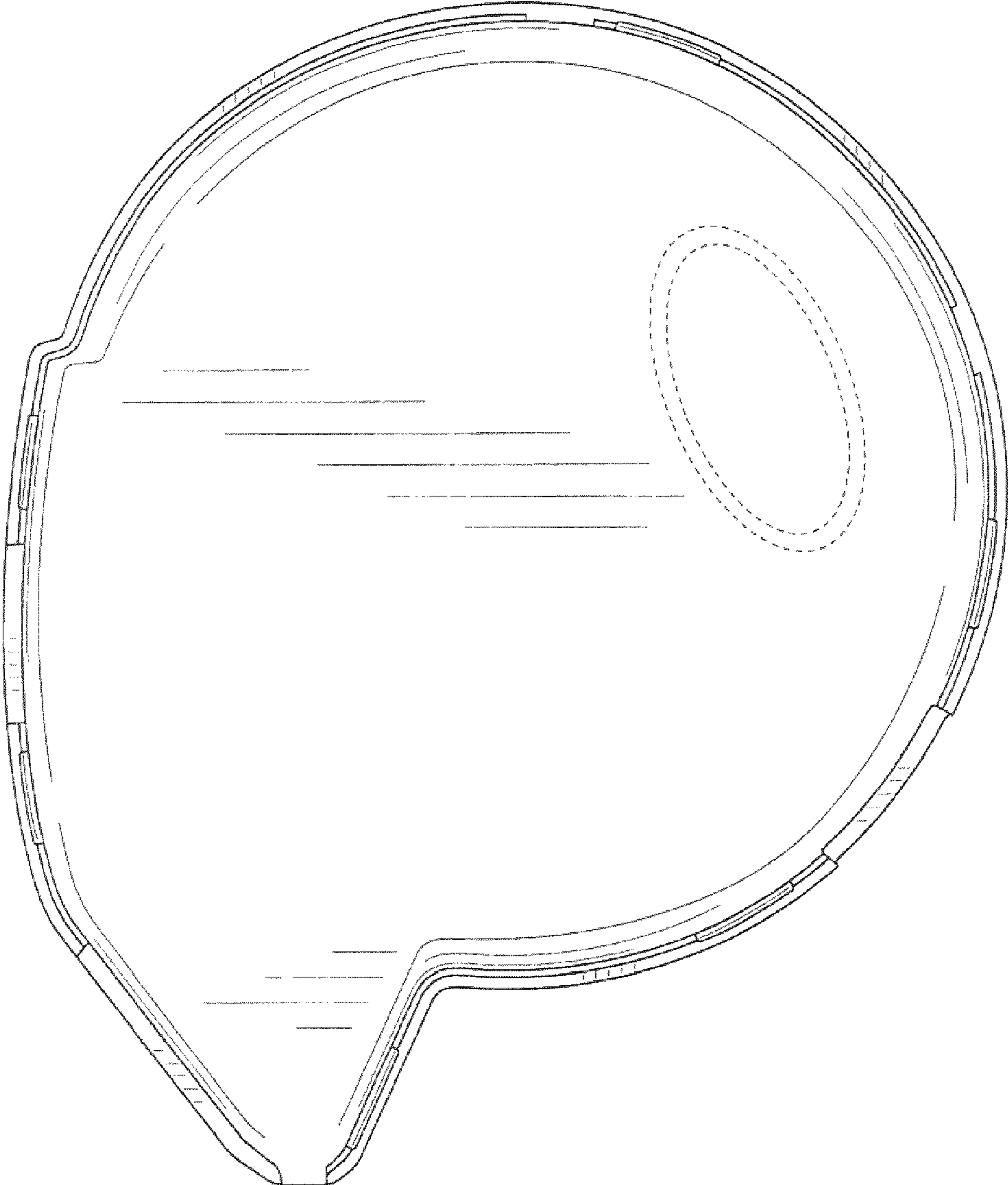

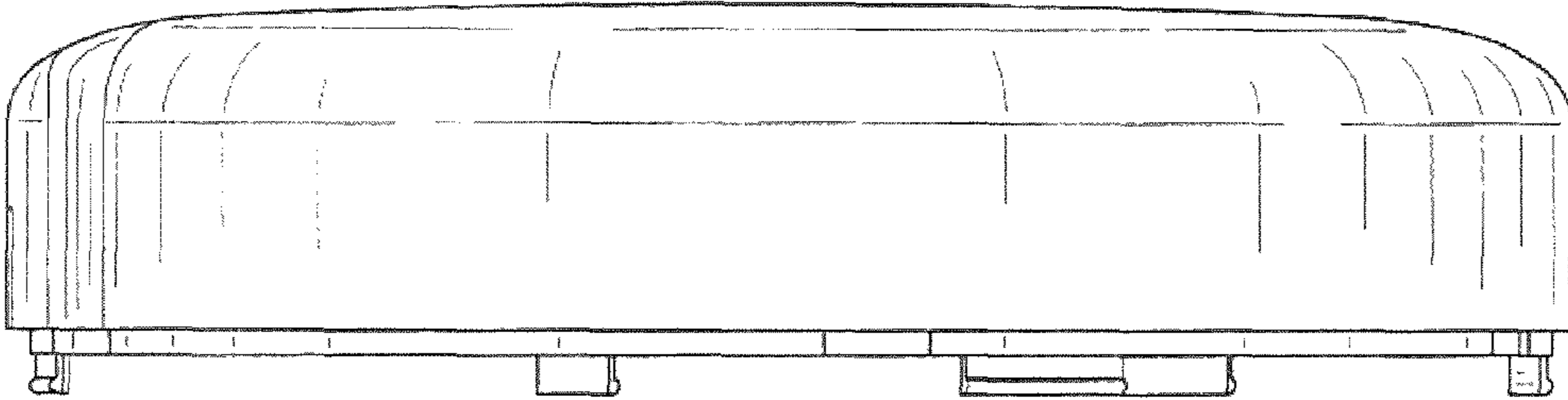

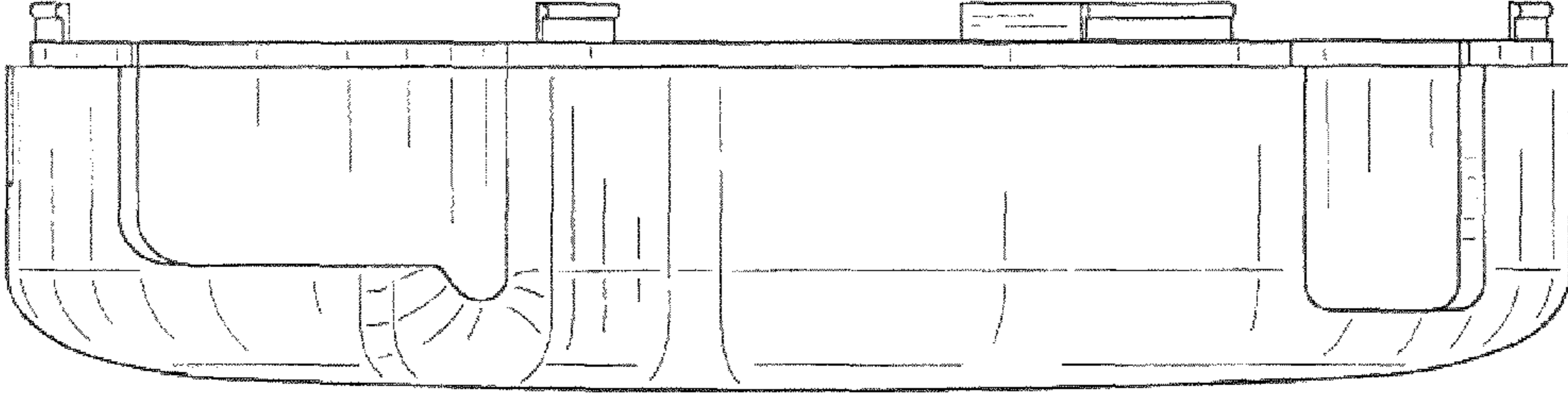

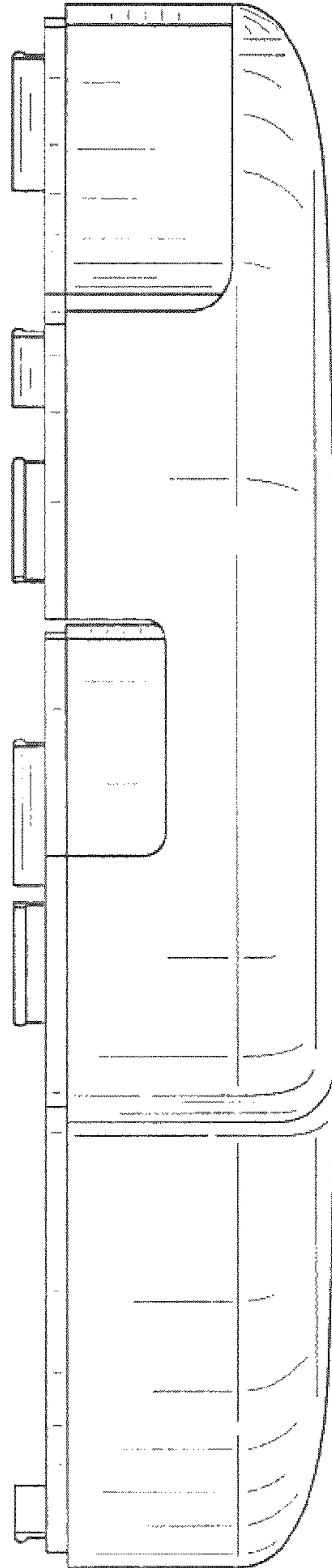

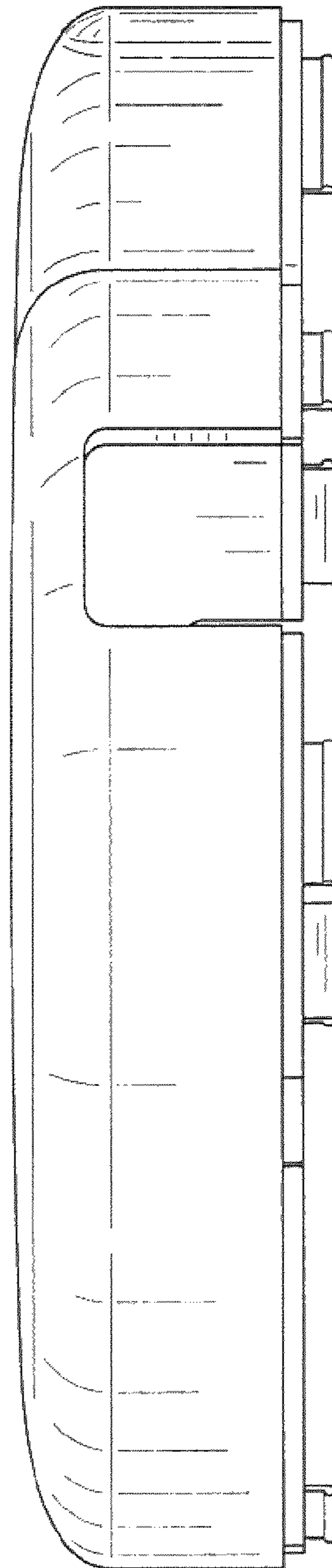

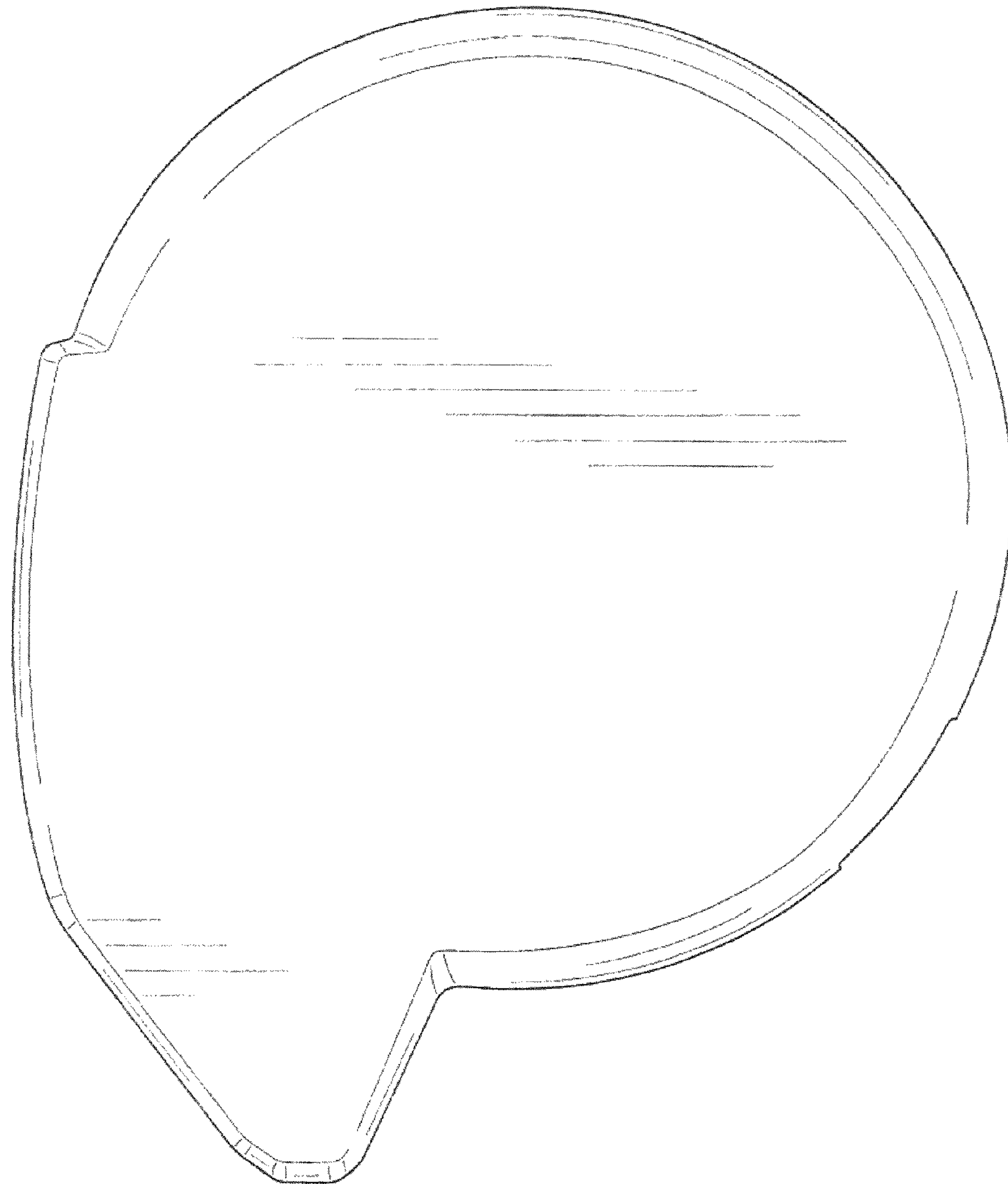

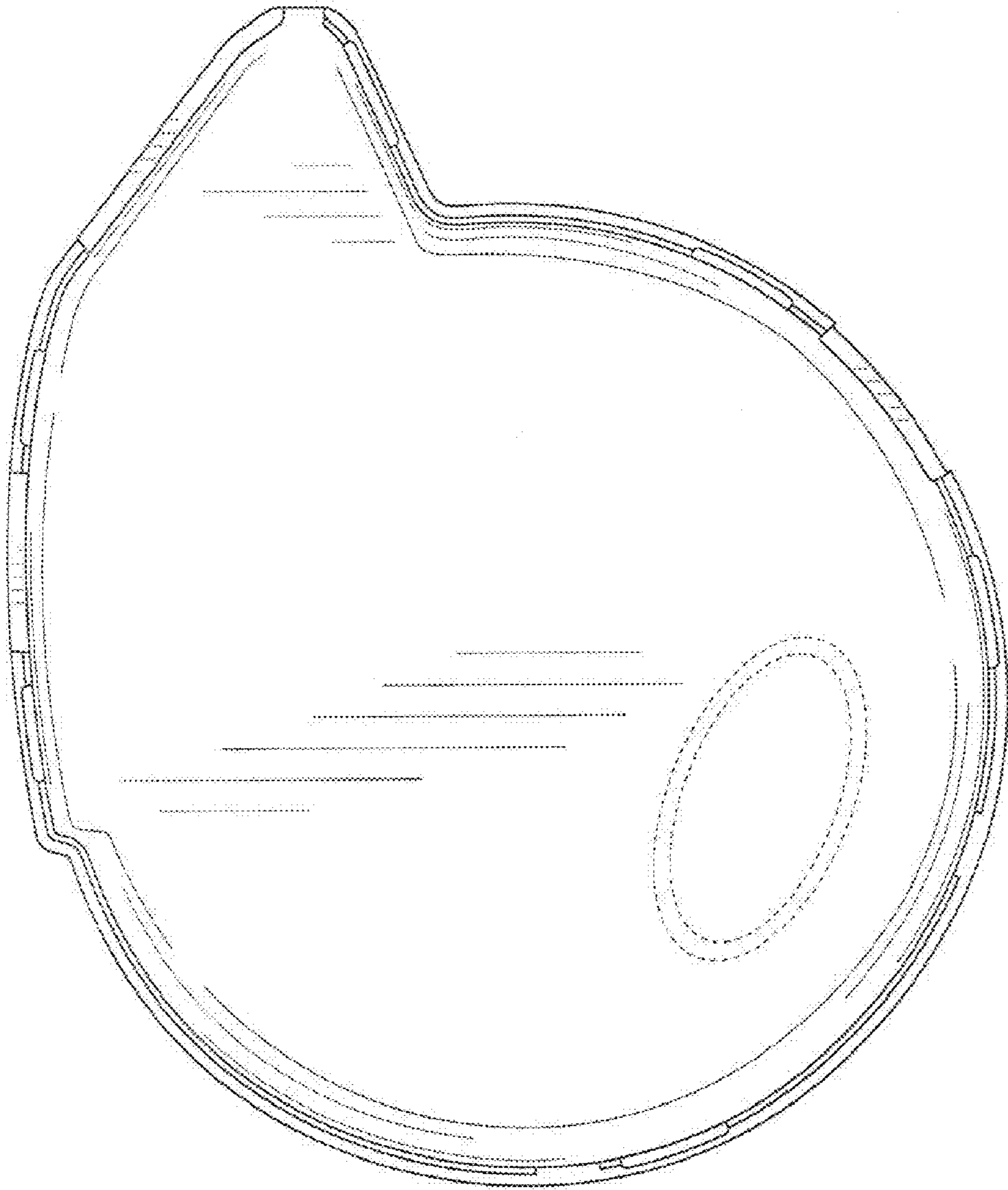

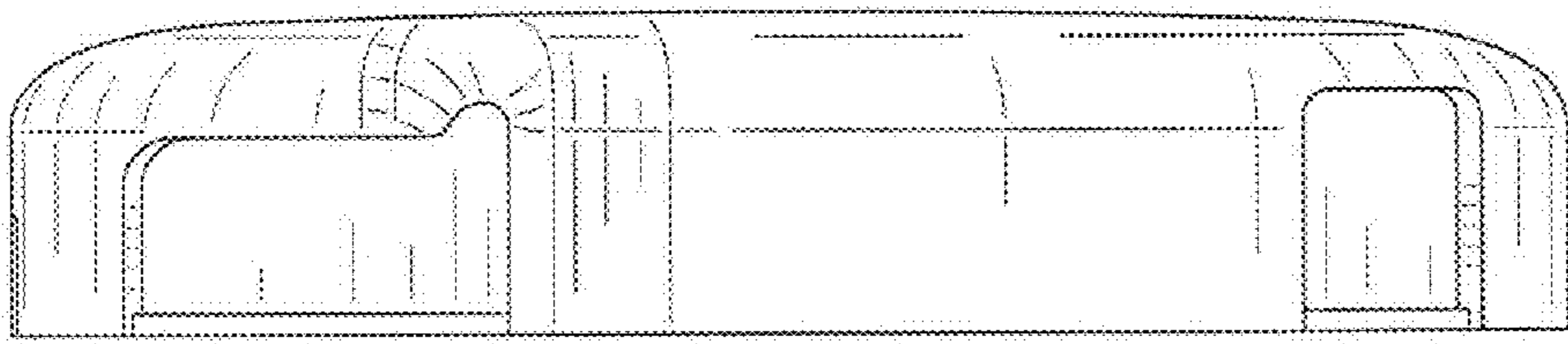

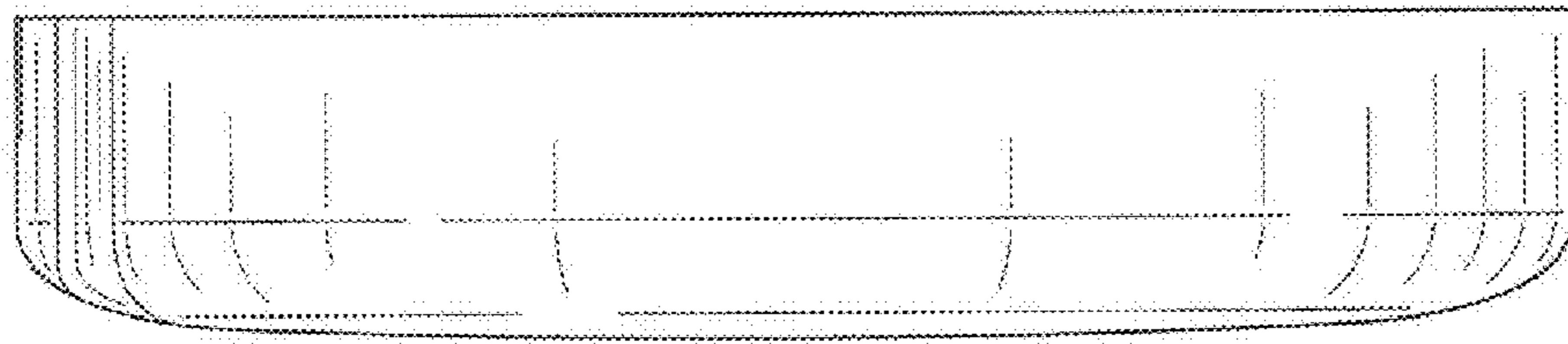

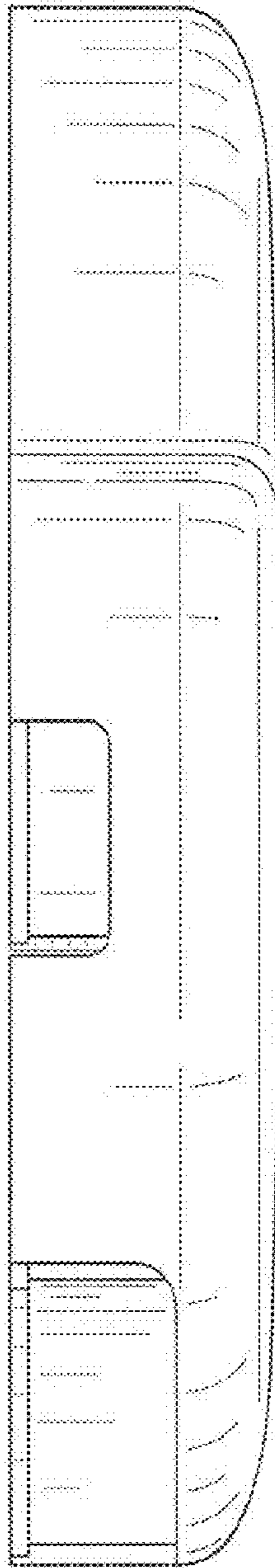

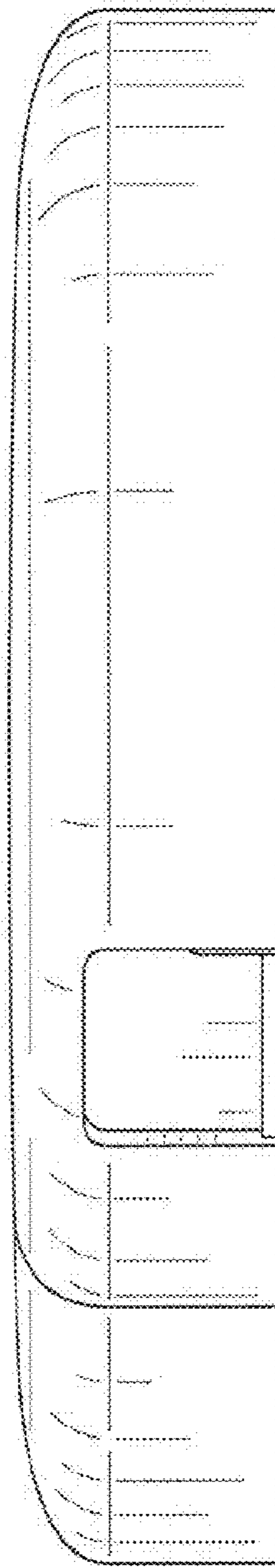
