FIG. 1 is a perspective view of a shoe showing our new design;

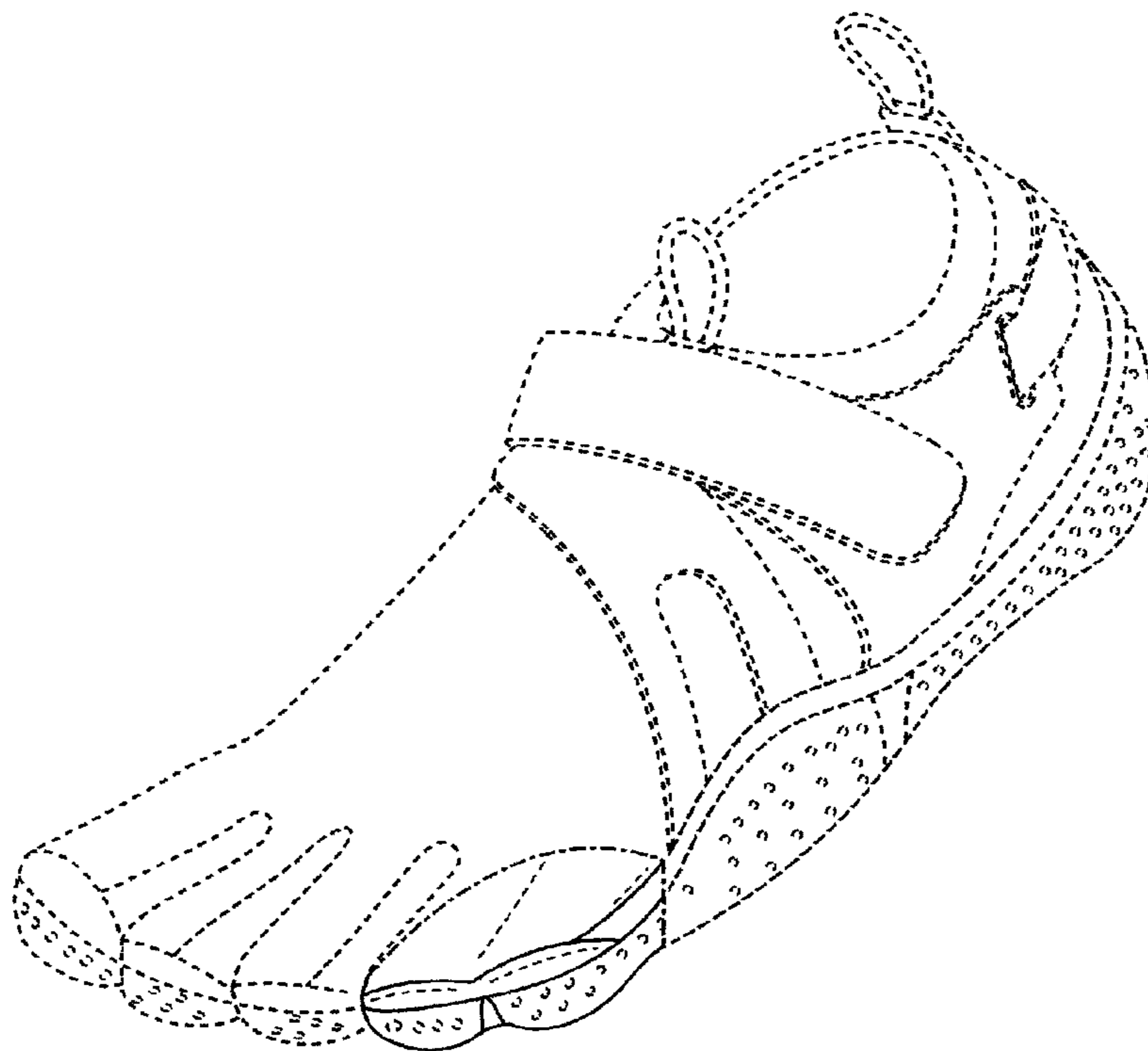
FIG. 2 is a top plan view of the design shown in FIG. 1;

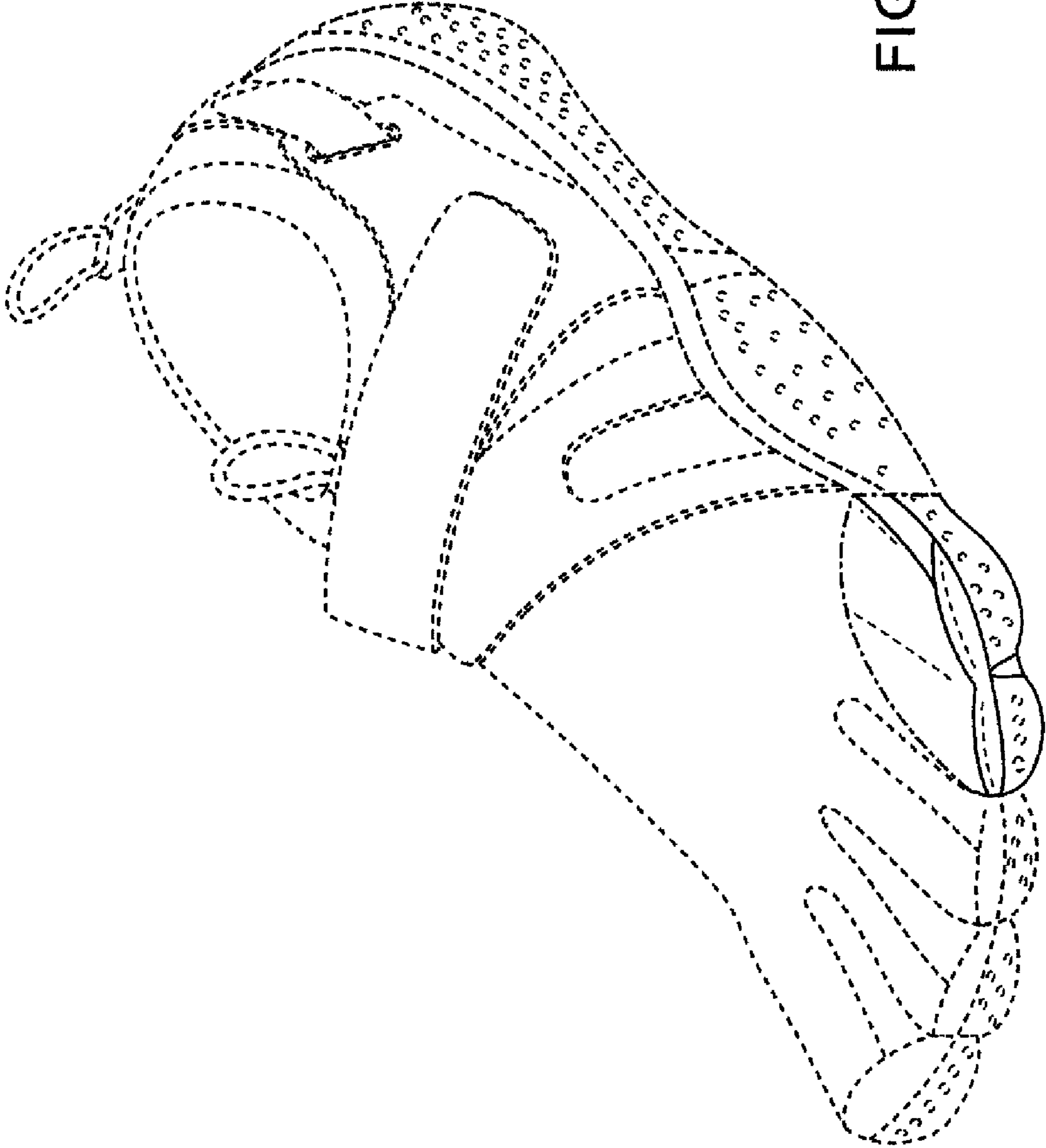

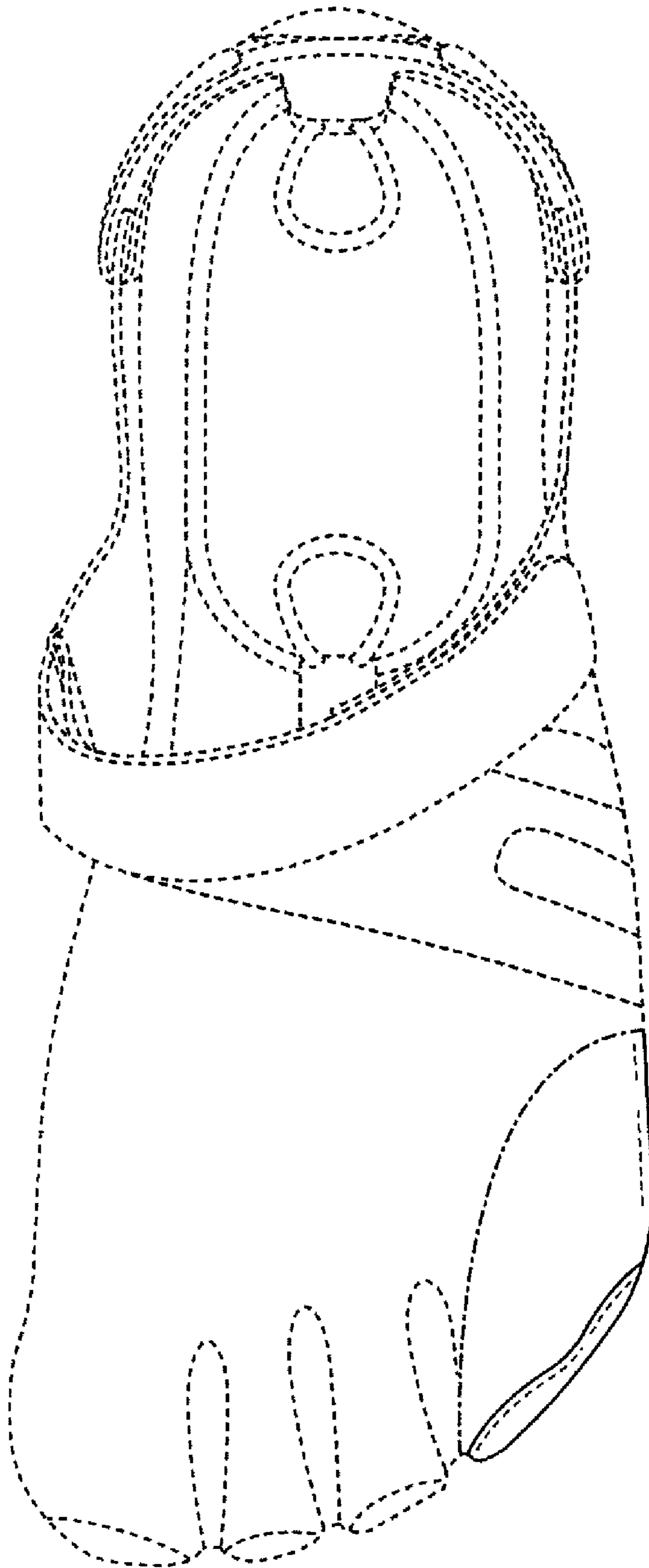

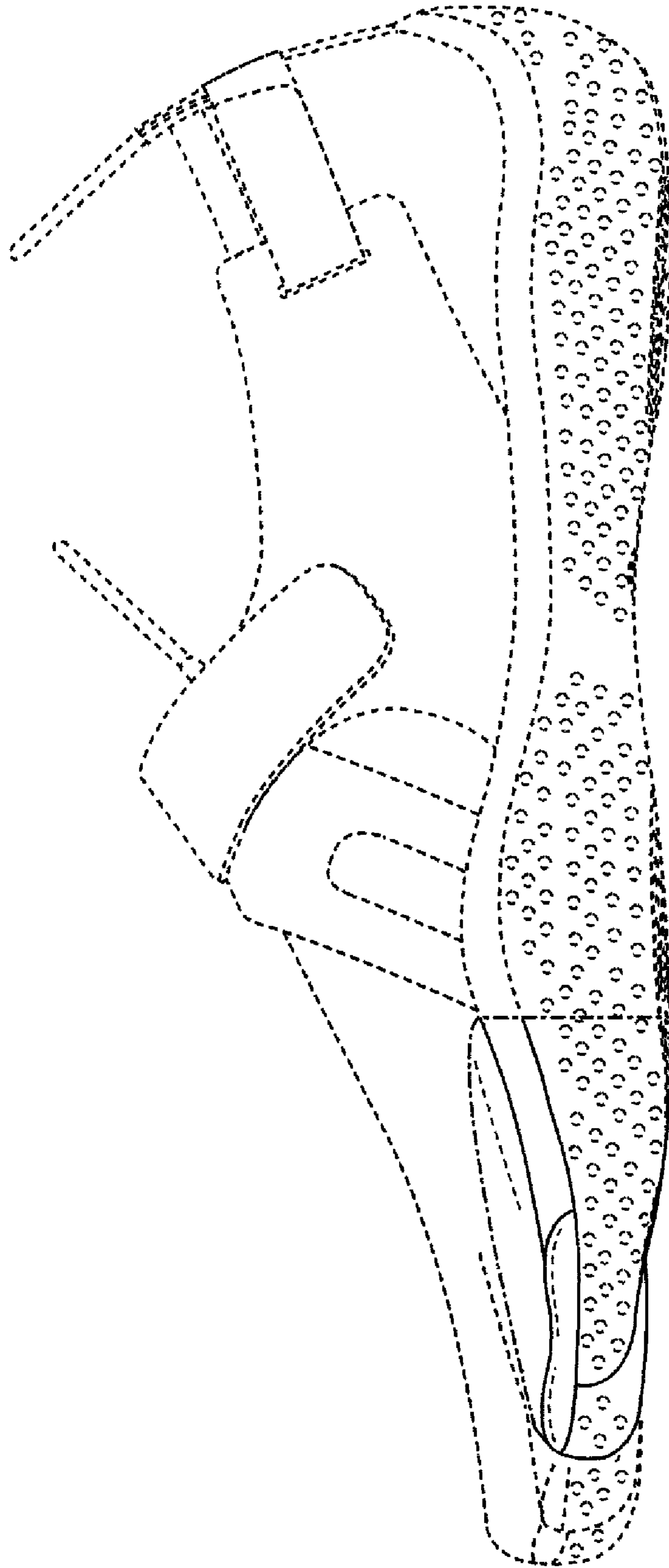

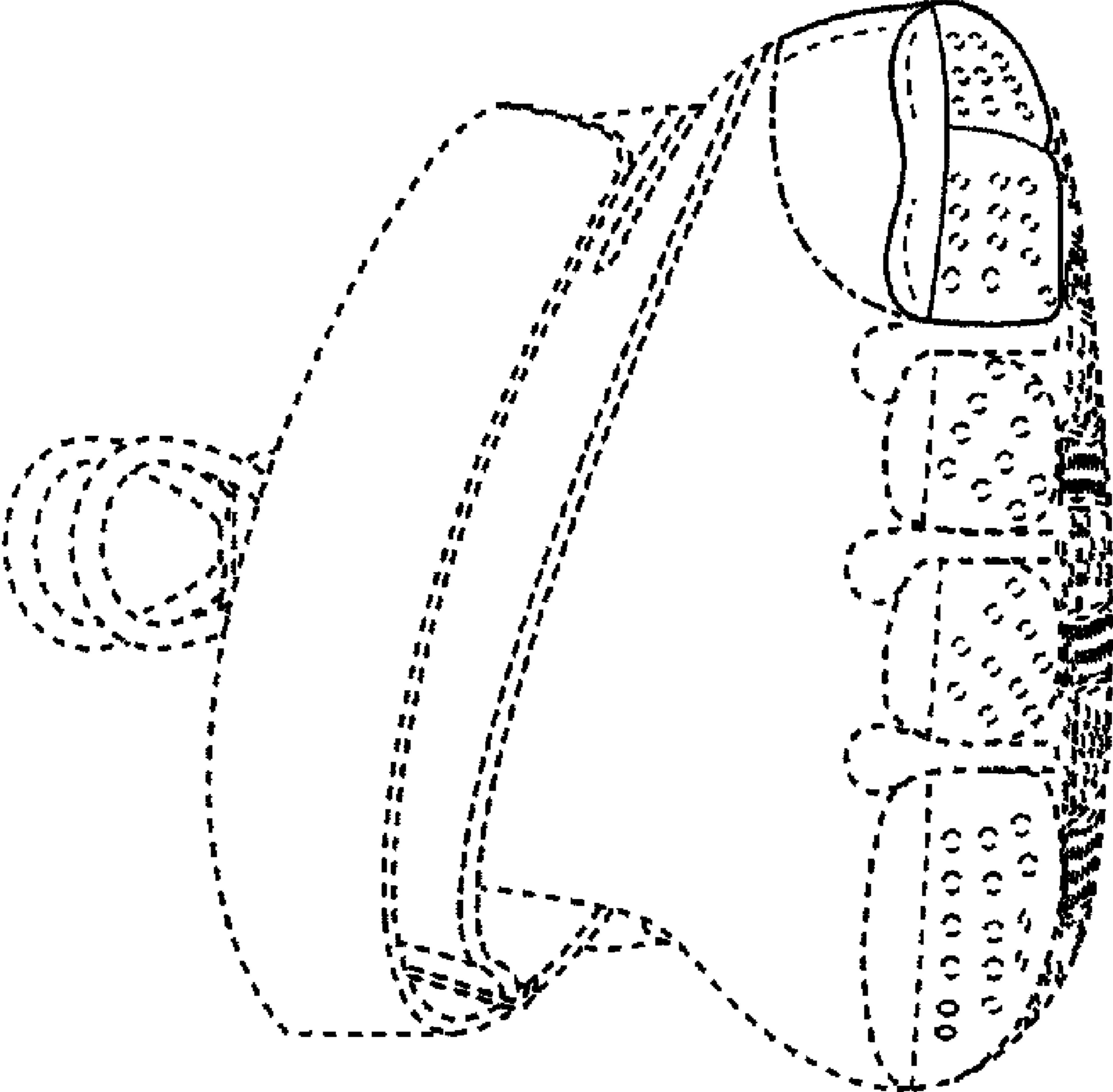
