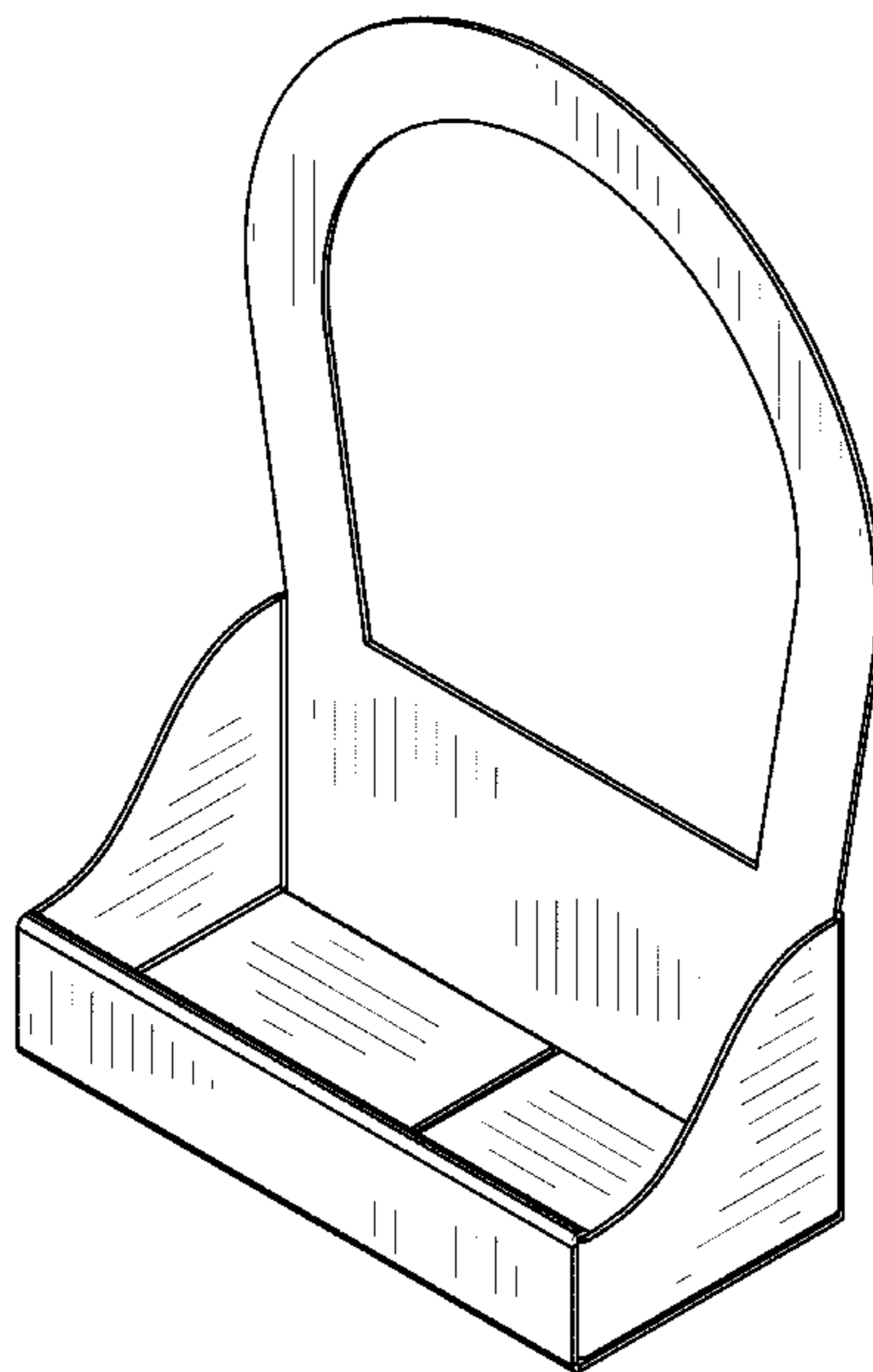
(57) **CLAIM**

The ornamental design for a neck-supported food and beverage carrier, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a neck-supported food and beverage carrier showing my new design;  
 FIG. 2 is a right side perspective view thereof;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a left side elevational view thereof;  
 FIG. 6 is a right side elevational view thereof;  
 FIG. 7 is a top plan view thereof; and,  
 FIG. 8 is a bottom plan view thereof.  
 The broken lines represent environmental structure and form no part of the claimed design.

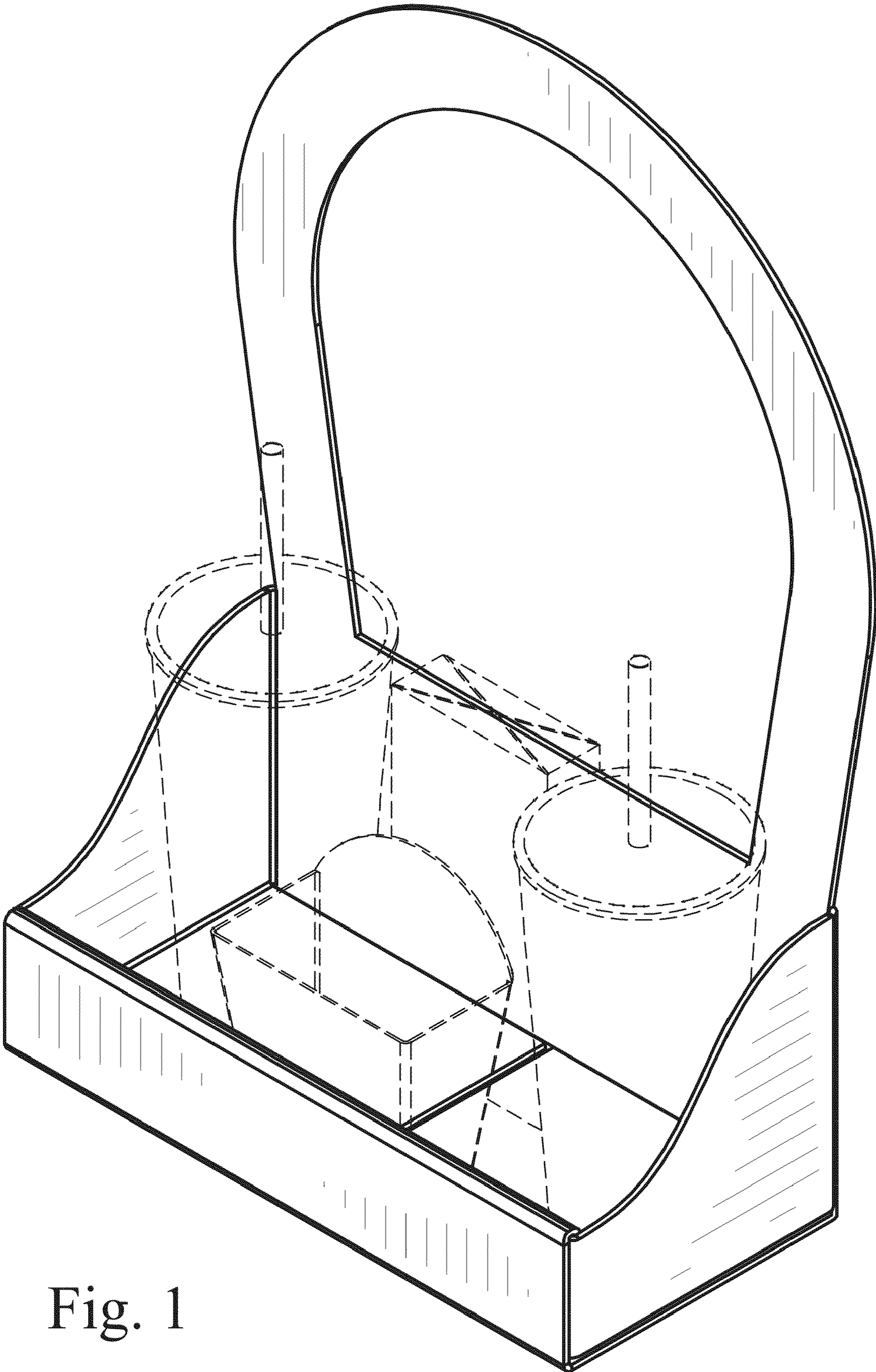

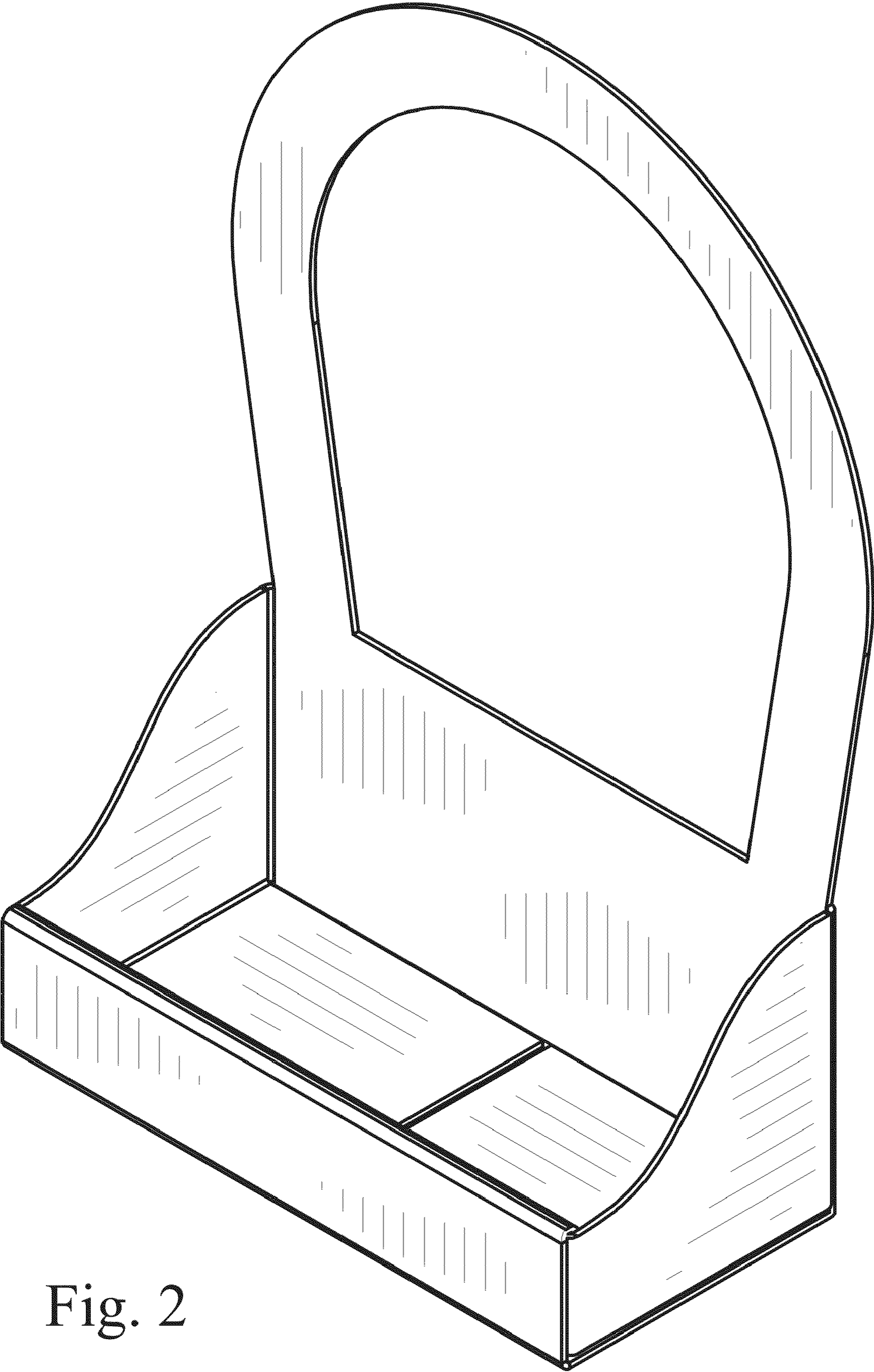

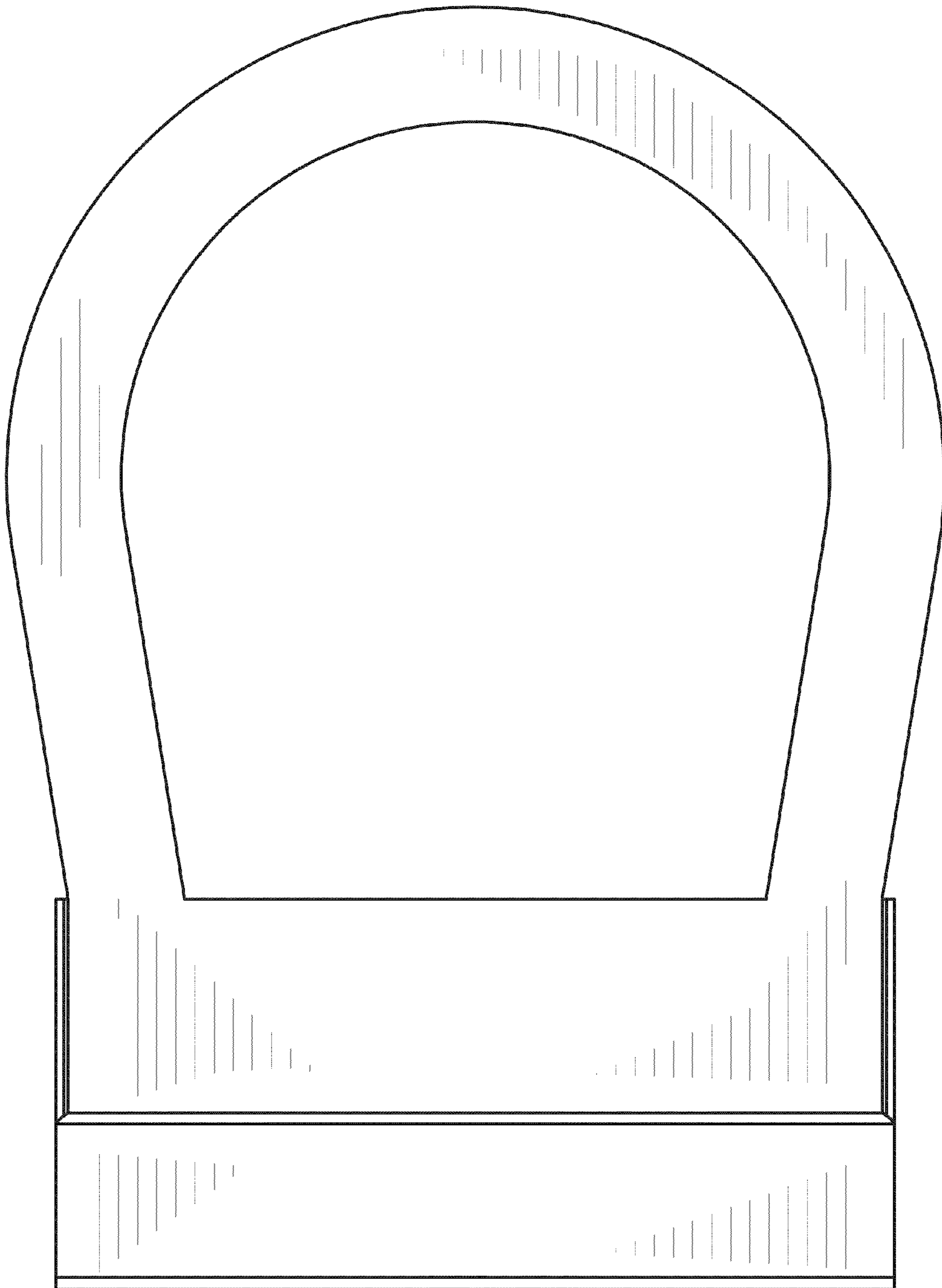

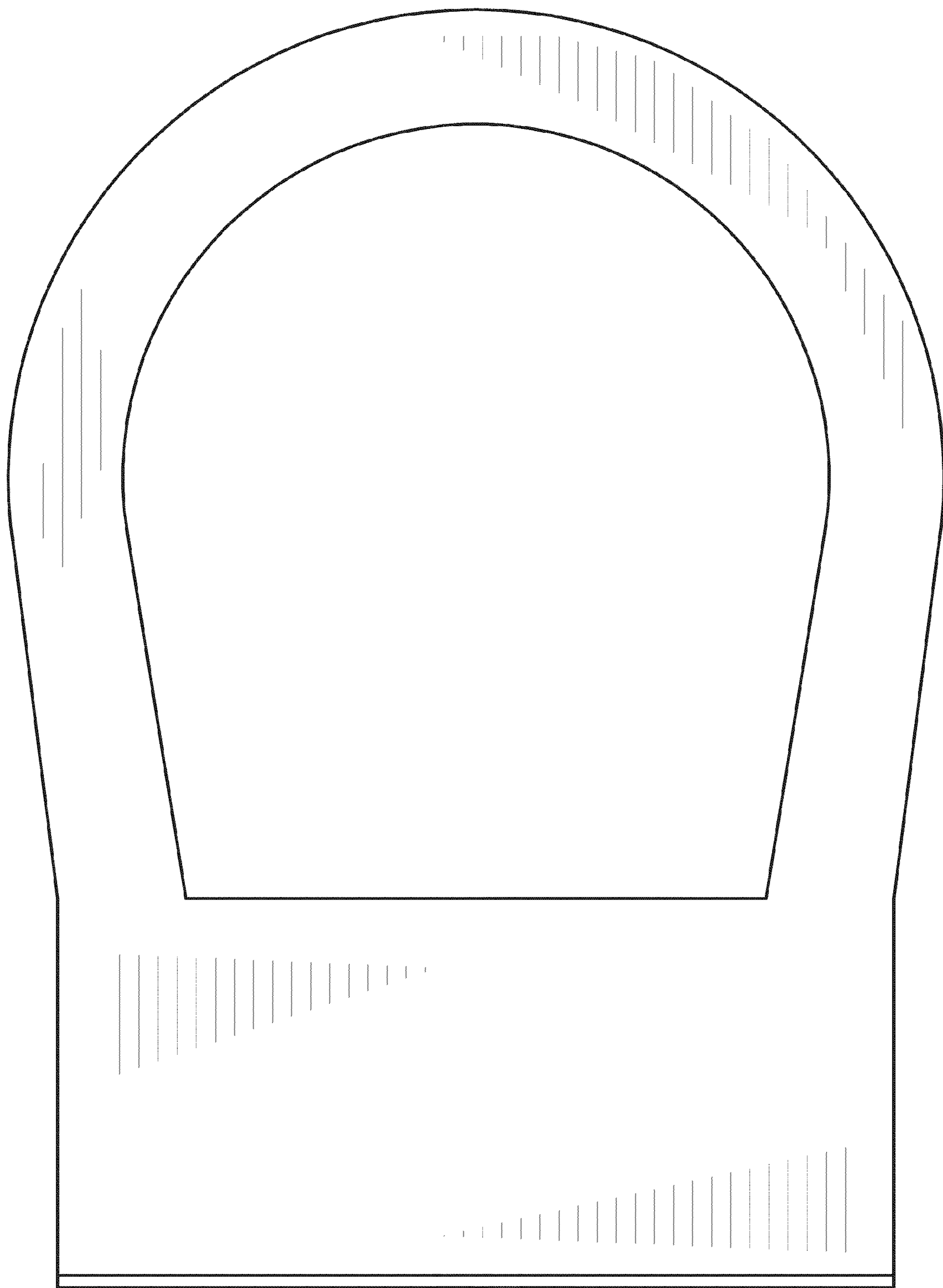

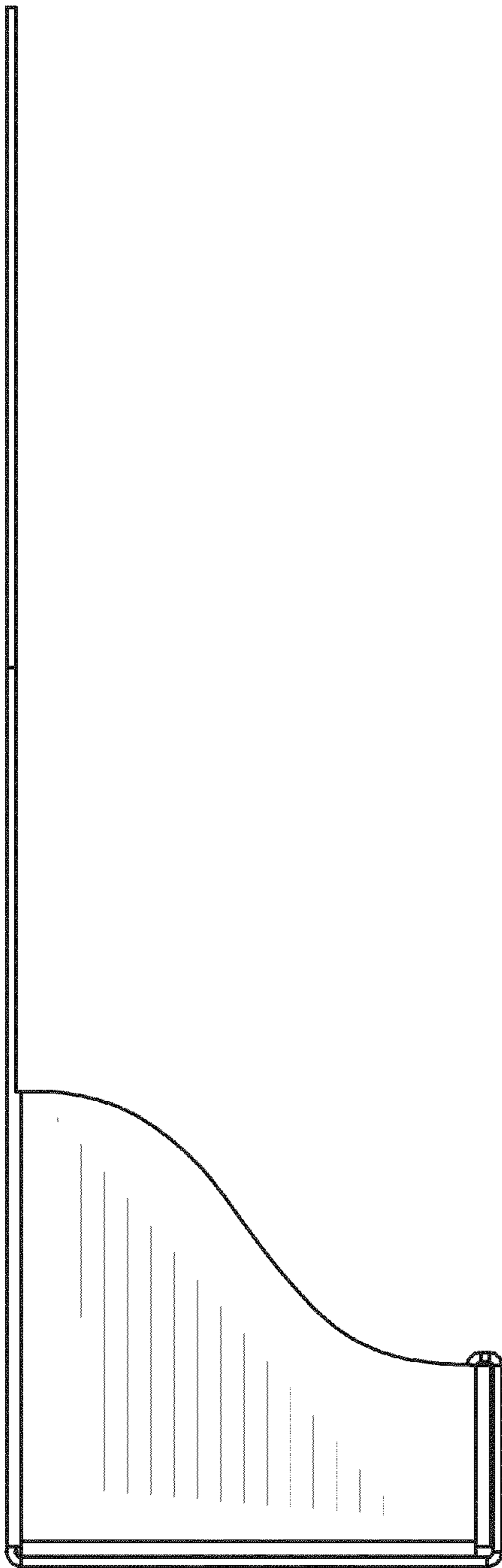

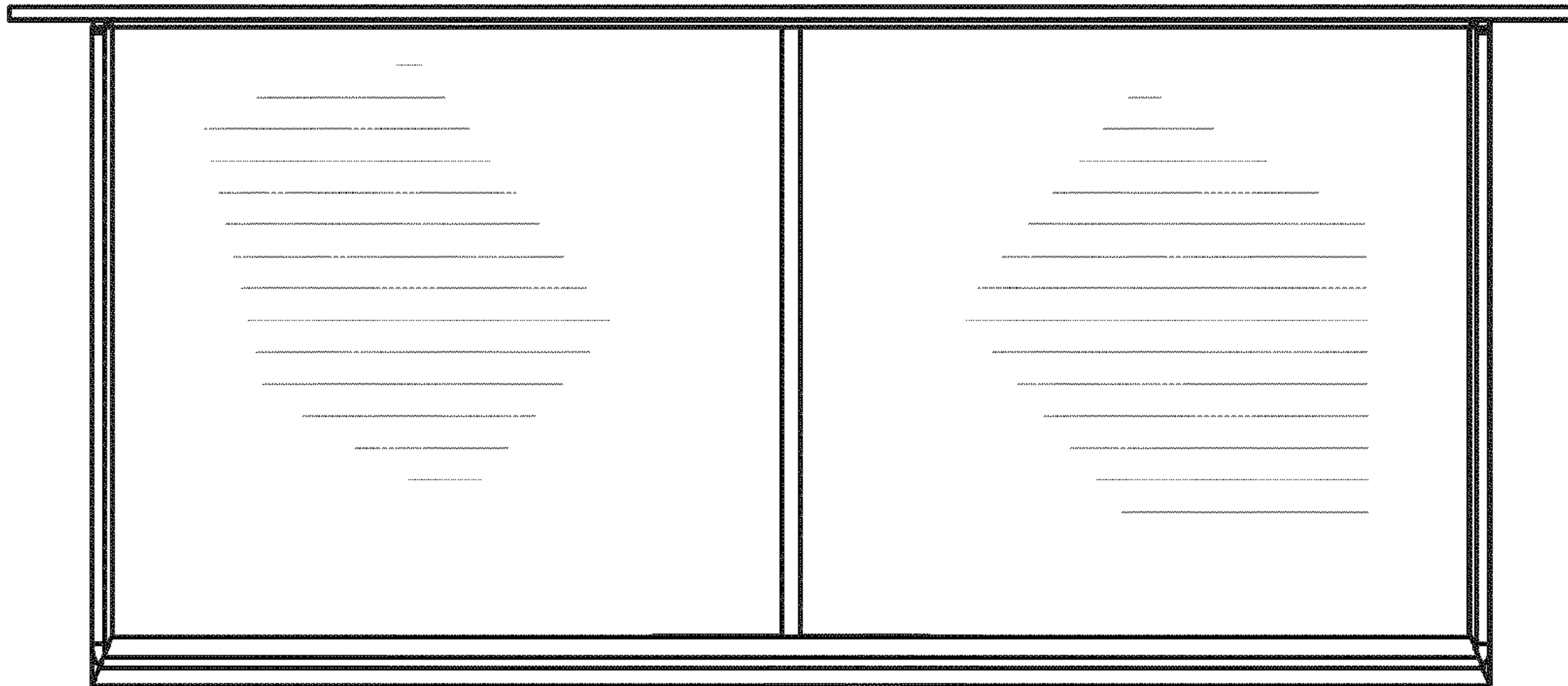

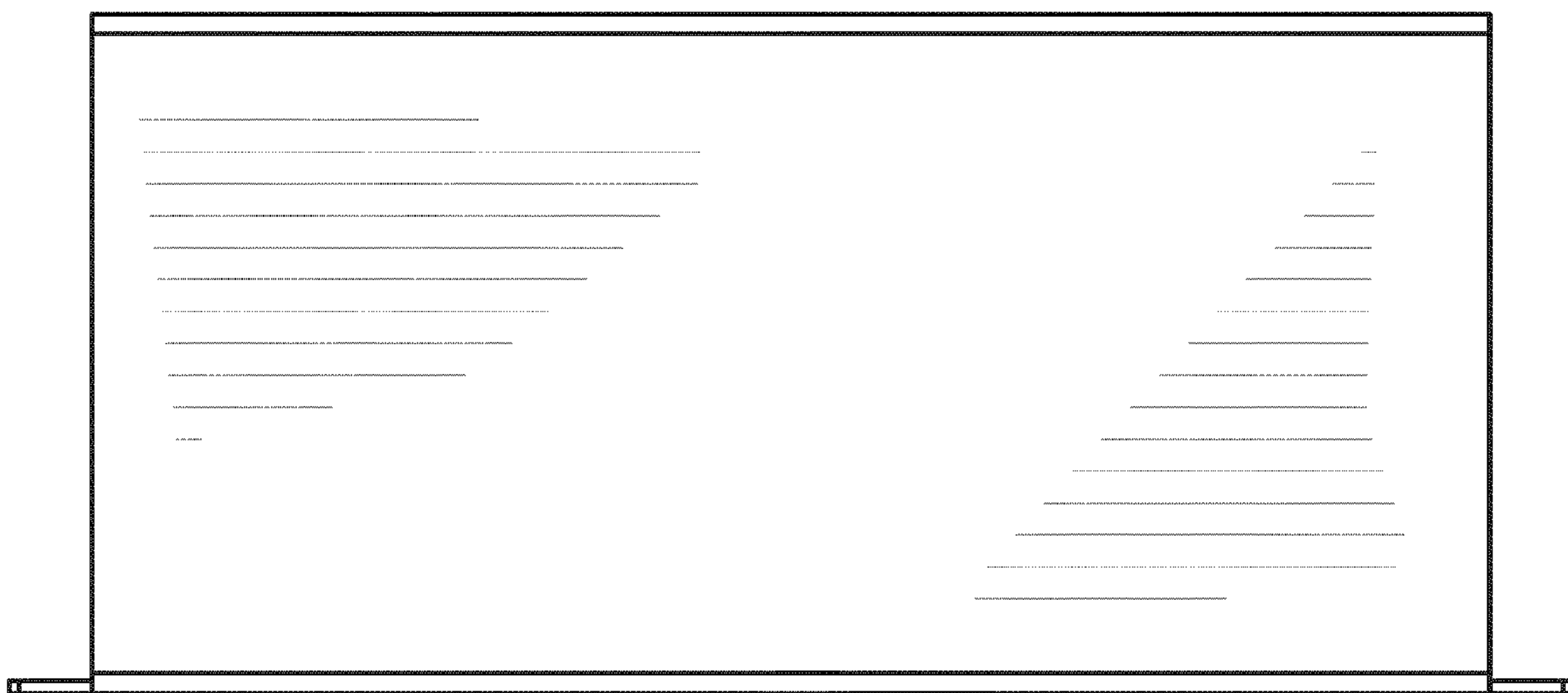
