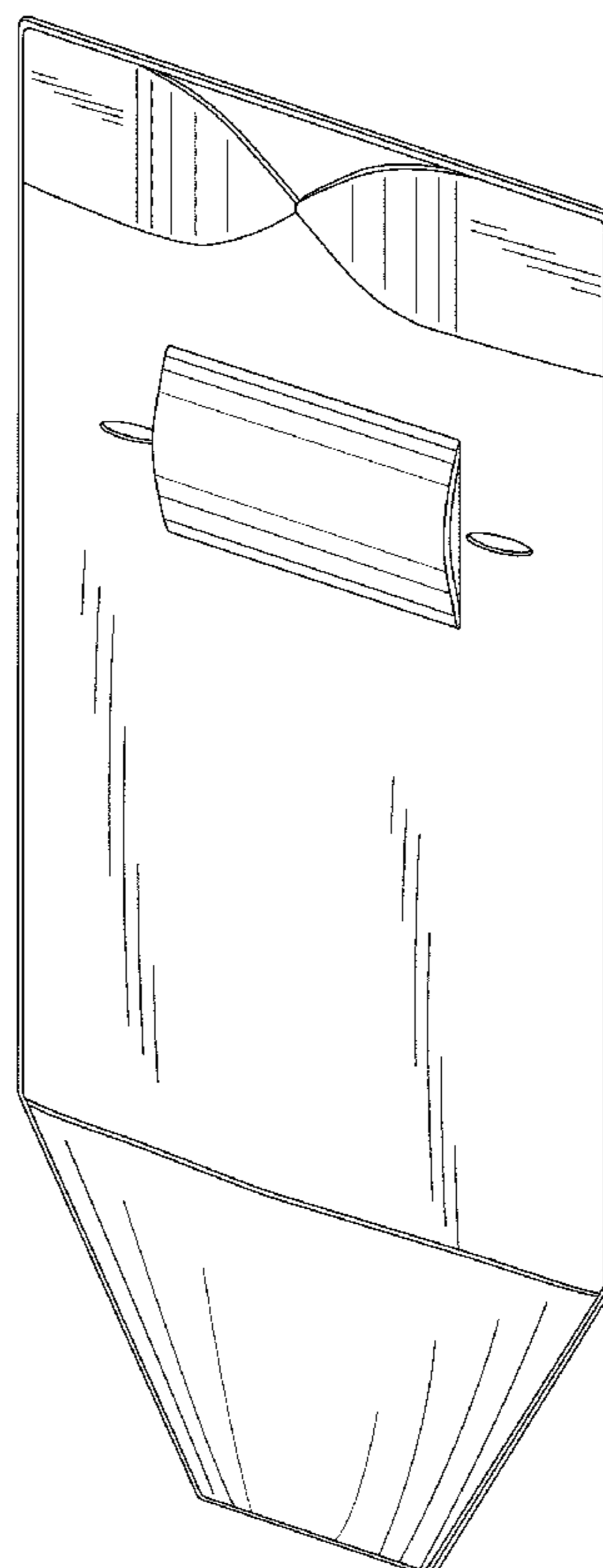
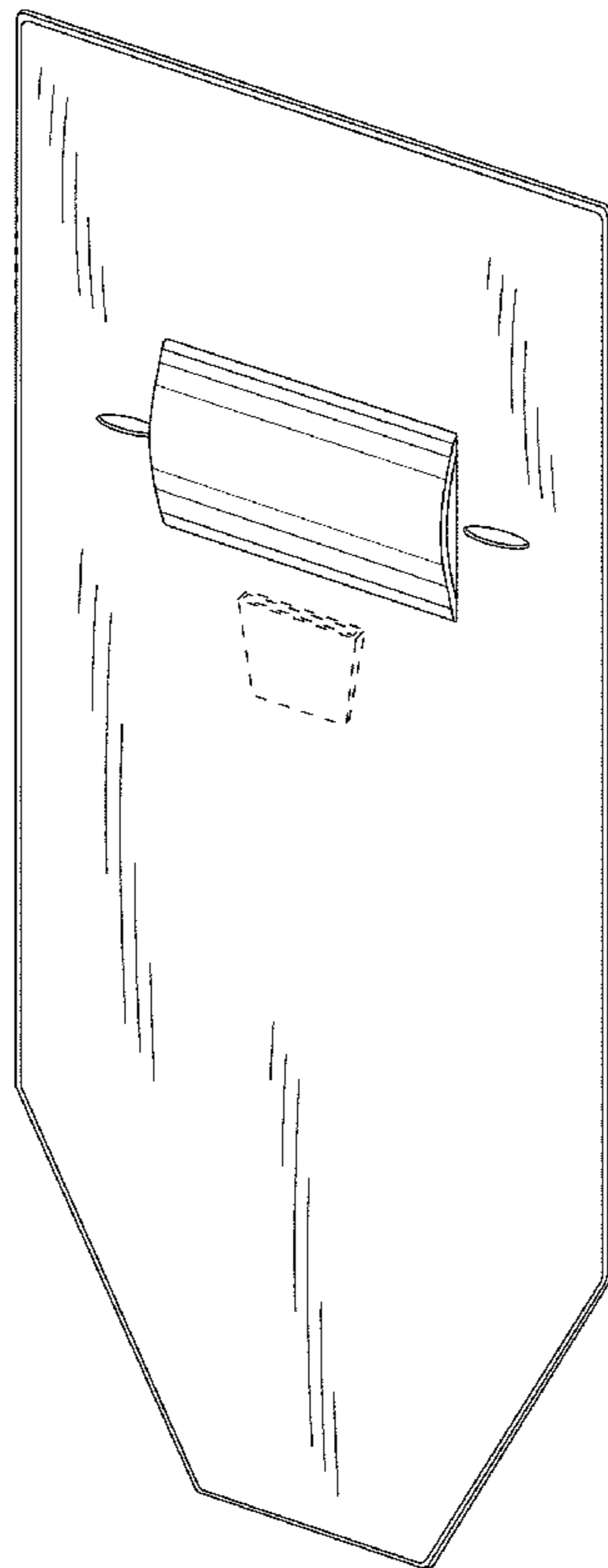
(57) **CLAIM**

The ornamental design for a body blanket with foot pouch and hand warmer sleeves, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a body blanket with foot pouch and hand warmer sleeves, showing my new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front view of thereof; FIG. 4 is rear view thereof; FIG. 5 is a left side view thereof with a right side view being a mirror image; FIG. 6 is an enlarged top view thereof; and, FIG. 7 is an enlarged bottom view thereof. The broken lines are for environmental purposes only and form no part of the claimed design.

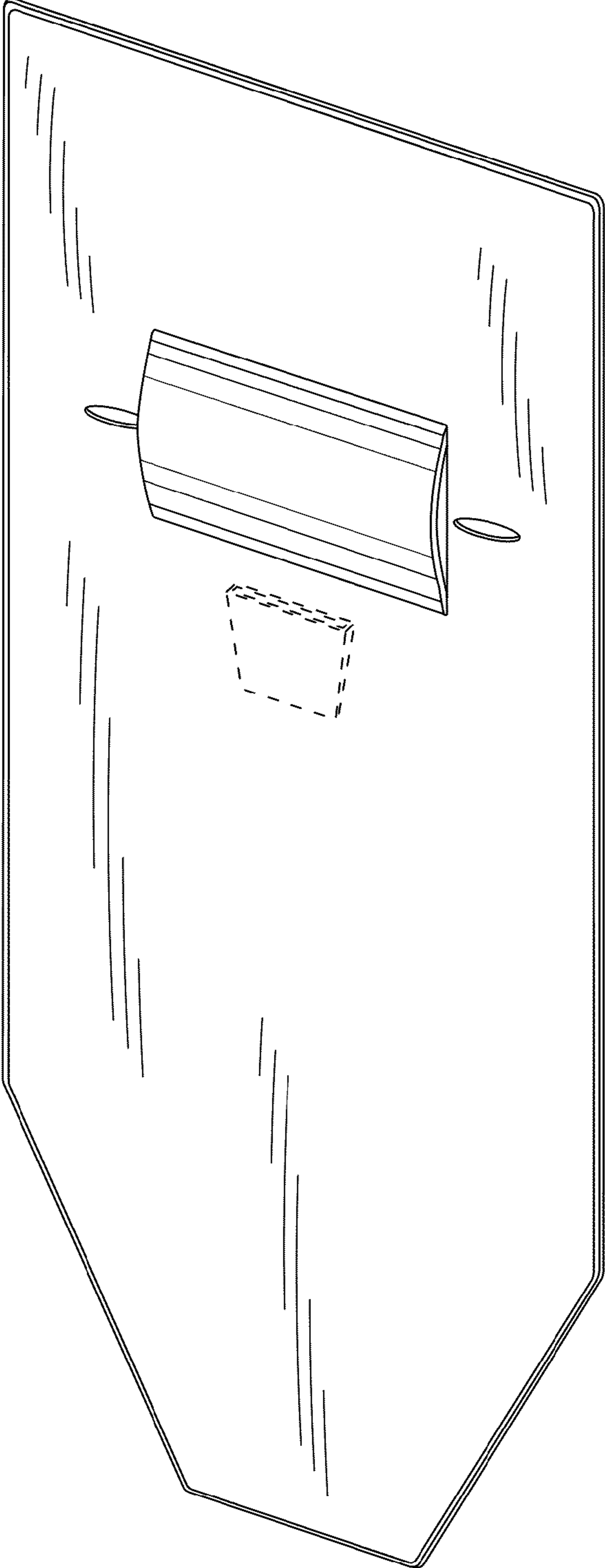

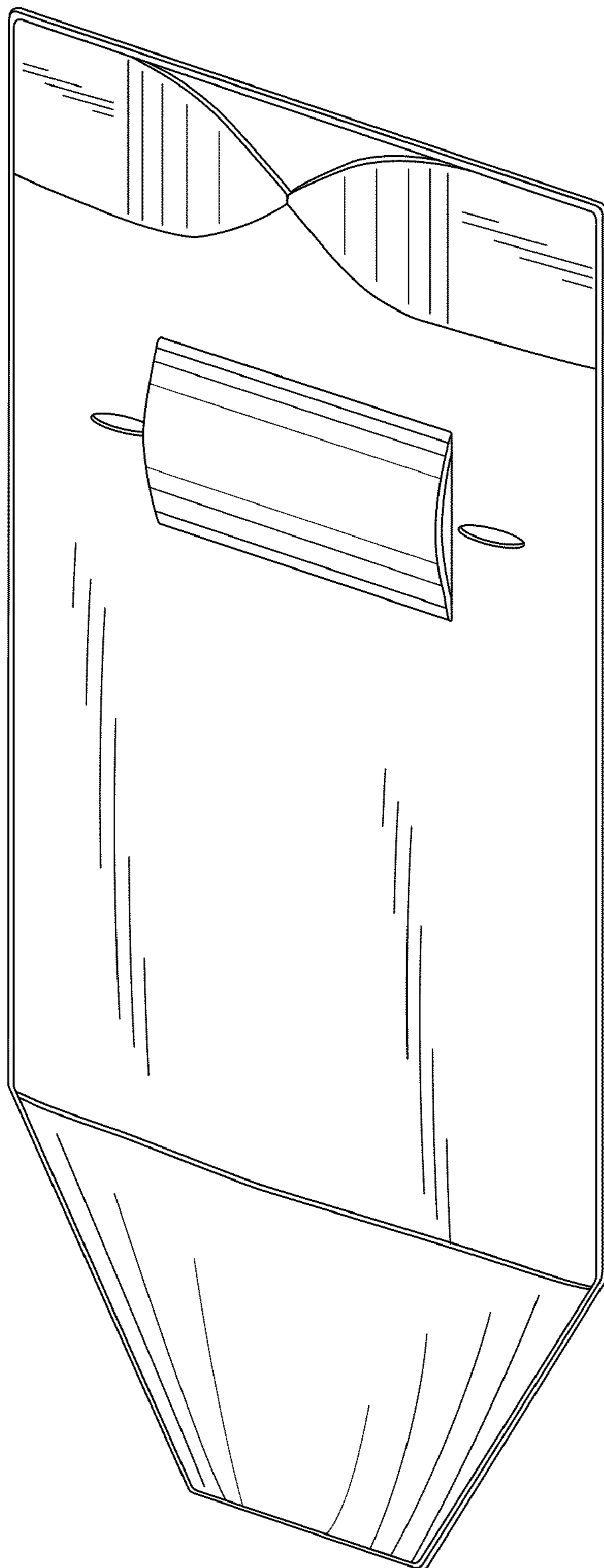

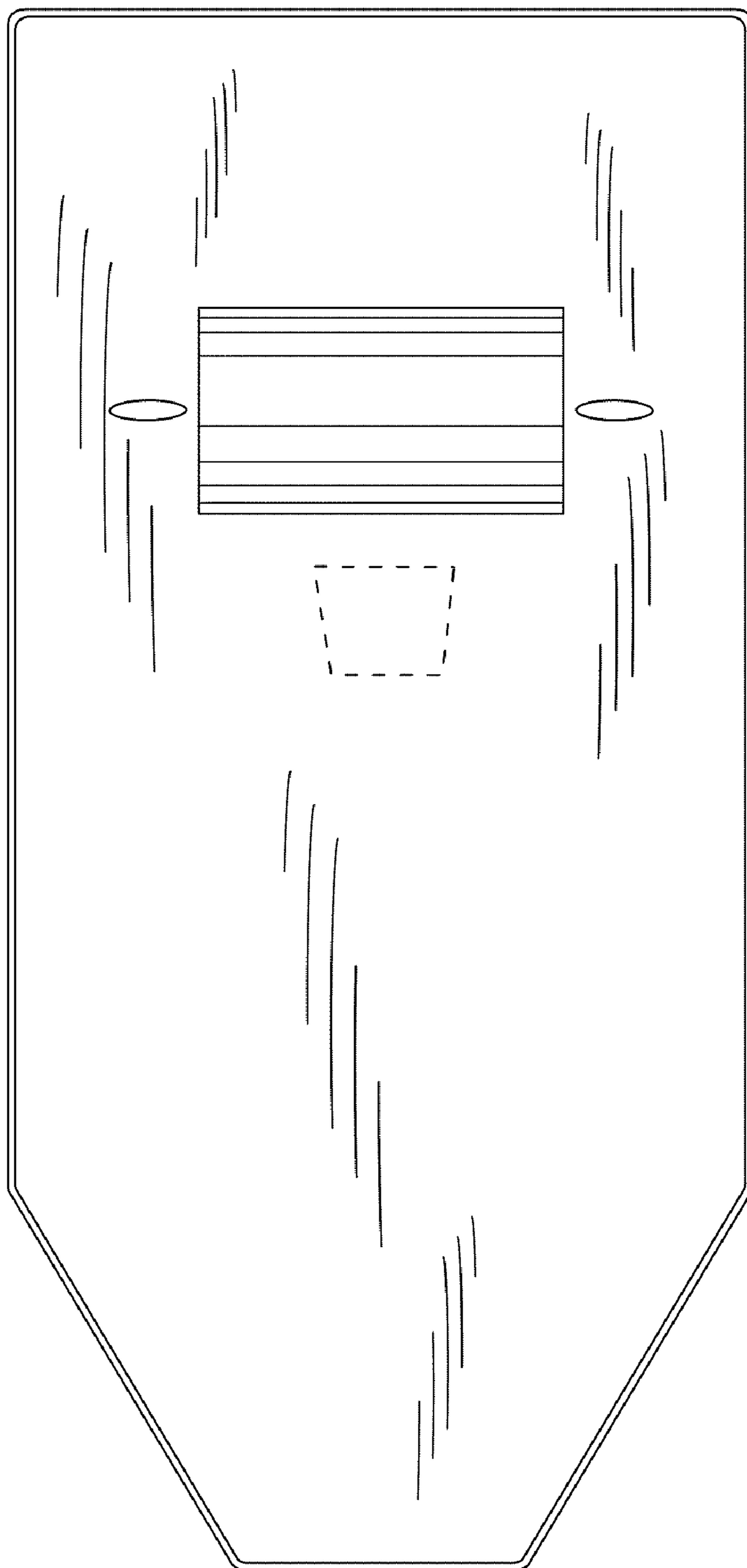

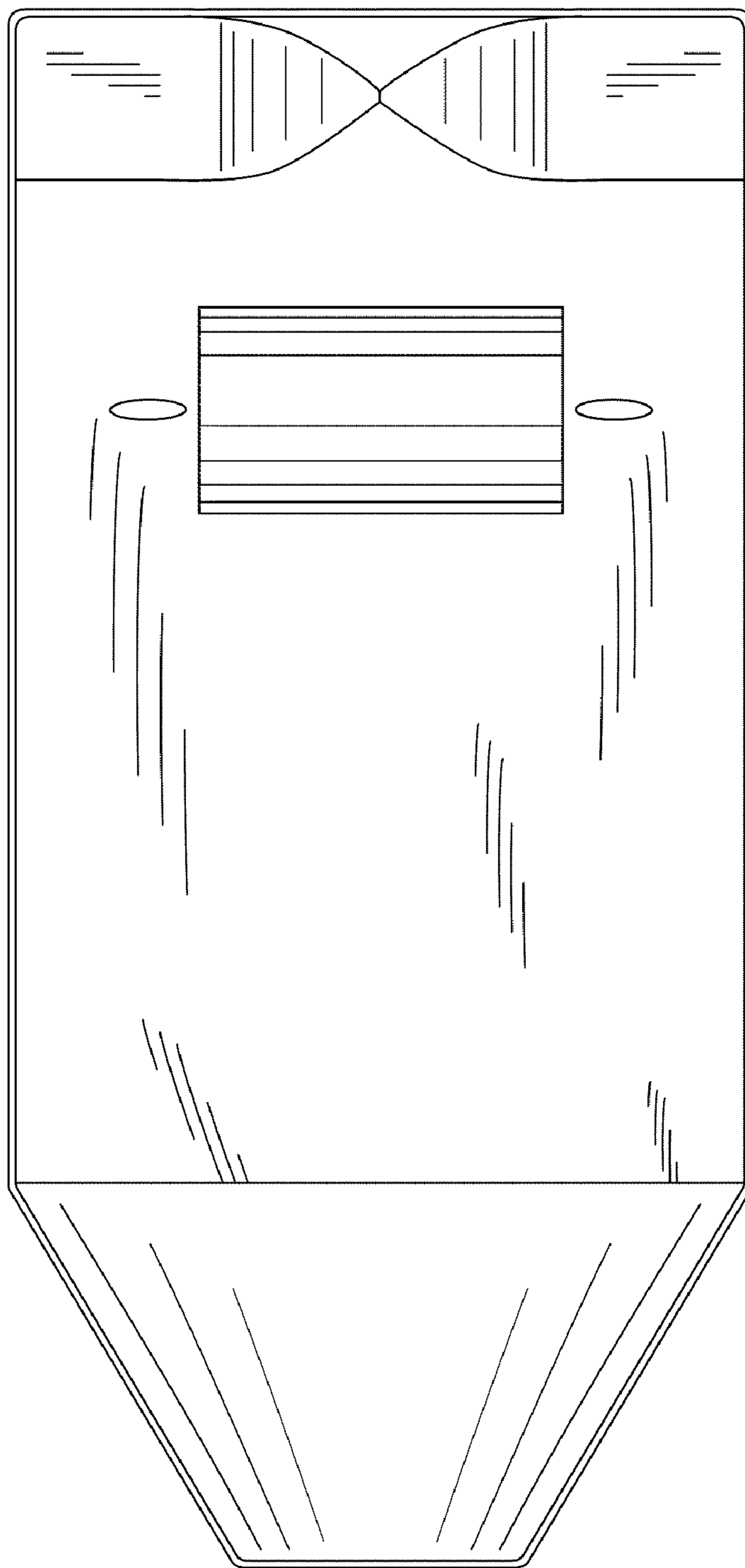

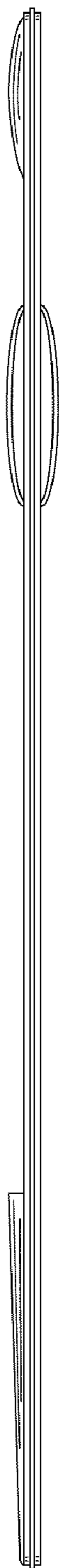

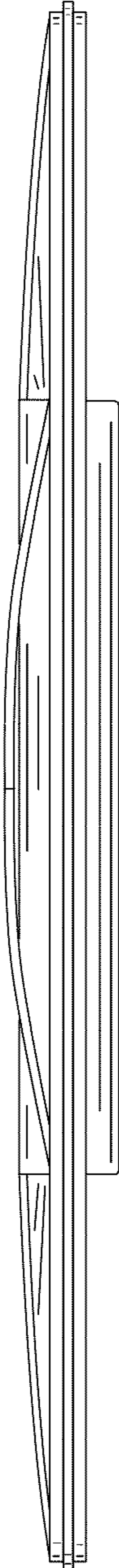

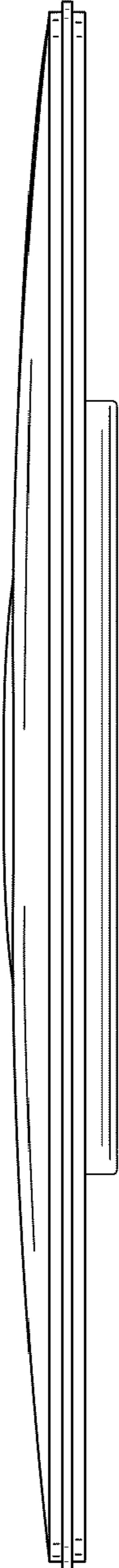
