(57) **CLAIM**

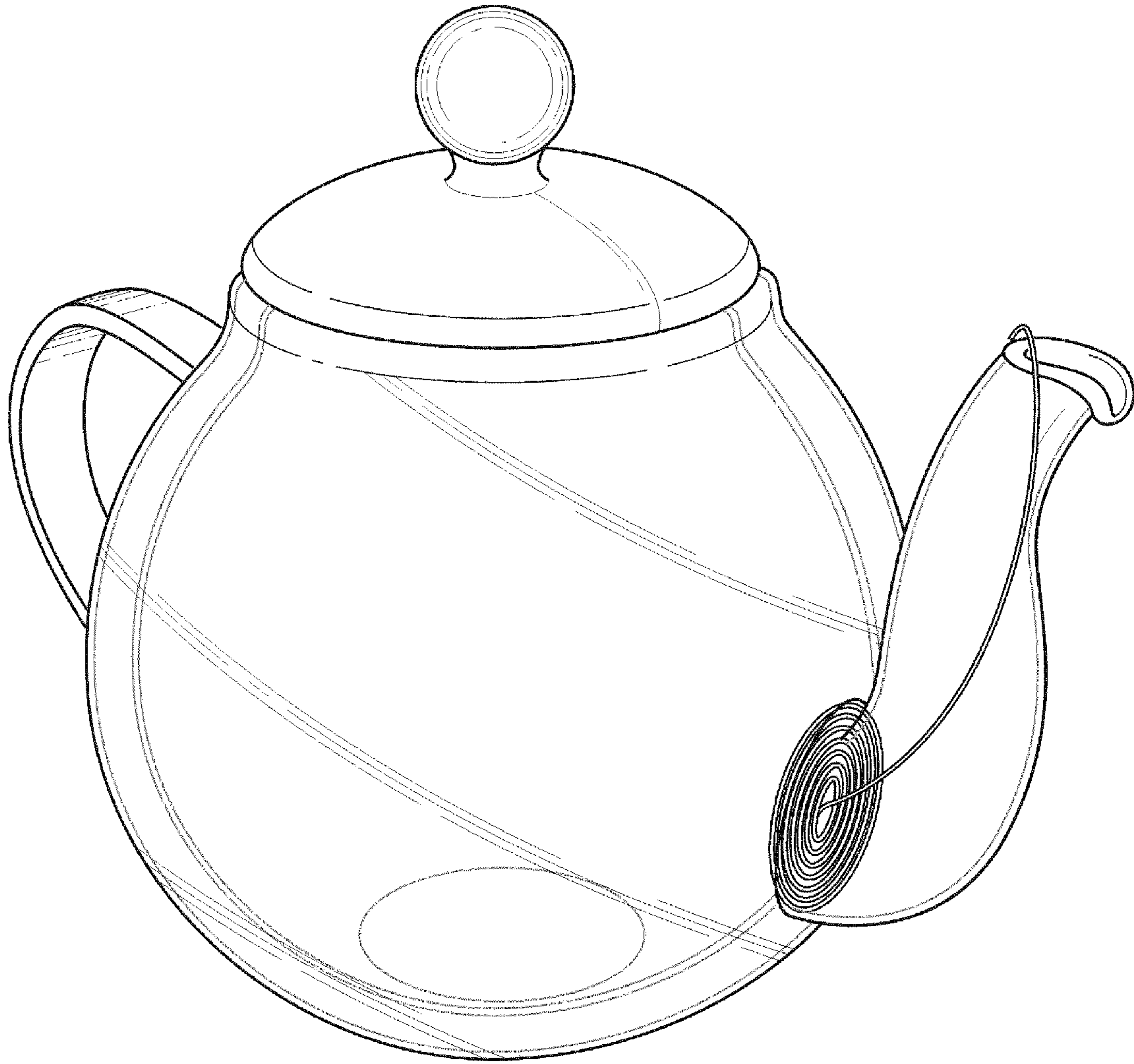
The ornamental design for a tea pot, as shown and described.

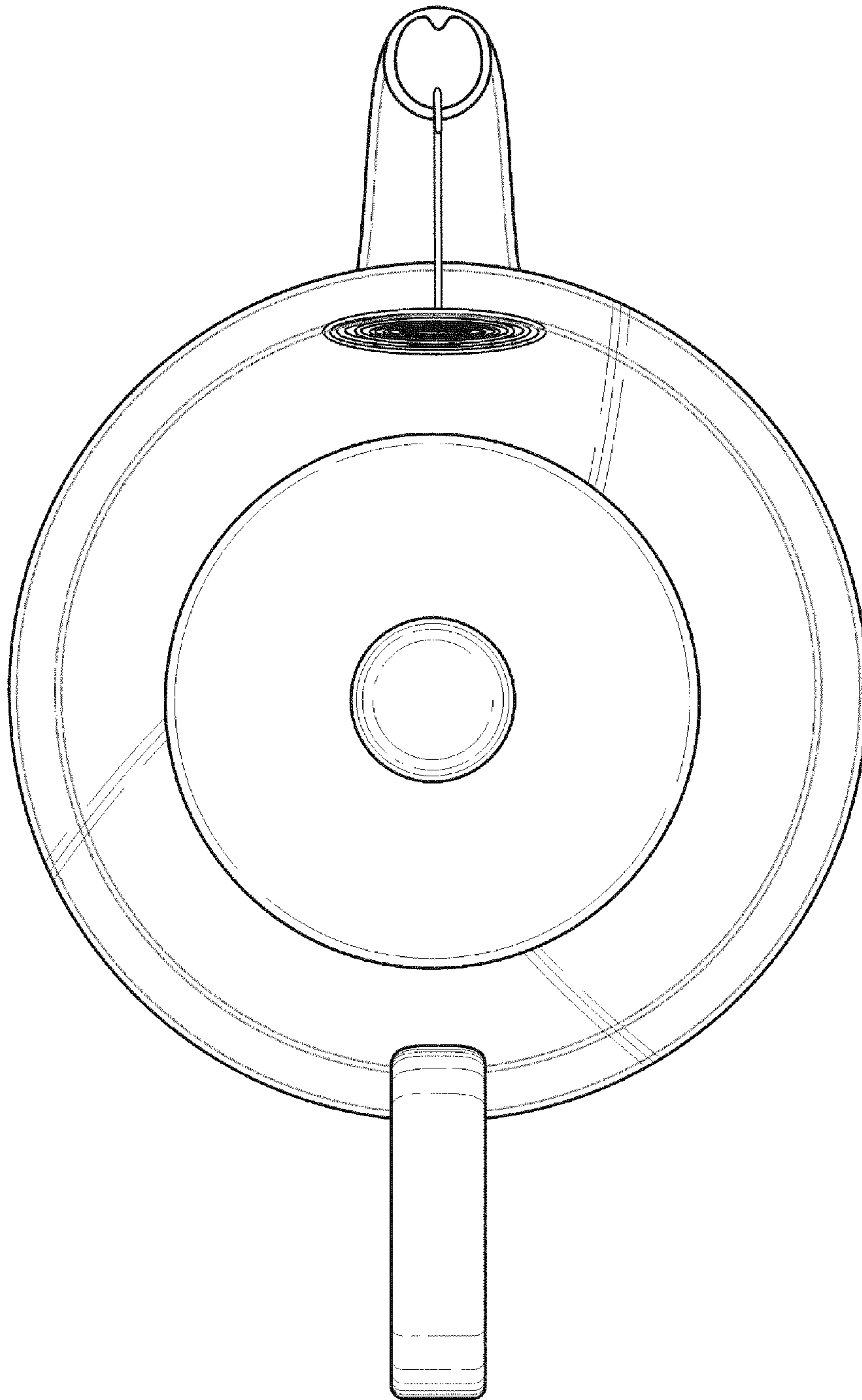

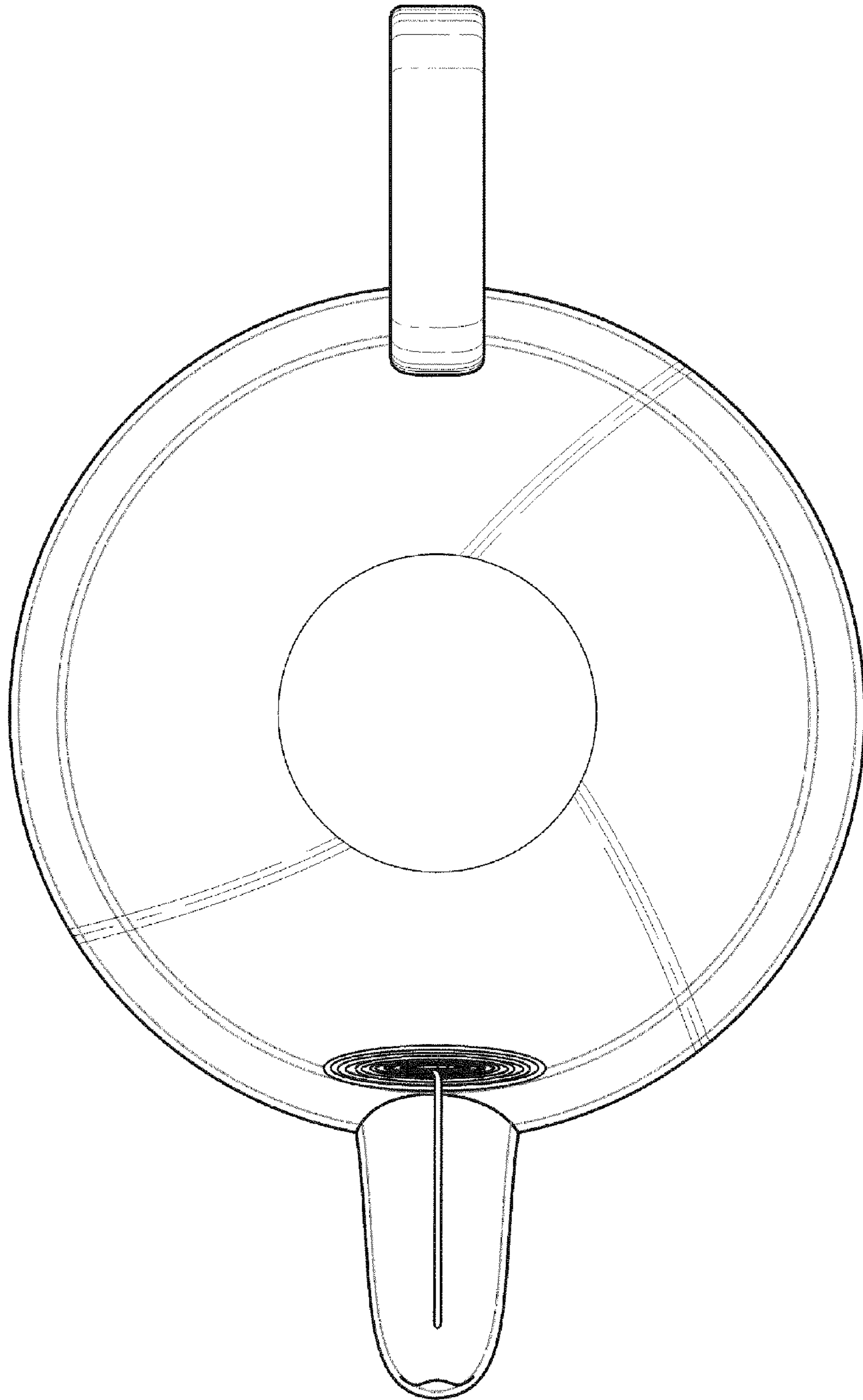

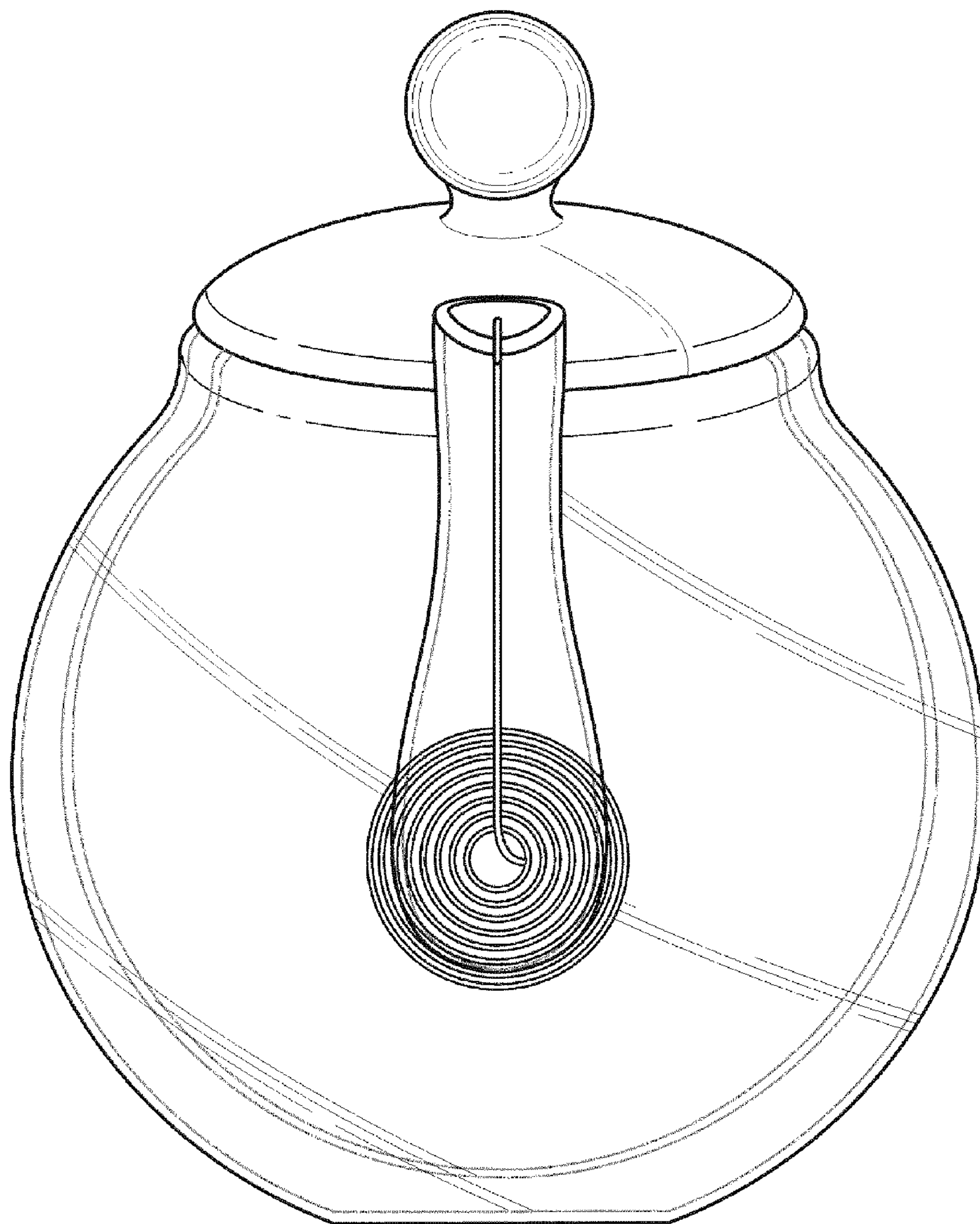

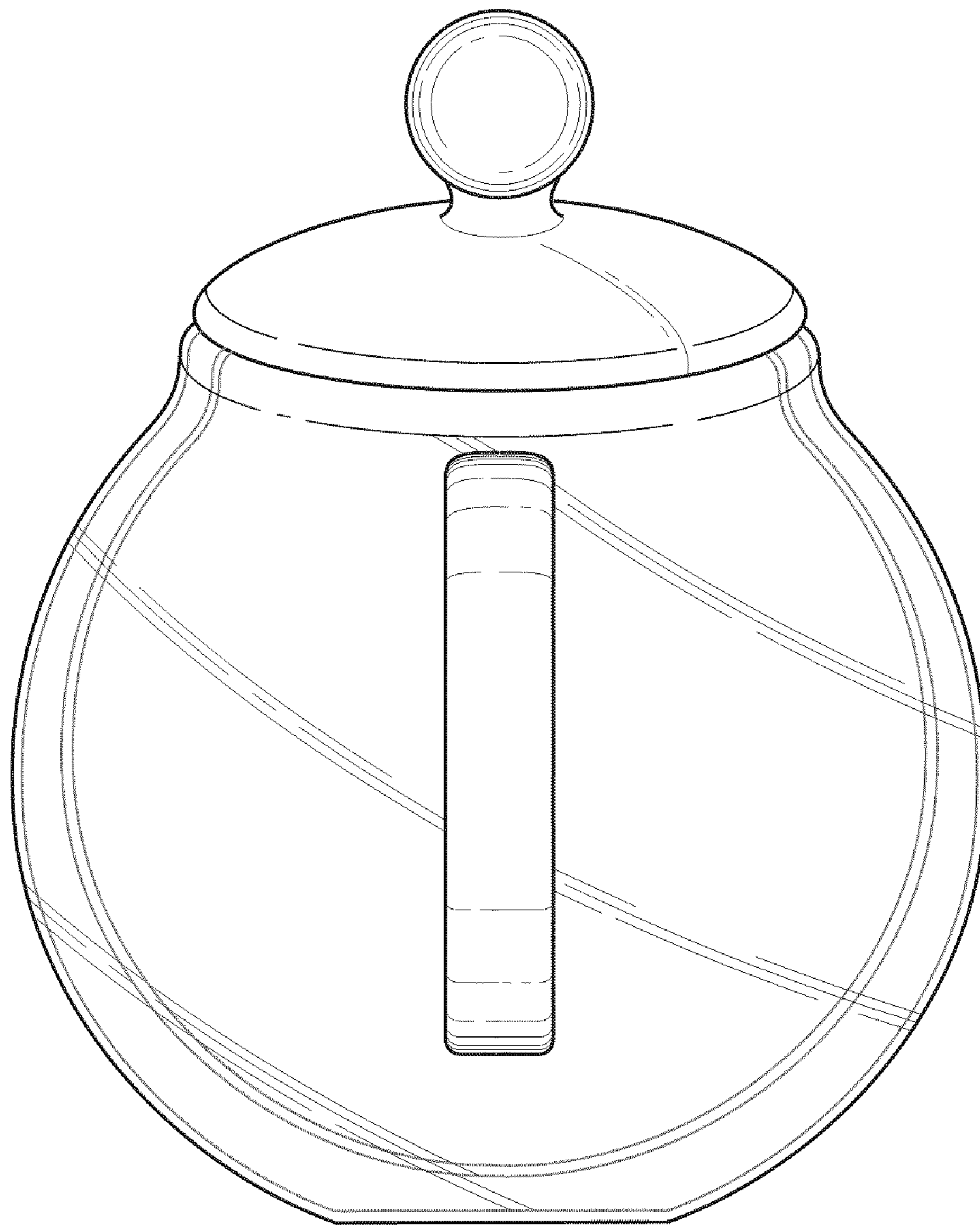
