(57) **CLAIM**

The ornamental design for a wristwatch, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a wristwatch showing our new design; and
FIG. 2 is a rear view thereof;
FIG. 3 is a bottom view of the wristwatch with the watchband shown in a different position;
FIG. 4 is a top view of FIG. 3;
FIG. 5 is a right side view of FIG. 1;
FIG. 6 is a left side view of FIG. 1; and,
FIG. 7 is a front perspective view with strap closed.

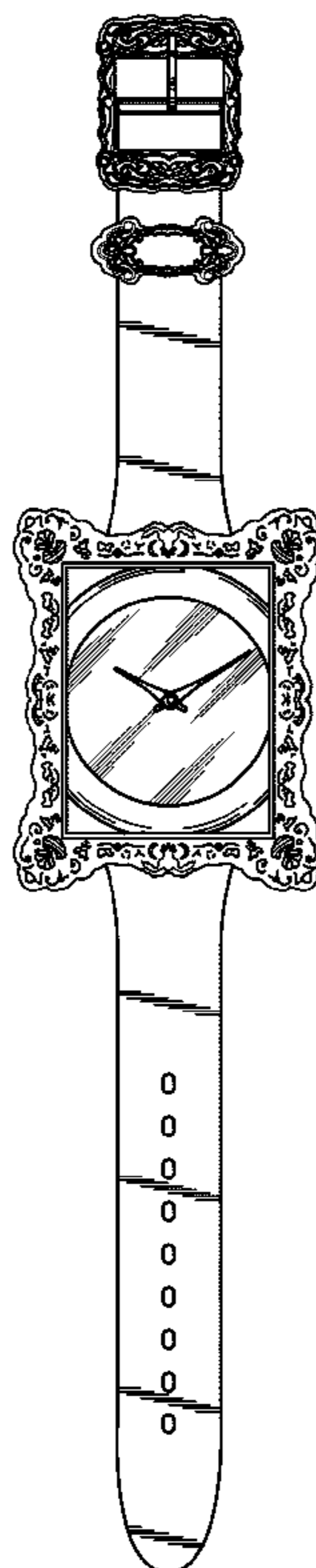

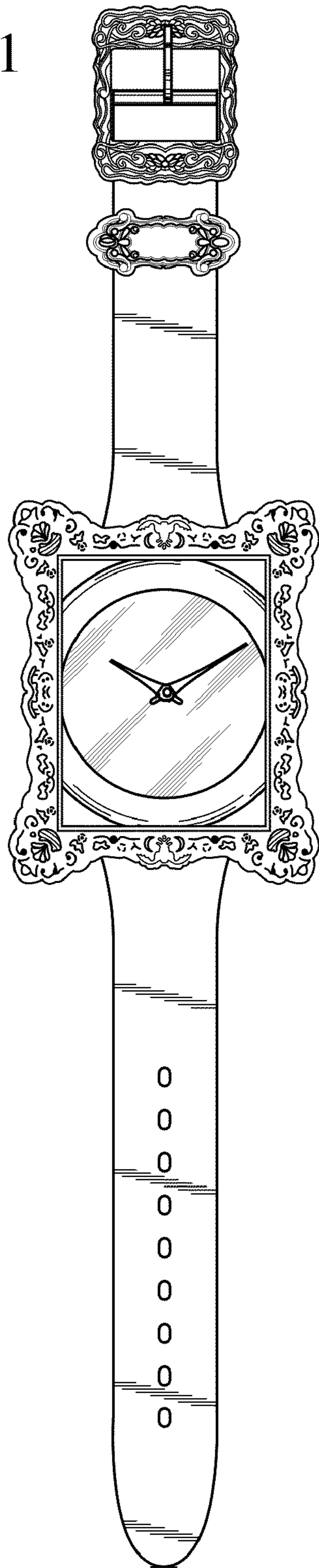

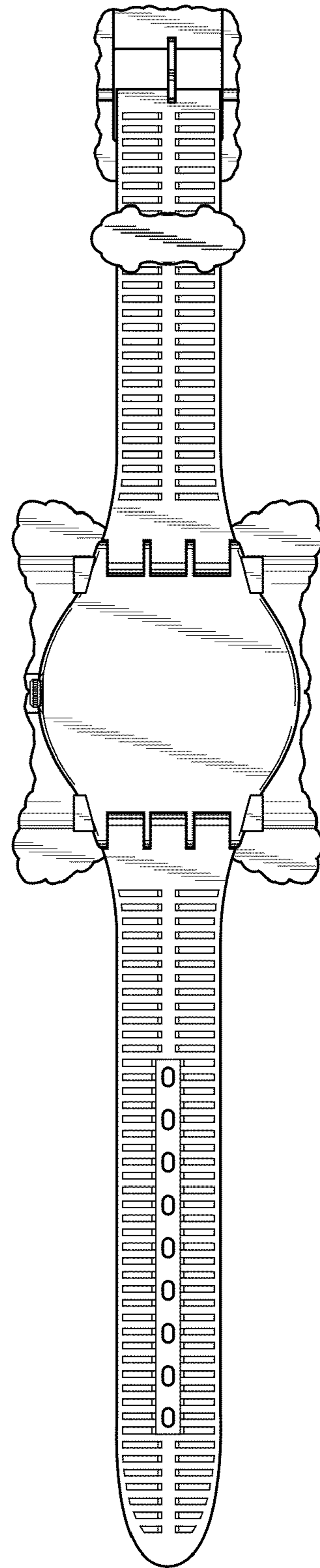

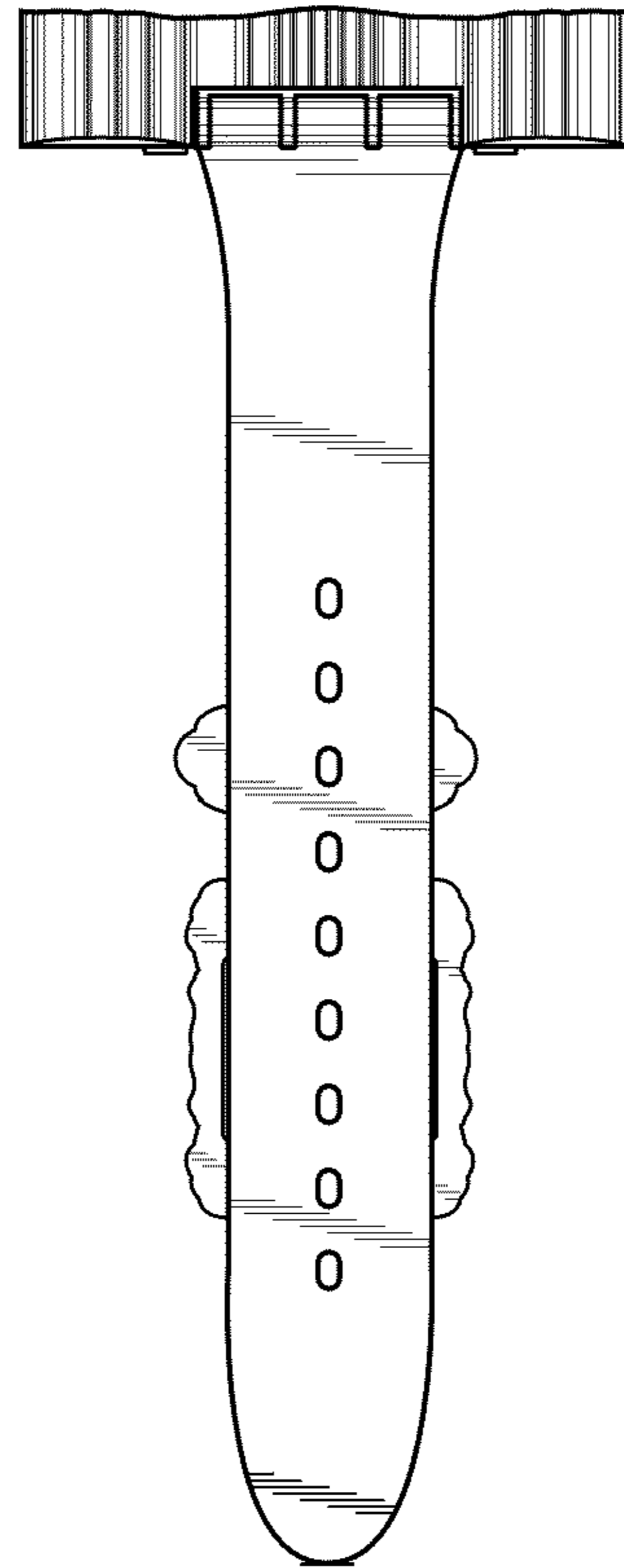

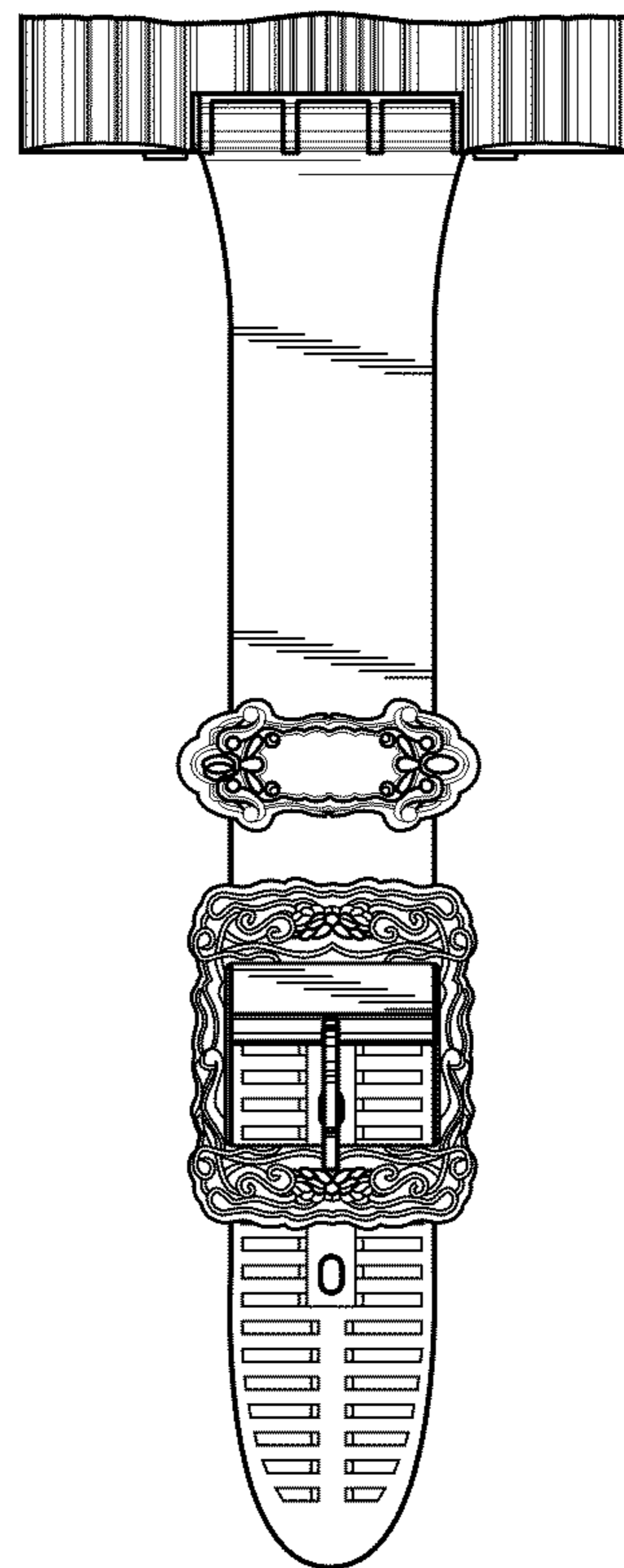

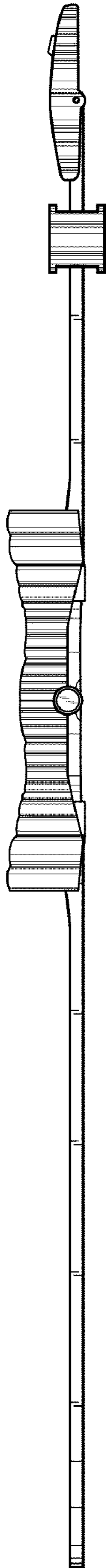

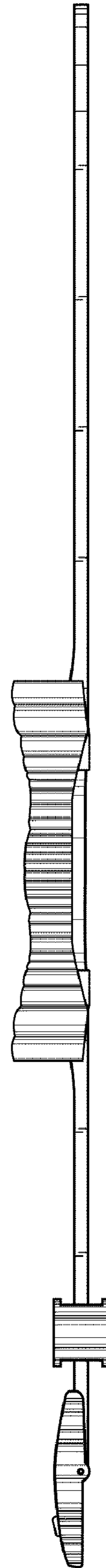
