FIG. 25 is a right side view of the cytometer of FIG. 22.

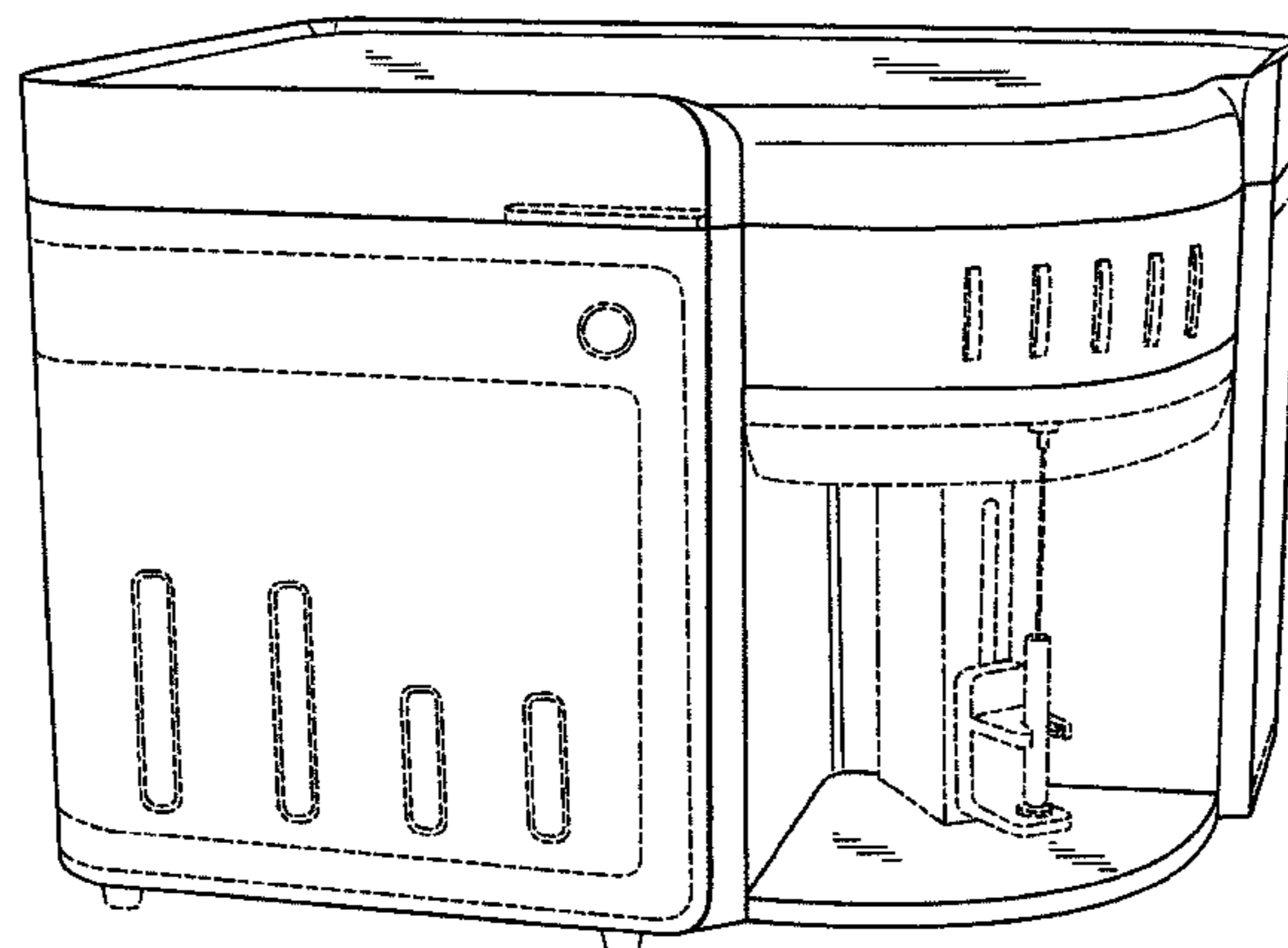
FIG. 26 is a left side view of the cytometer of FIG. 22.

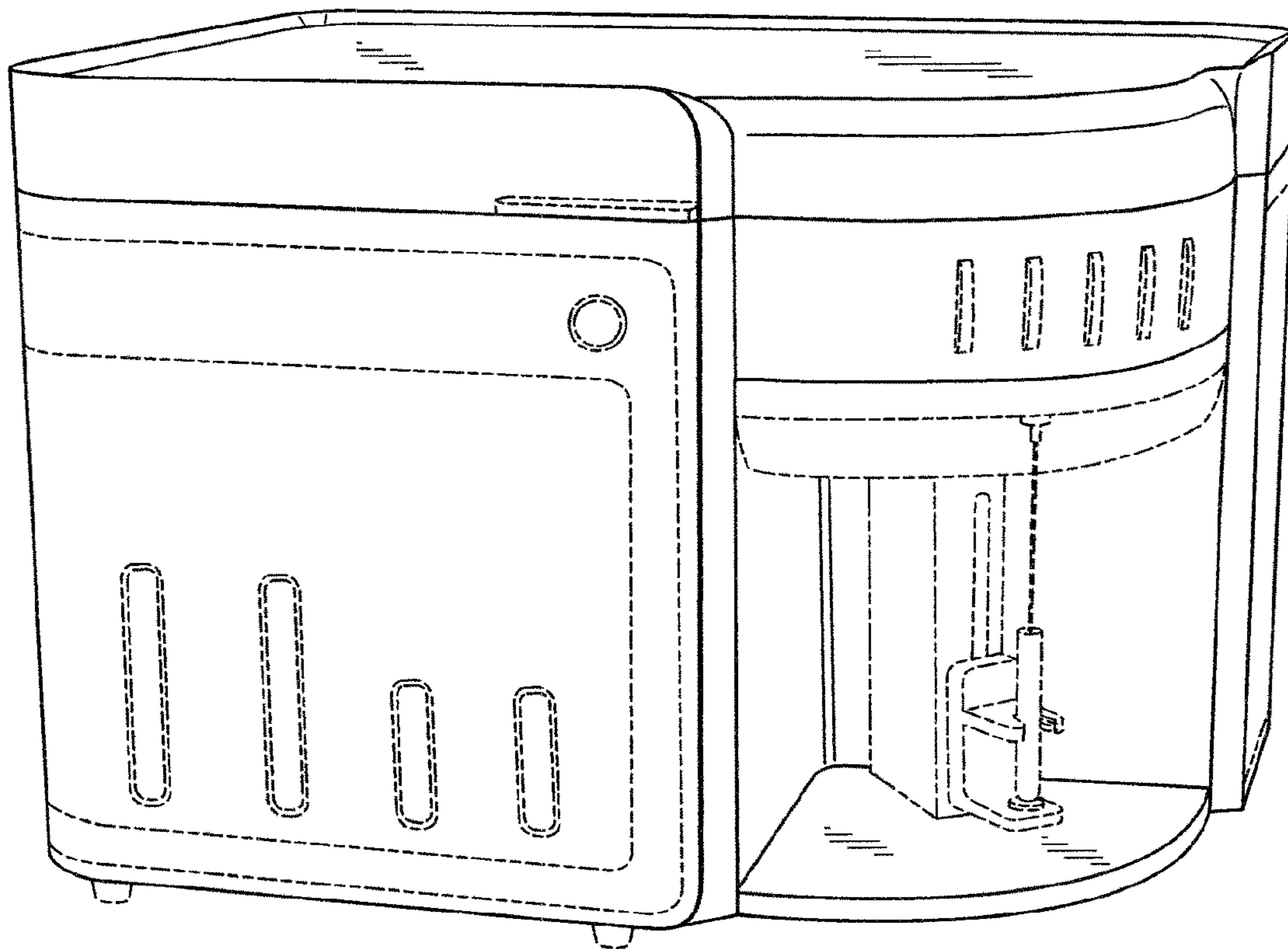

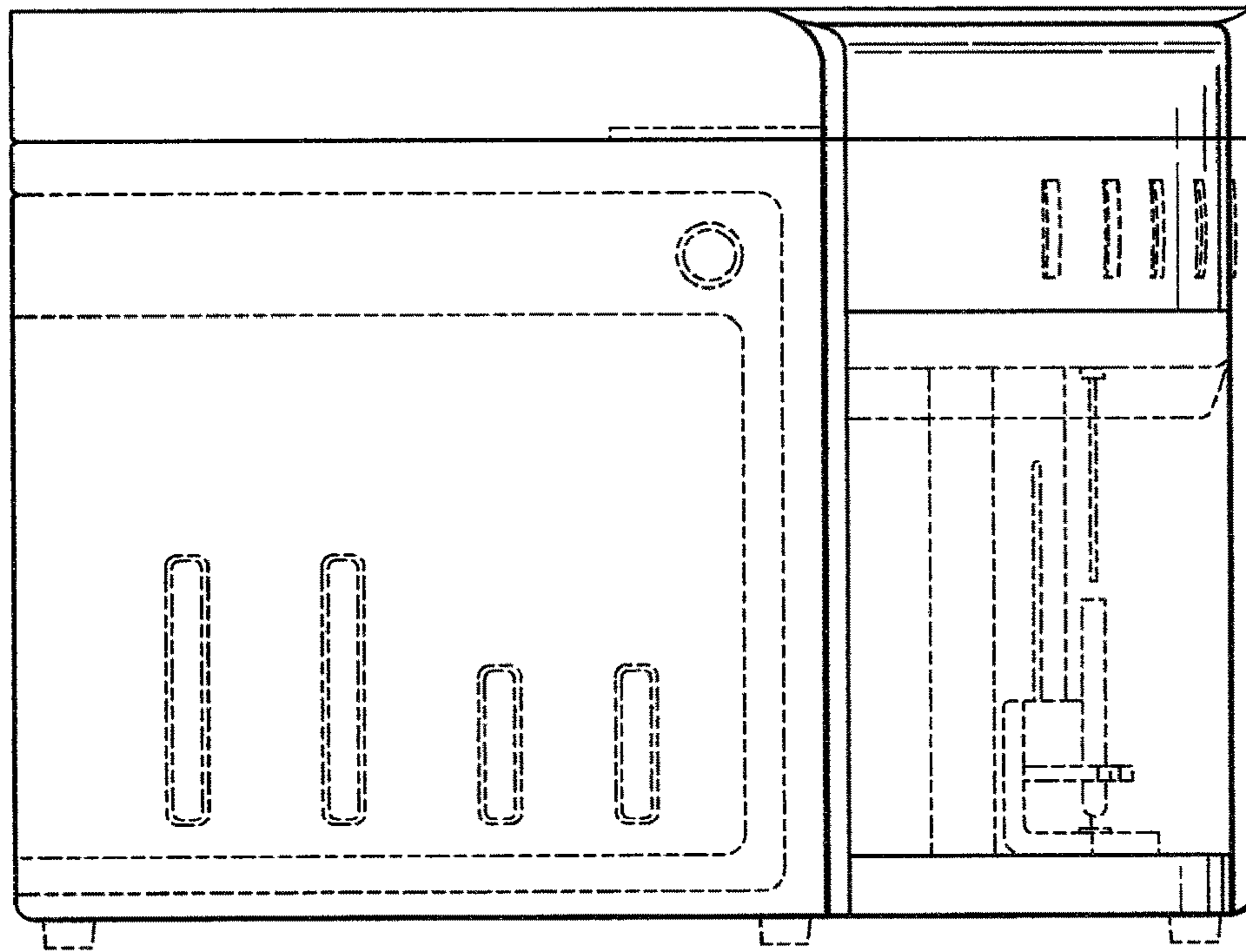

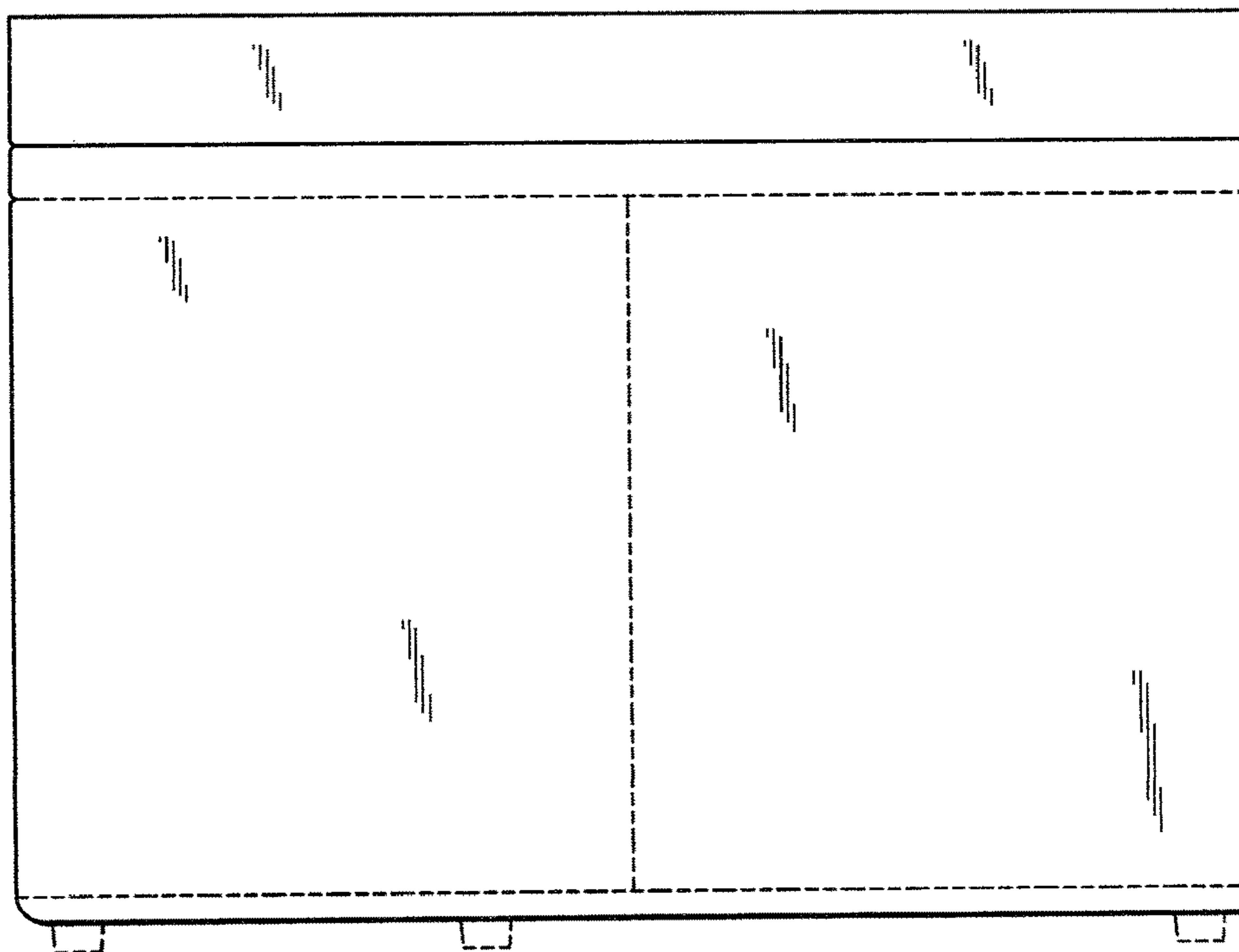

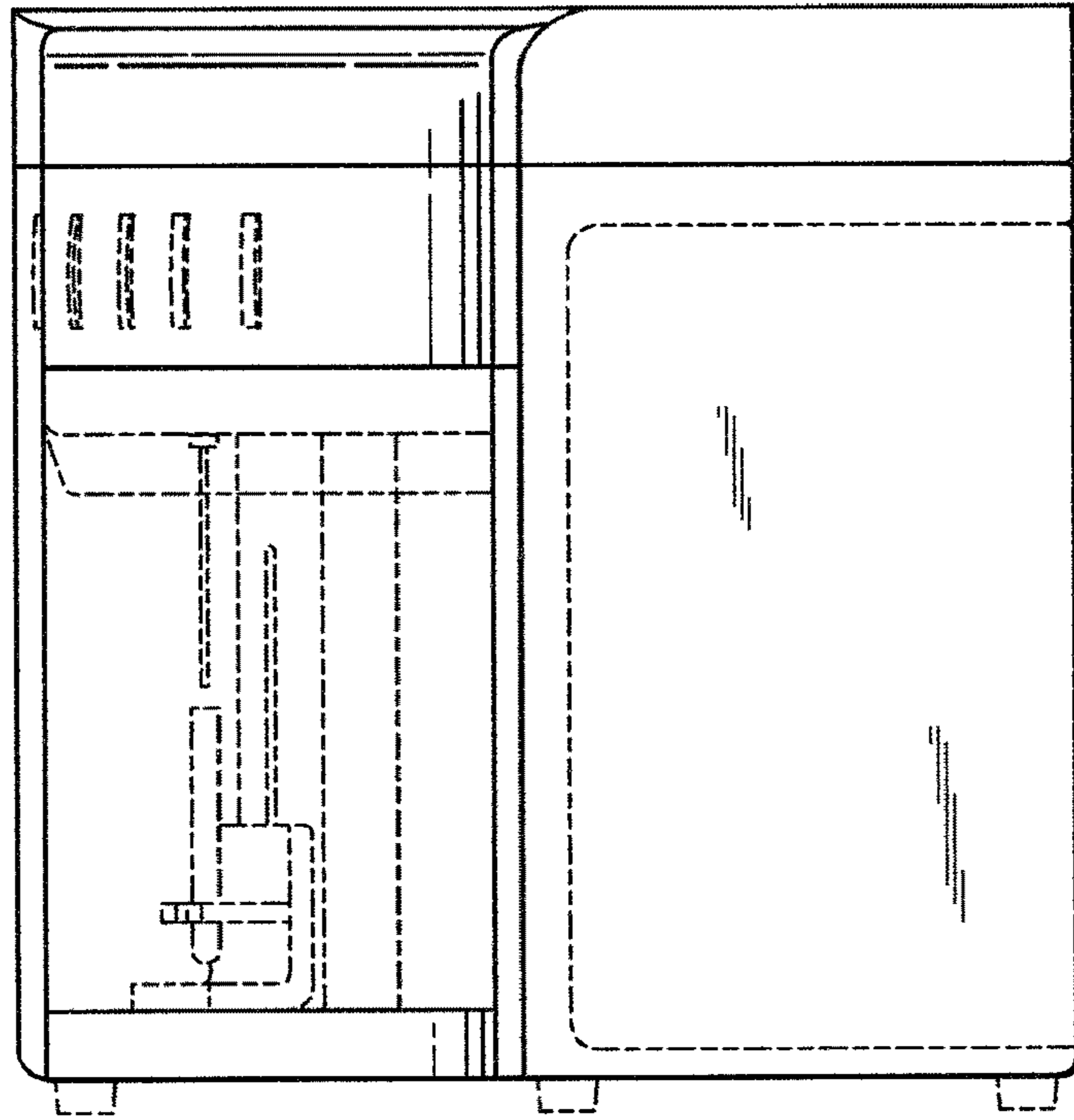

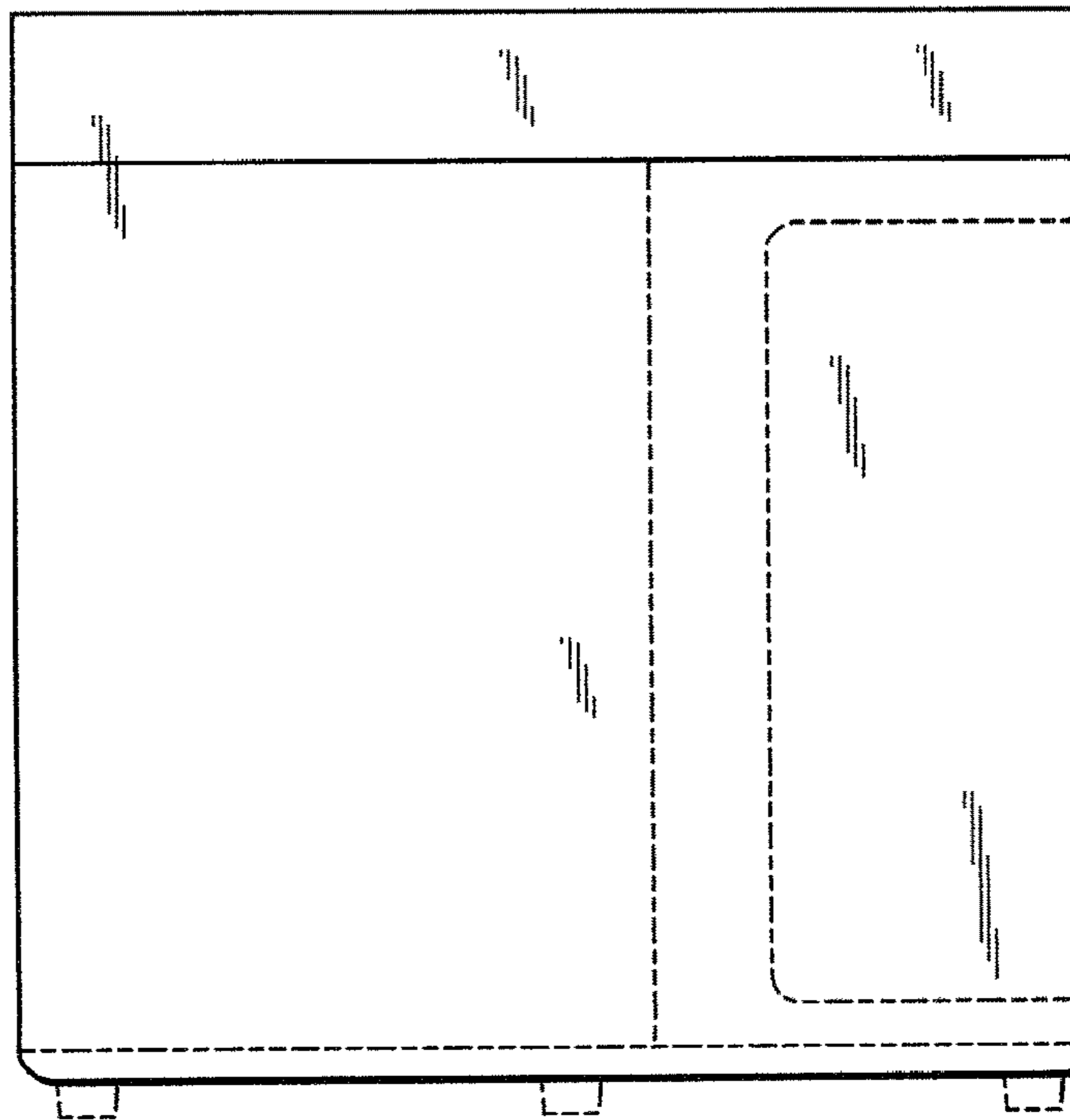

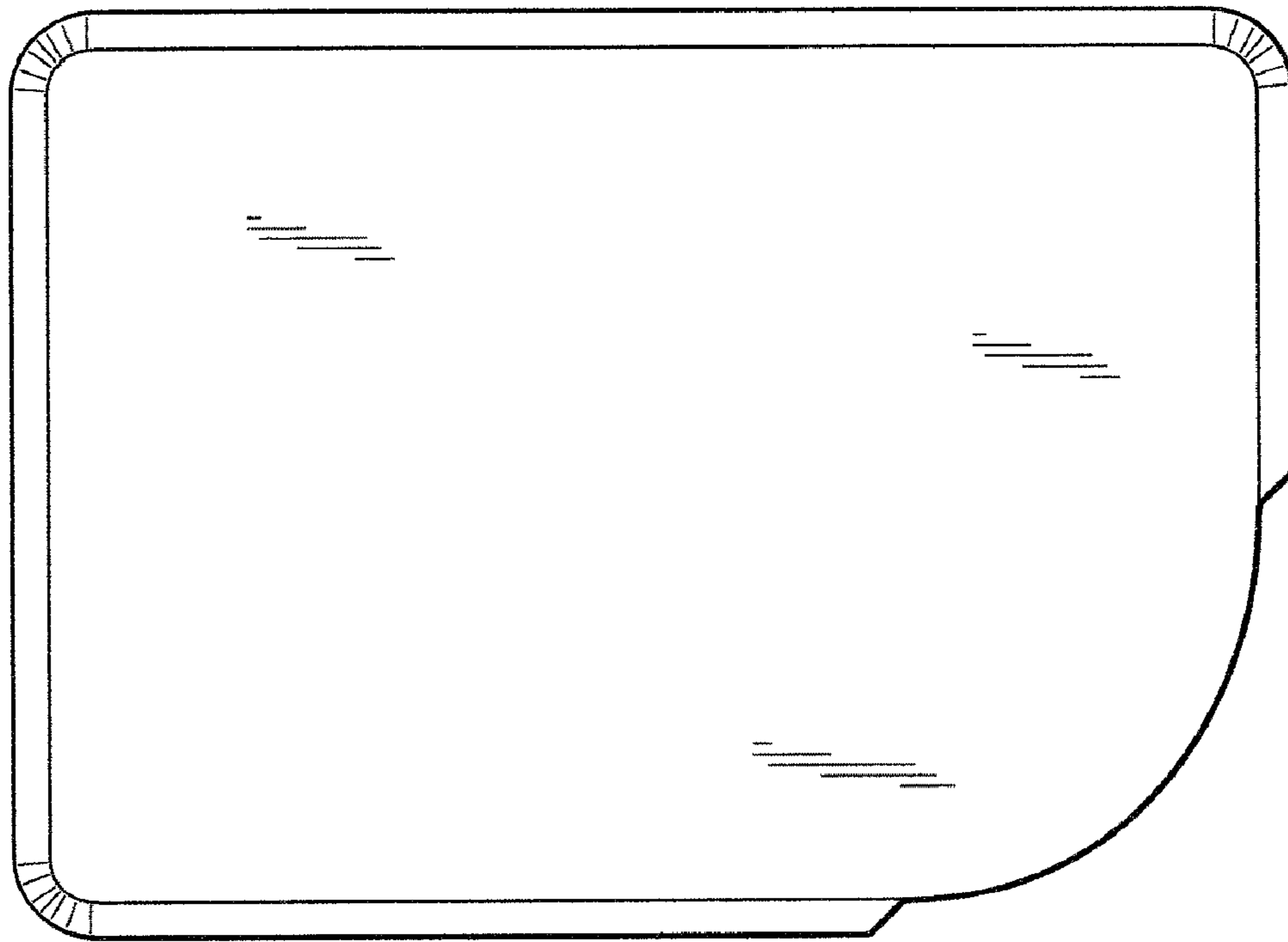

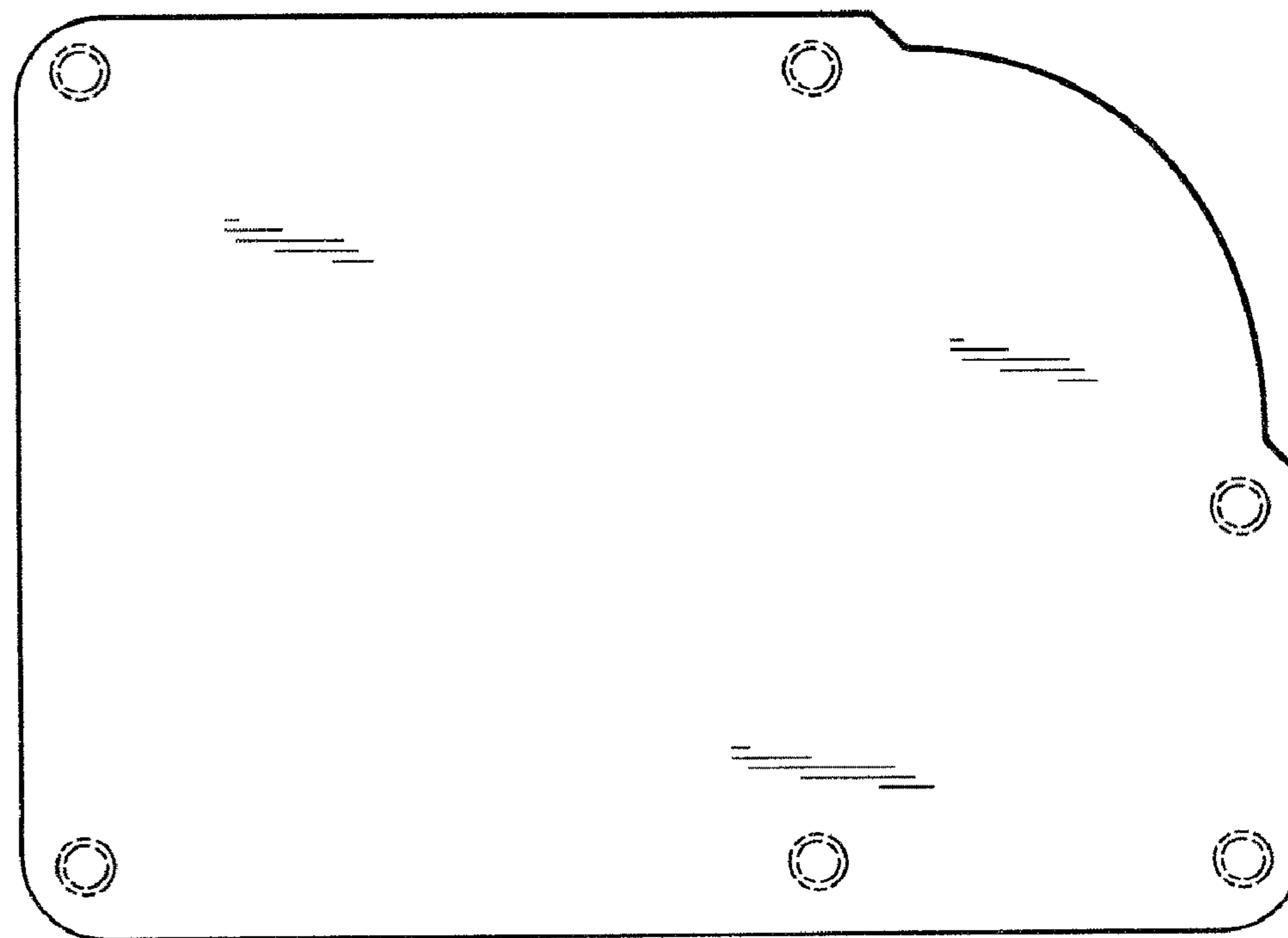

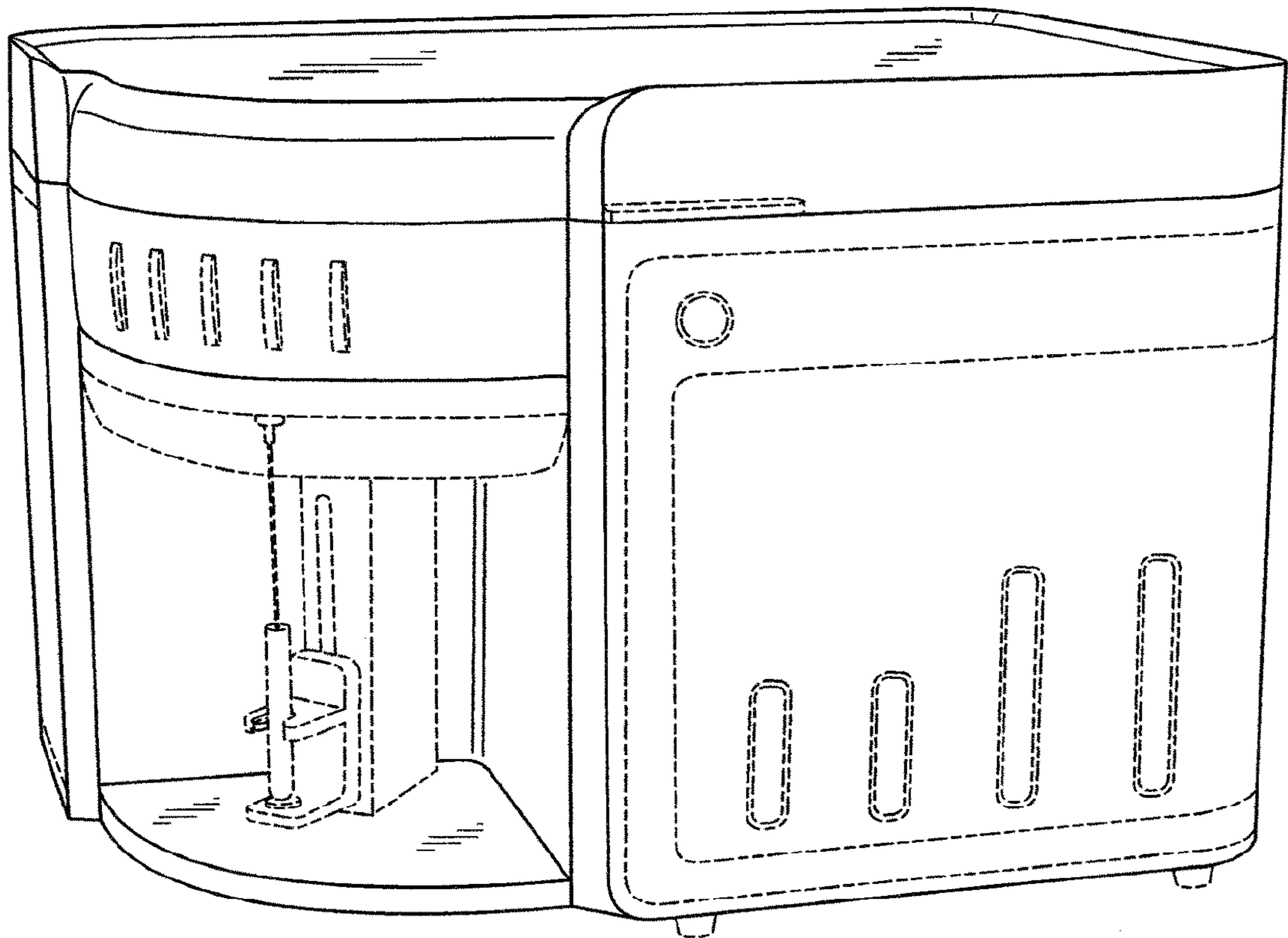

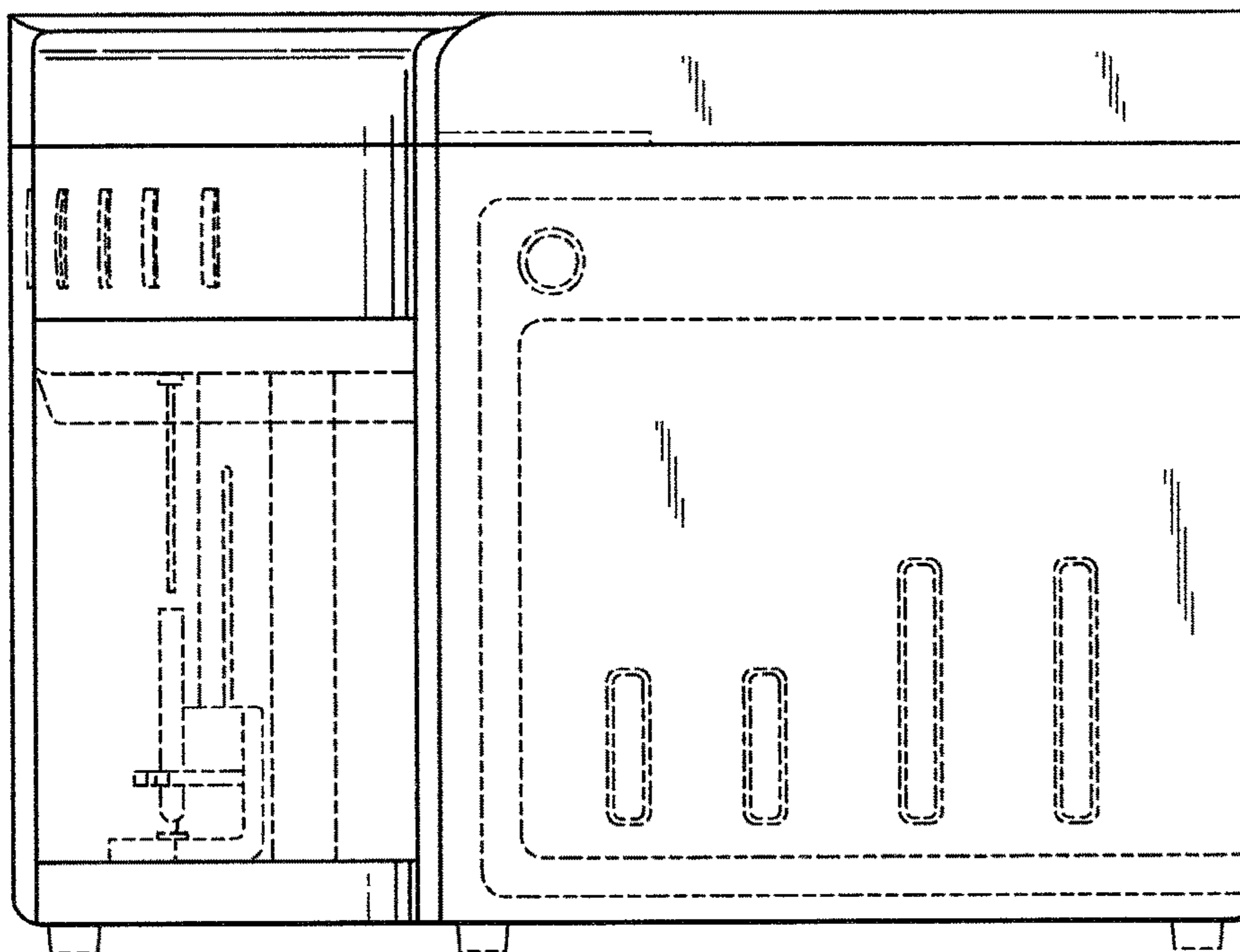

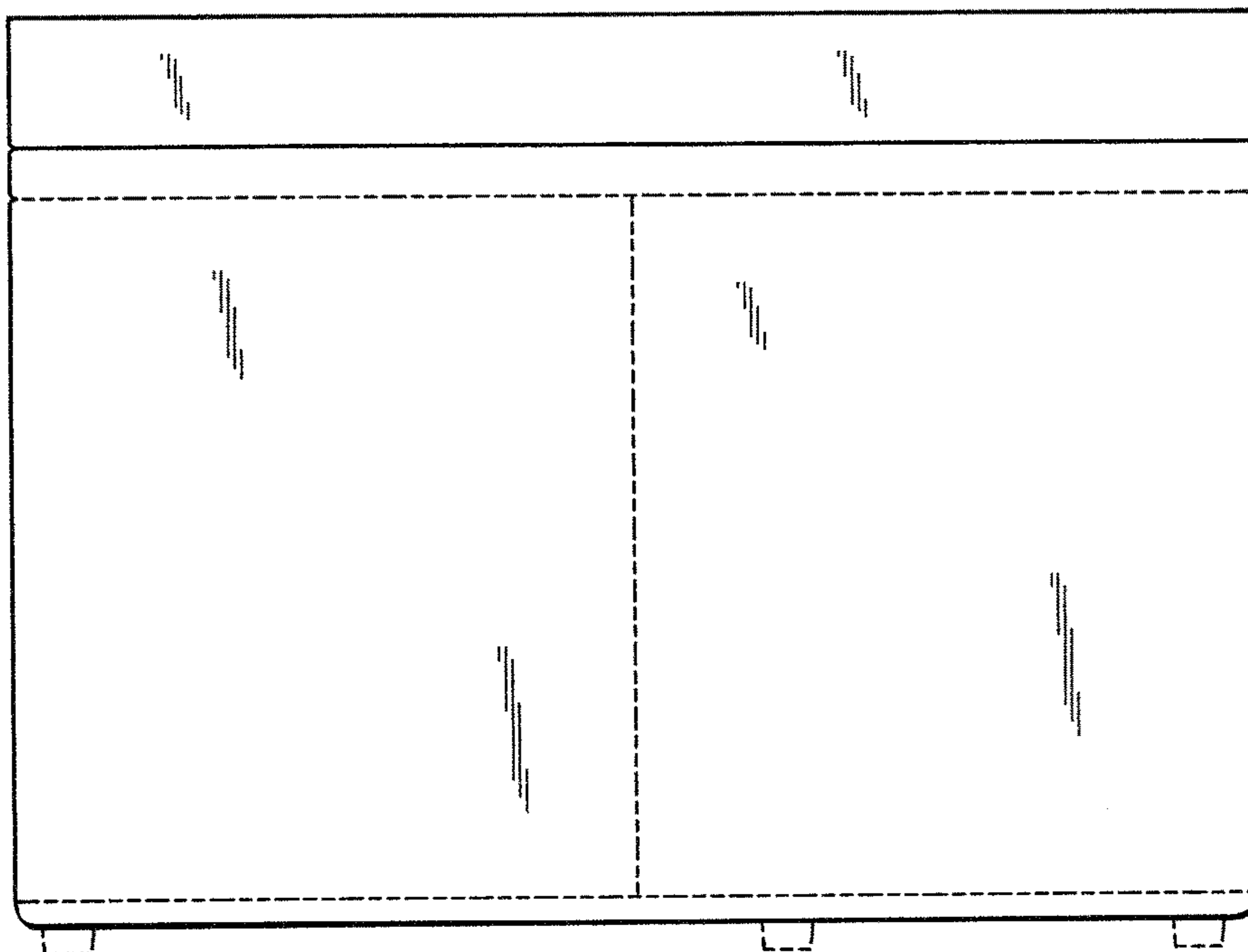

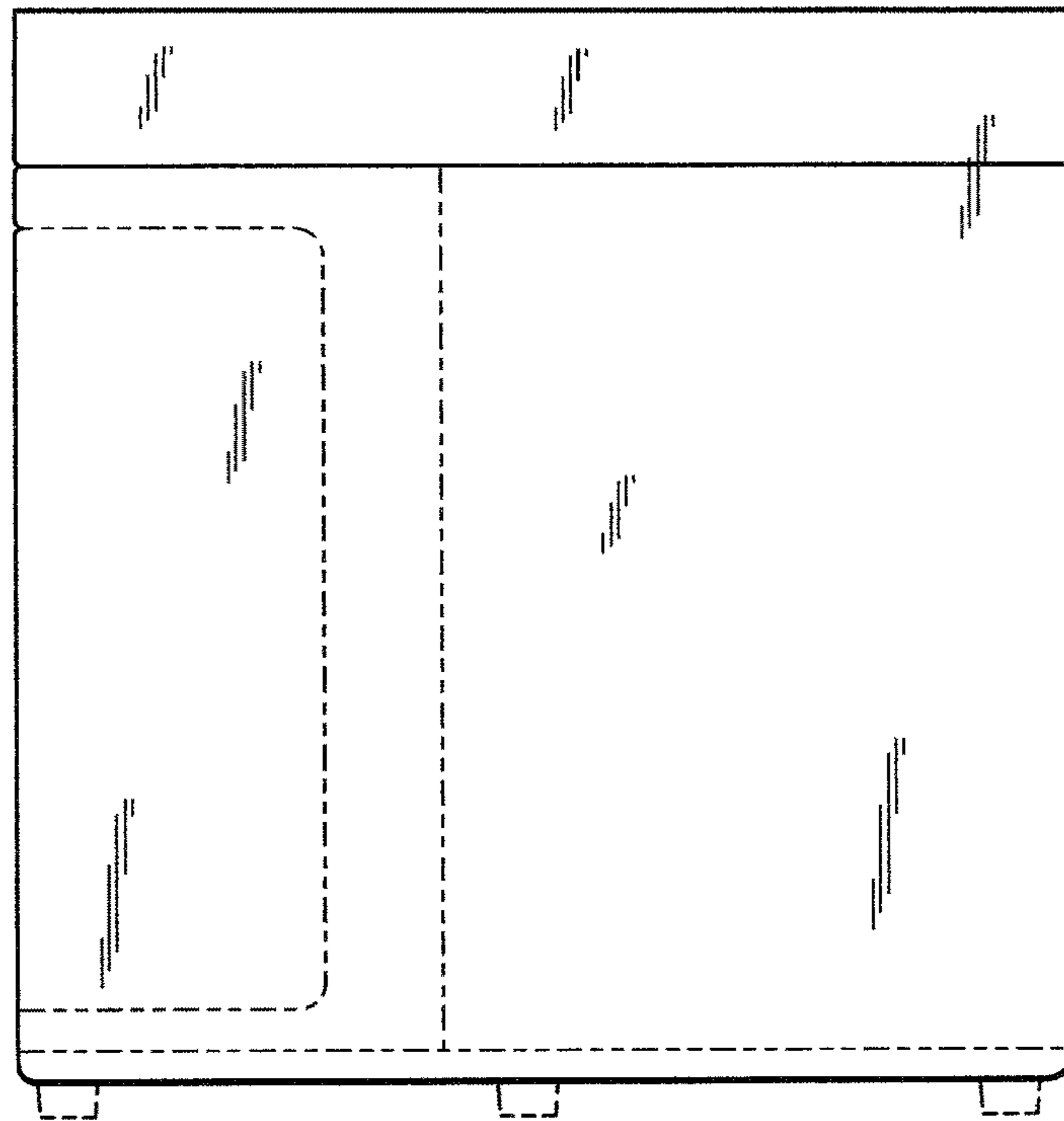

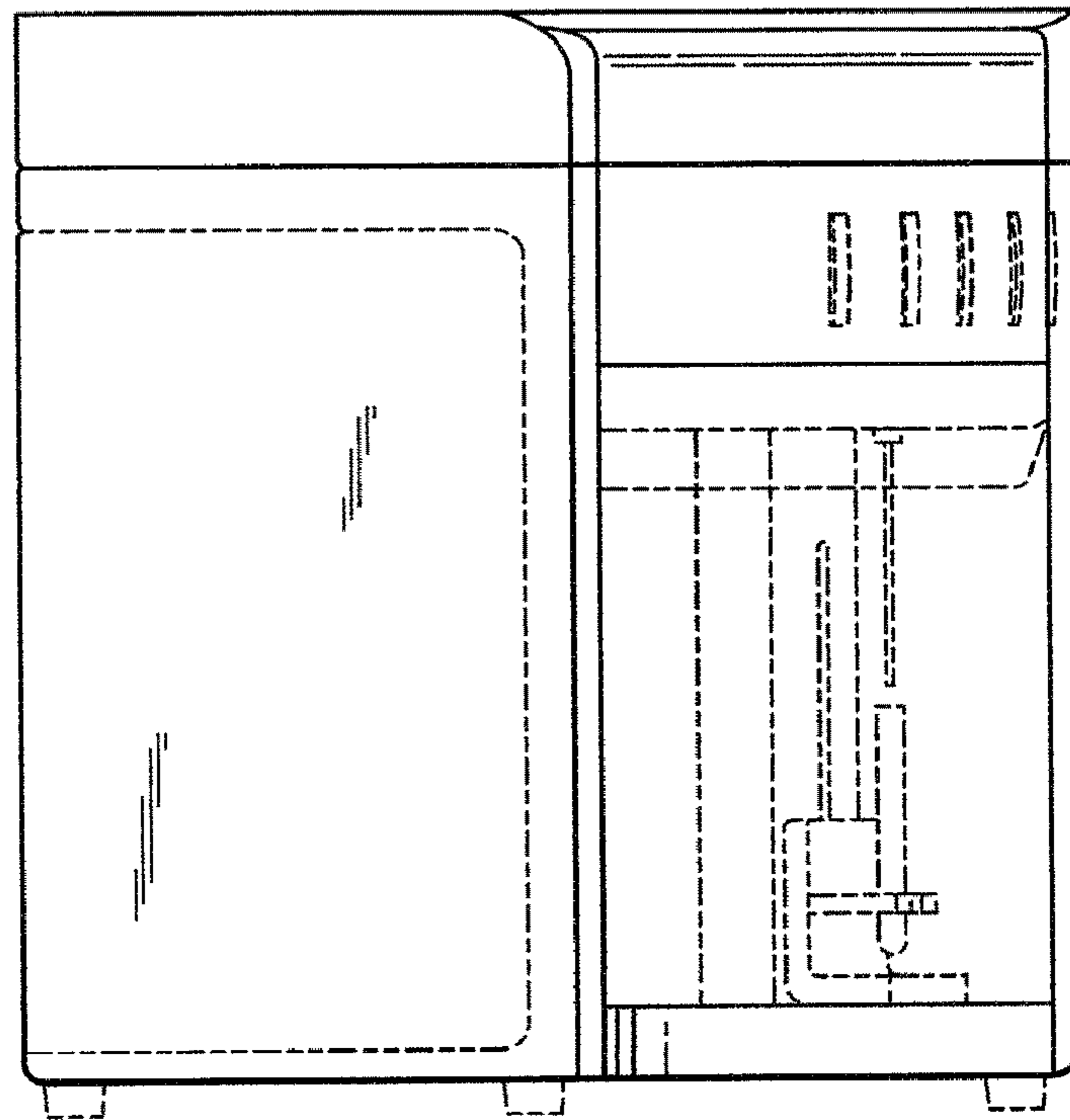

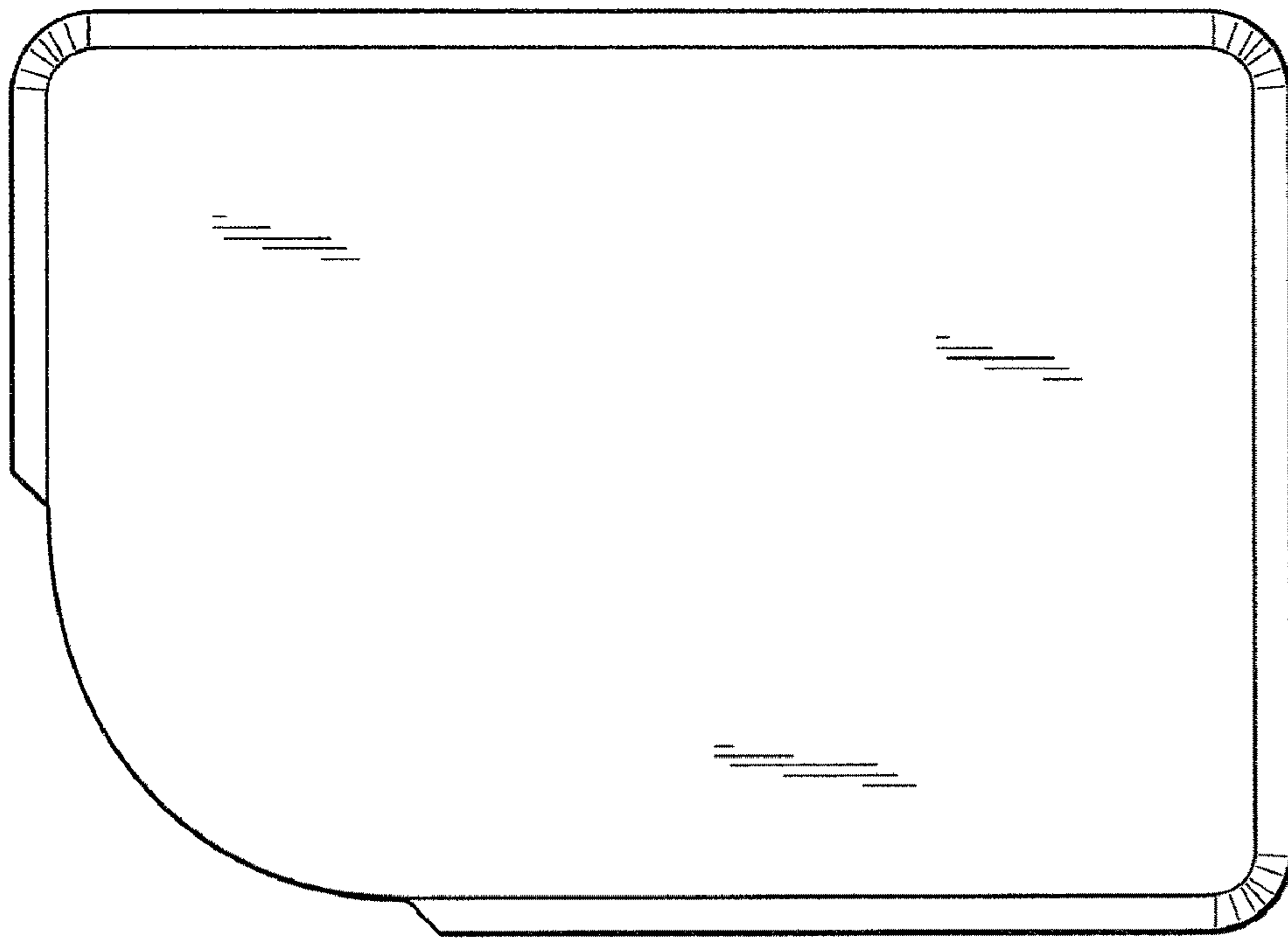

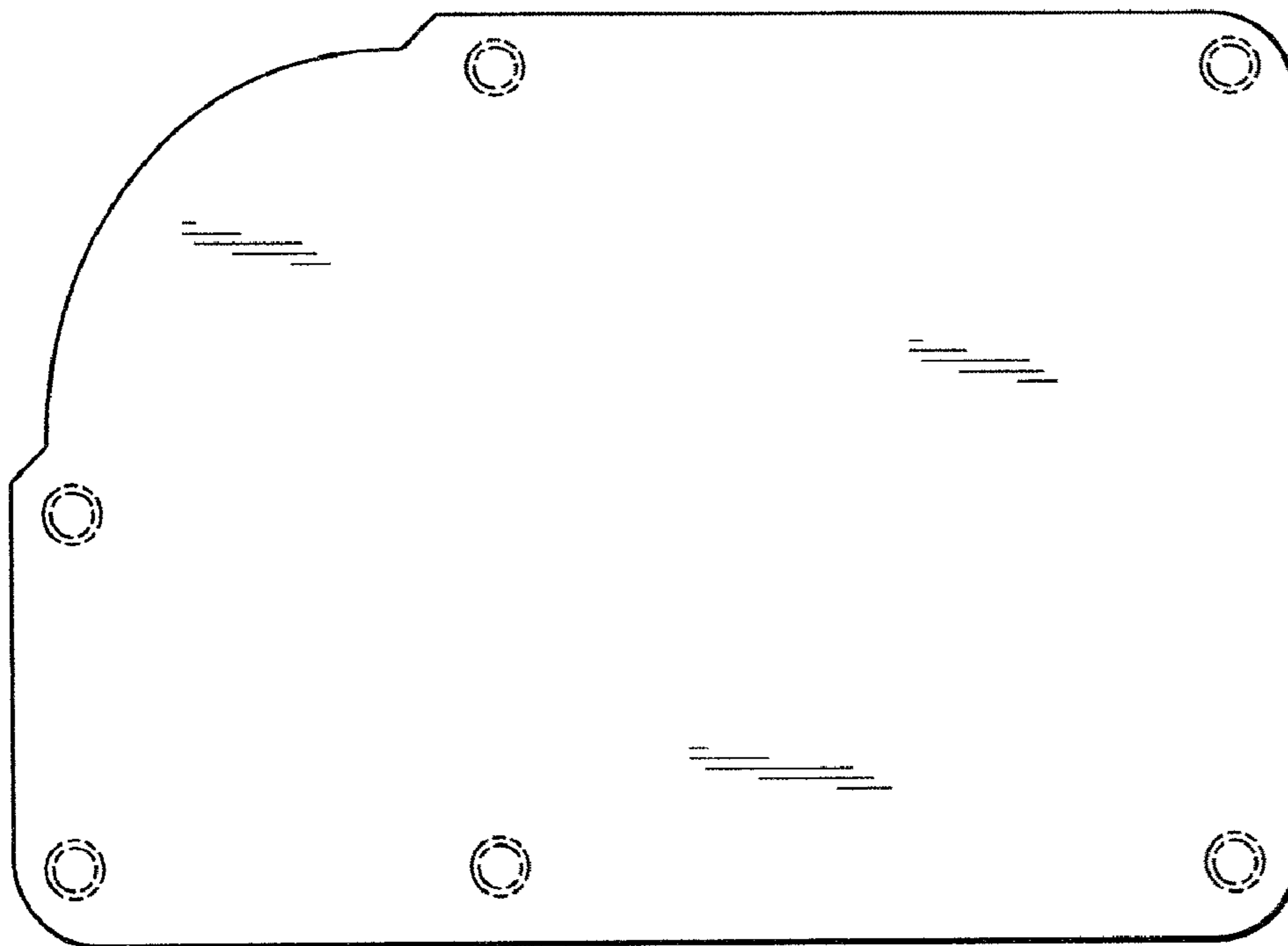

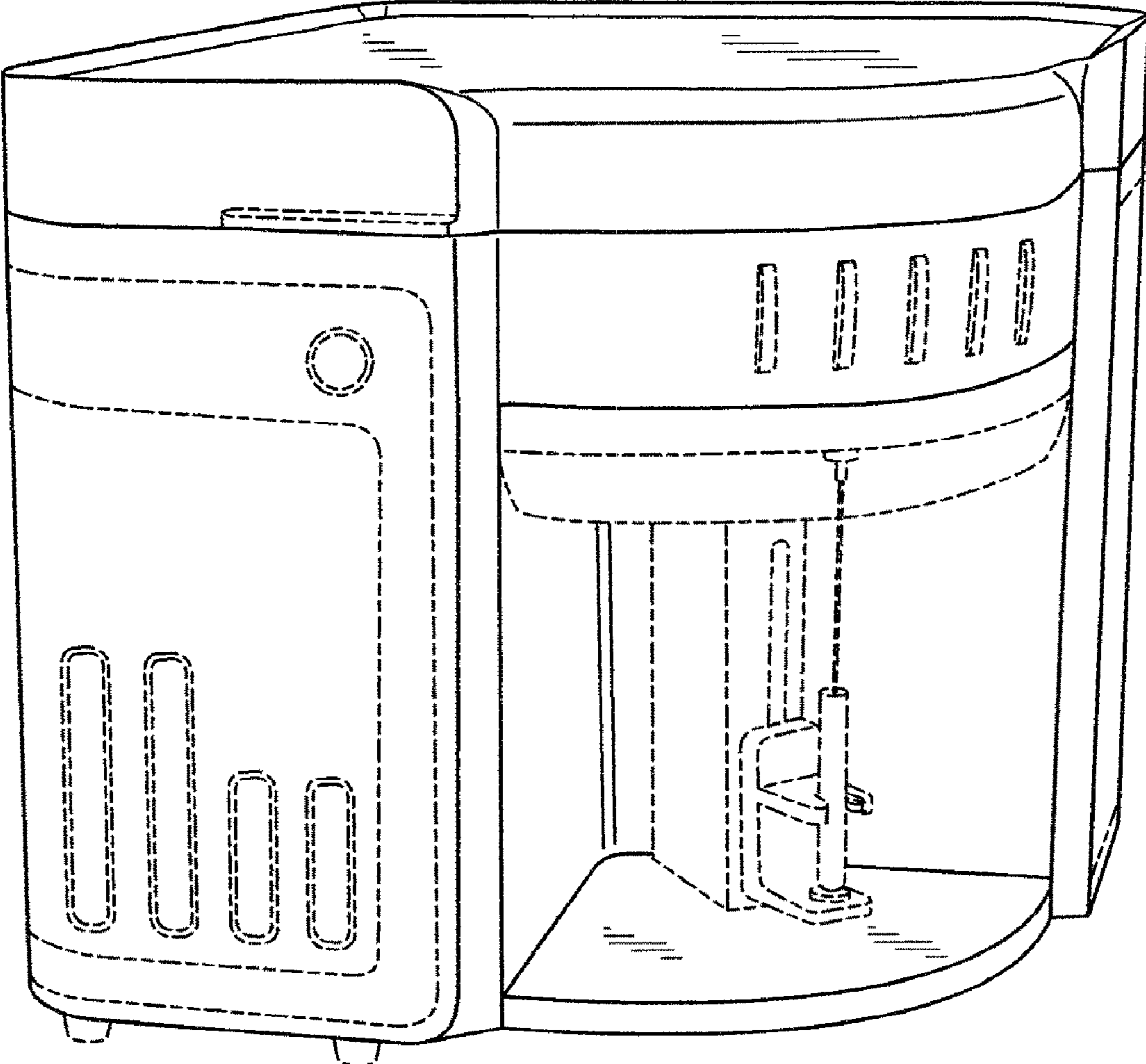

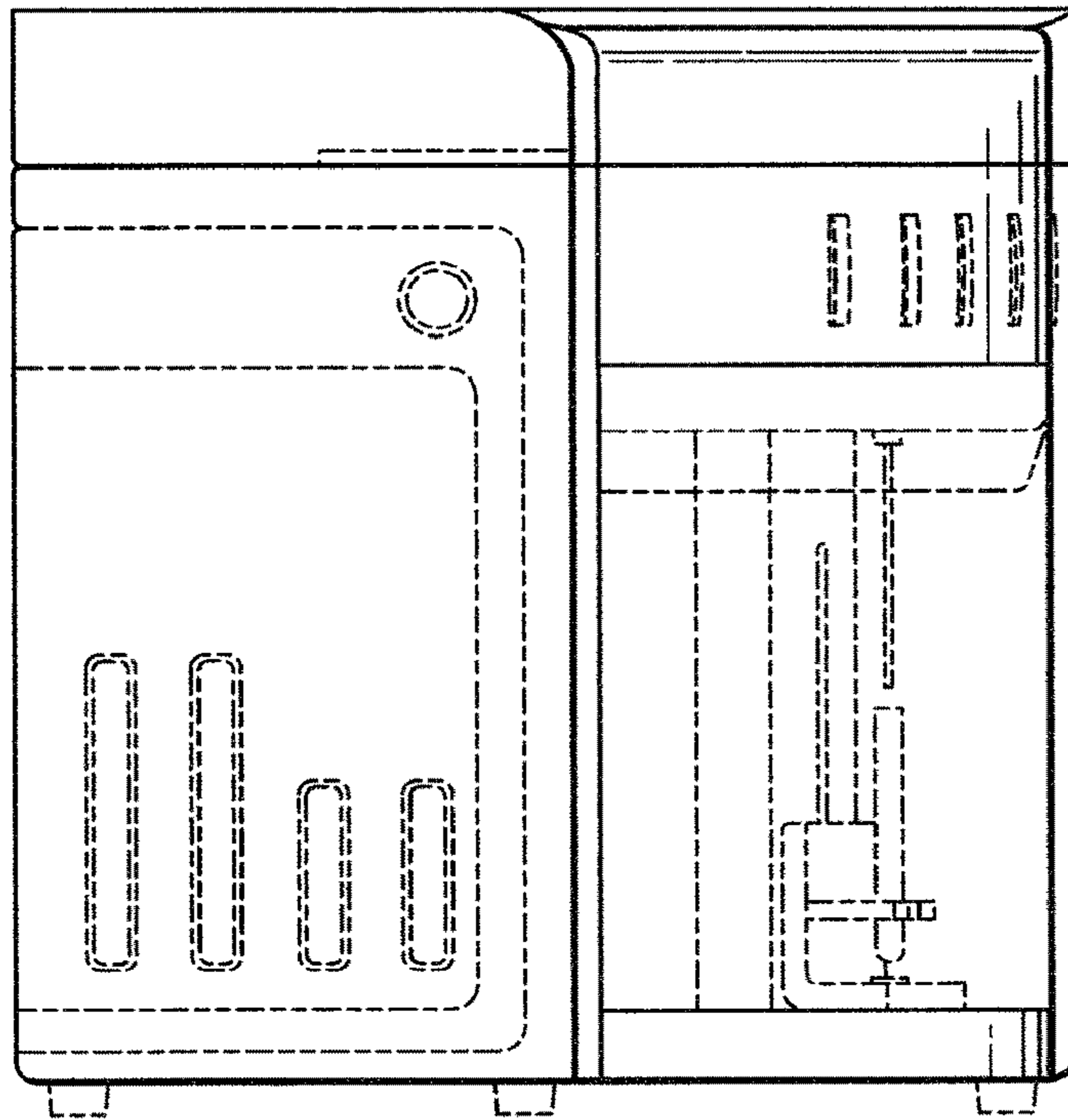

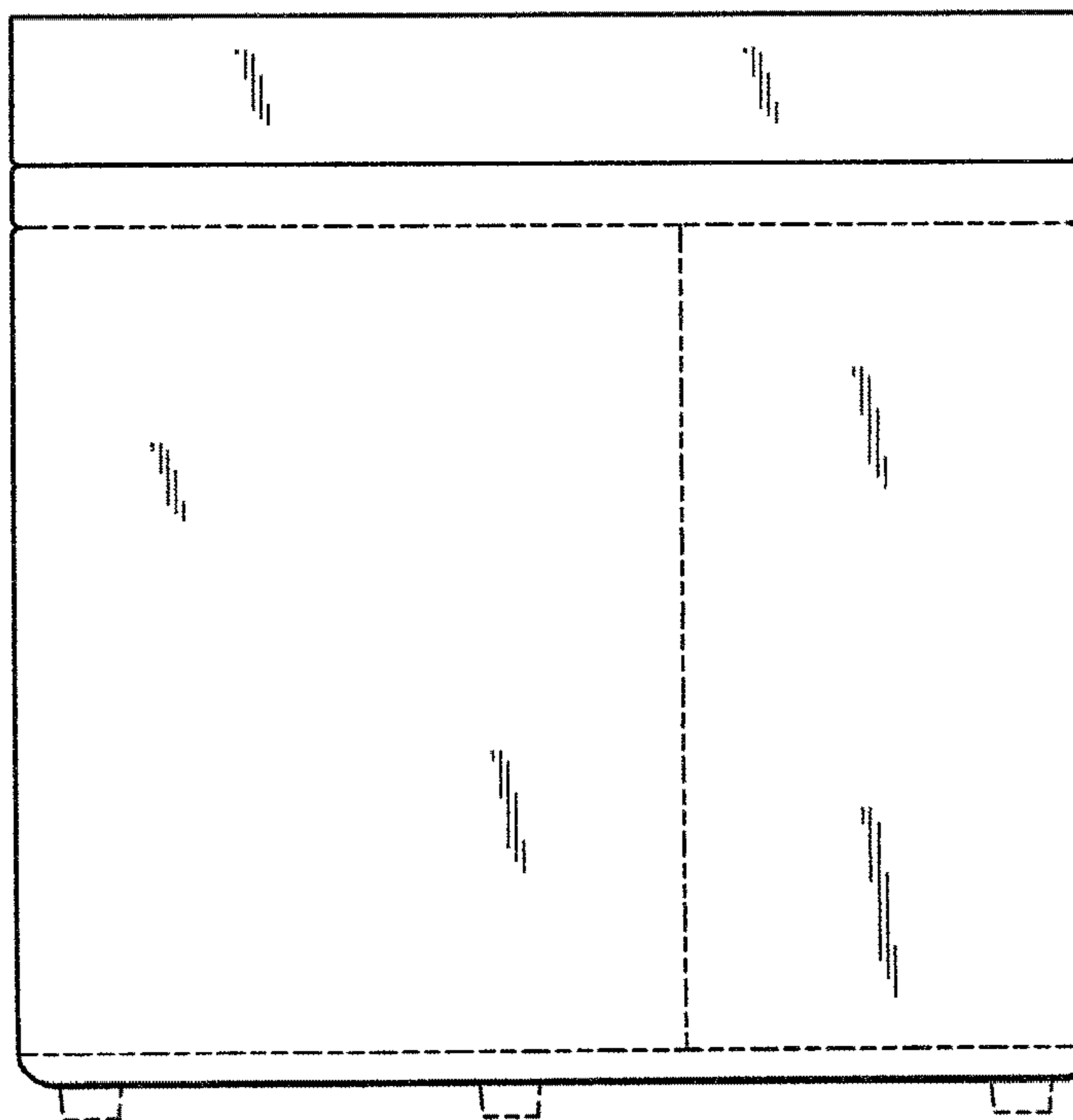

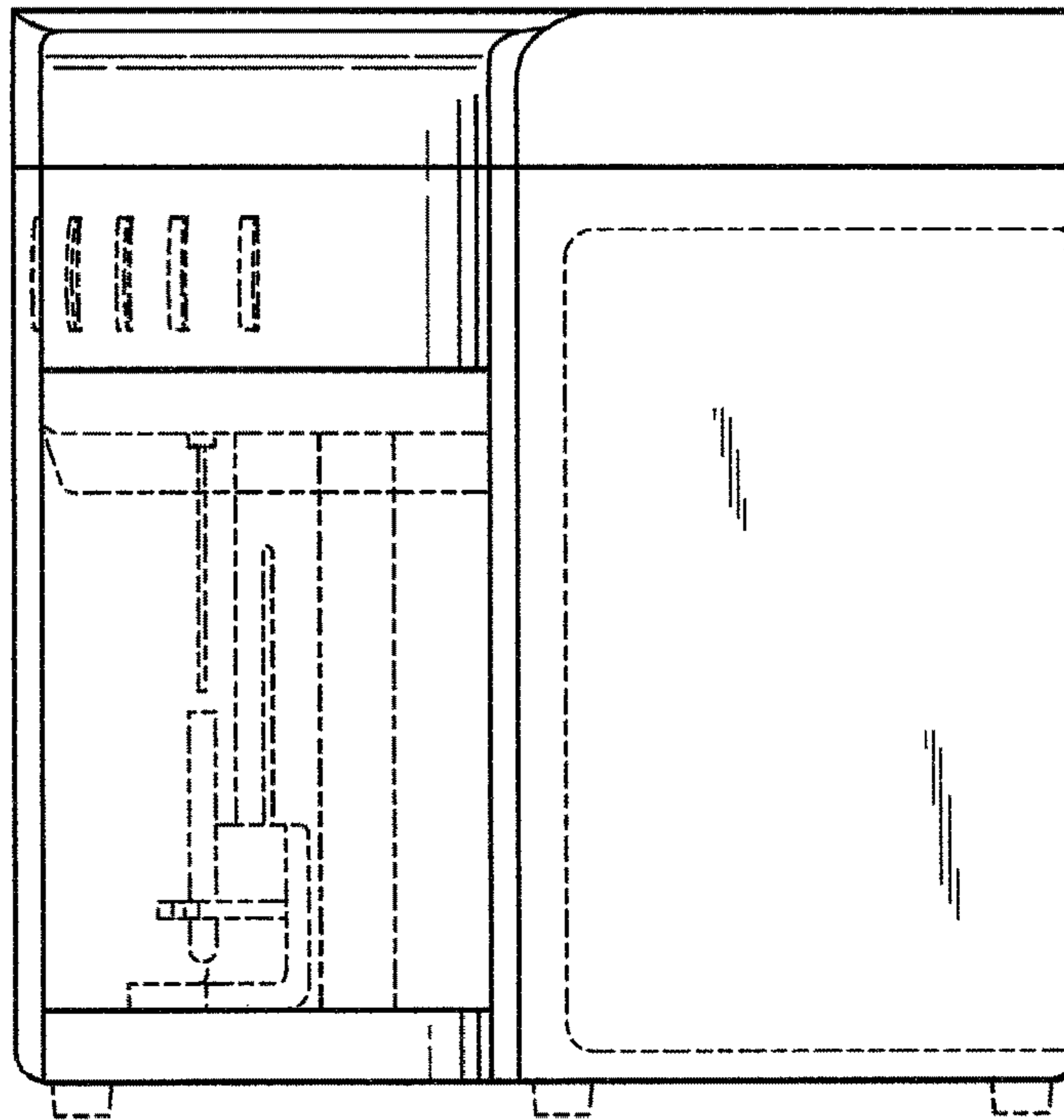

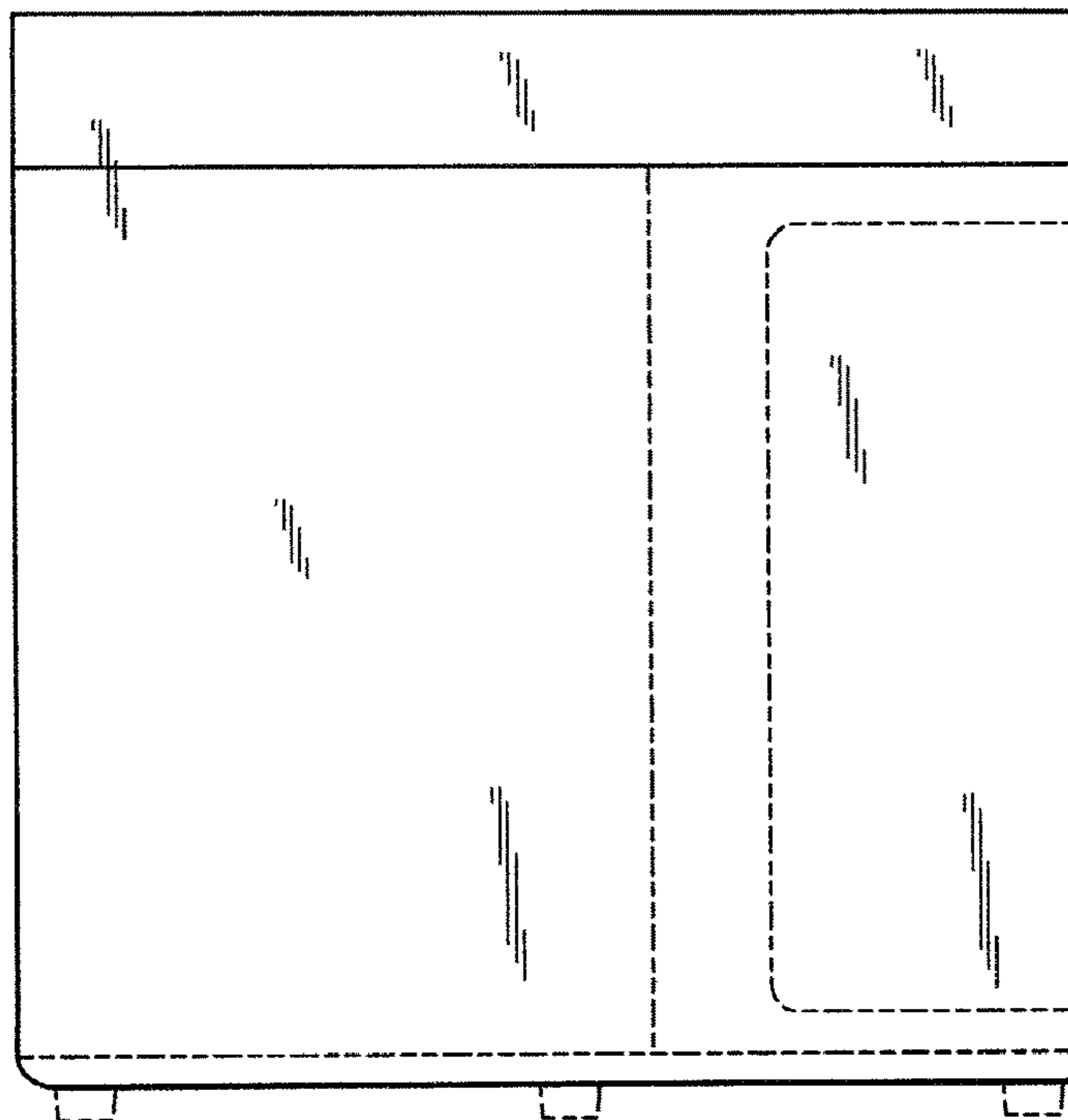

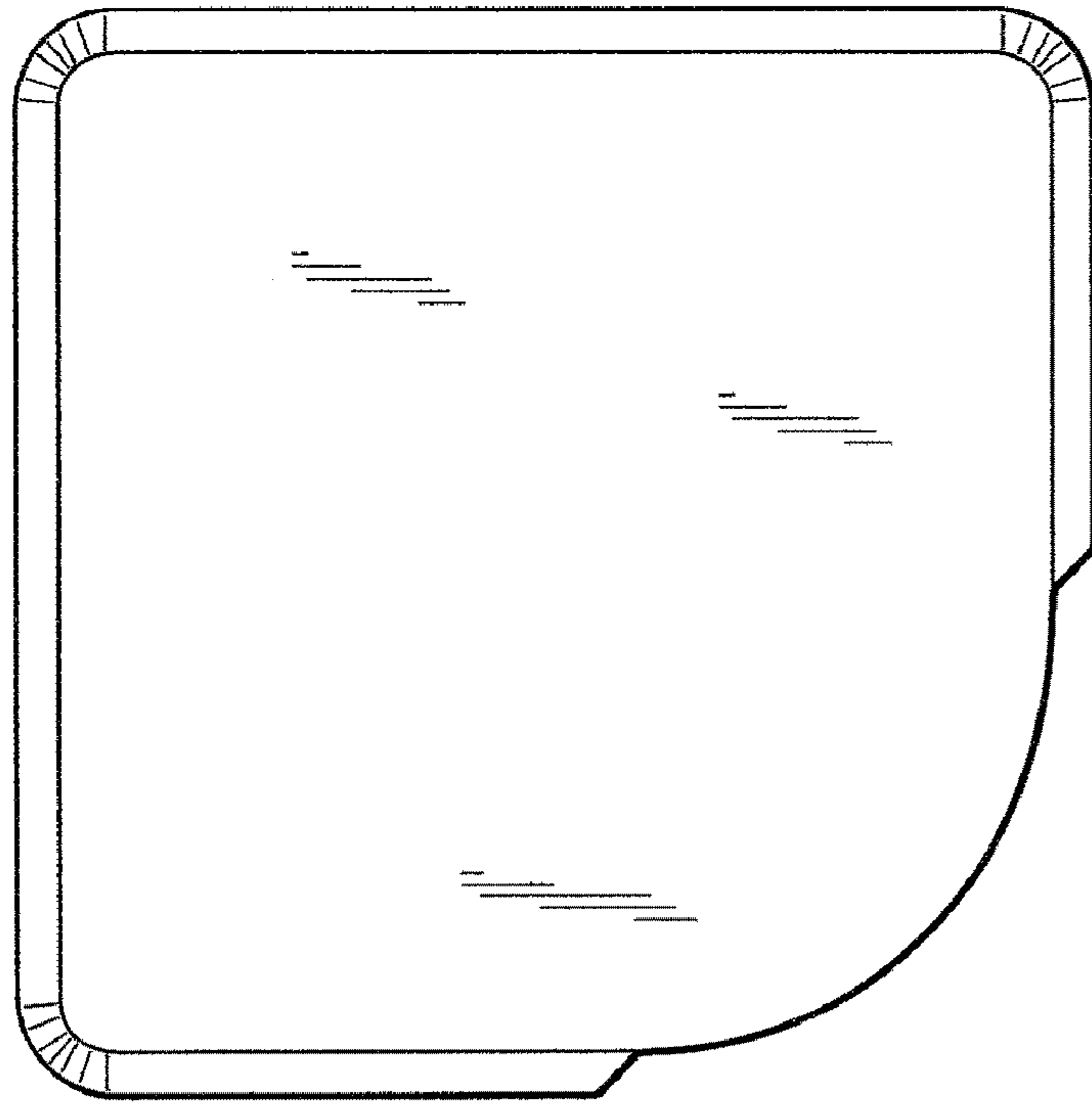

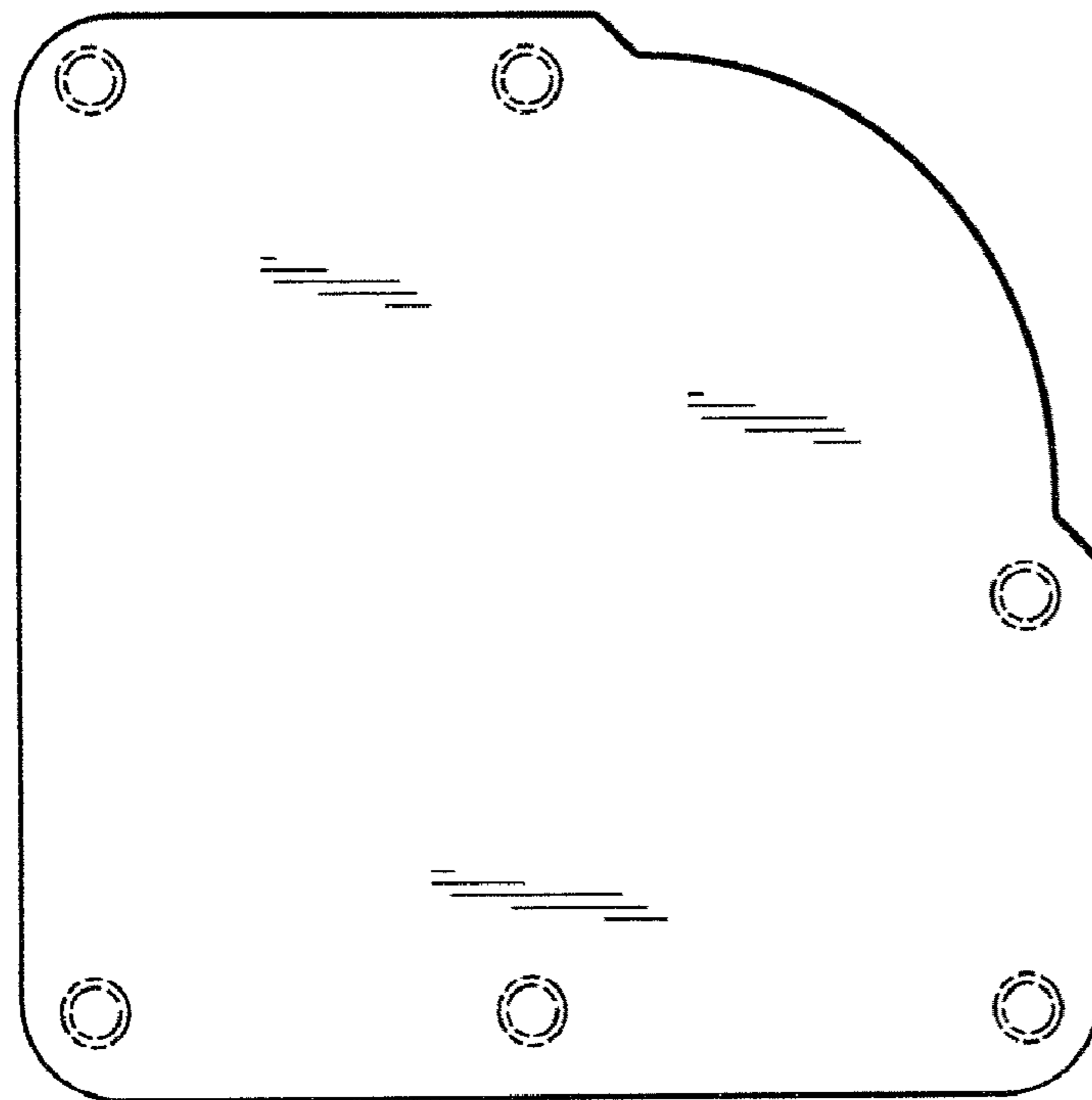

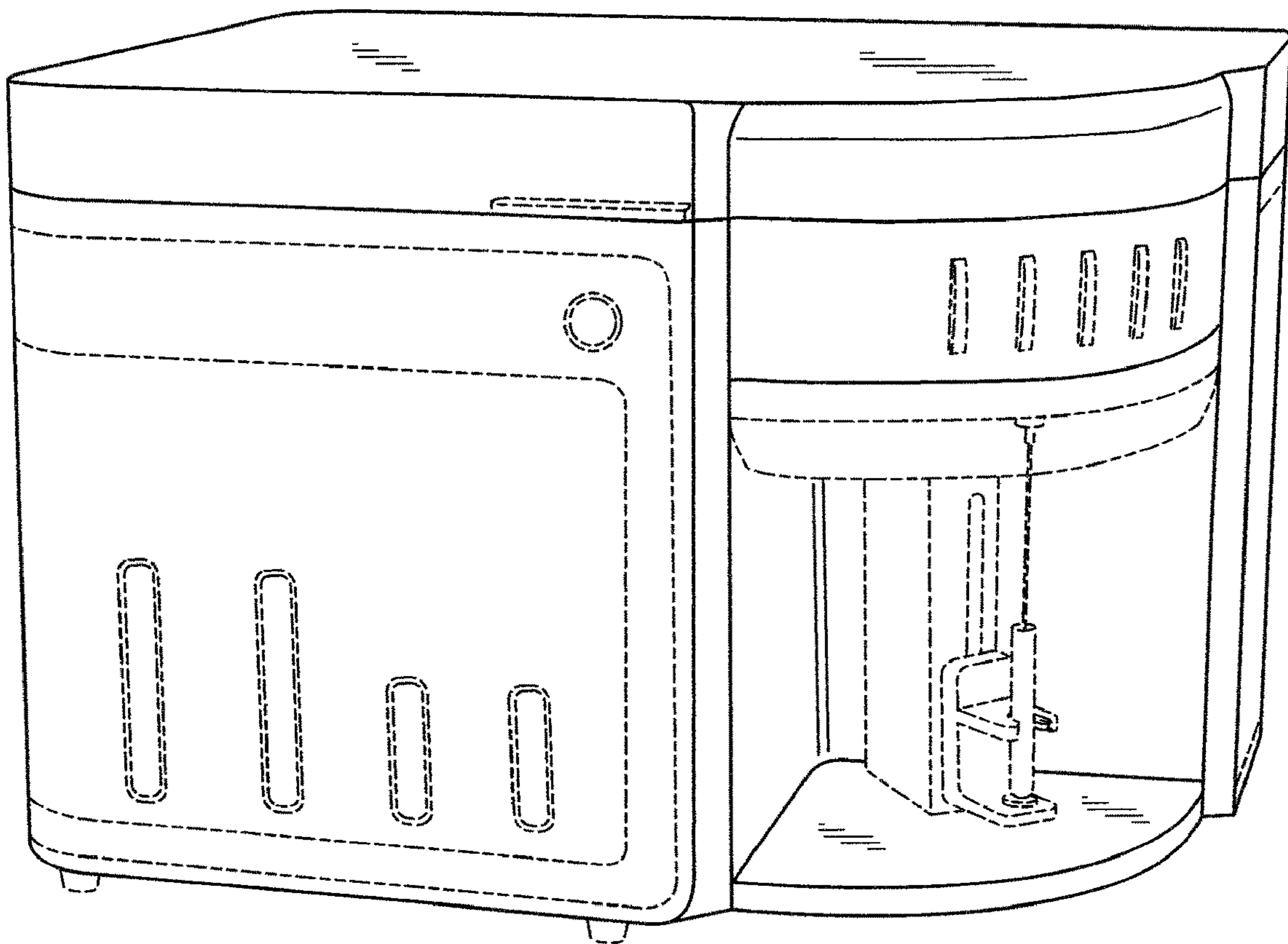

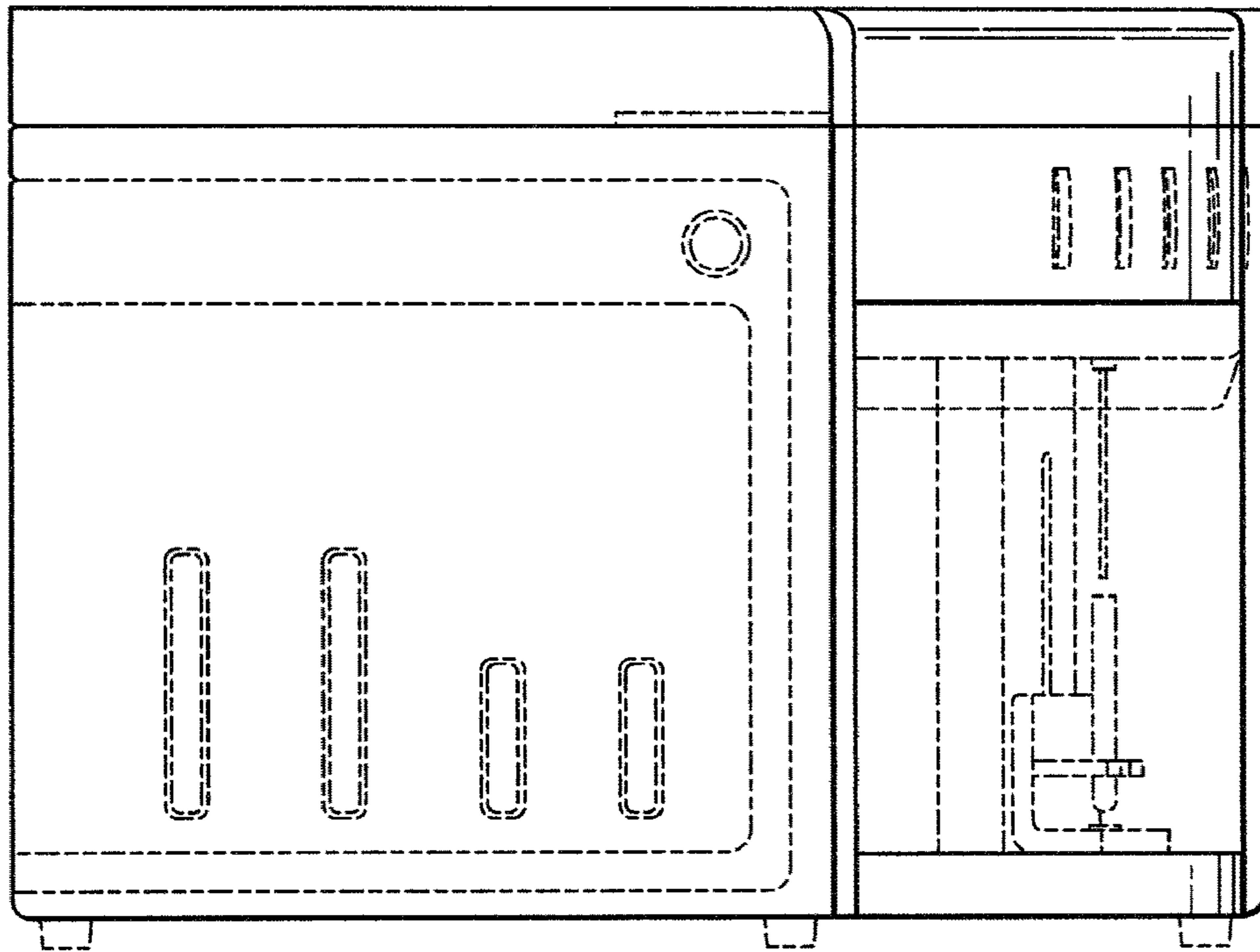

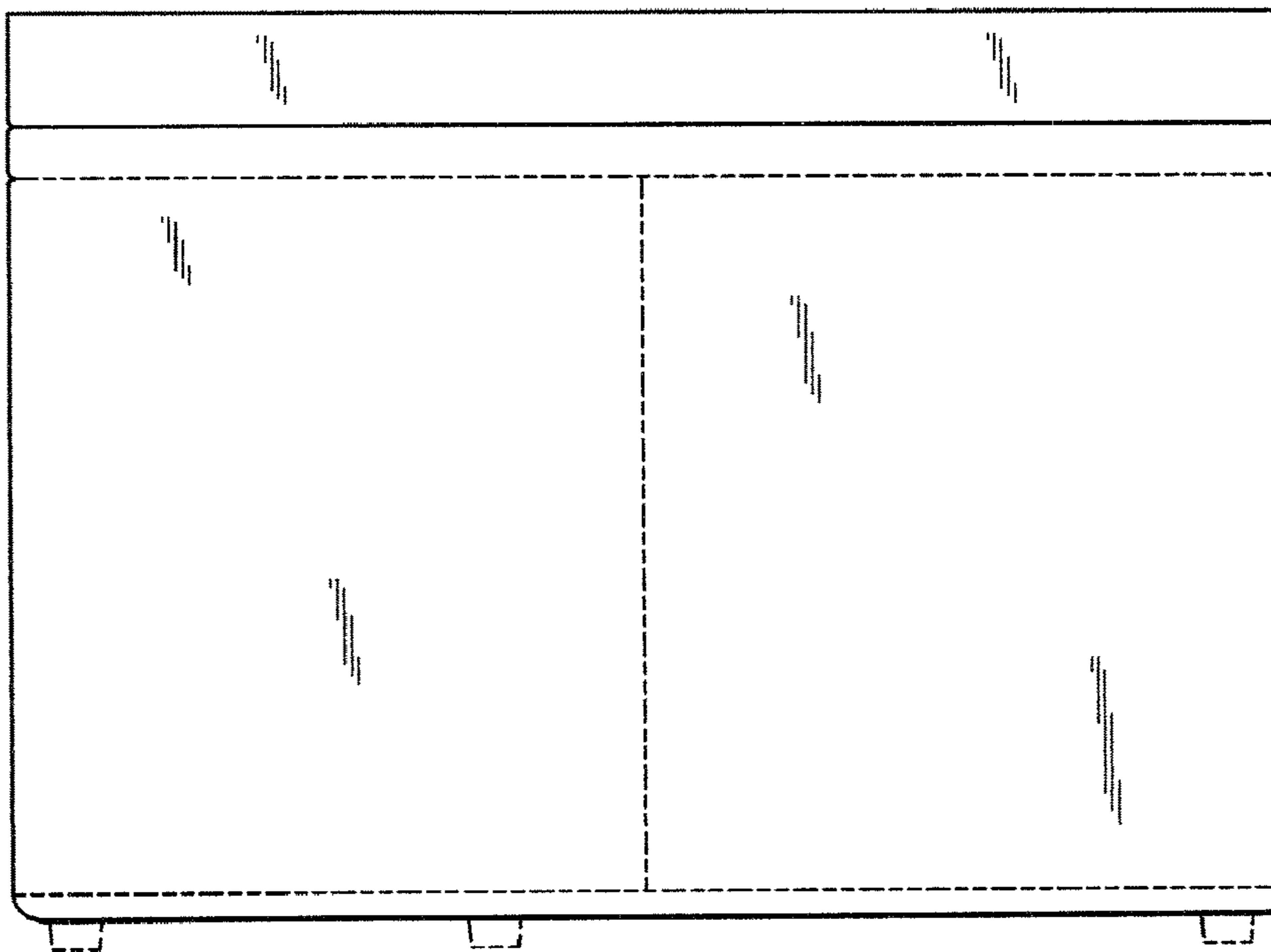

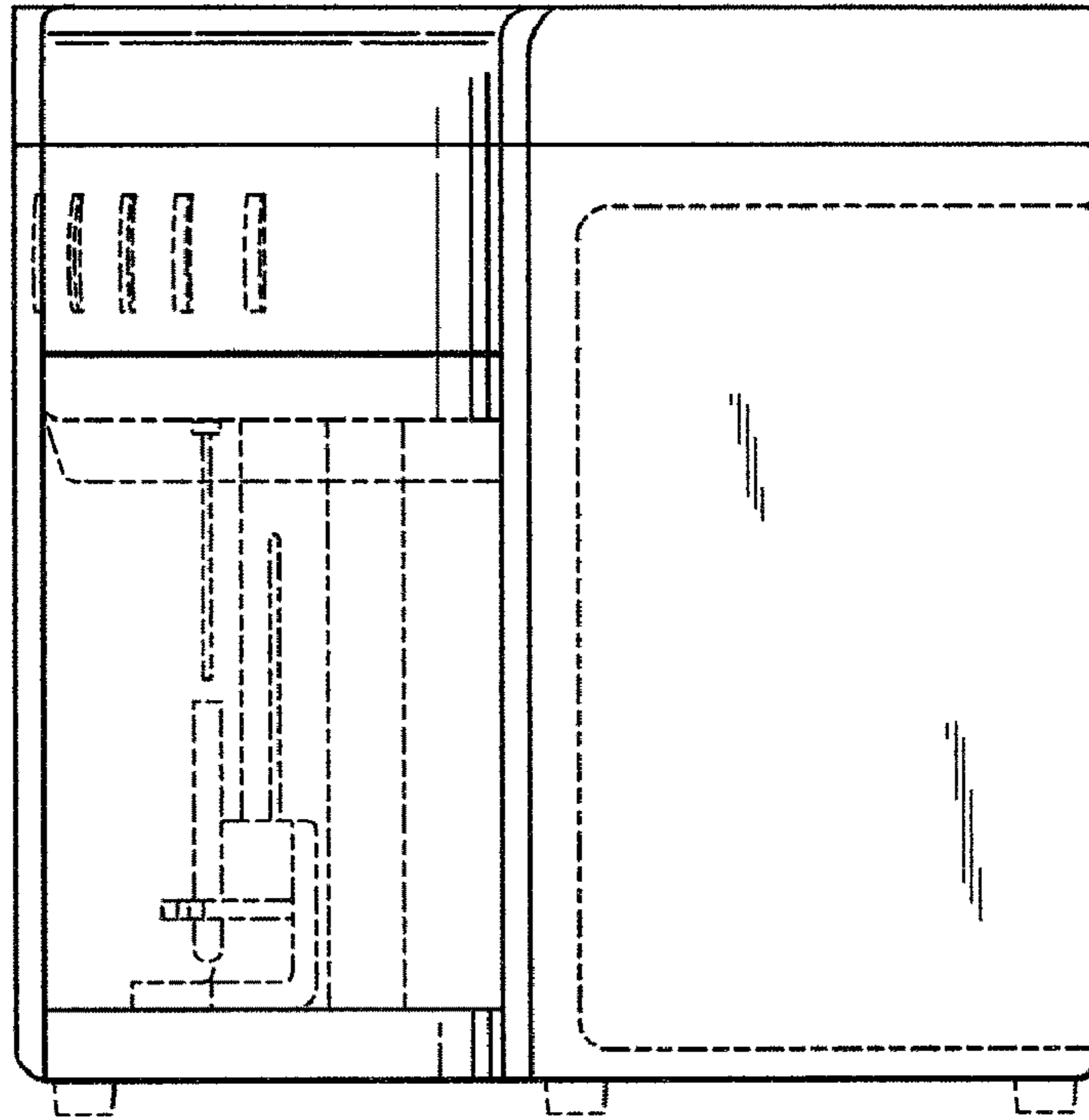

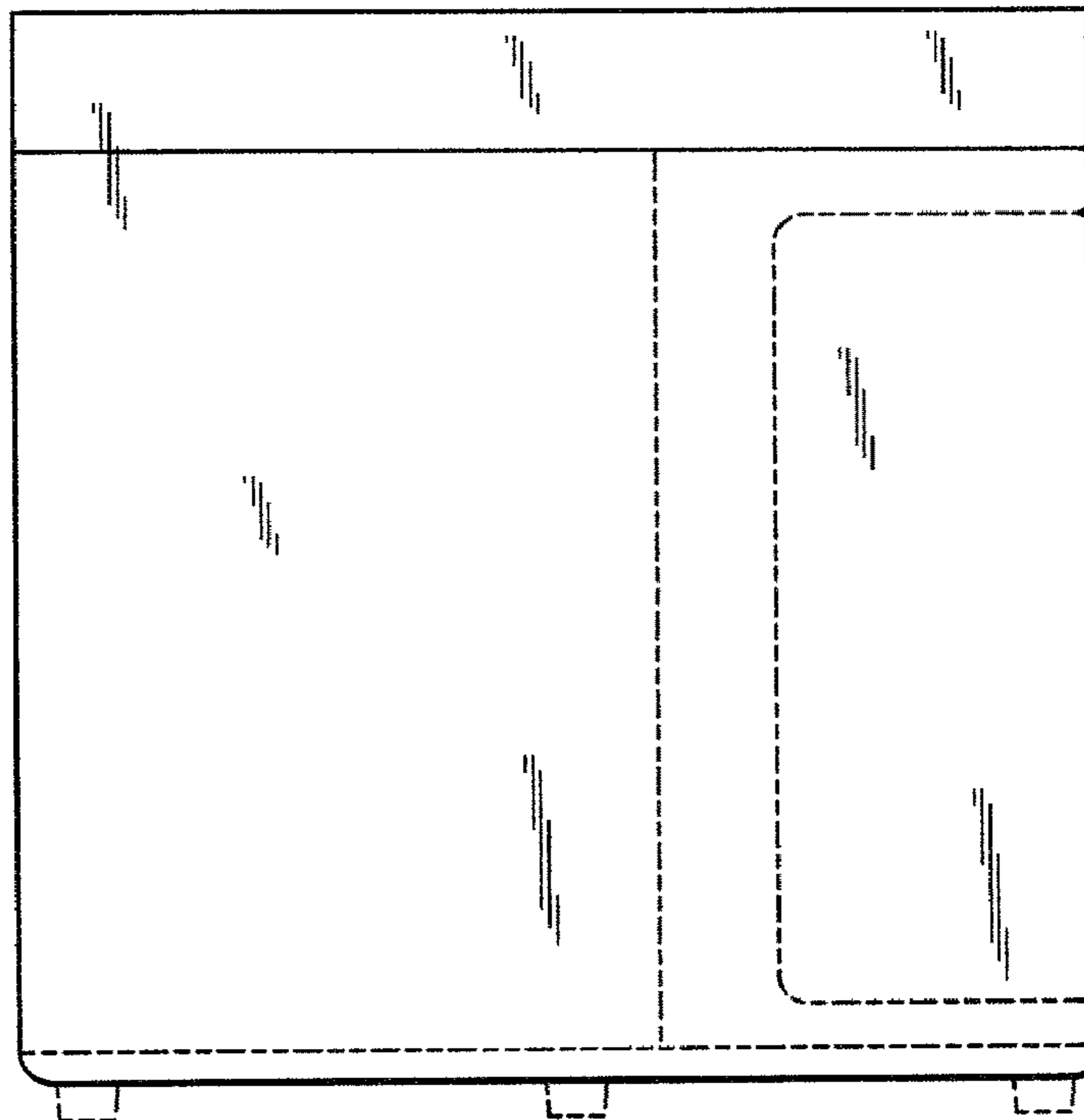

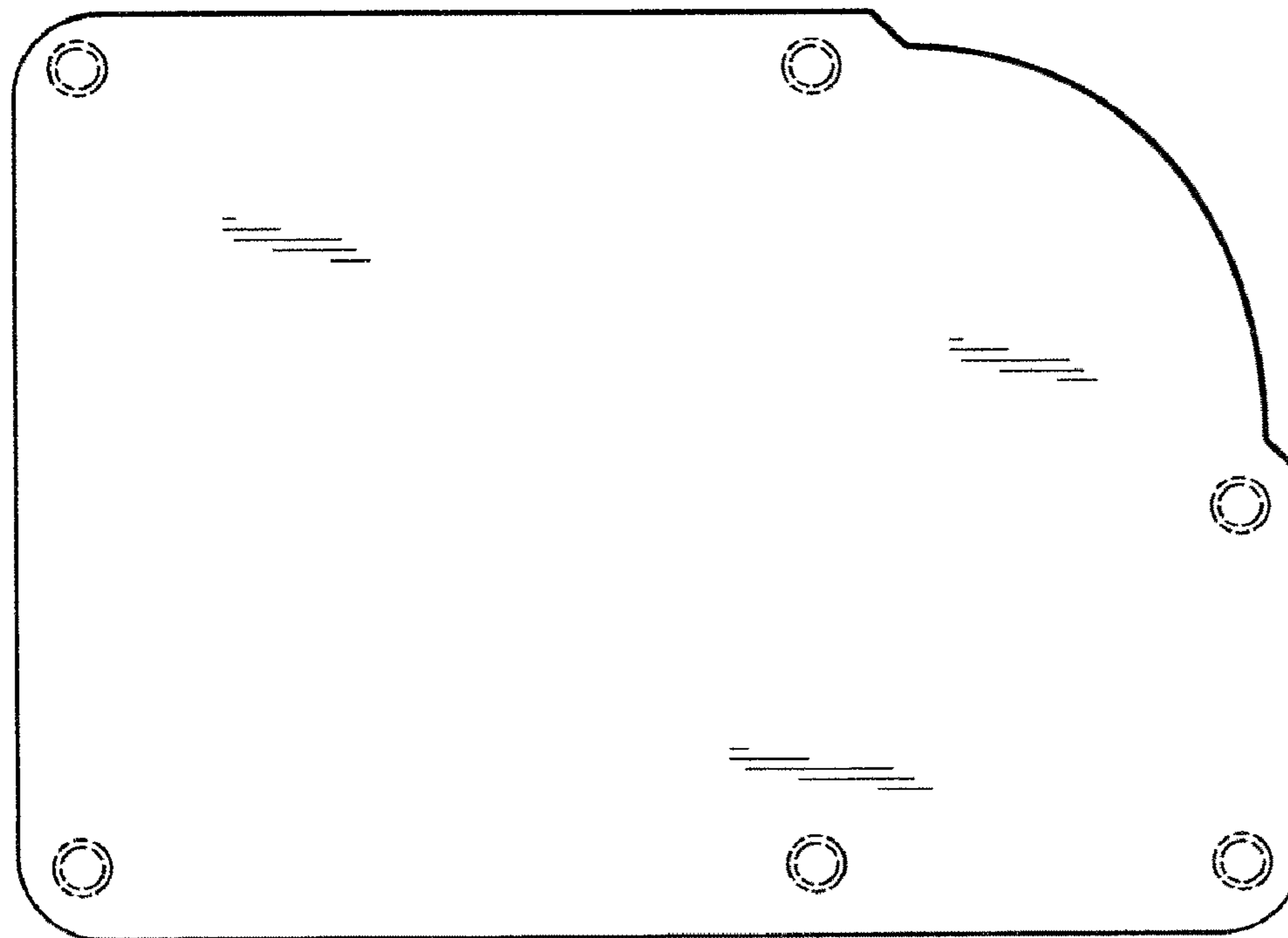
