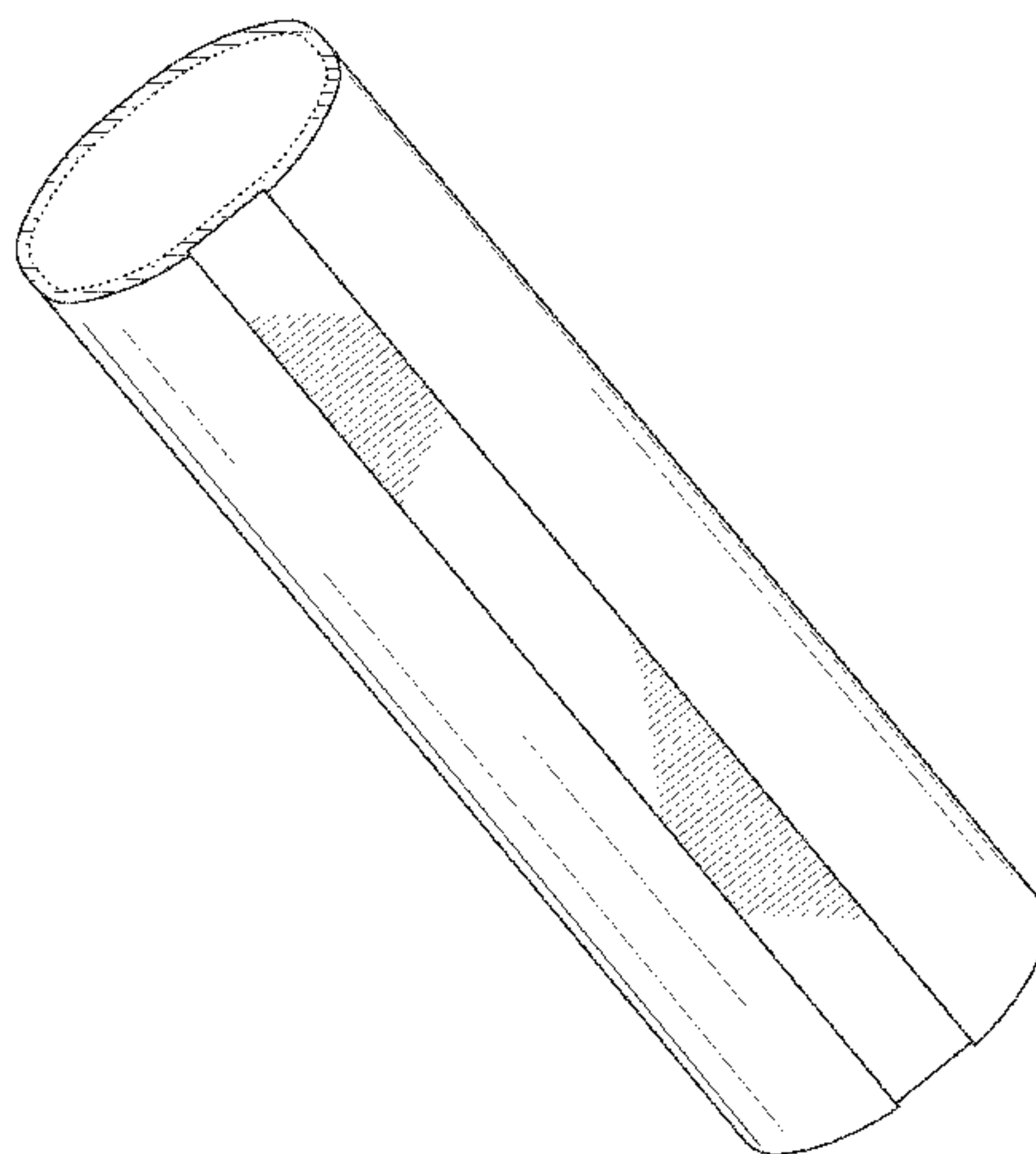
(57) **CLAIM**

The ornamental design for stroller frame tubing, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a stroller frame tubing, showing our new design;  
FIG. 2 is a perspective view of the fragmentary section taken from lines 2-2 in FIG. 1;  
FIG. 3 is front elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a right side elevation view thereof;  
FIG. 6 is a rear elevation view thereof;  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a bottom plan view thereof.  
The broken lines illustrated environmental structure and form no part of the claimed design.

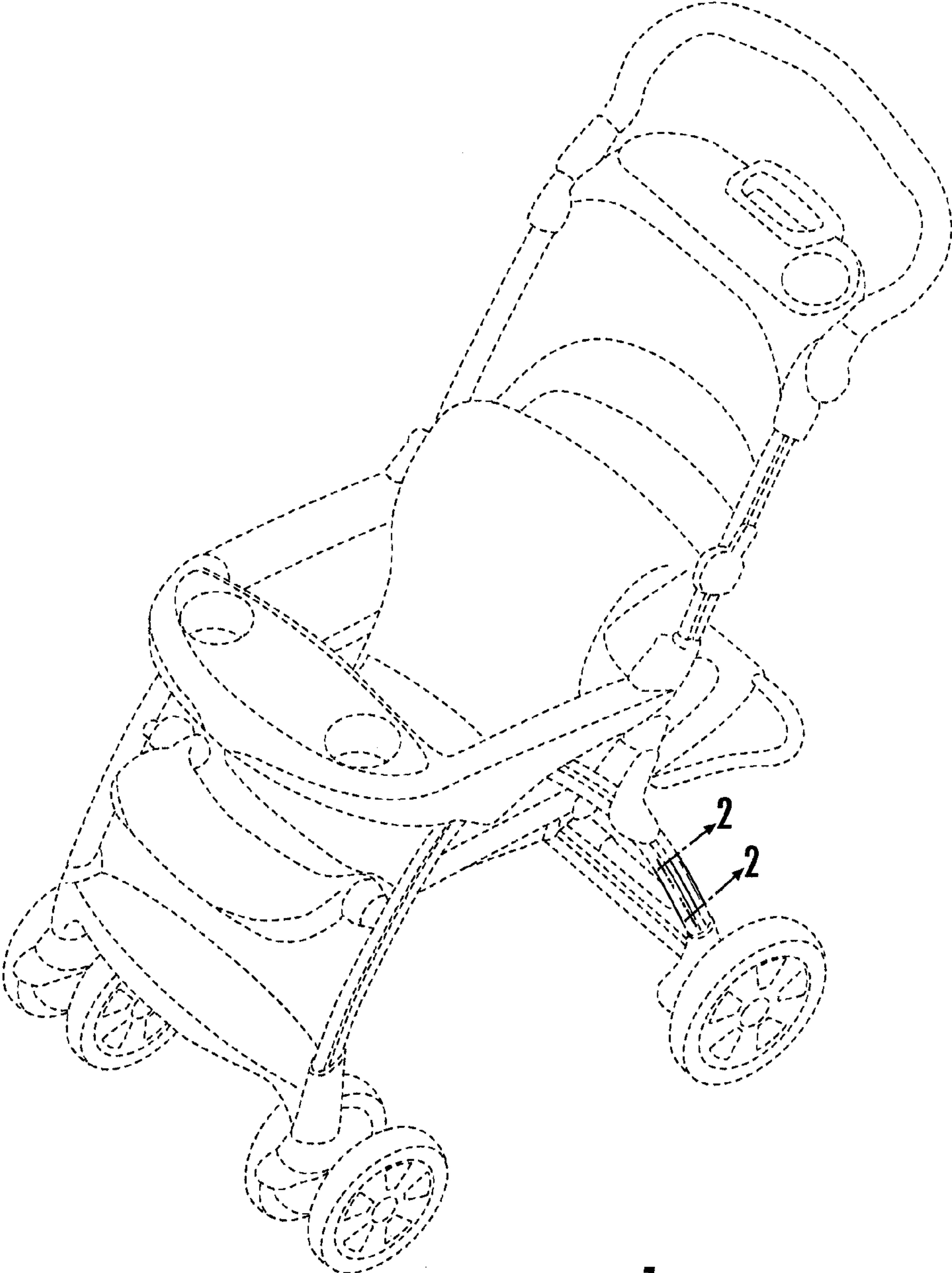
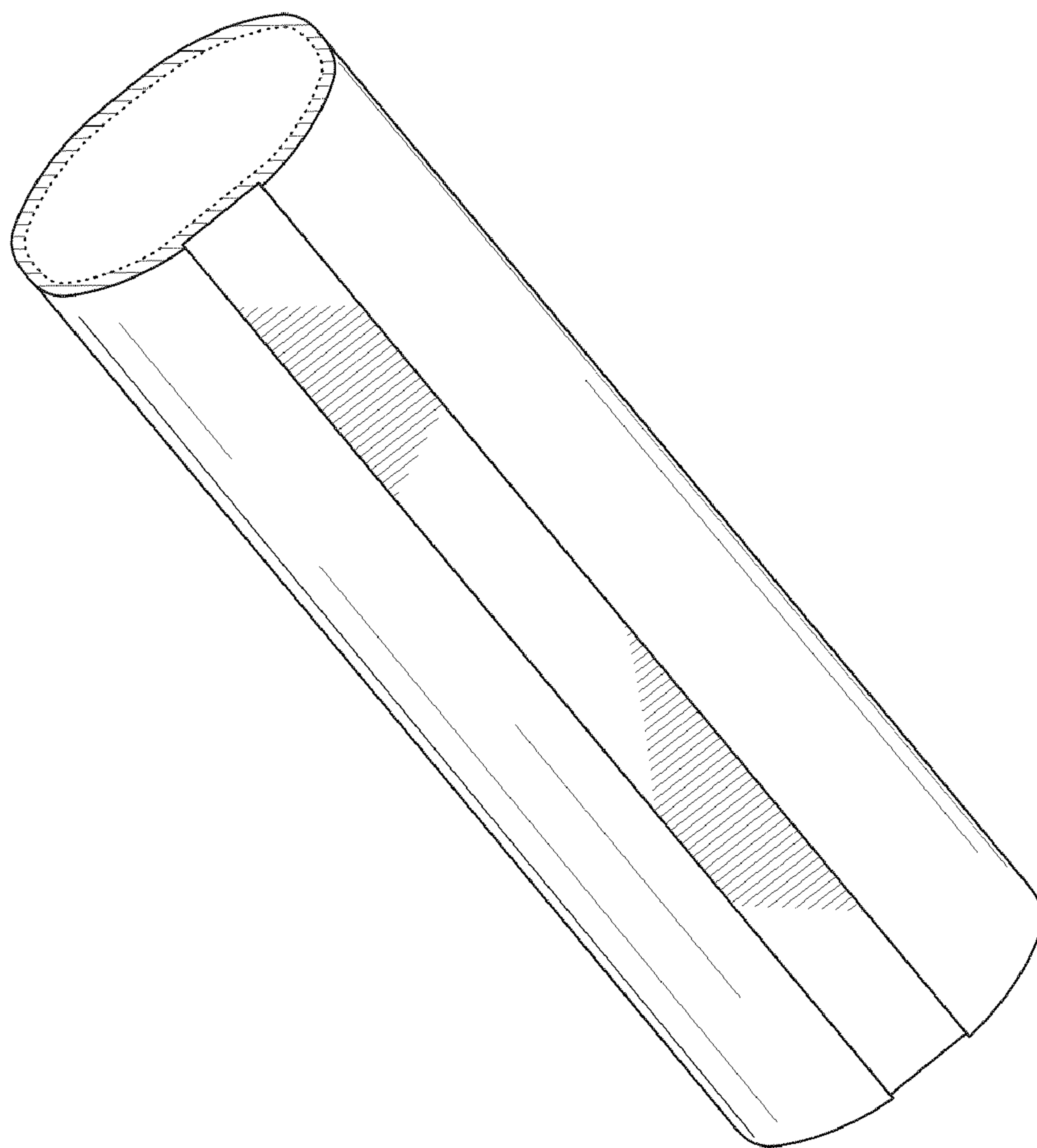

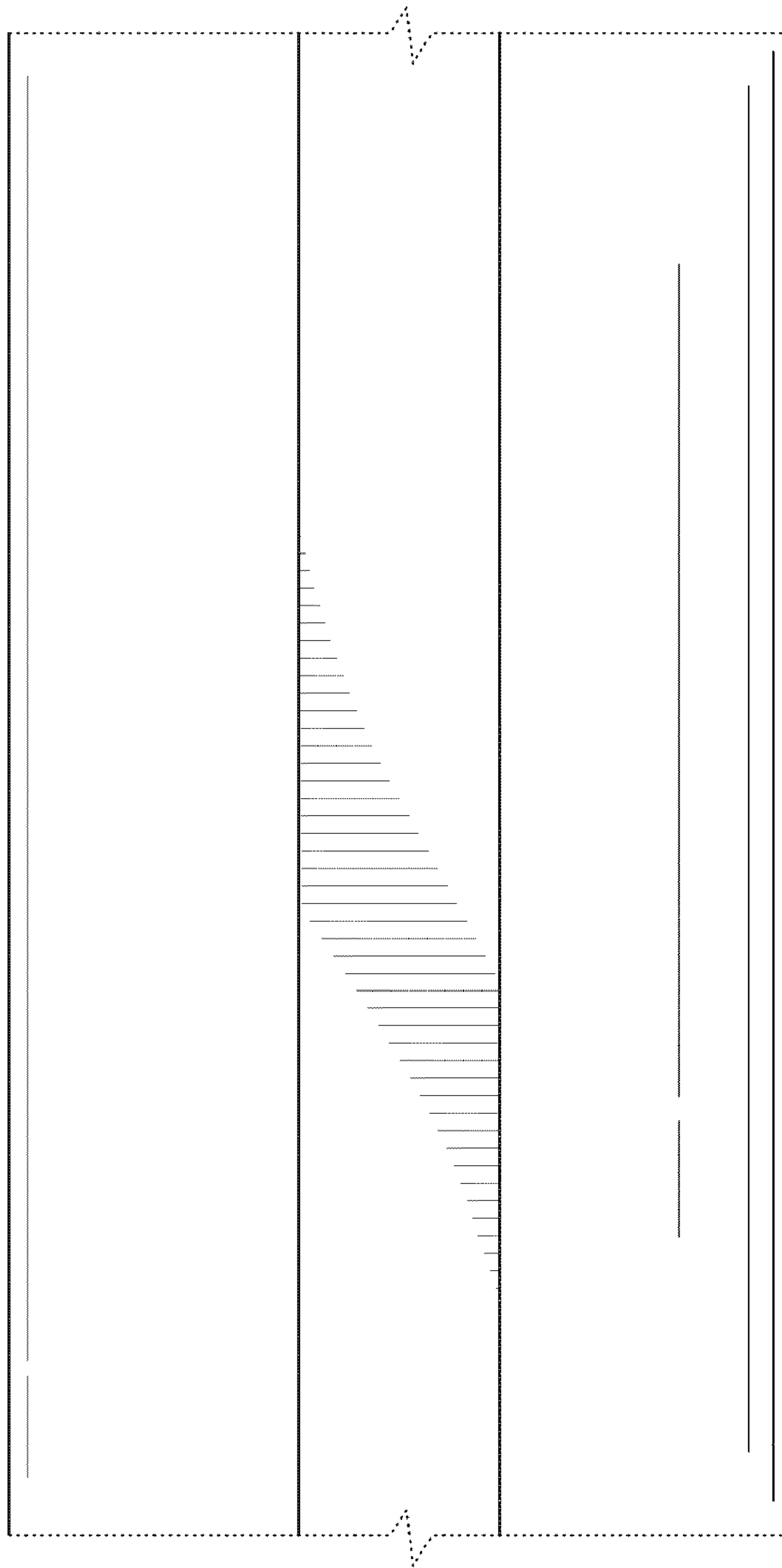
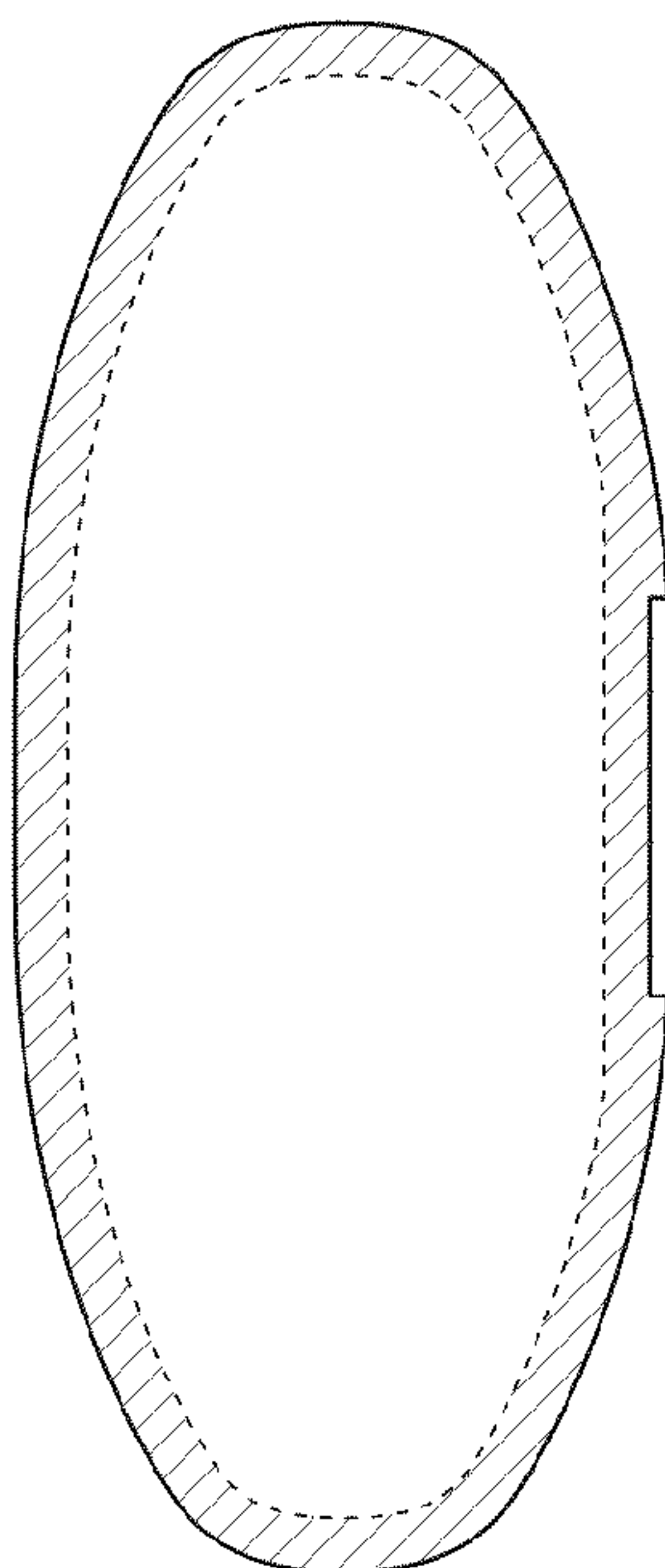
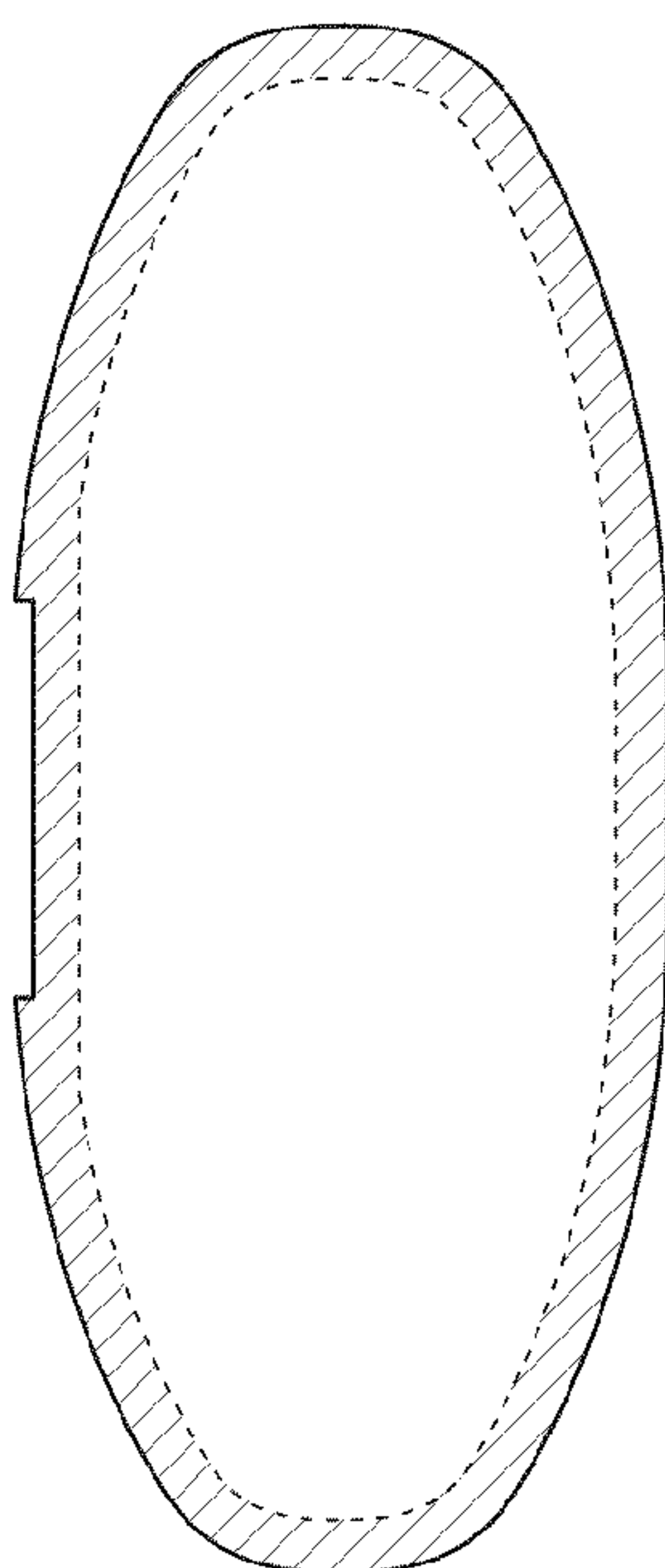

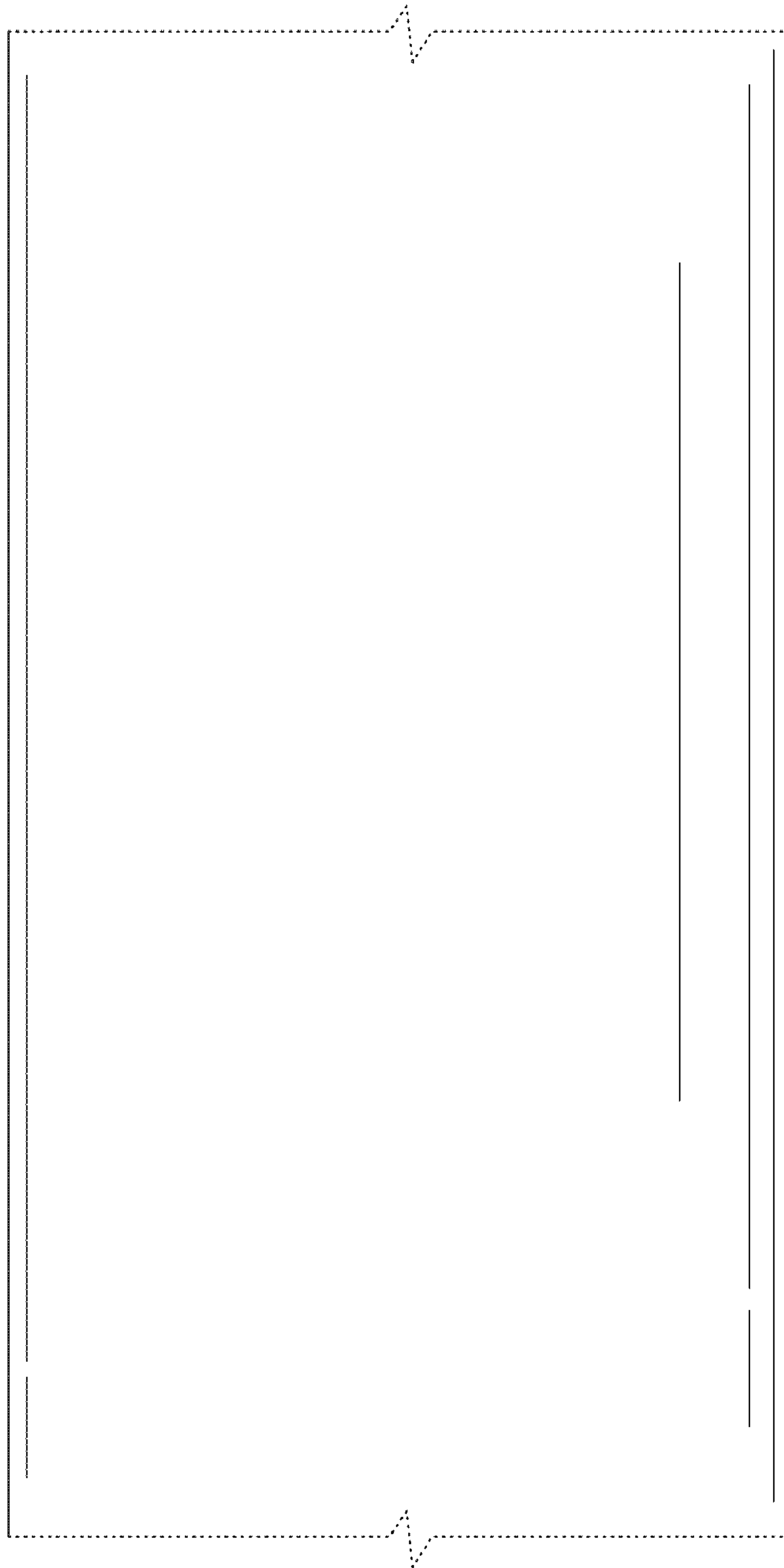
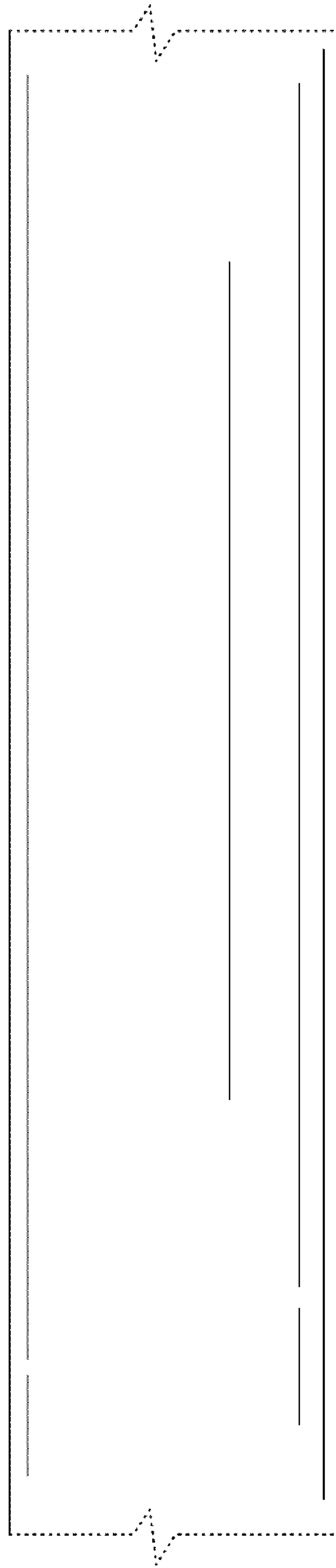

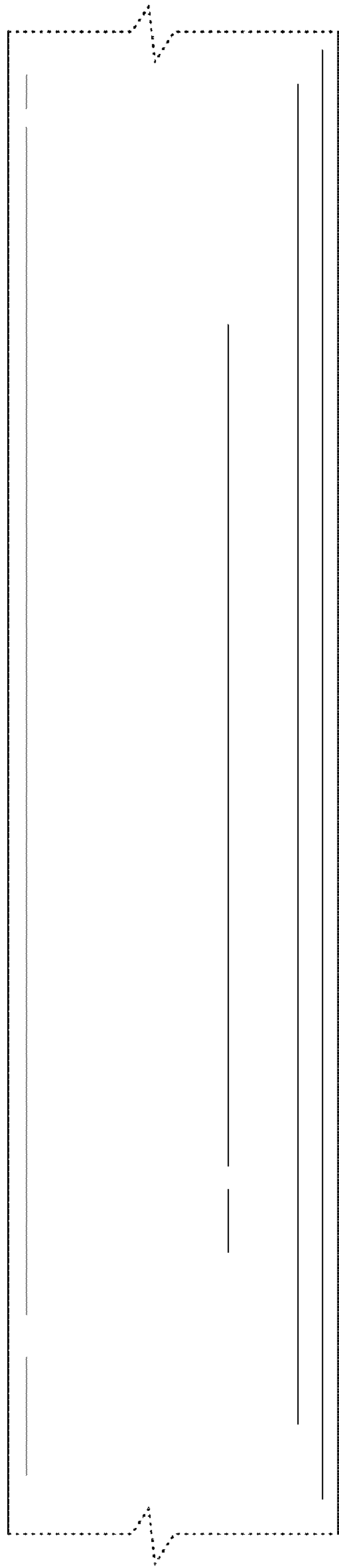
