(57) **CLAIM**

The ornamental design for a tire for automobile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tire for automobile showing my new design, it being understood that the pattern repeats uniformly throughout the circumference of the tread; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a left side elevational view thereof; and, FIG. 5 is an enlarged fragmentary front elevational view thereof.

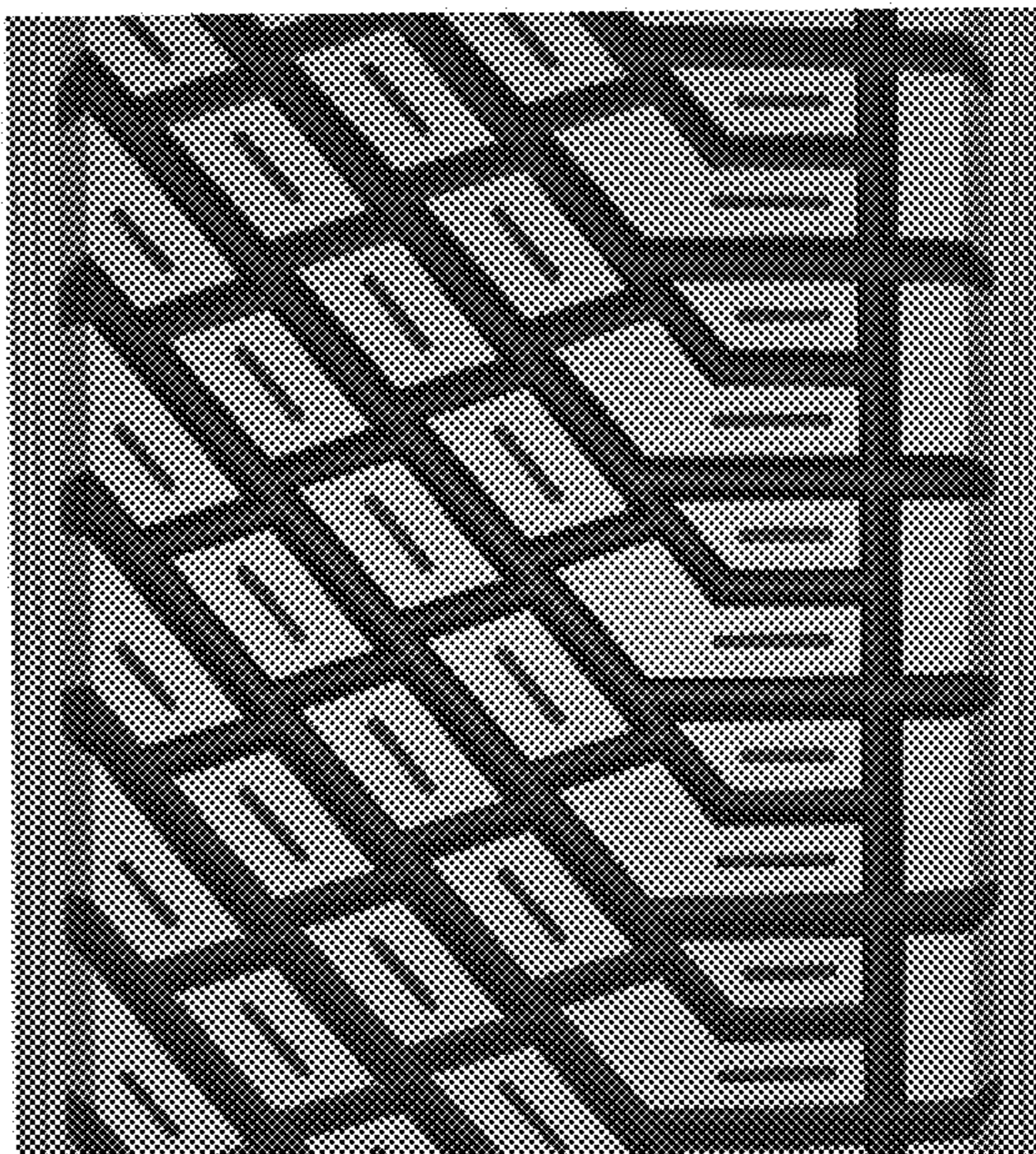
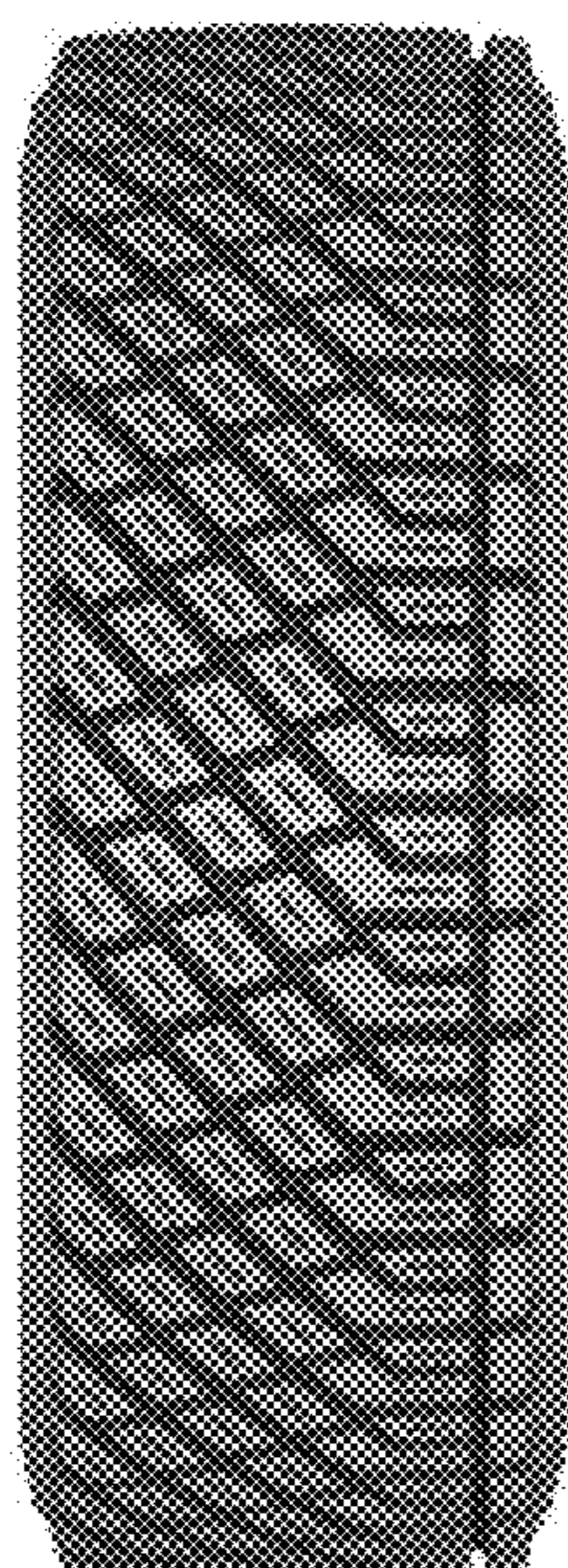

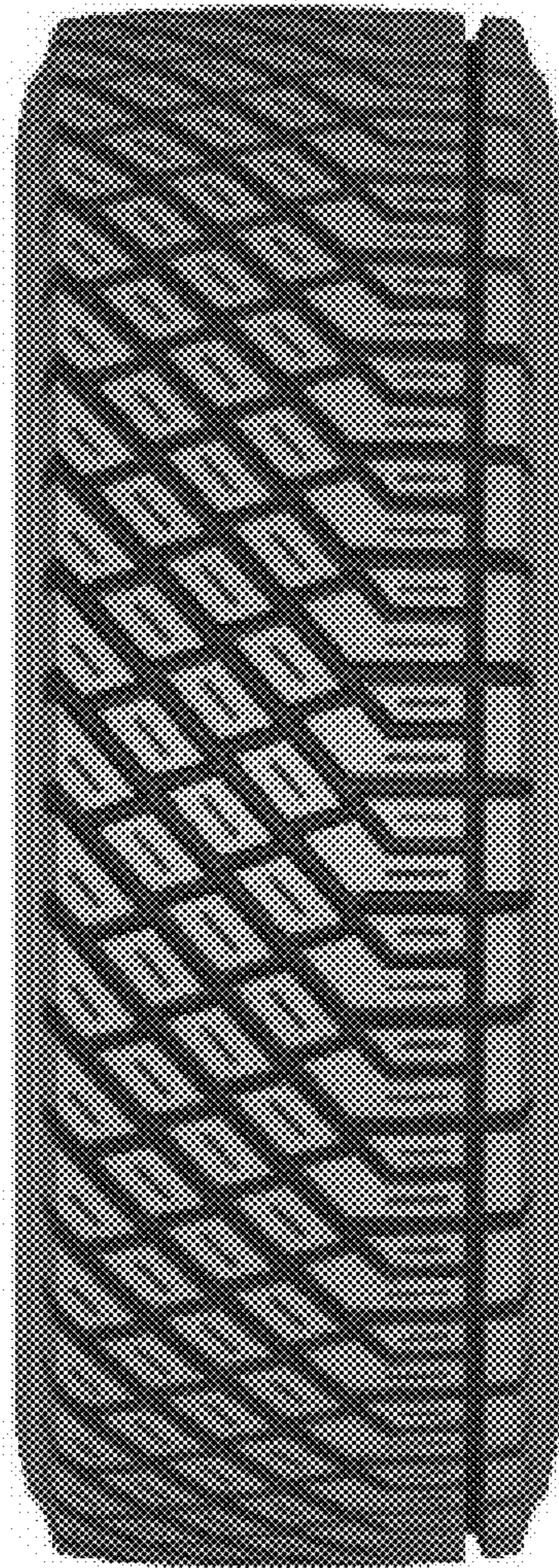

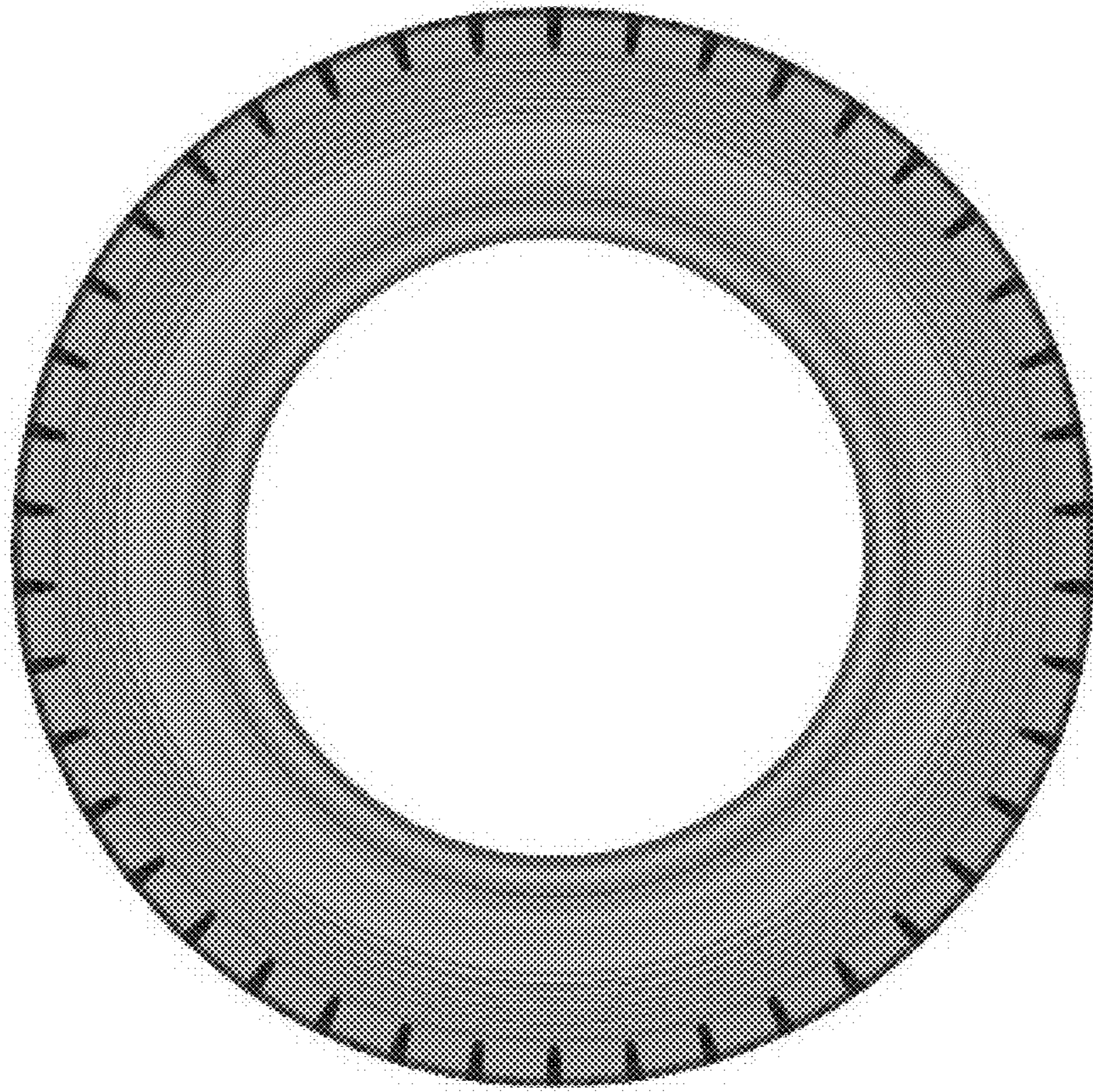

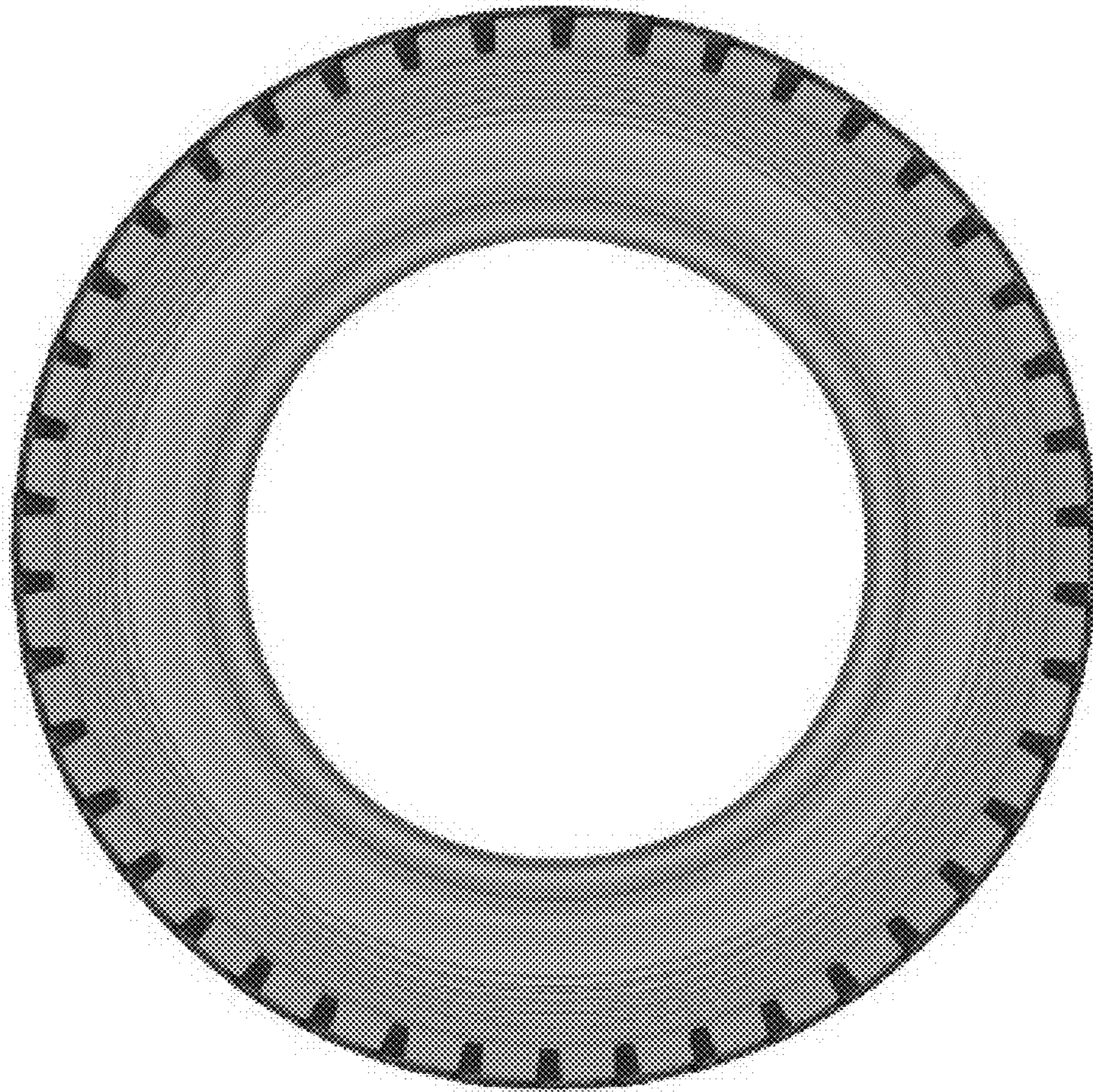

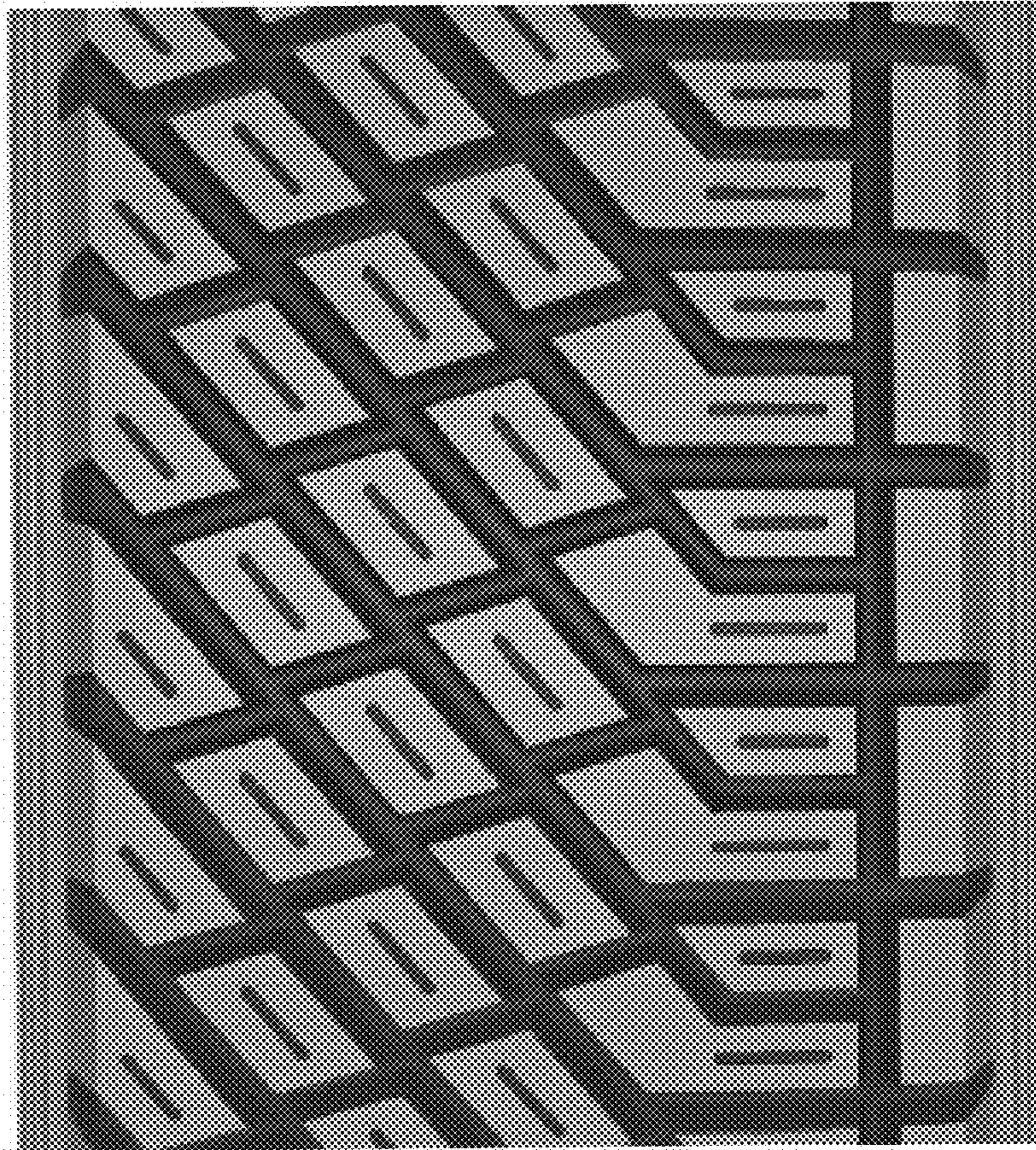
