An ornamental design for a clip-on lens.

DESCRIPTION

FIG. 1 is a perspective view of the clip-on lens as used in conjunction with a pair of glasses shown in dot dash lines and which do not form a portion of the instant design;

FIG. 2 is a top plan view of the clip-on lens;

FIG. 3 is a front elevational view thereof;

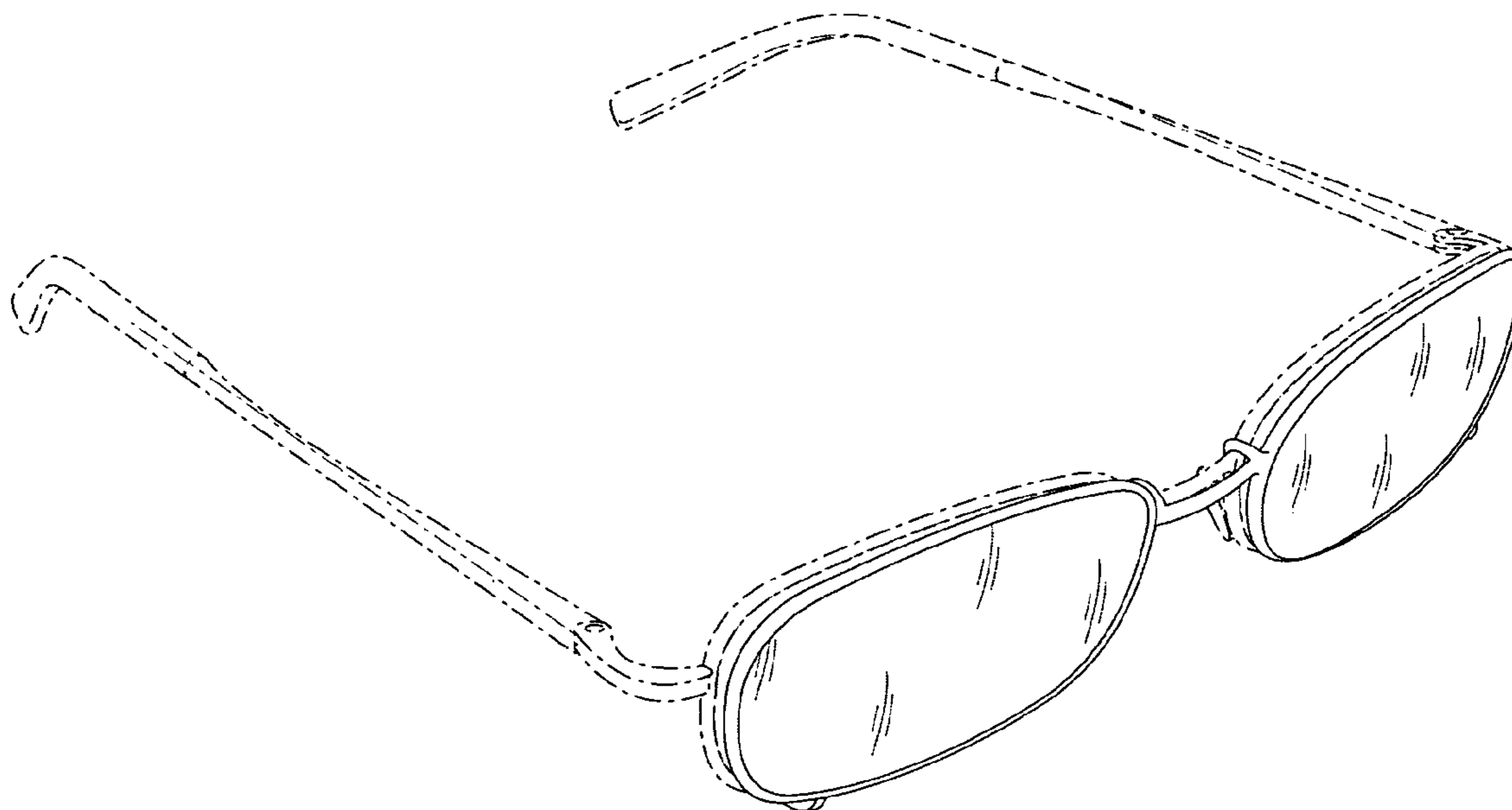
FIG. 4 is a side elevational view as seen from the left hand side of FIG. 3;

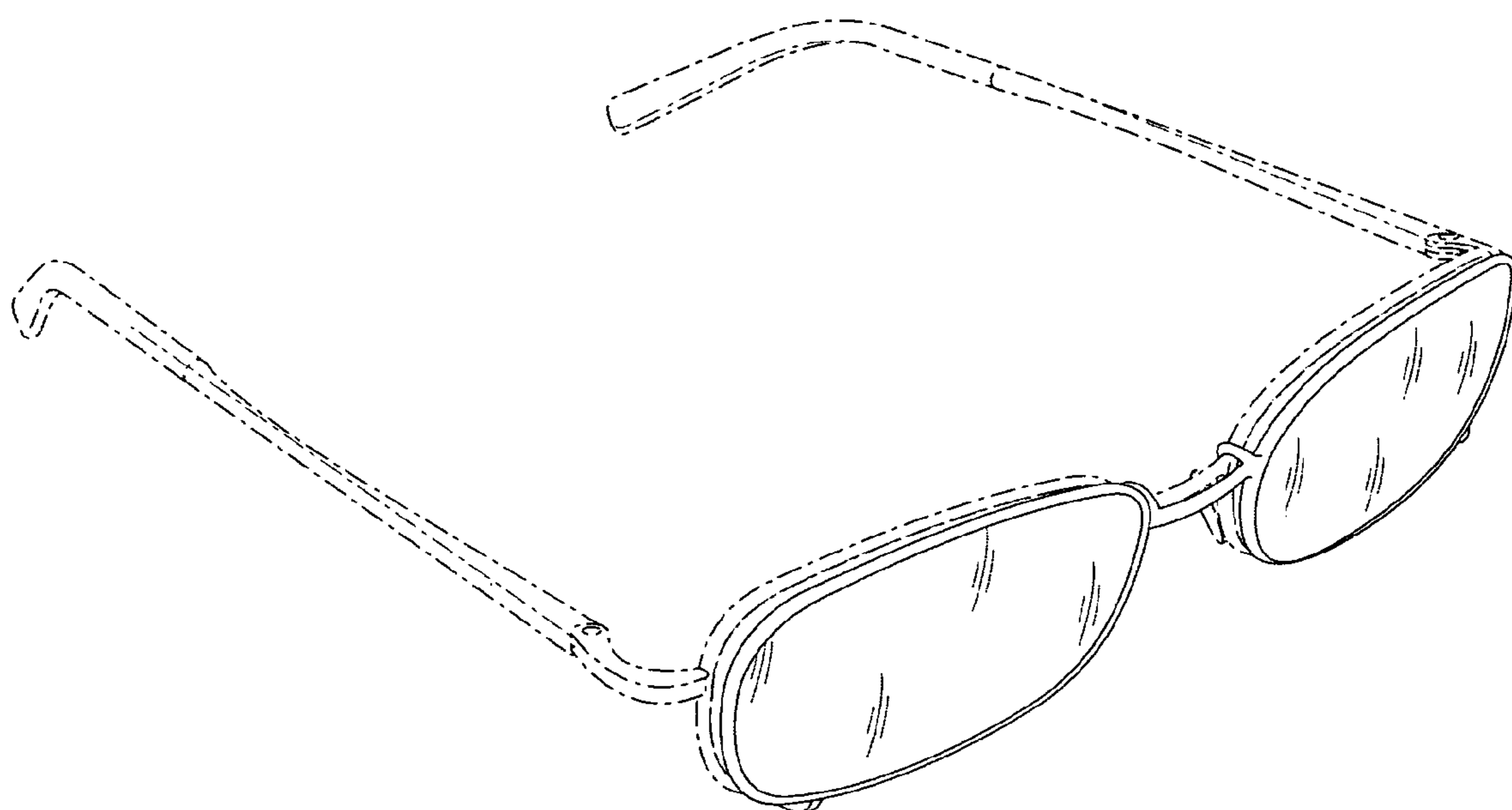

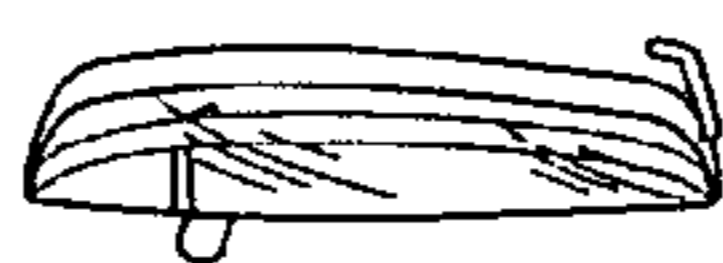

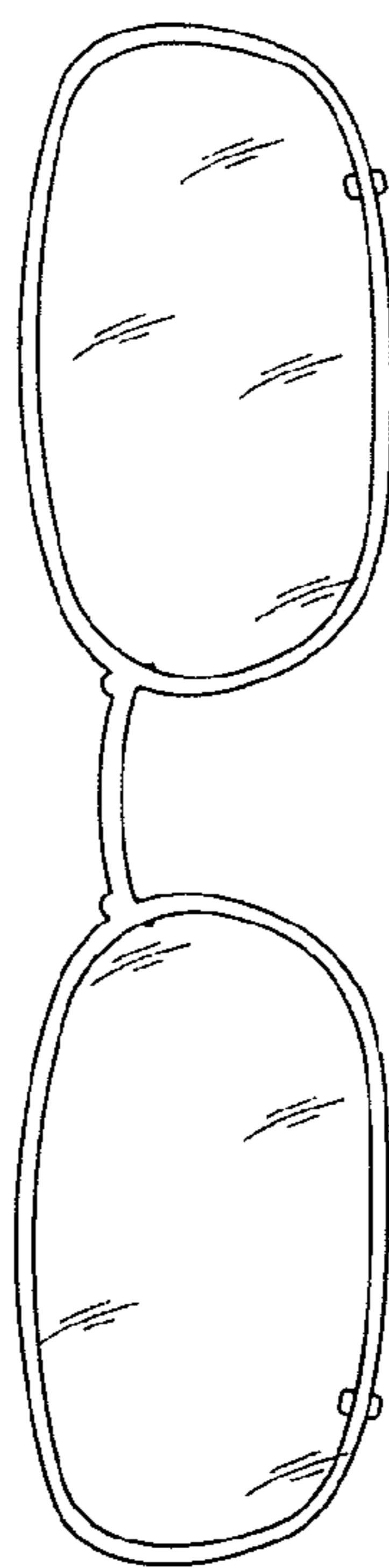

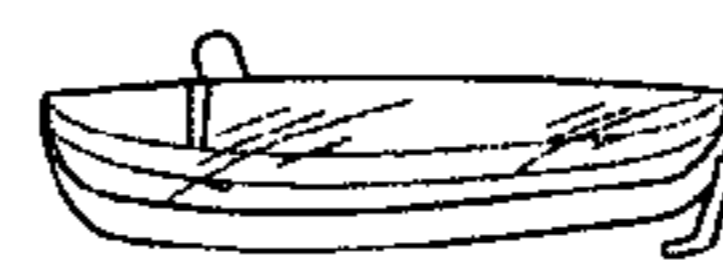

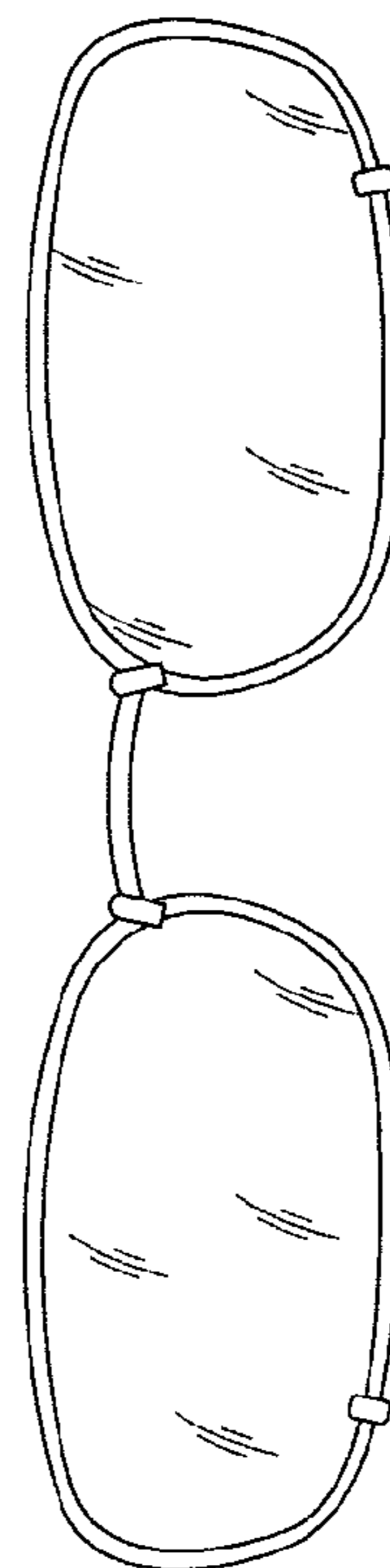
