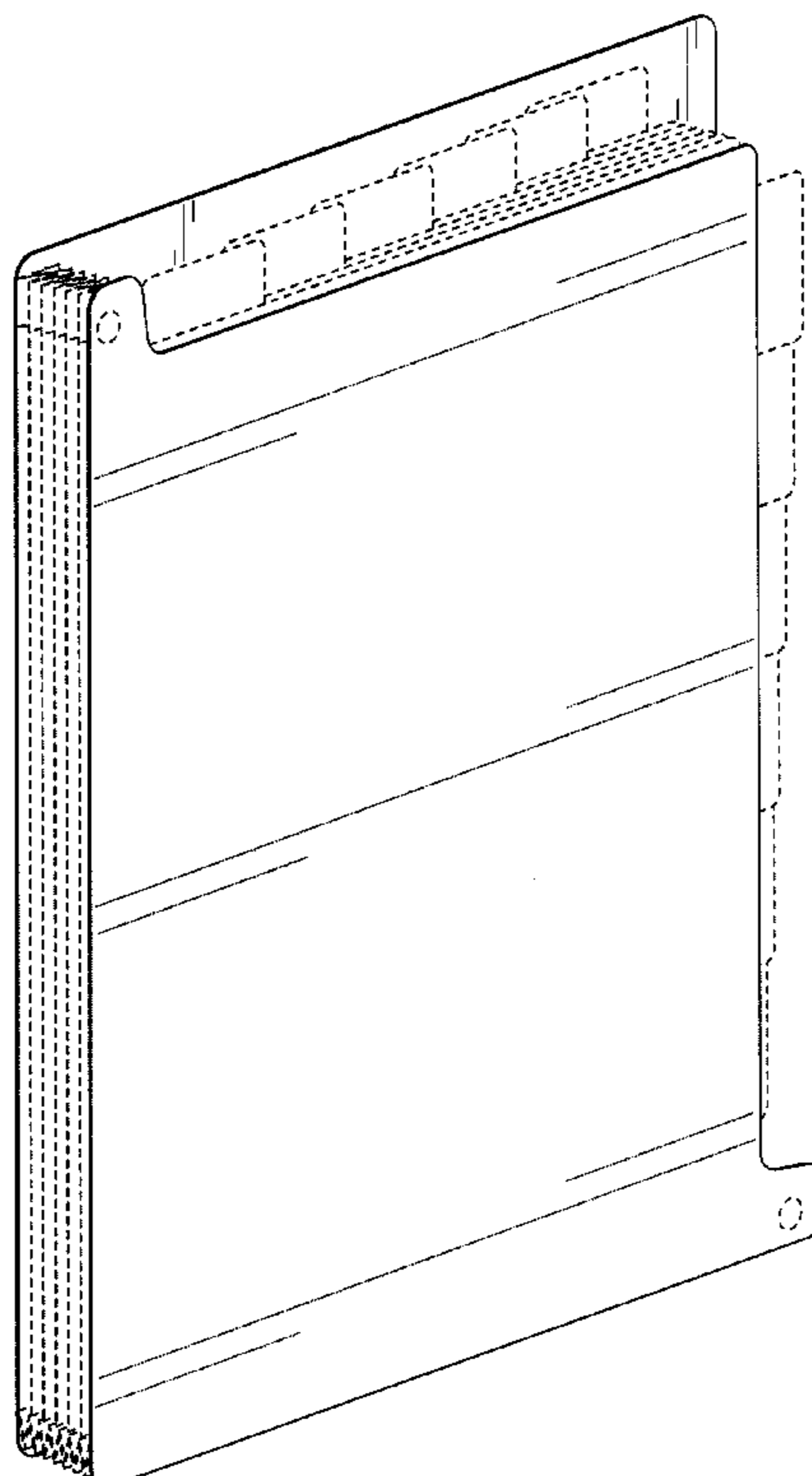
(57) **CLAIM**

The ornamental design for an expandable file, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the expandable file;
FIG. 2 is a front elevational view of the expandable file;
FIG. 3 is a rear elevational view of the expandable file;
FIG. 4 is a left side elevational view of the expandable file;
and
FIG. 5 is a right side elevational view of the expandable file;
FIG. 6 is a top plan view of the expandable file; and,
FIG. 7 is a bottom plan view of the expandable file.

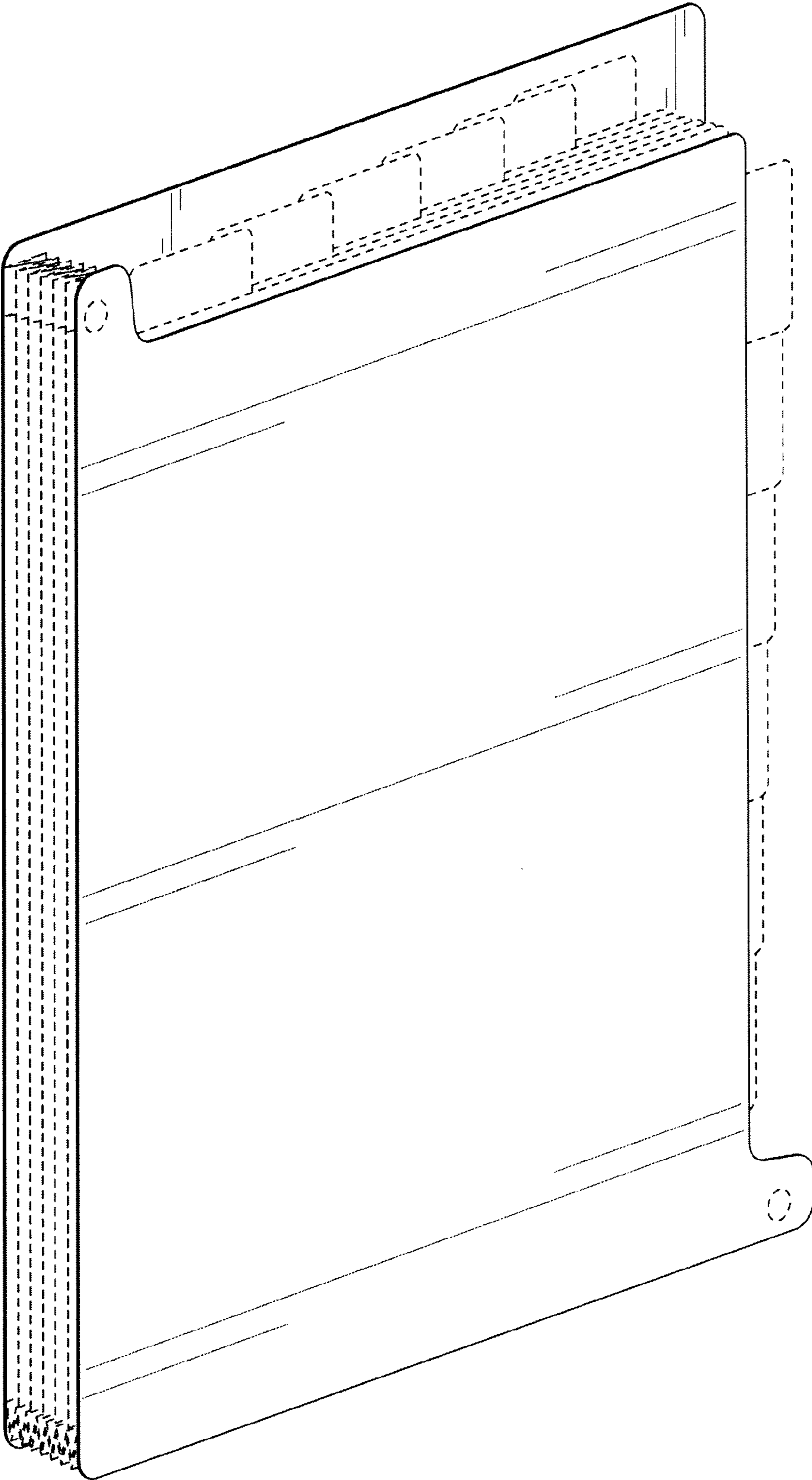

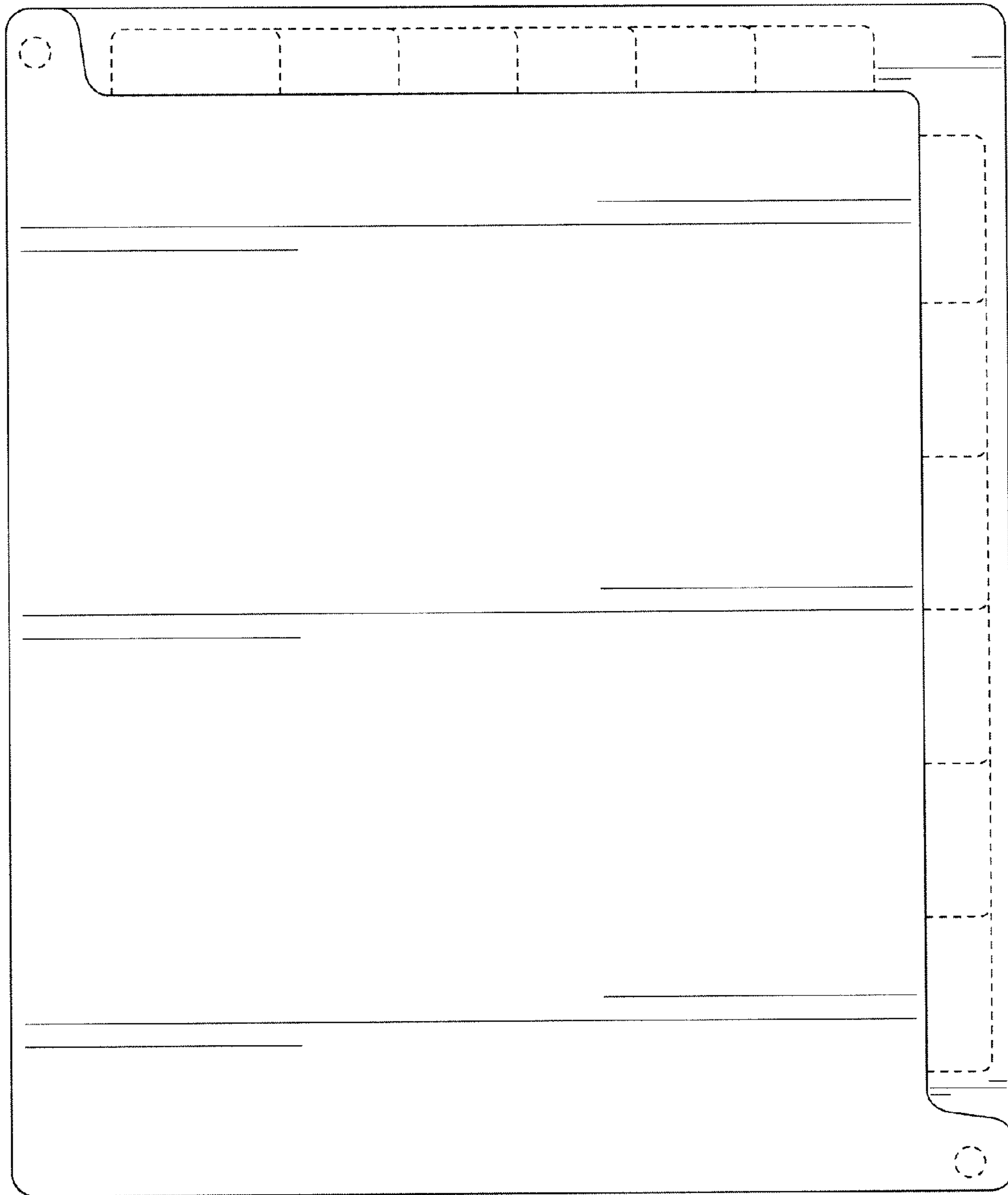

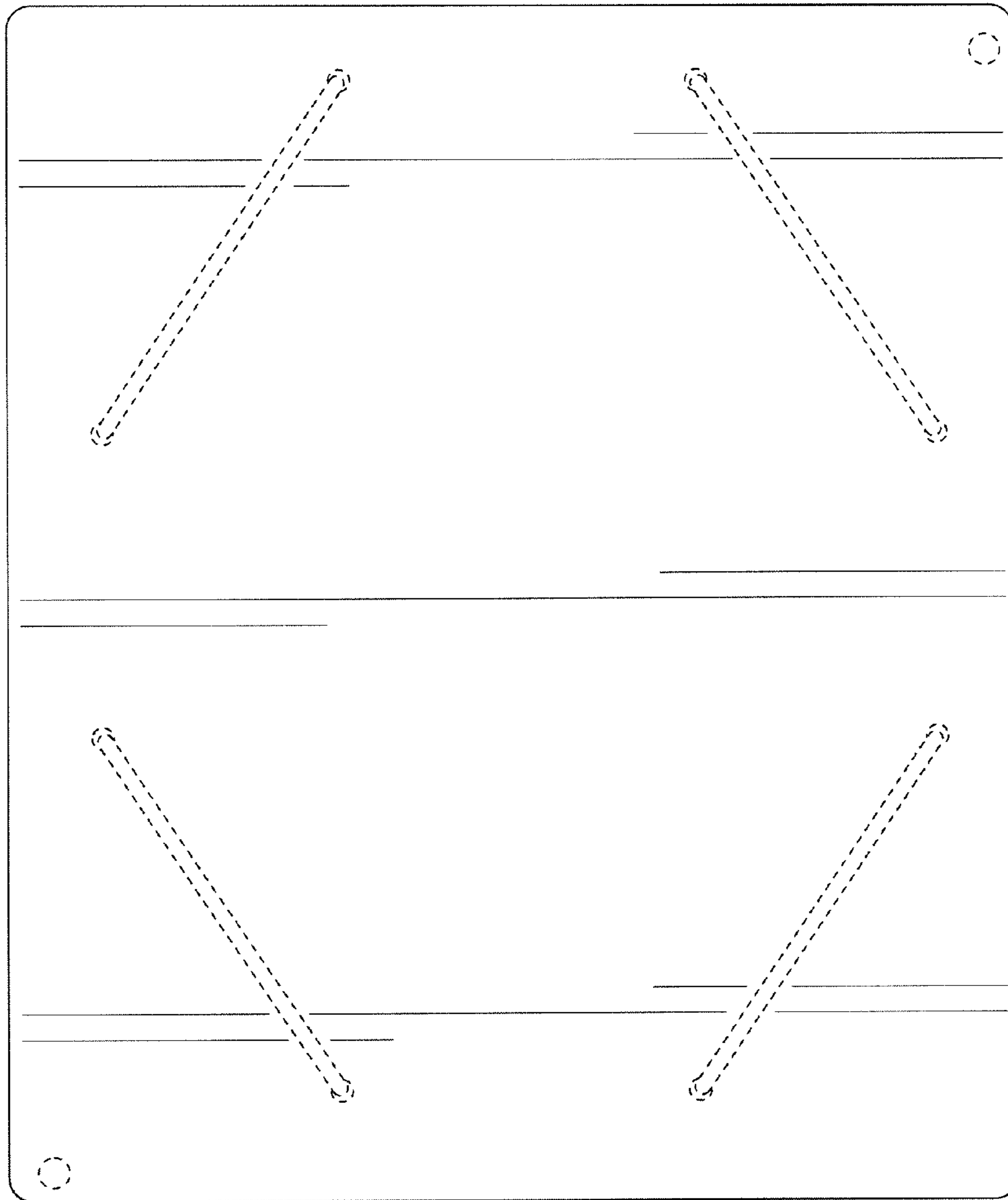

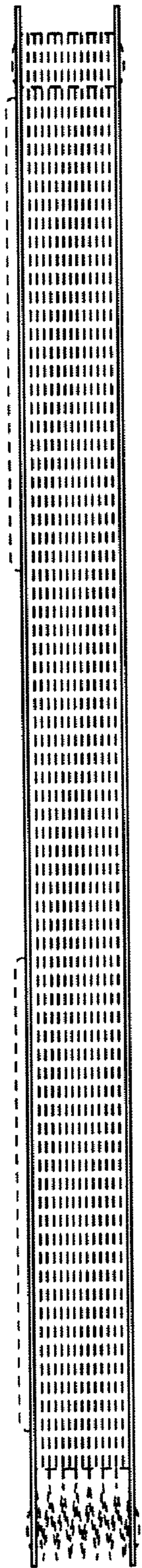

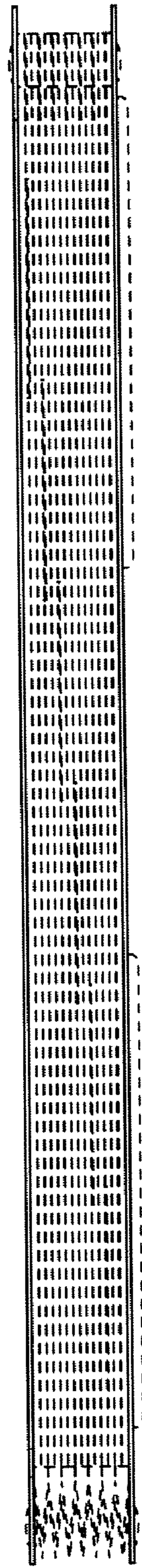

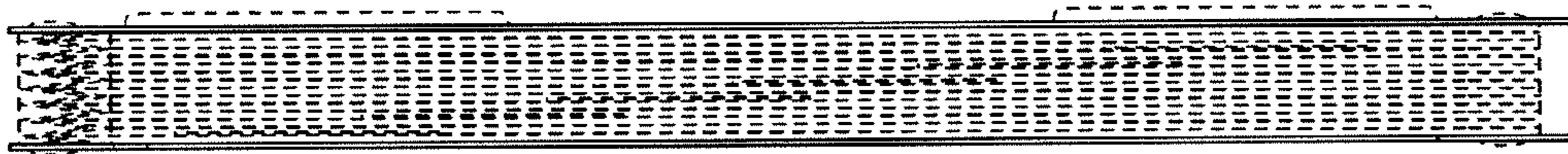

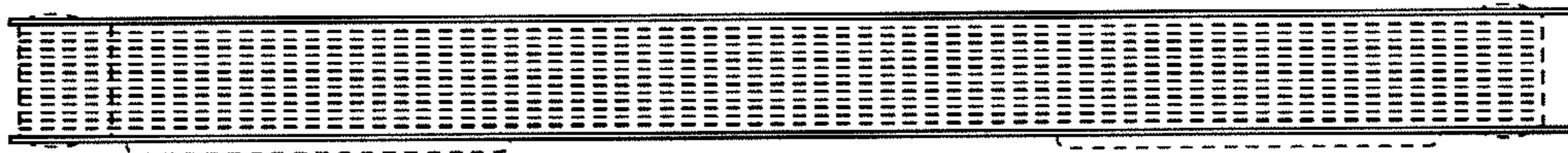
