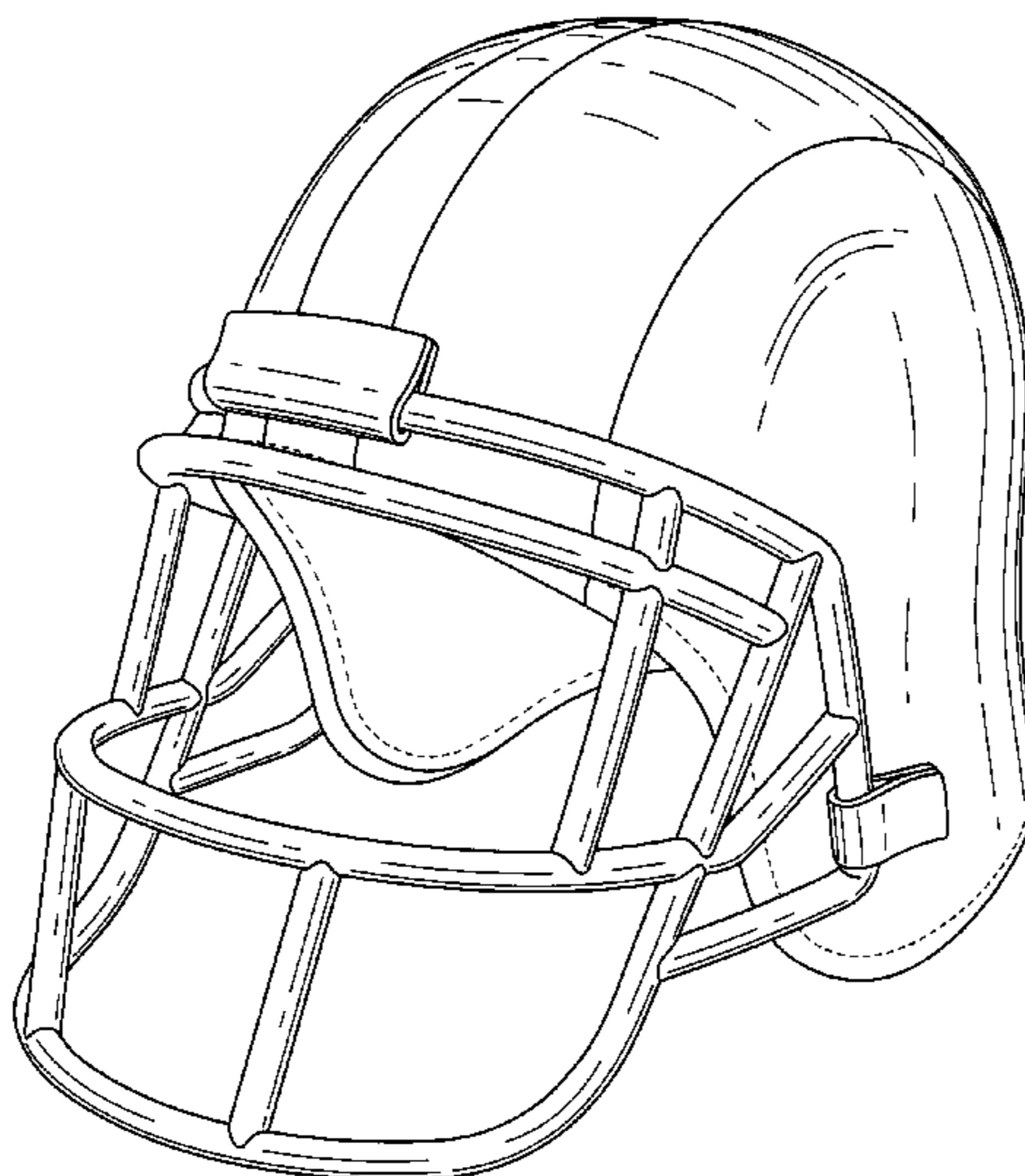
(57) **CLAIM**

We claim the ornamental design for a helmet cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a helmet cap.
FIG. 2 is a front view of the helmet cap shown in FIG. 1.
FIG. 3 is a side view of the helmet cap shown in FIG. 1.
FIG. 4 is a back view of the helmet cap shown in FIG. 1.

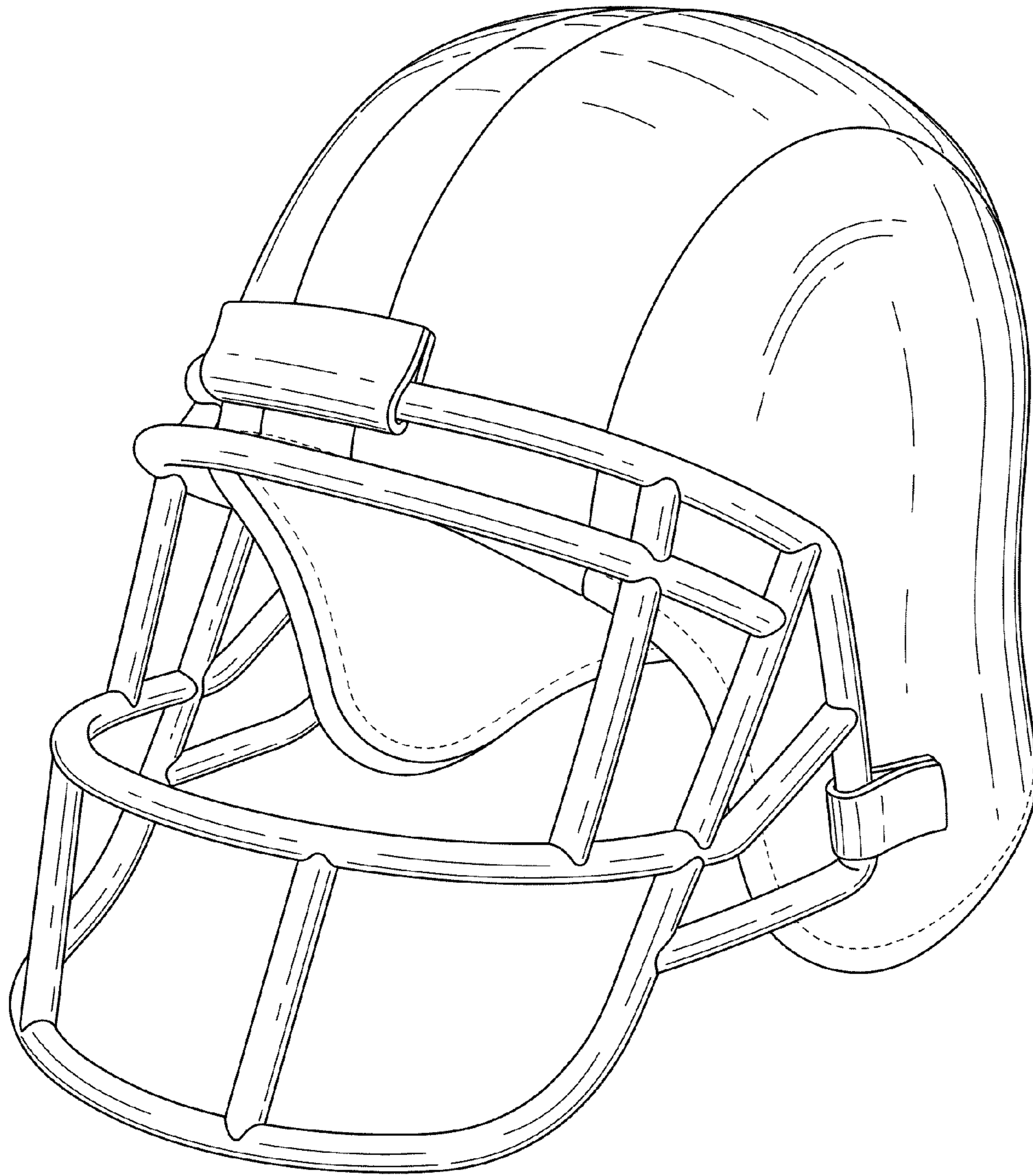

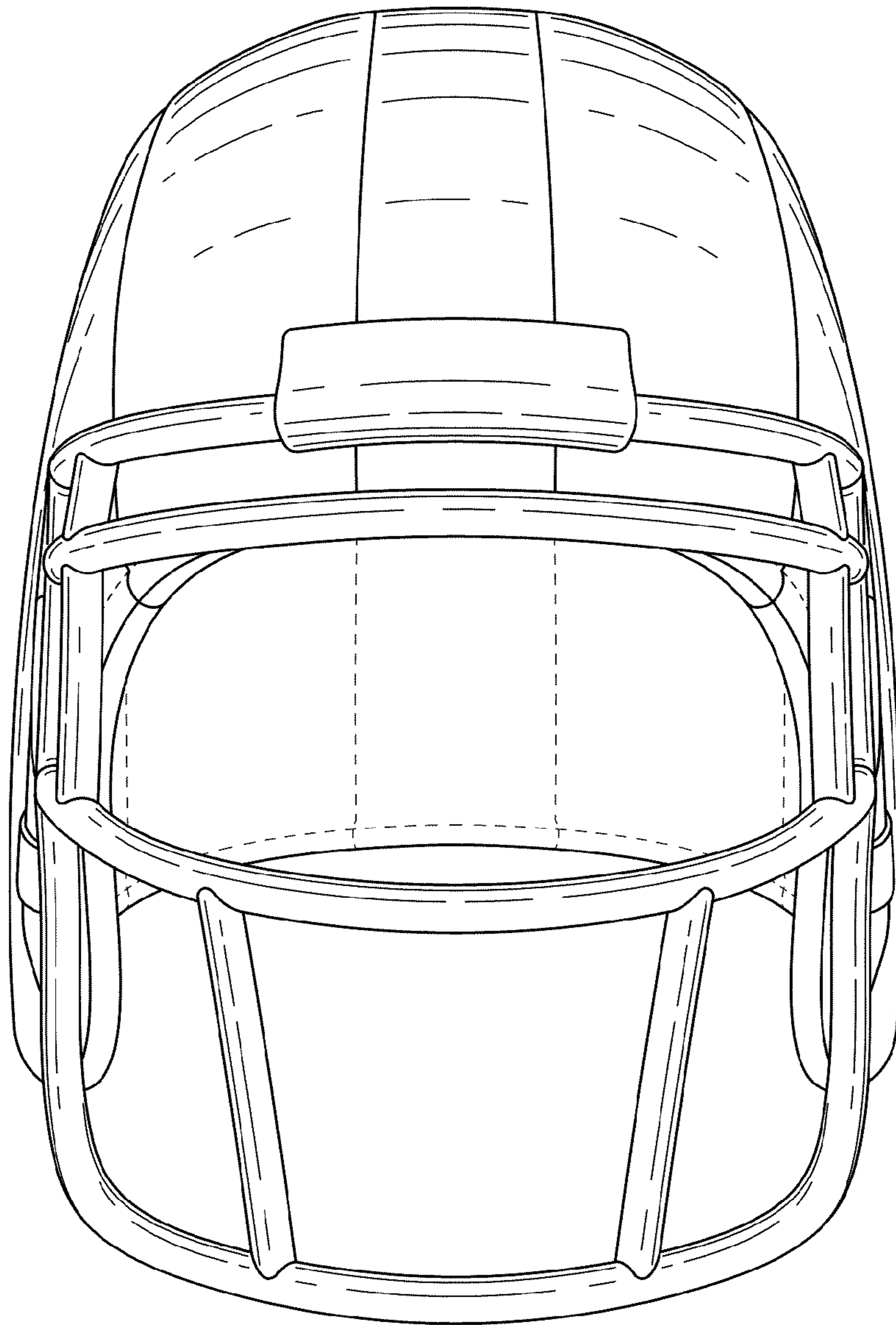

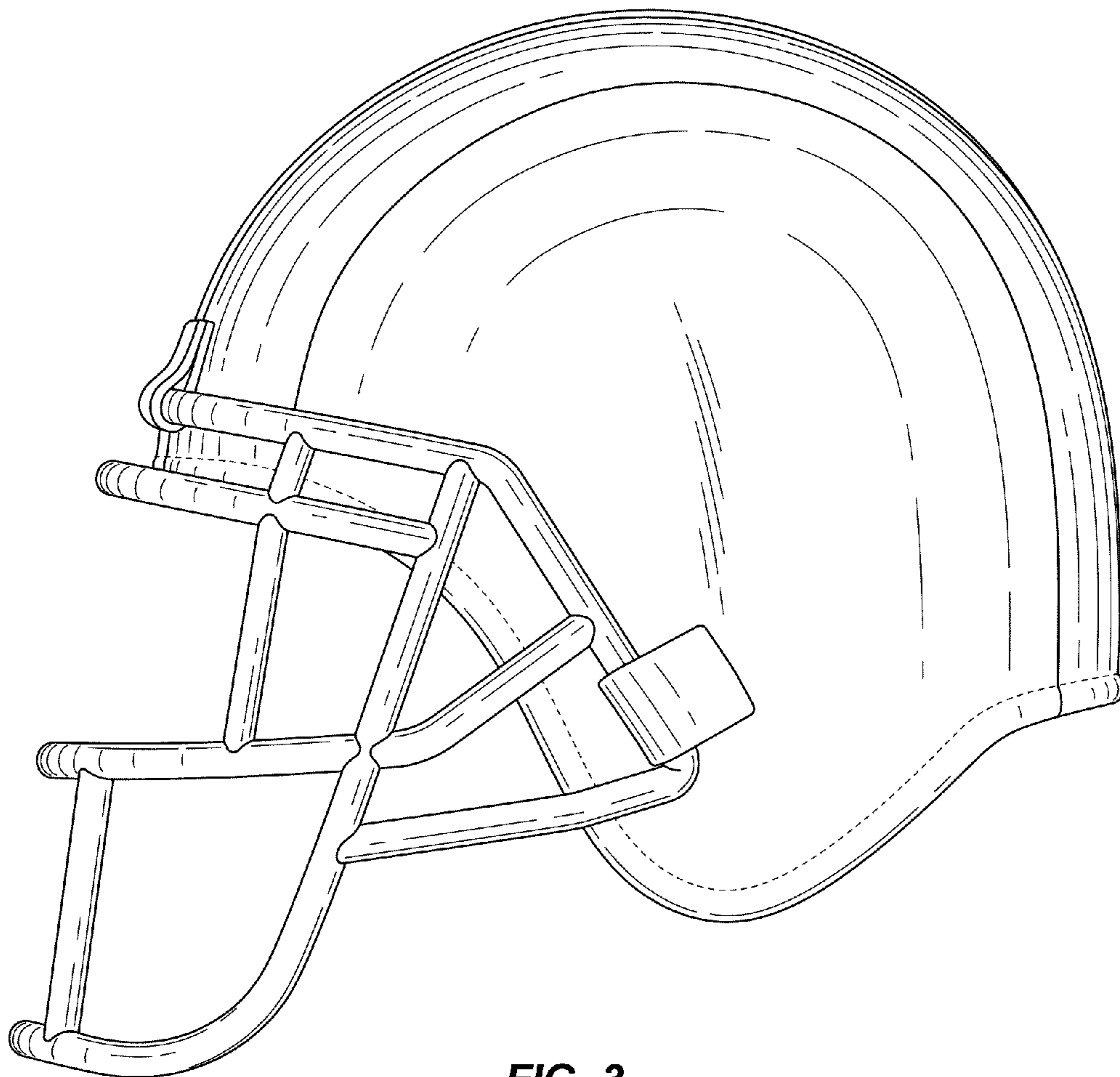

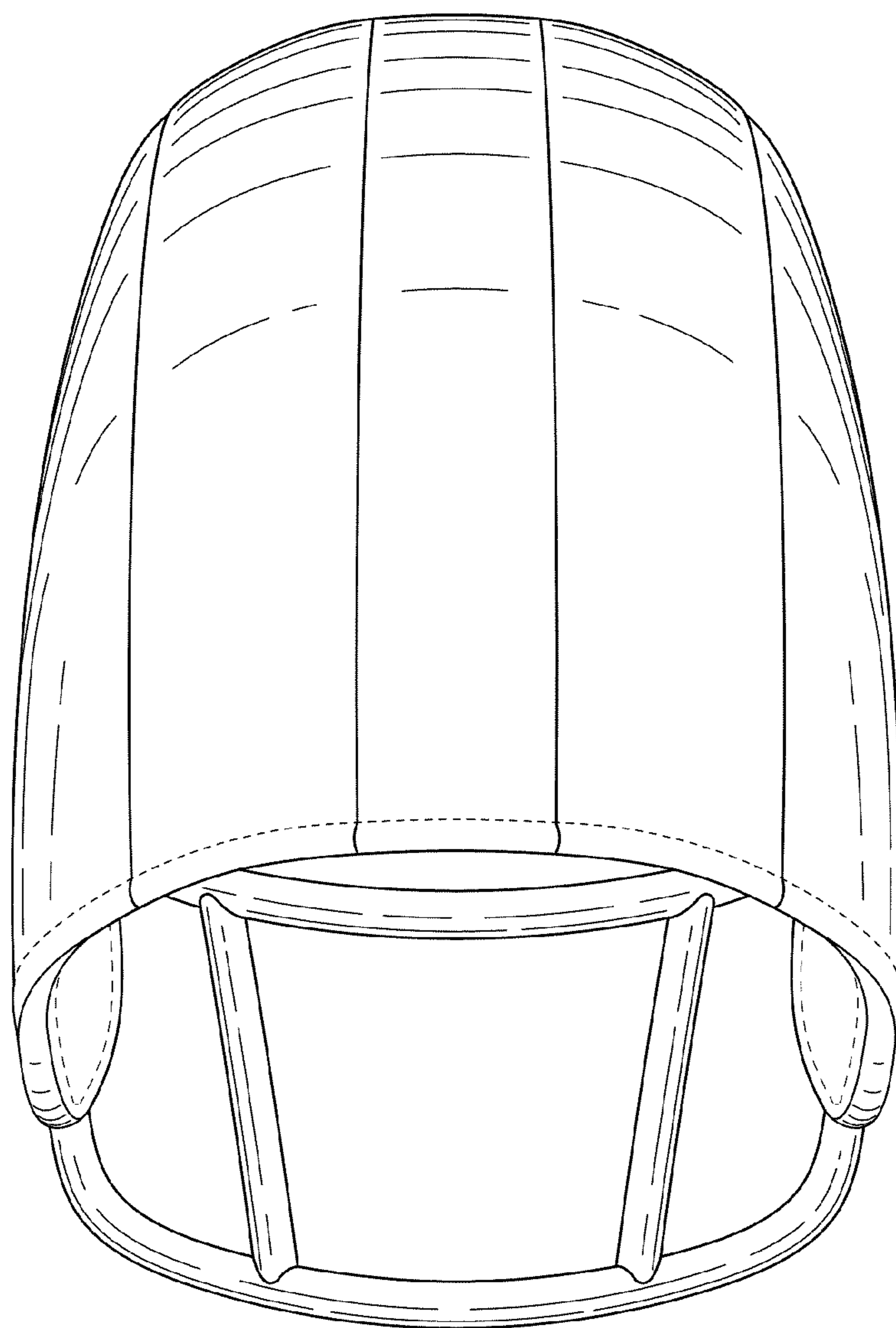

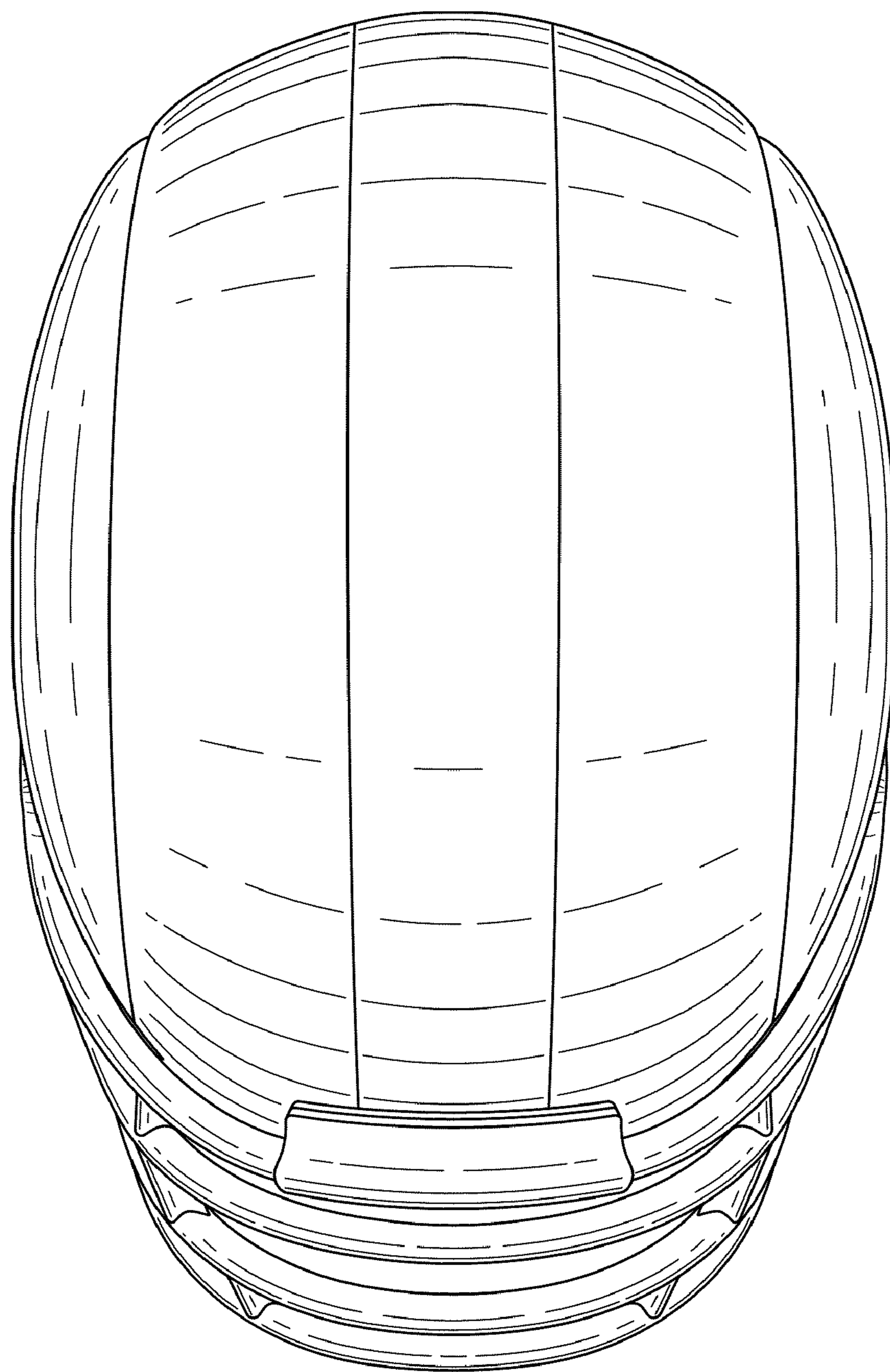

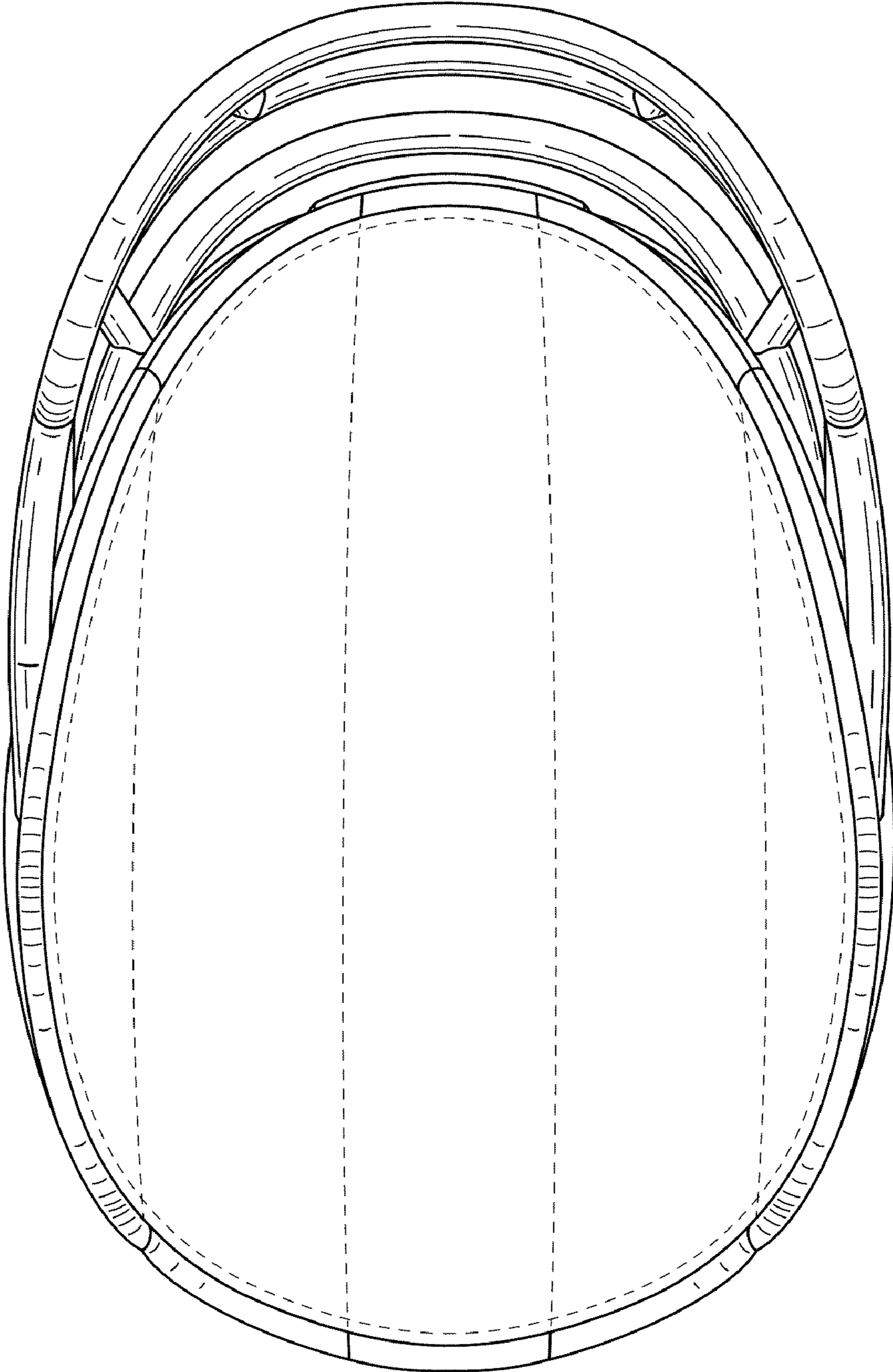
