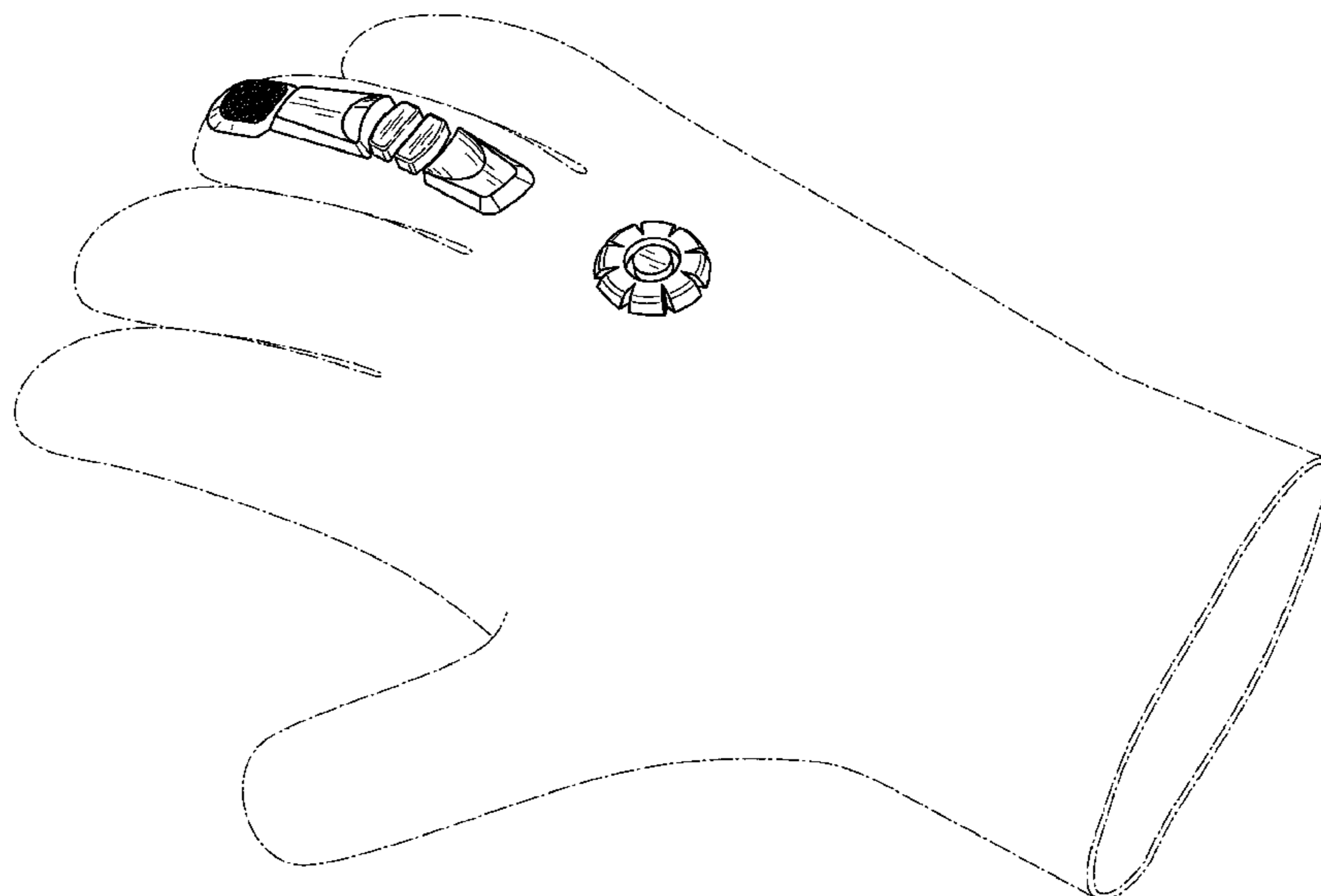
(57) **CLAIM**

The ornamental design for a glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a glove showing my new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a left side elevational view thereof; and, FIG. 4 is a perspective top view thereof. The broken lines of the glove in FIGS. 1-4 and the unshaded regions therein are for illustrative purposes only and form no part of the claimed design.

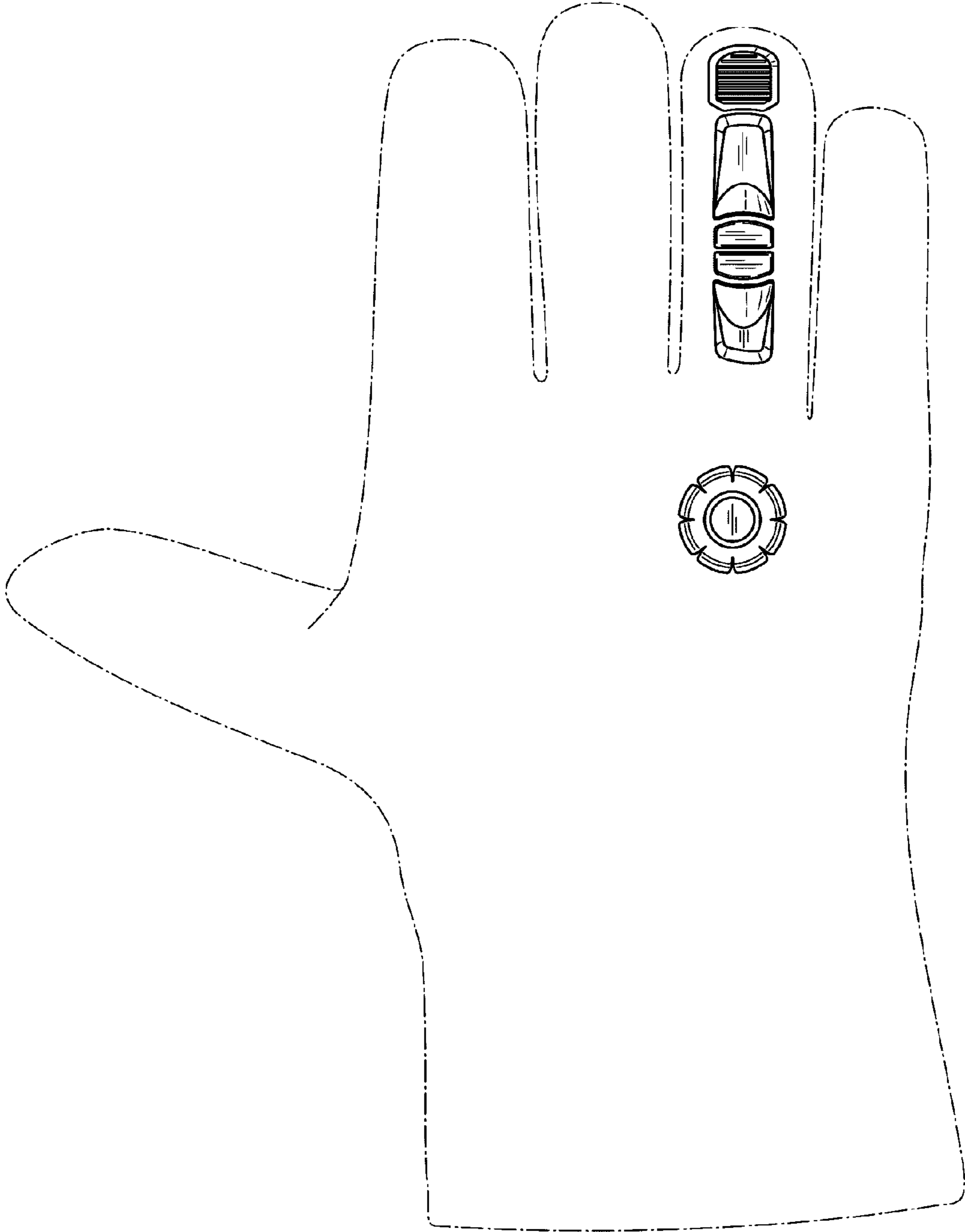

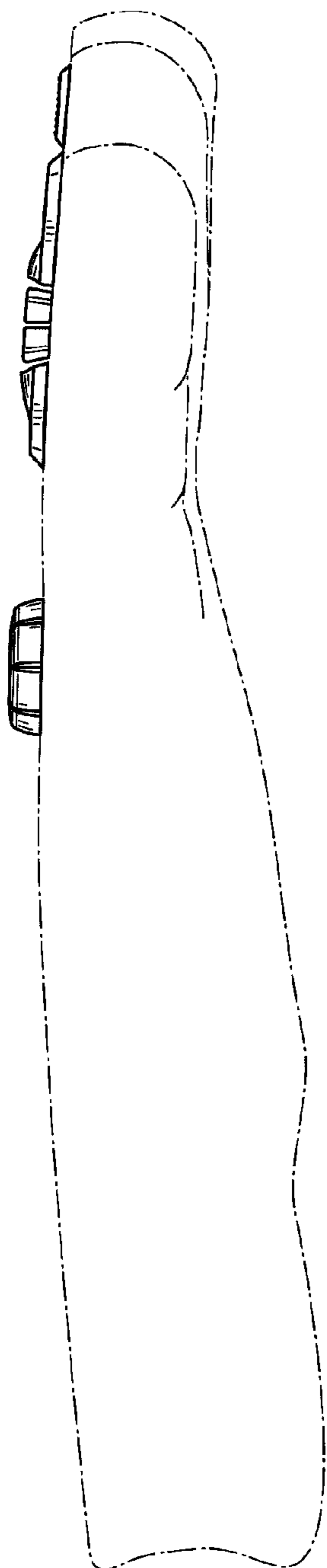

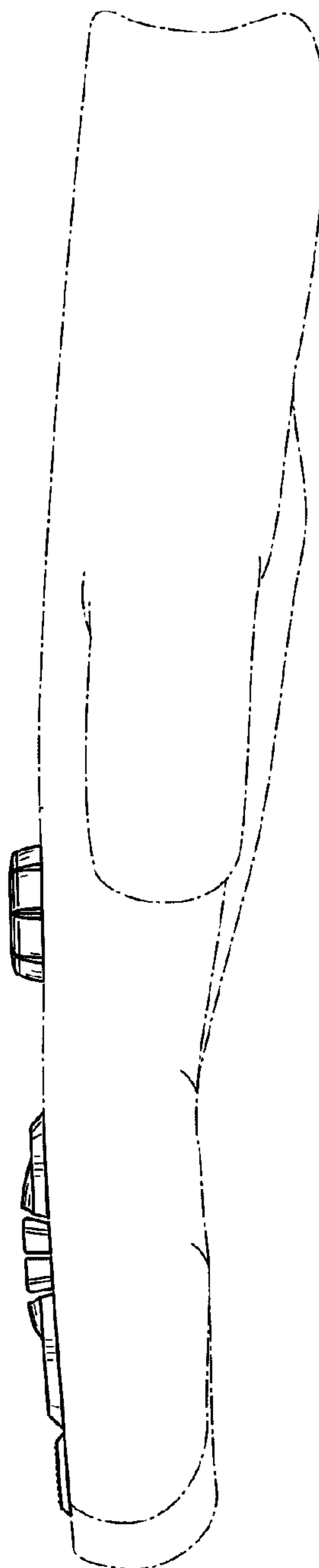

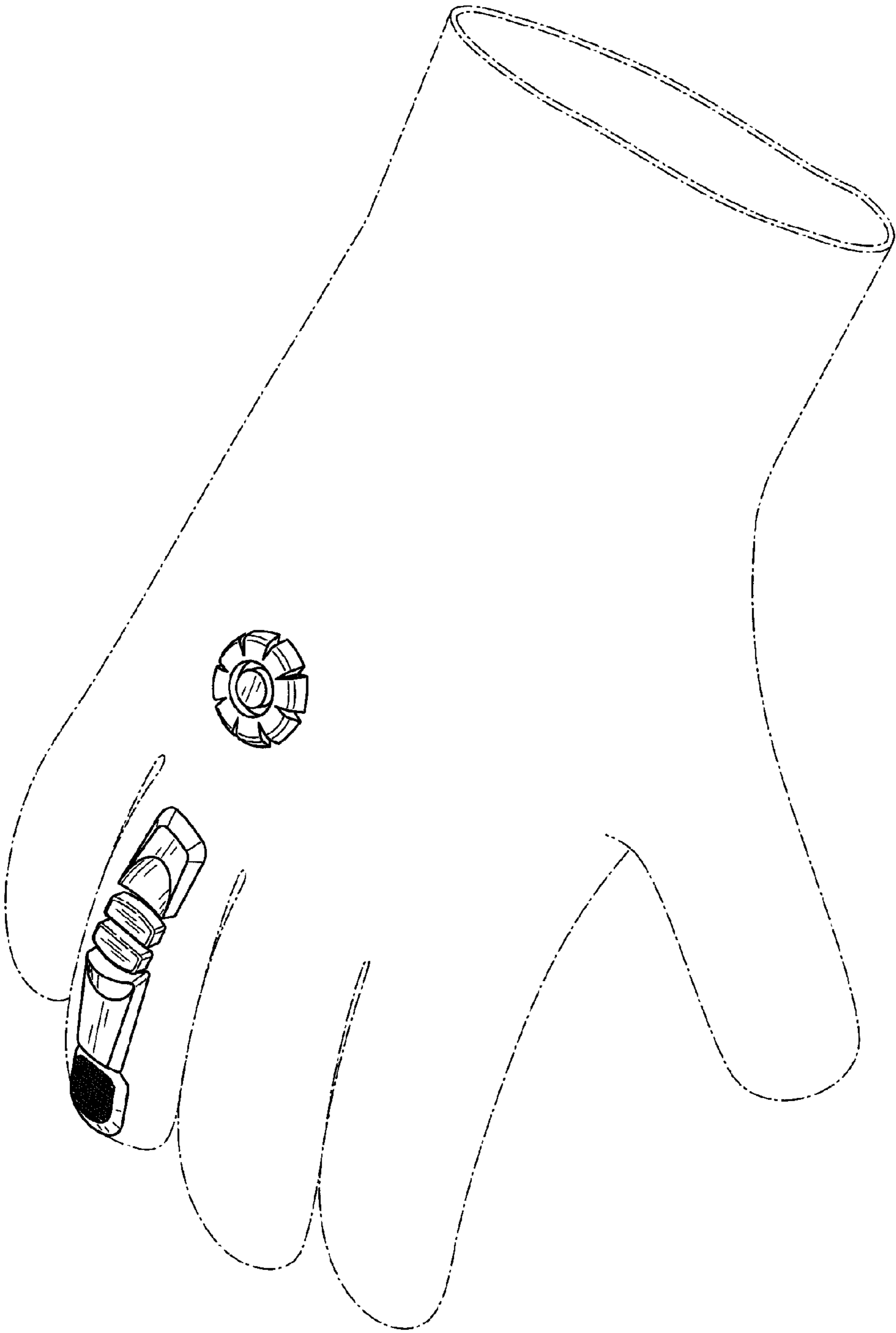
