(57) **CLAIM**

The ornamental design for athletic legging stripe for jeans, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the invented athletic legging stripe for jeans showing my new design.

FIG. 2 is a rear elevational view thereof.

FIG. 3 is a bottom plan view thereof.

FIG. 4 is a top plan view thereof.

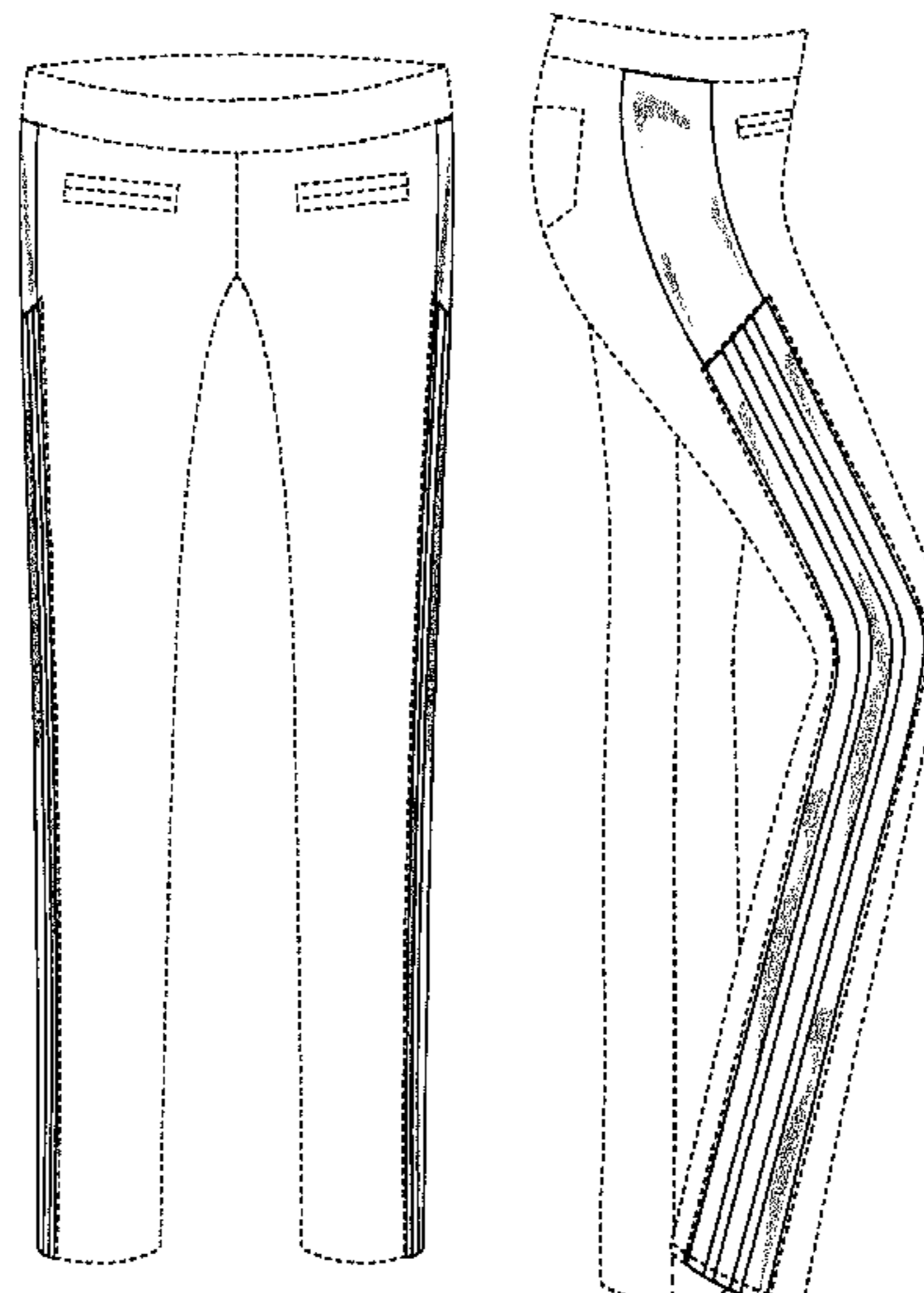
FIG. 5 is a side elevational view thereof, the opposite side being a mirror image thereof.

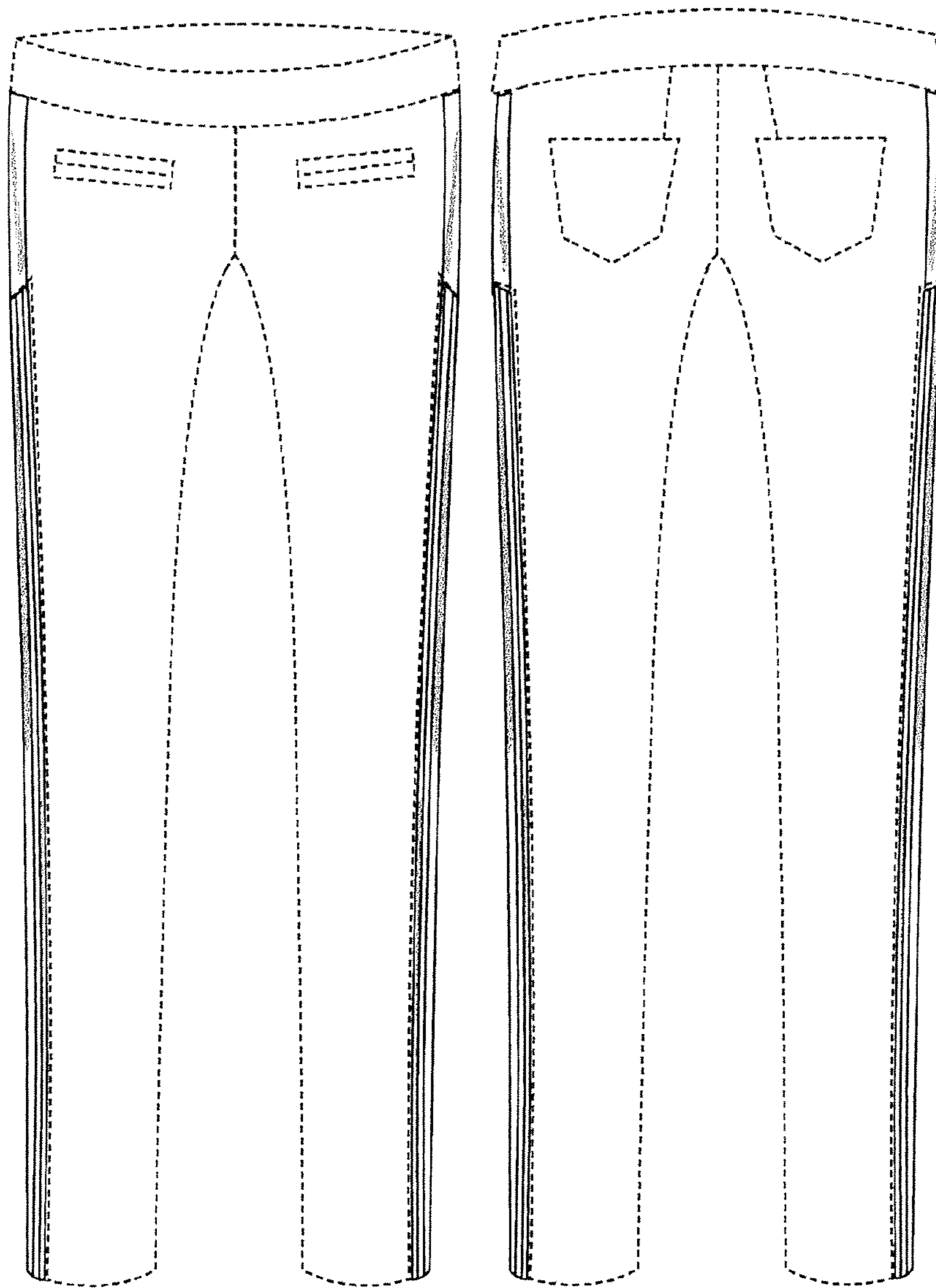
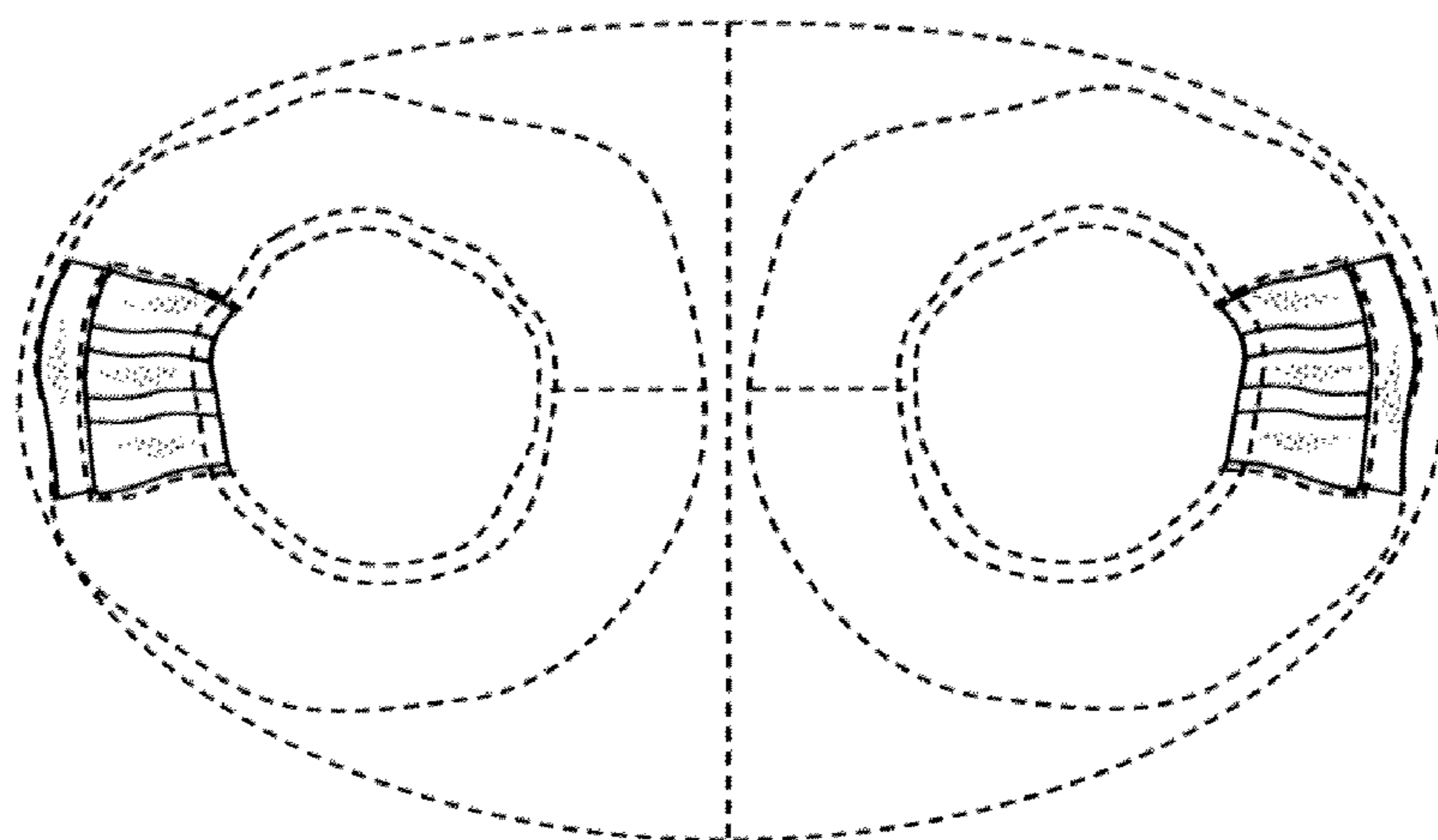
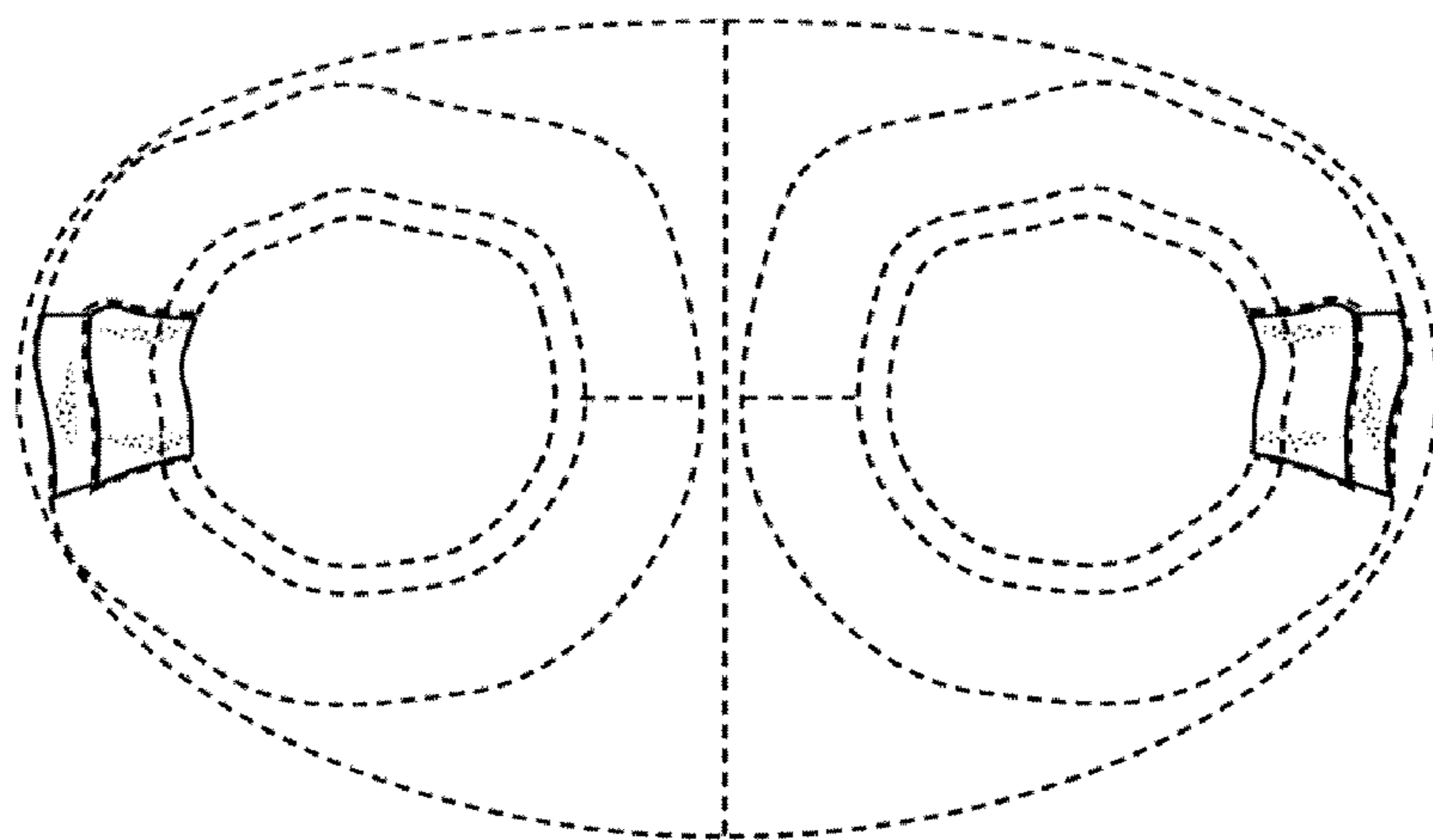

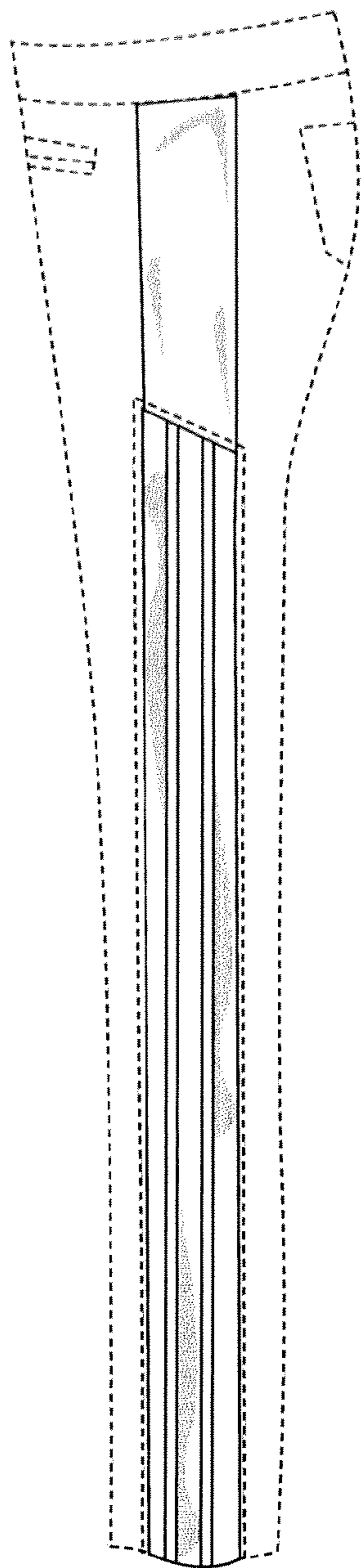

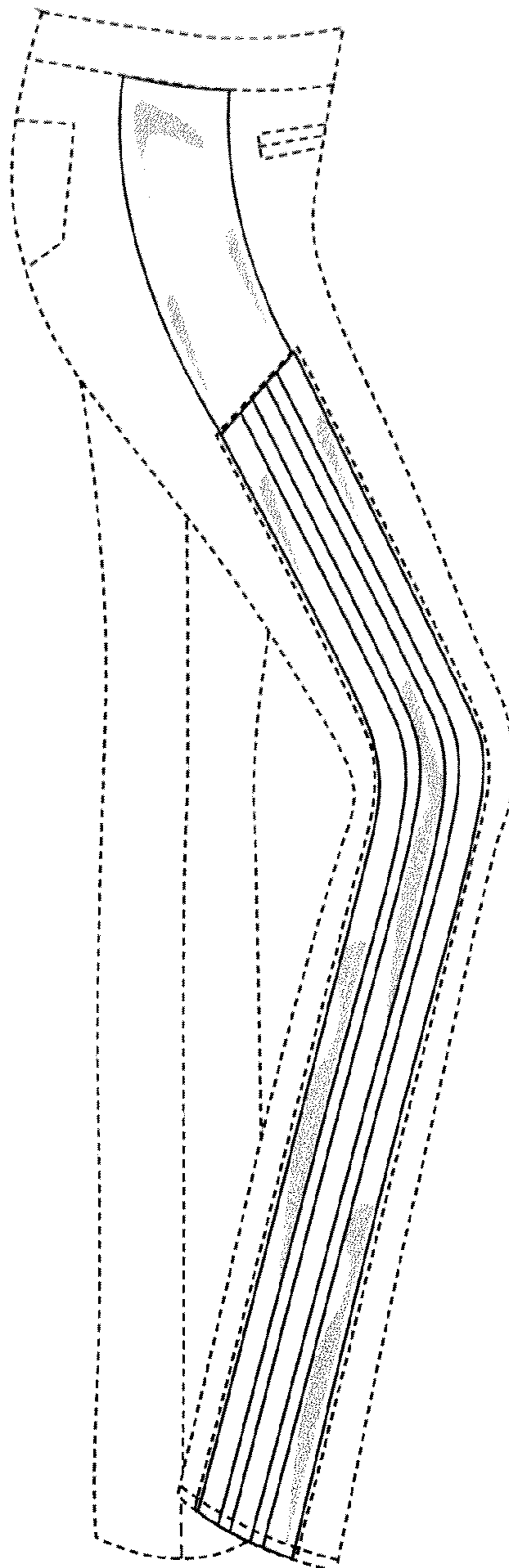
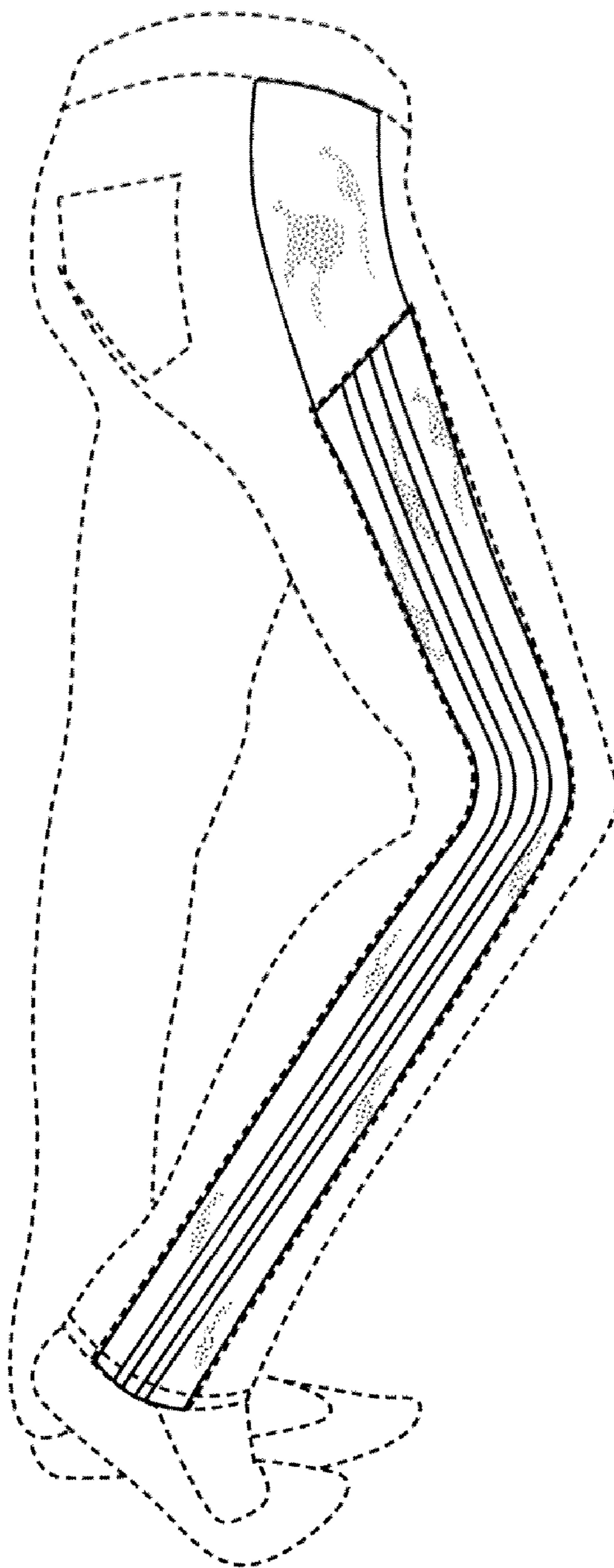
