FIG. 4 is a top view of the shoe shown in FIG. 1;

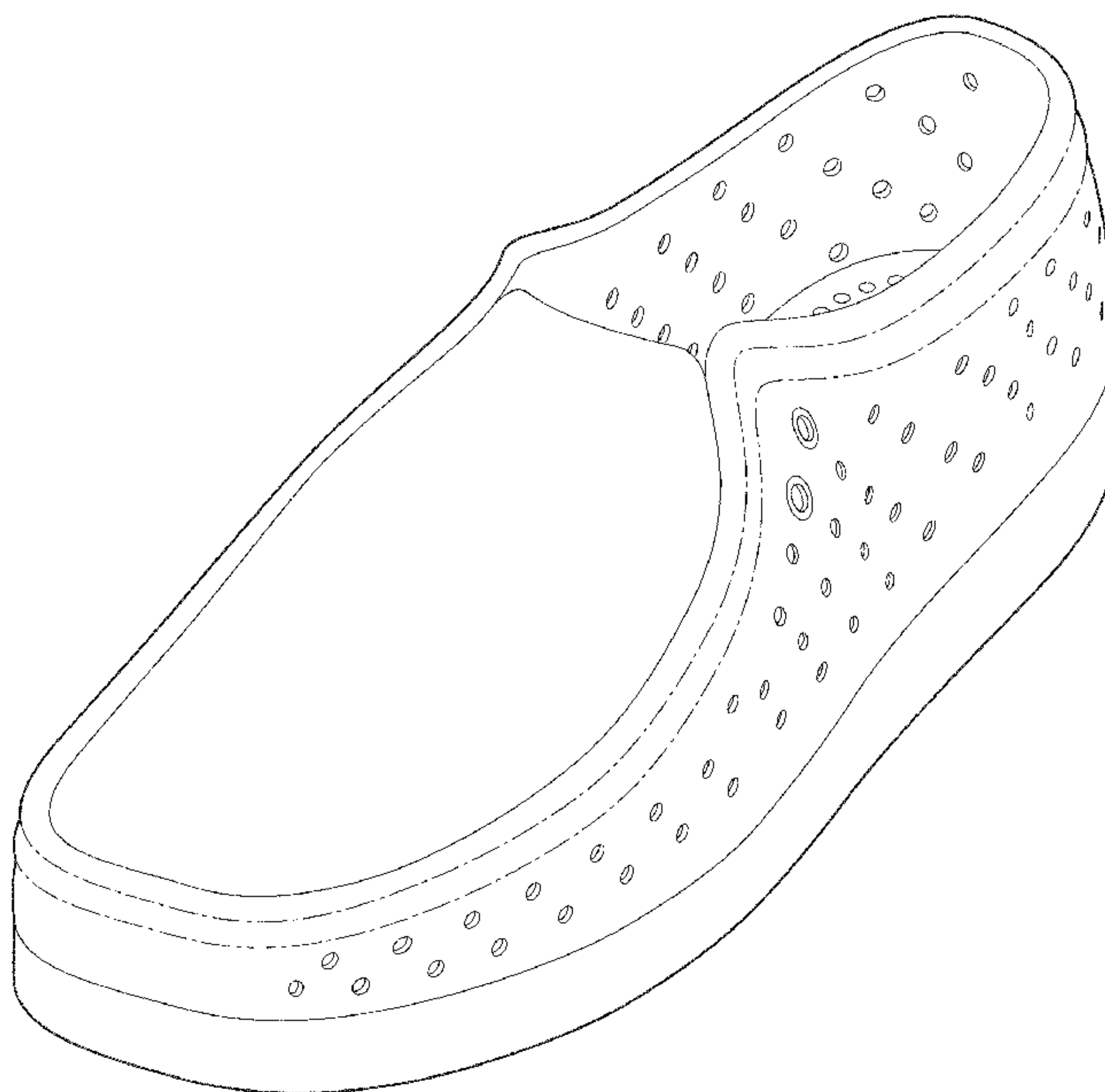
FIG. 5 is a rear view of the shoe shown in FIG. 1;

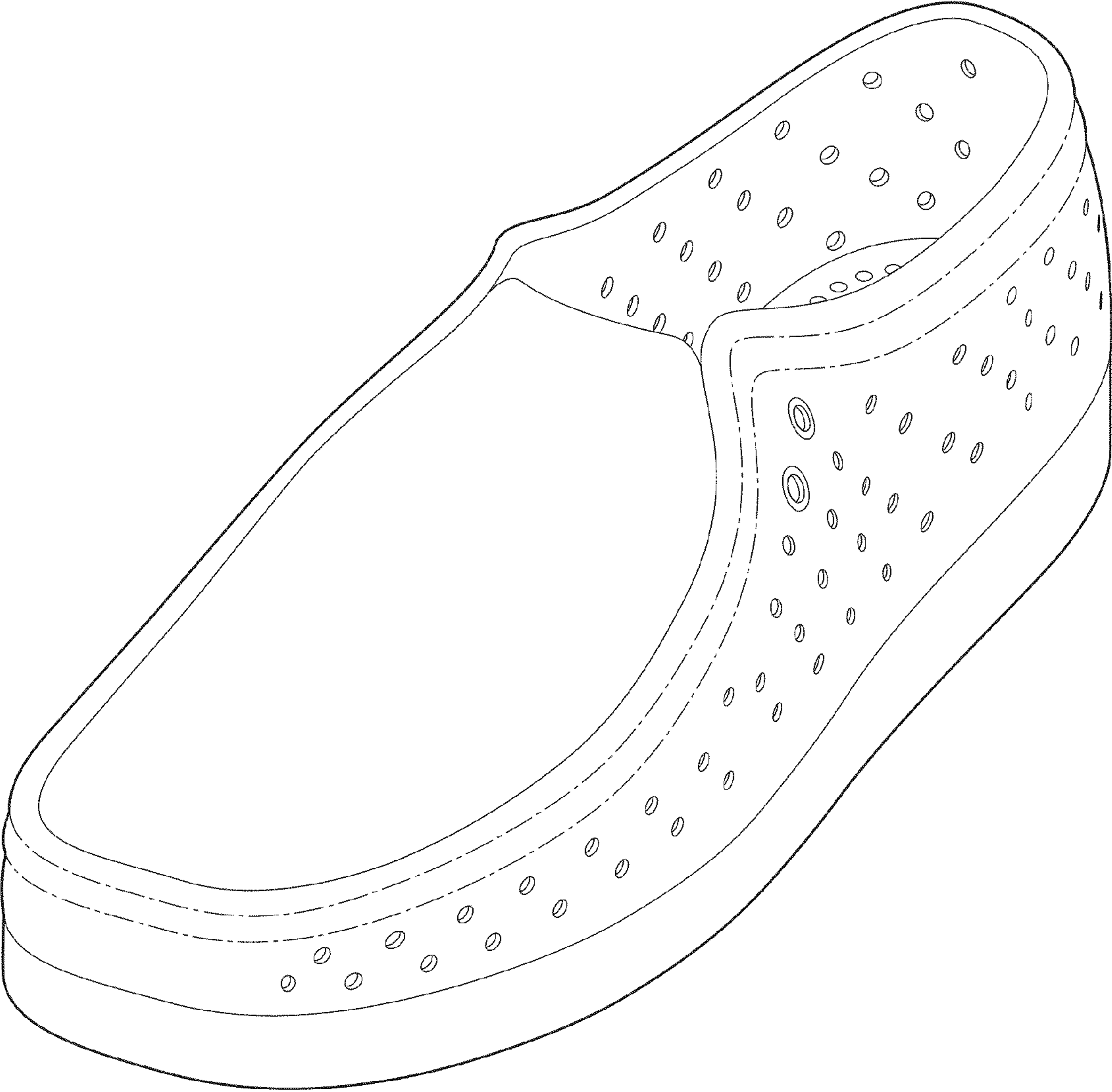
FIG. 6 is a front view of the shoe shown in FIG. 1; and,

FIG. 7 is a bottom view of the shoe shown in FIG. 1.

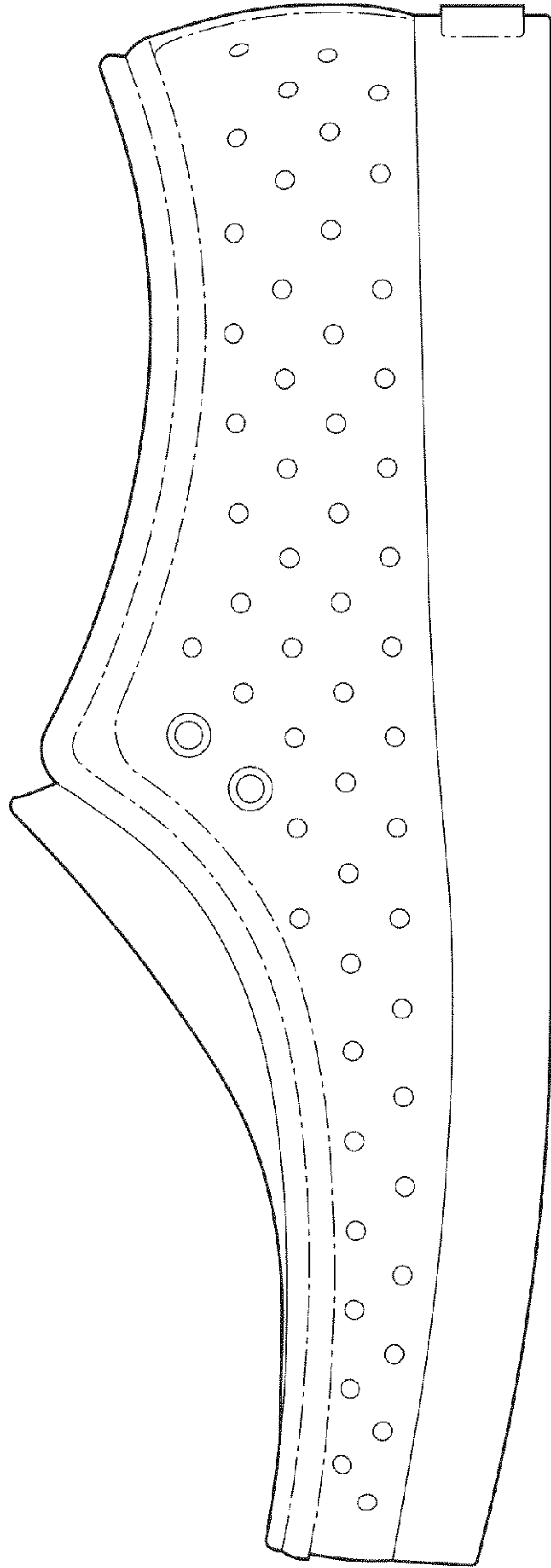

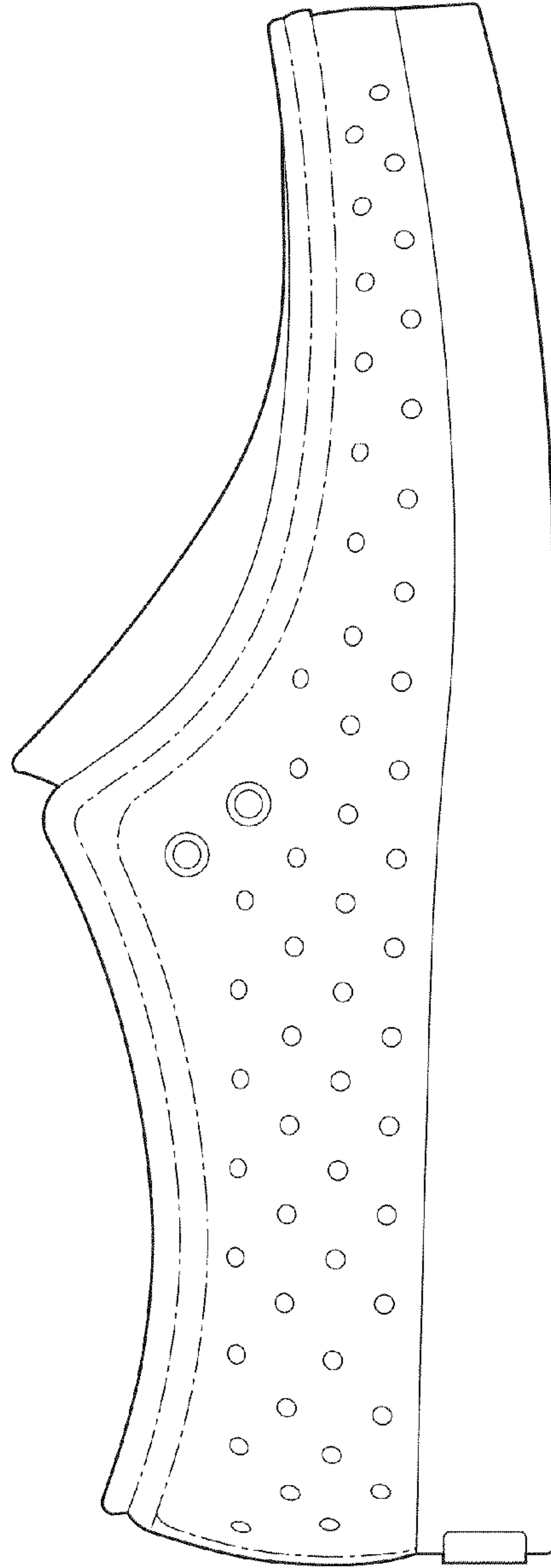




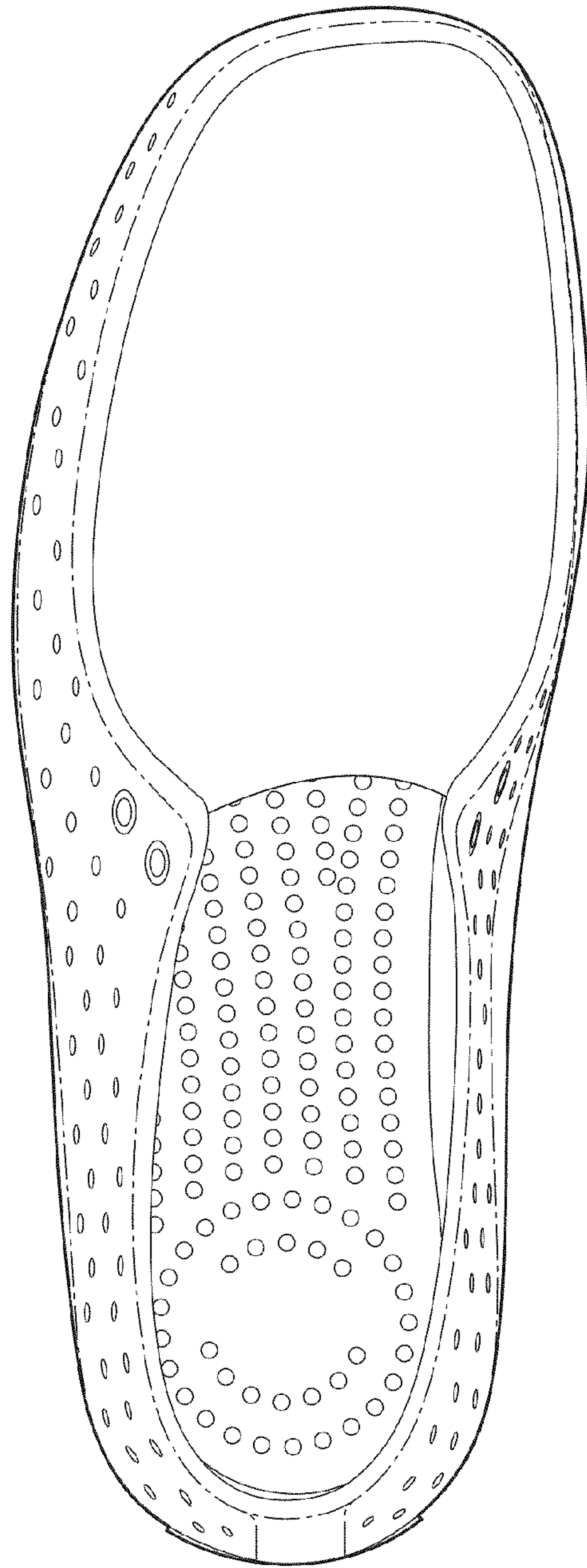

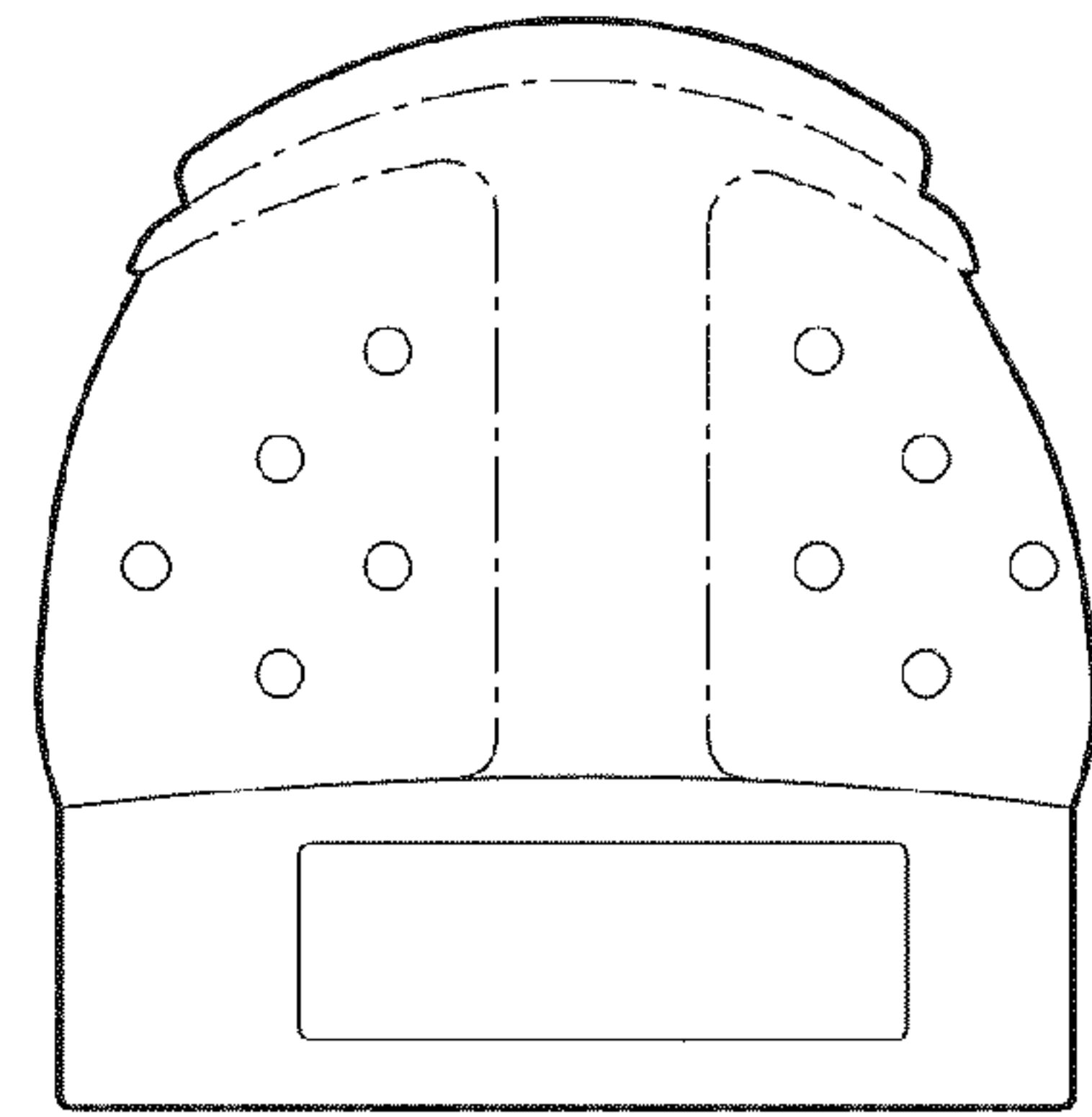

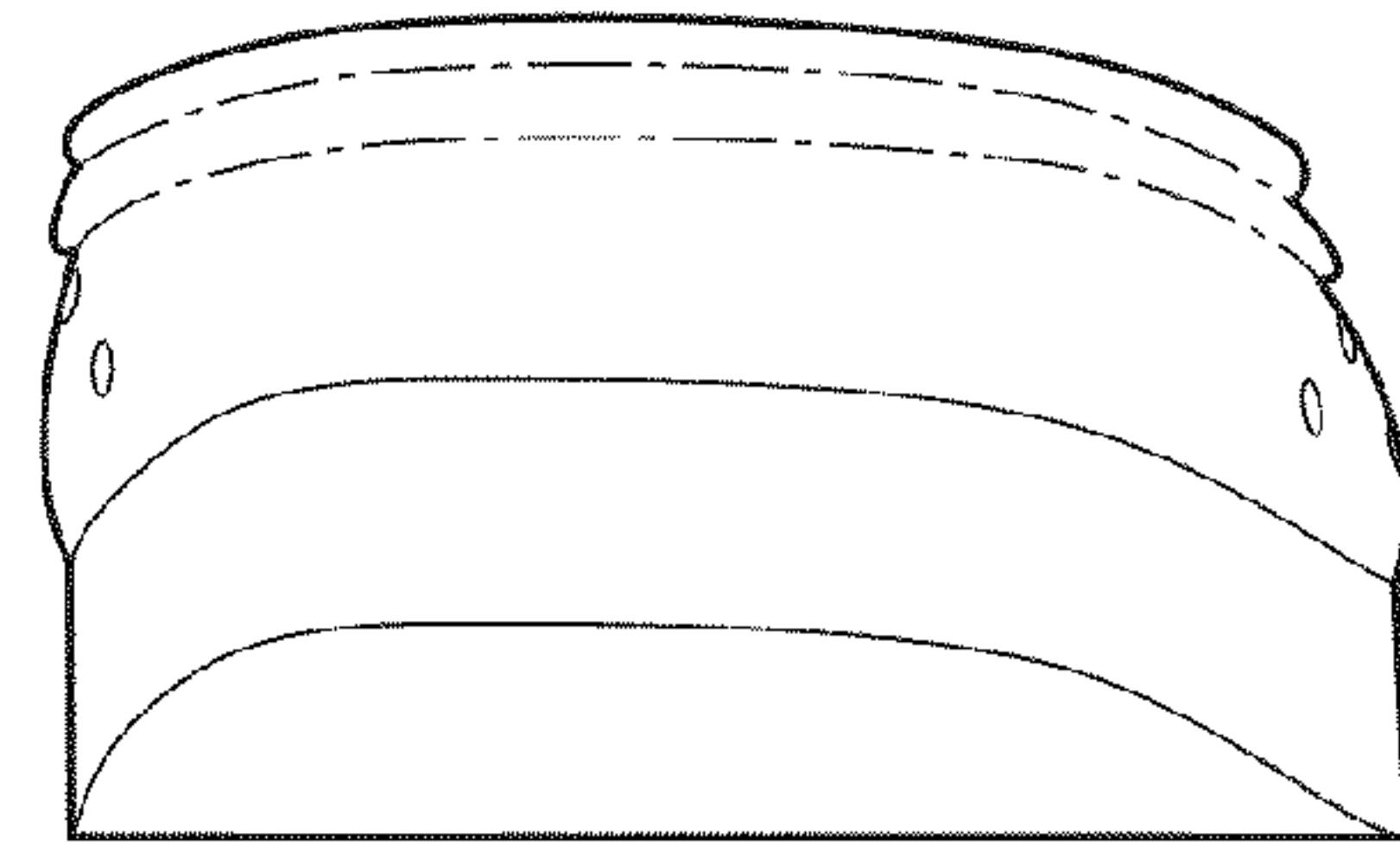

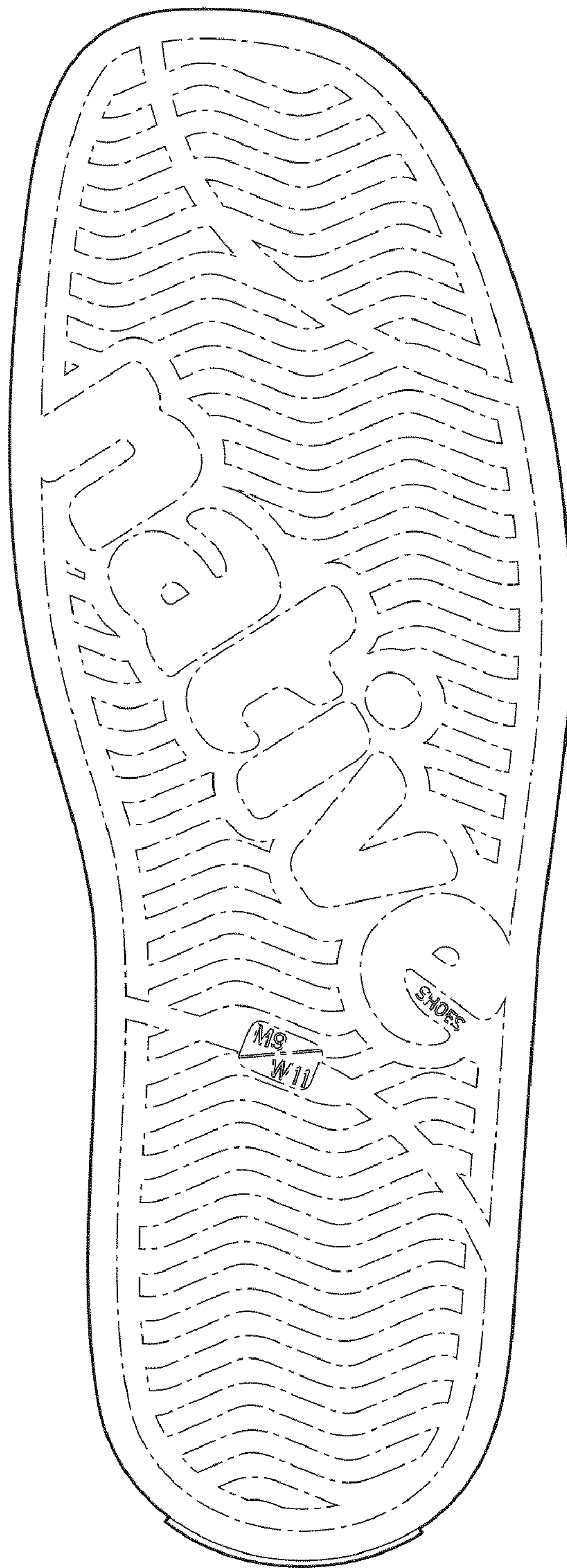
