FIG. 9 is a front perspective view of the garment bag in another partially folded condition.

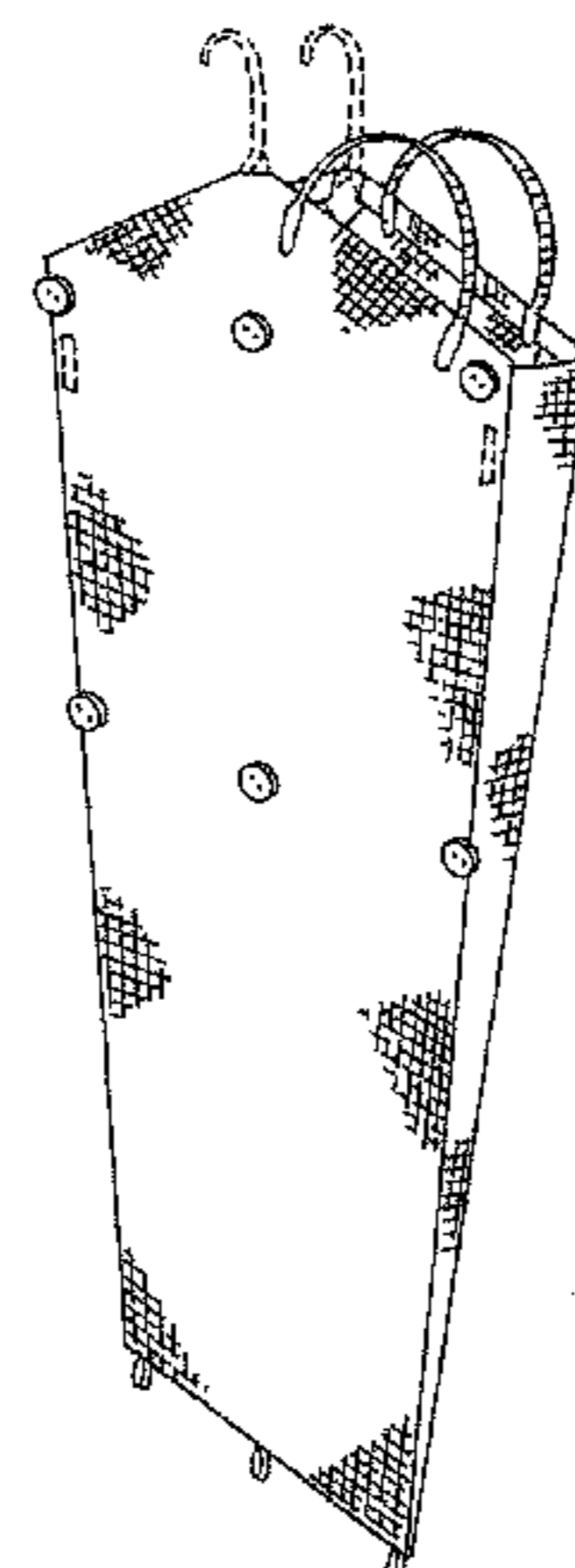
FIG. 10 is a front perspective view of the garment bag in an open condition showing internal flaps folded out;

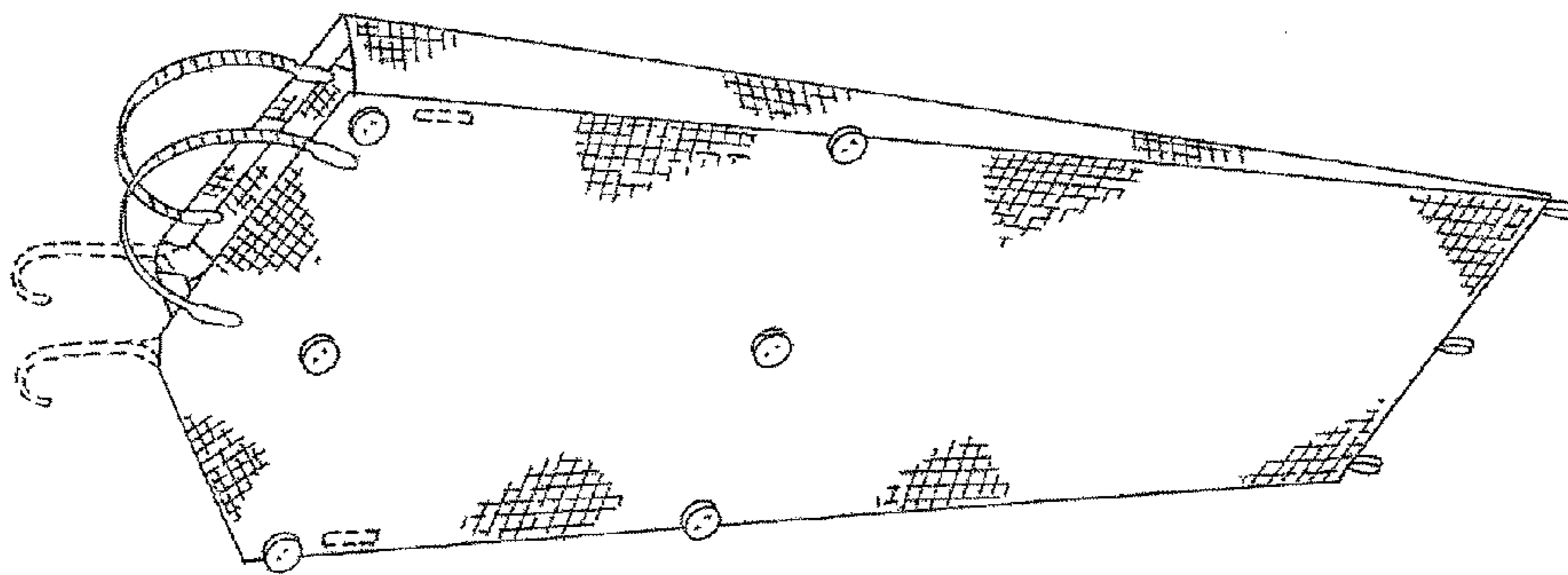

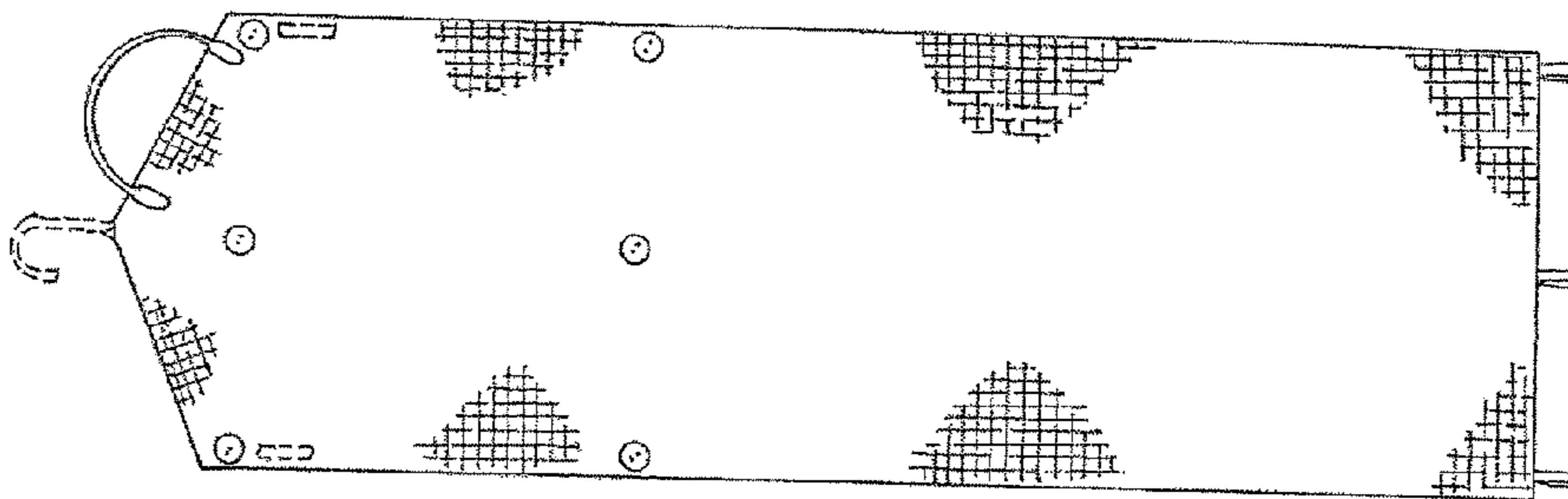

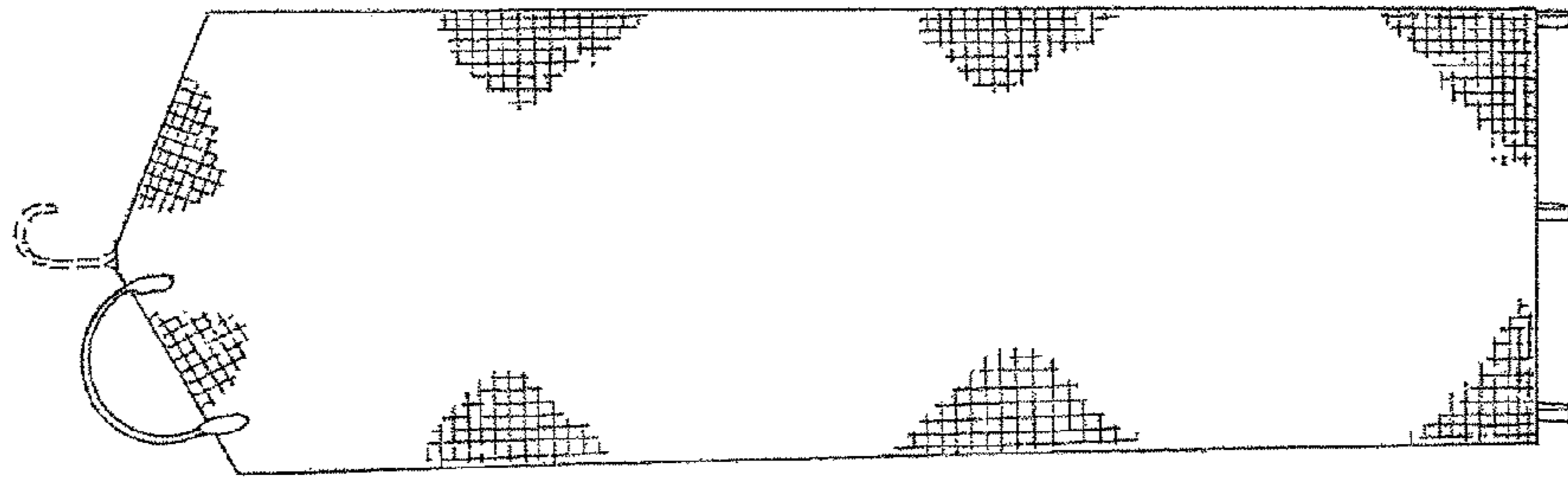

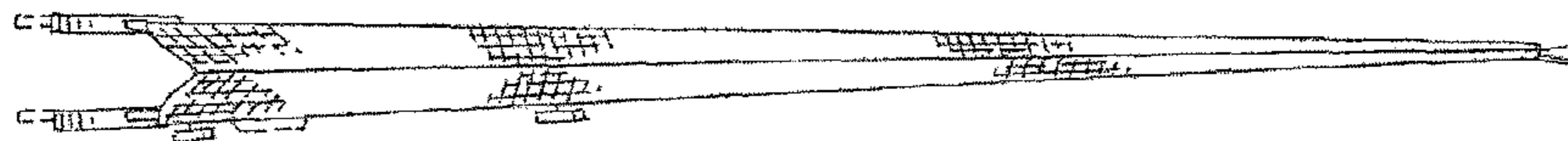

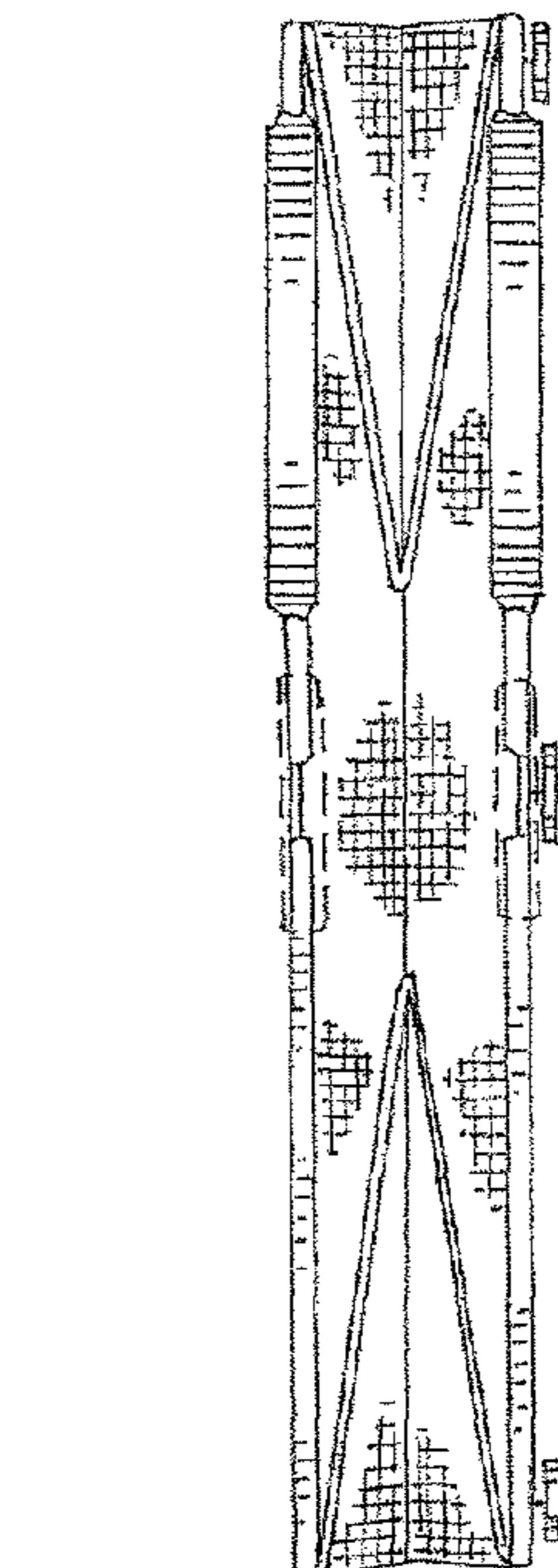

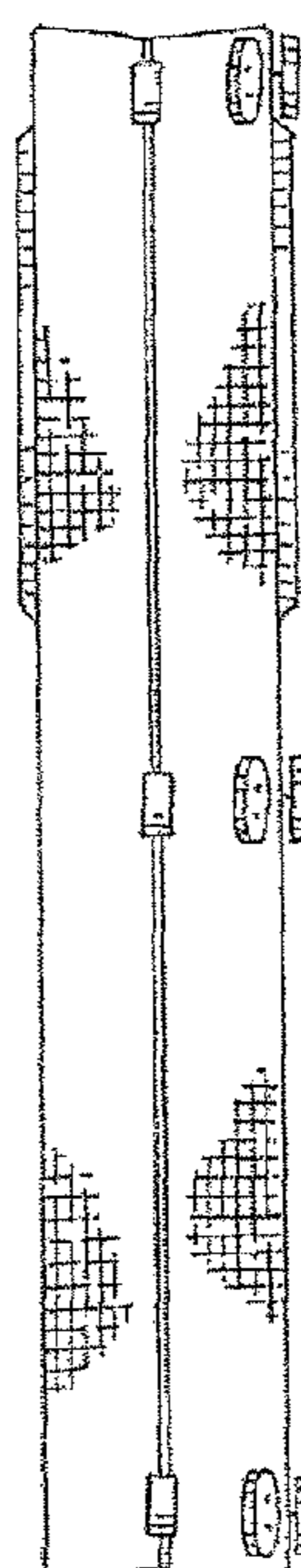
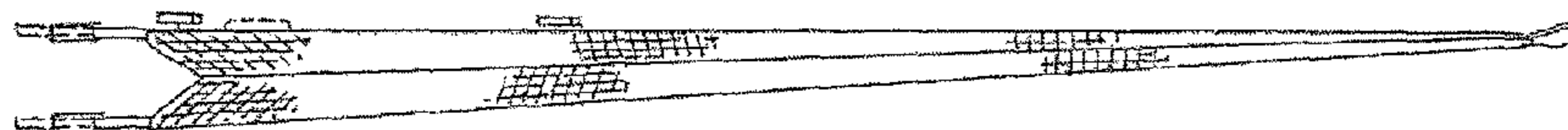

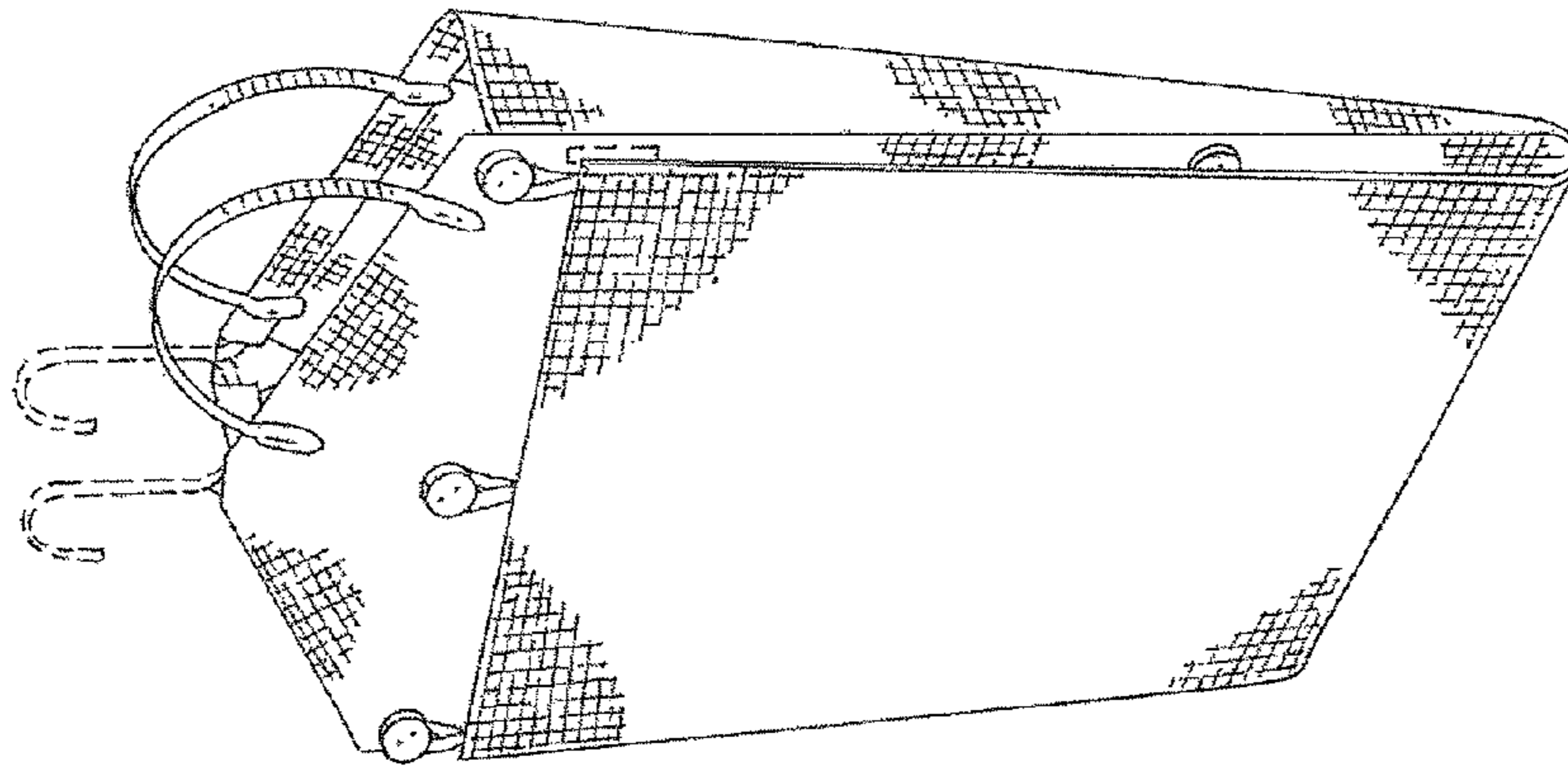

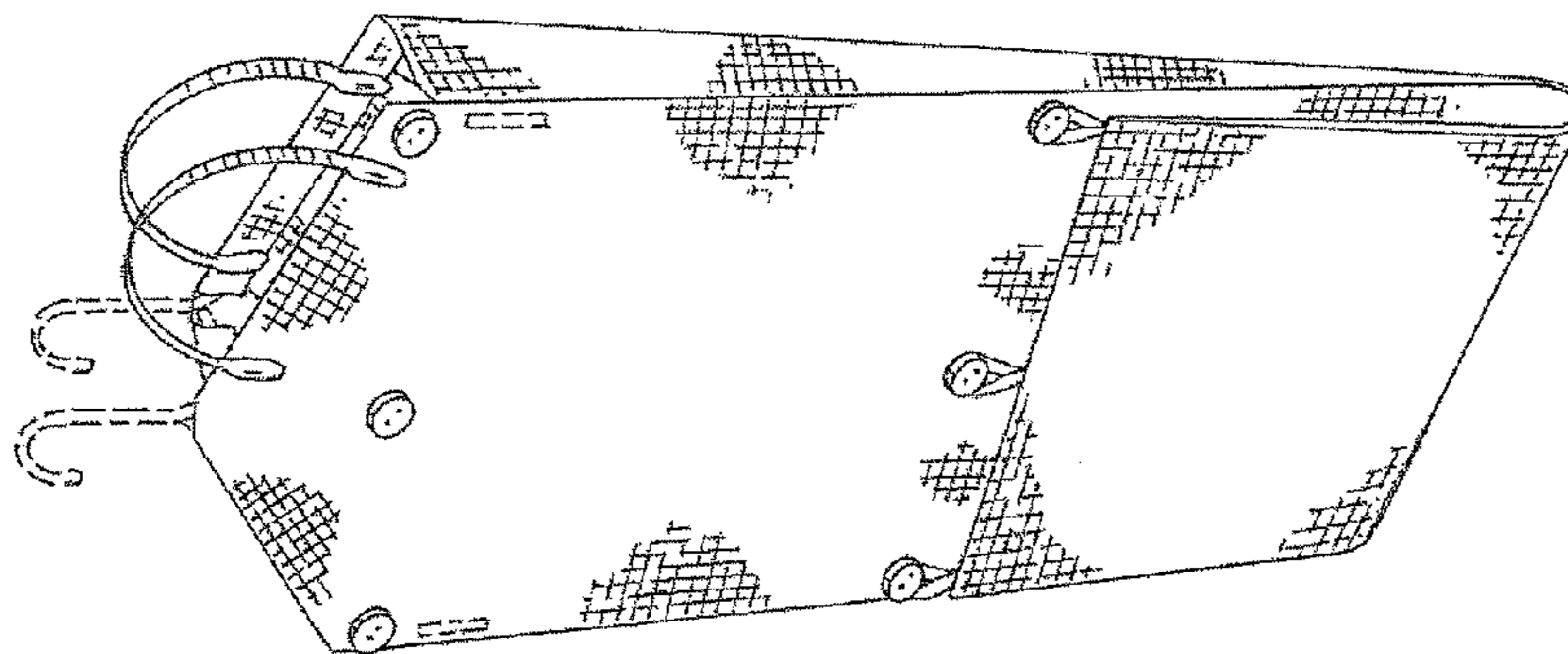

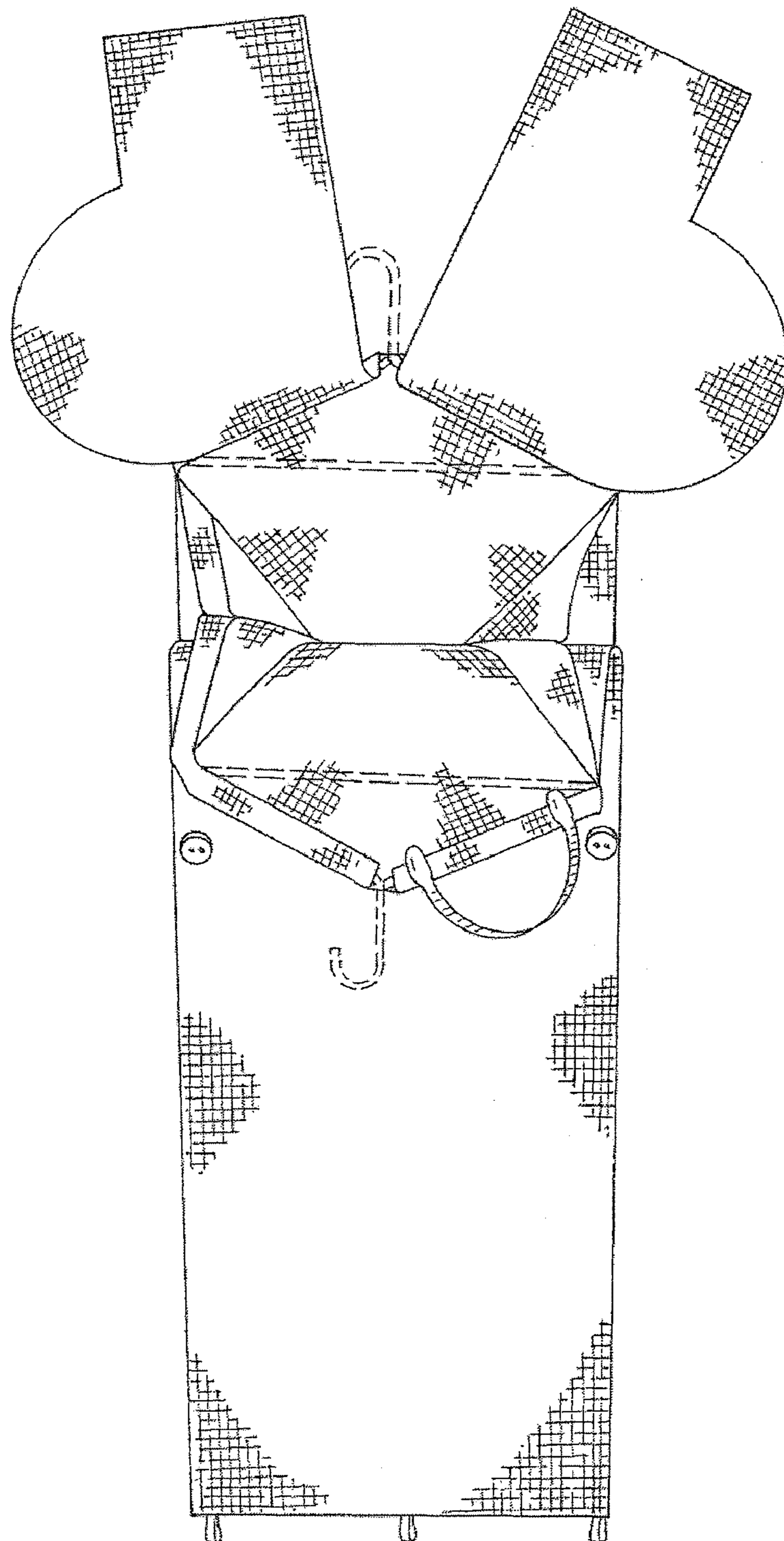

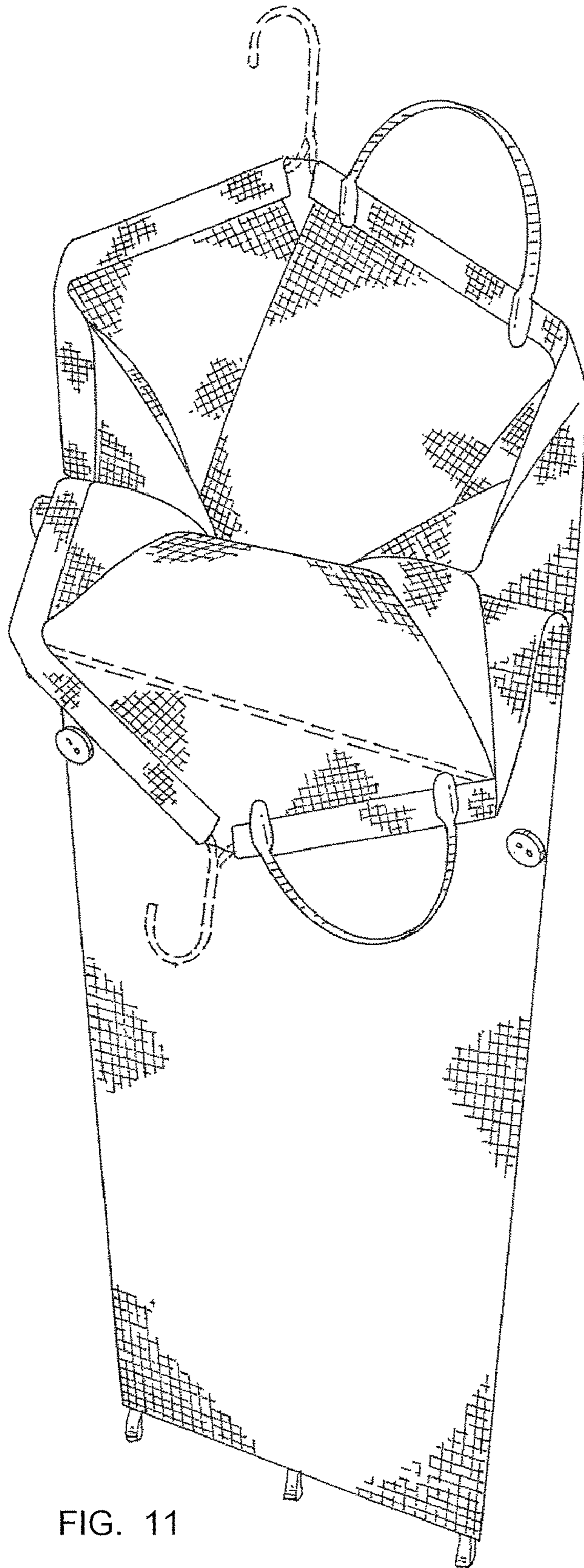

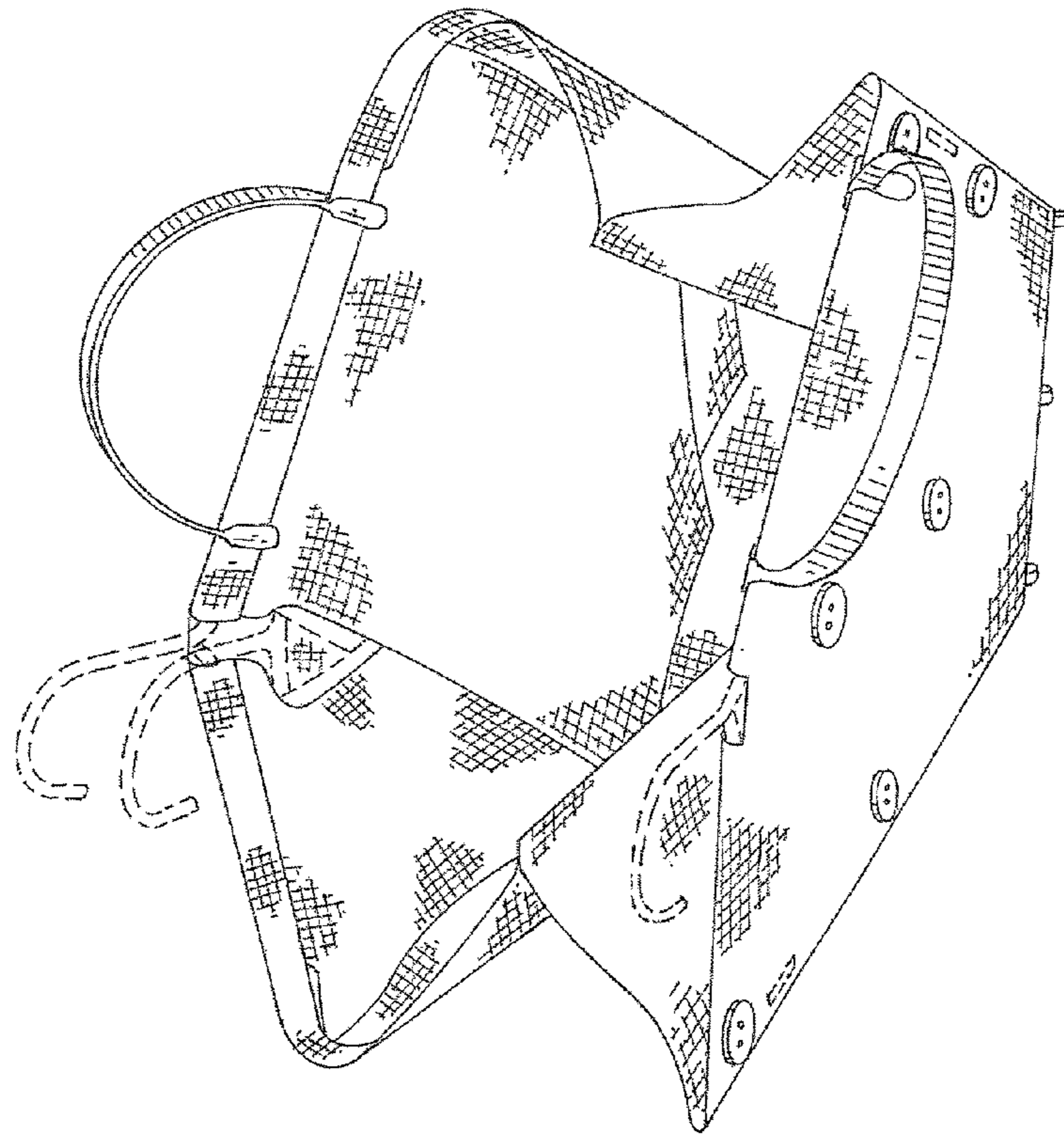
