We claim the ornamental design for a sheet material with surface pattern, as shown and described.

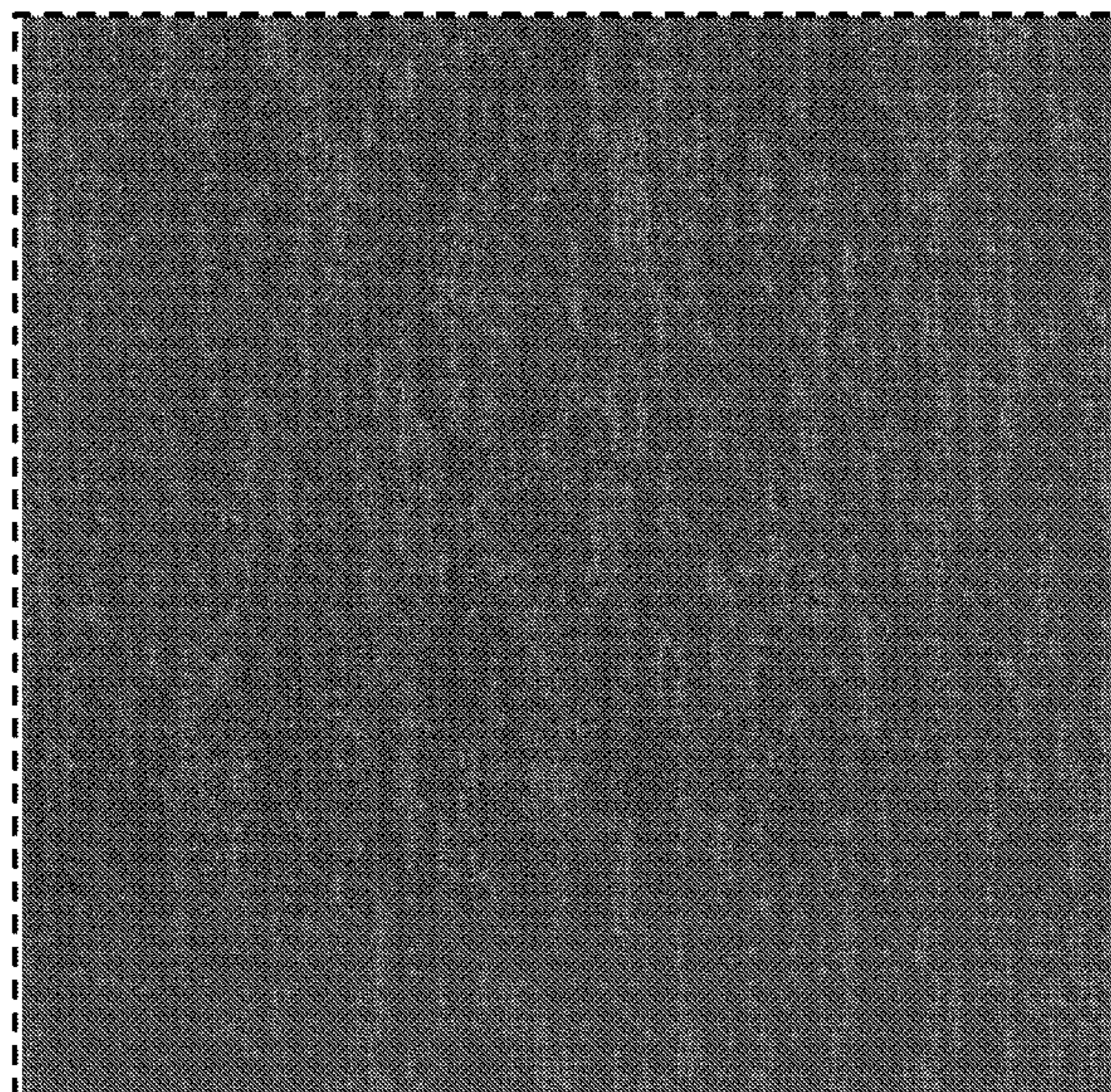
**DESCRIPTION**

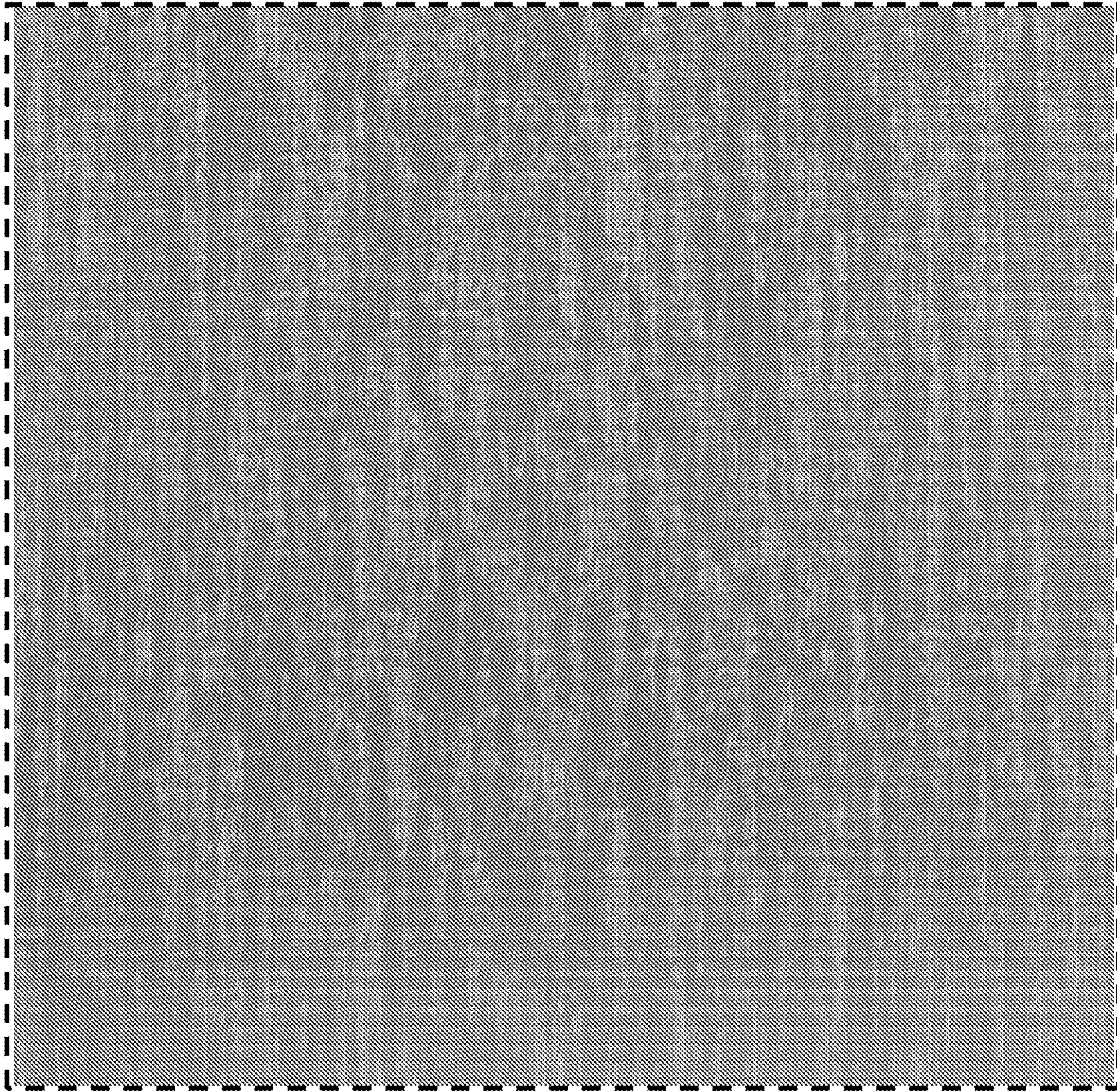
The sole FIGURE is a plan view of a sheet material with surface pattern.
