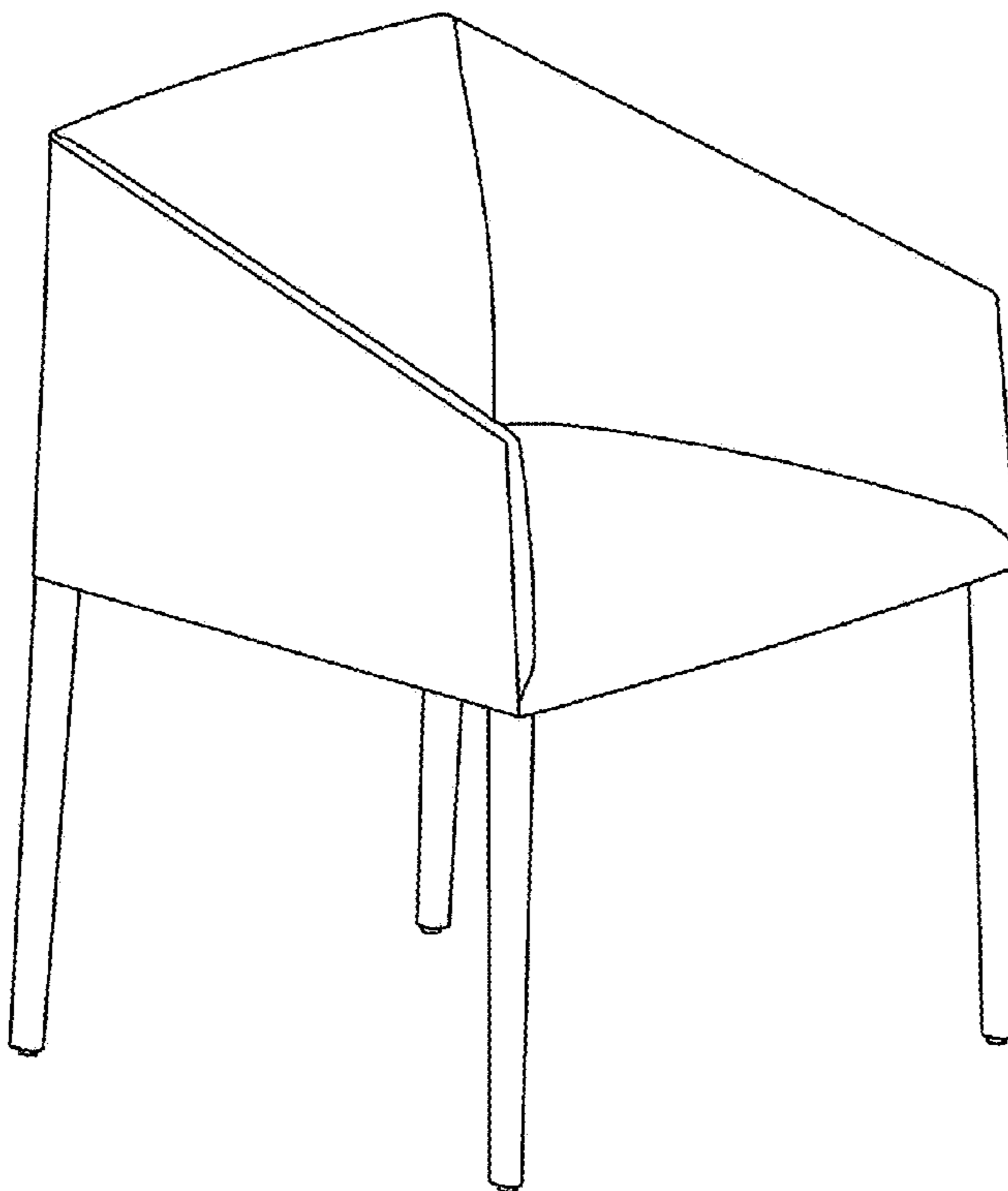
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an armchair, showing my new design from the front, top and right side;

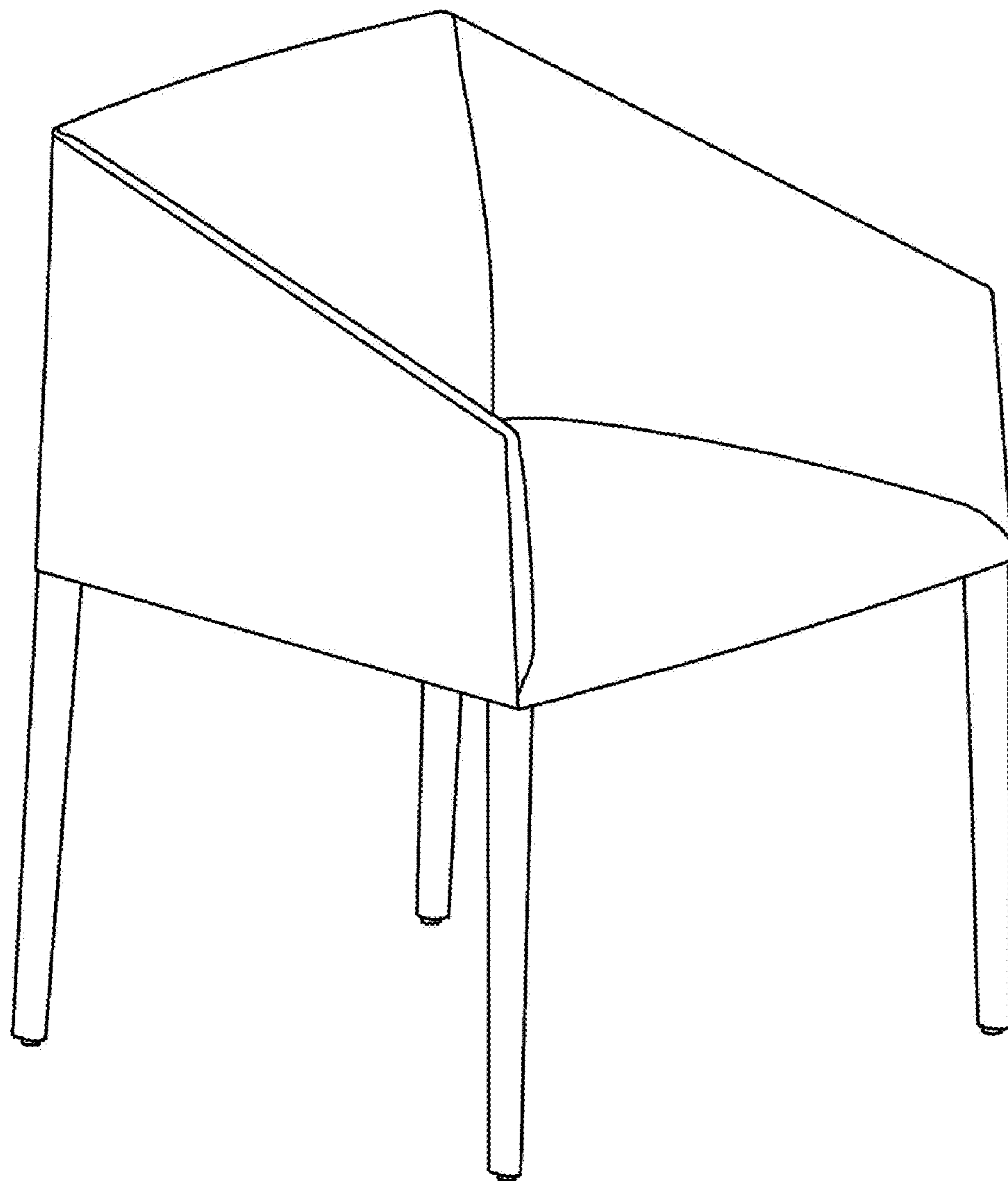

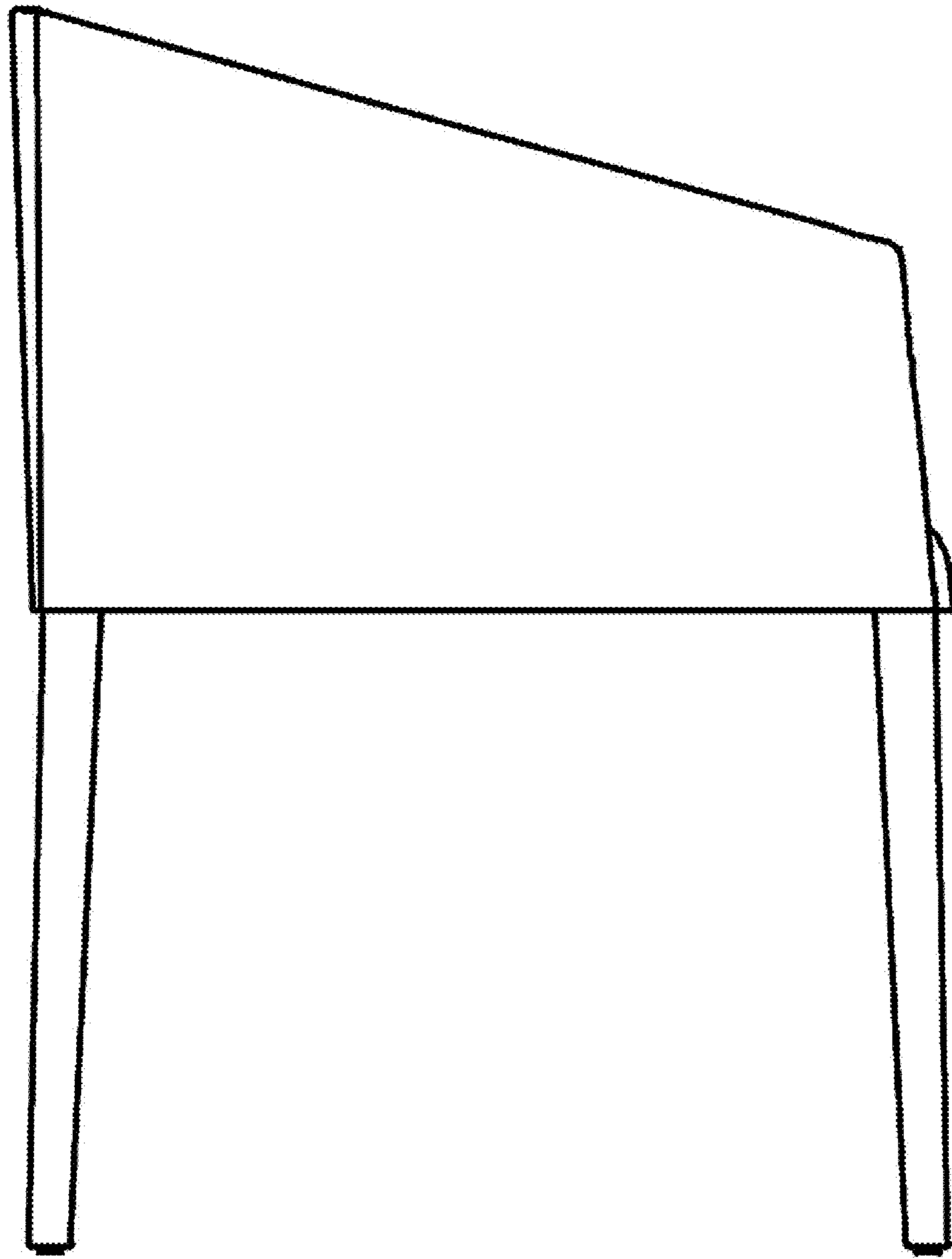

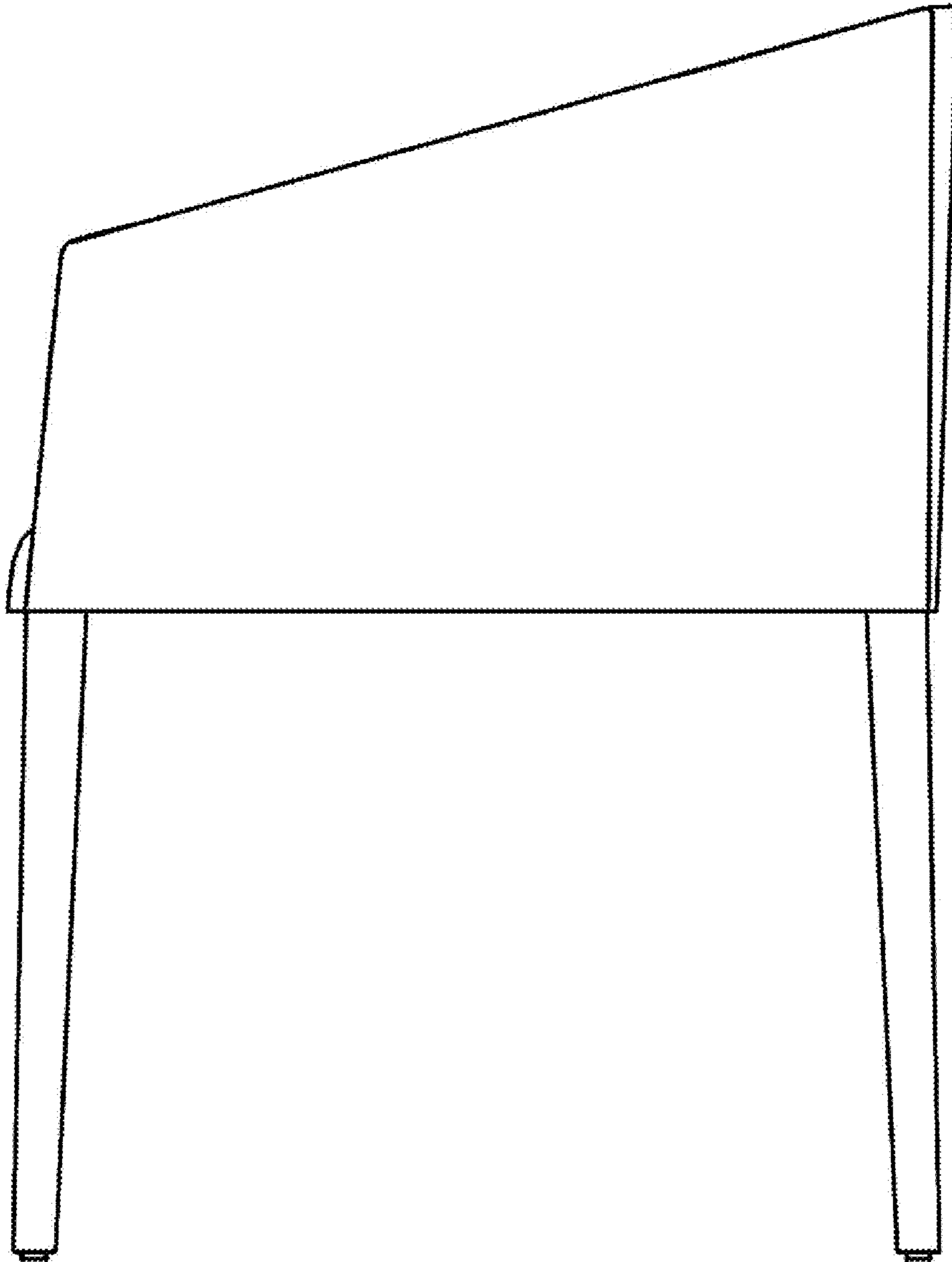

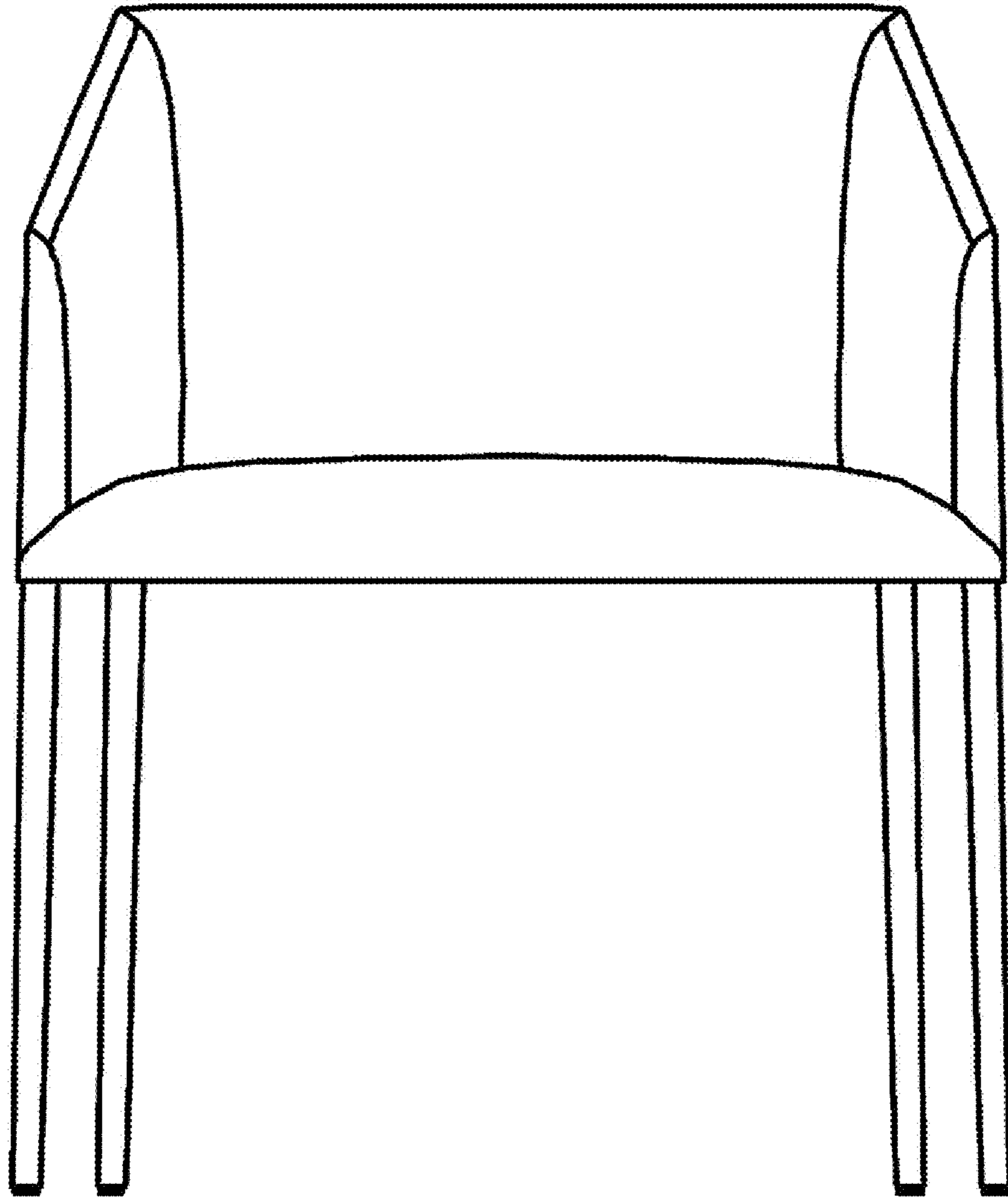

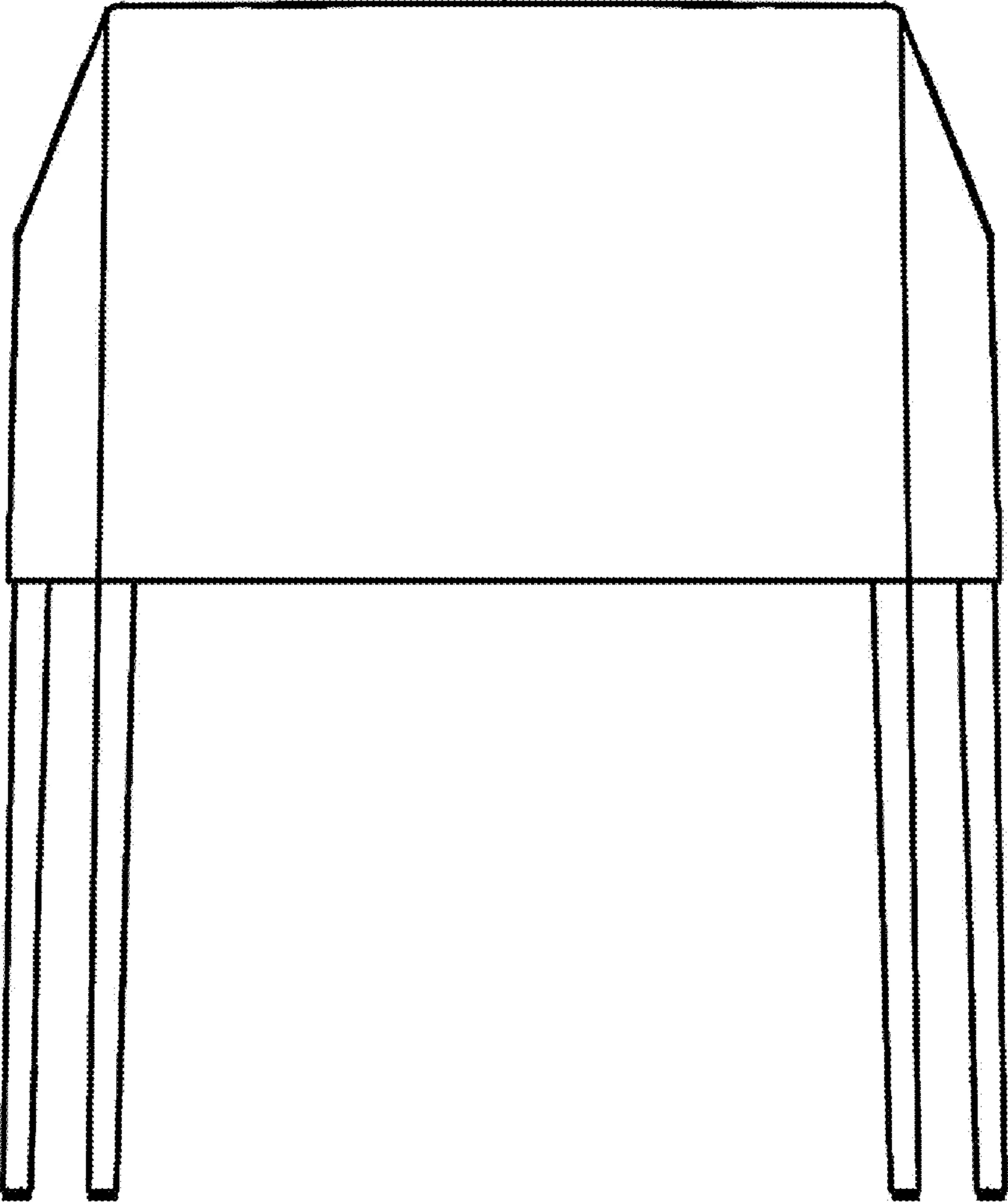

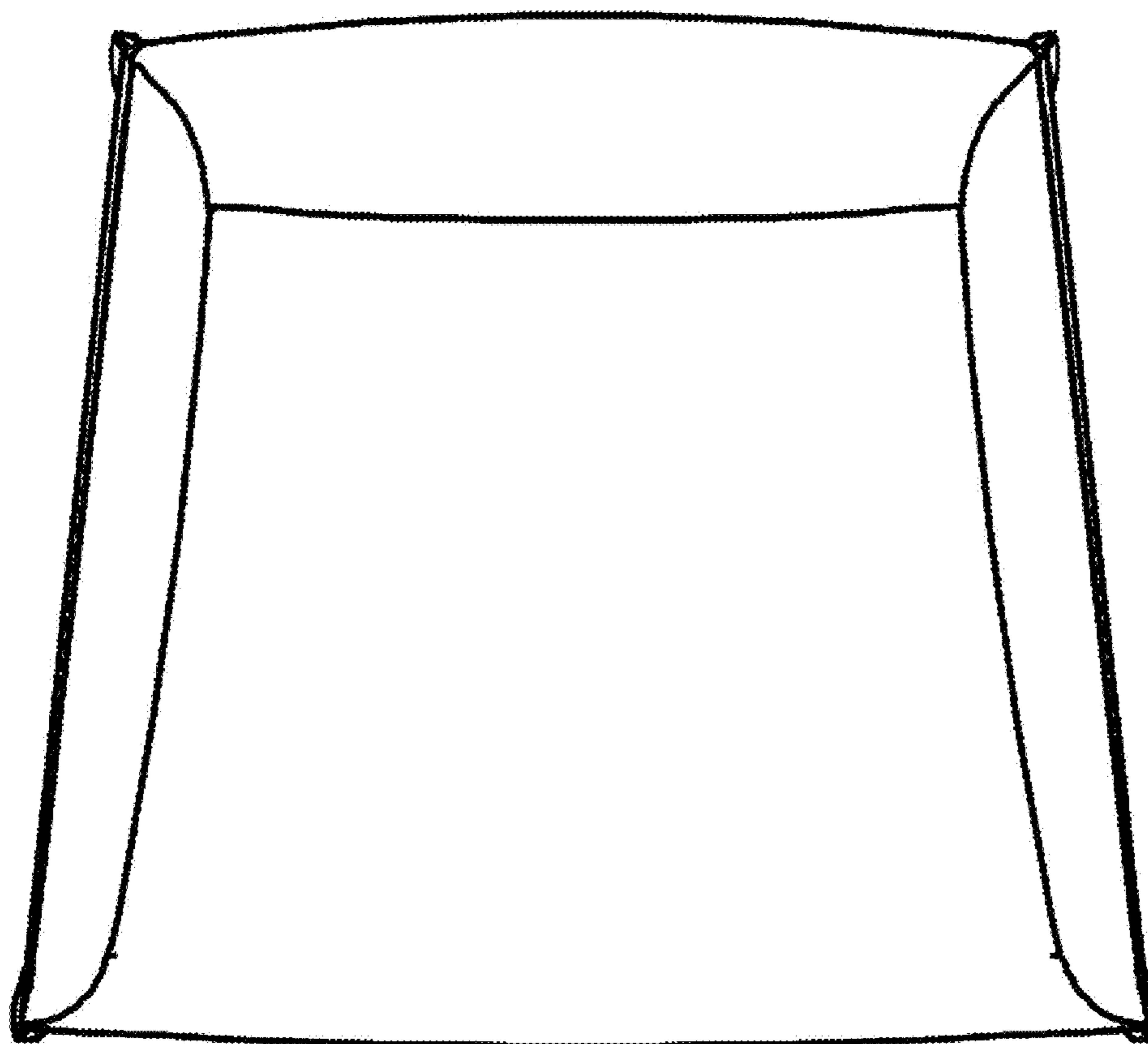

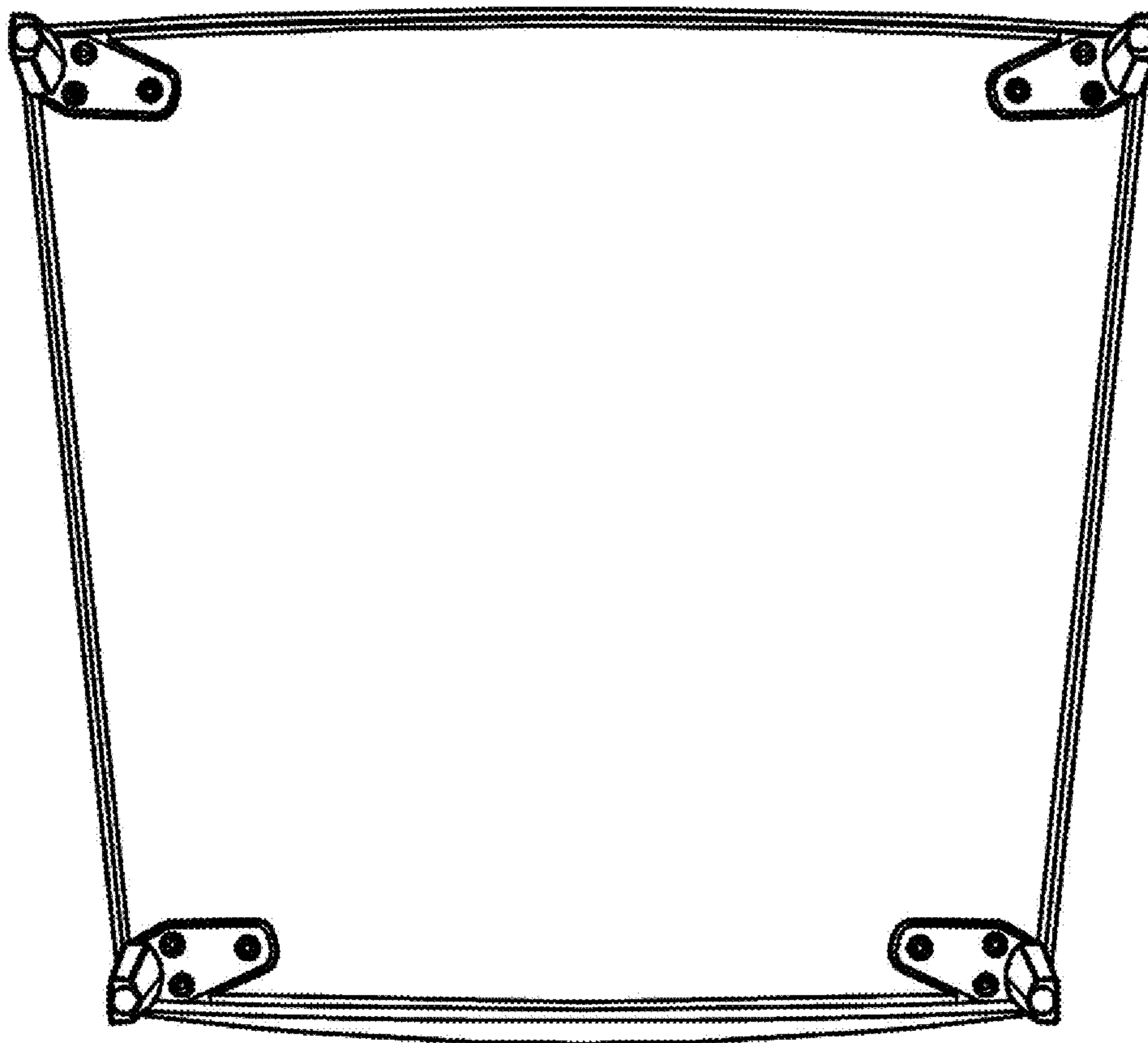
