The ornamental design for a pillow case with corner holders, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a pillow case with corner holders showing our new design;

FIG. 2 is a top plan view of the pillow case with corner holders as shown in FIG. 1;

FIG. 3 is a bottom plan view of the pillow case with corner holders as shown in FIG. 1;

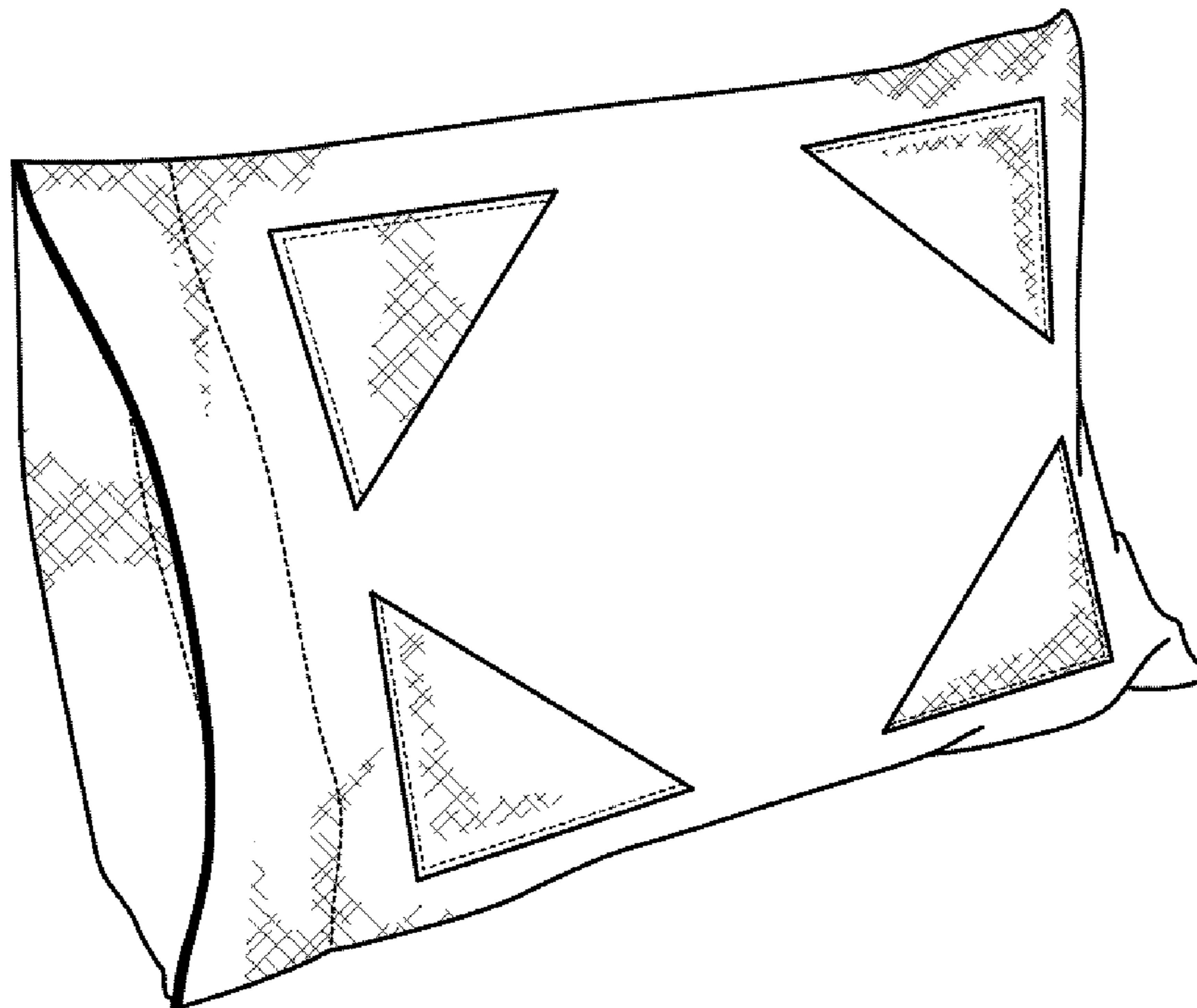
FIG. 4 is a right elevational view of the pillow case with corner holders as shown in FIG. 1;

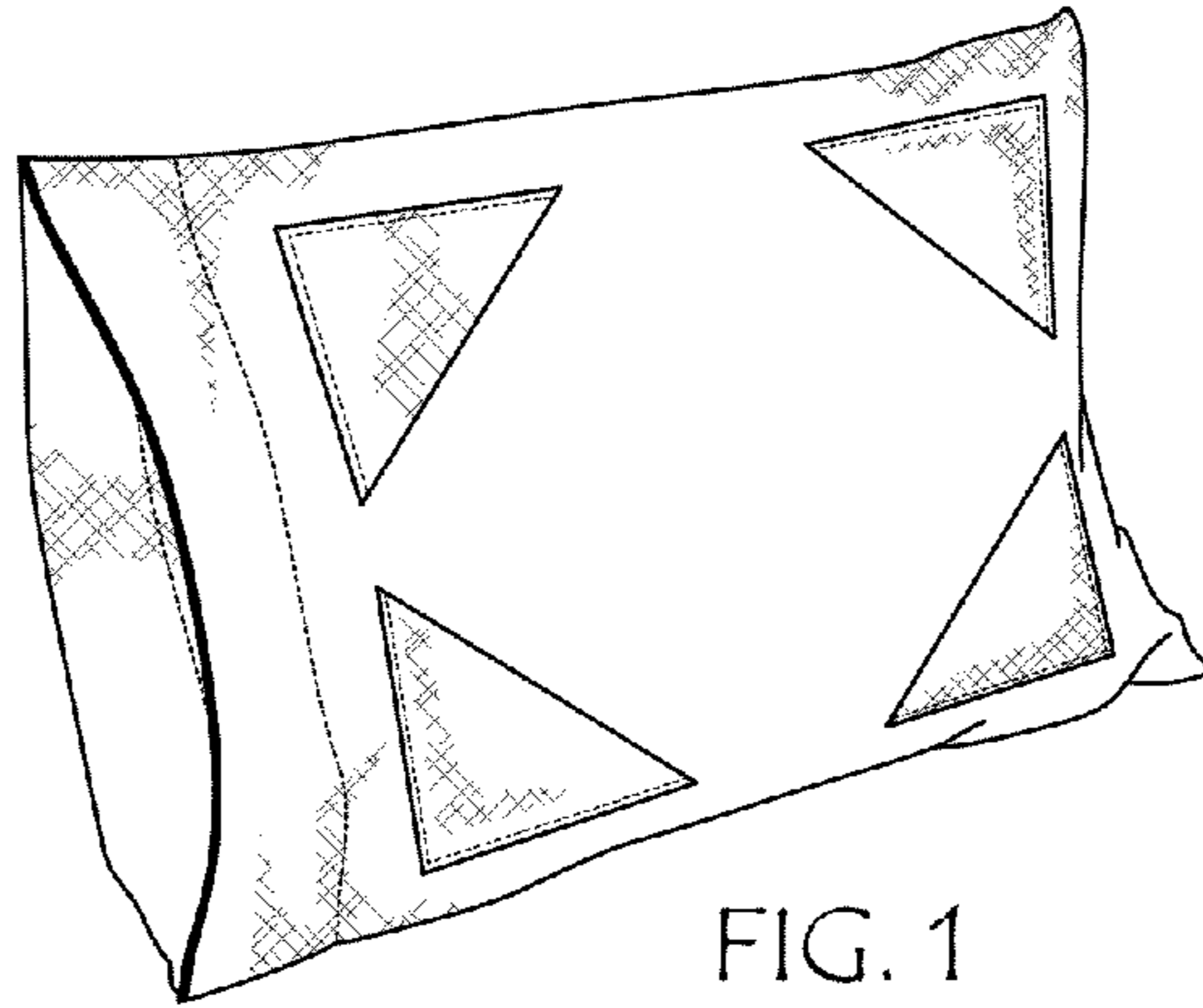

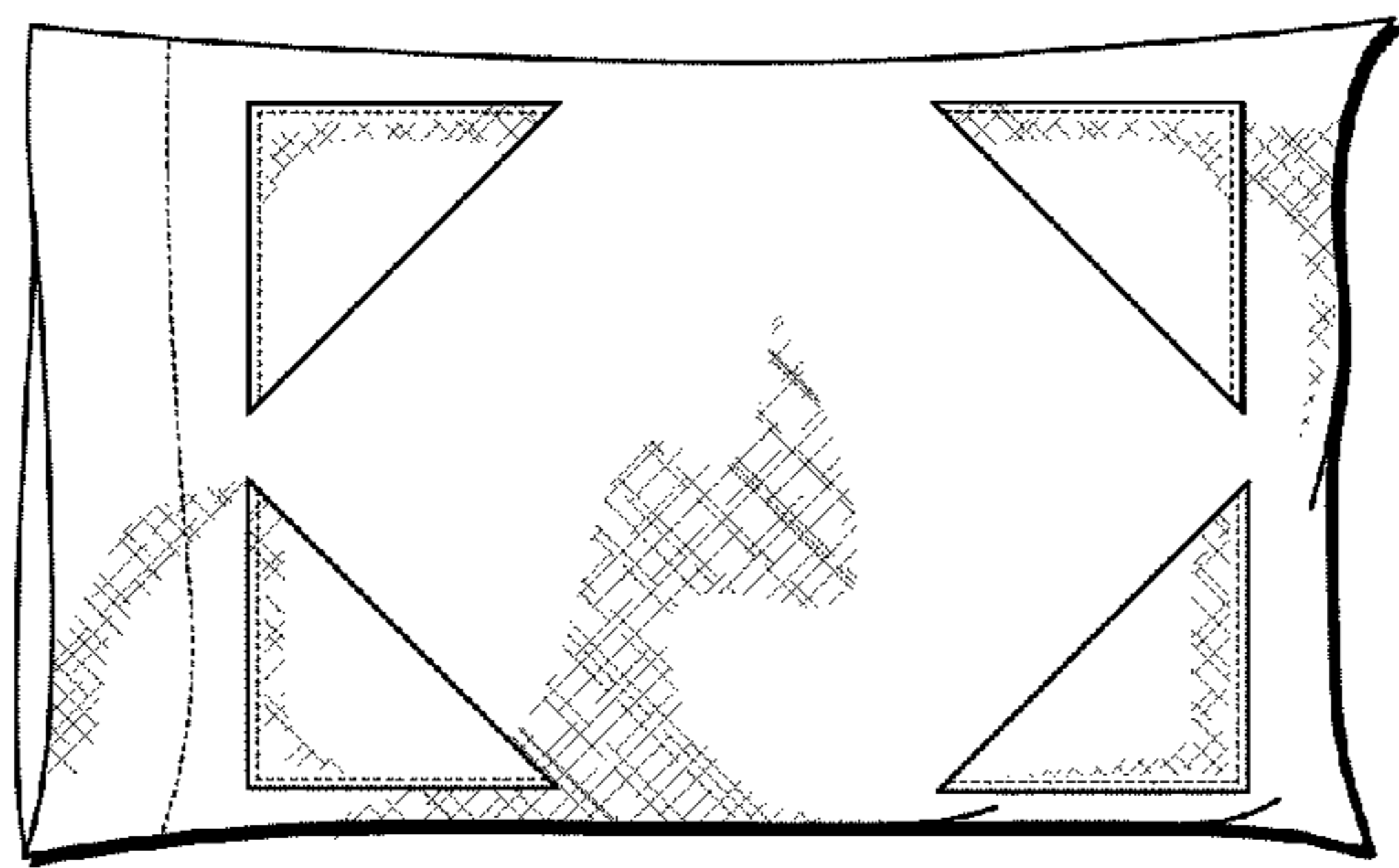

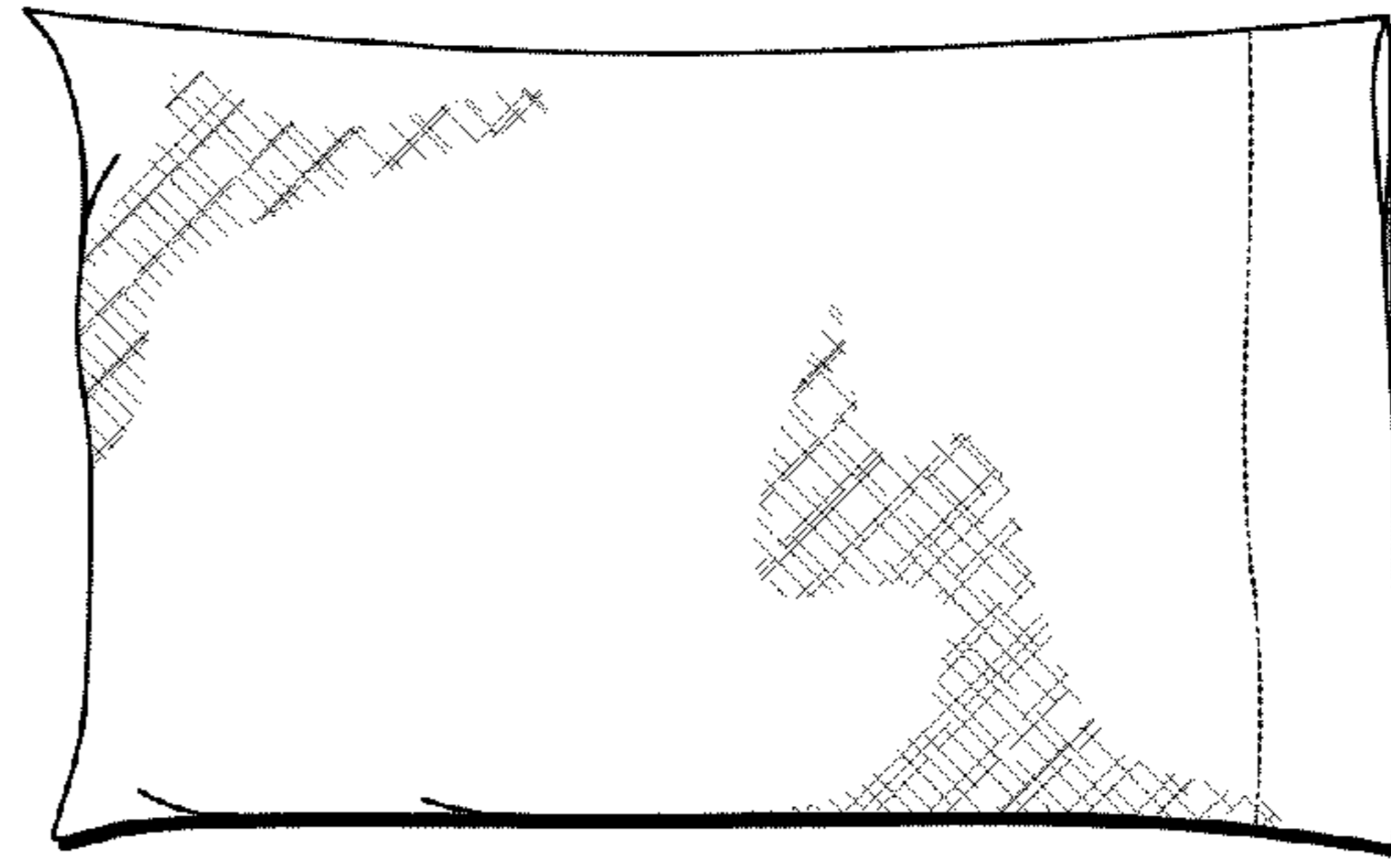

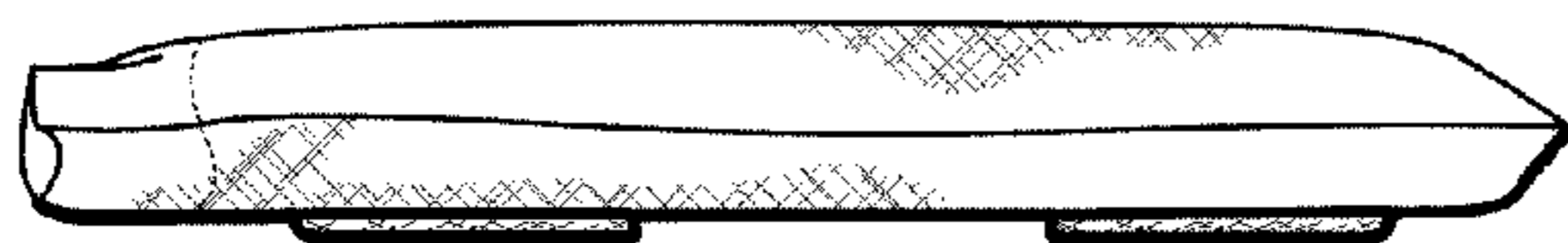

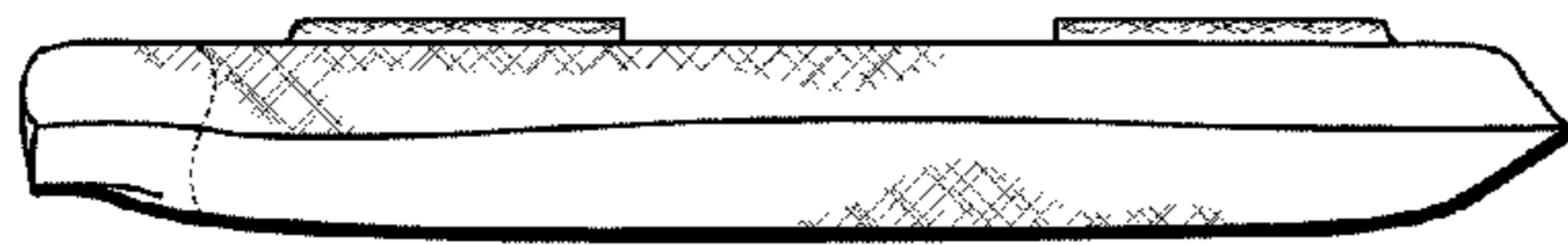
