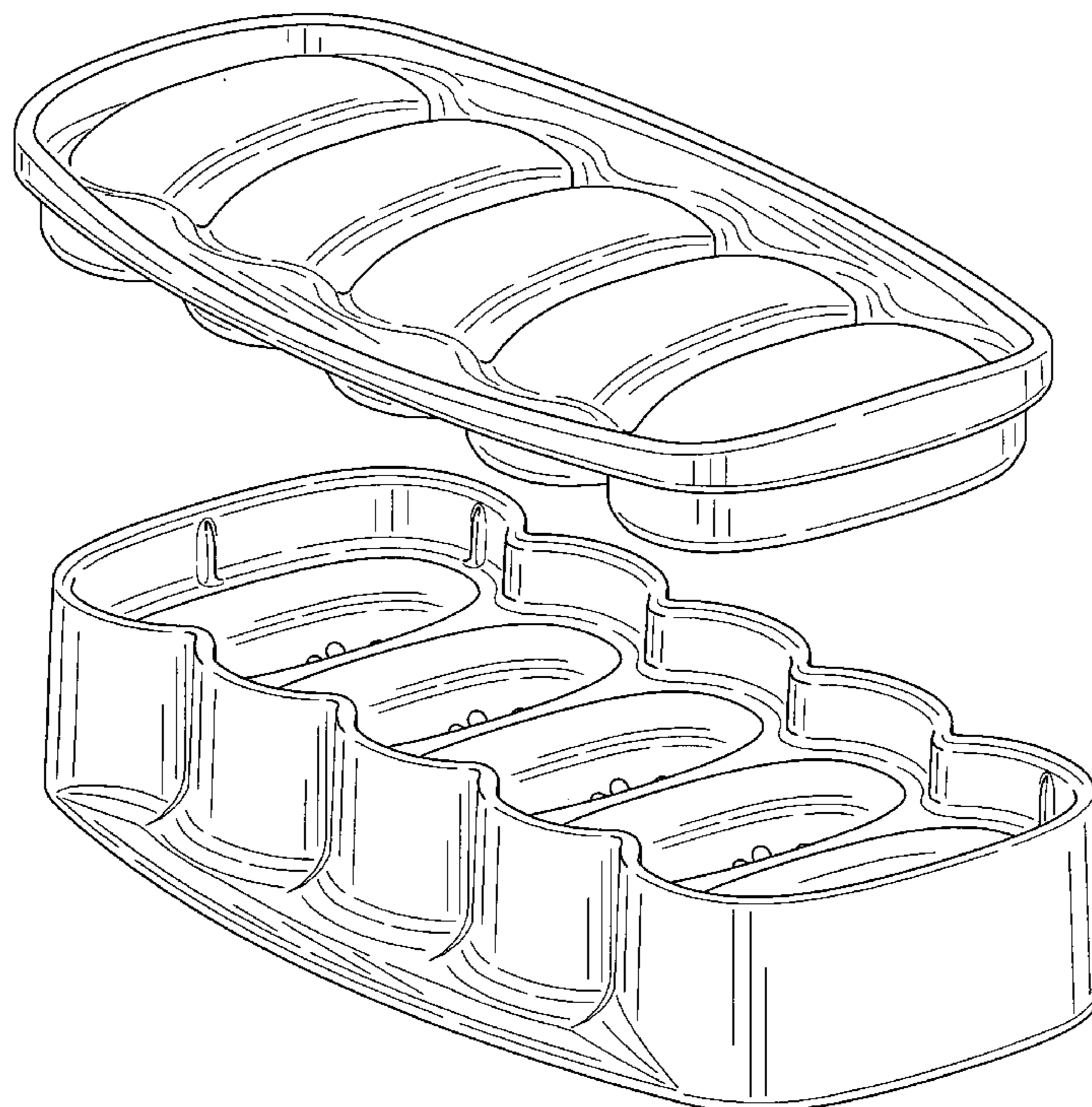
(57) **CLAIM**

The ornamental design for a container for making nigiri sushi, as shown and described.

DESCRIPTION

FIG. 1 is a top, side and front perspective view of a container for making nigiri sushi showing my new design;
FIG. 2 is a bottom, side and front perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a front elevation view, the rear elevation being identical thereto;
FIG. 6 is a right side elevation view, the left side elevation being identical thereto; and,
FIG. 7 is an exploded perspective view of the container for making nigiri sushi shown in FIG. 1.

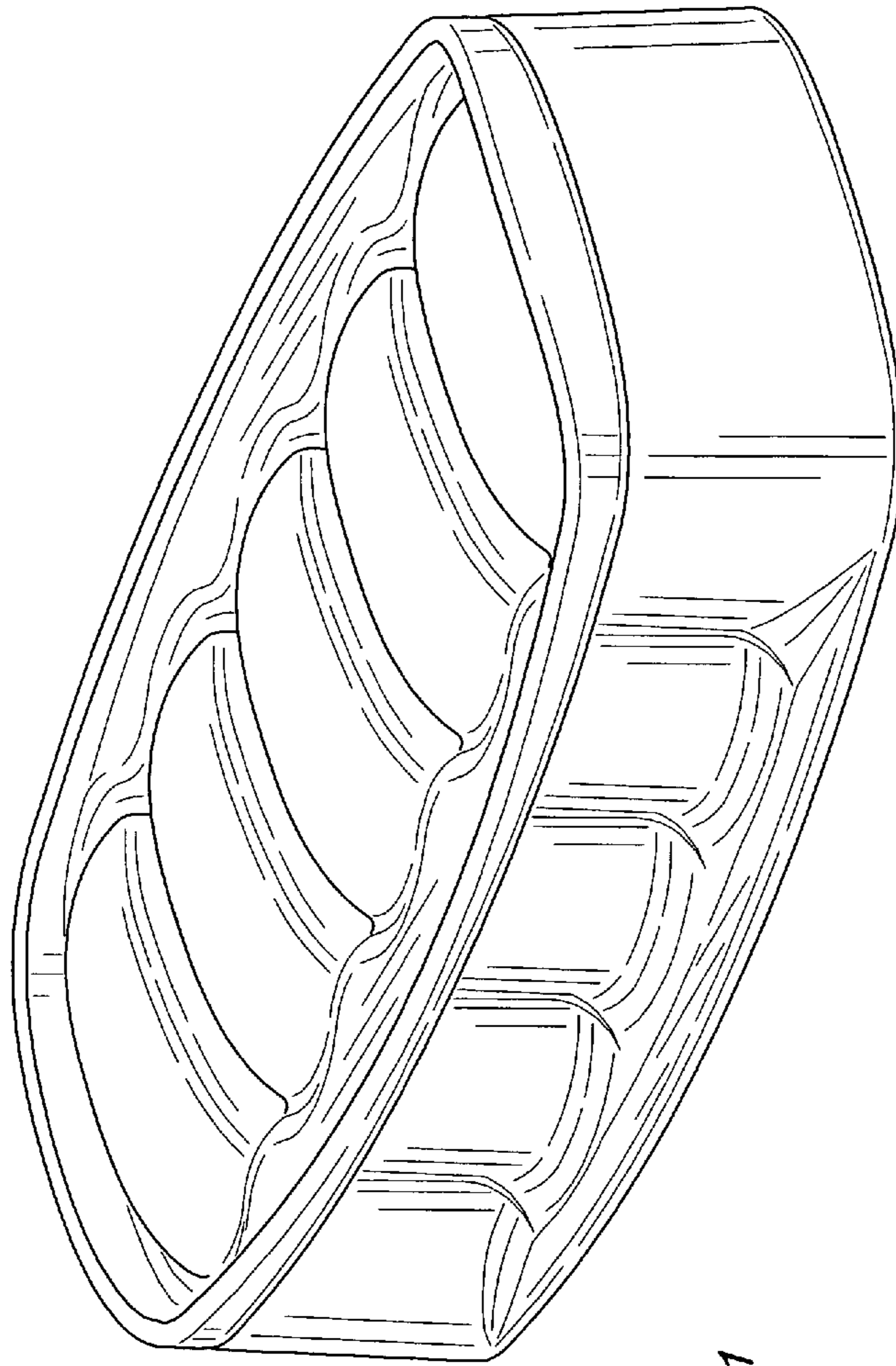

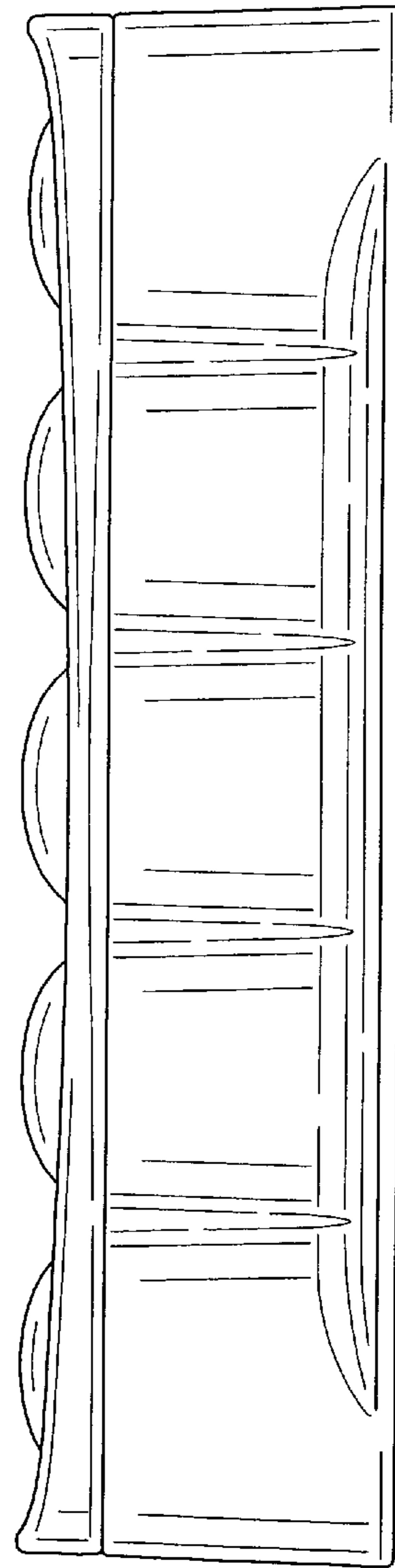

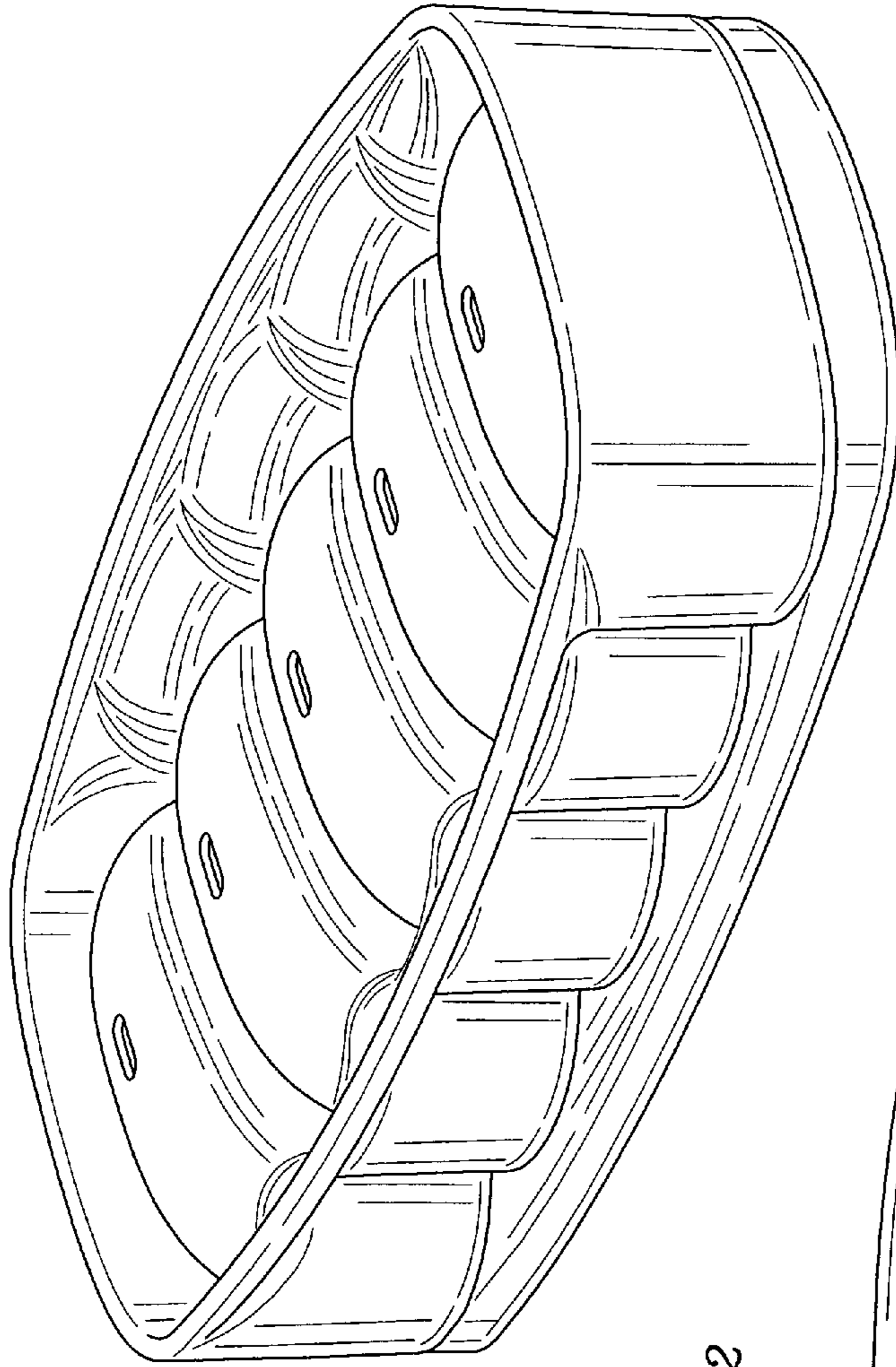

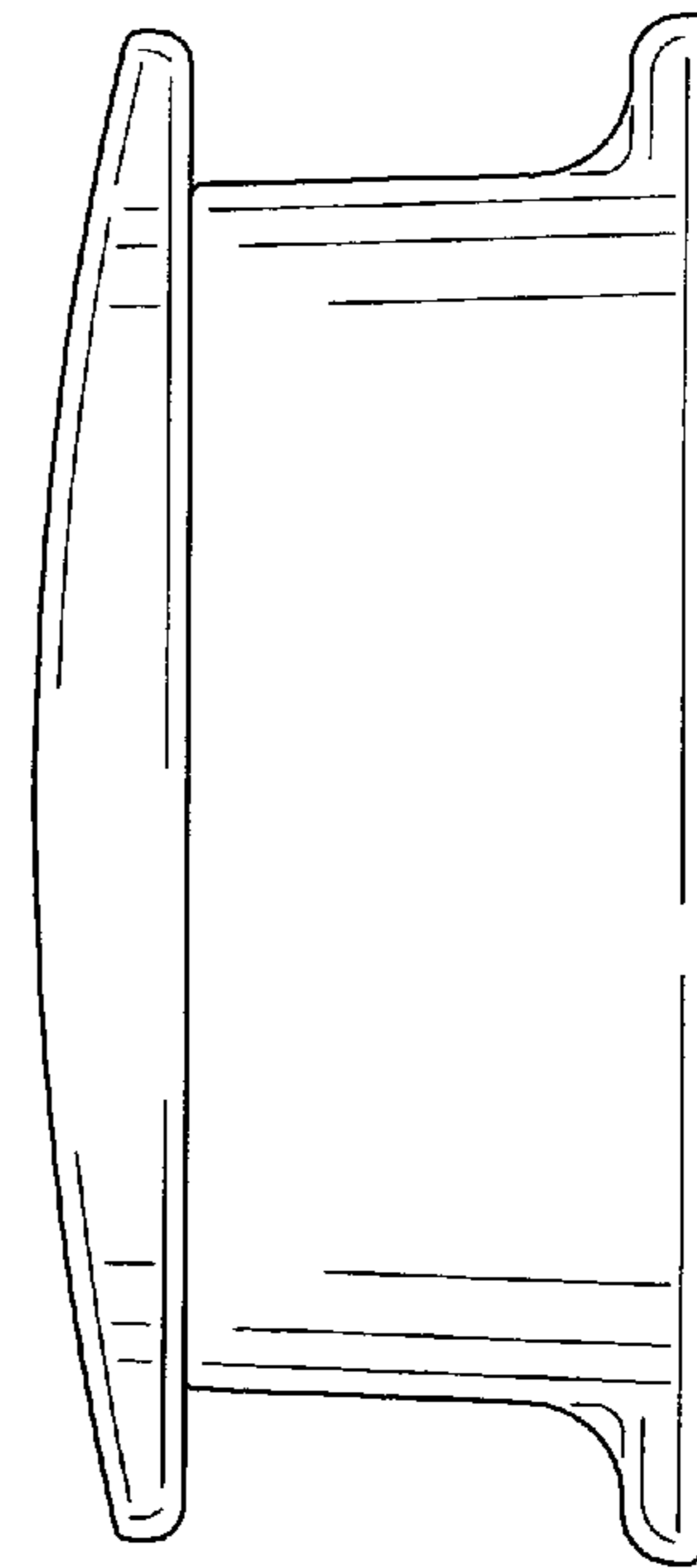

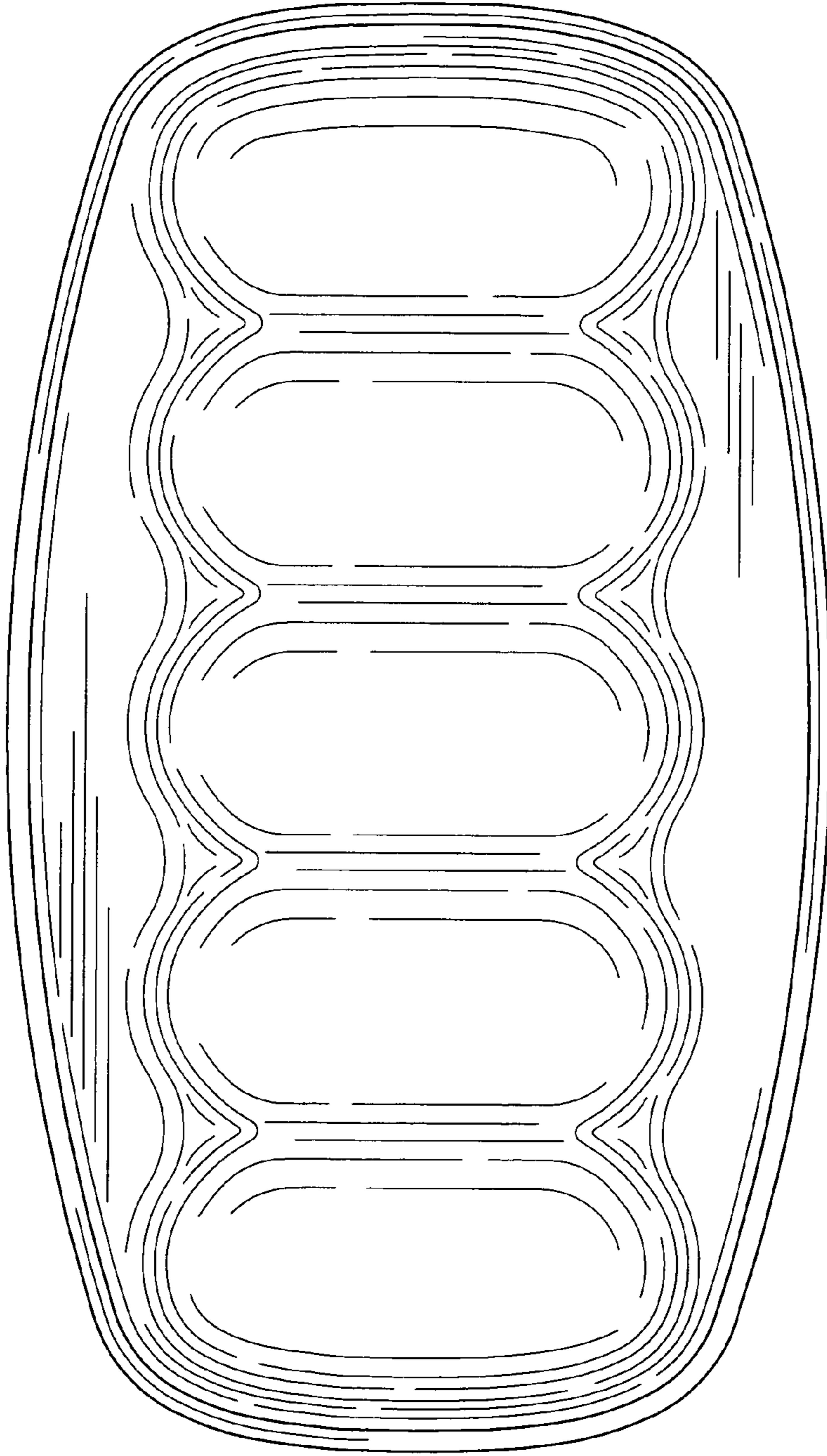

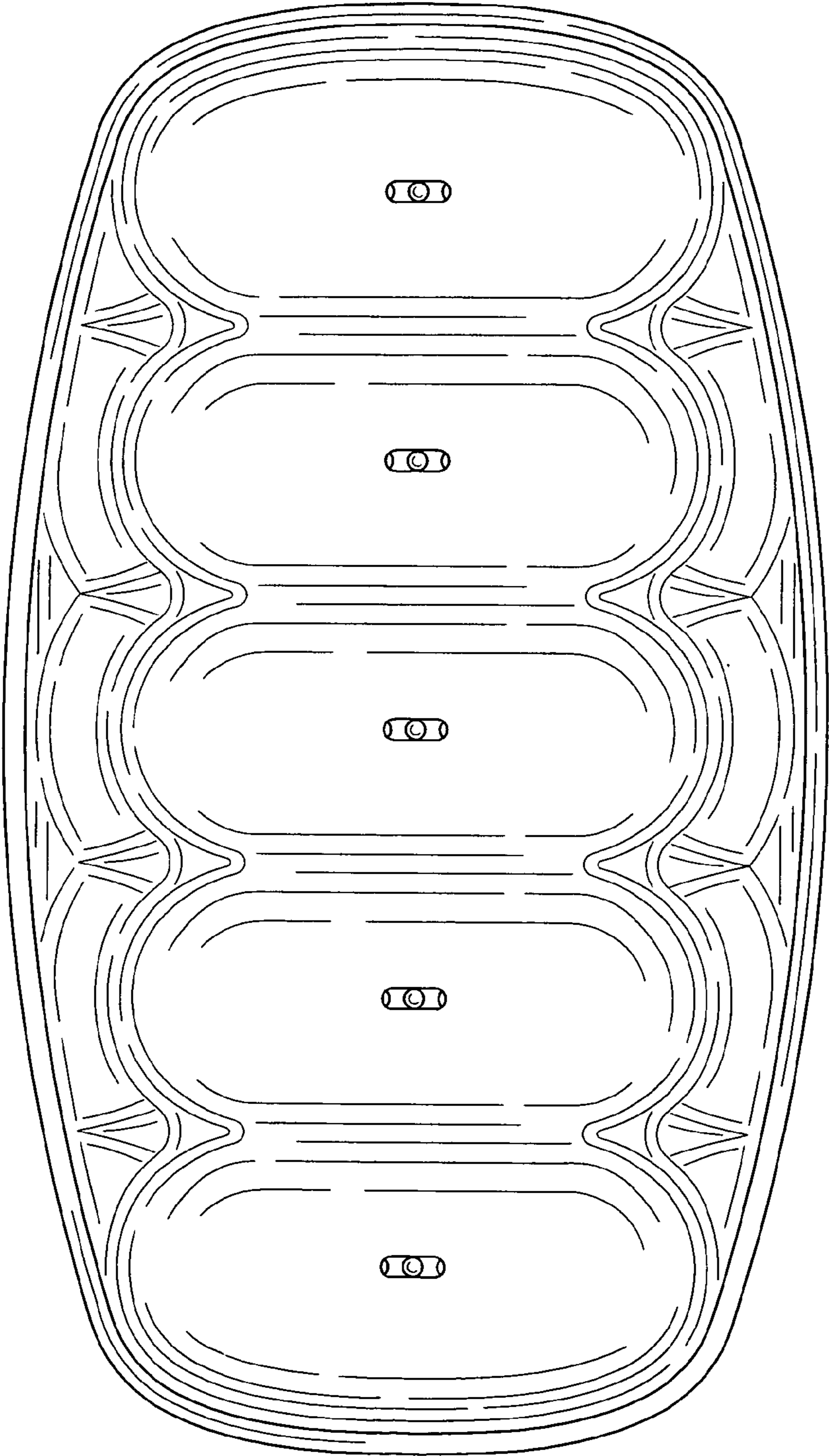
