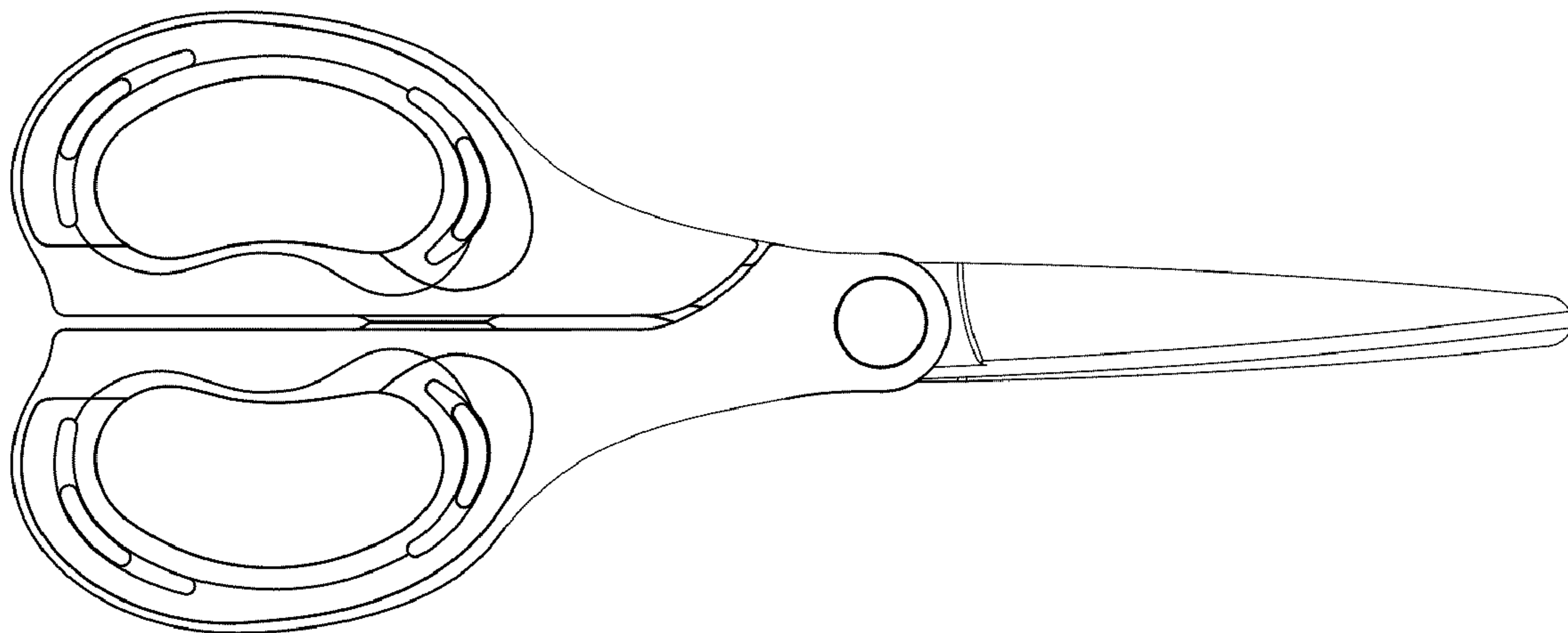
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an enlarged perspective view of the scissors;

 FIG. 11 is an enlarged cross-sectional view thereof at 11-11 of FIG. 2;  
 FIG. 12 is an enlarged cross-sectional view thereof at 12-12 of FIG. 2; and,  
 FIG. 13 is an enlarged cross-sectional view thereof at 13-13 of FIG. 2.

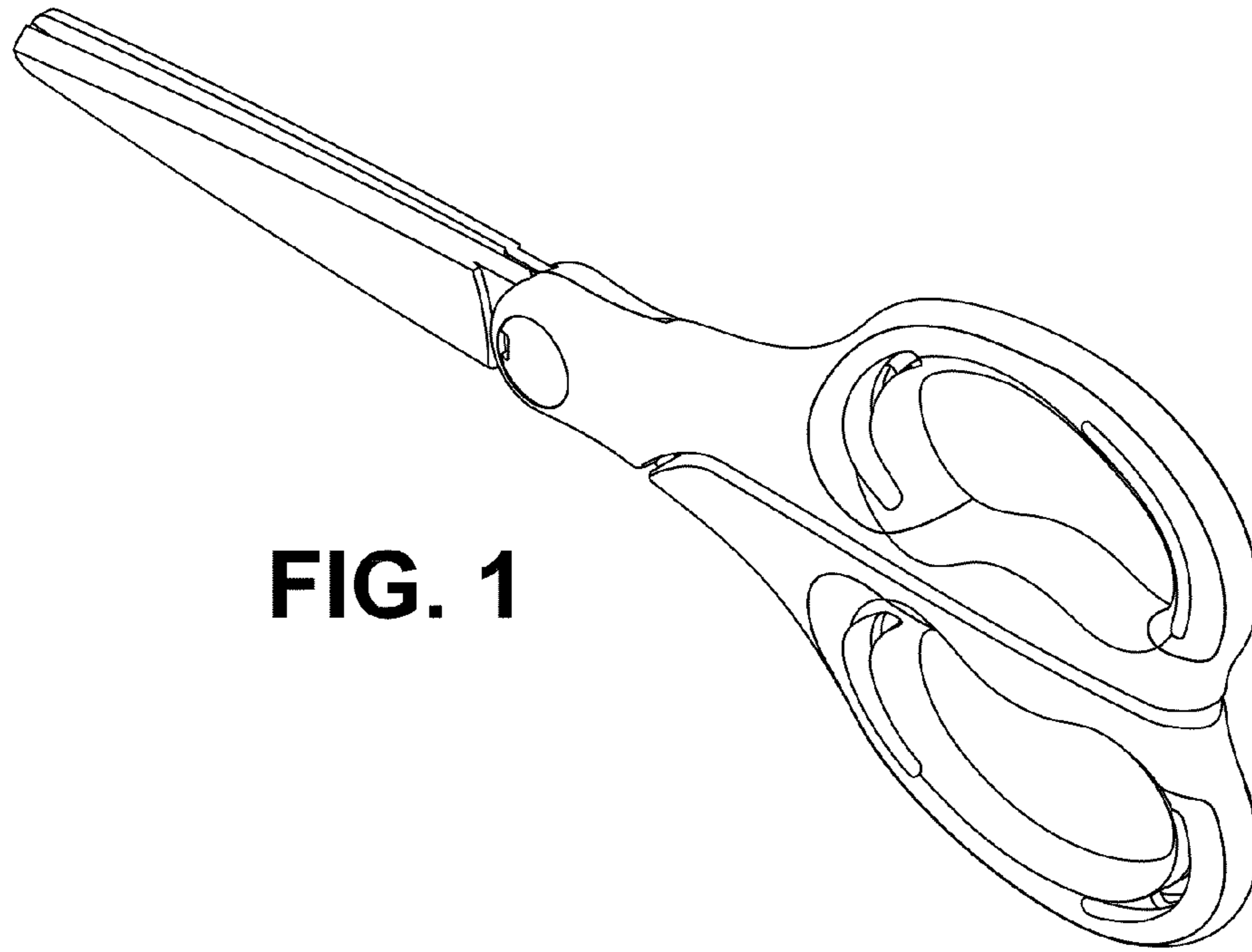

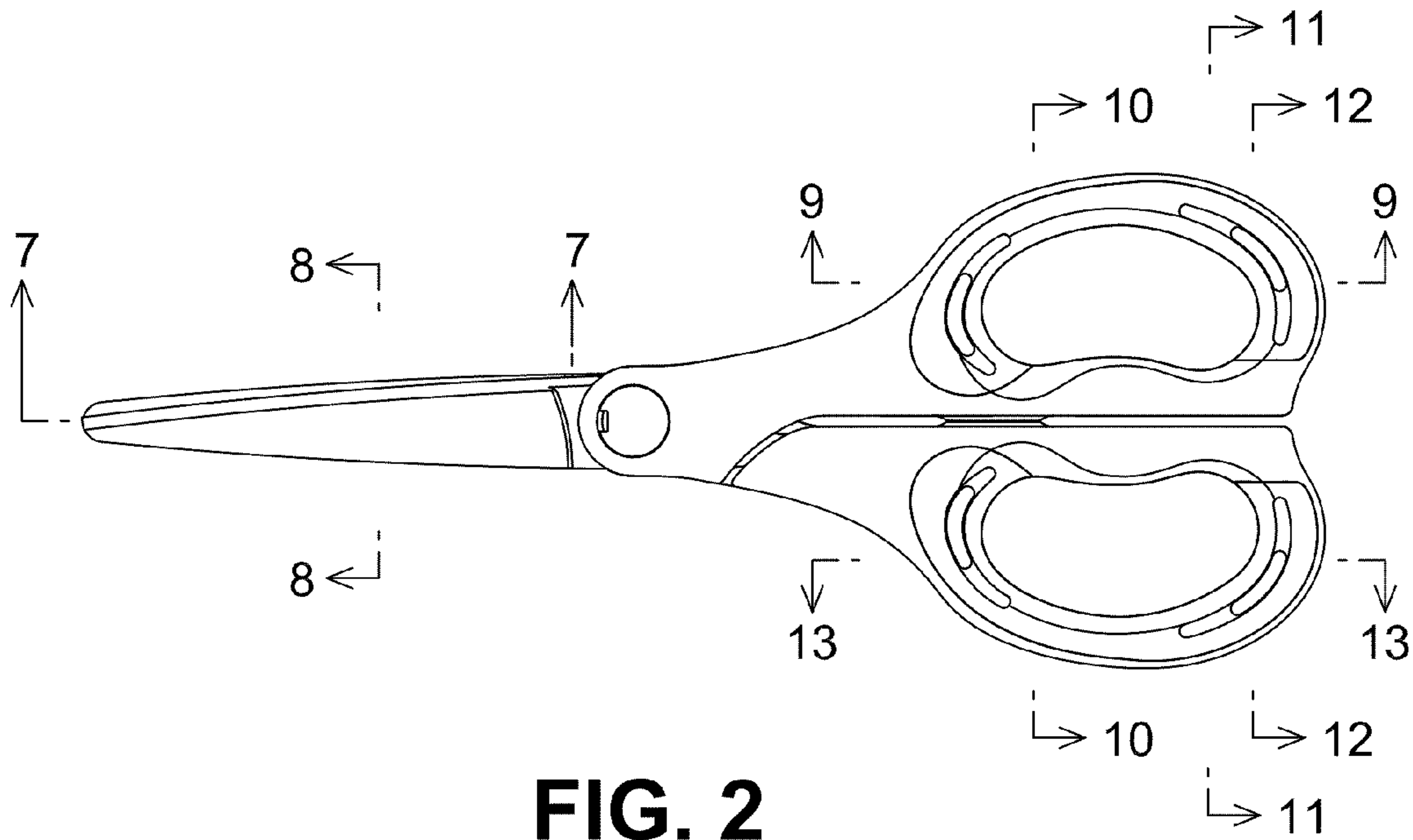

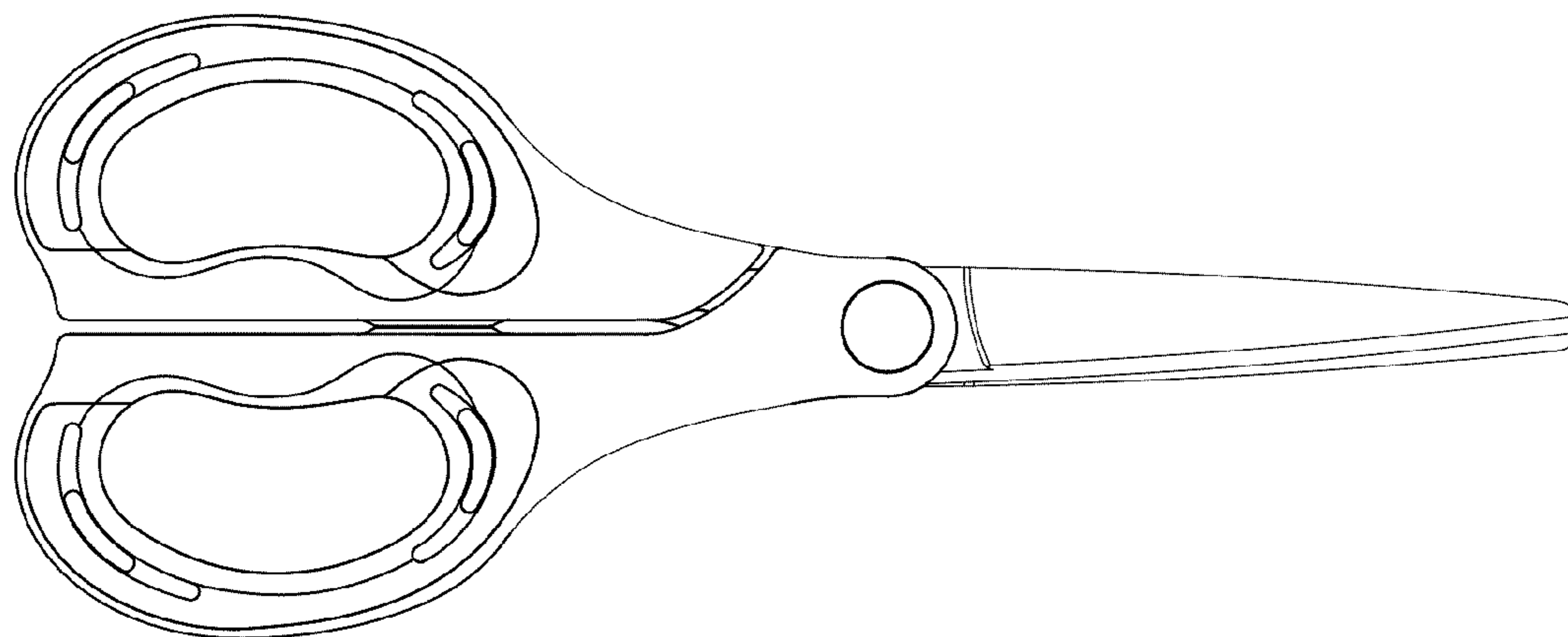

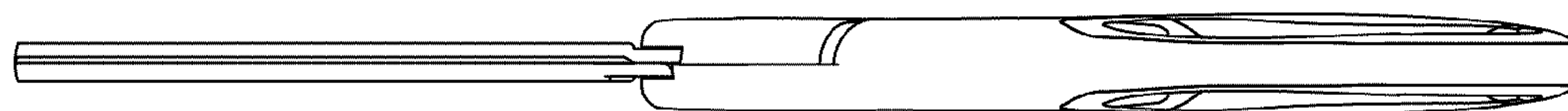

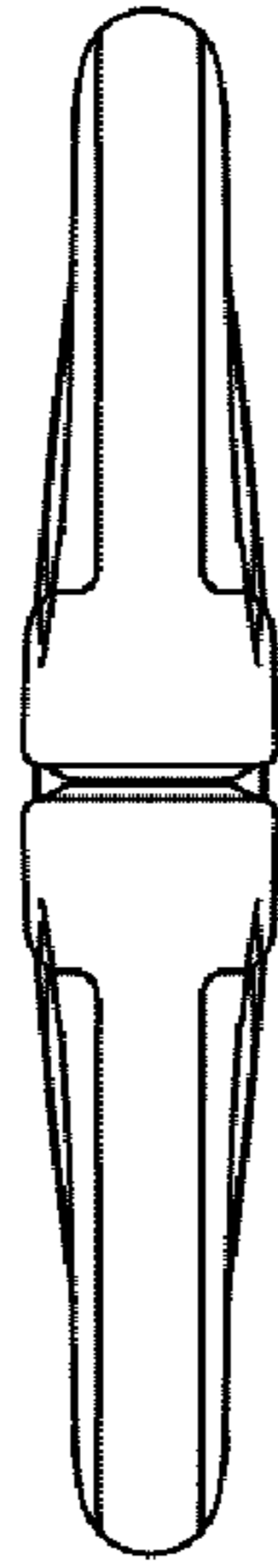

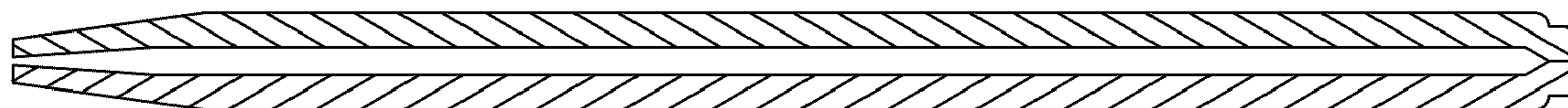

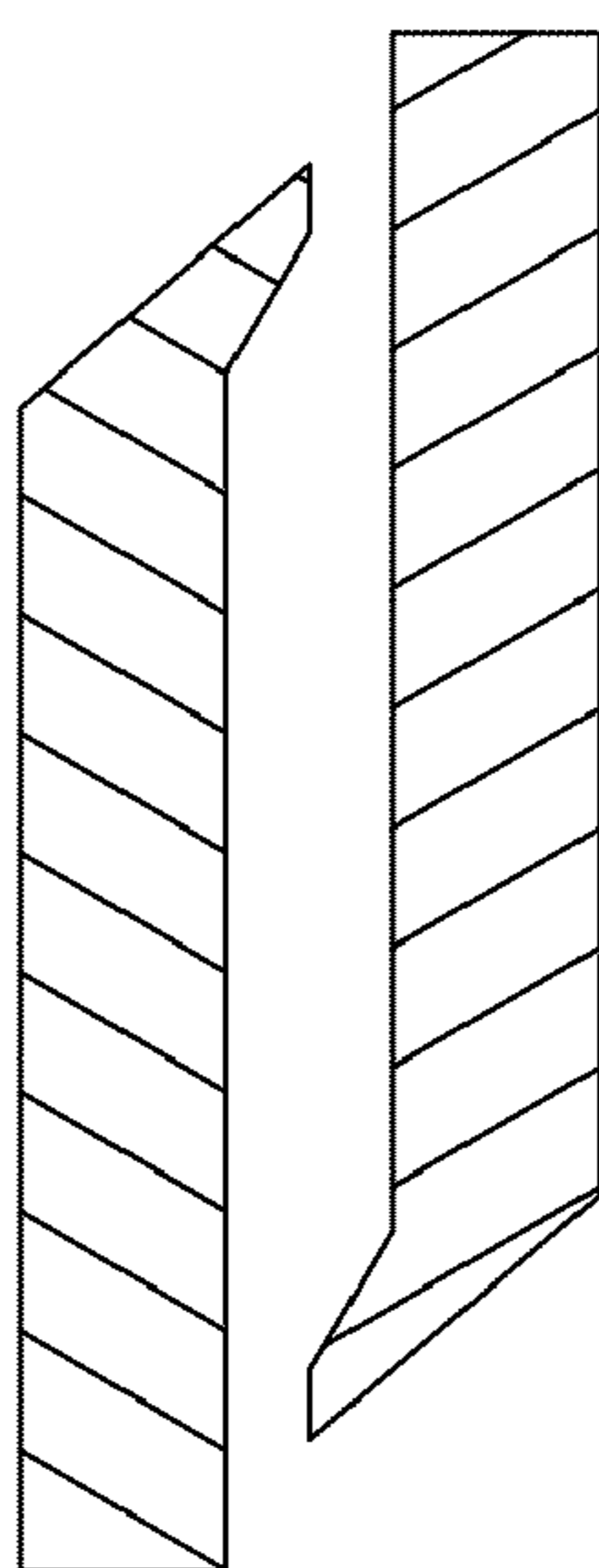

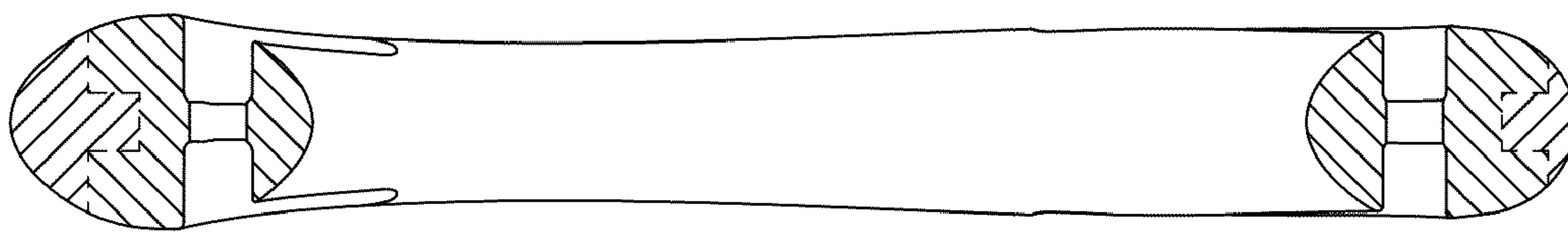

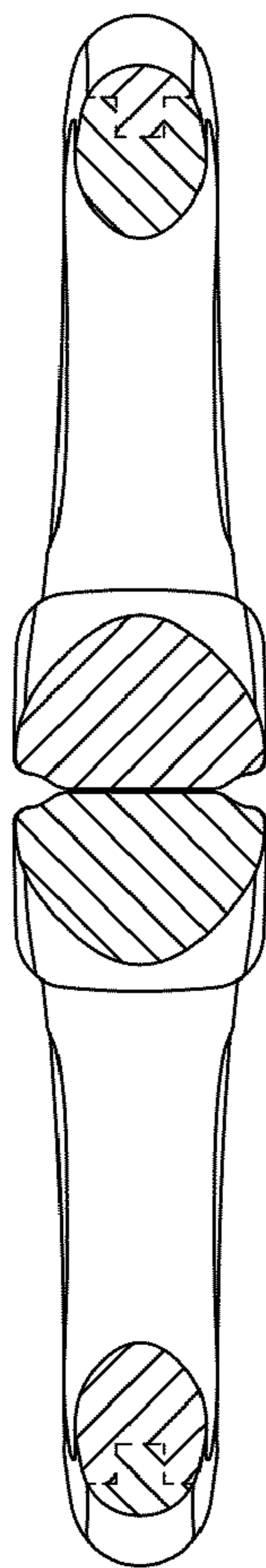

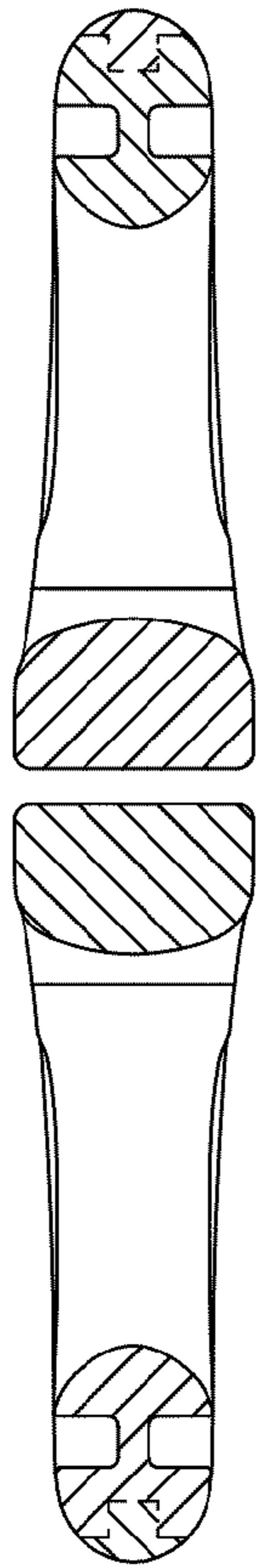




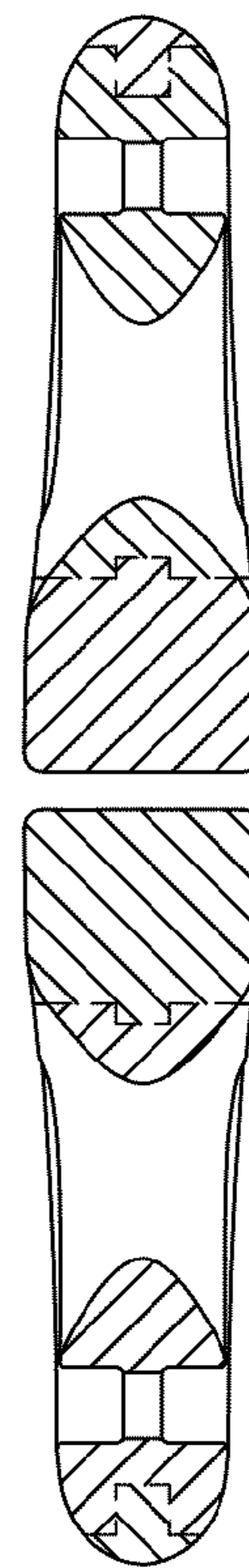

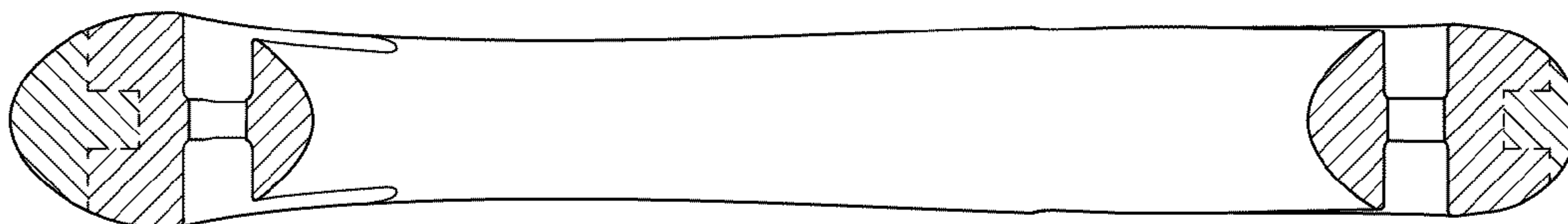
