(57) **CLAIM**

The ornamental design for a cloth band, as shown.

DESCRIPTION

FIG. 1 is a front and top perspective view of a cloth band showing my new design;

FIG. 2 is side elevational view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front and top perspective view of a second embodiment of a cloth band showing my new design;

FIG. 5 is a side elevational view thereof; and,

FIG. 6 is a bottom plan view thereof.

The rear of the cloth band is unornamented in each embodiment.

The broken lines shown in the drawings represent unclaimed portions of the cloth band and form no part of the claimed design.

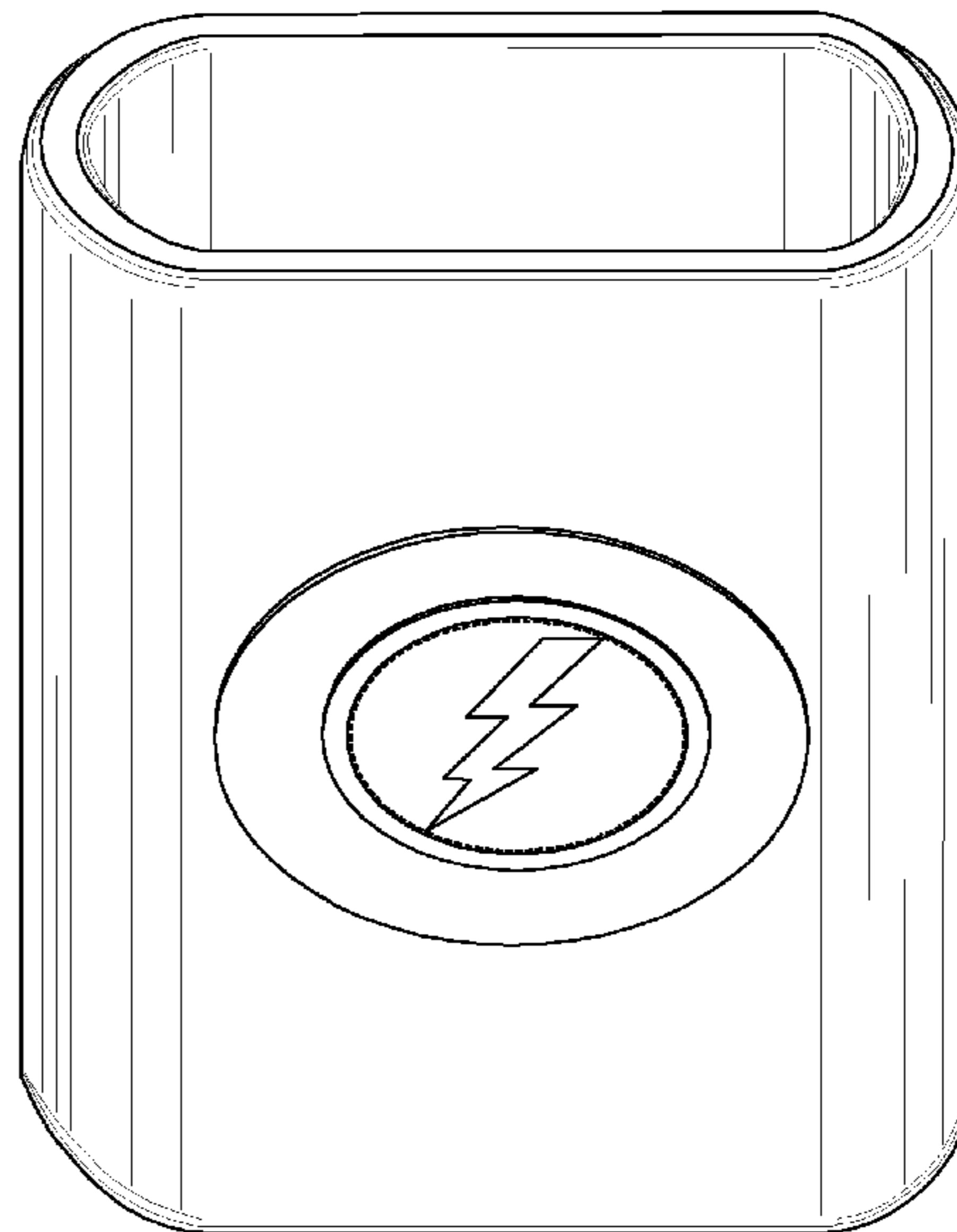
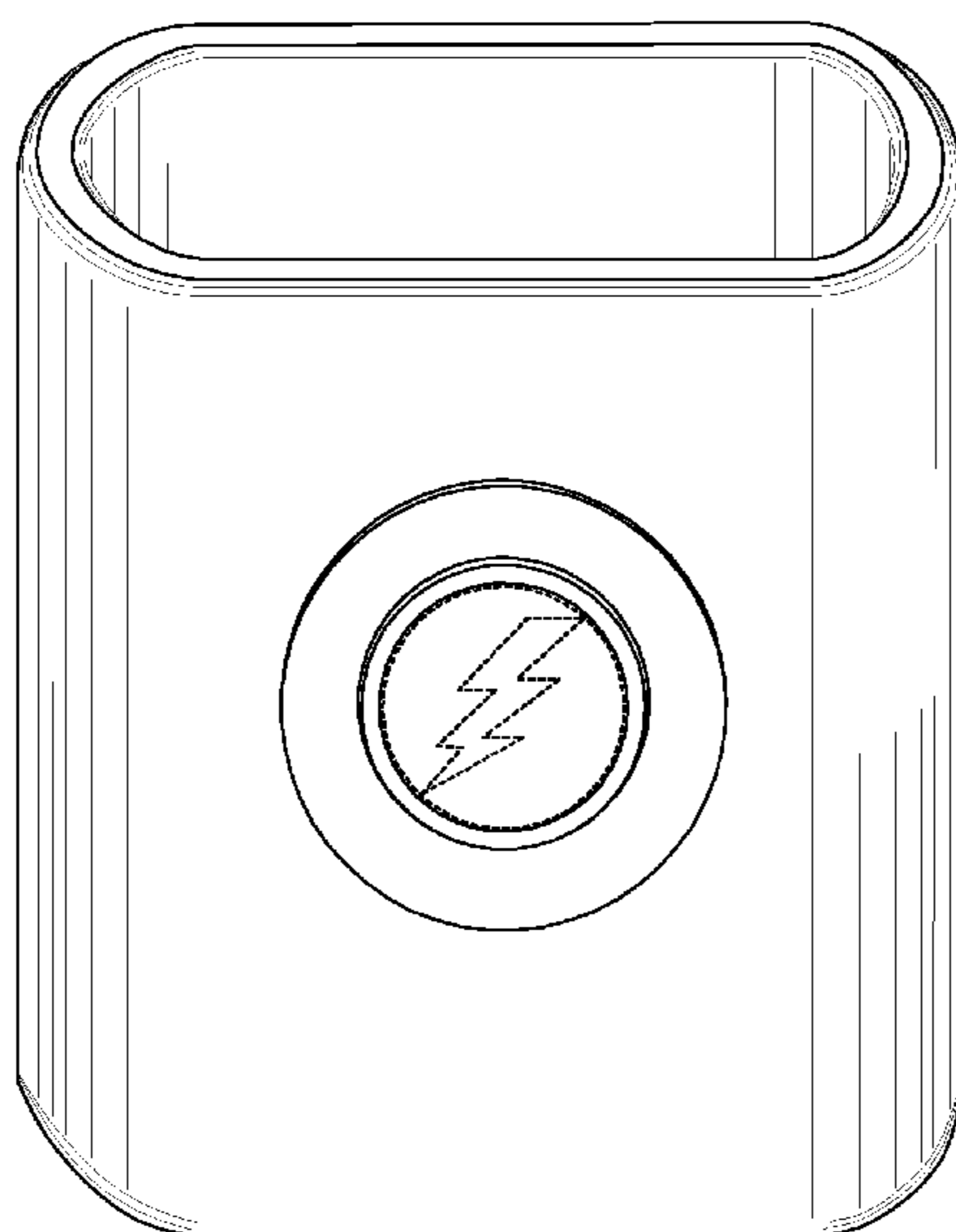

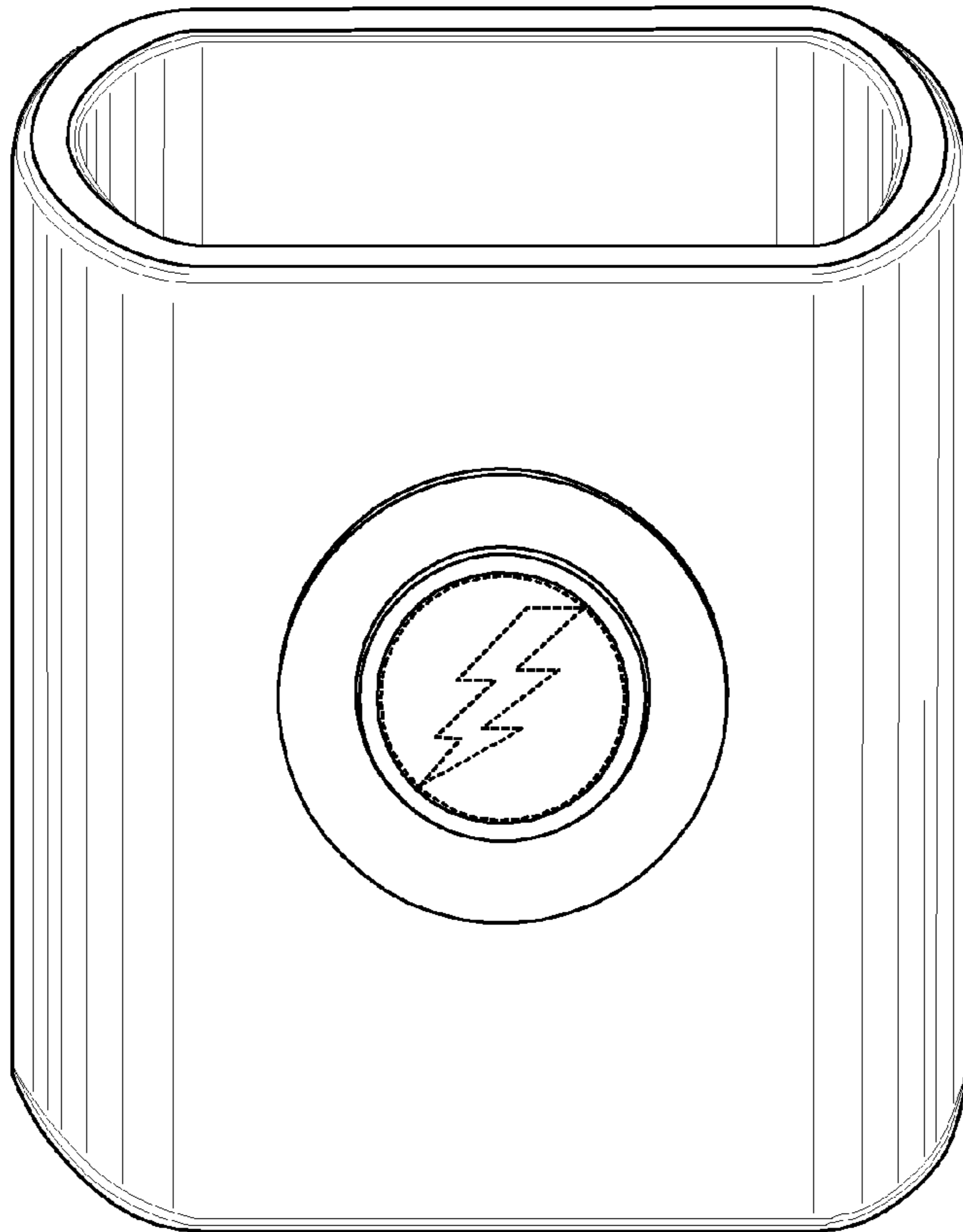

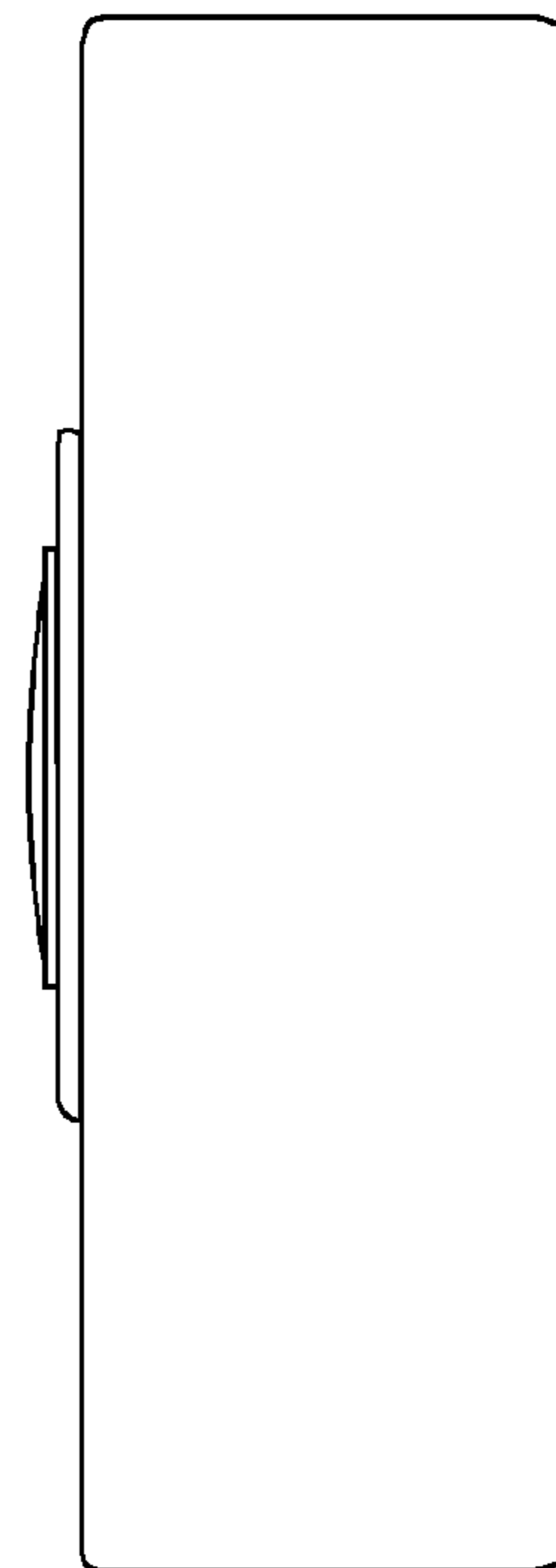

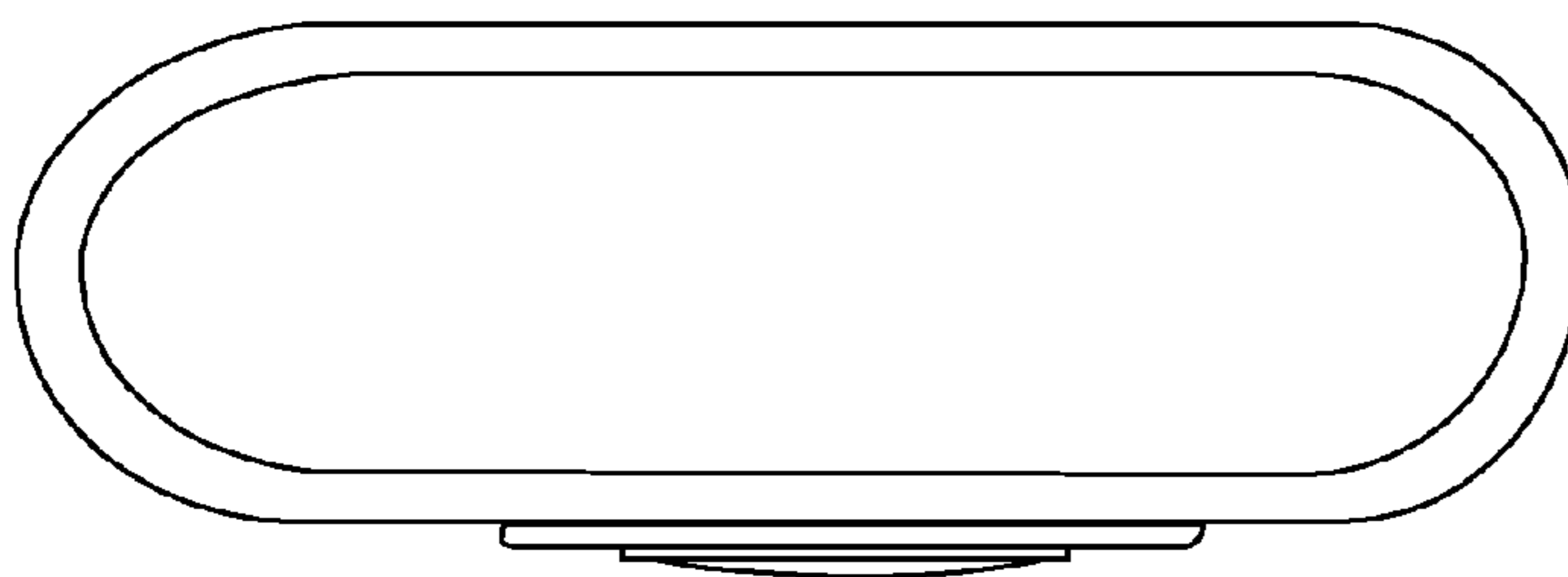

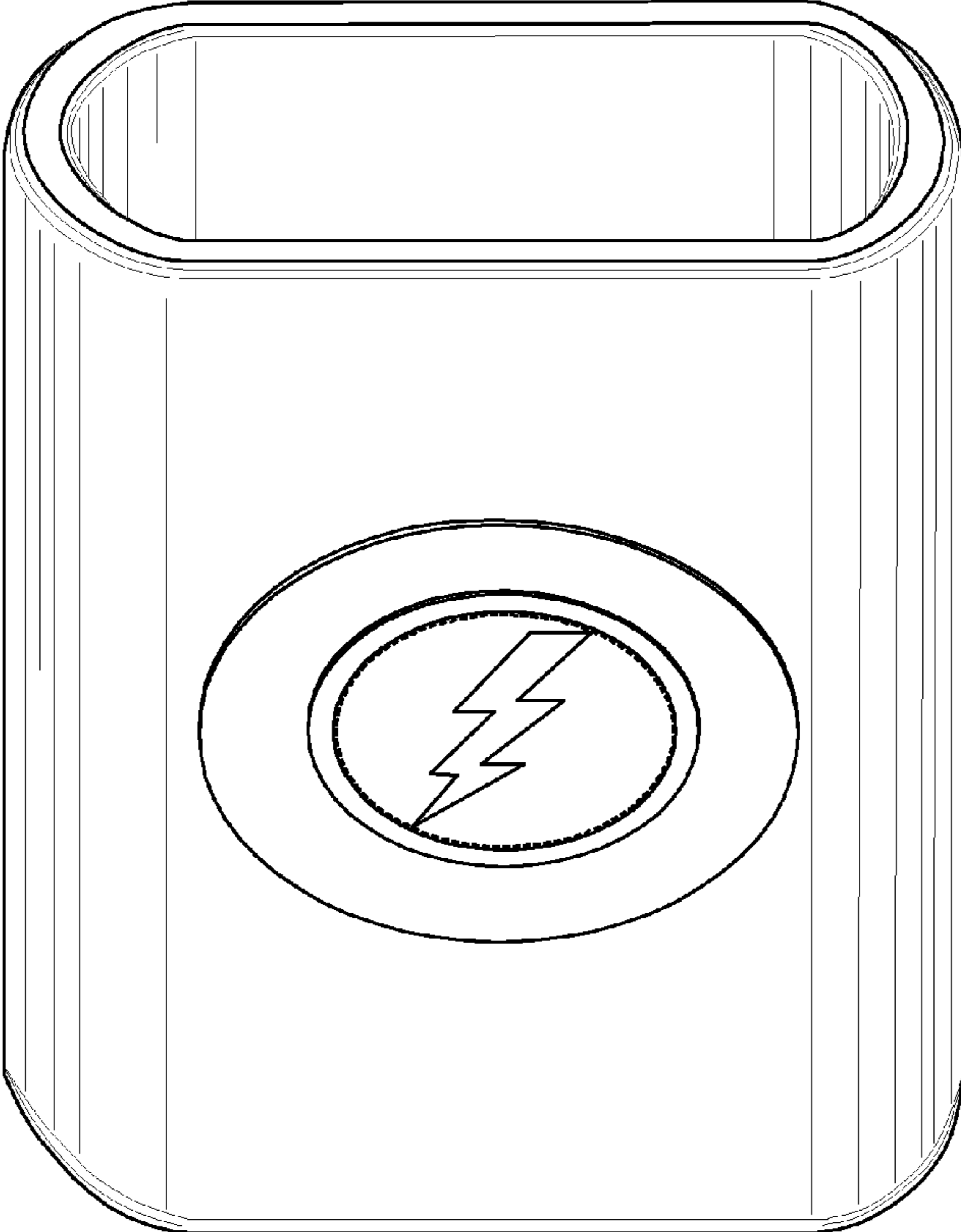

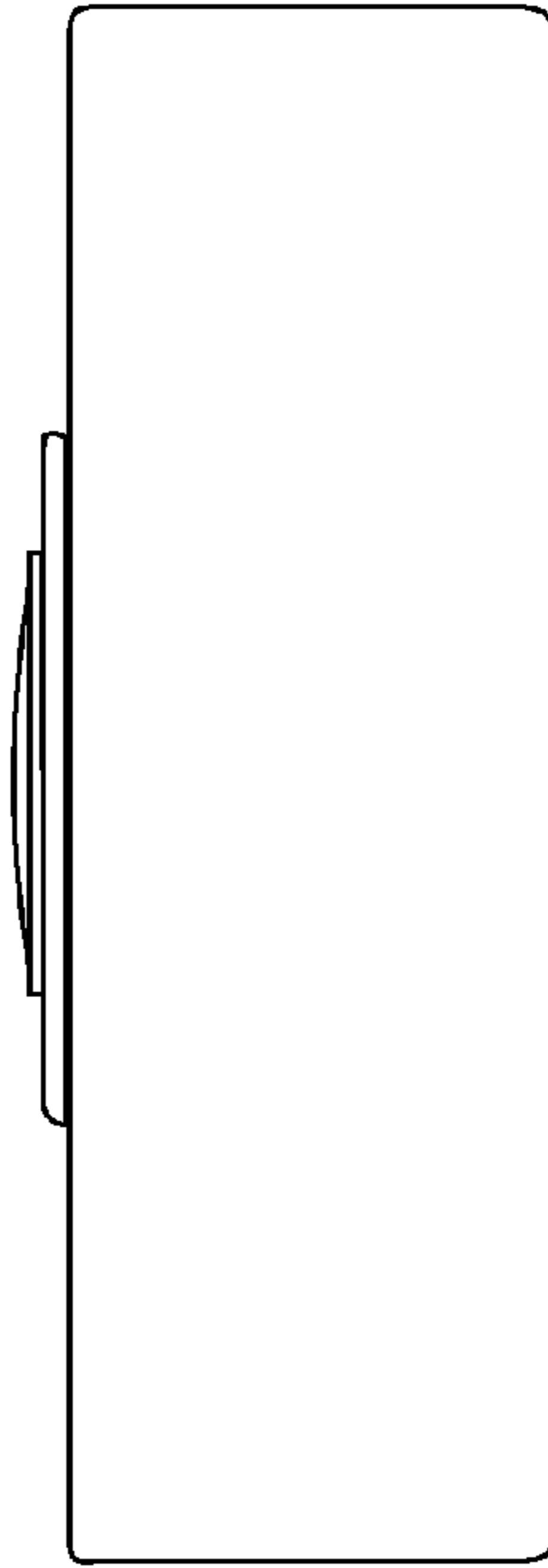
