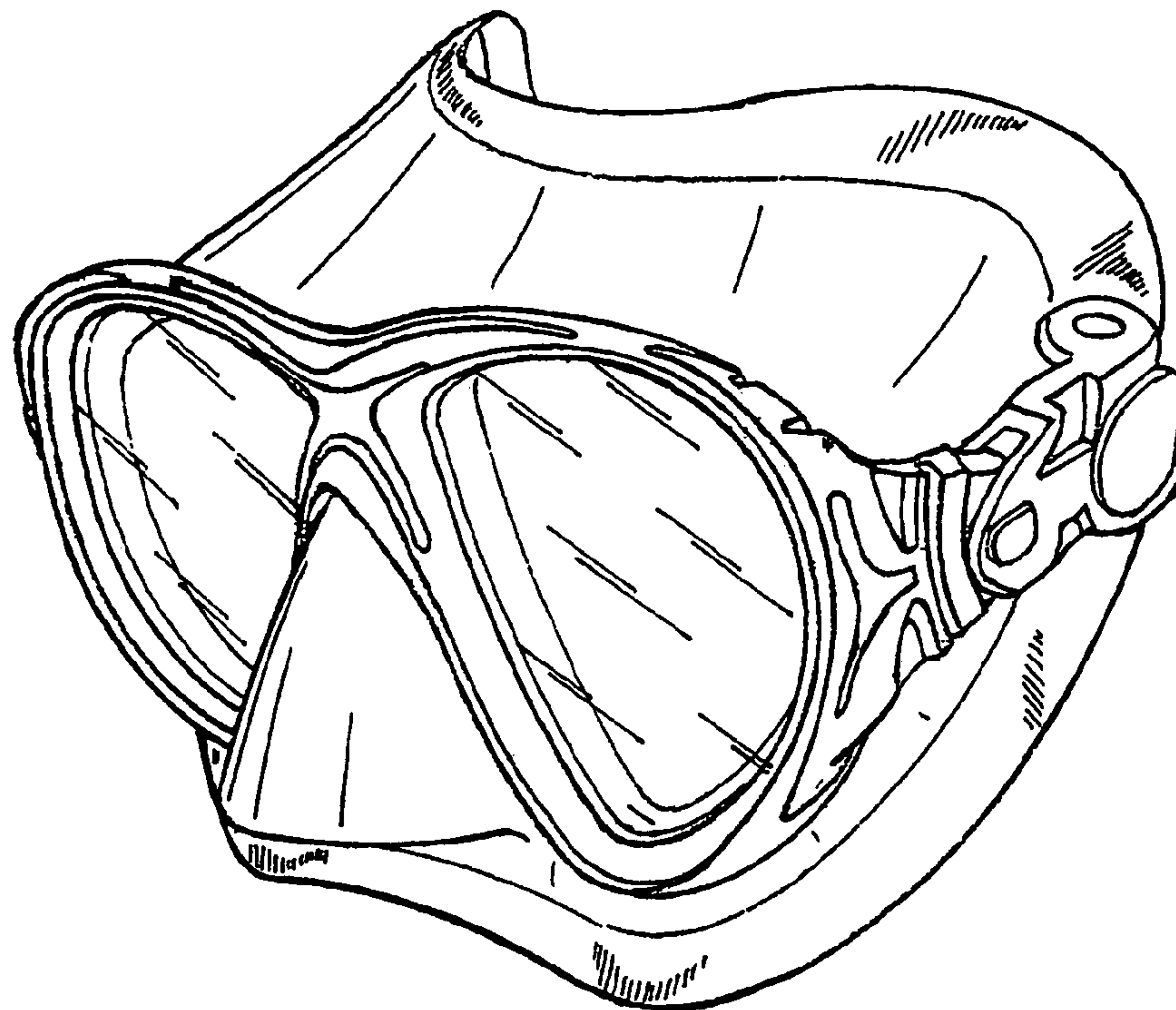
(57) **CLAIM**

The ornamental design for a dive mask, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a dive mask, according to one aspect of the present invention;
 FIG. 2 is a frontal side view of the mask shown in FIG. 1;
 FIG. 3 is a right side view of the mask illustrated in FIG. 1, the left side view being a mirror image thereof;
 FIG. 4 is a rear view of the dive mask shown in FIG. 1;
 FIG. 5 is a plan view of the mask set forth in FIG. 1;
 FIG. 6 is a reverse plan view of the mask shown in FIG. 1;
 FIG. 7 is a perspective view of a dive mask, according to another aspect of the present invention;
 FIG. 8 is a frontal side view of the mask shown in FIG. 7;
 FIG. 9 is a right side view of the mask illustrated in FIG. 7, the left side view being a mirror image thereof;
 FIG. 10 is a rear view of the mask shown in FIG. 7;
 FIG. 11 is a plan view of the mask set forth in FIG. 7; and,
 FIG. 12 is a reverse plan view of the mask shown in FIG. 7.

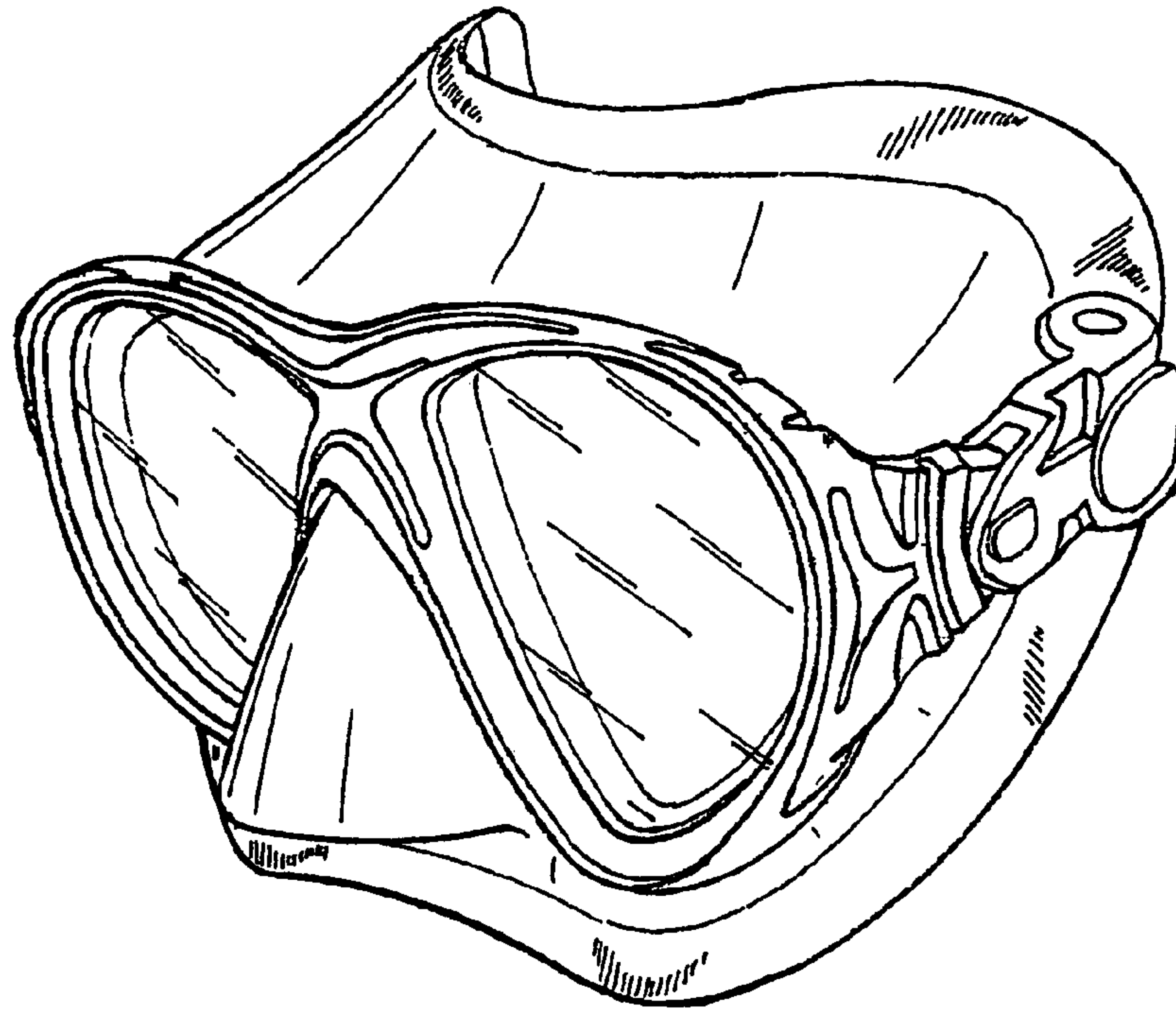

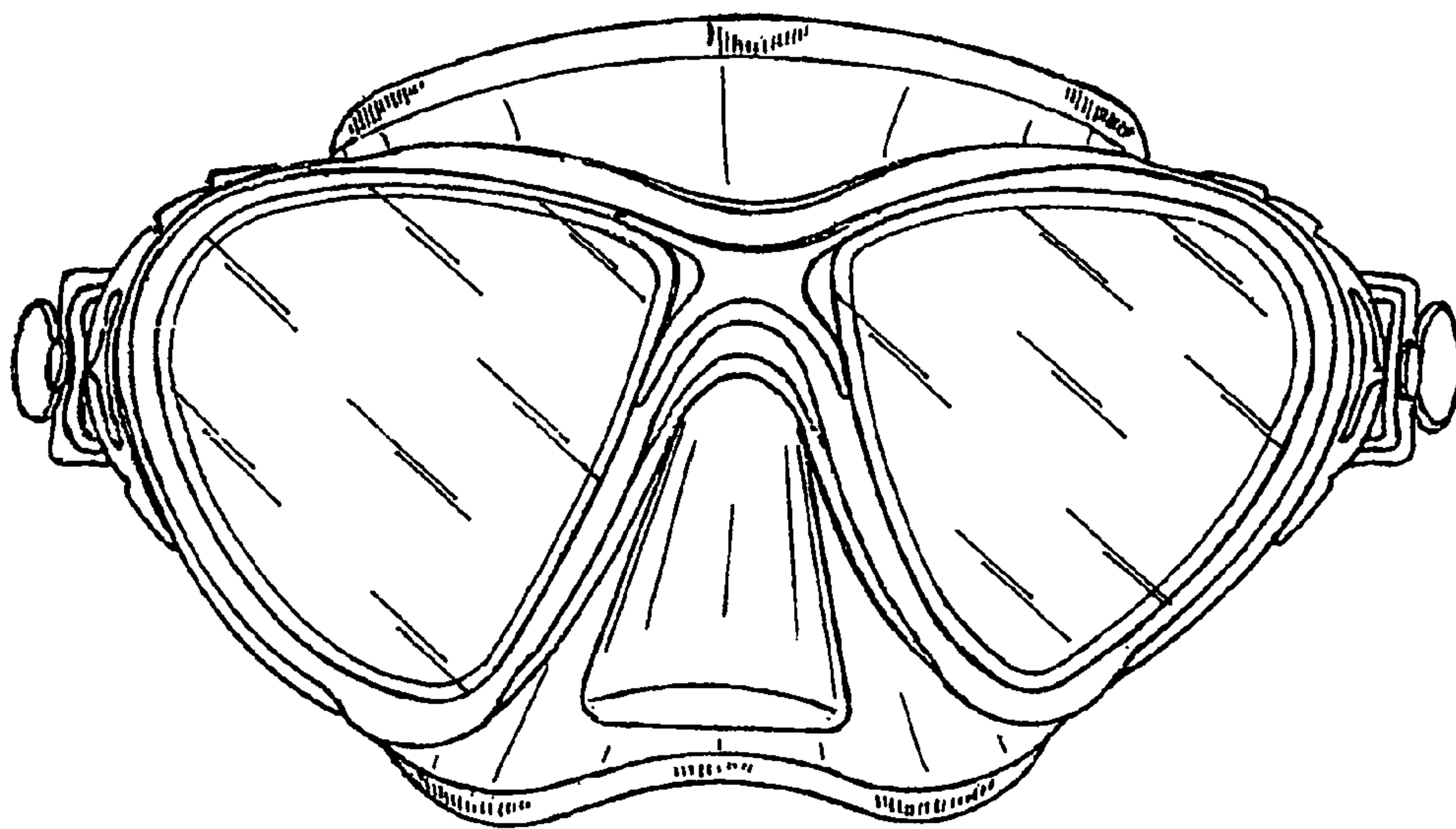

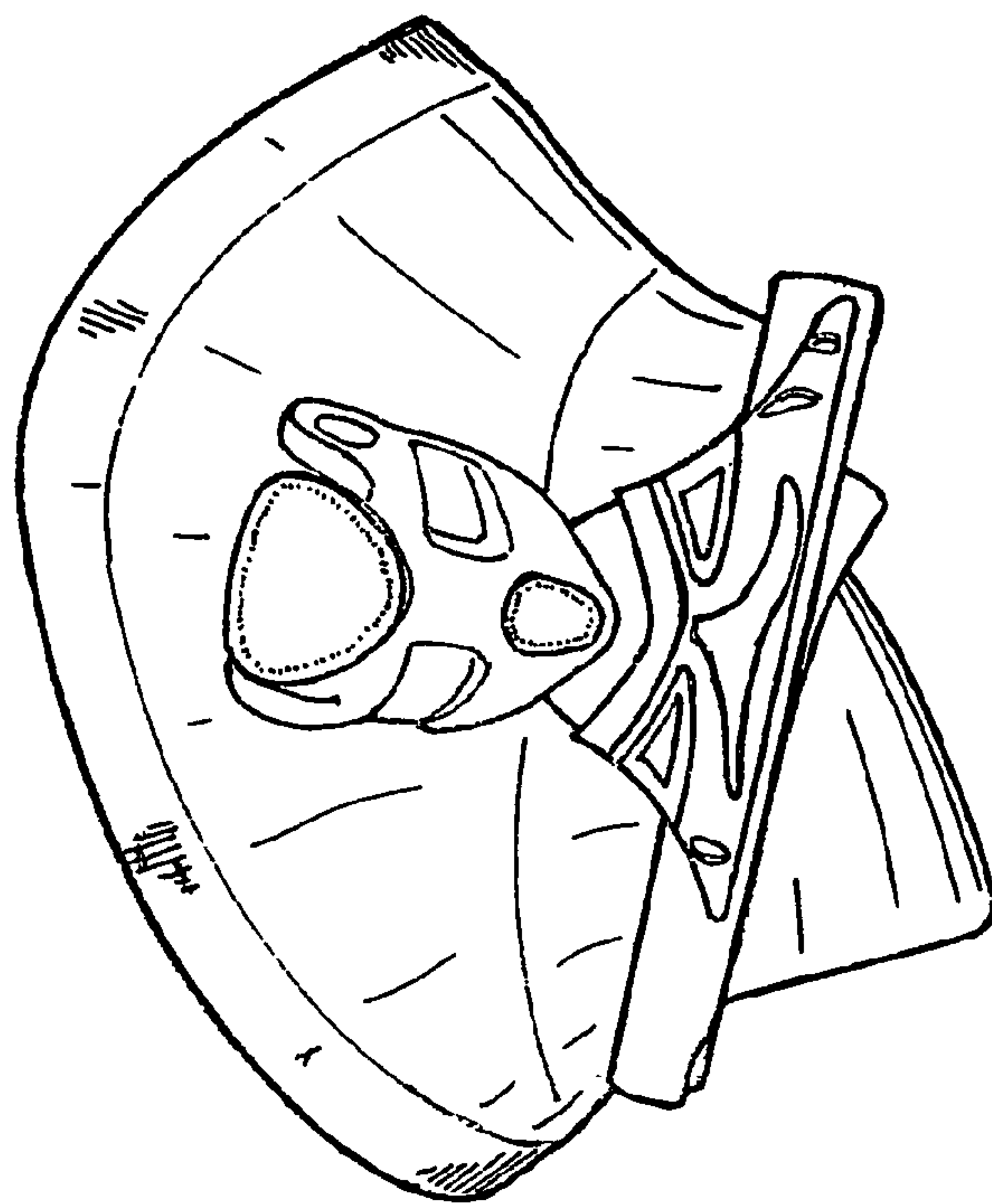

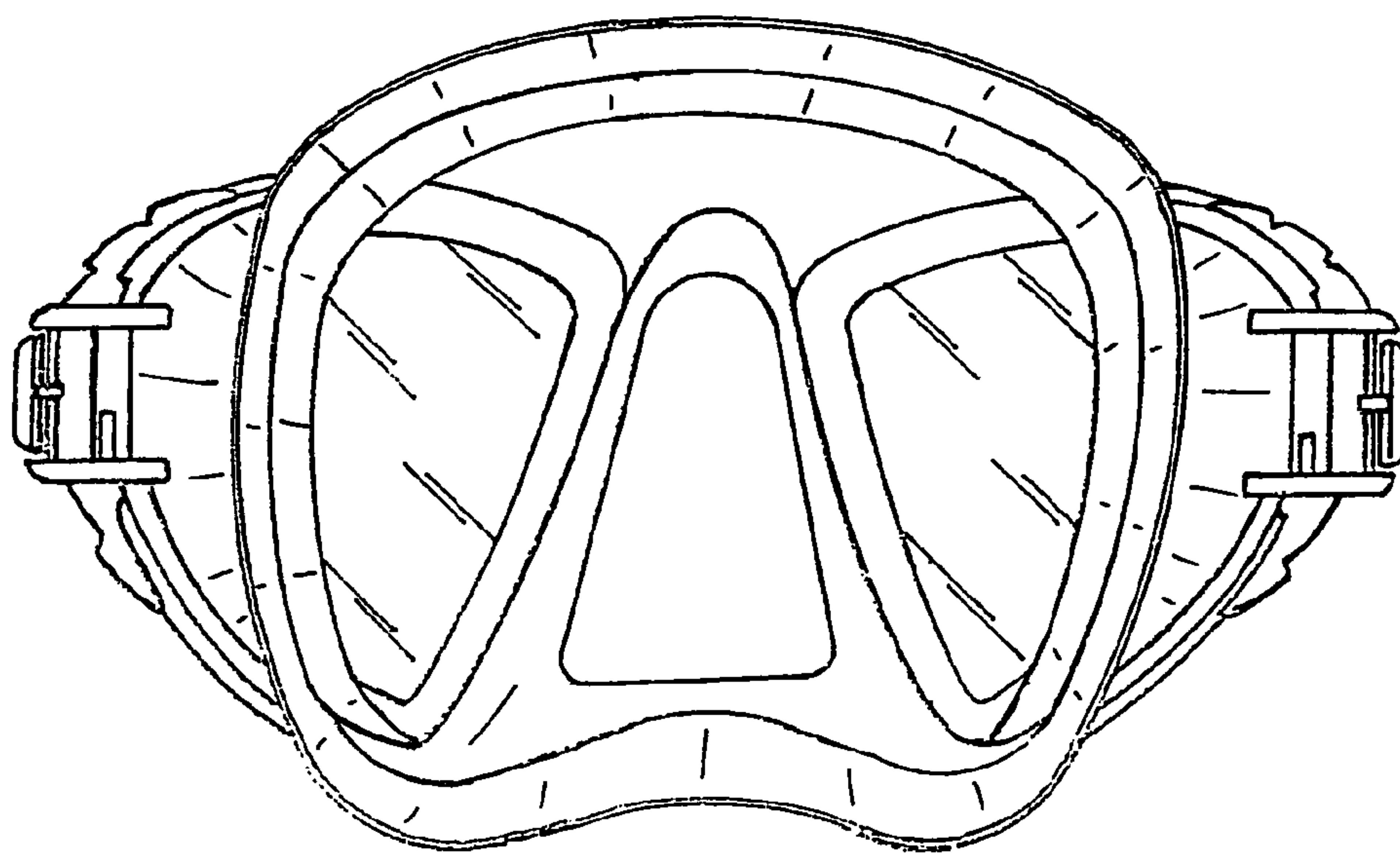

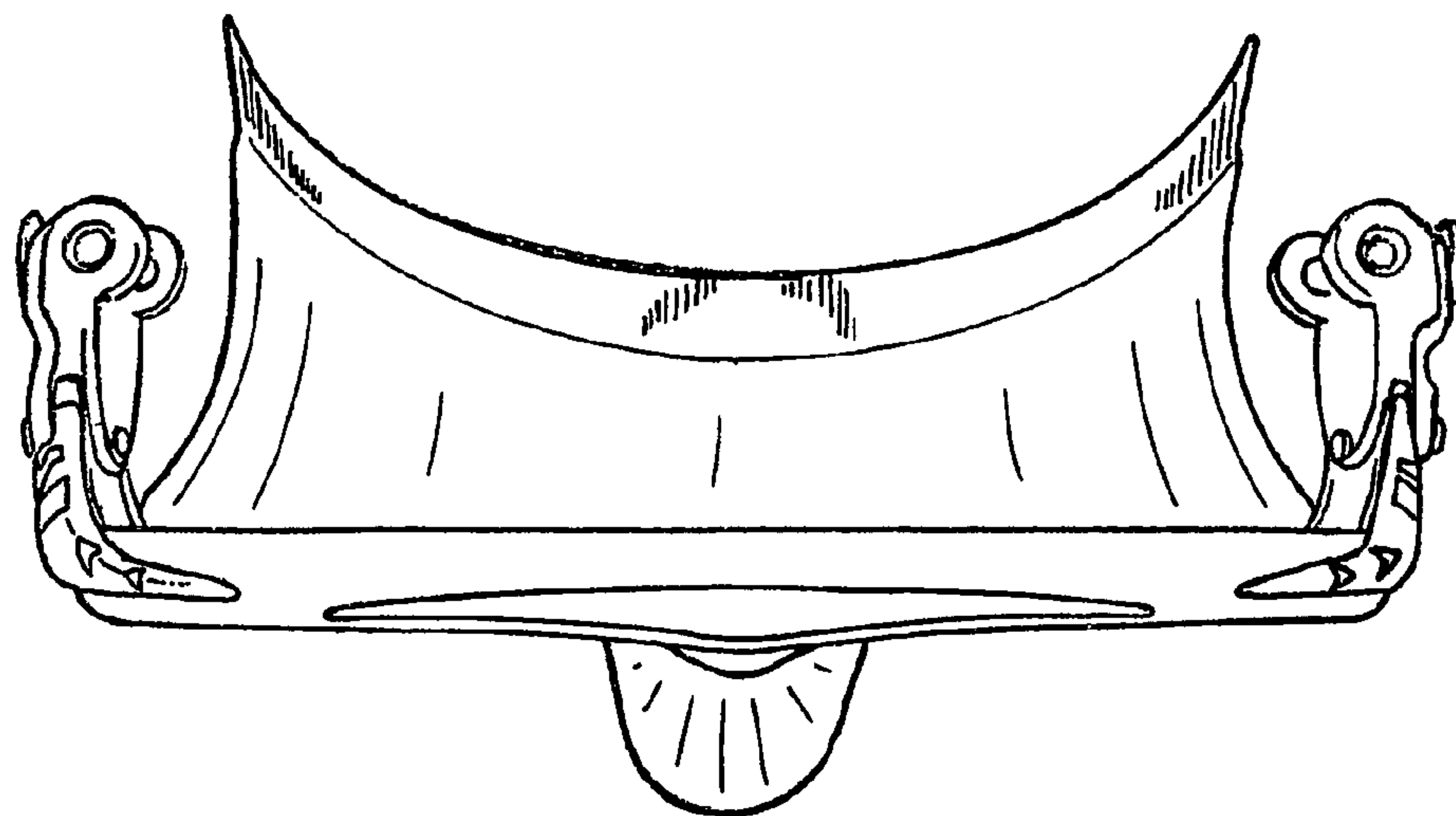

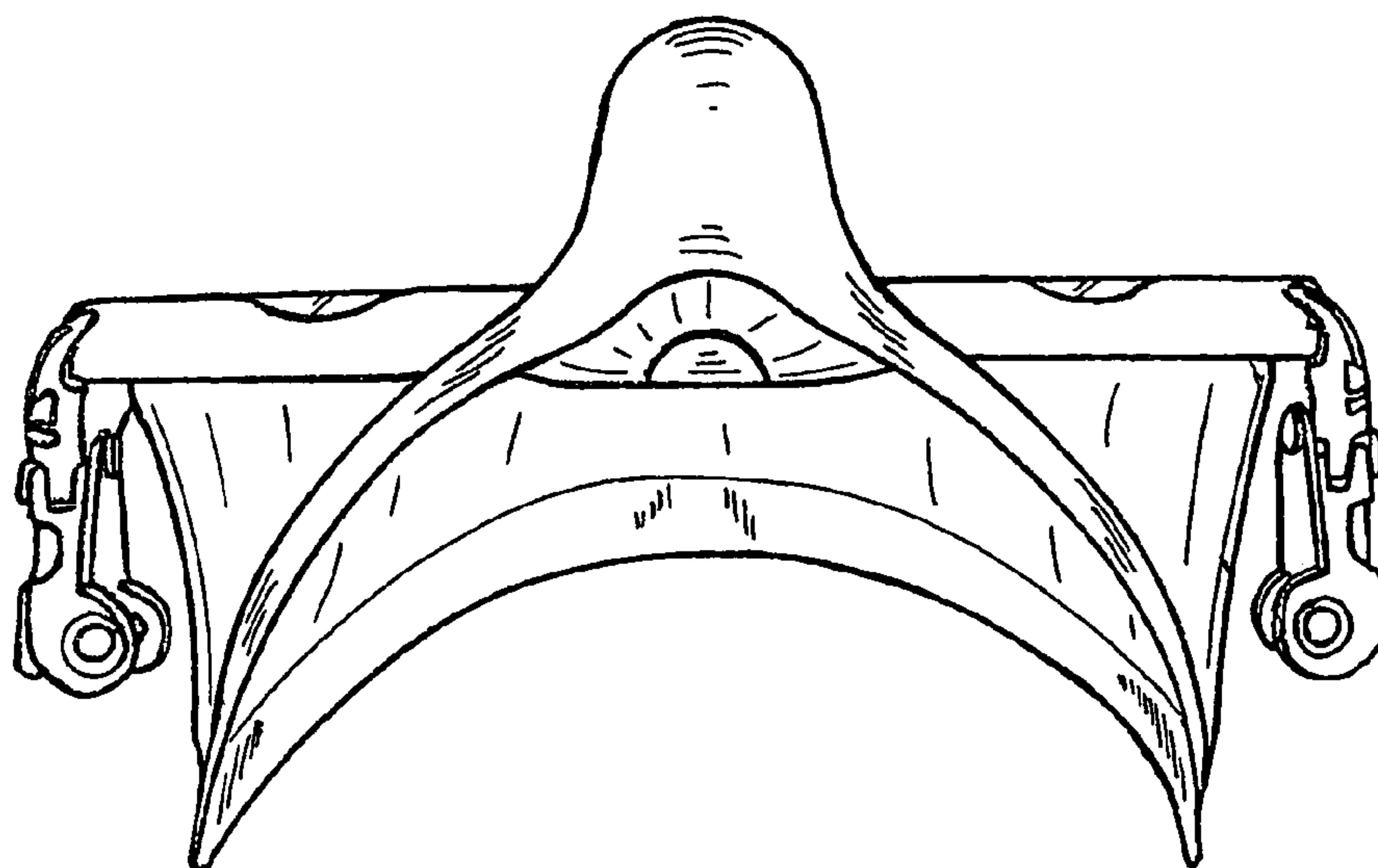

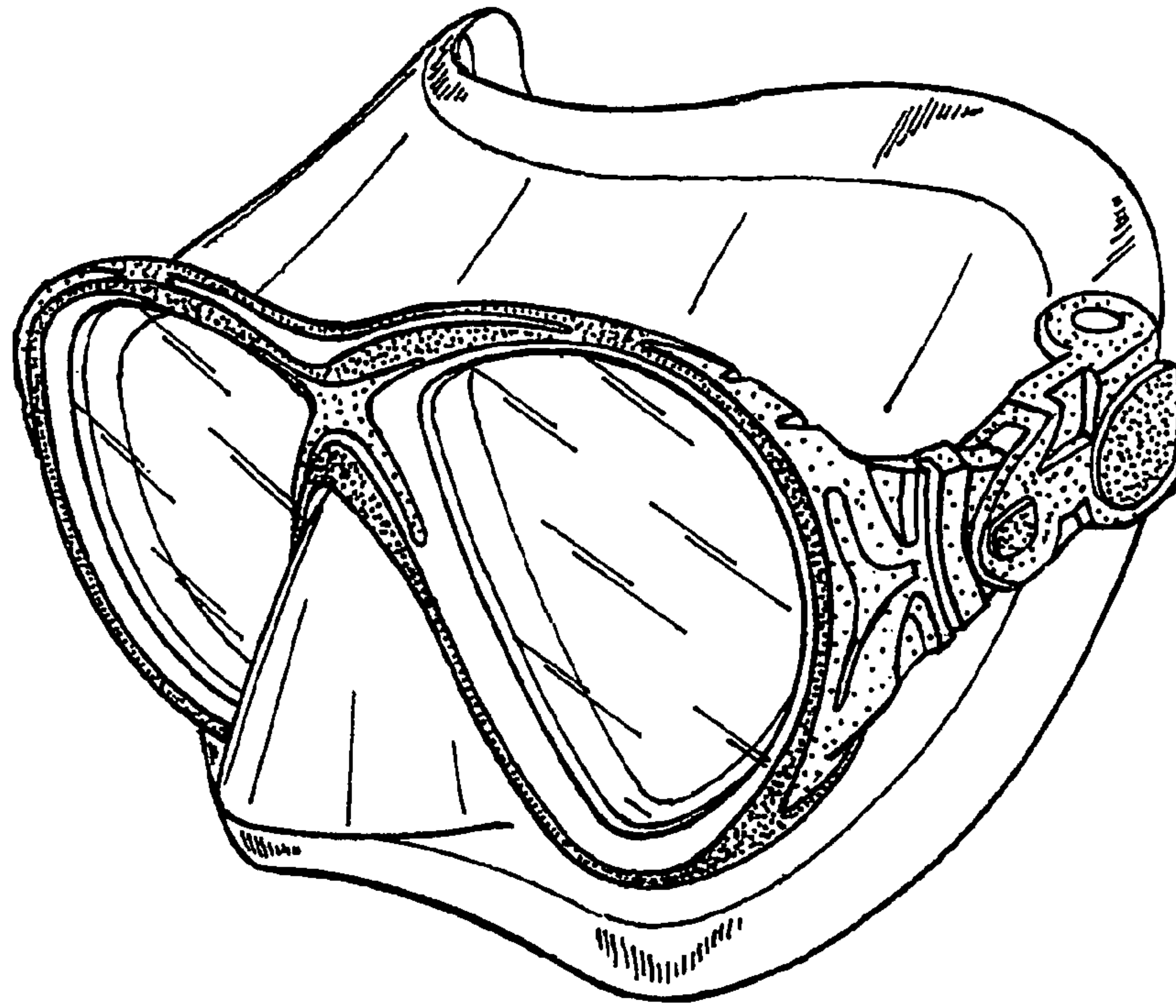

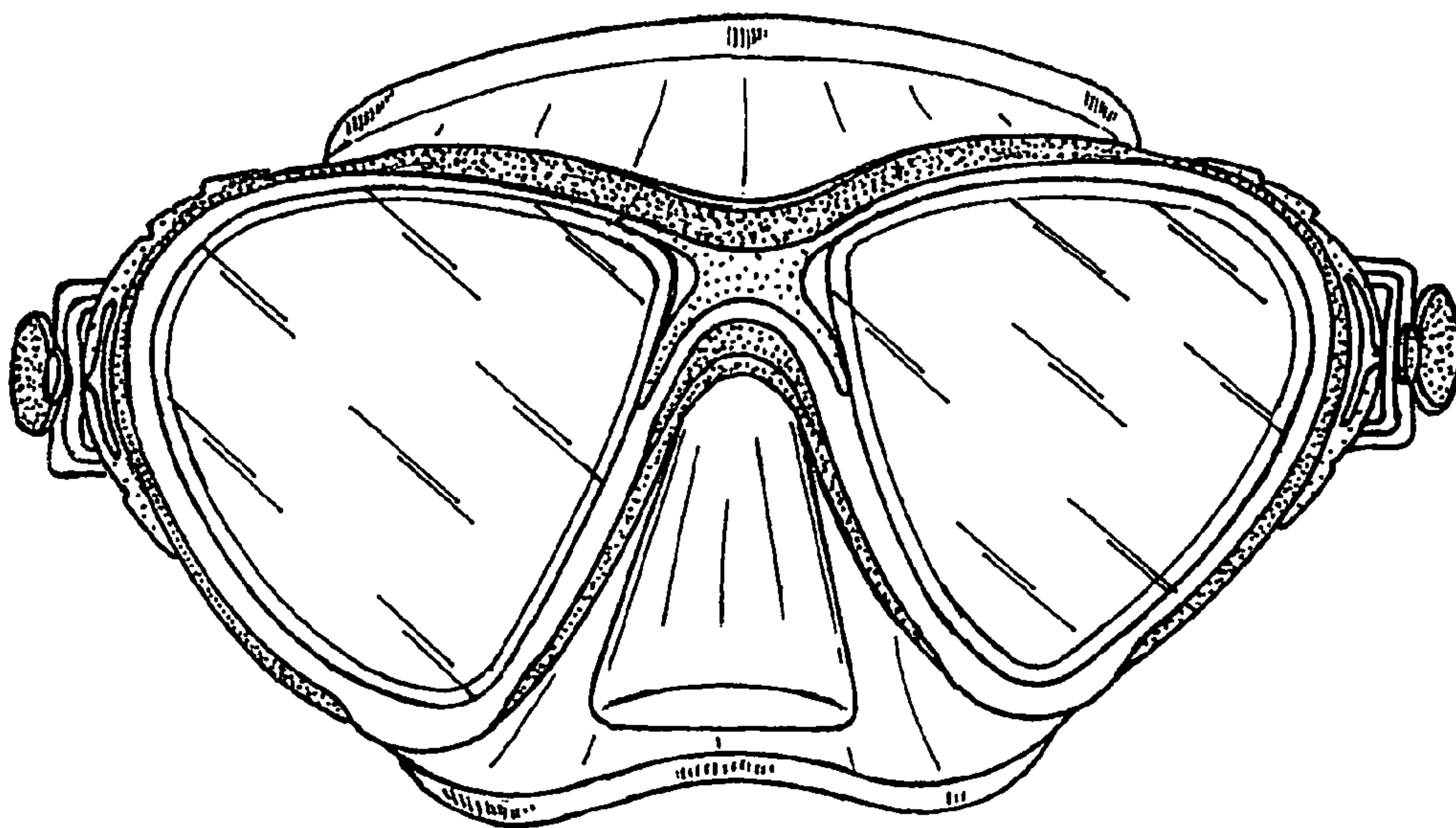

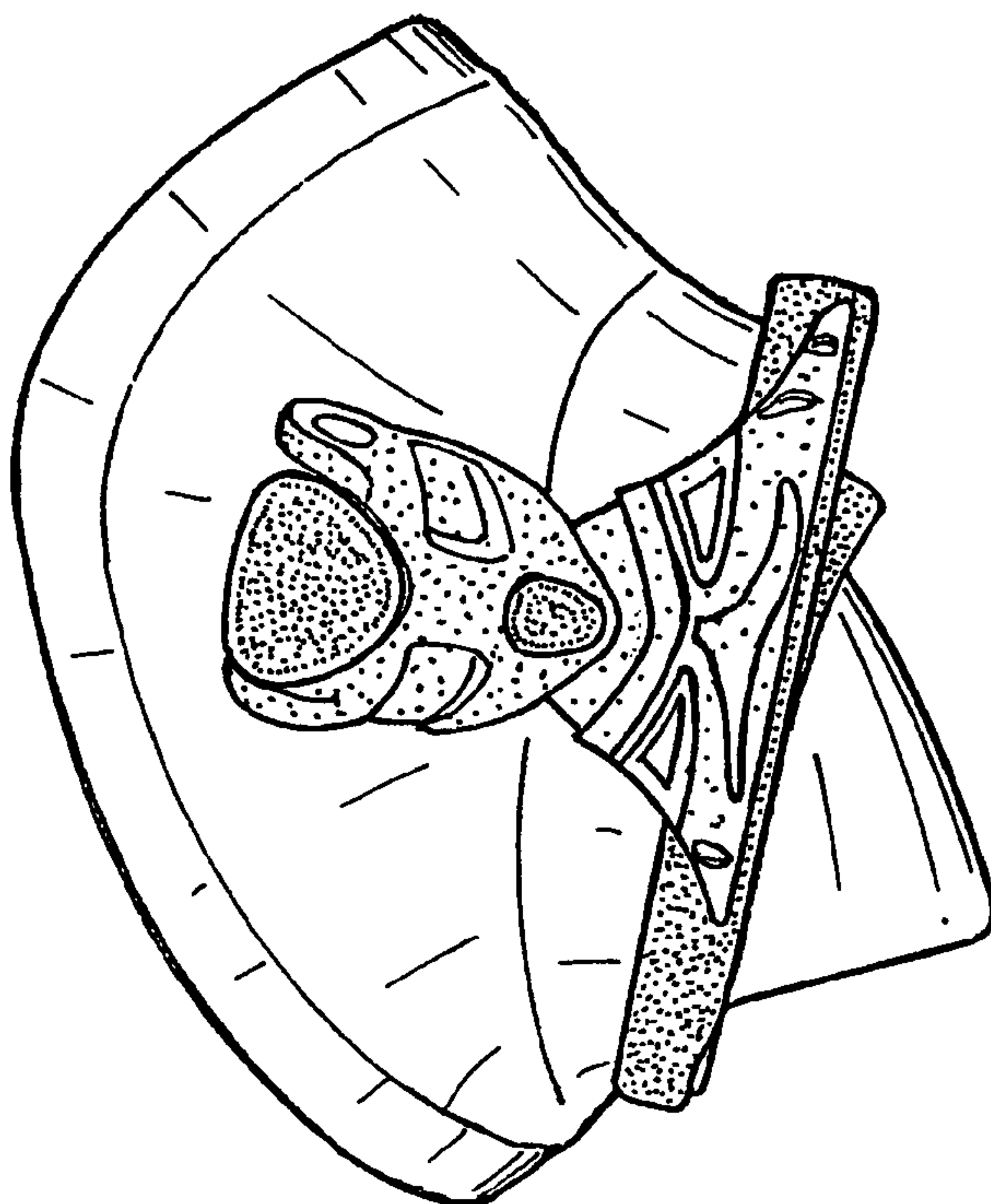

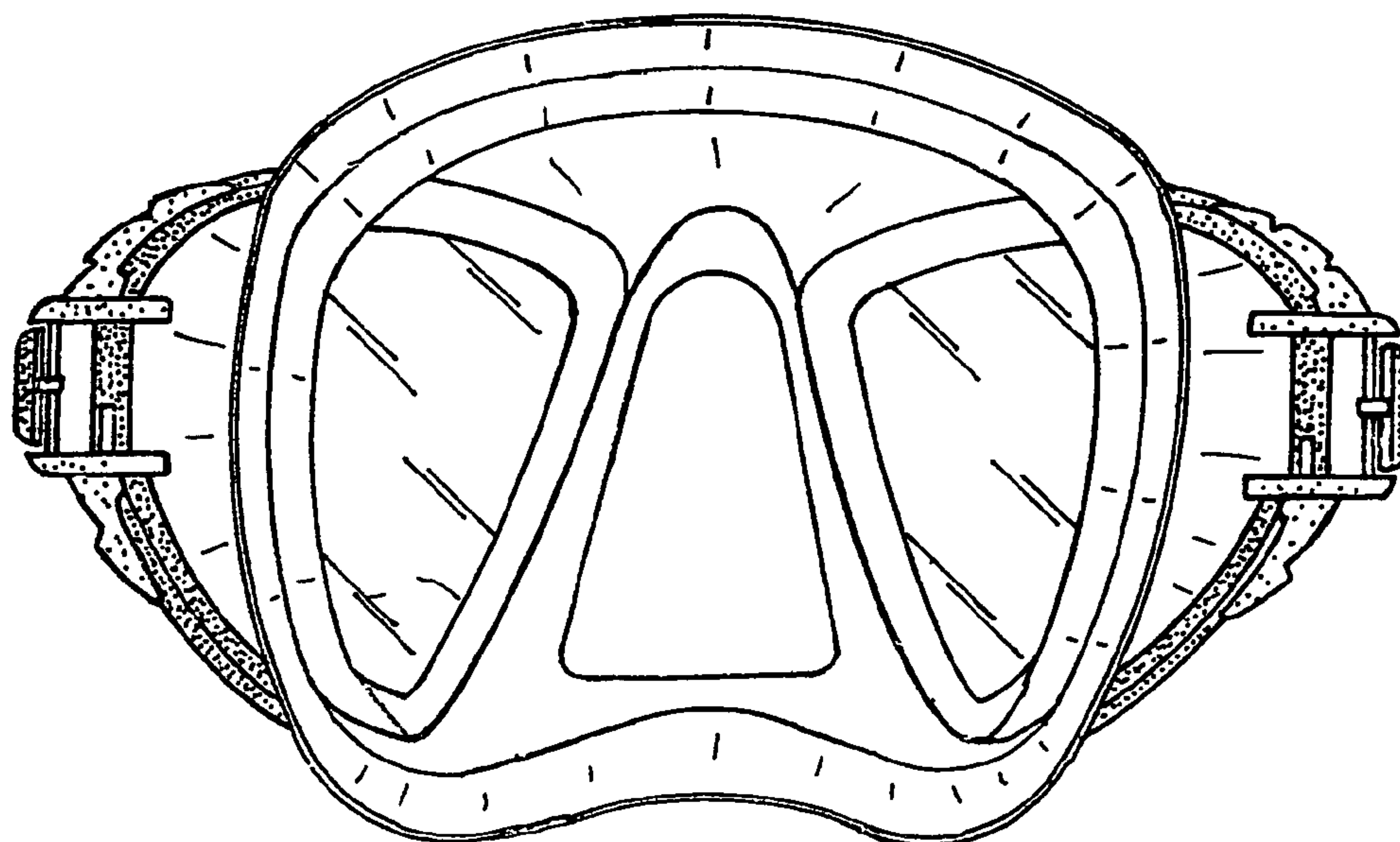

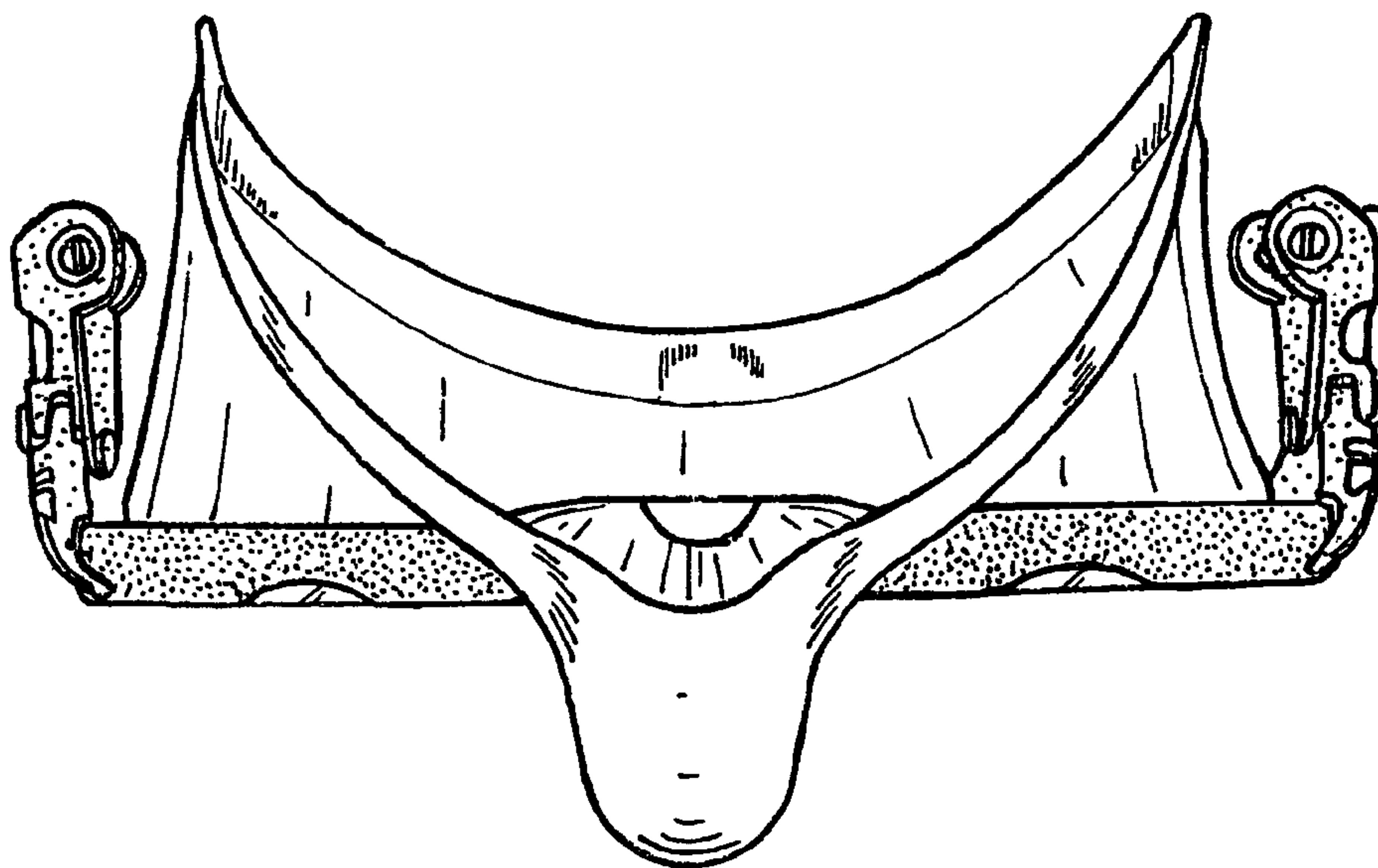

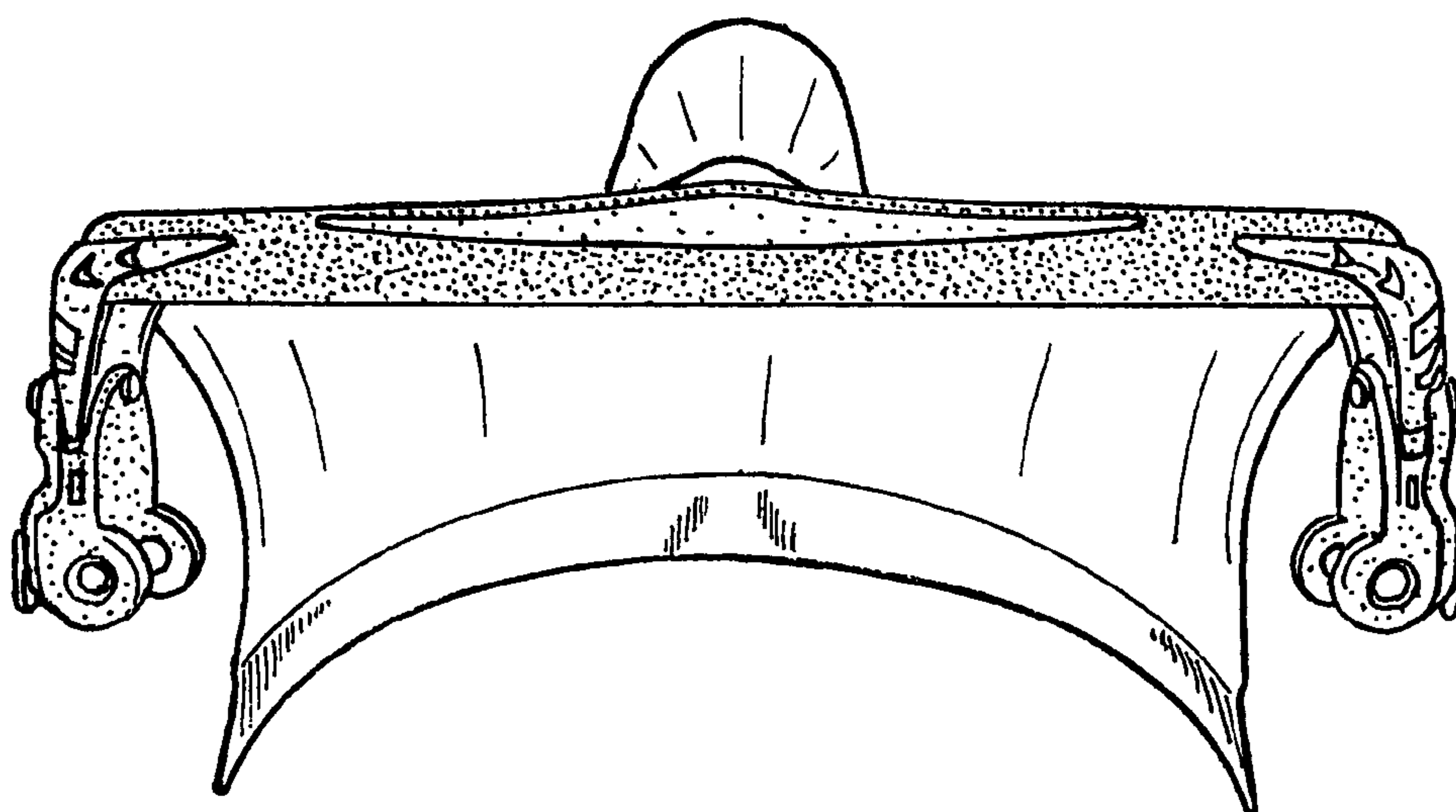
