The ornamental design for a toy track, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the toy track in accordance with my design;

FIG. 2 is a front view of the toy track shown in FIG. 1;

FIG. 3 is a rear view of the toy track shown in FIGS. 1-2;

FIG. 4 is a top view of the toy track shown in FIGS. 1-3;

FIG. 5 is a bottom view of the toy track shown in FIGS. 1-4;

FIG. 6 is a right side view of the toy track shown in FIGS. 1-5;

FIG. 7 is a left side view of the toy track shown in FIGS. 1-6;

FIG. 8 is a perspective view of an alternative embodiment of the toy track shown in FIGS. 1-7;

FIG. 9 is a front view of the alternative embodiment of the toy track shown in FIG. 8;

FIG. 10 is a rear view of the alternative embodiment of the toy track shown in FIGS. 8-9;

FIG. 11 is a top view of the alternative embodiment of the toy track shown in FIGS. 8-10;

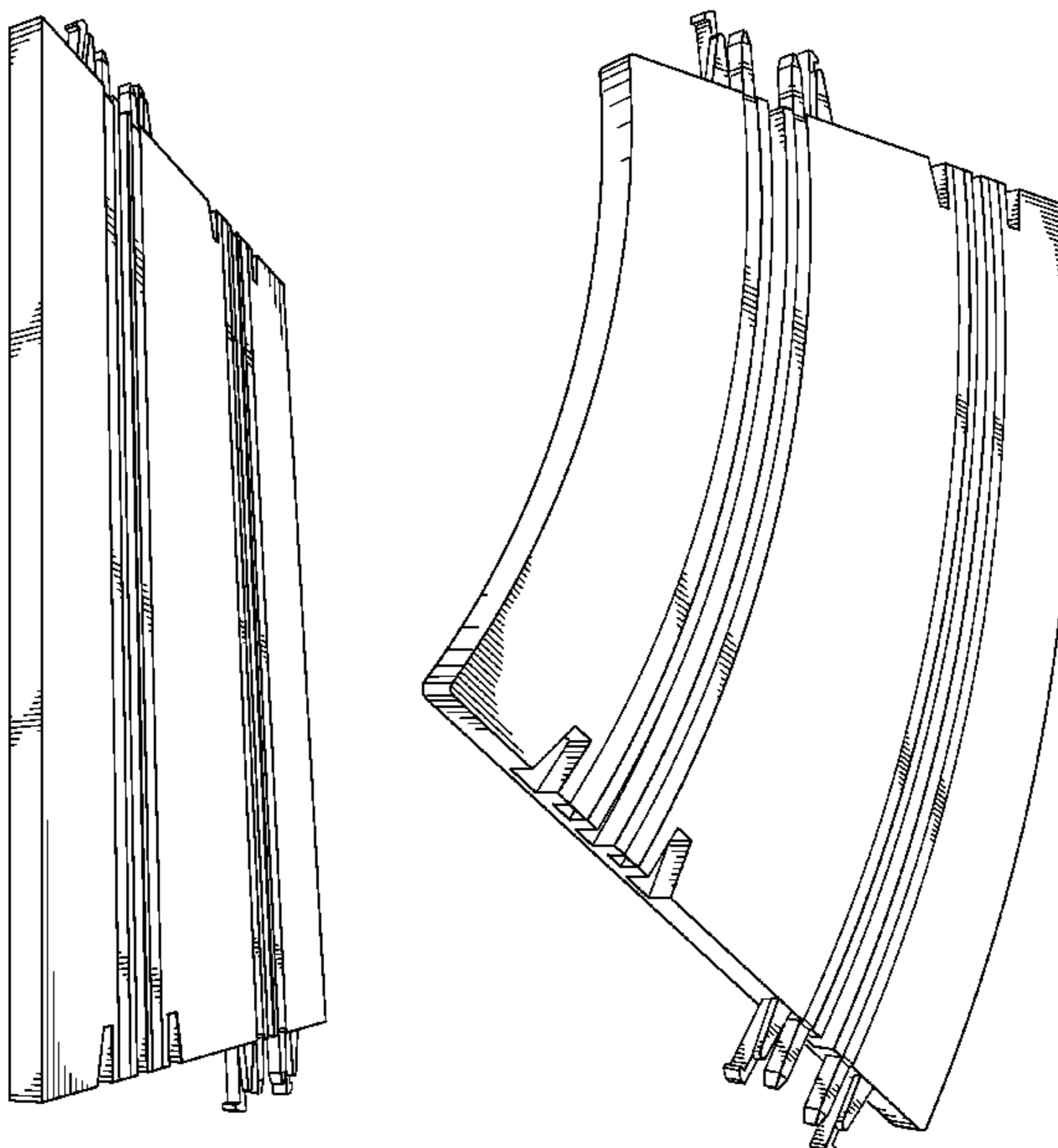
FIG. 12 is a bottom view of the alternative embodiment of the toy track shown in FIGS. 8-11;

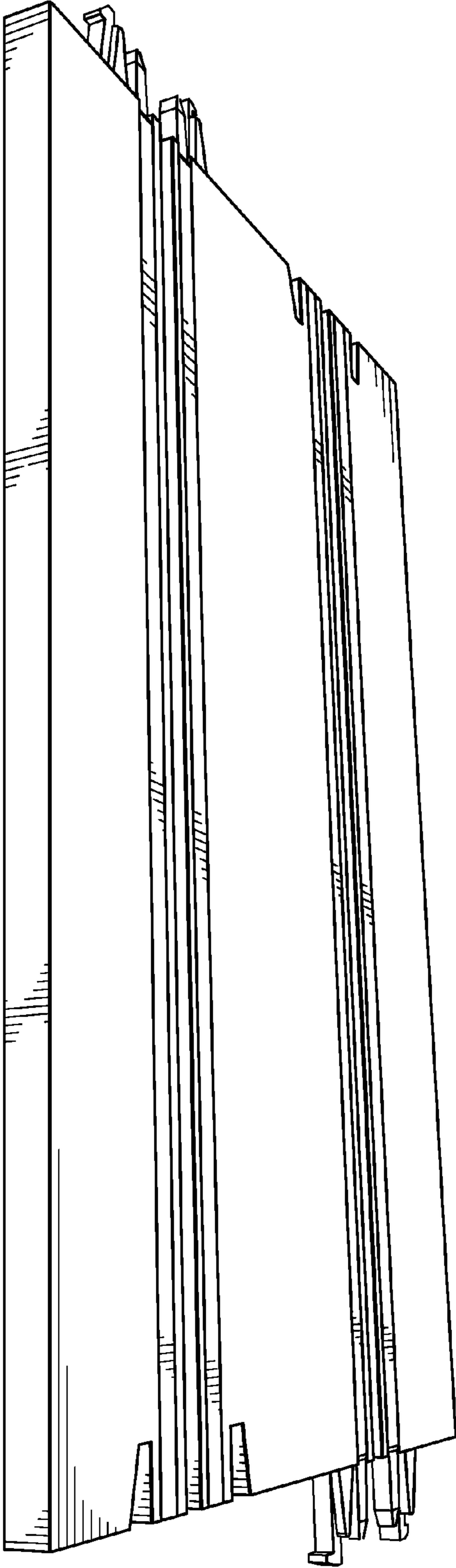

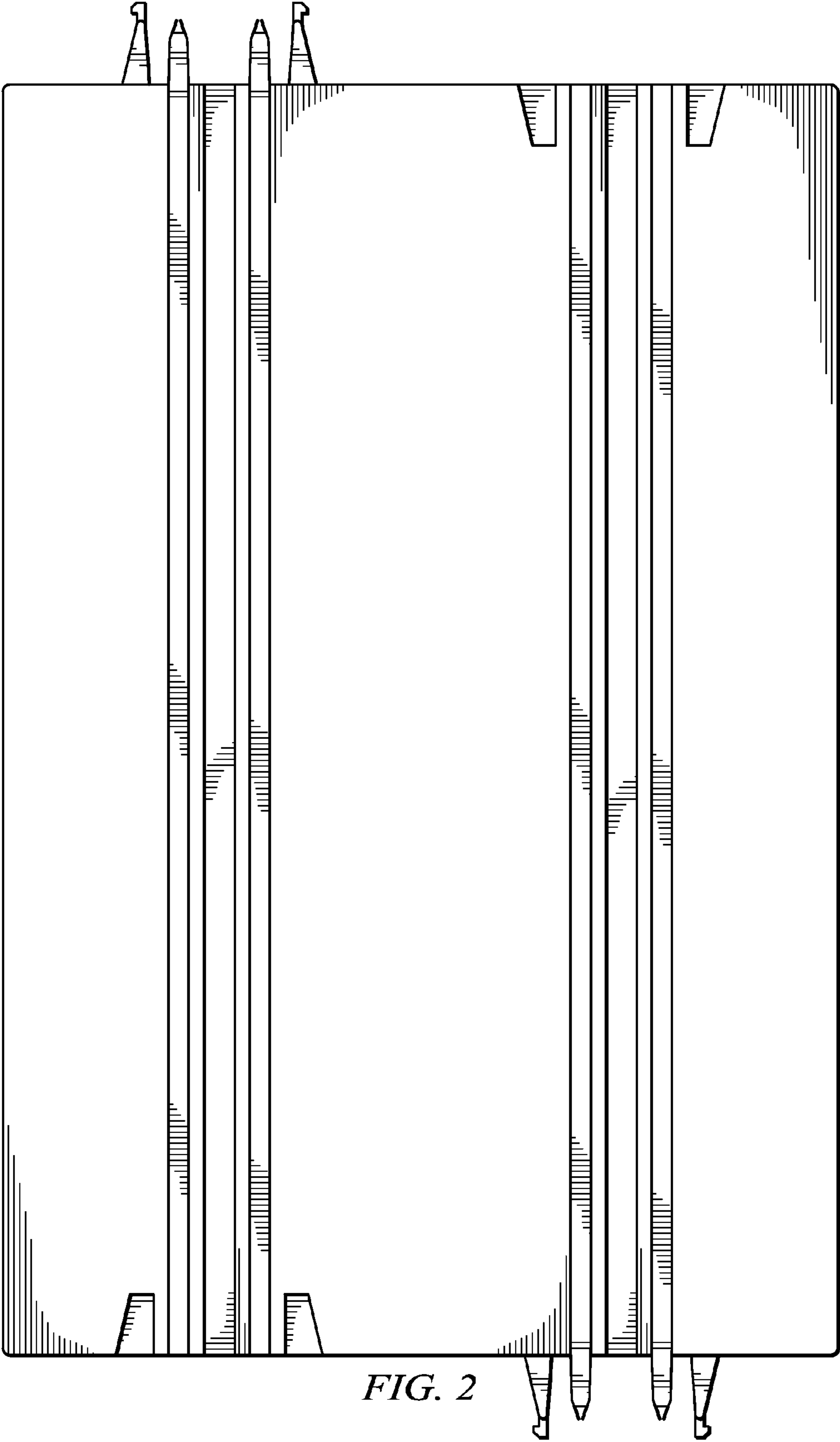

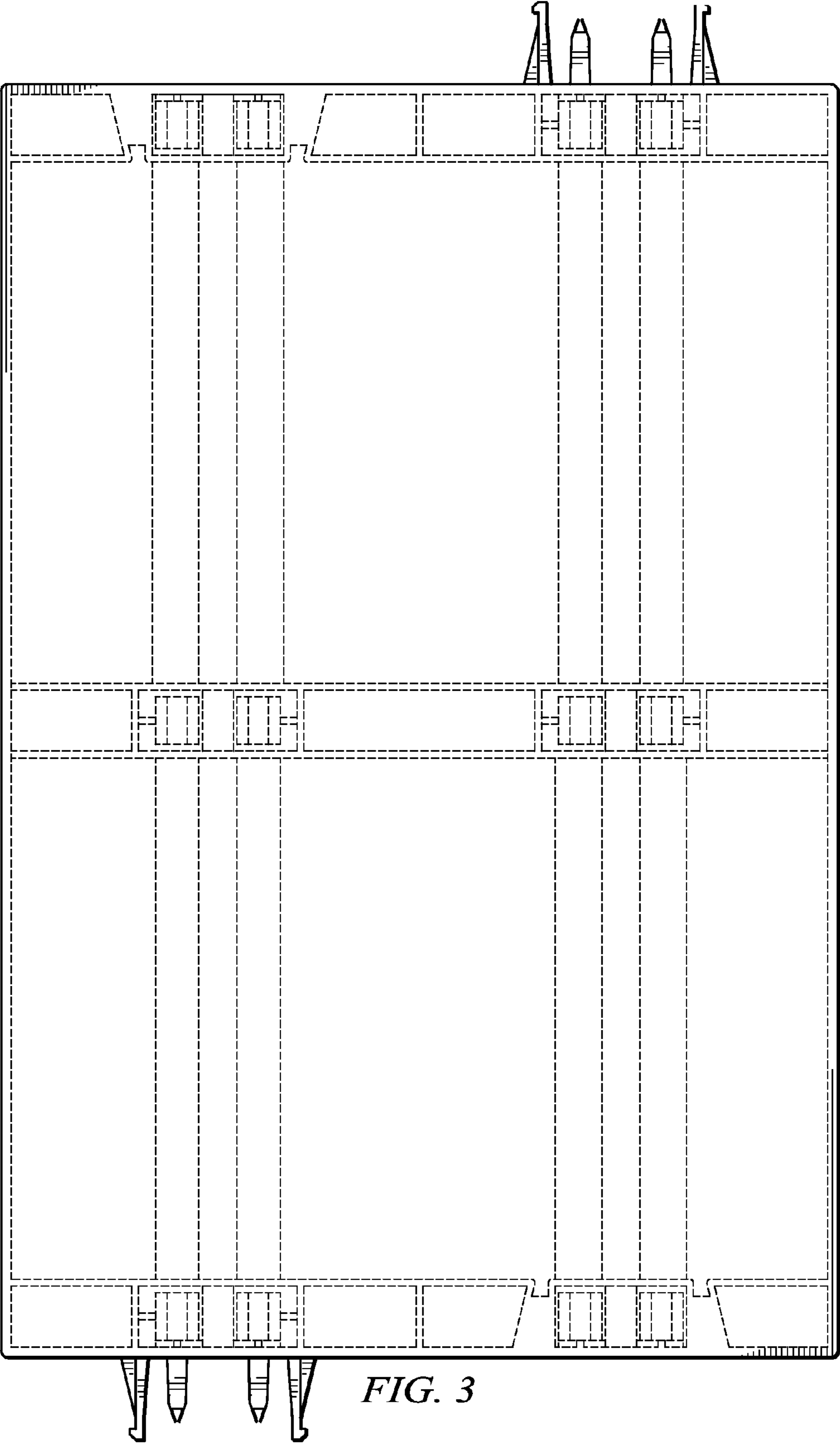

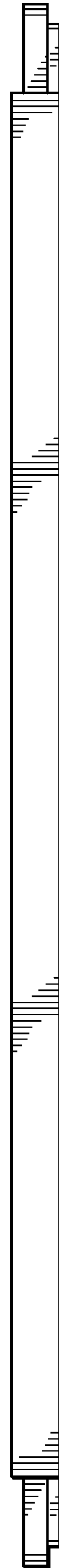

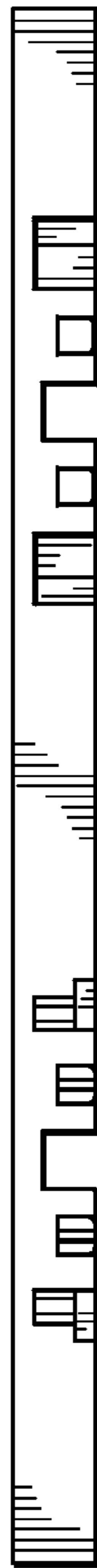

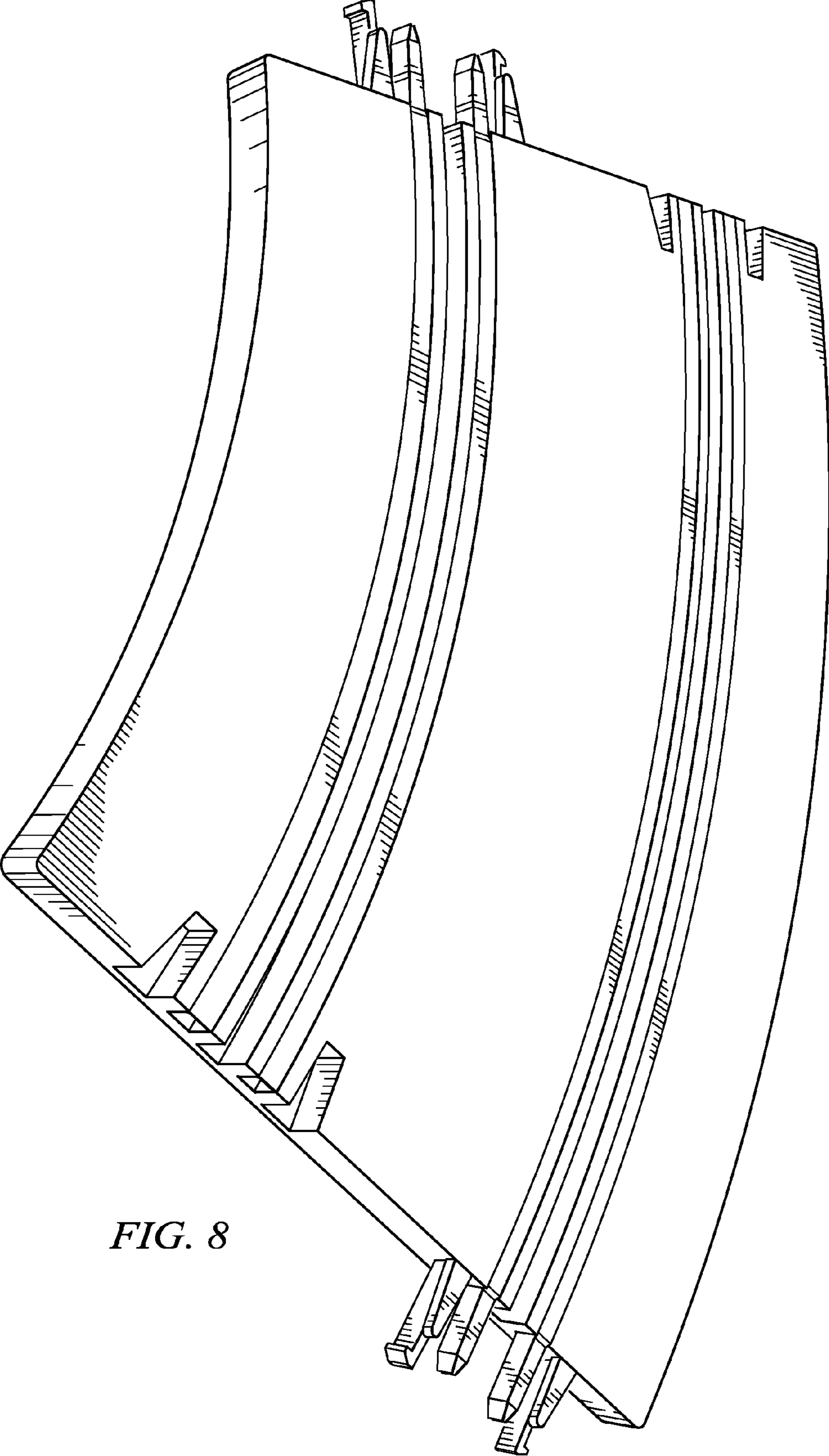

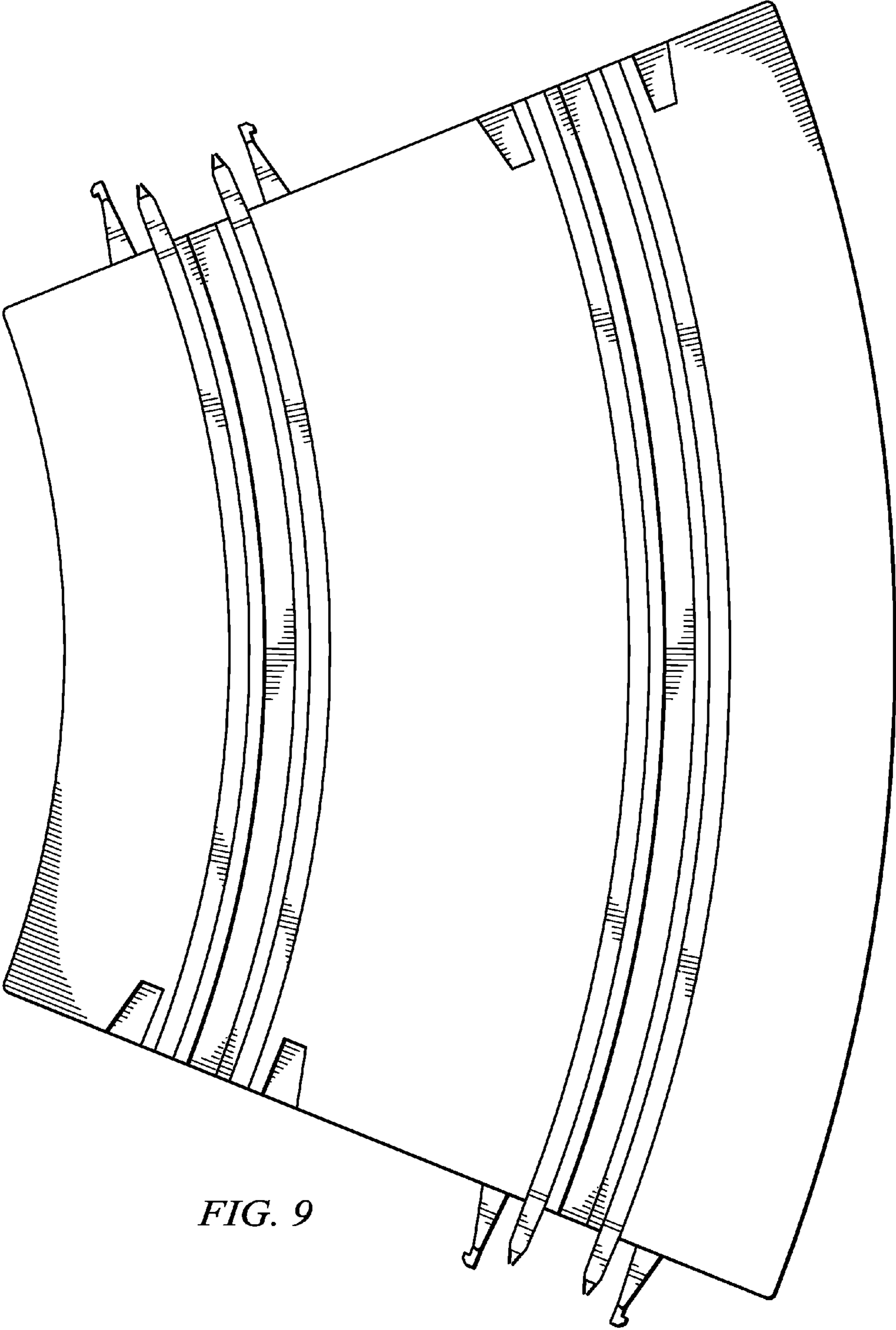

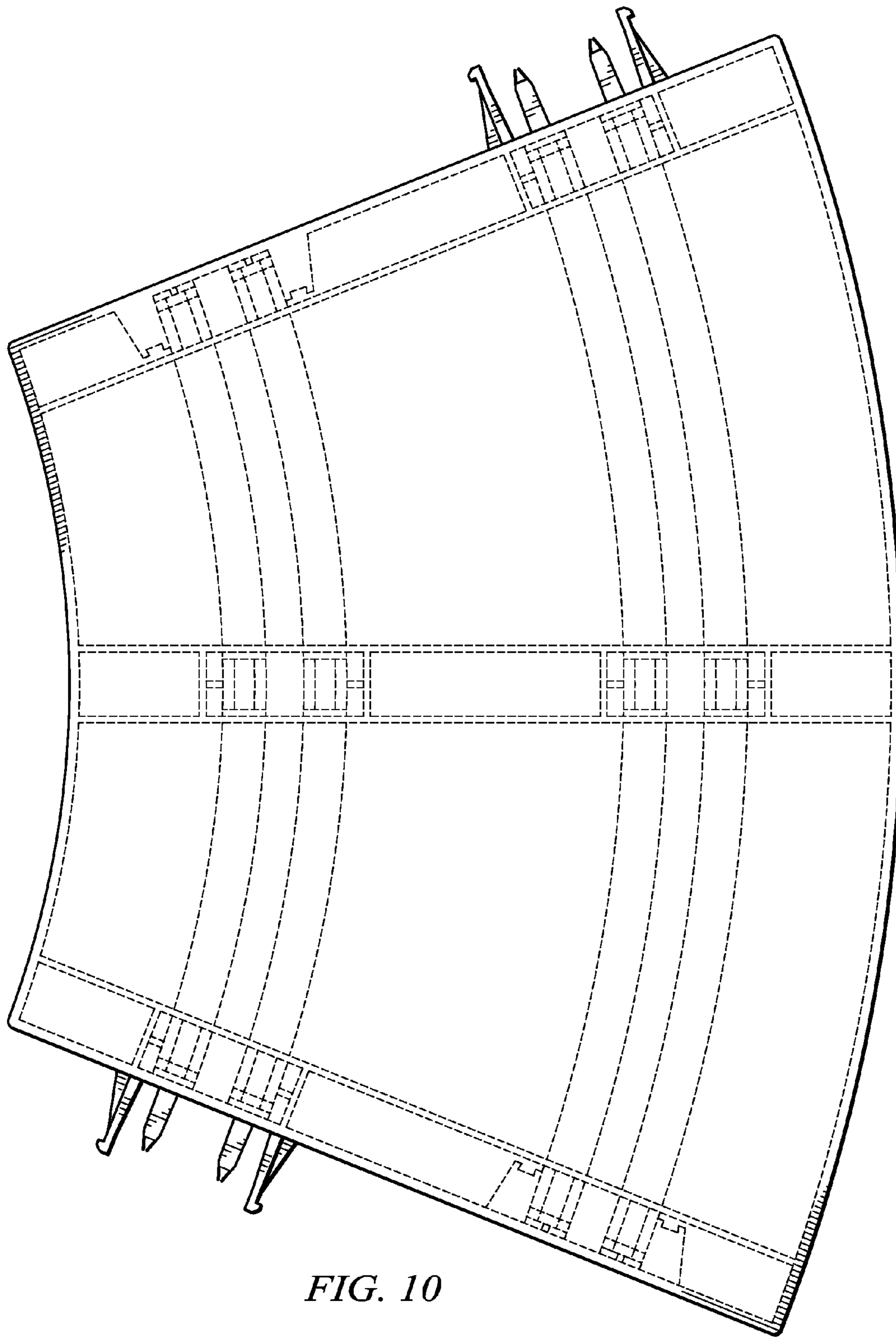

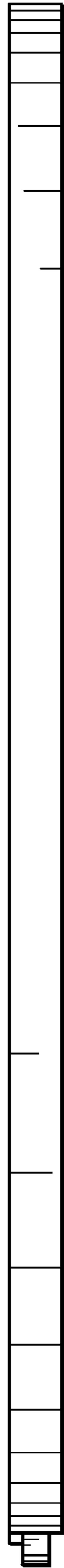
