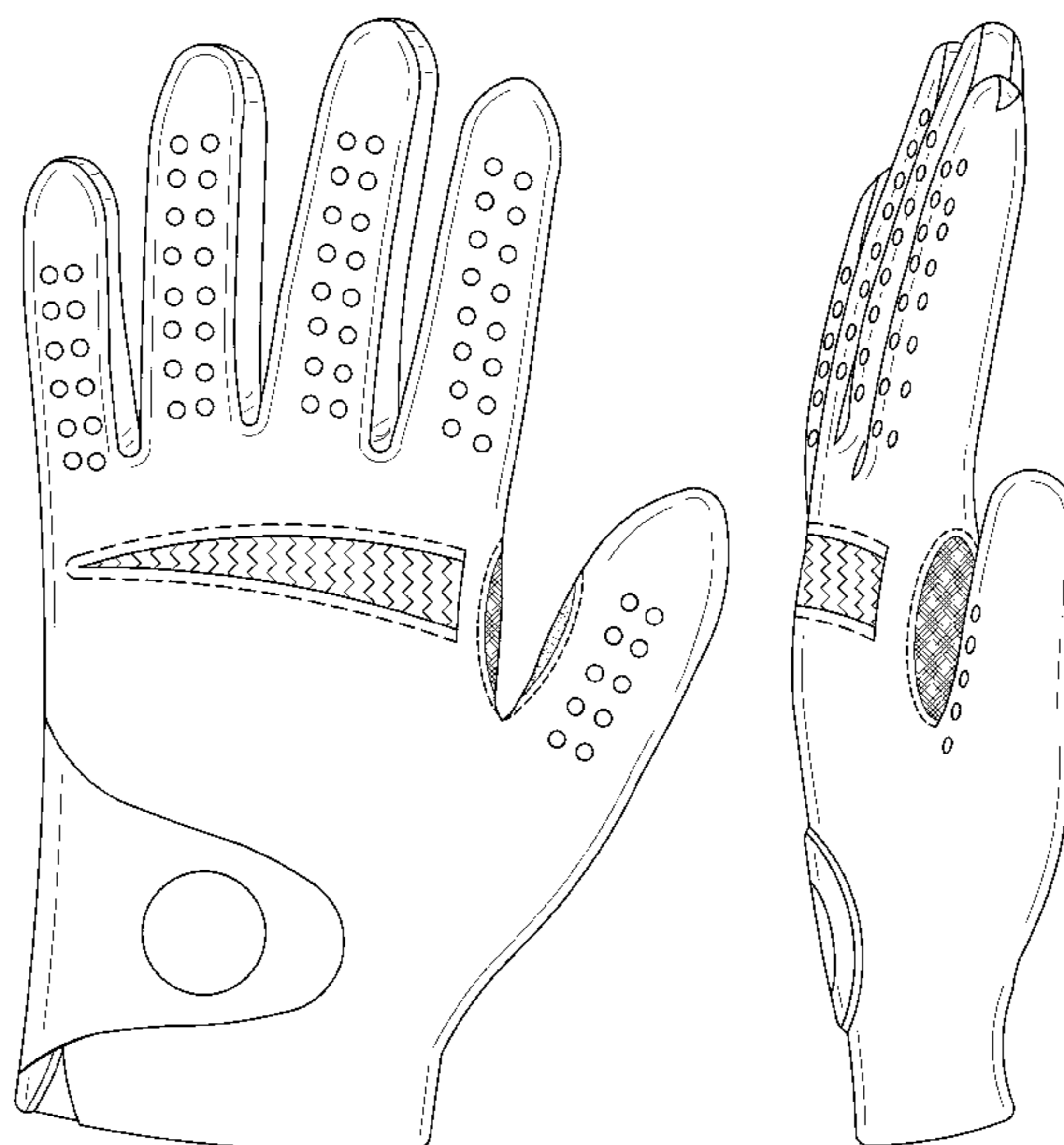
(57) **CLAIM**

The ornamental design for a golf glove, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a golf glove showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a right elevation view thereof;
FIG. 4 is a left elevation view thereof;
FIG. 5 is a front elevation view thereof; and,
FIG. 6 is a rear elevation view thereof.
The dashed lines in the drawings depict stitching.

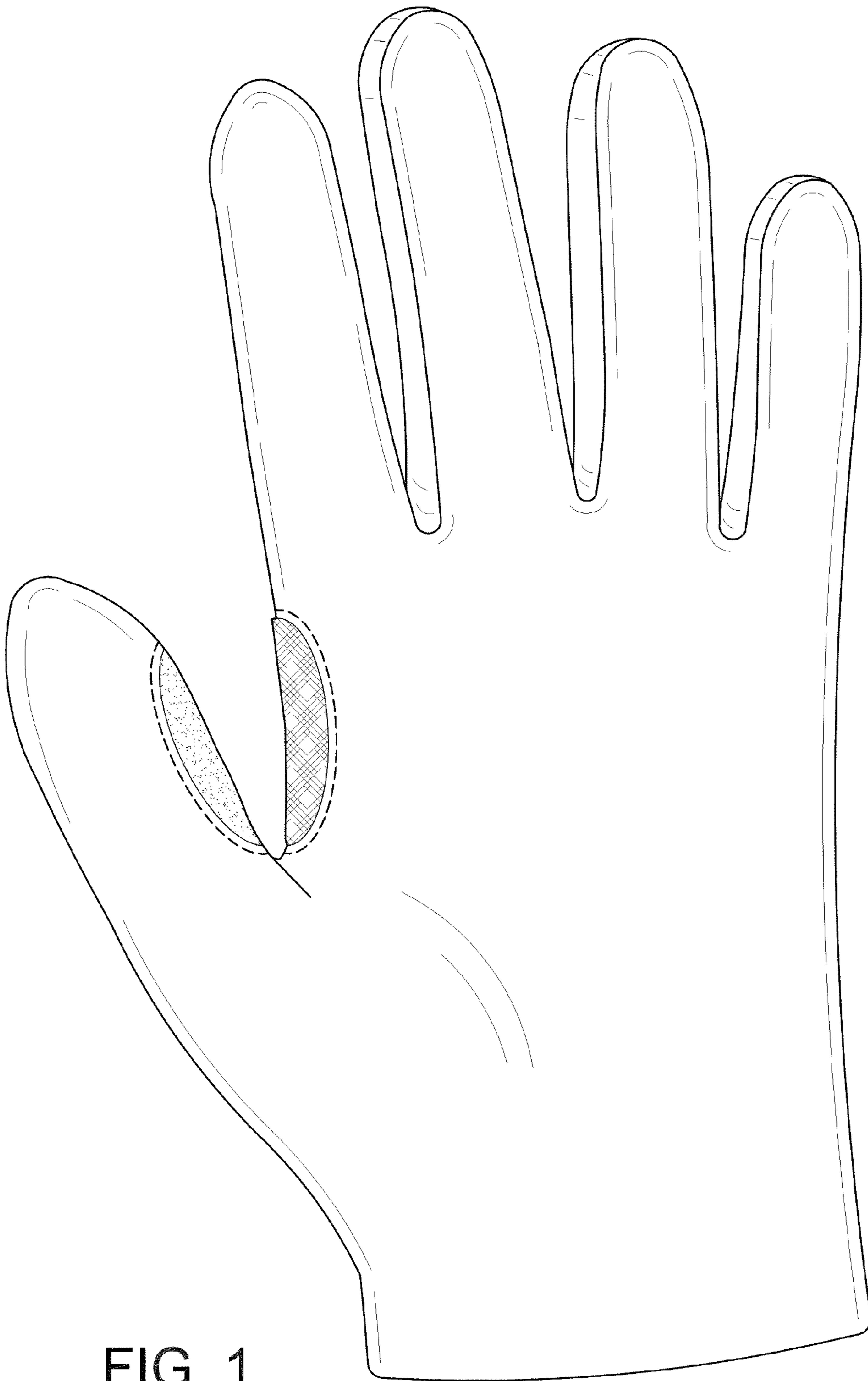

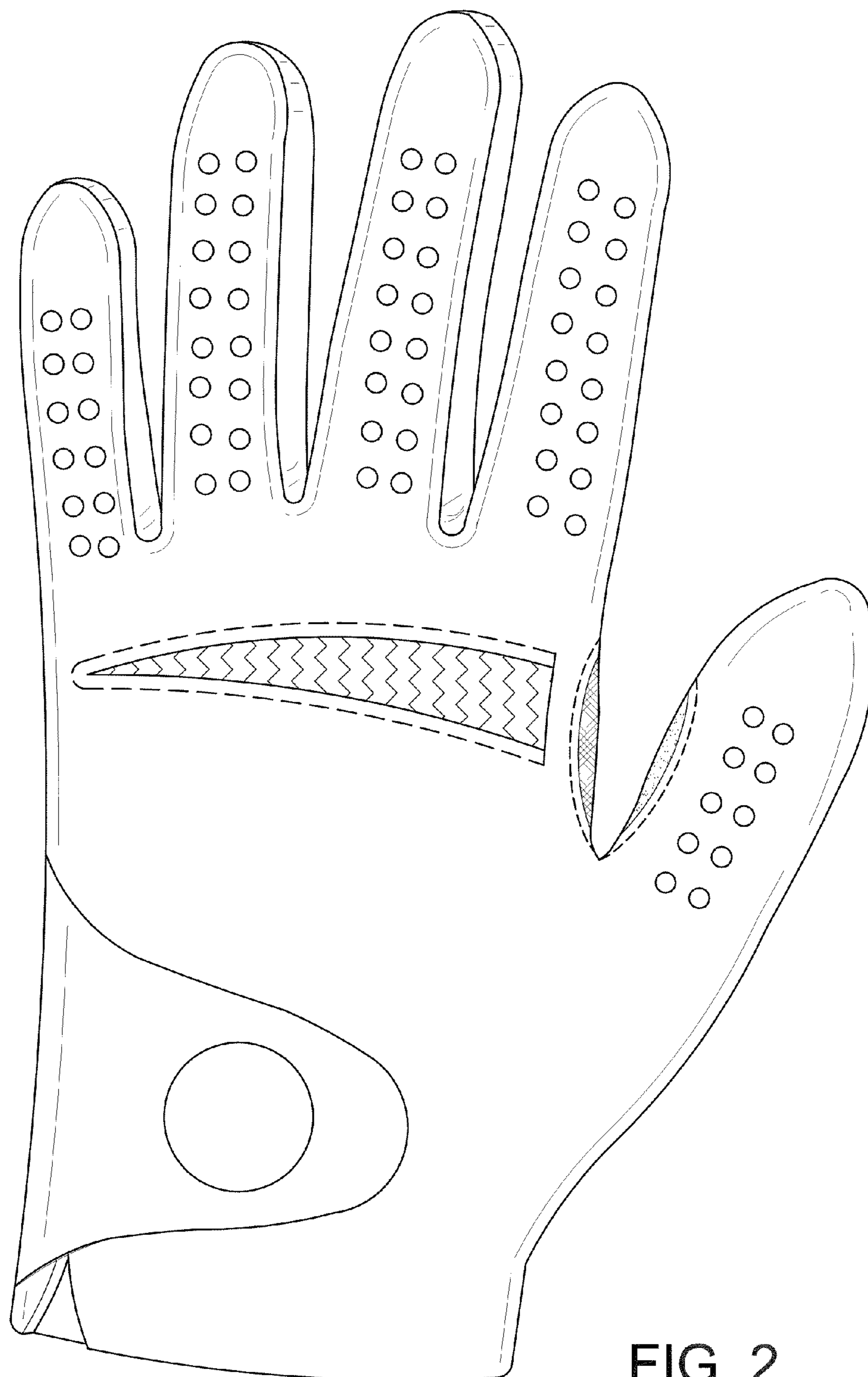

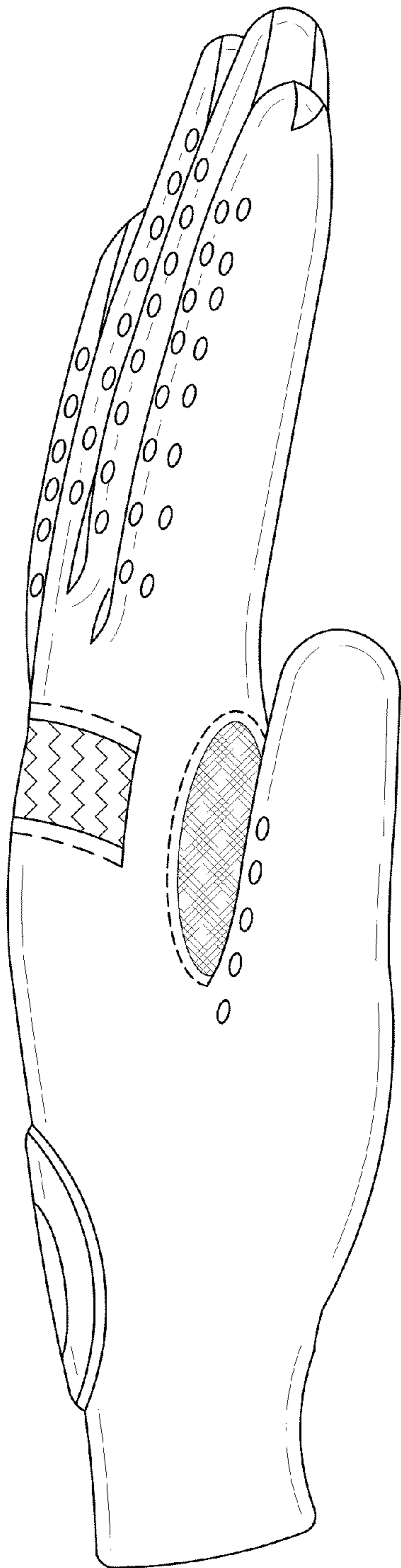

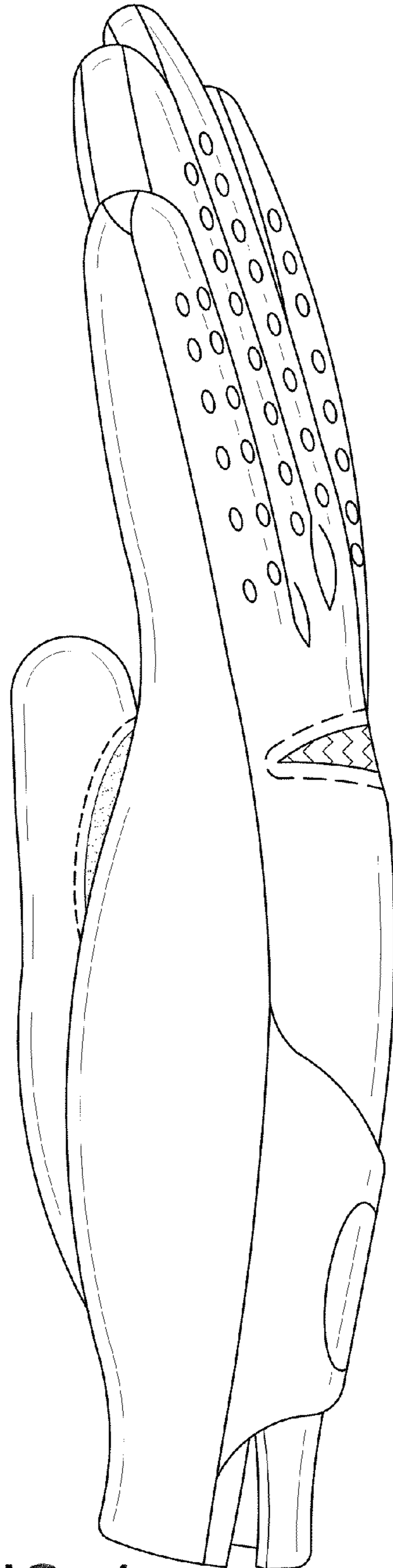

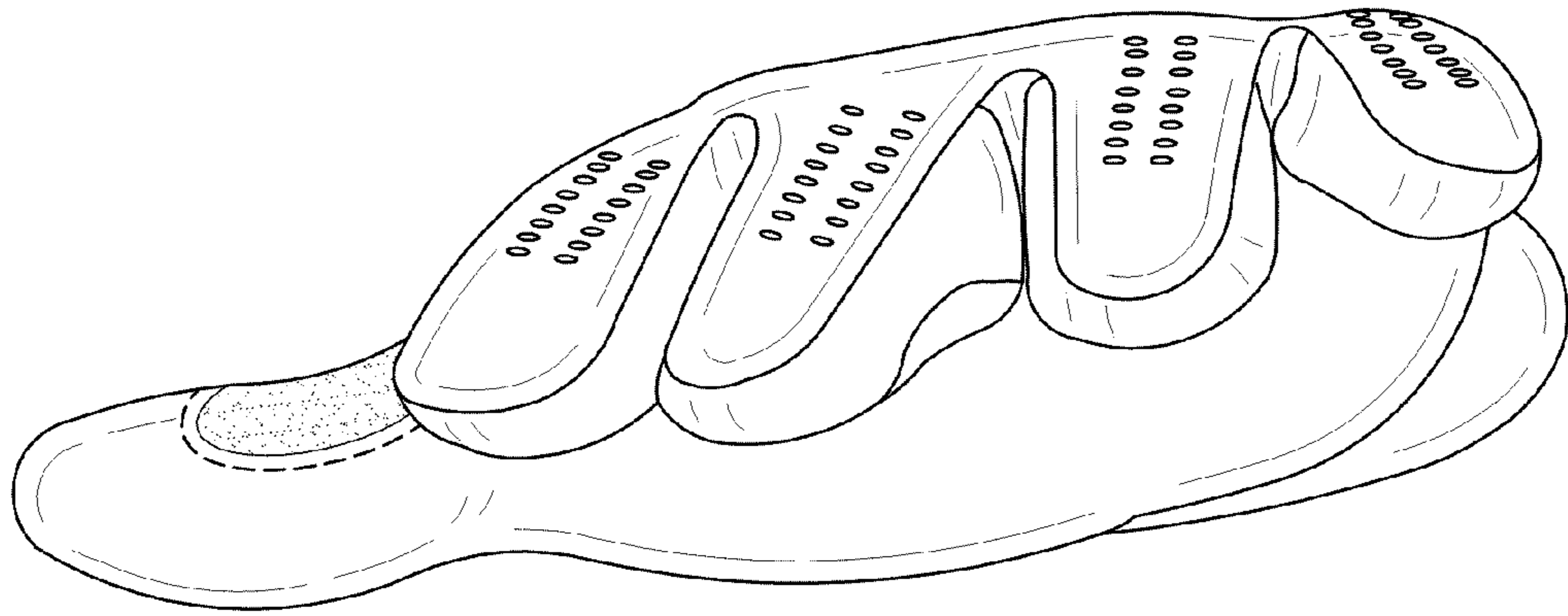

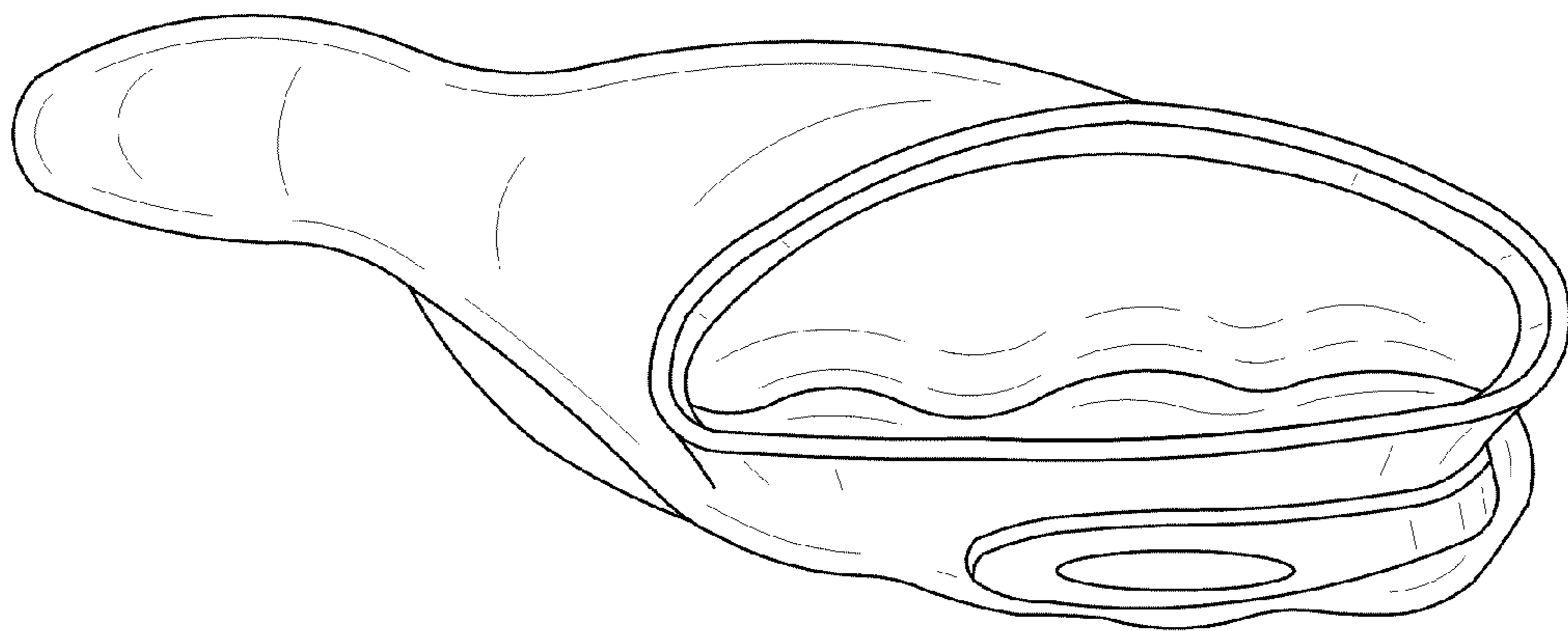
