(57) **CLAIM**

The ornamental design for a cat scratcher, substantially as shown.

DESCRIPTION

FIG. 1 is a perspective view of the cat scratcher of the present invention;

FIG. 2 is a side view thereof, the opposite side is identical;

FIG. 3 is a front elevational view thereof, the opposite side is identical;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is an exploded perspective view thereof illustrating the insert normally nested within the outer shell of the FIG. 1 configuration;

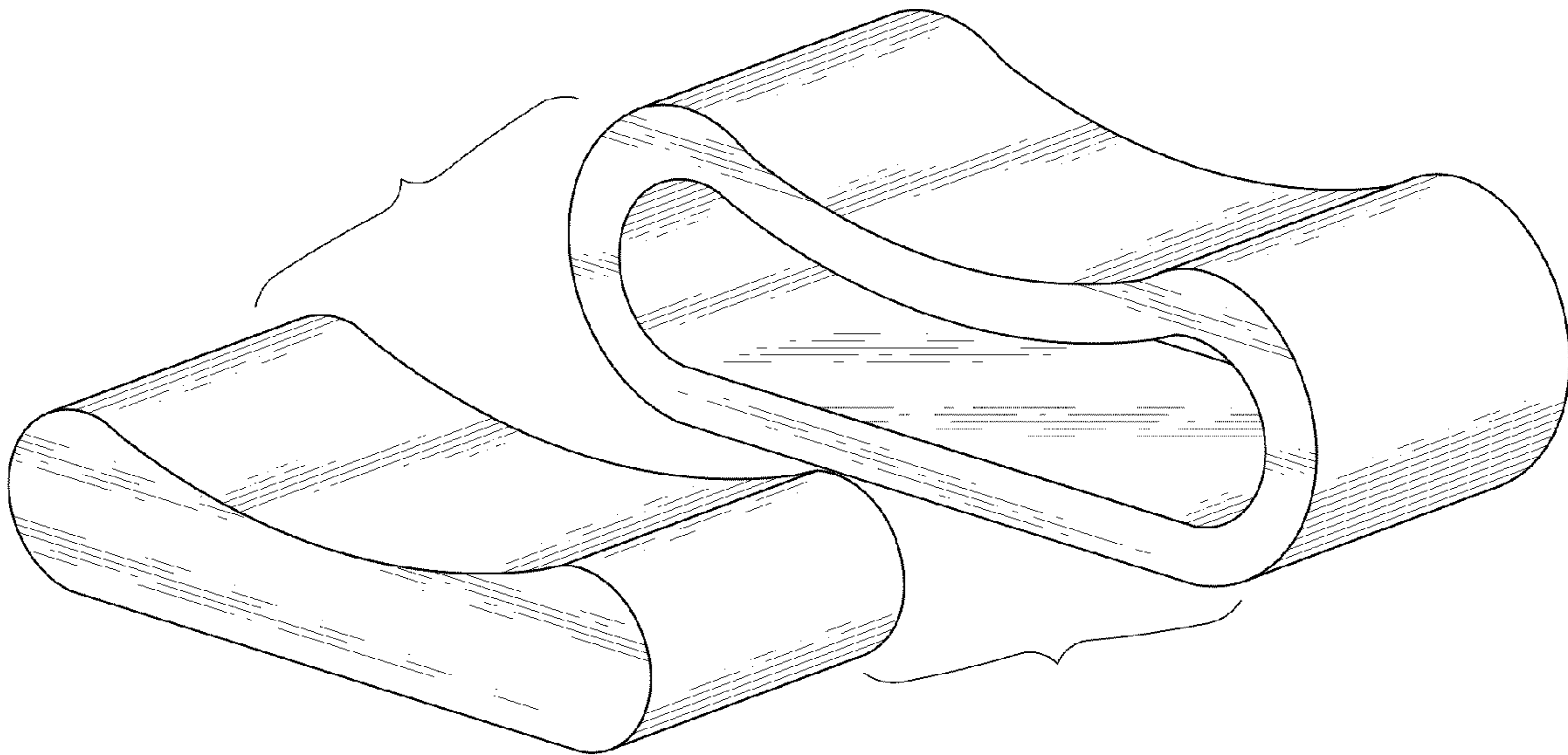
FIG. 7 is a side view of the insert of FIG. 6, the opposite side is identical;

FIG. 8 is a front elevational view of the insert of FIG. 6, the opposite side is identical;

FIG. 9 is a top plan view of the insert of FIG. 6; and,

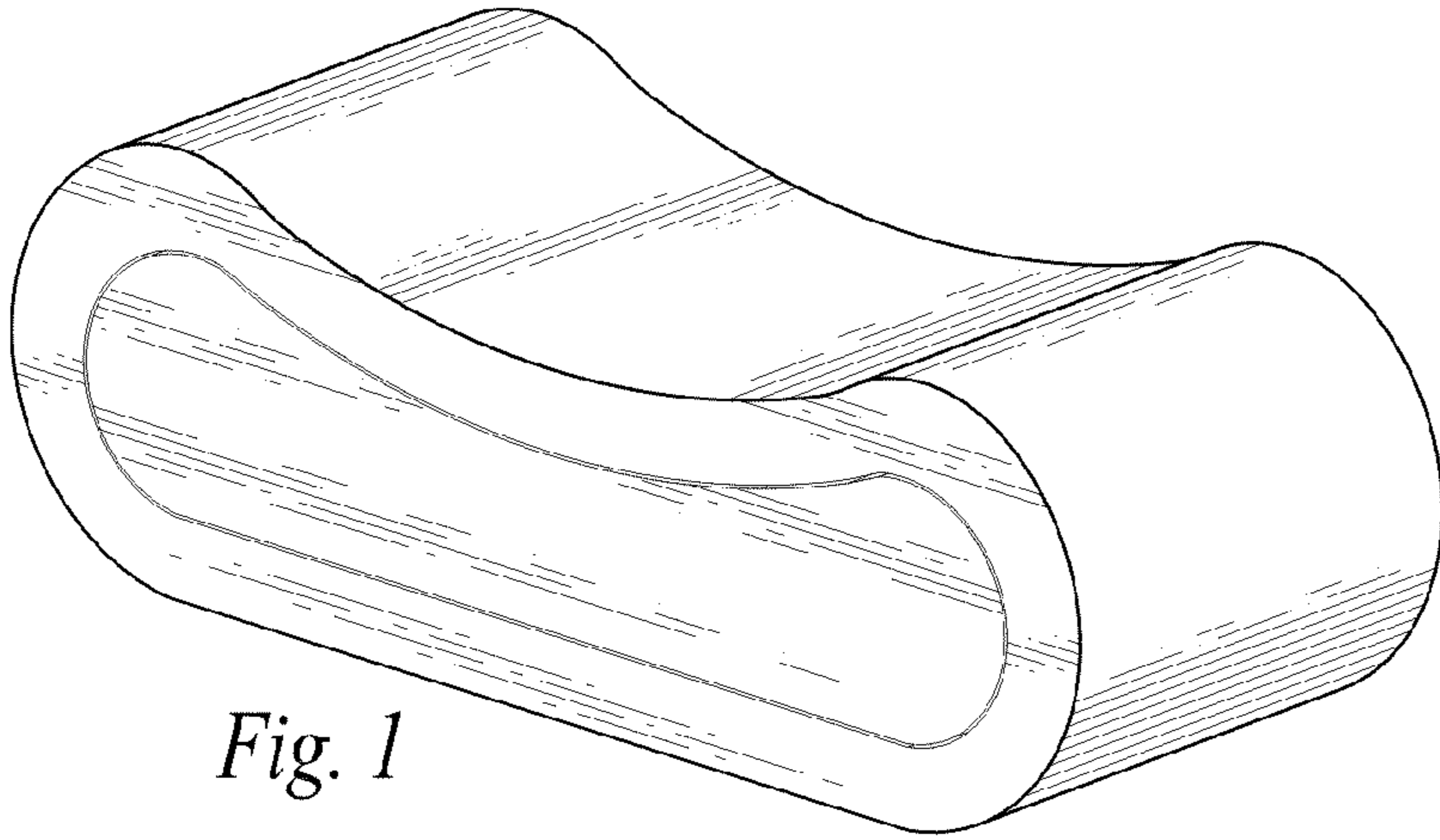

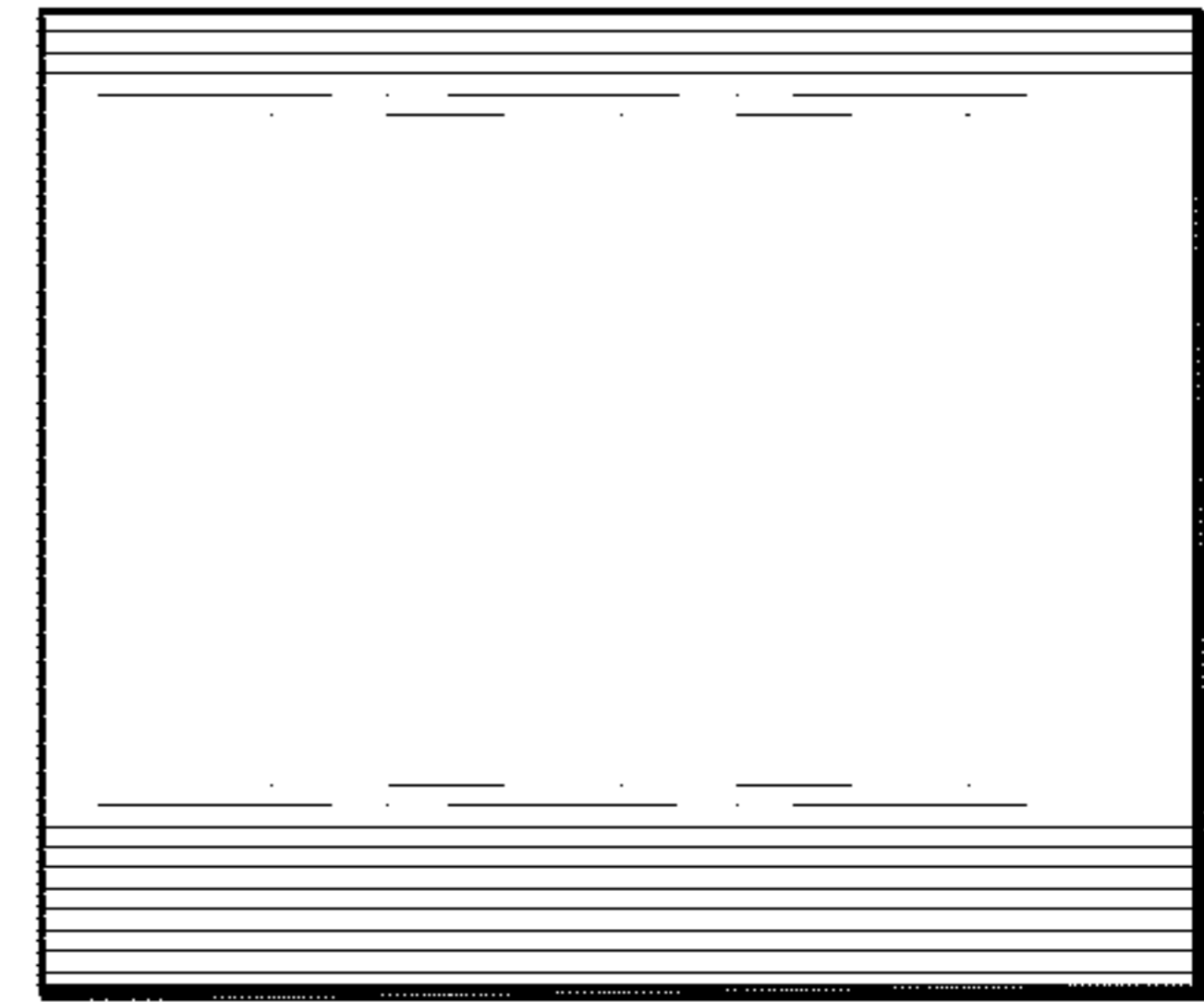

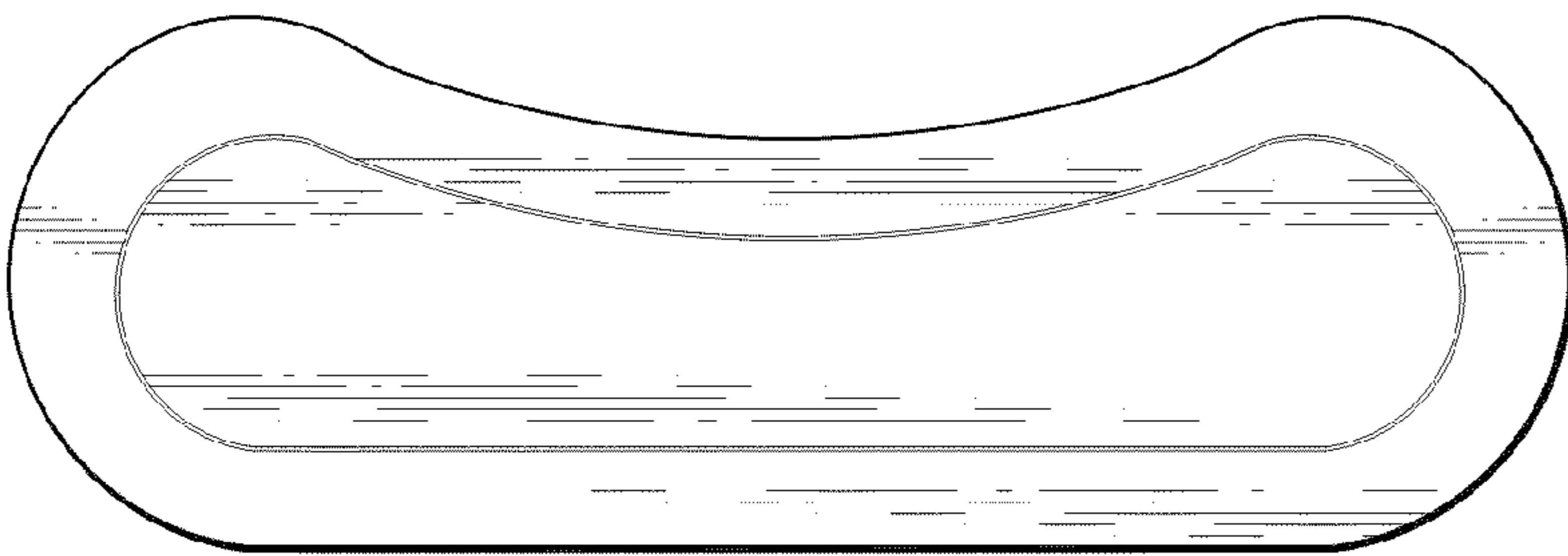

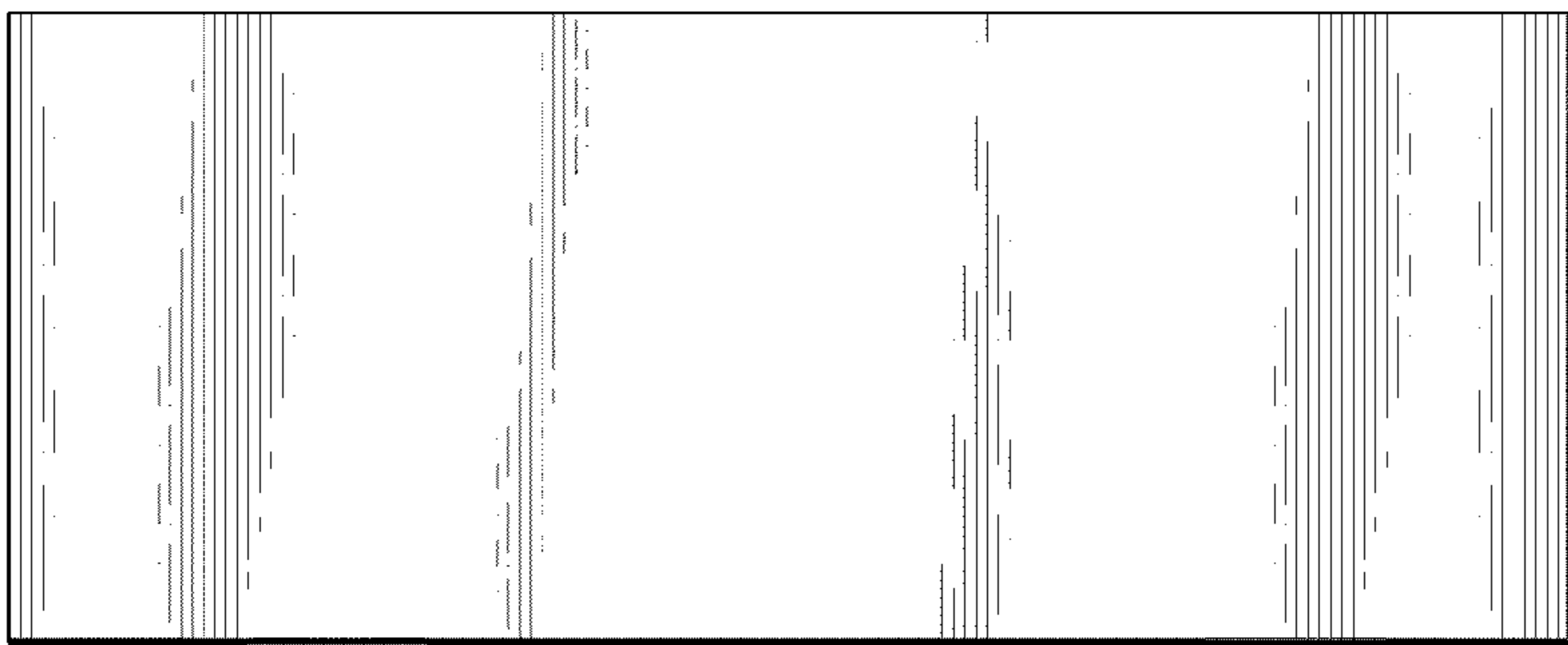

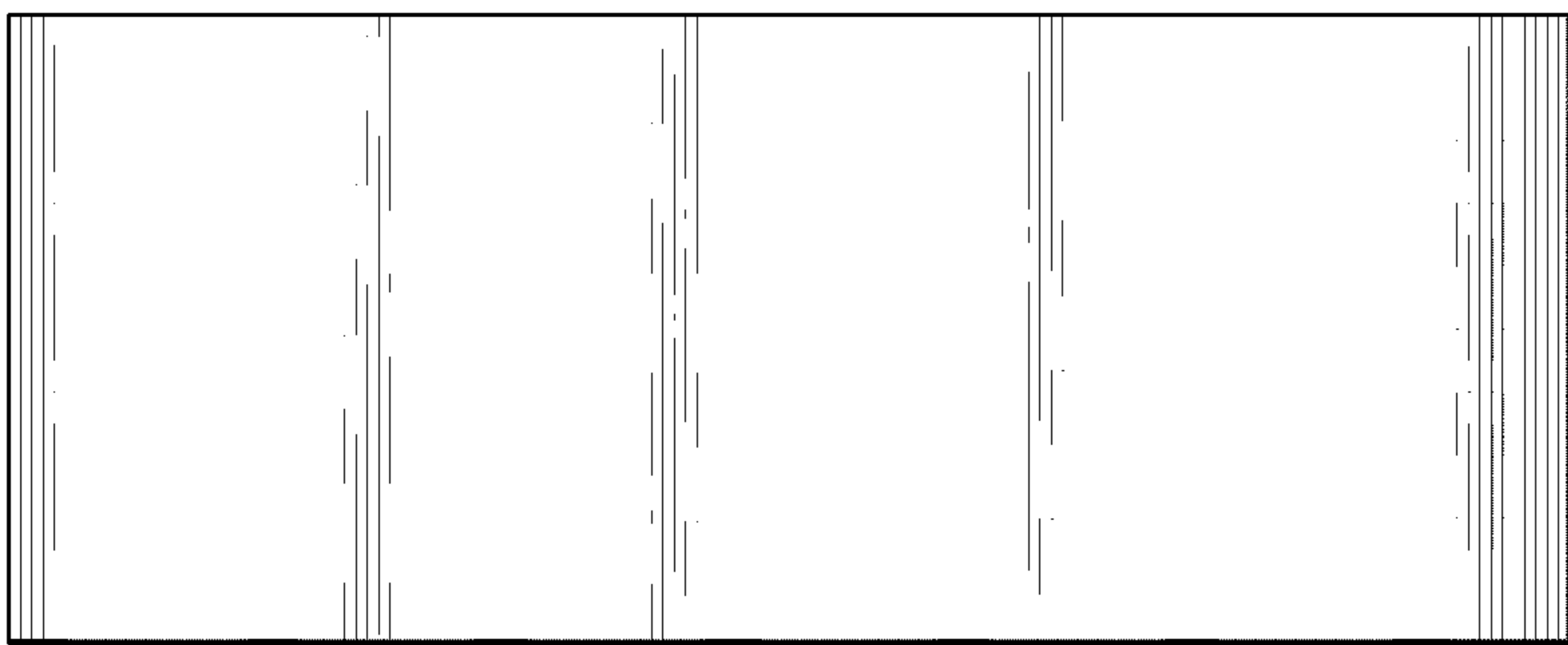

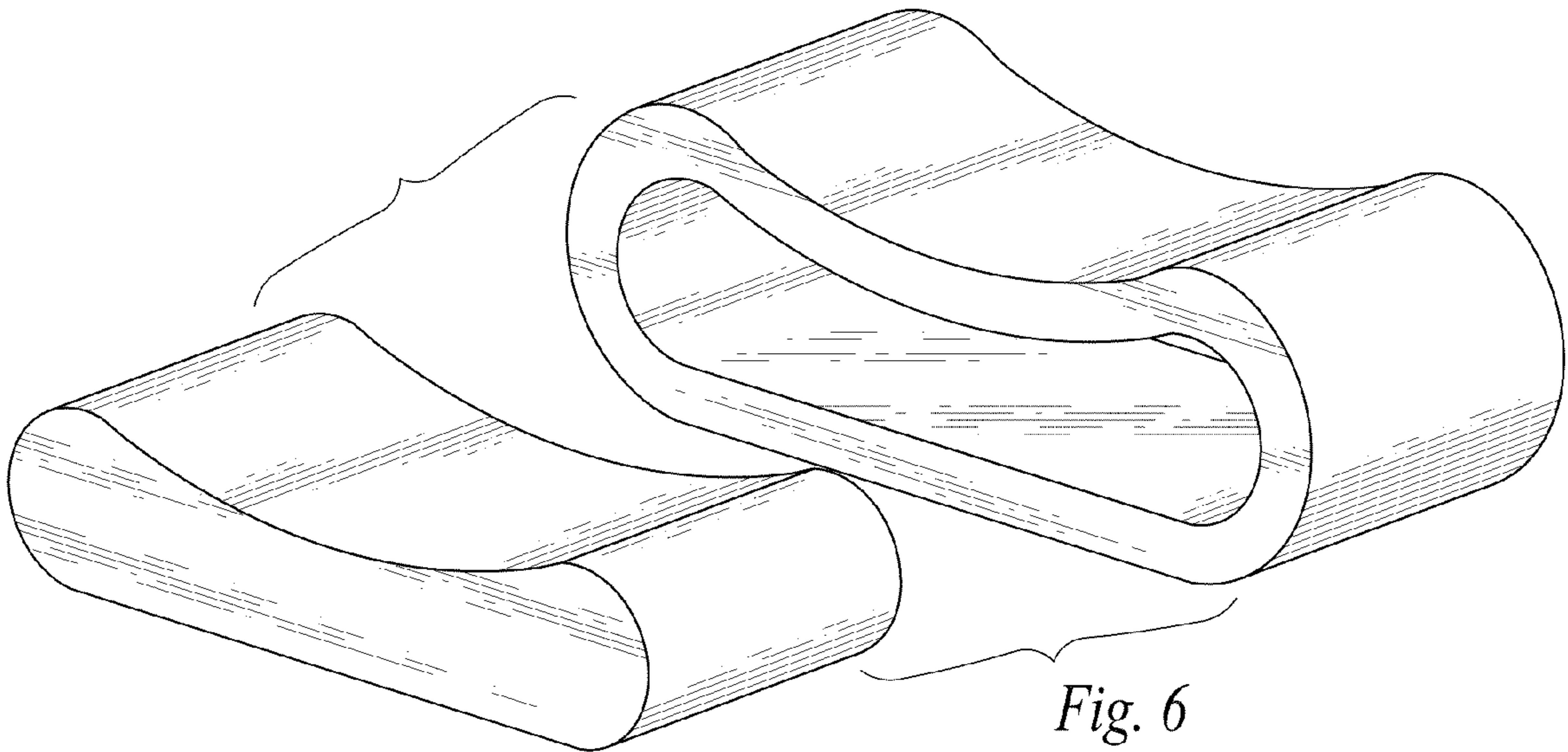

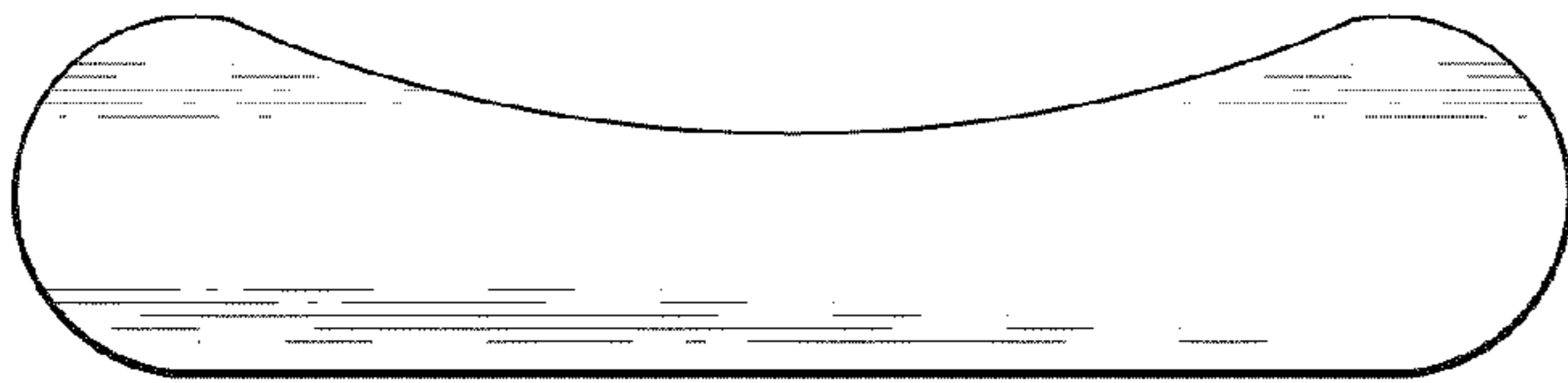

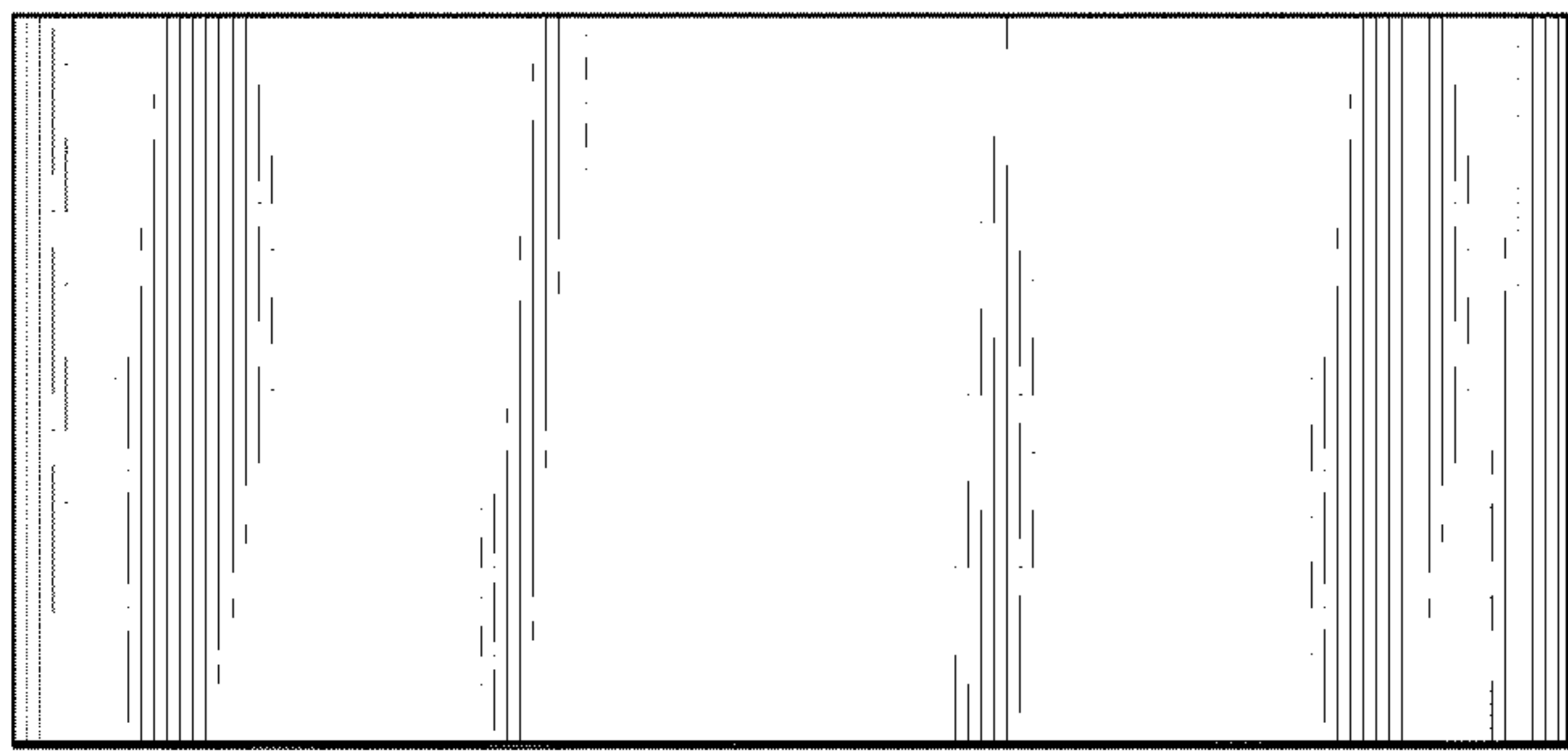

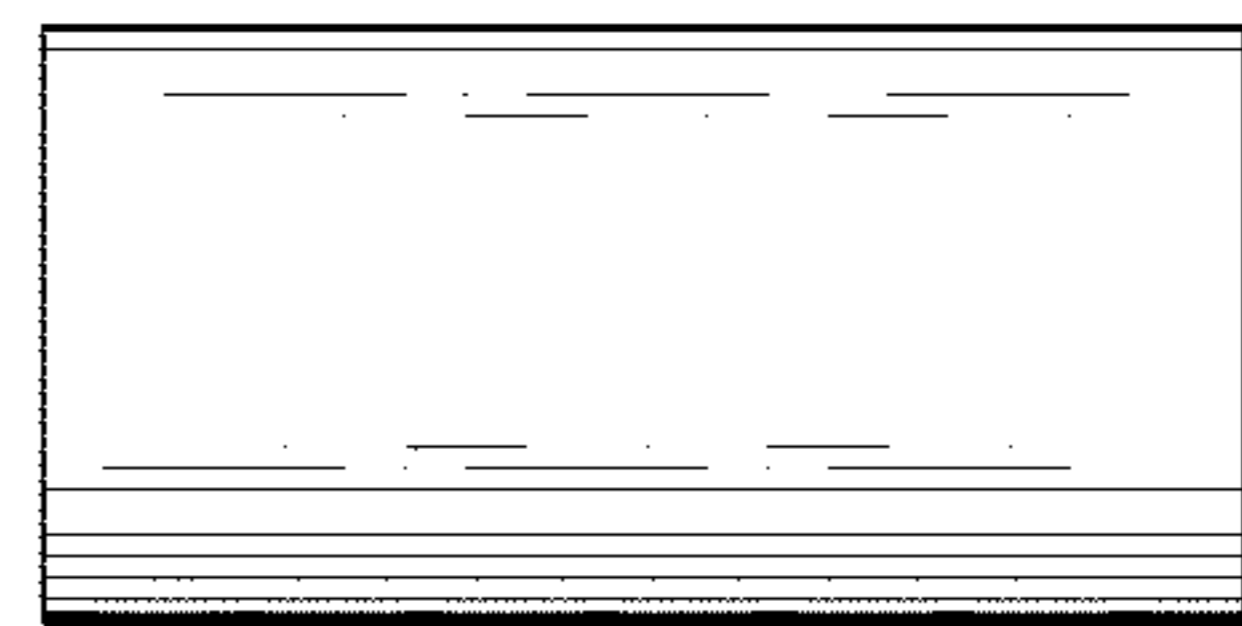

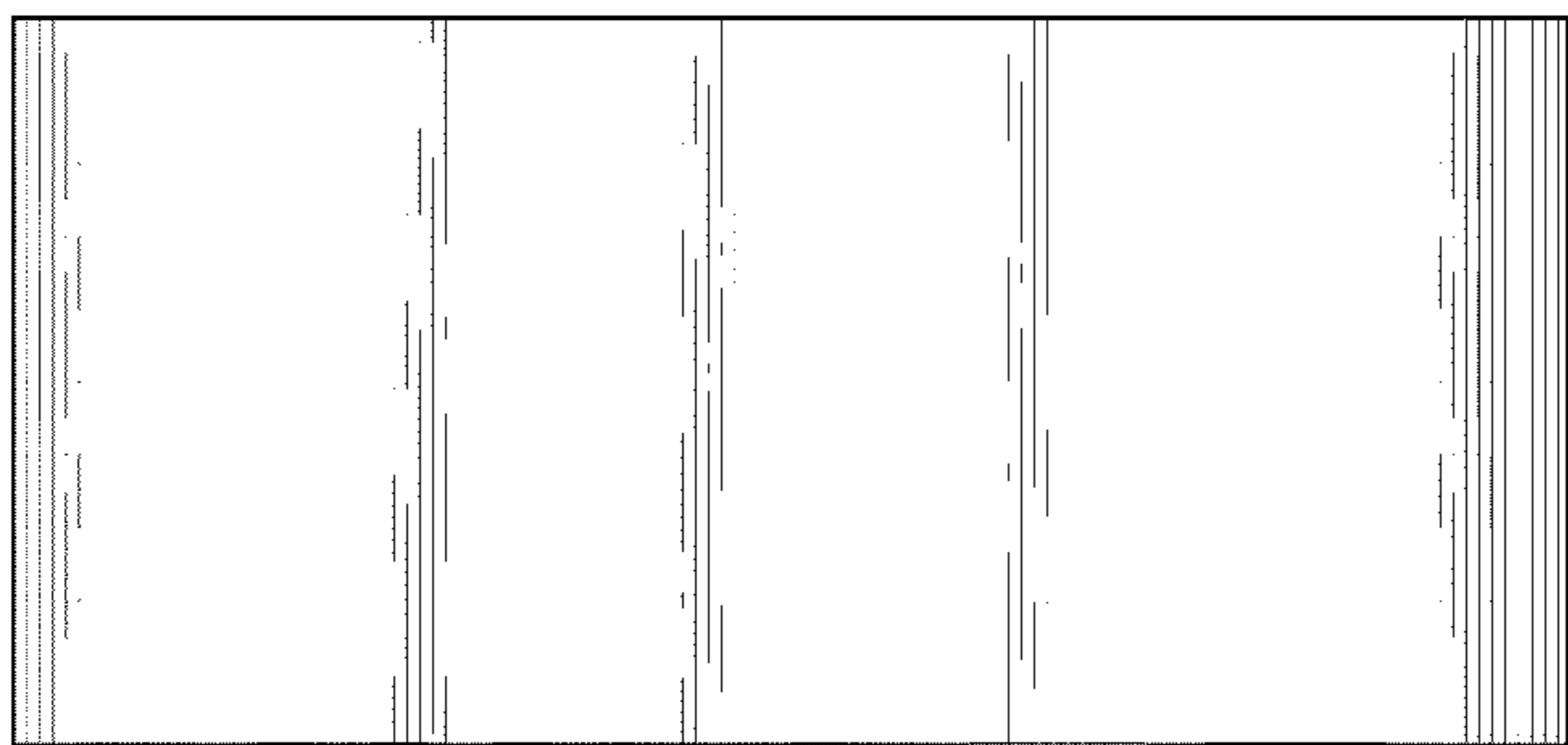
