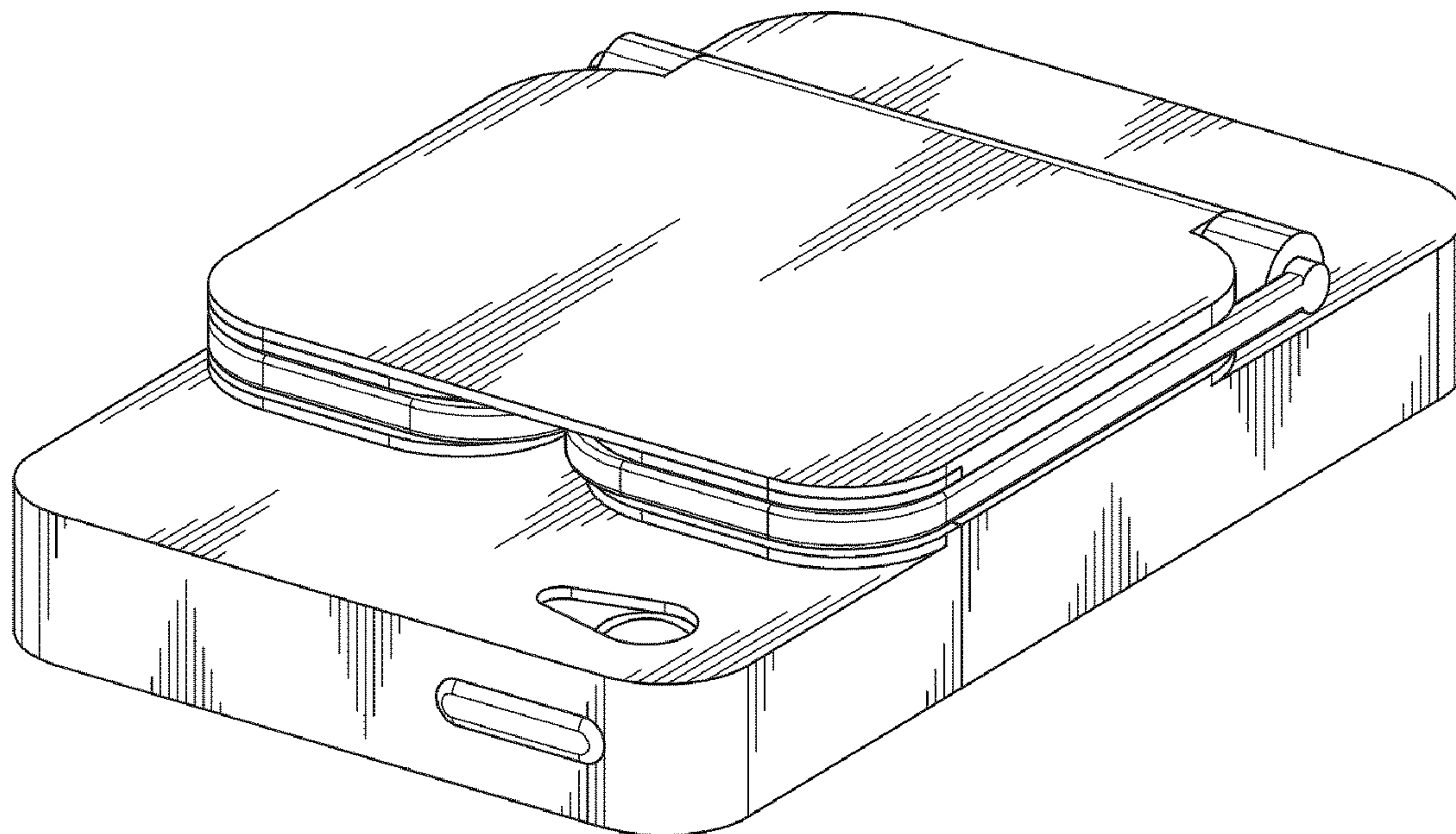

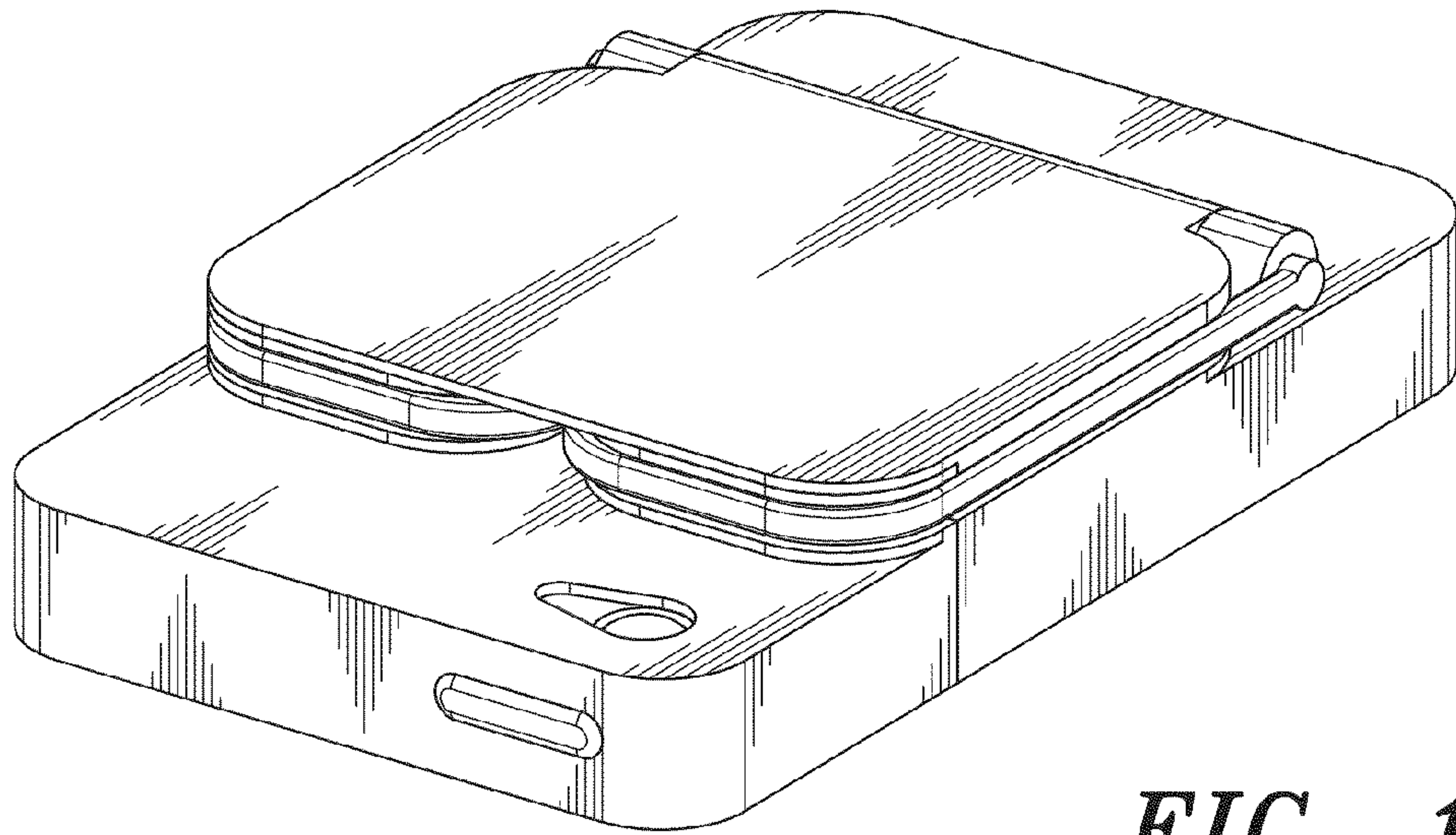
The ornamental design for the case for holding ear buds, as shown and described.

**DESCRIPTION**

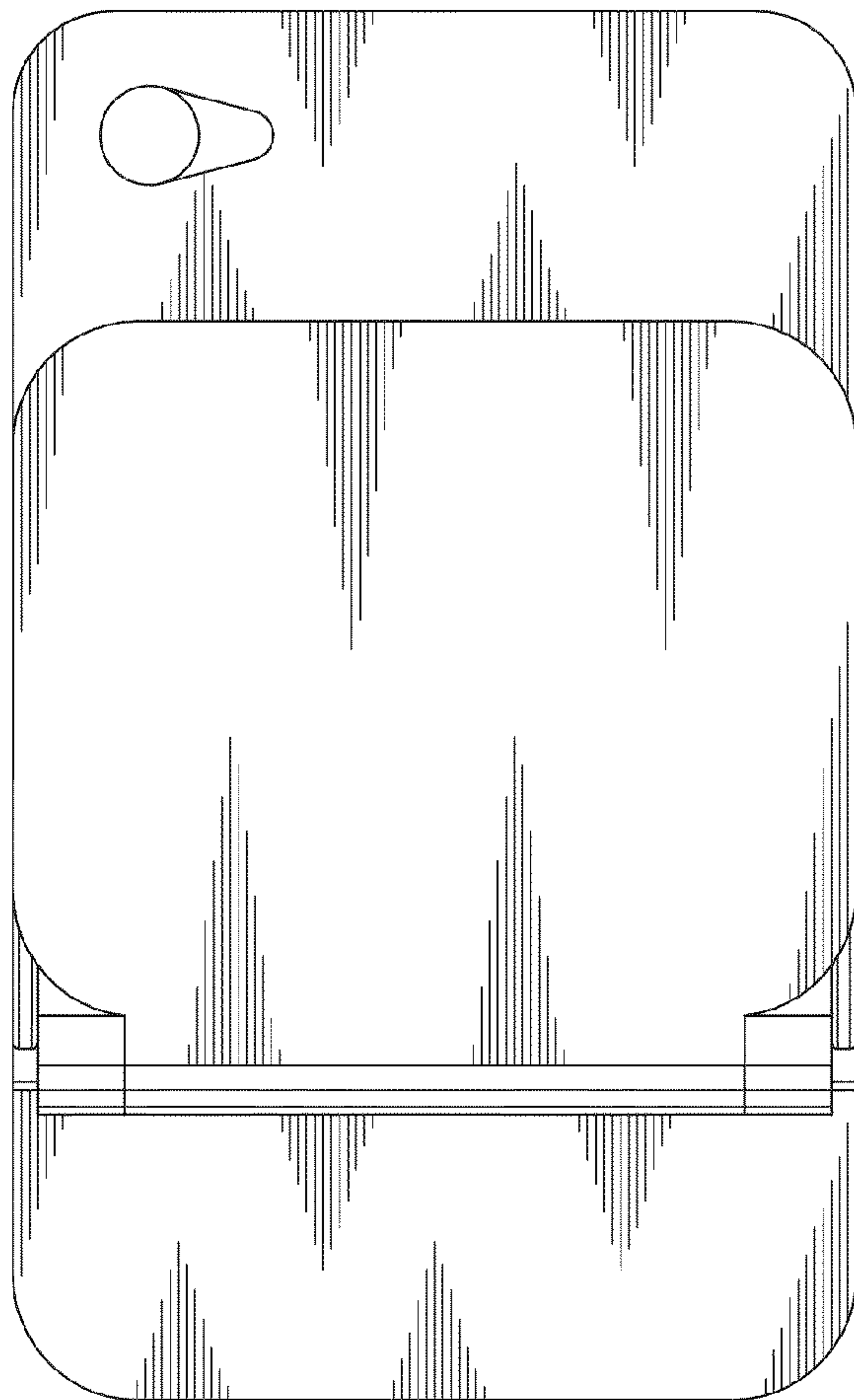

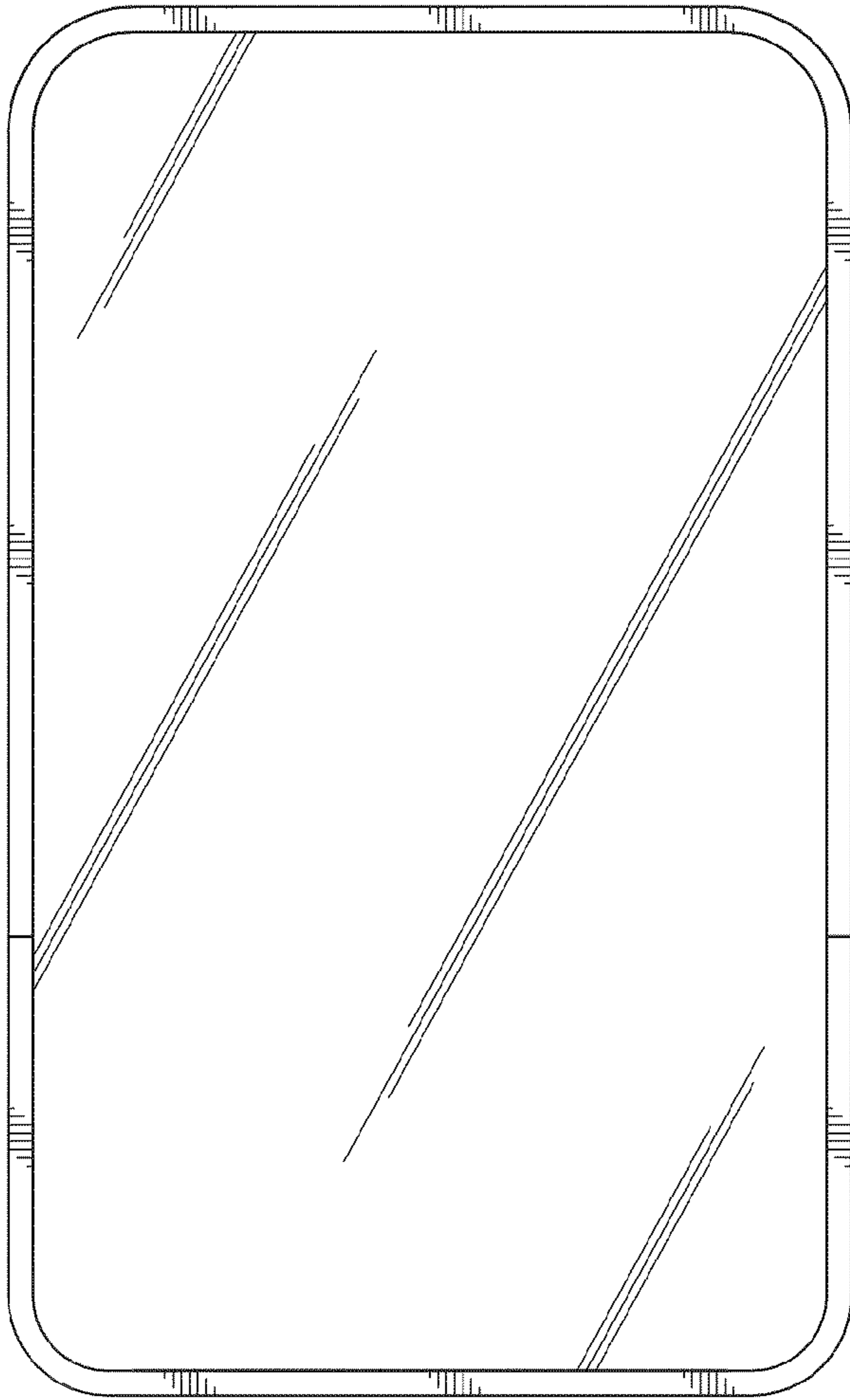




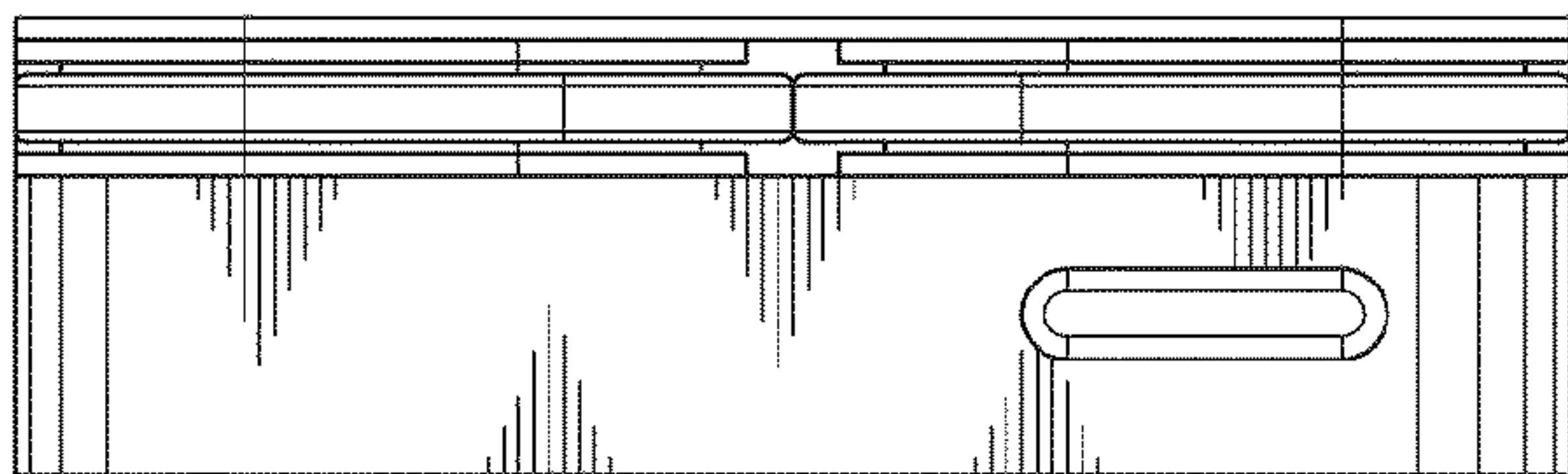

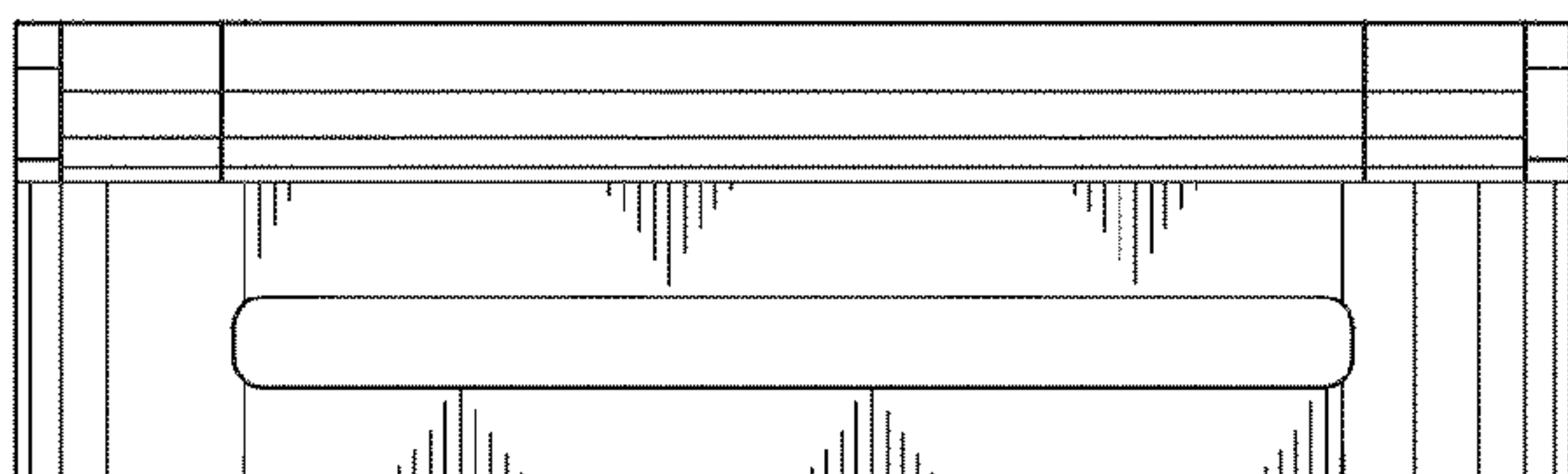

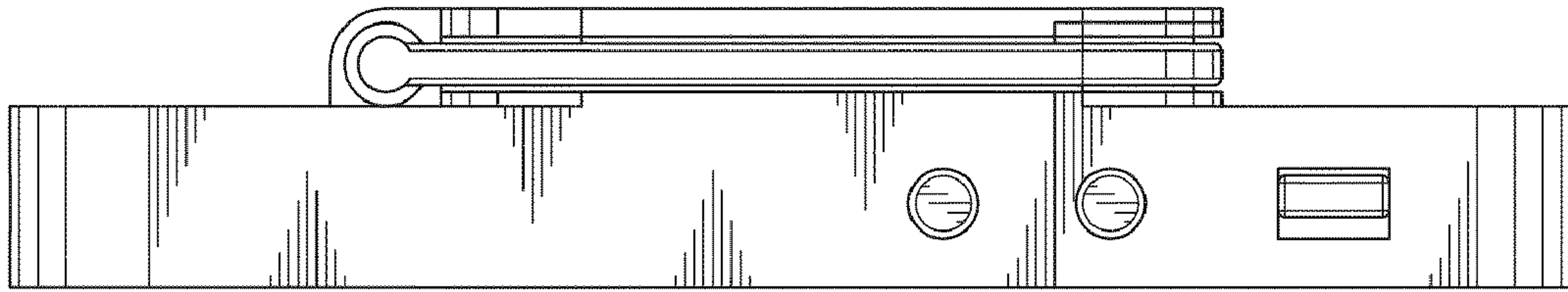

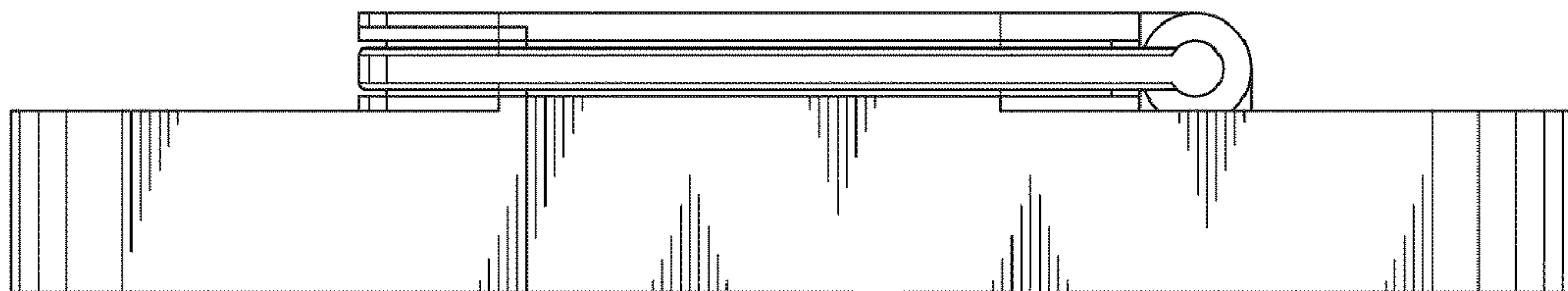
