The ornamental design for a folding chair, as shown and described.

DESCRIPTION

FIG. 1 is an upper front left perspective view of a folding chair showing my new design for a folding chair;

FIG. 4 is a front view thereof;

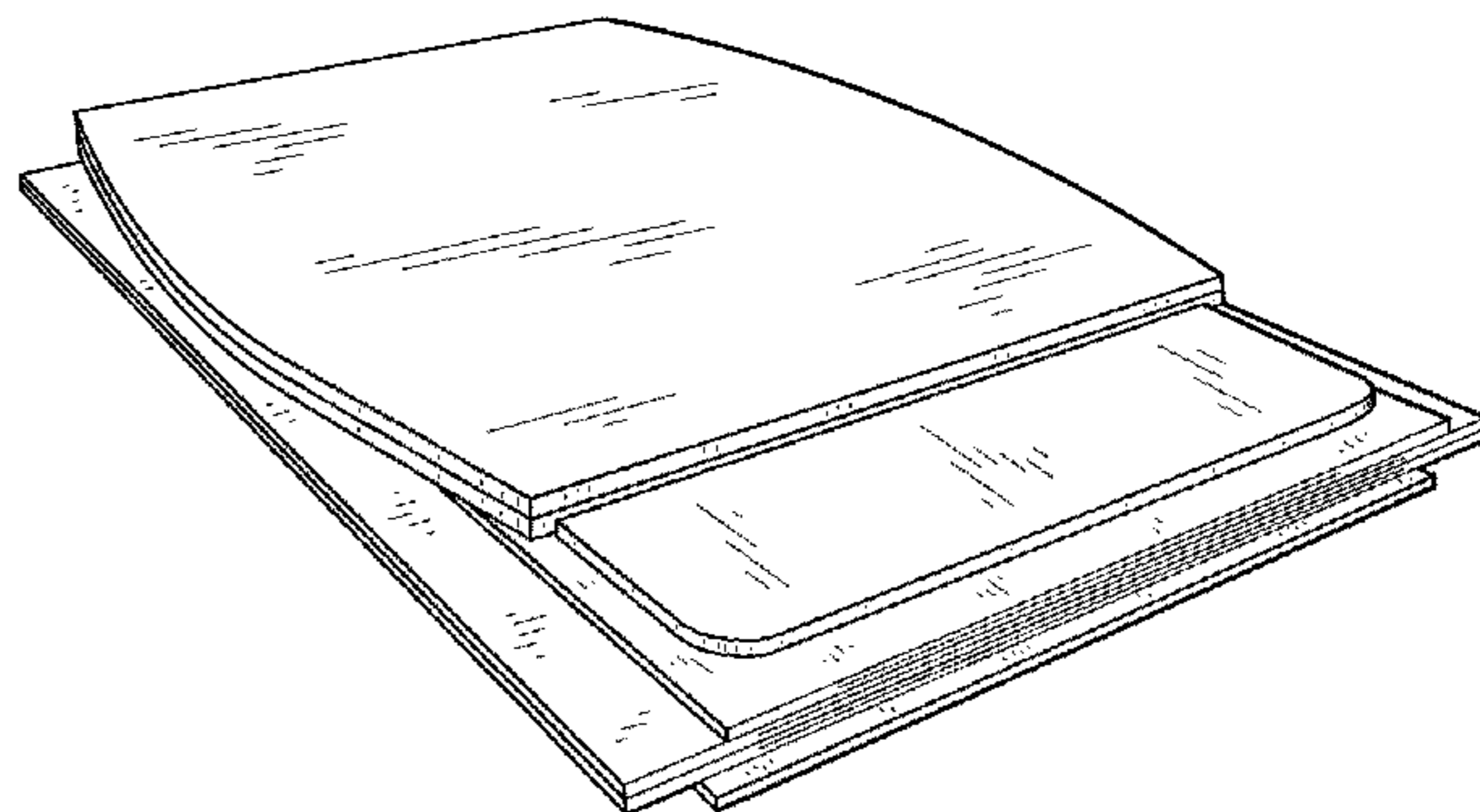
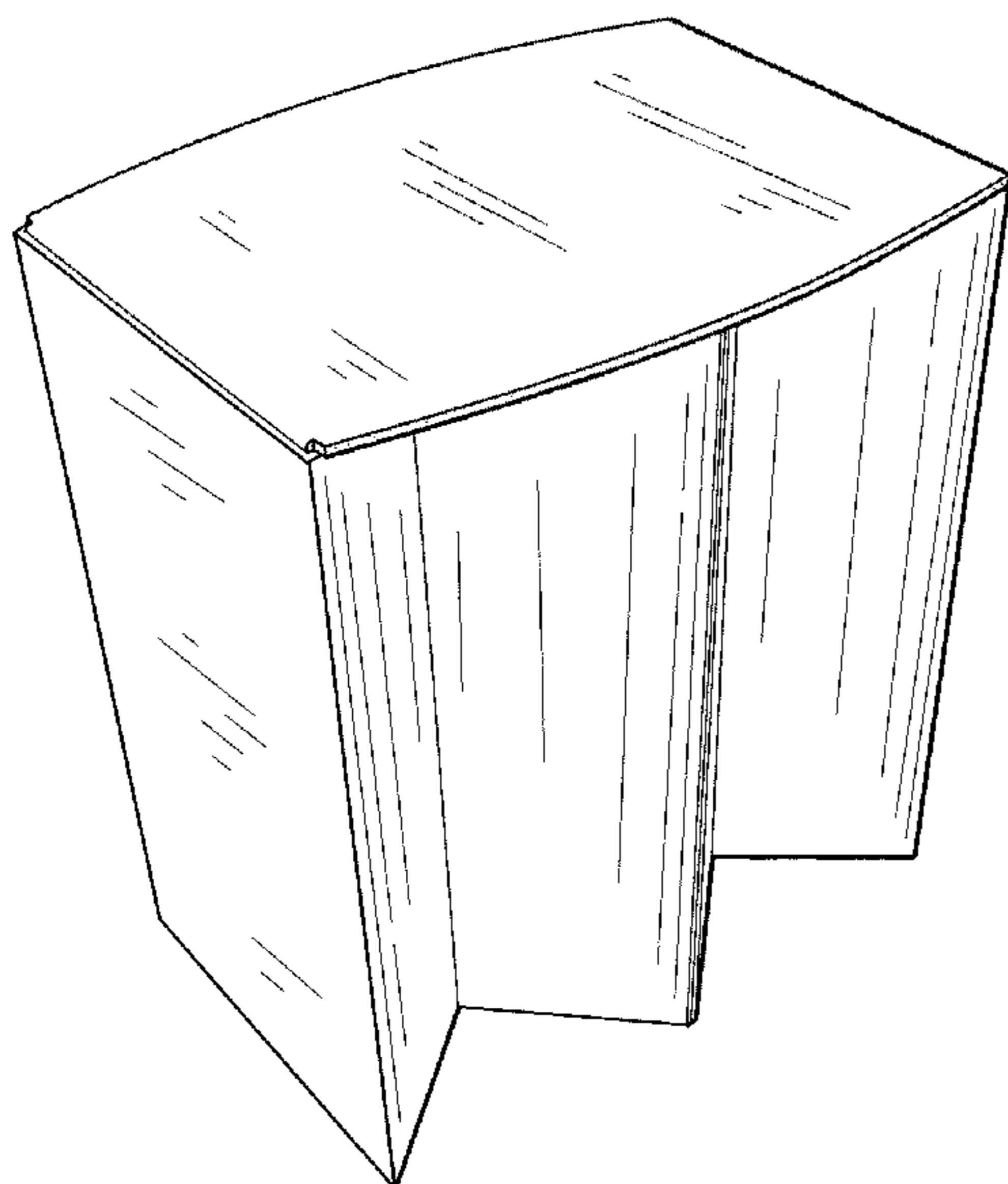

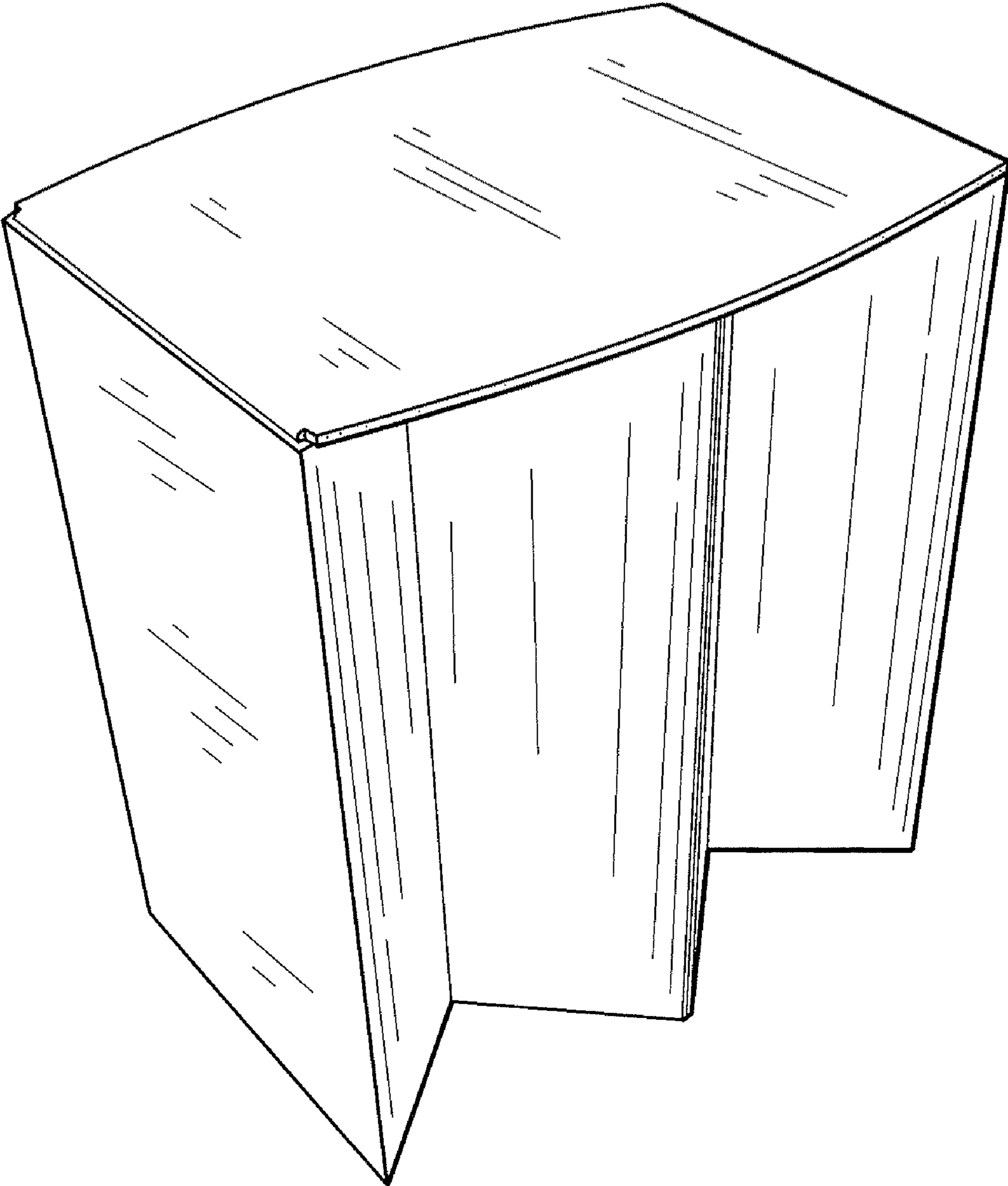

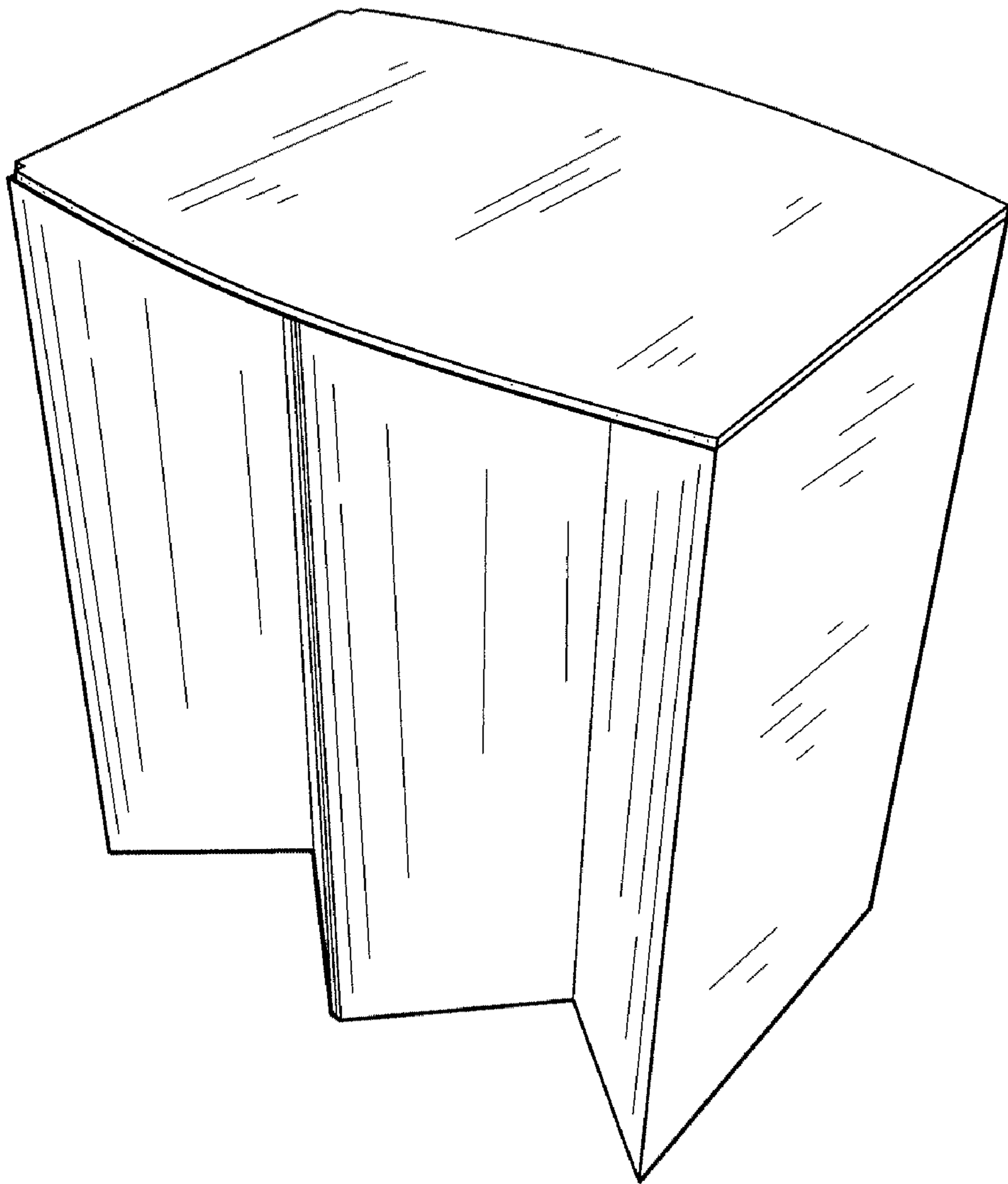

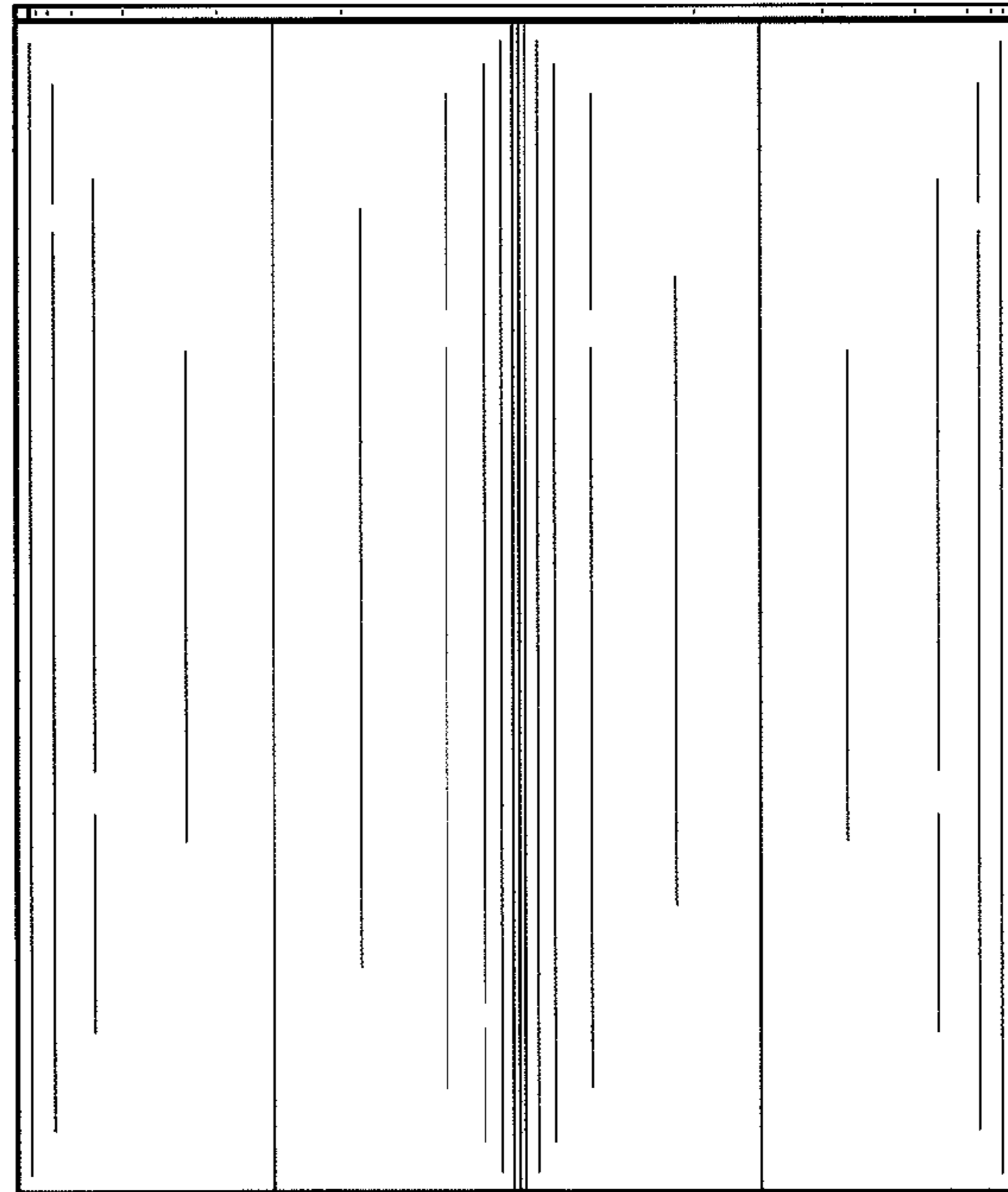

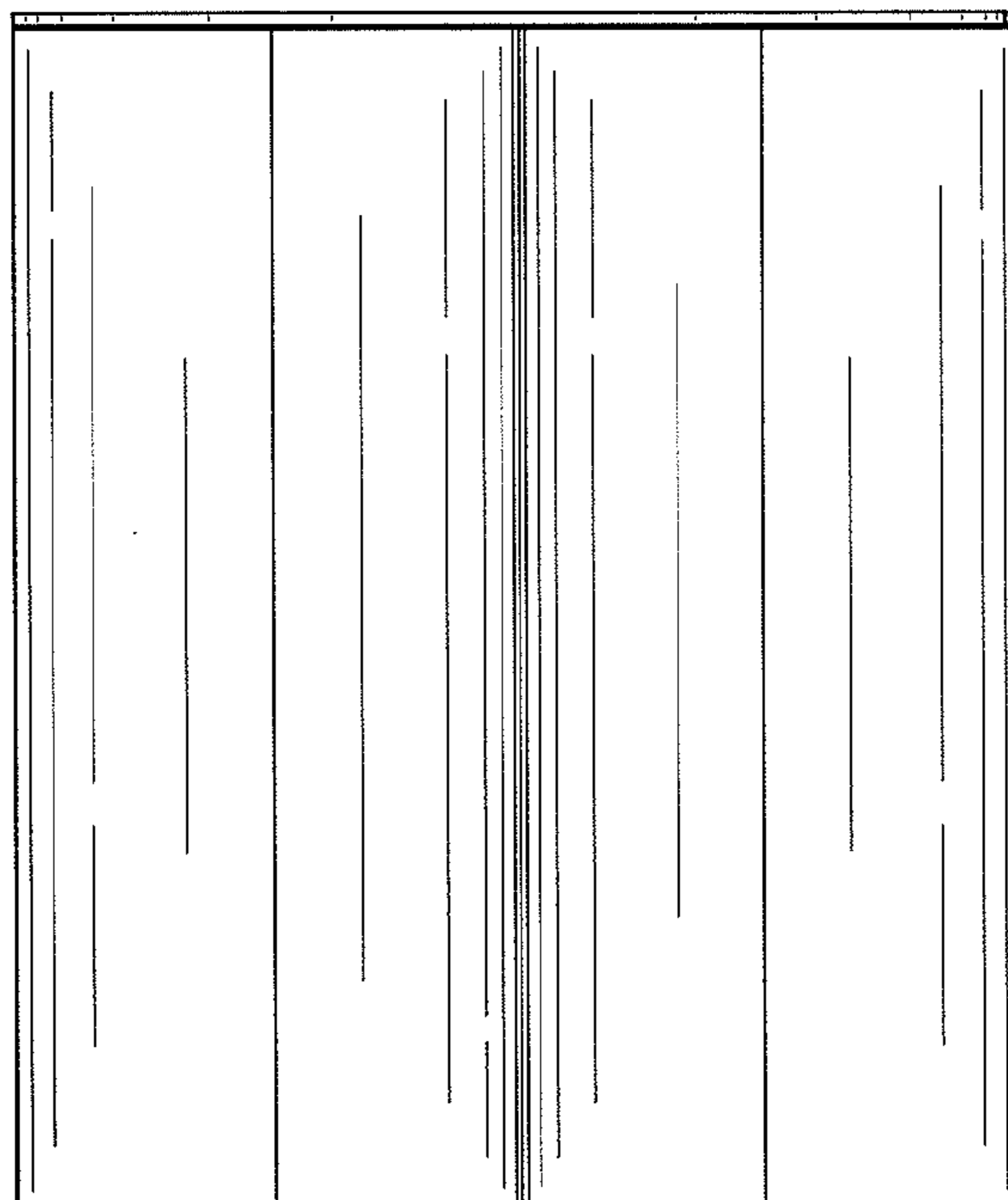

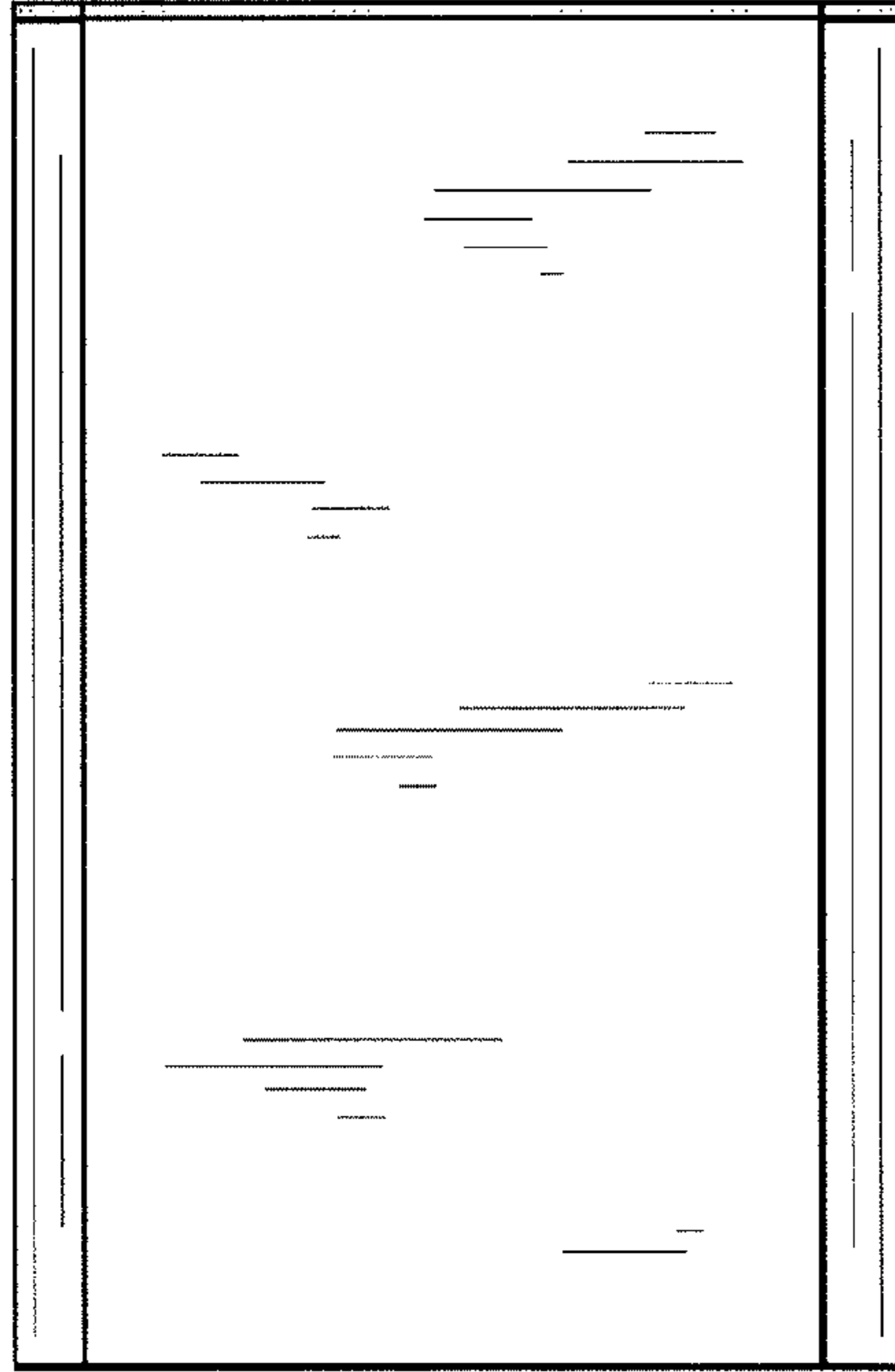

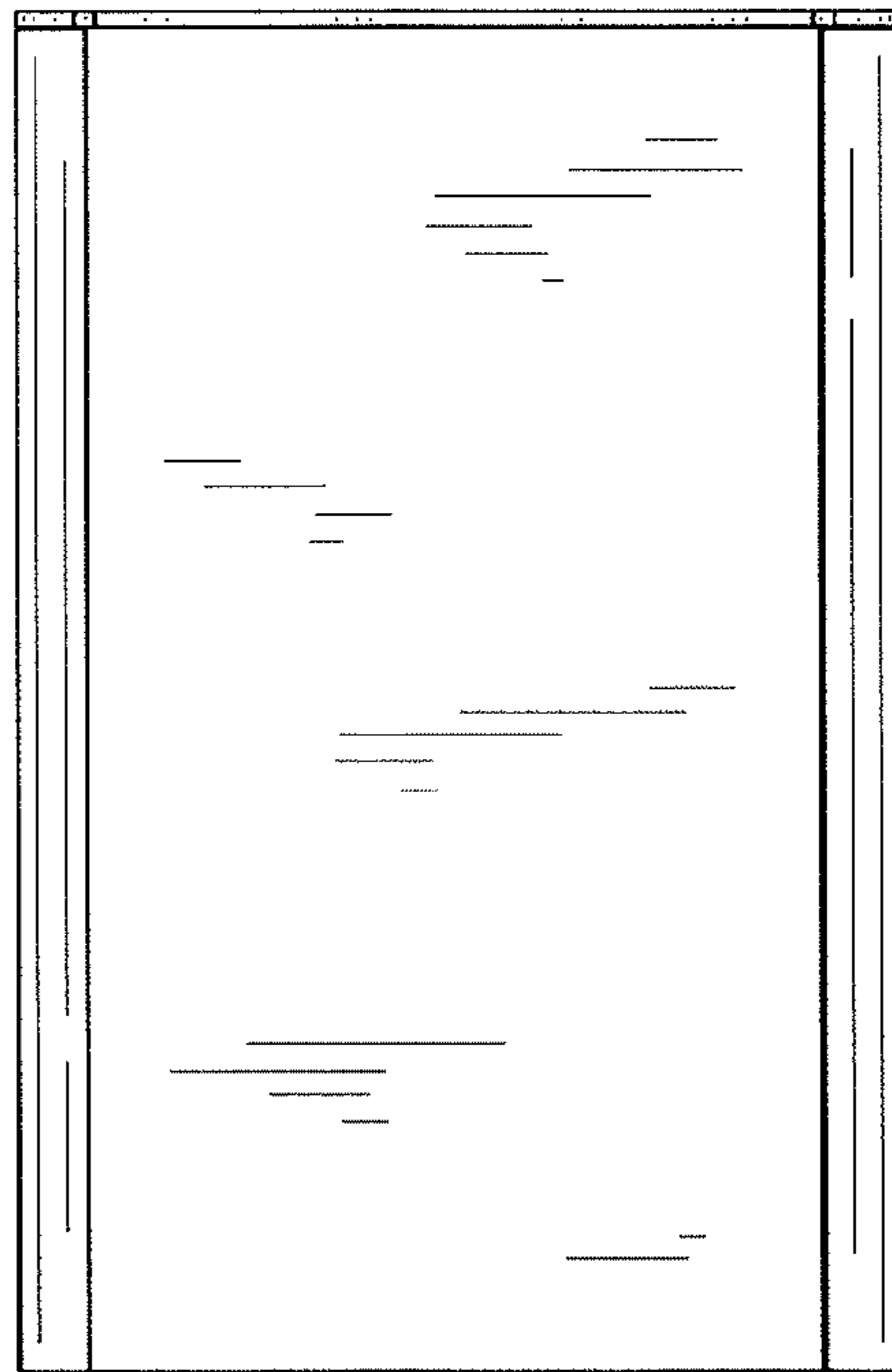

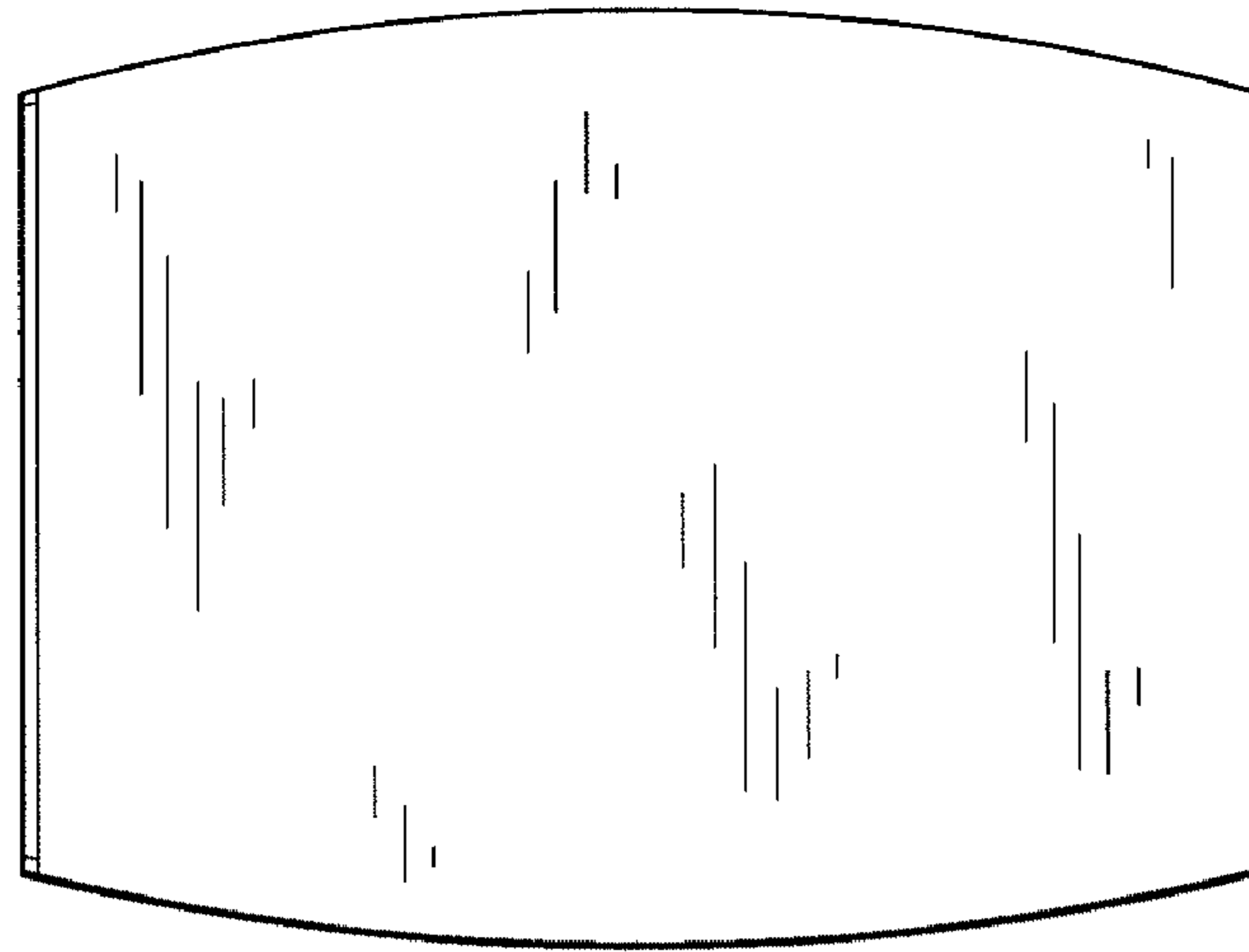

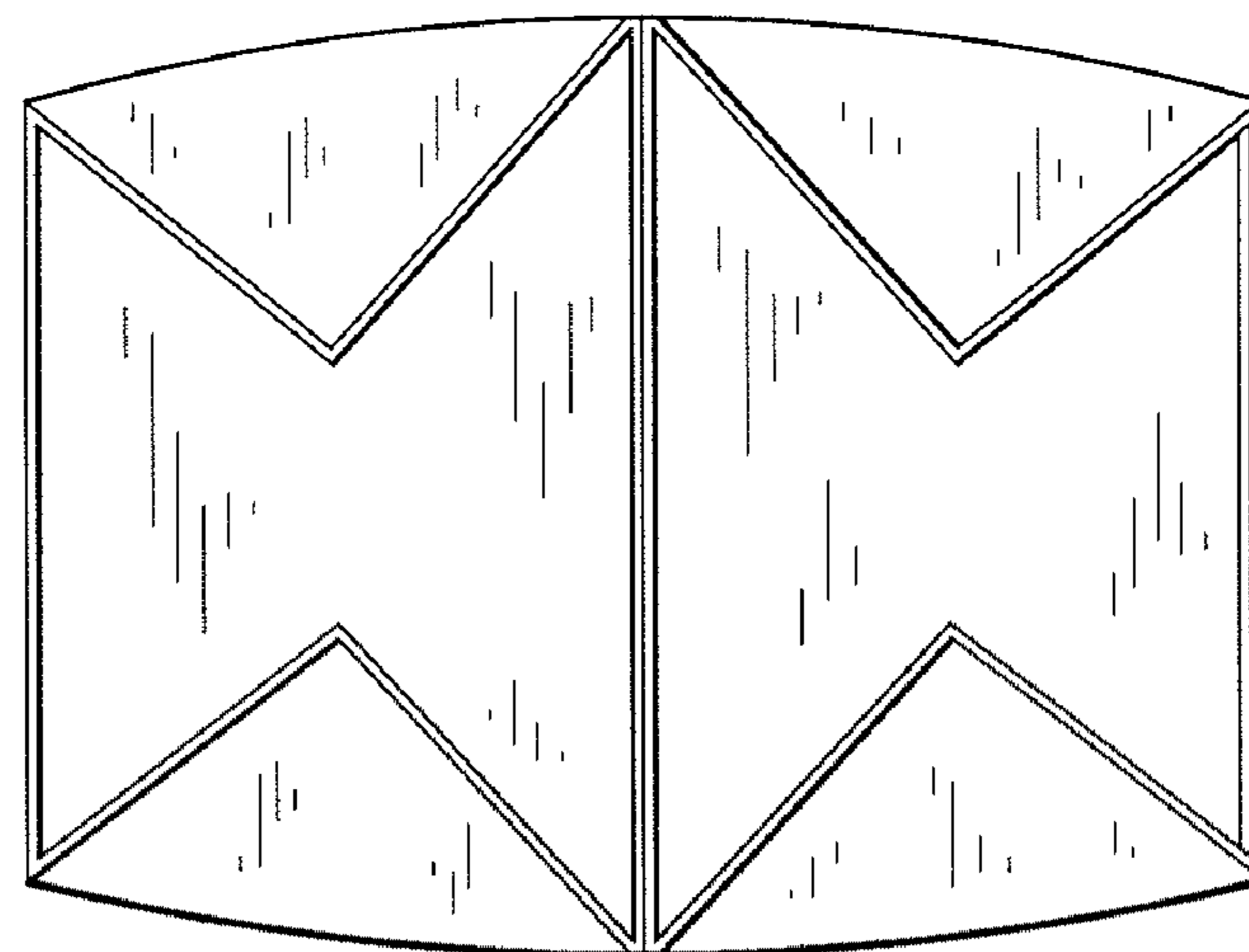

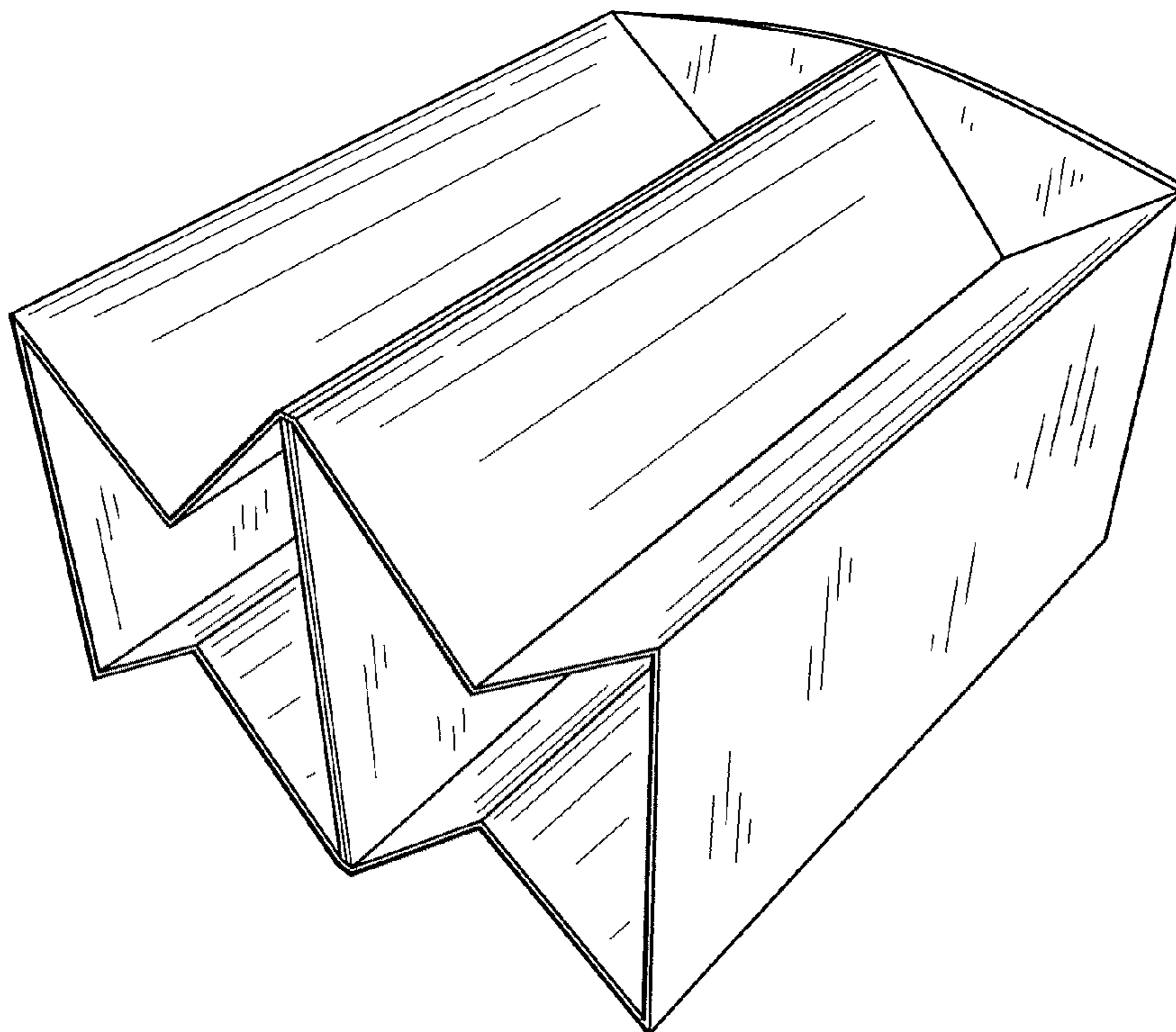

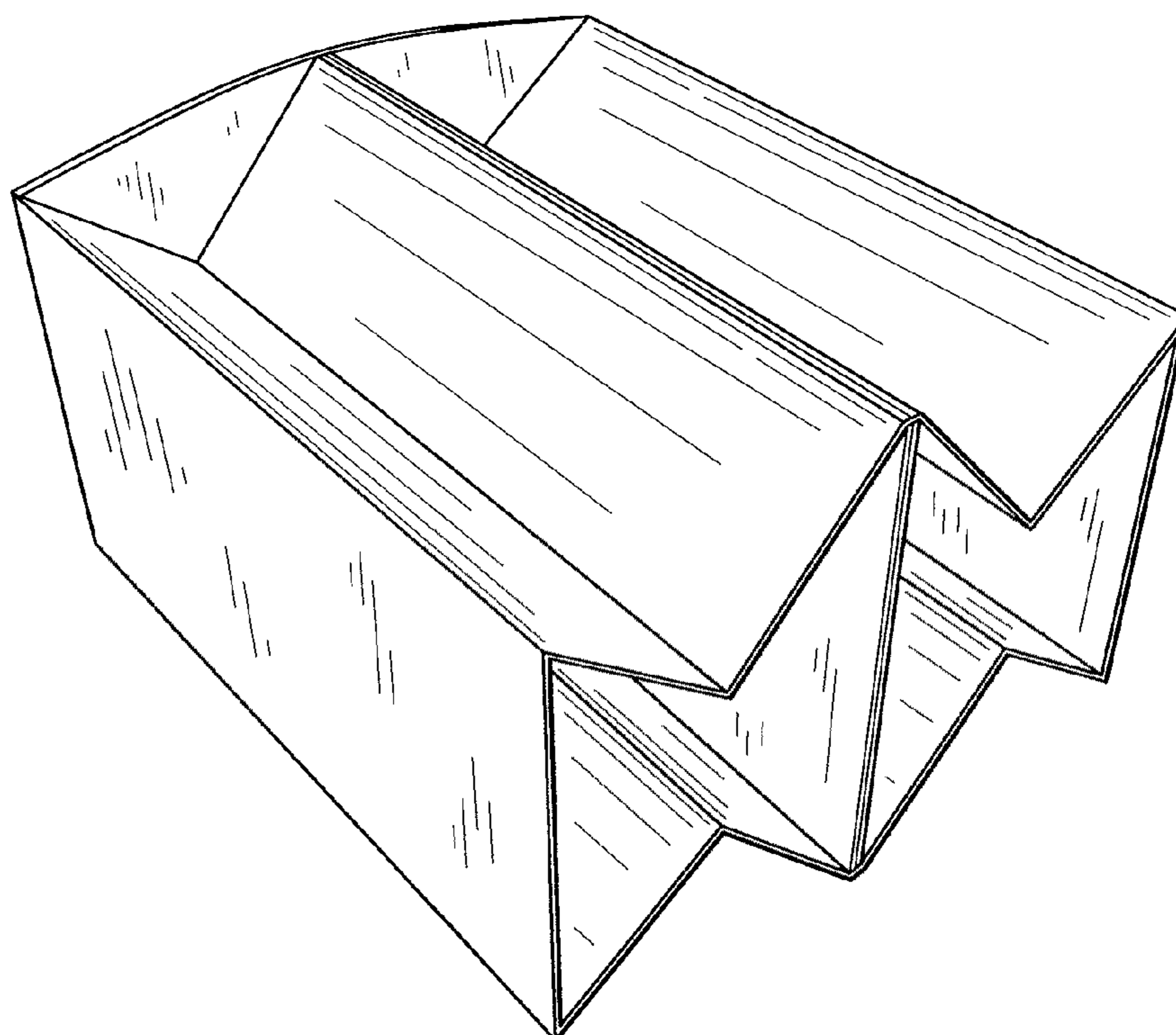

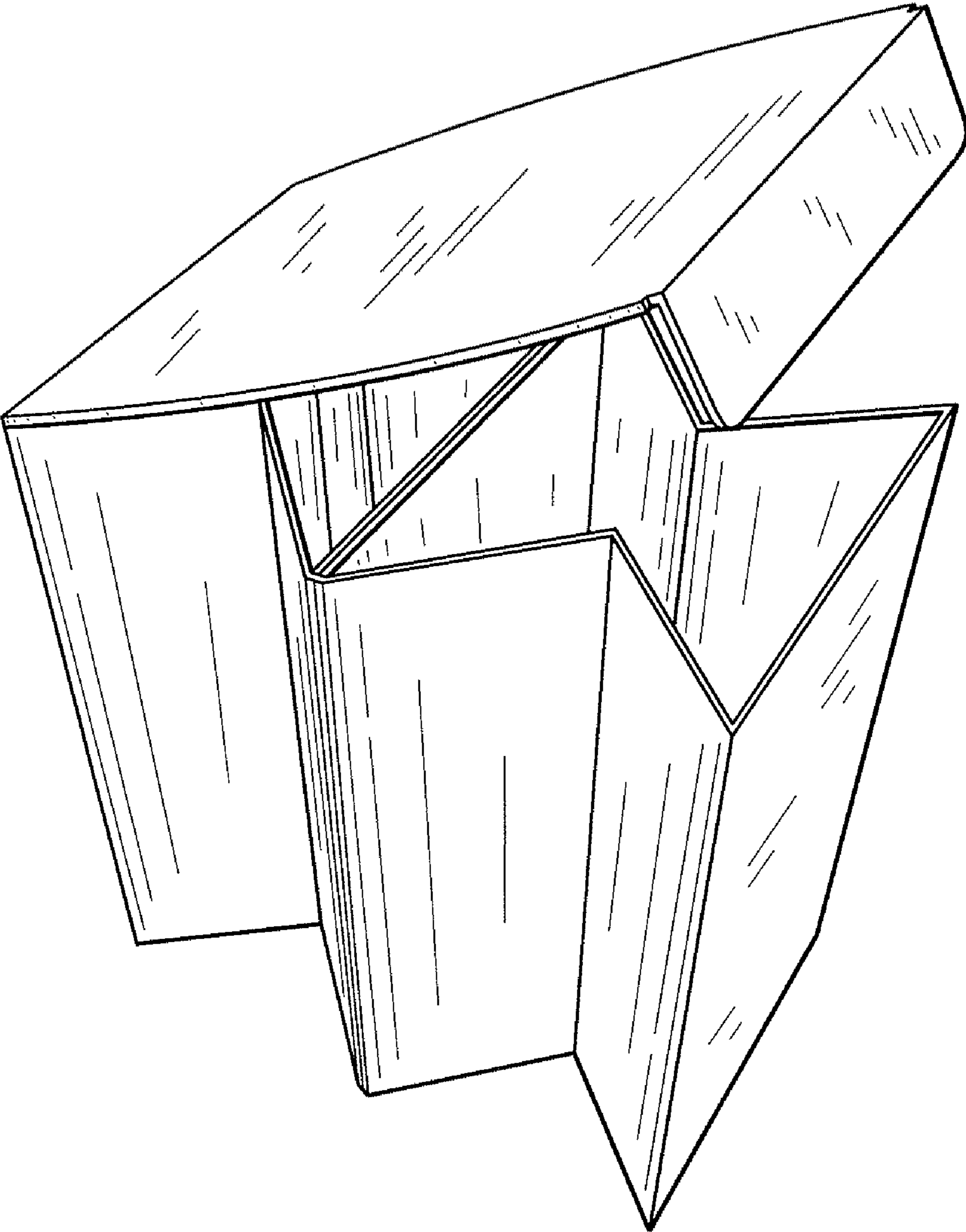

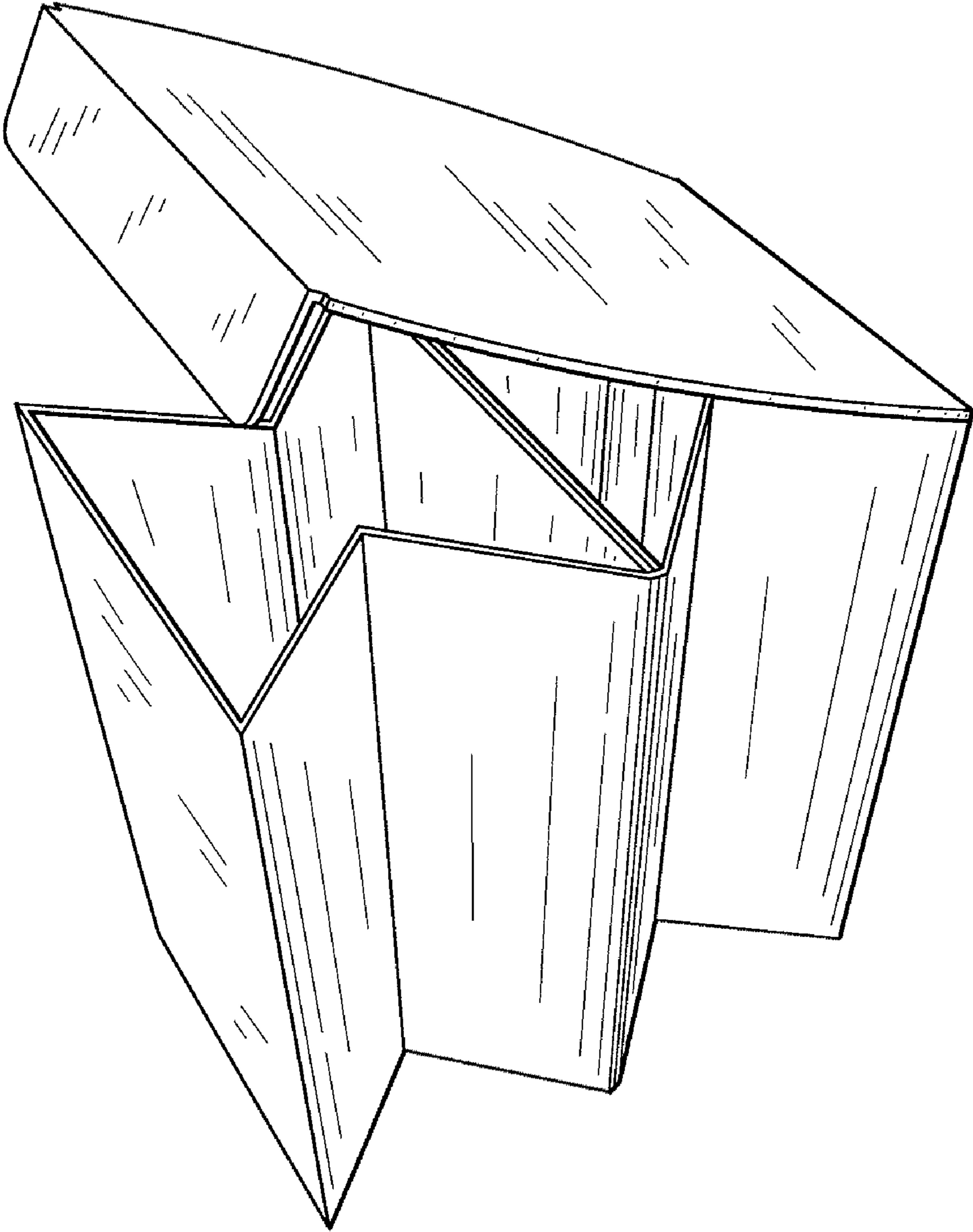

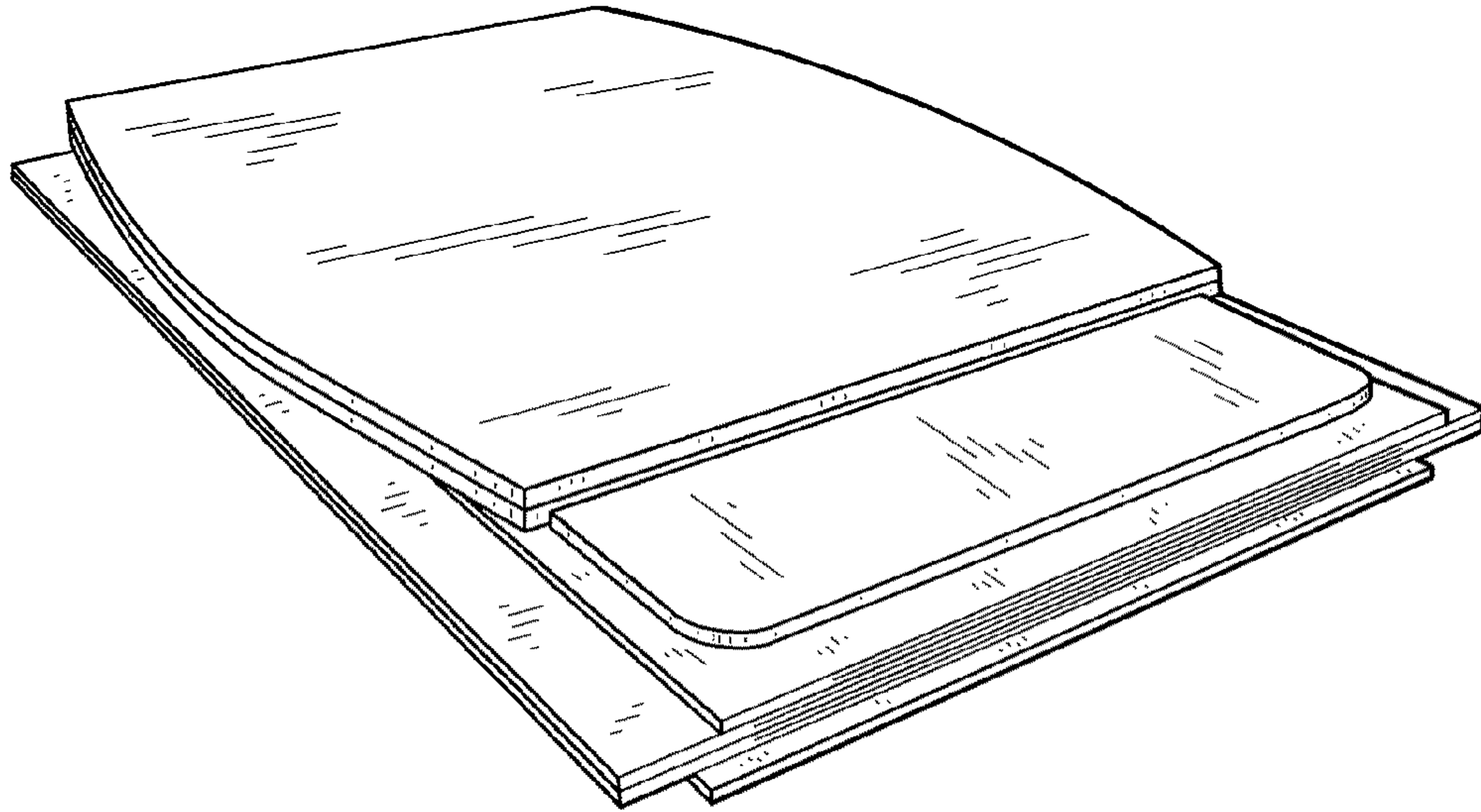

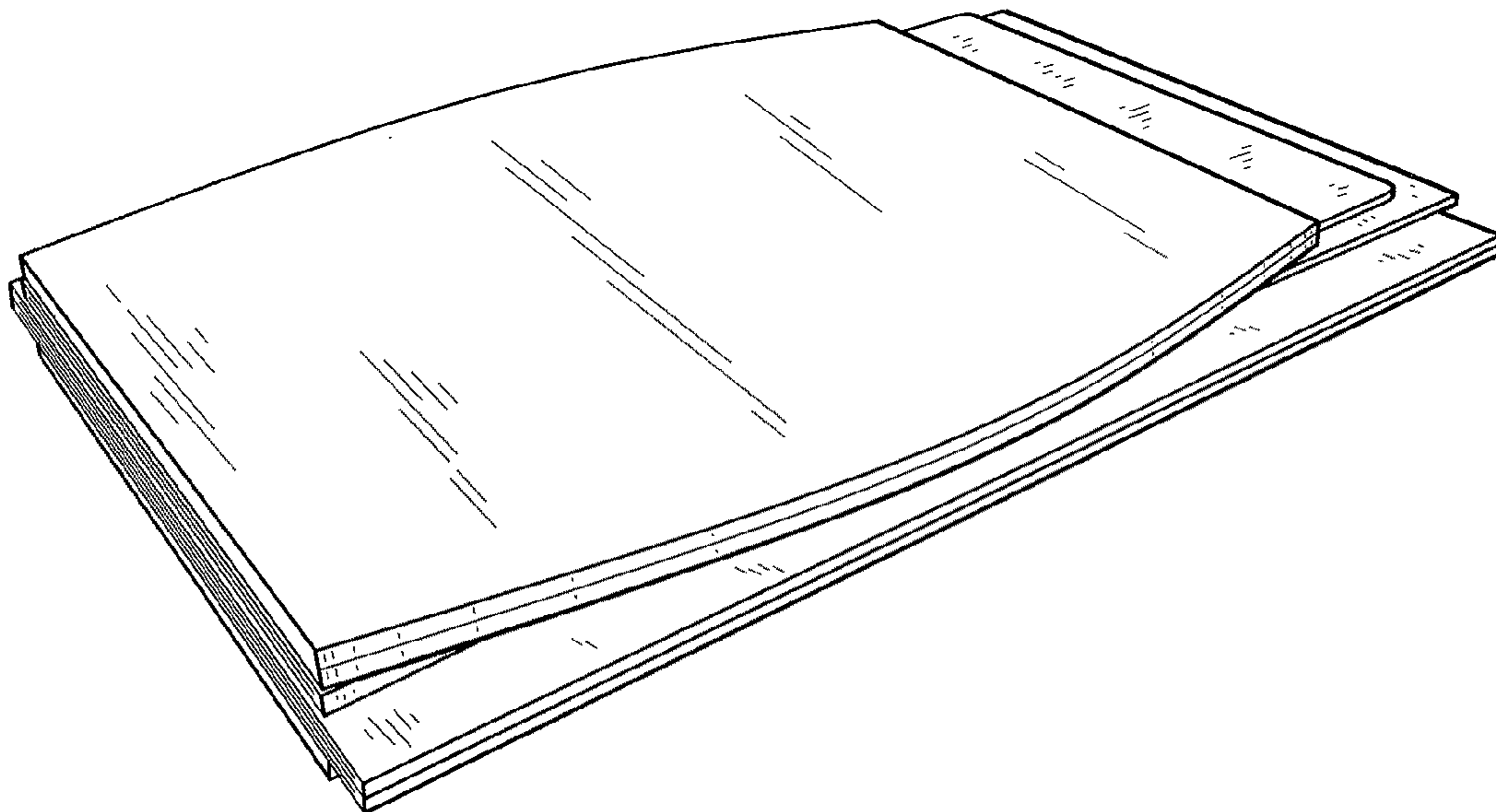

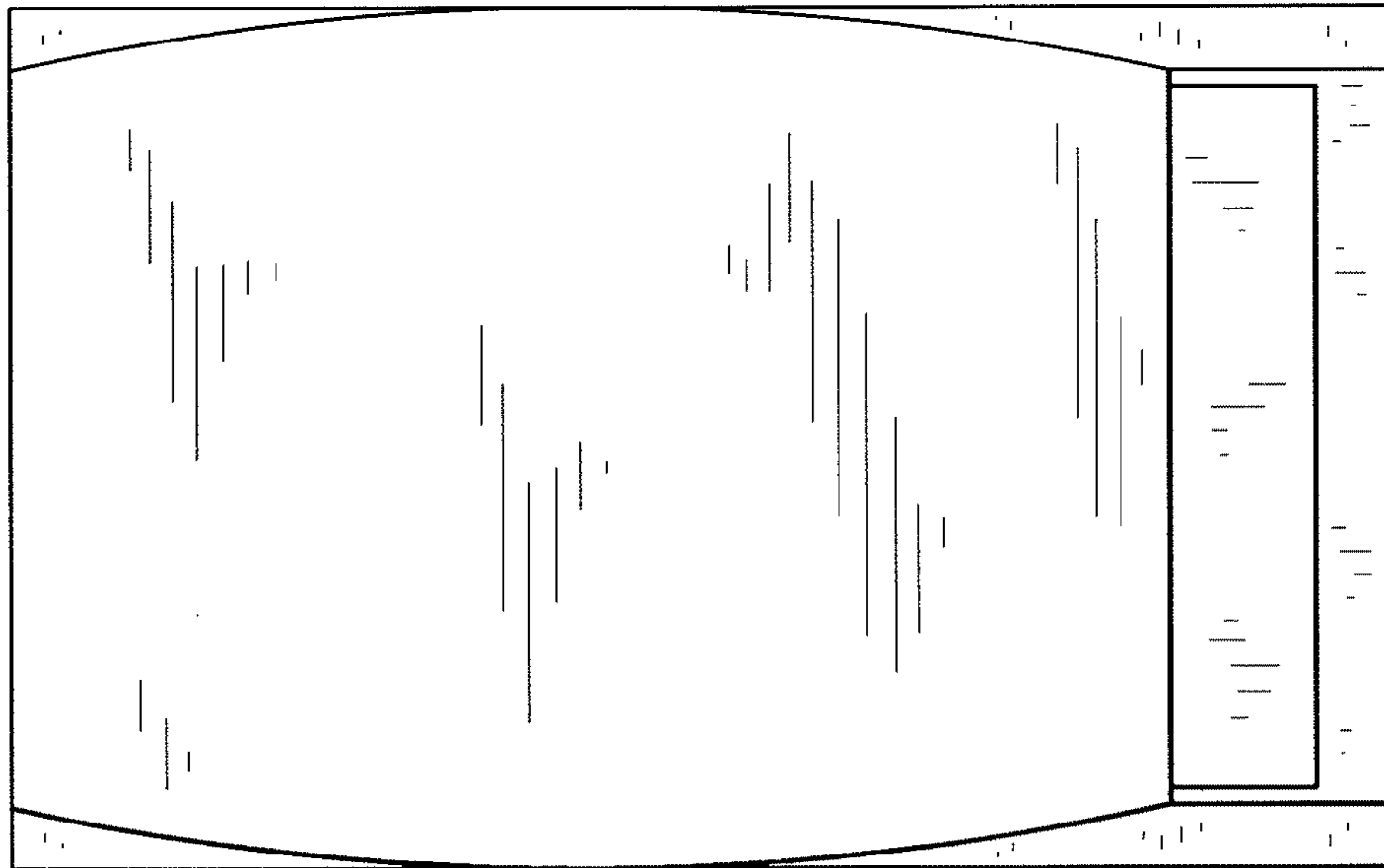
