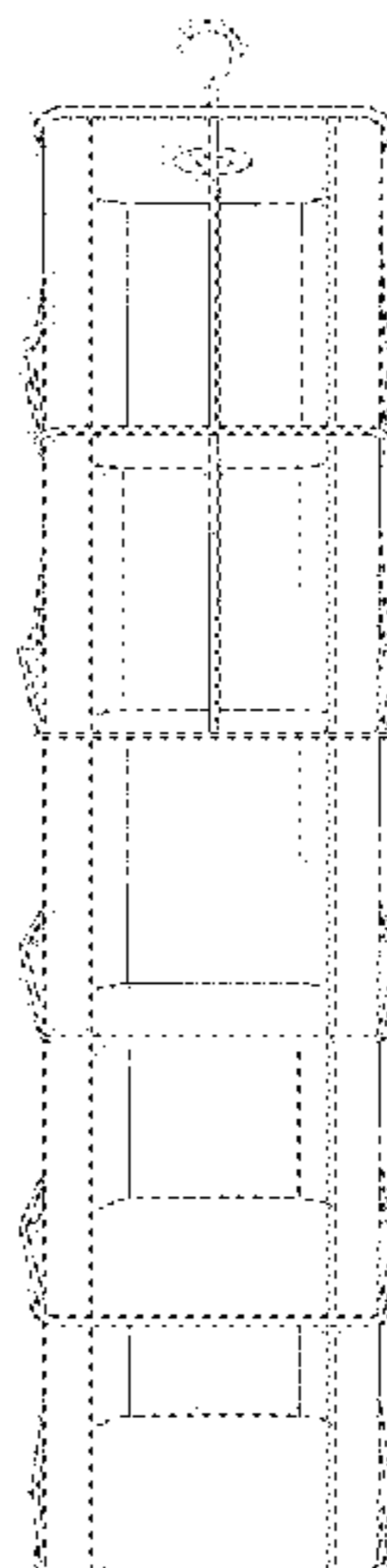
(57) **CLAIM**

The ornamental design for a square carousel organizer with strapped shelves, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the carousel organizer of this invention with hinged shelves in a closed configuration; FIG. 2 is a left side perspective of the carousel organizer of FIG. 1; FIG. 3 is a back perspective of the carousel organizer of FIG. 1; FIG. 4 is a right perspective of the carousel organizer of FIG. 1; FIG. 5 is a top plan view of the carousel organizer of FIG. 1; FIG. 6 is bottom plan view of the carousel organizer of FIG. 1; FIG. 7 is a front perspective view of a second embodiment of the carousel organizer of FIG. 1; FIG. 8 is a left side perspective of the carousel organizer of FIG. 7; FIG. 9 is a back perspective of the carousel organizer of FIG. 7; FIG. 10 is a right perspective of the carousel organizer of FIG. 7; FIG. 11 is a top plan view of the carousel organizer of FIG. 7; and, FIG. 12 is bottom plan view of the carousel organizer of FIG. 7. The hook shown in broken lines is not part of the claimed design.

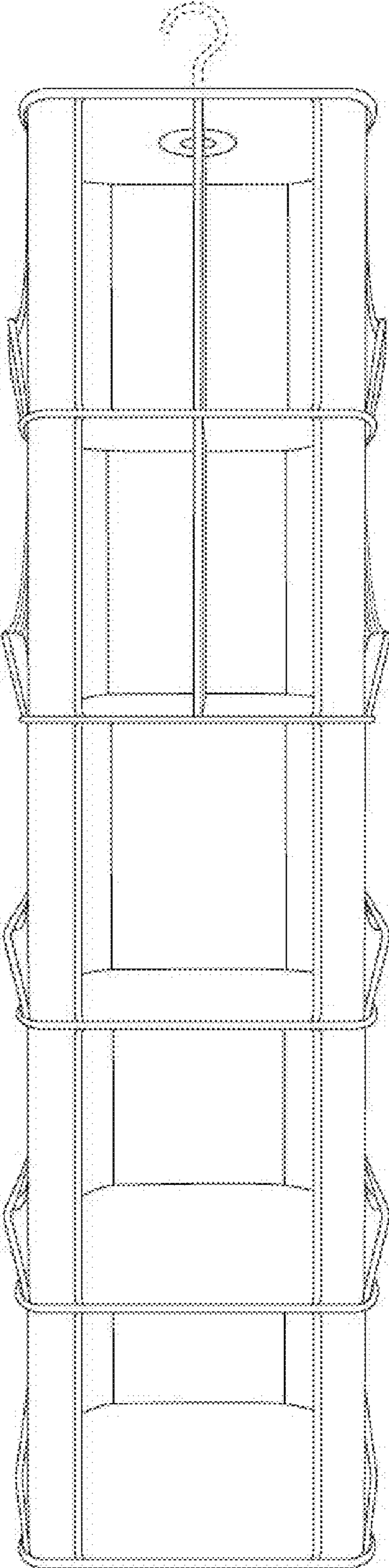

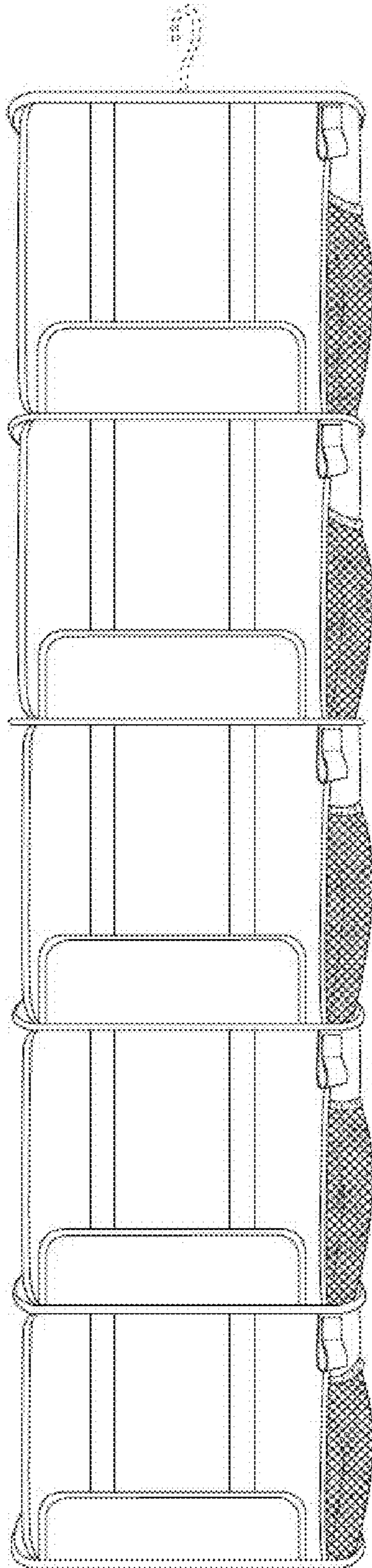

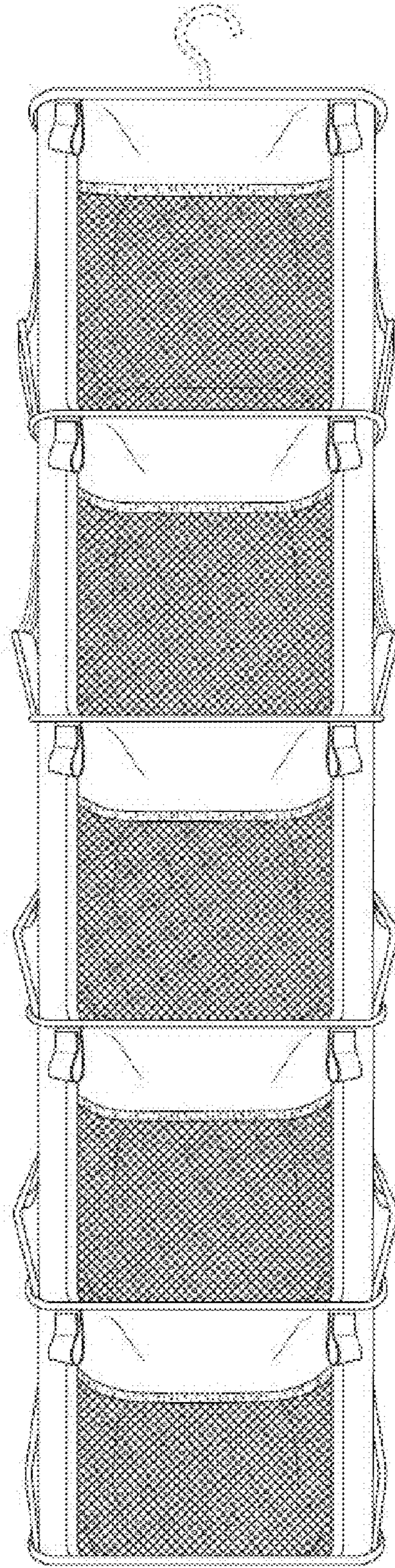

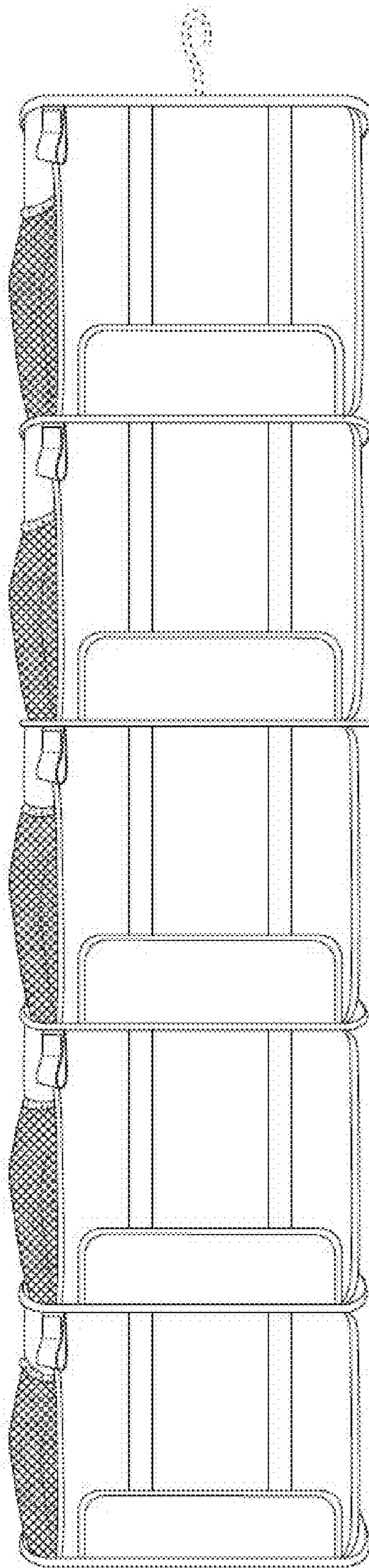

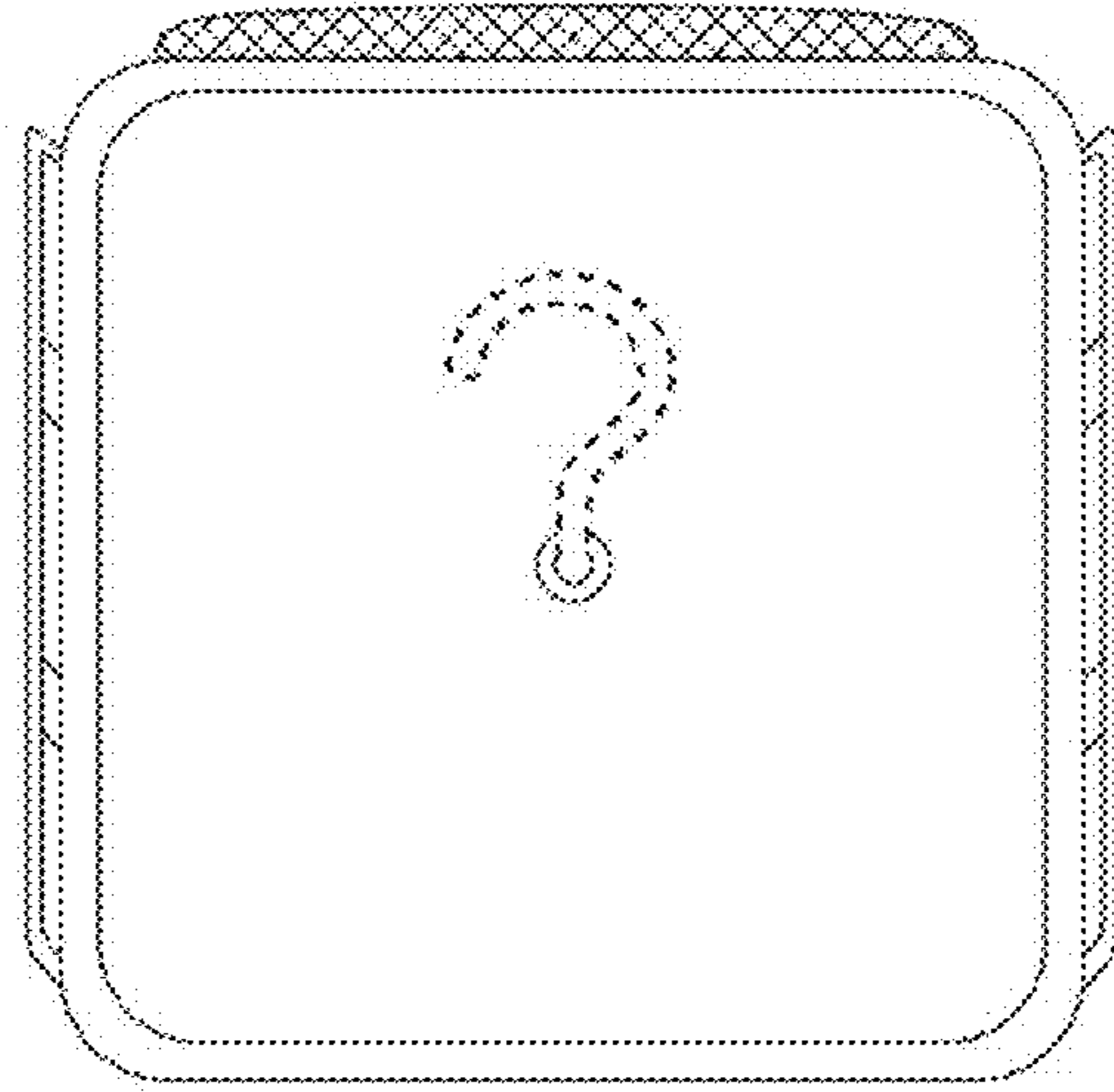

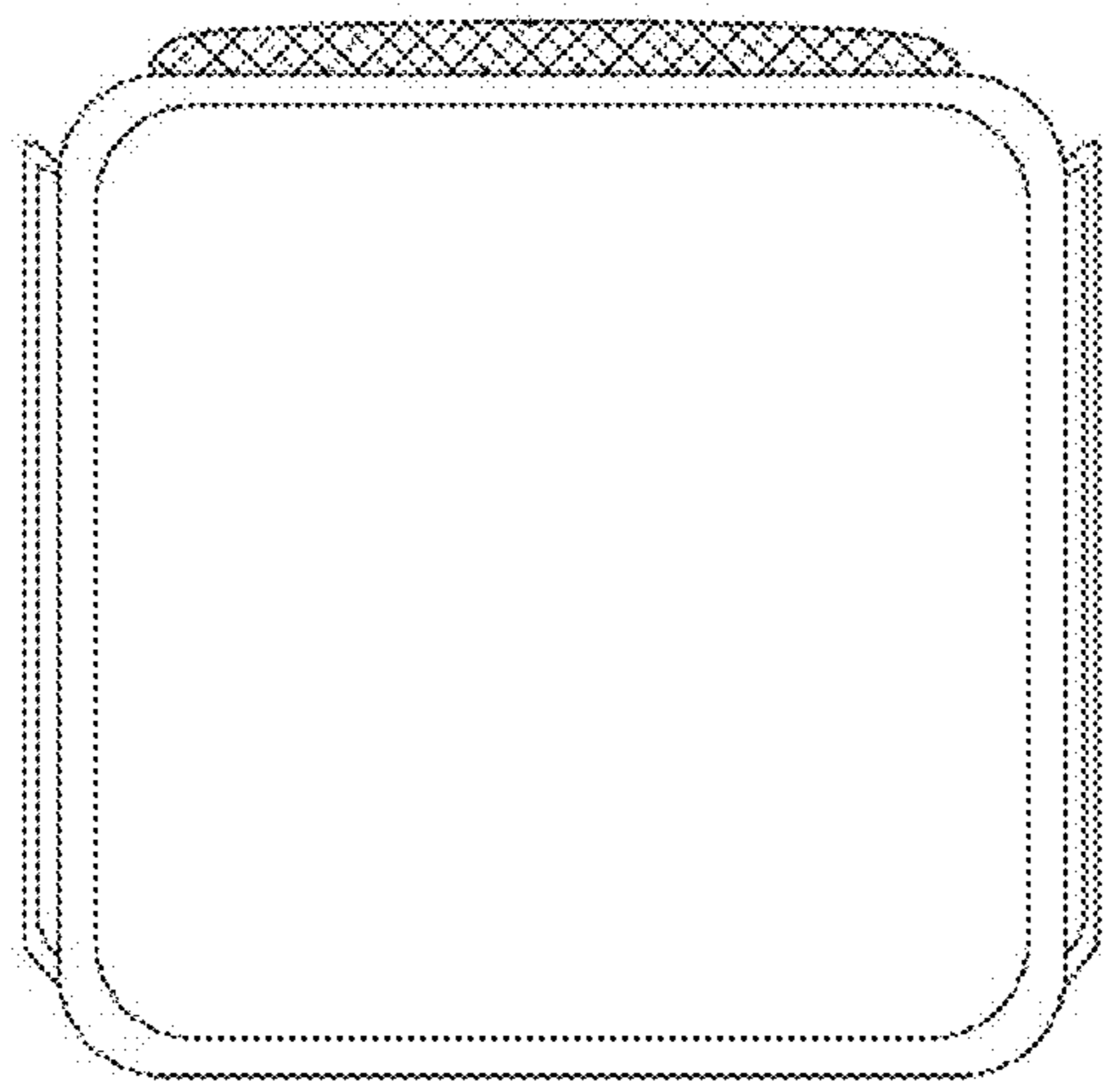

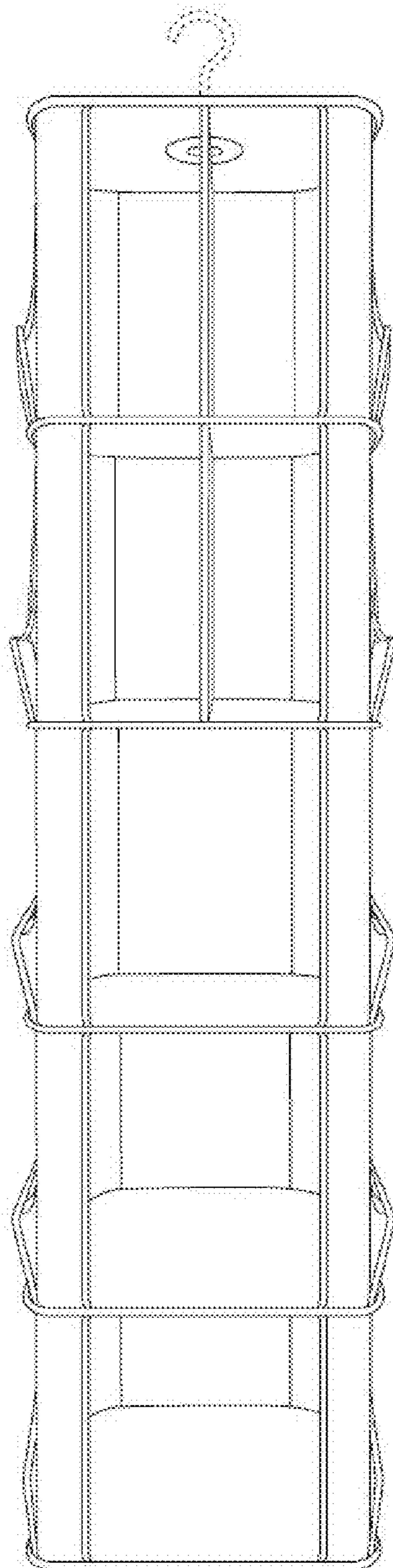

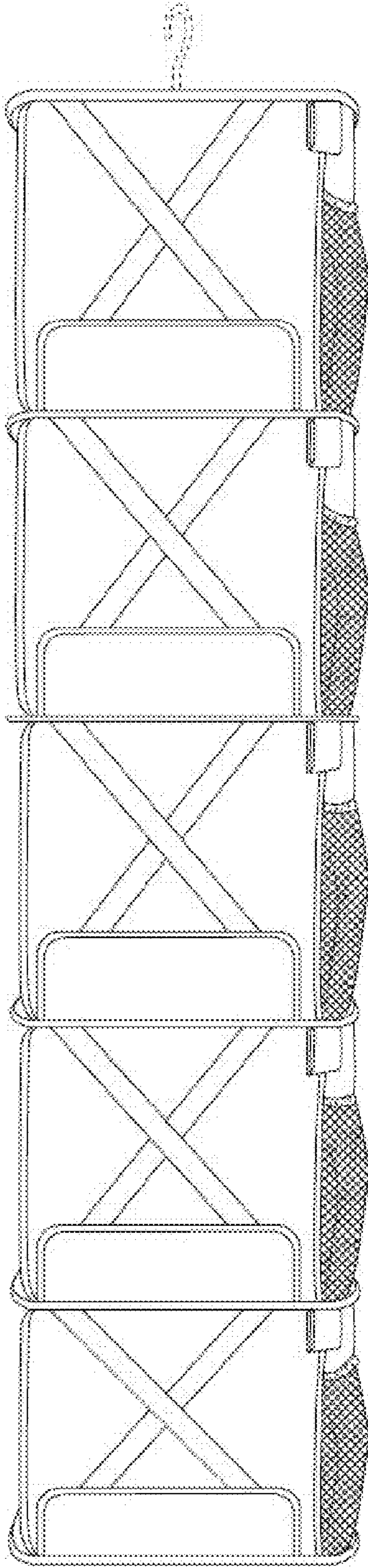

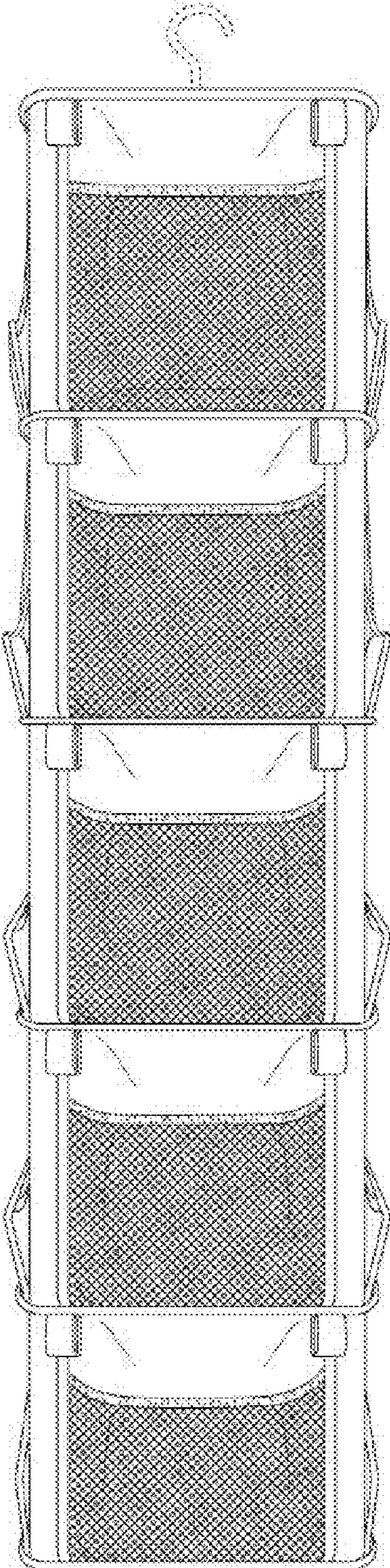

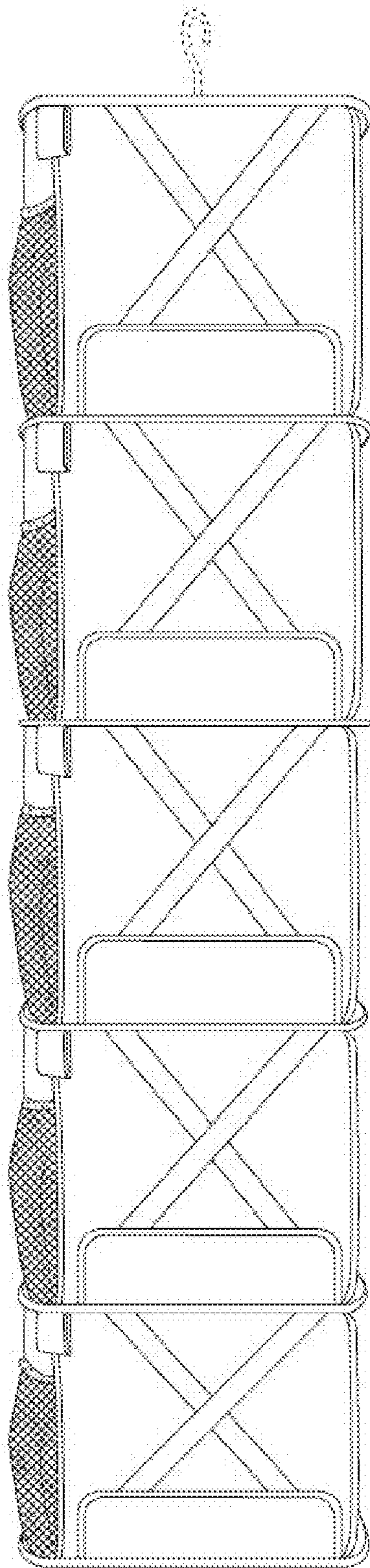

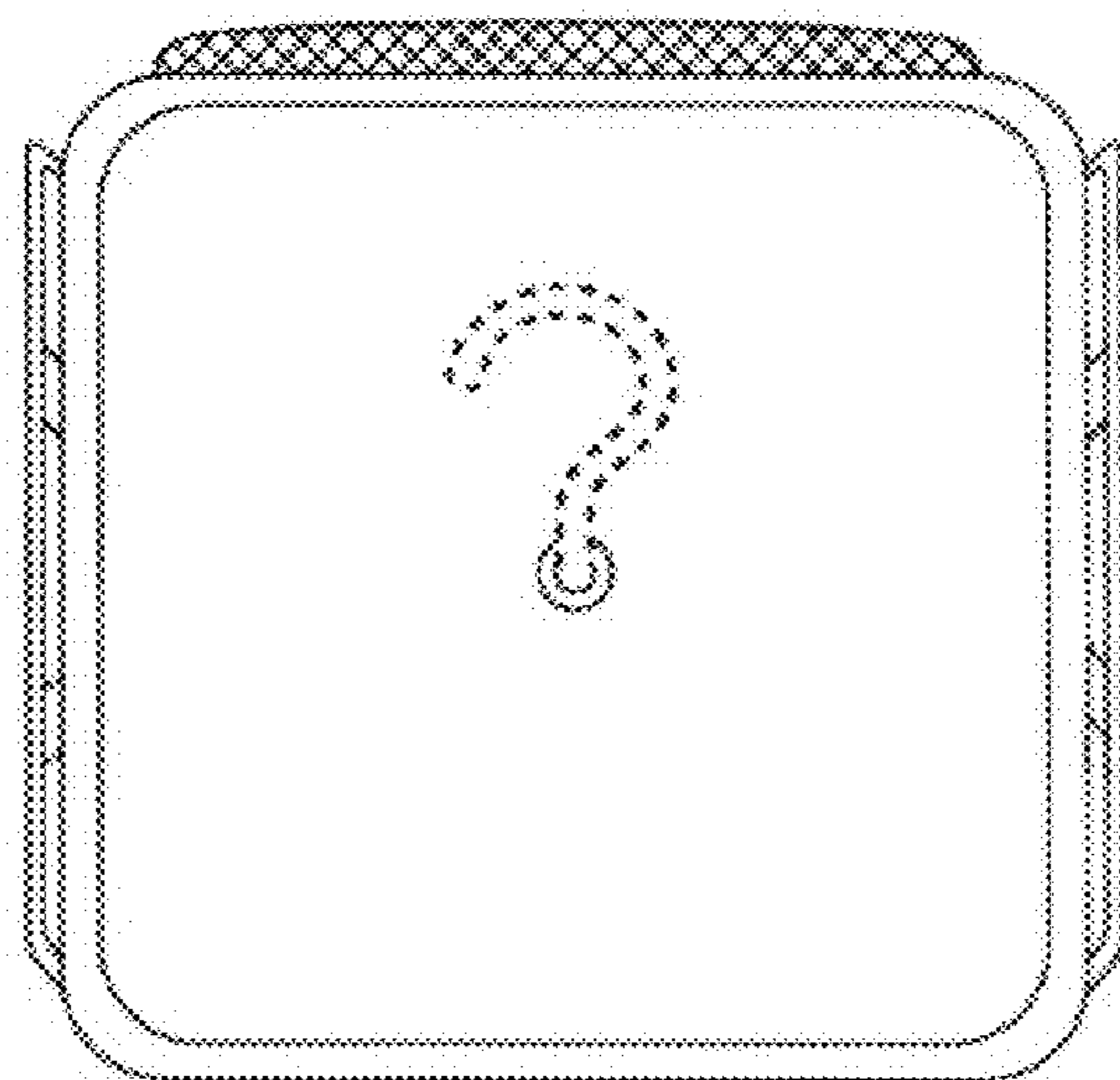

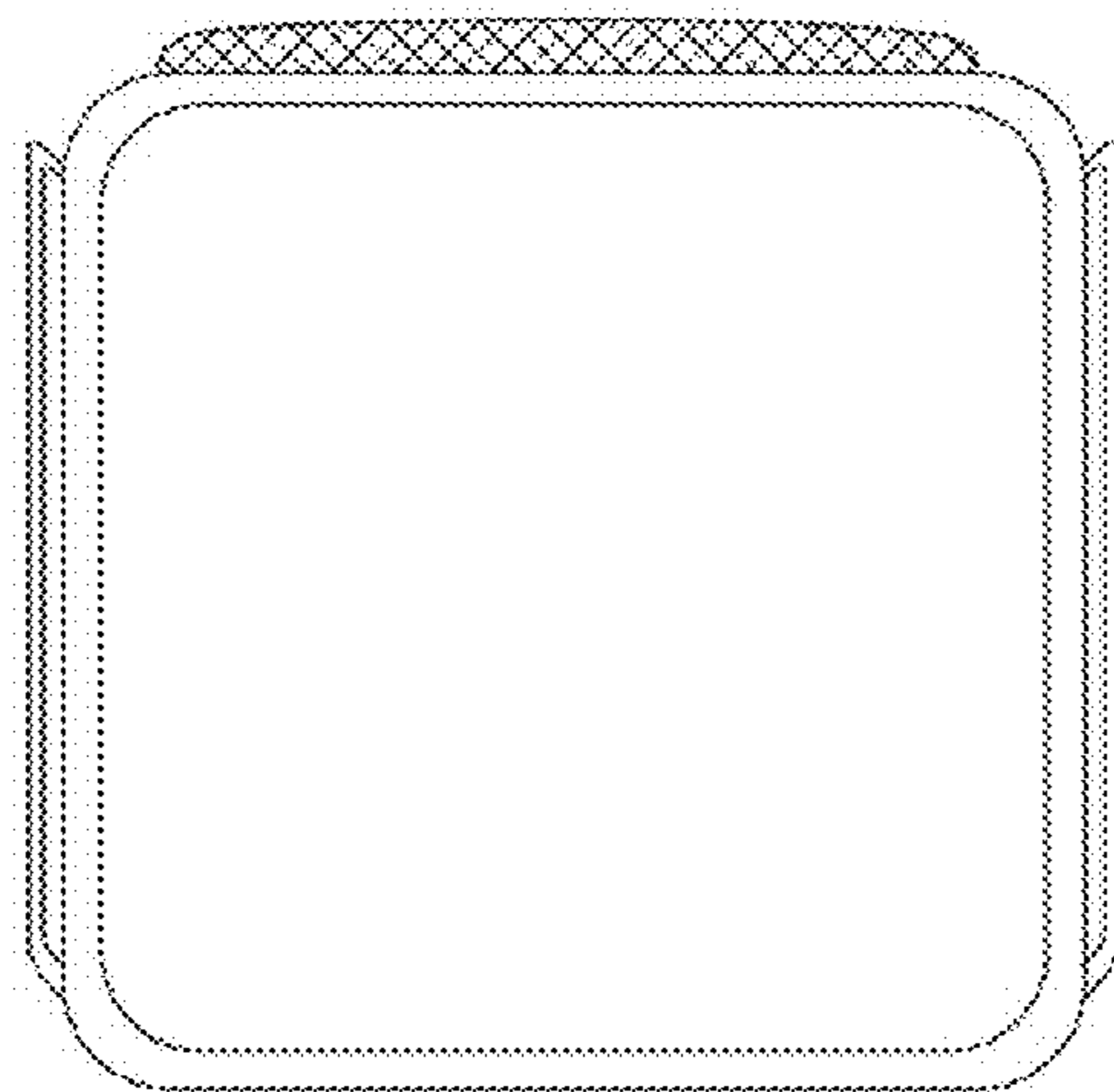
