(57) **CLAIM**

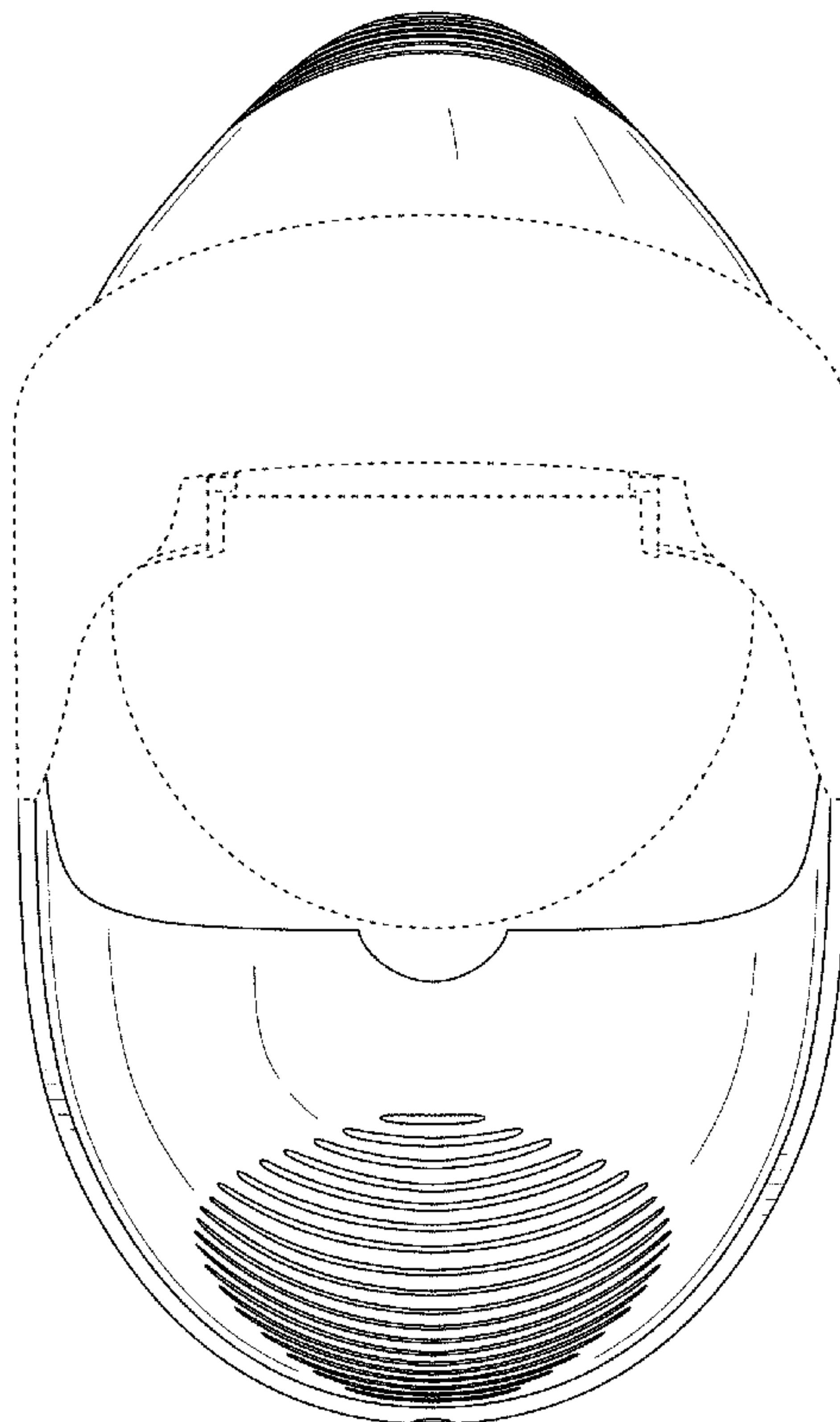
The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left perspective view of a container showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left right side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

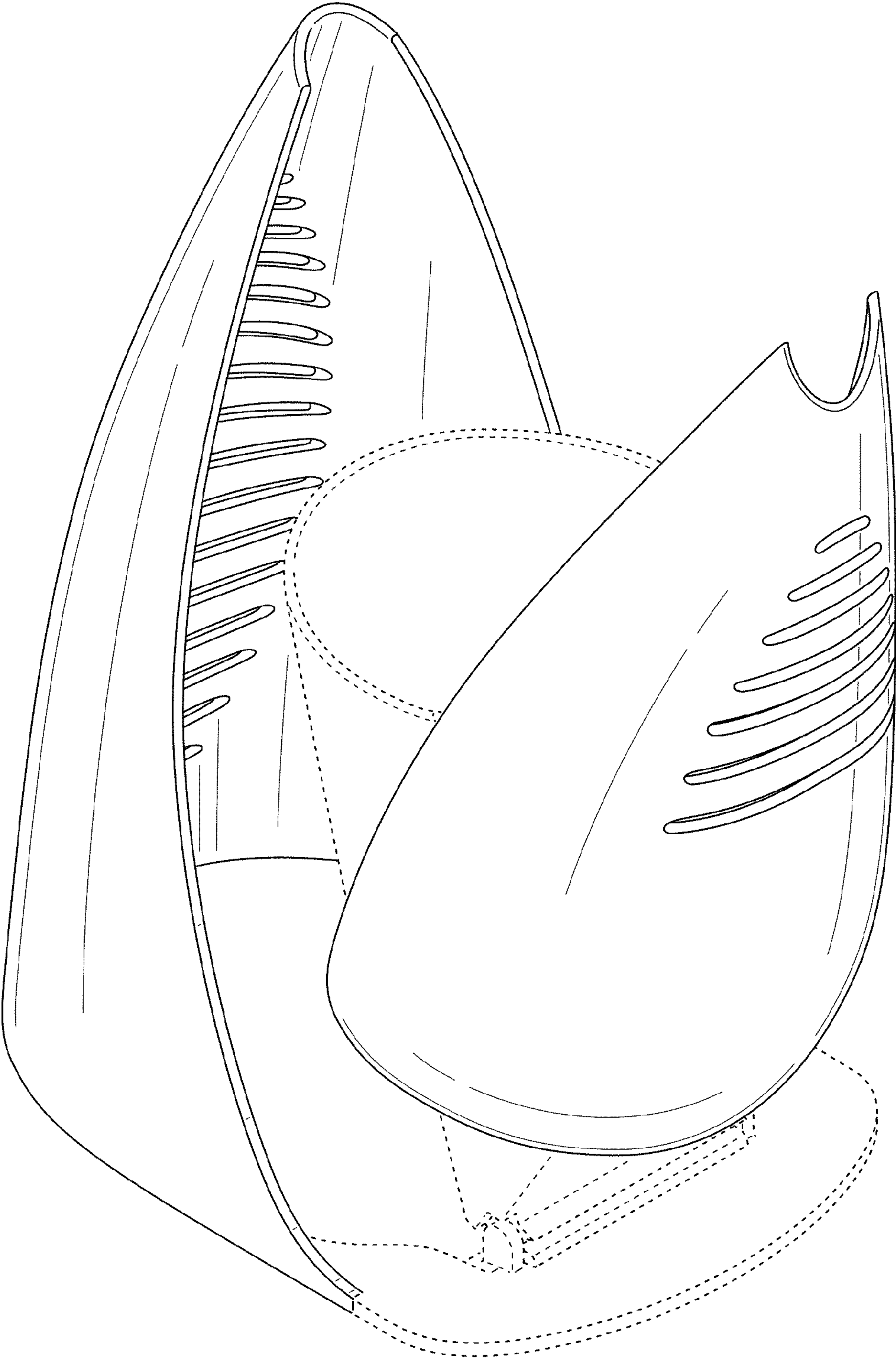

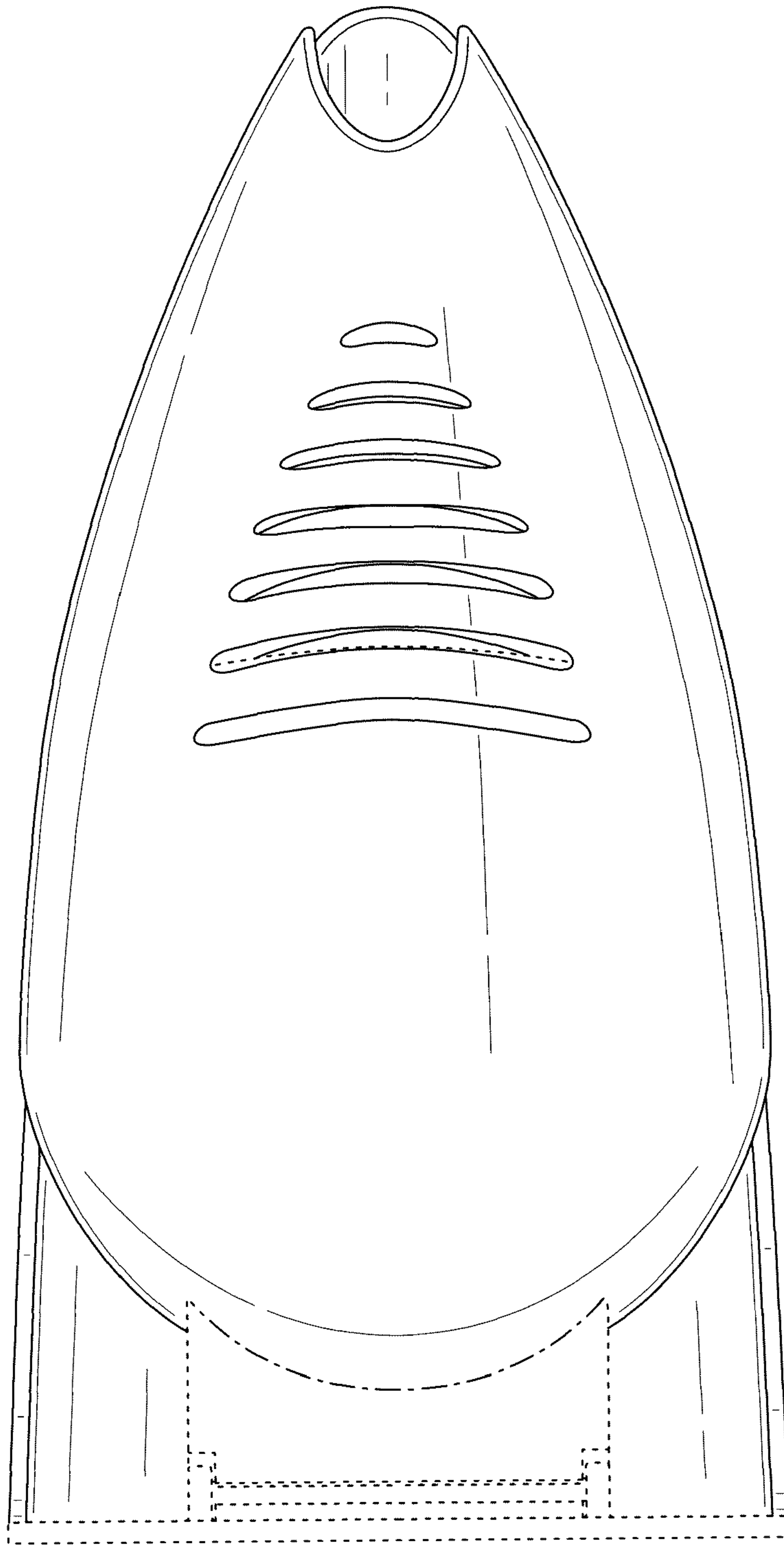

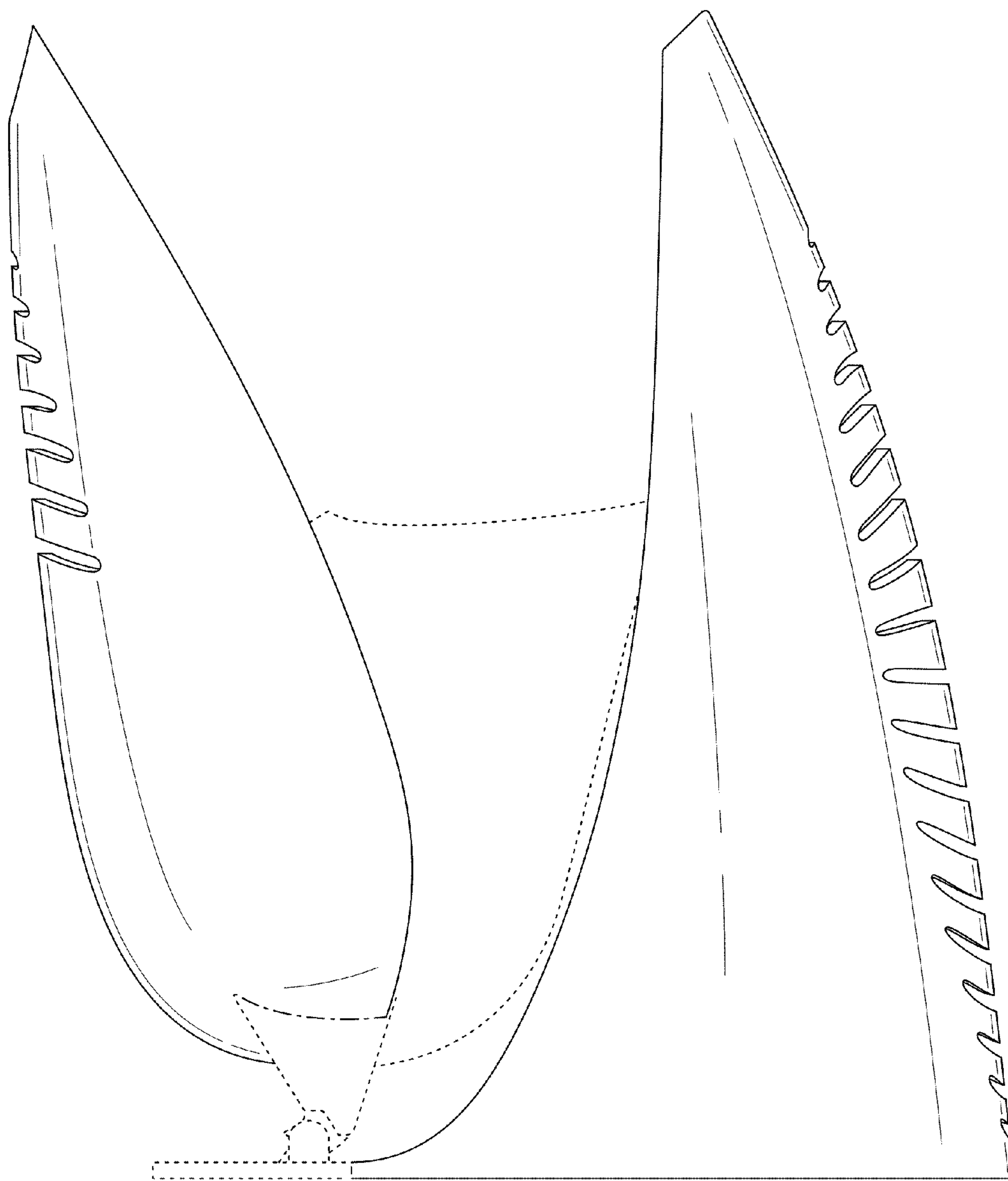

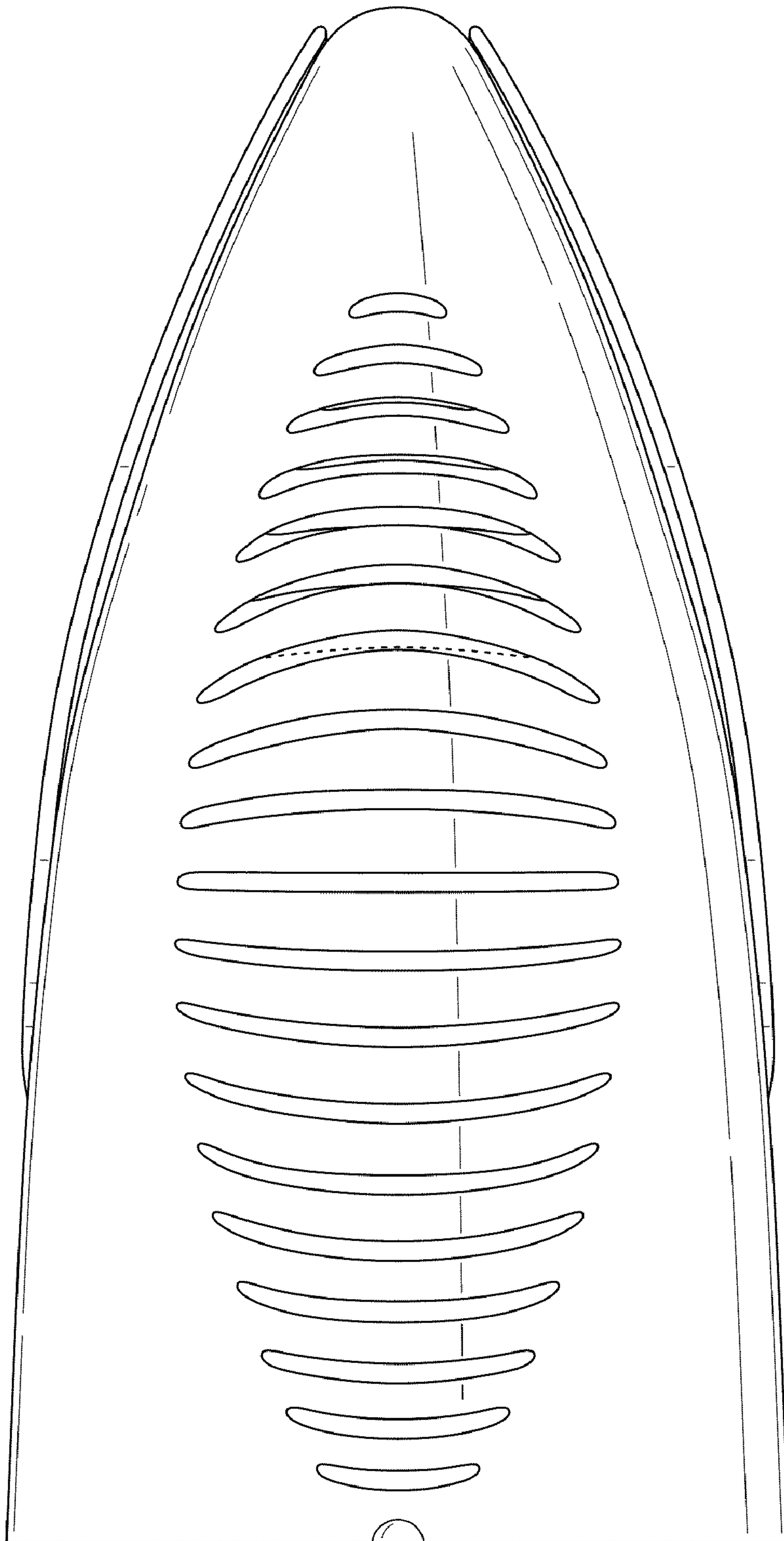

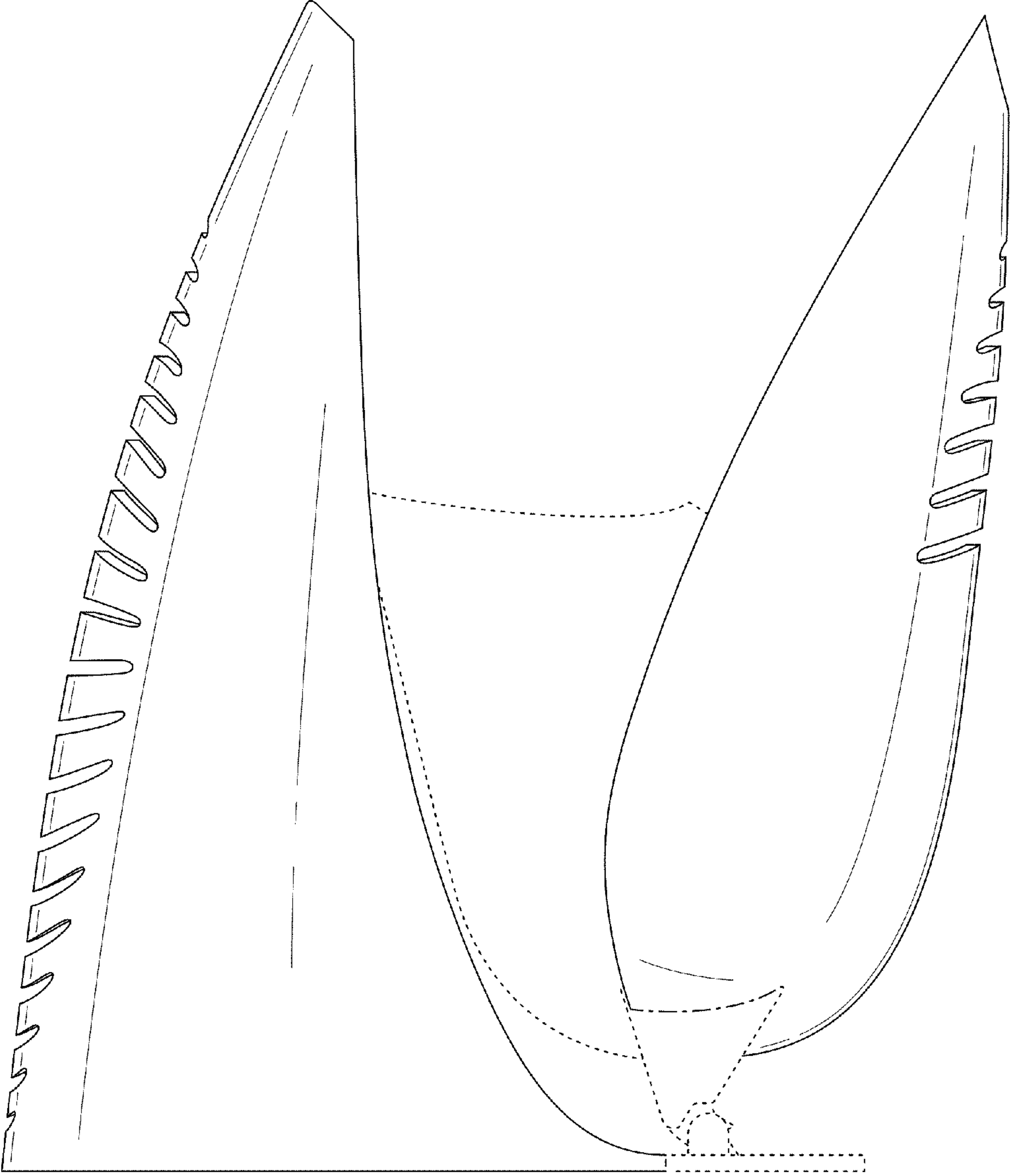

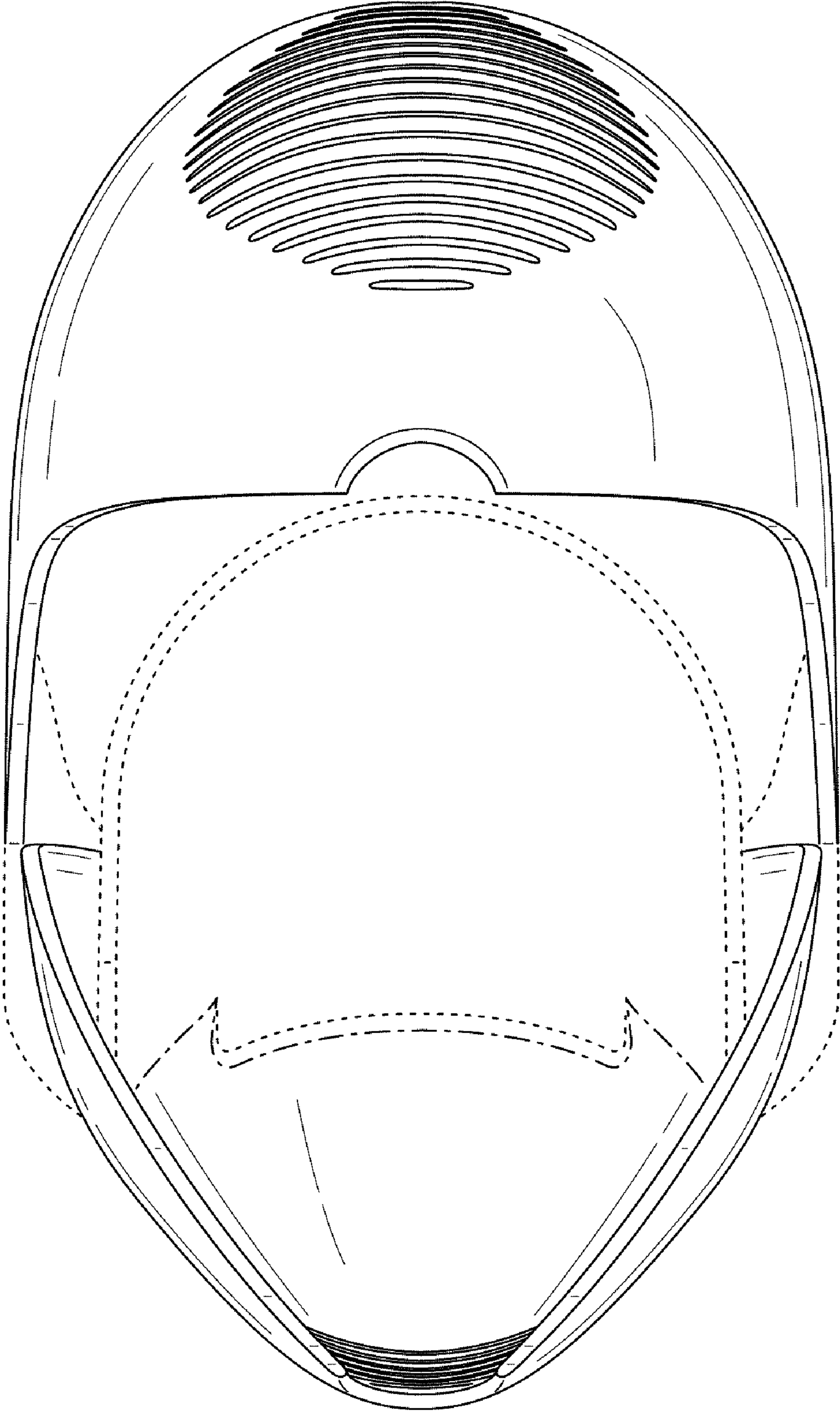

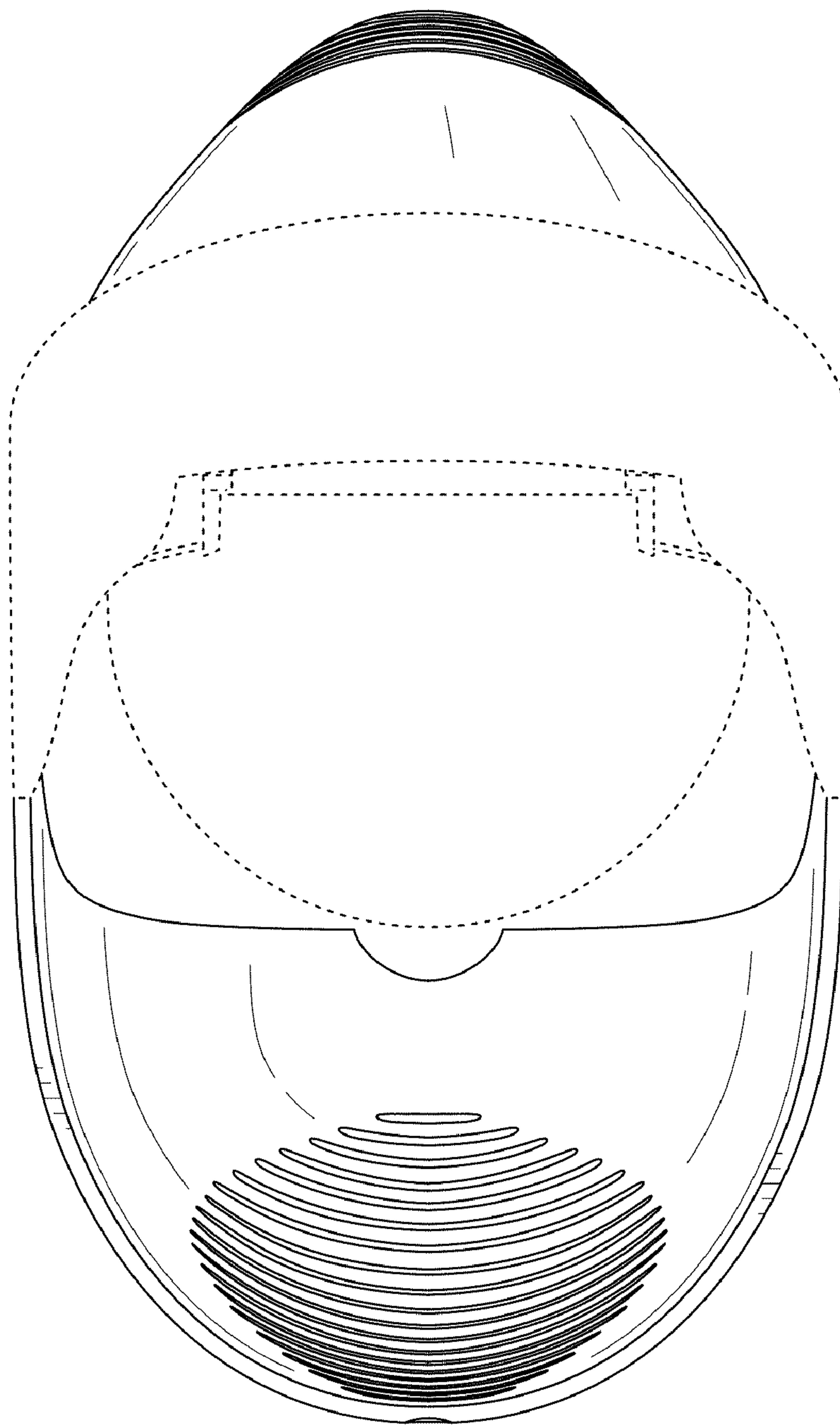
