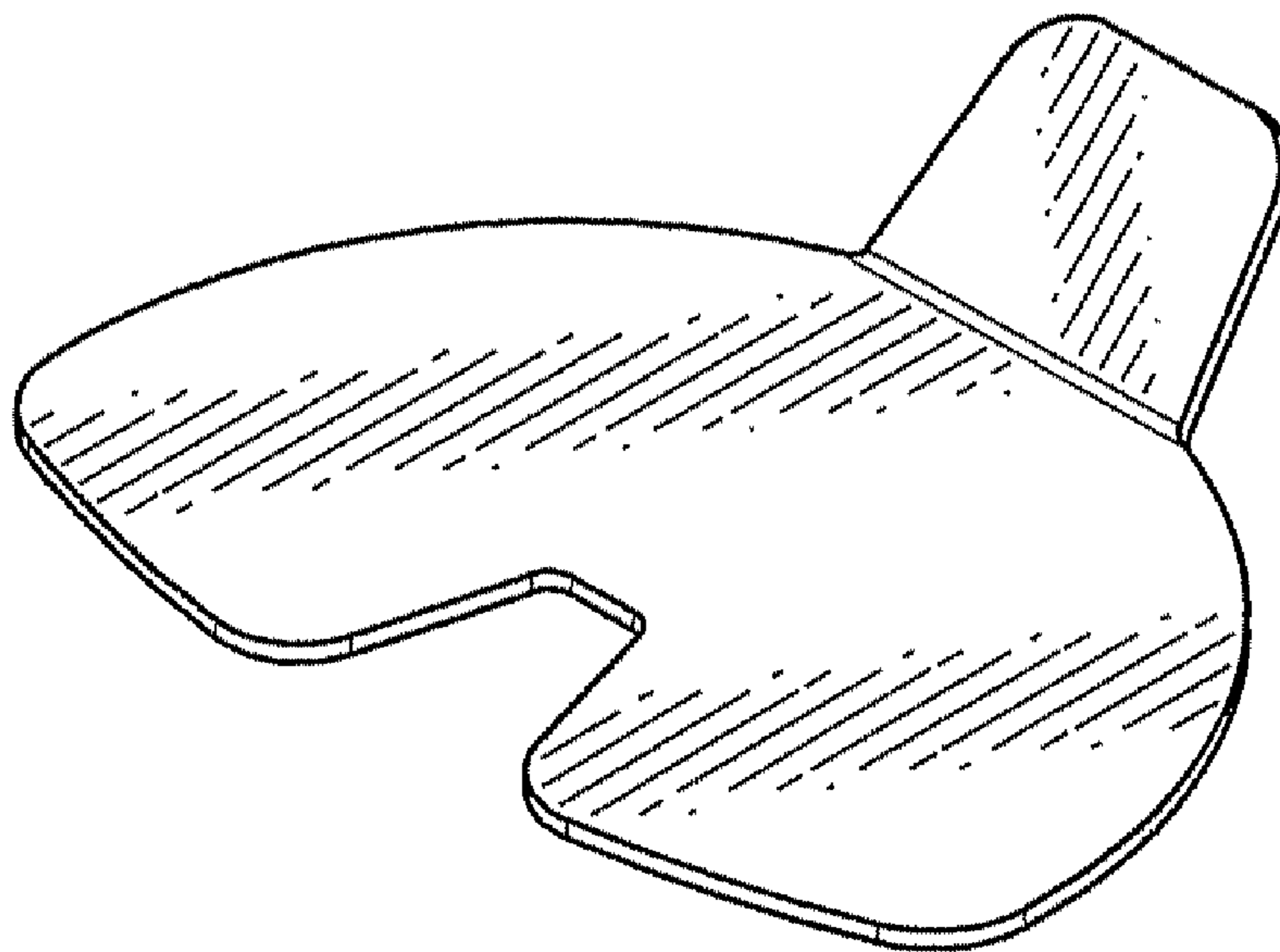
(57) **CLAIM**

The ornamental design for a removable beverage can lid, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the removable beverage can lid, with the beverage can shown in phantom;
FIG. 2 is a perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a front elevational view thereof;
FIG. 7 is a right side elevational view thereof; and,

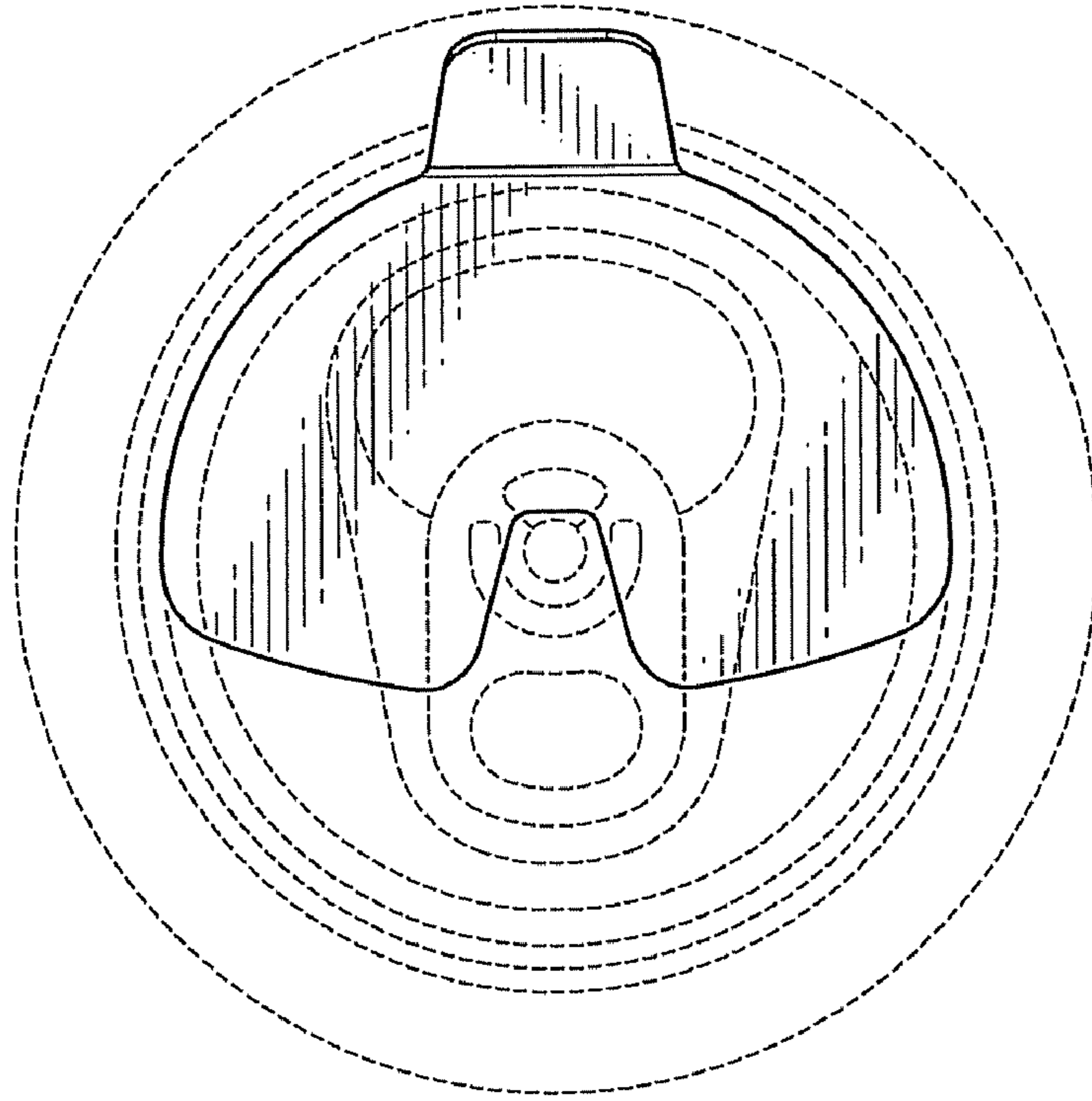

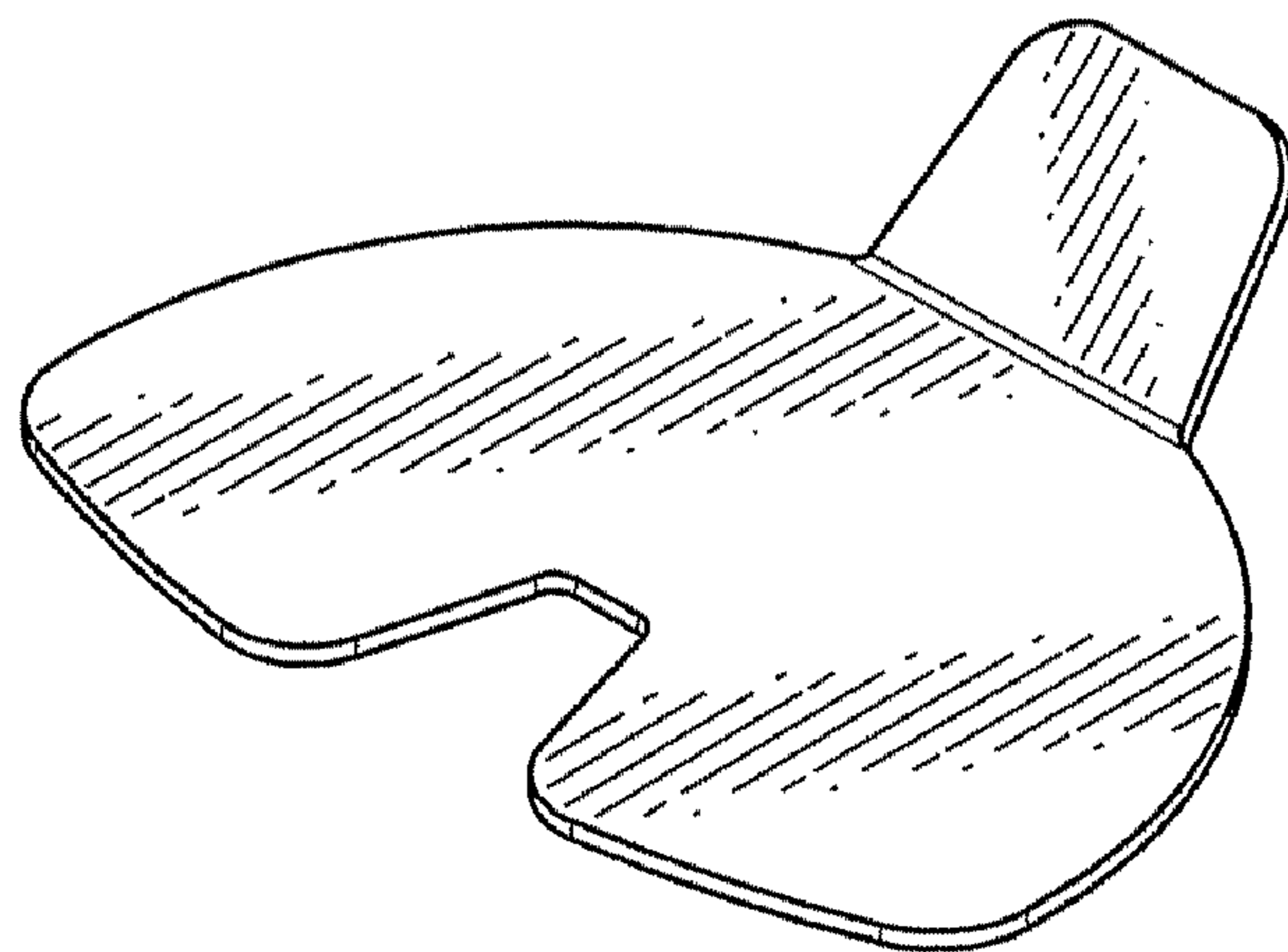

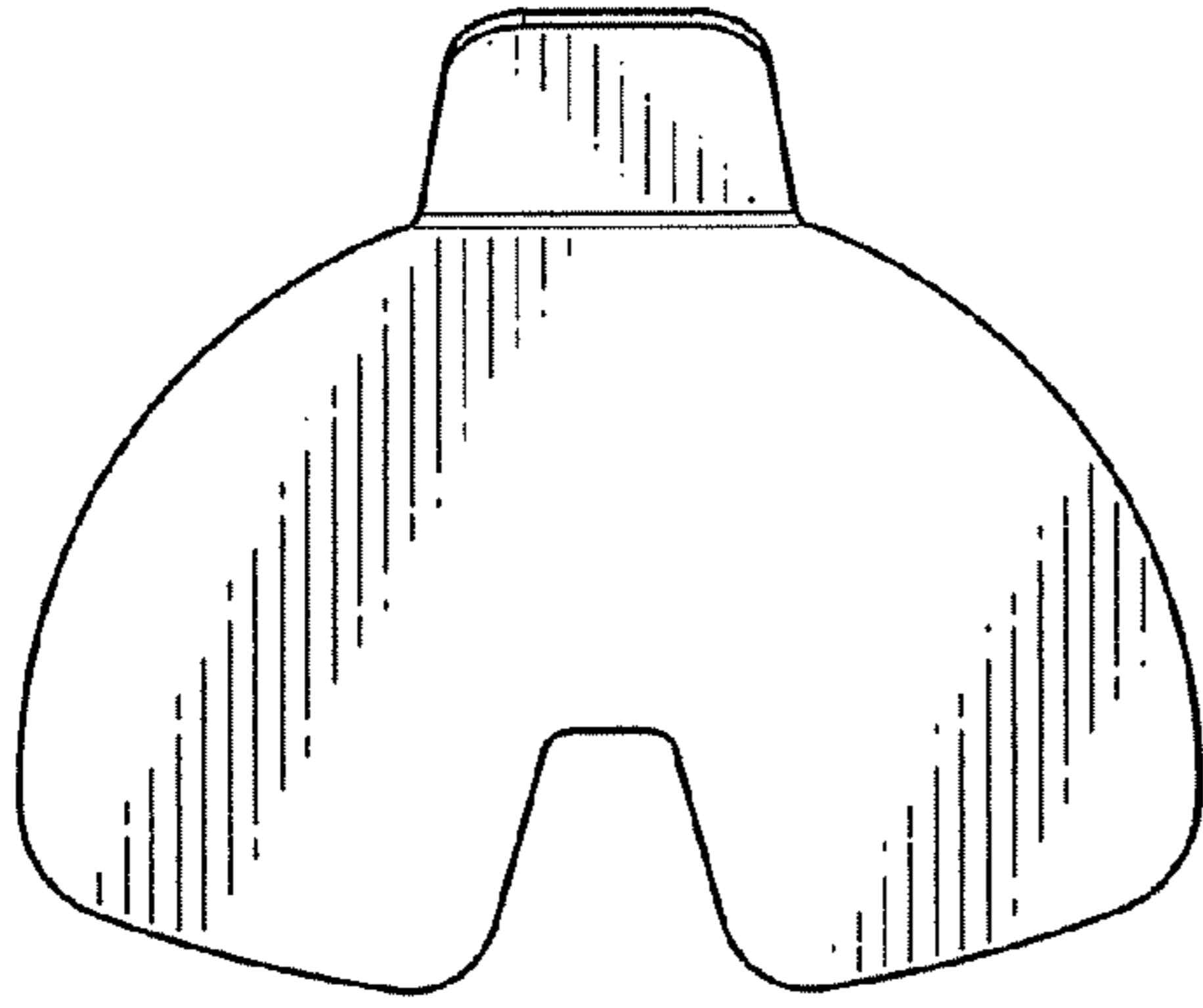

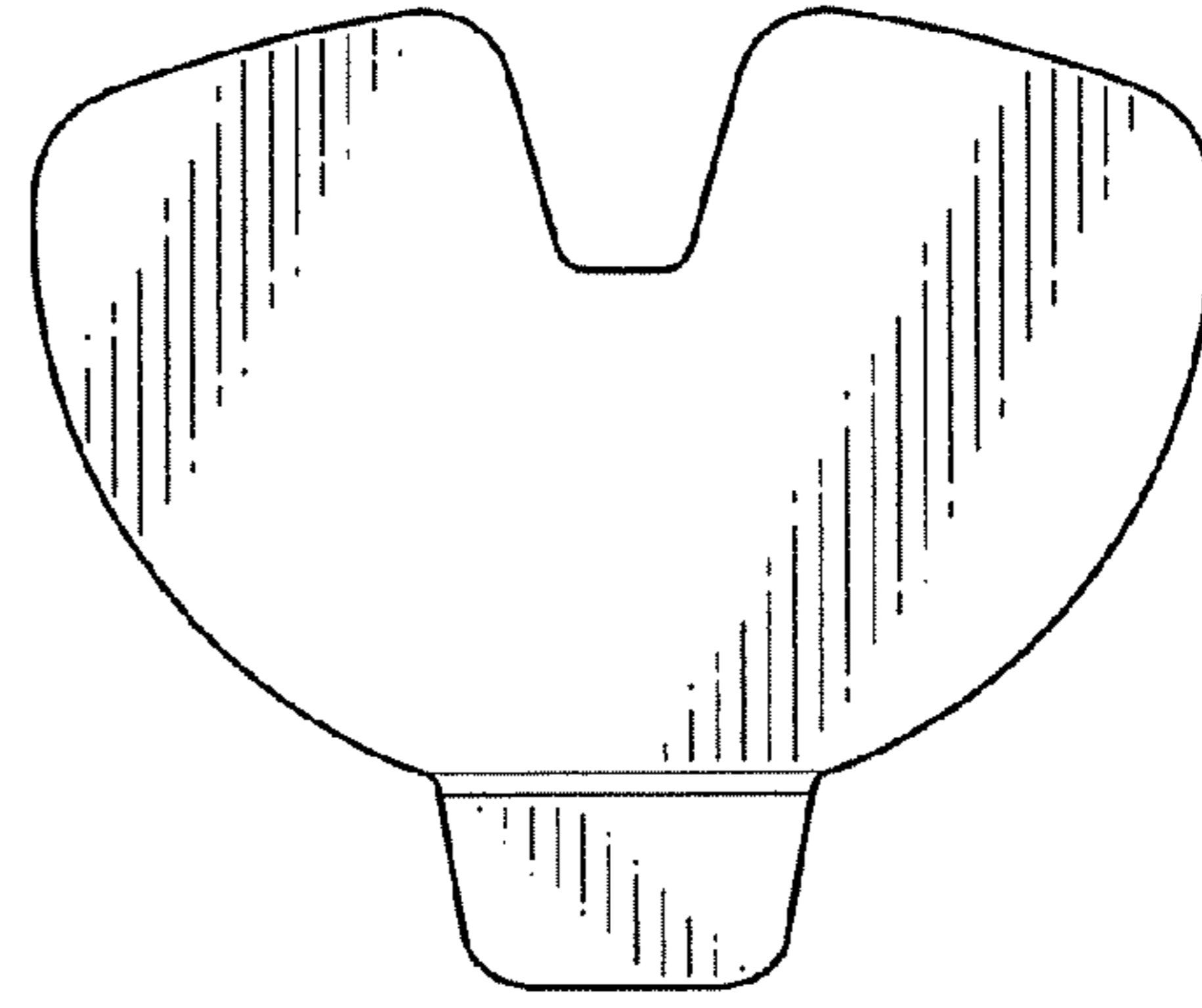

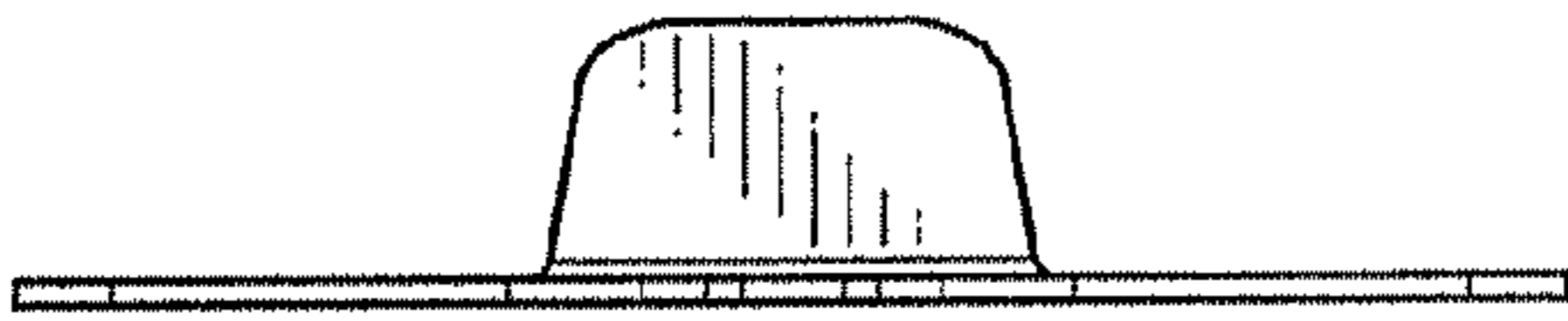

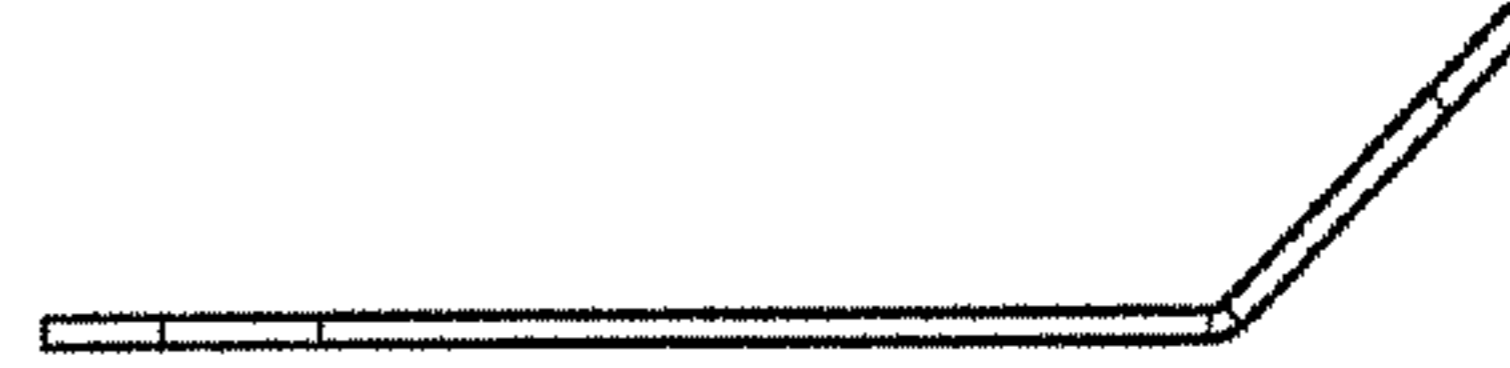
