(57) **CLAIM**

The ornamental design for a cosmetic bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a cosmetic bottle showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a right side elevation view thereof;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.
The broken lines in the drawings showing the outer structure of the cosmetic bottle illustrate the portions of the design that form no part of the claim.

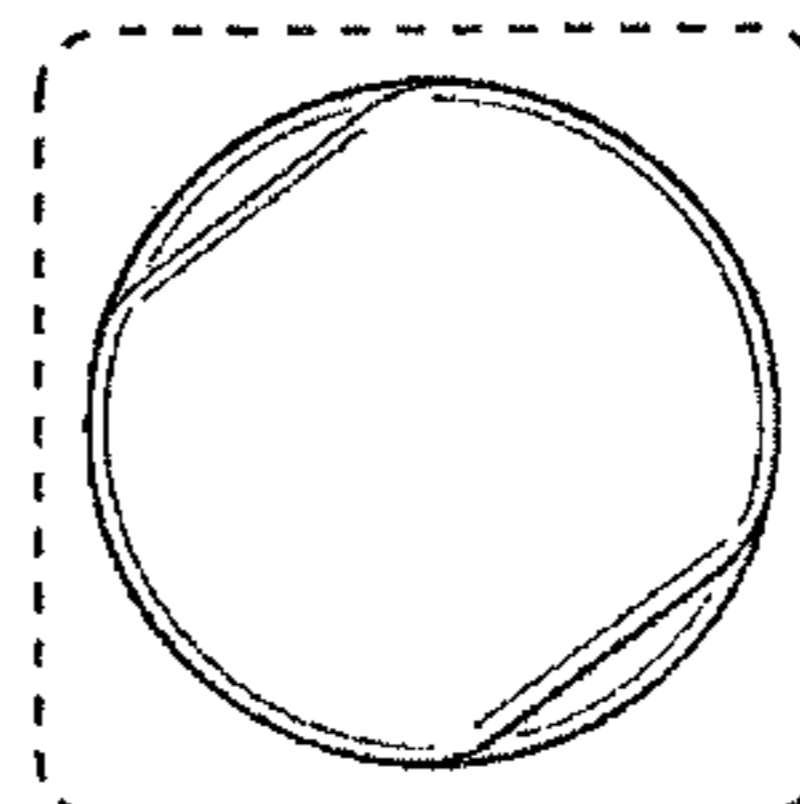
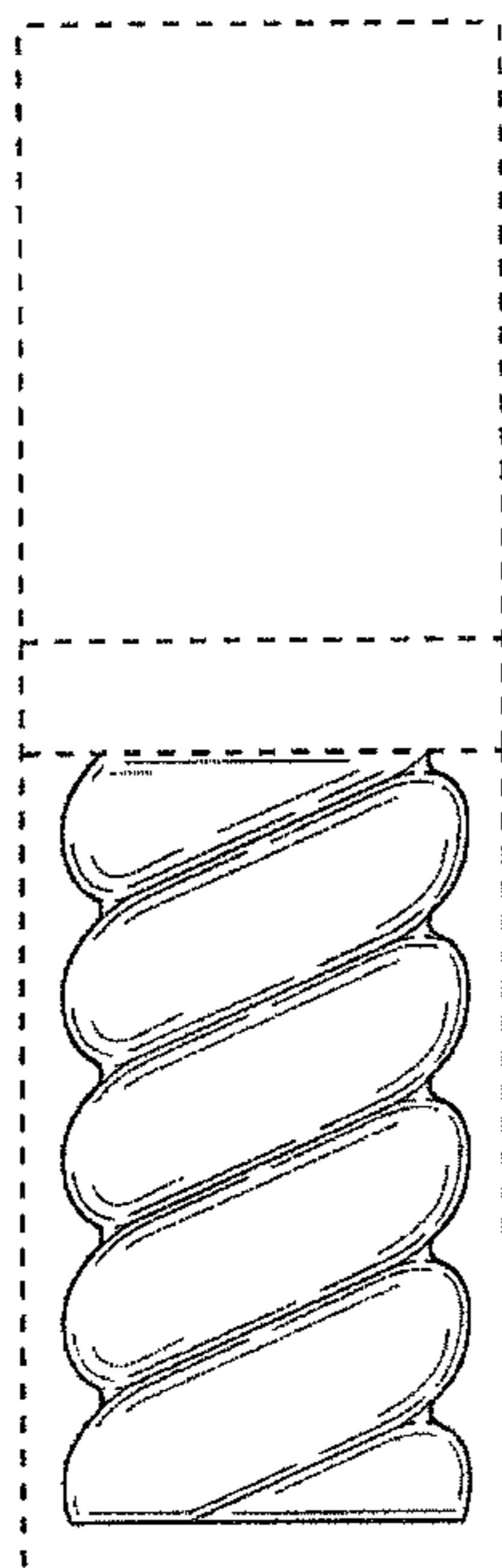

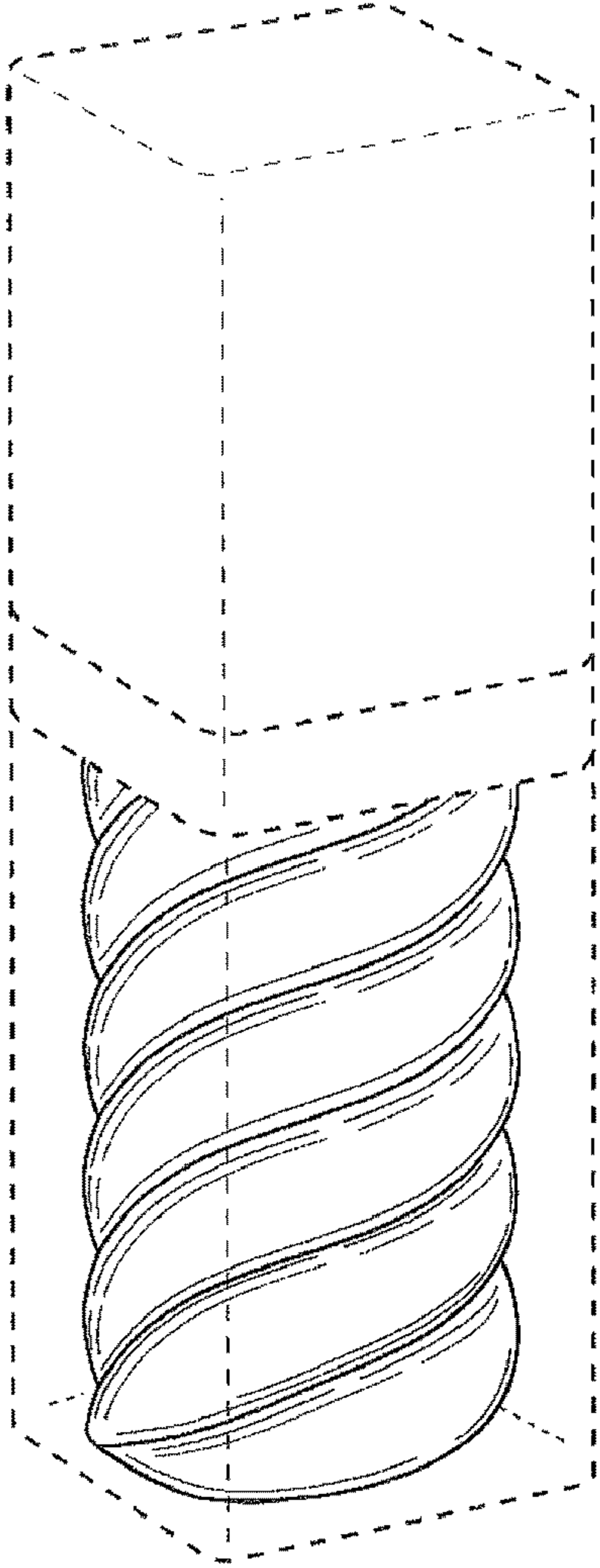

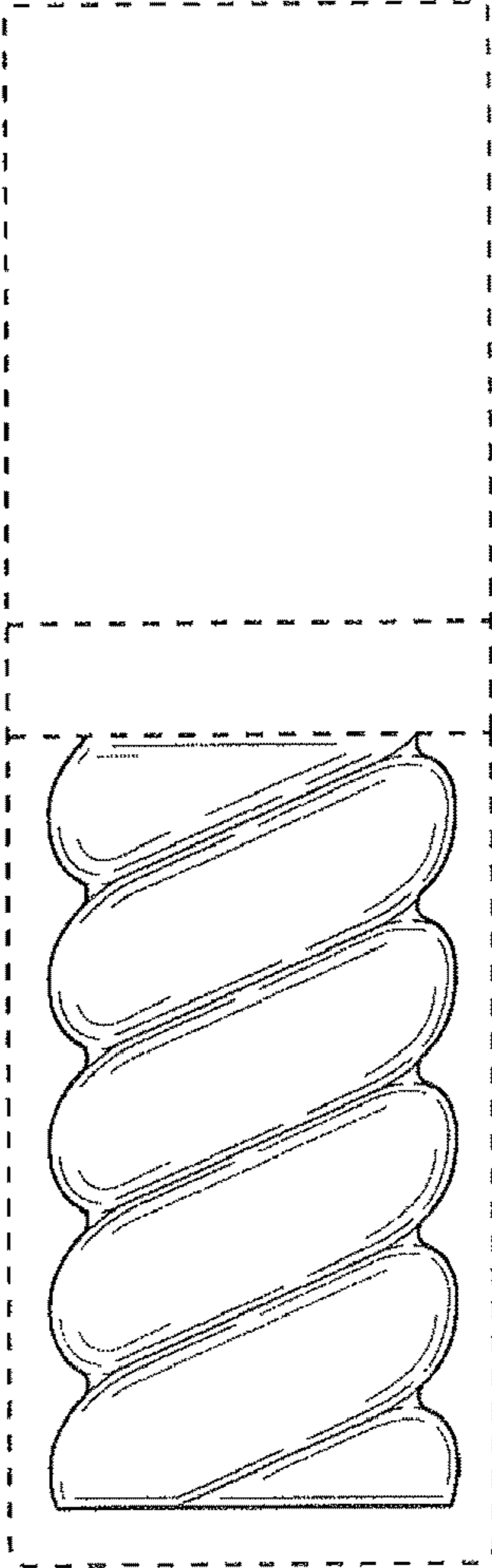

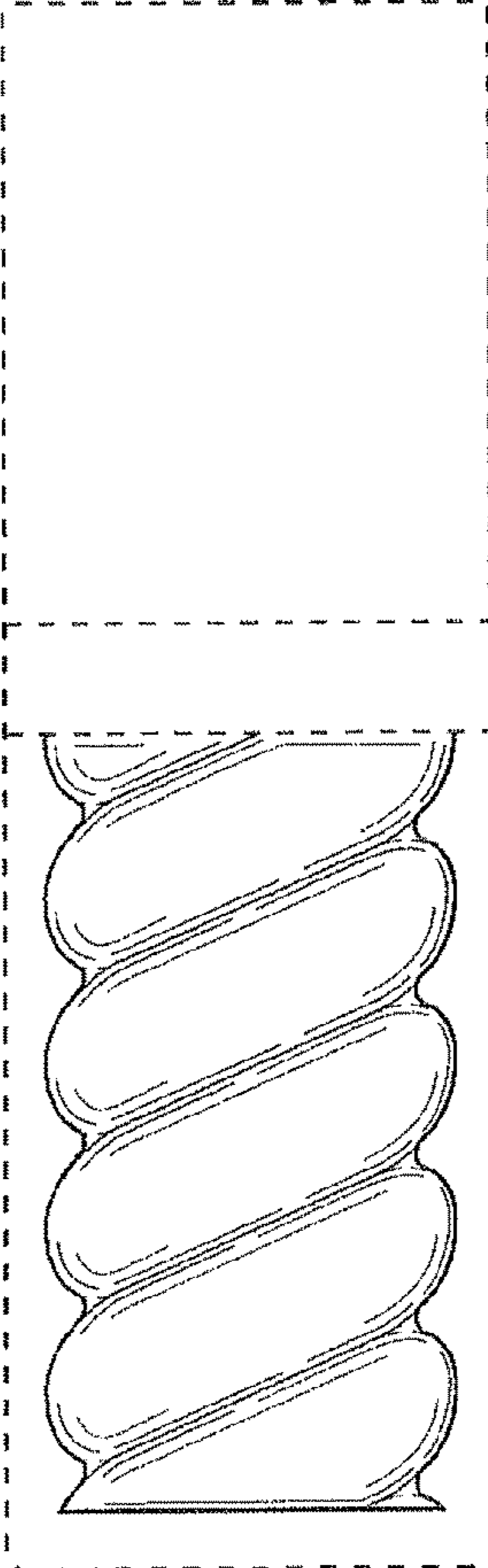

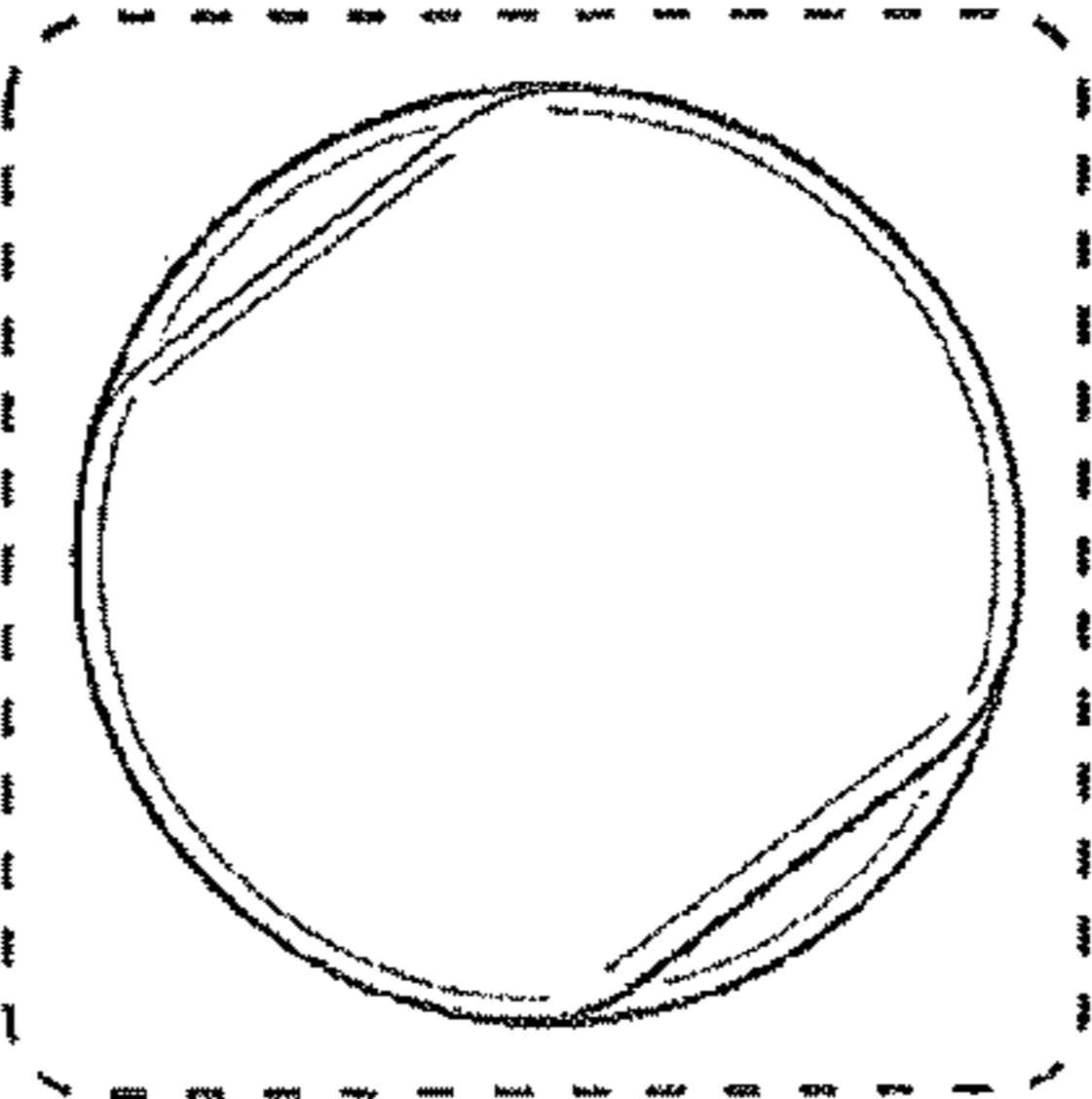
