FIG. 3 is a rear view of a container comprising the new, original and ornamental design;

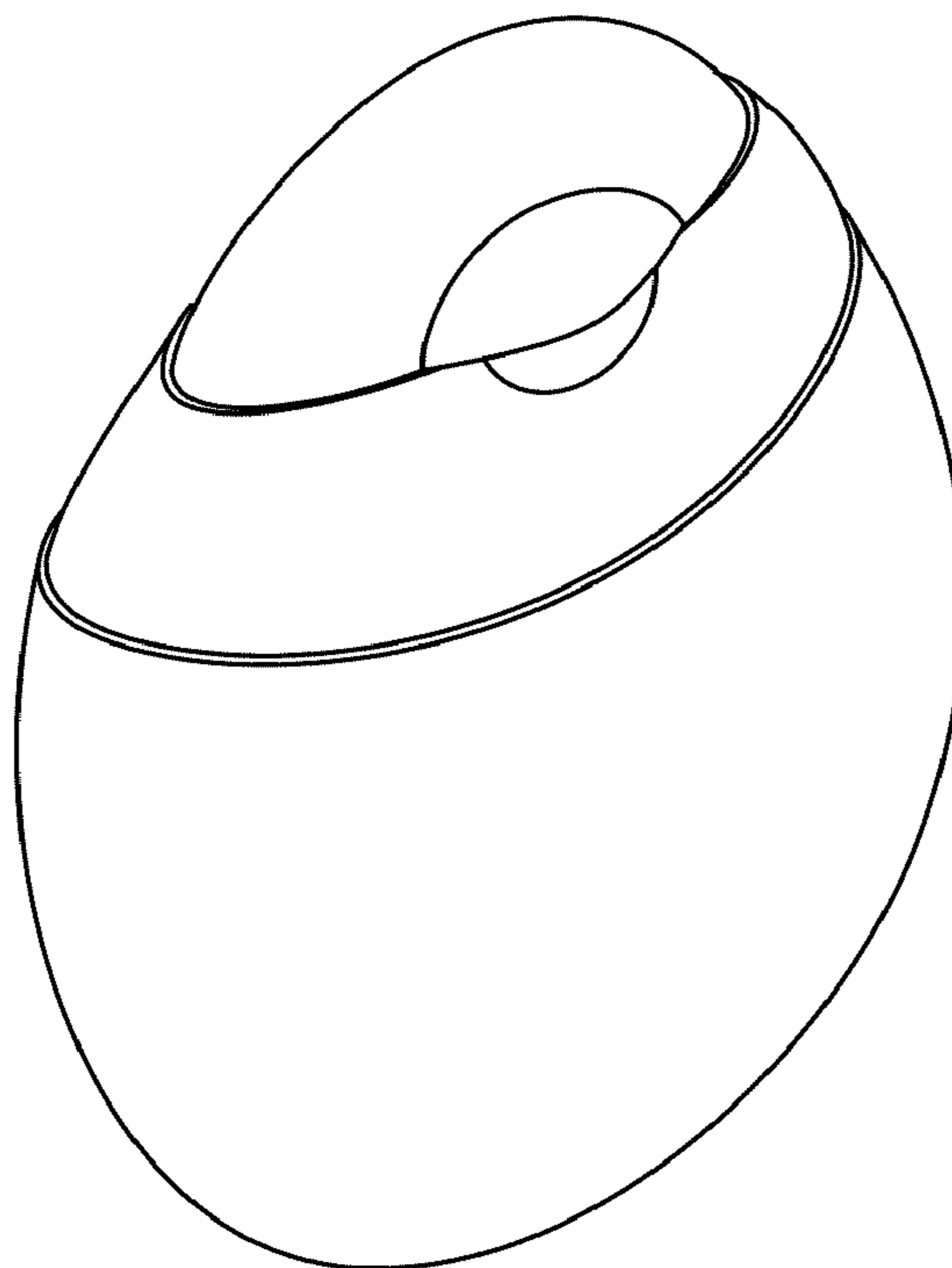
FIG. 4 is a left-hand side view of a container comprising the new, original and ornamental design;

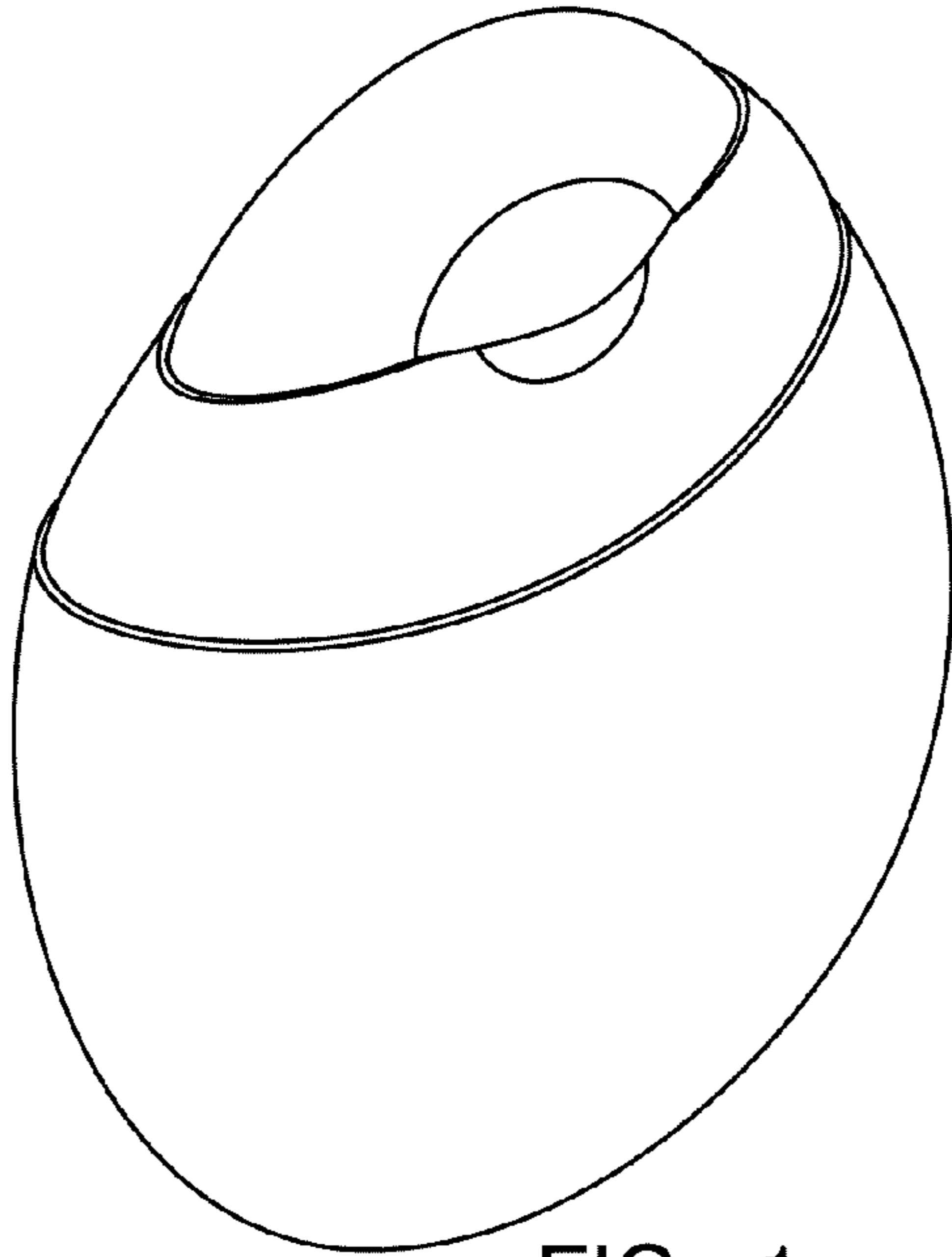

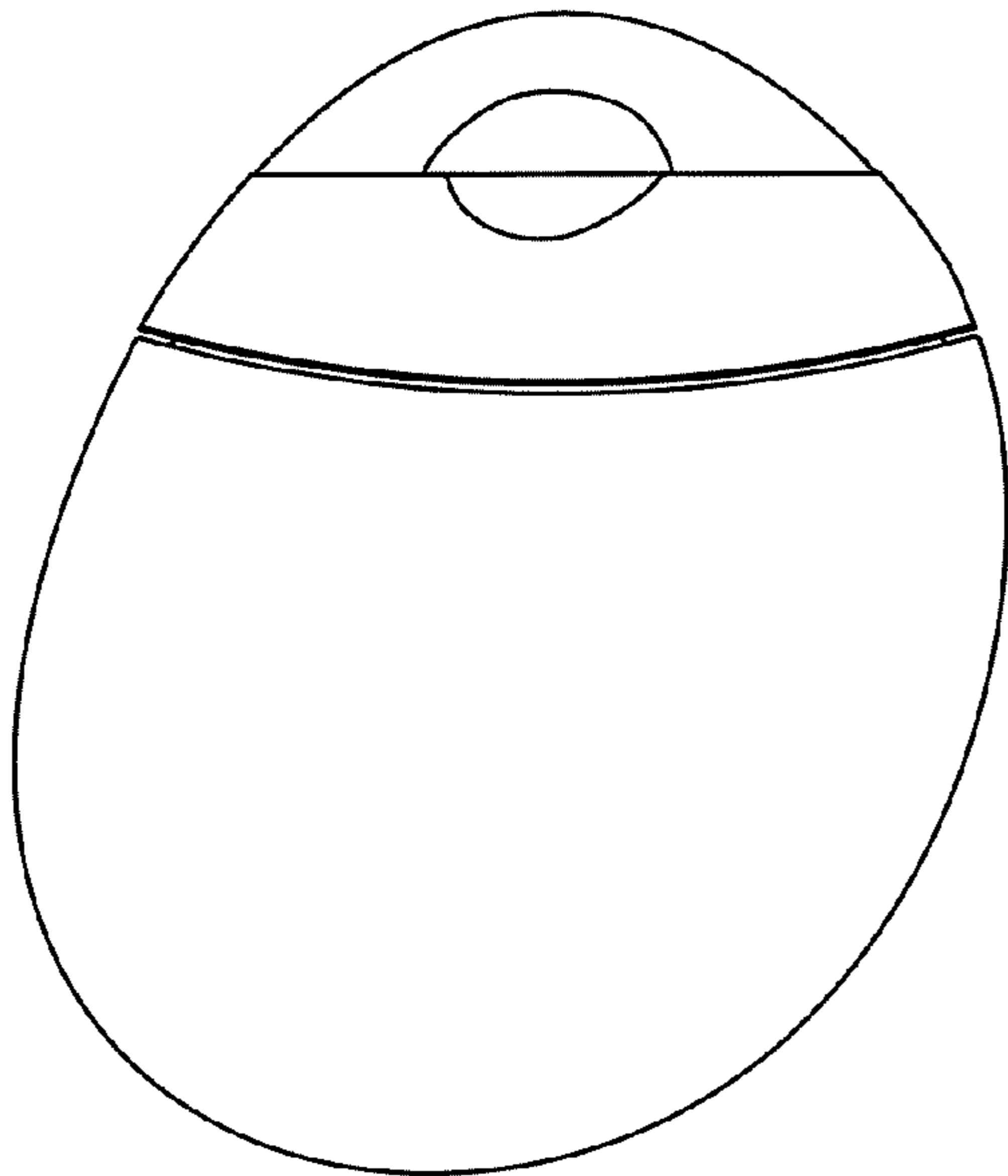

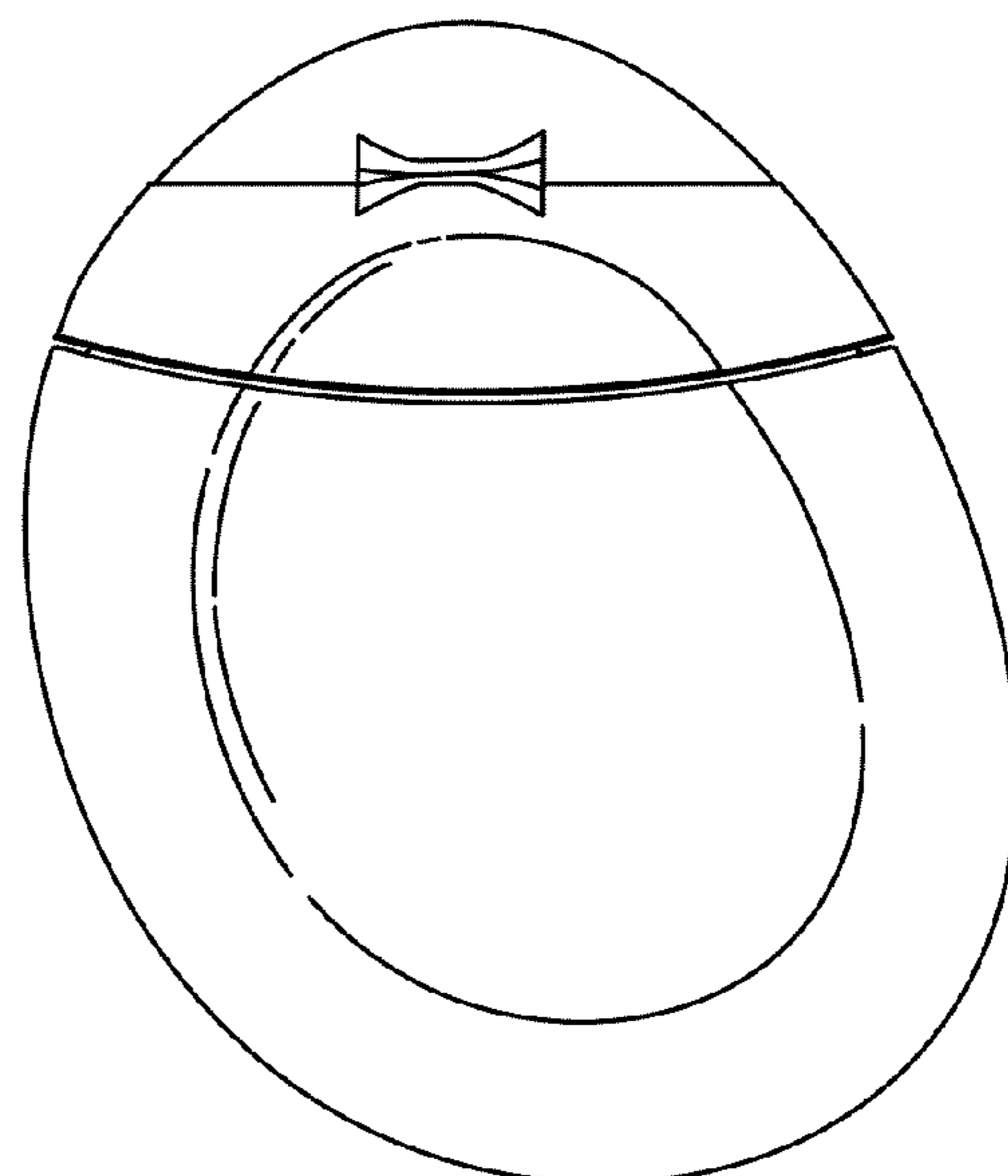

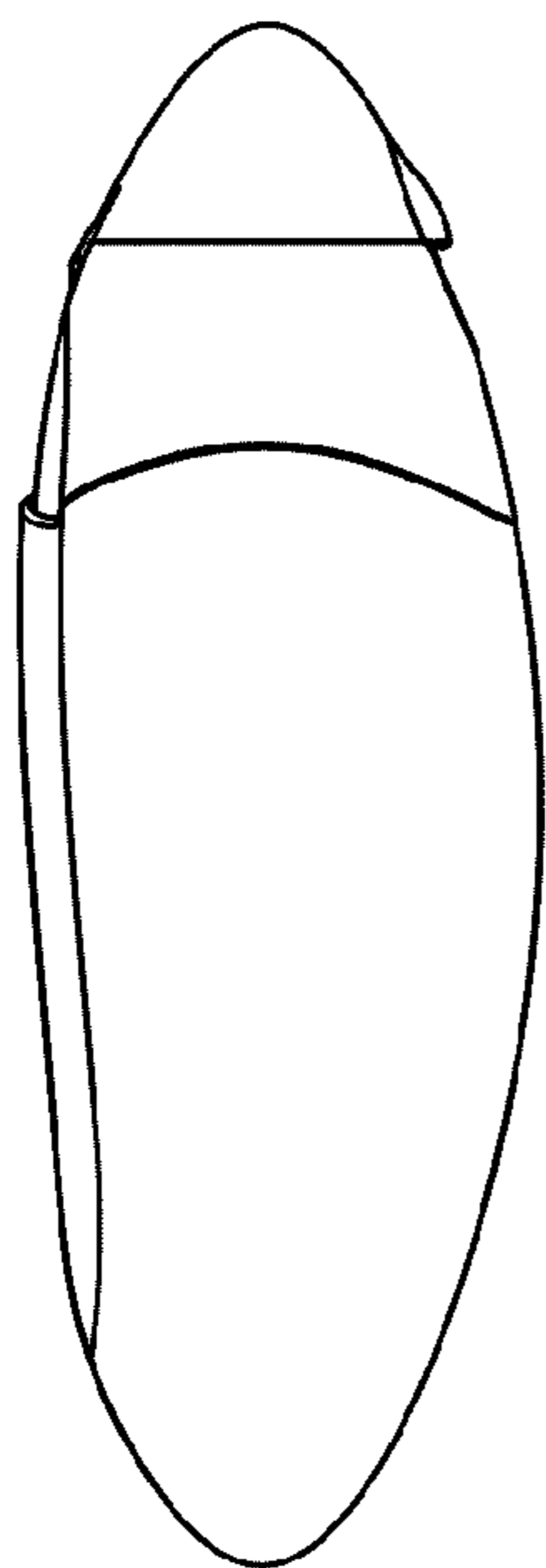

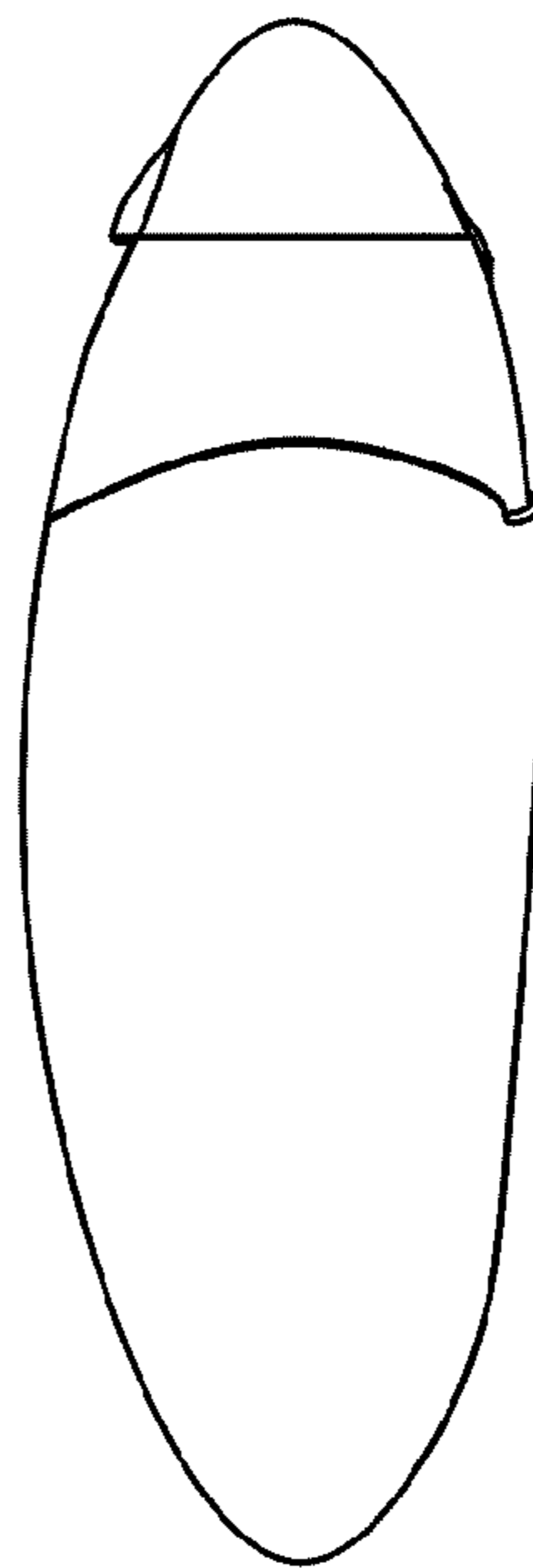

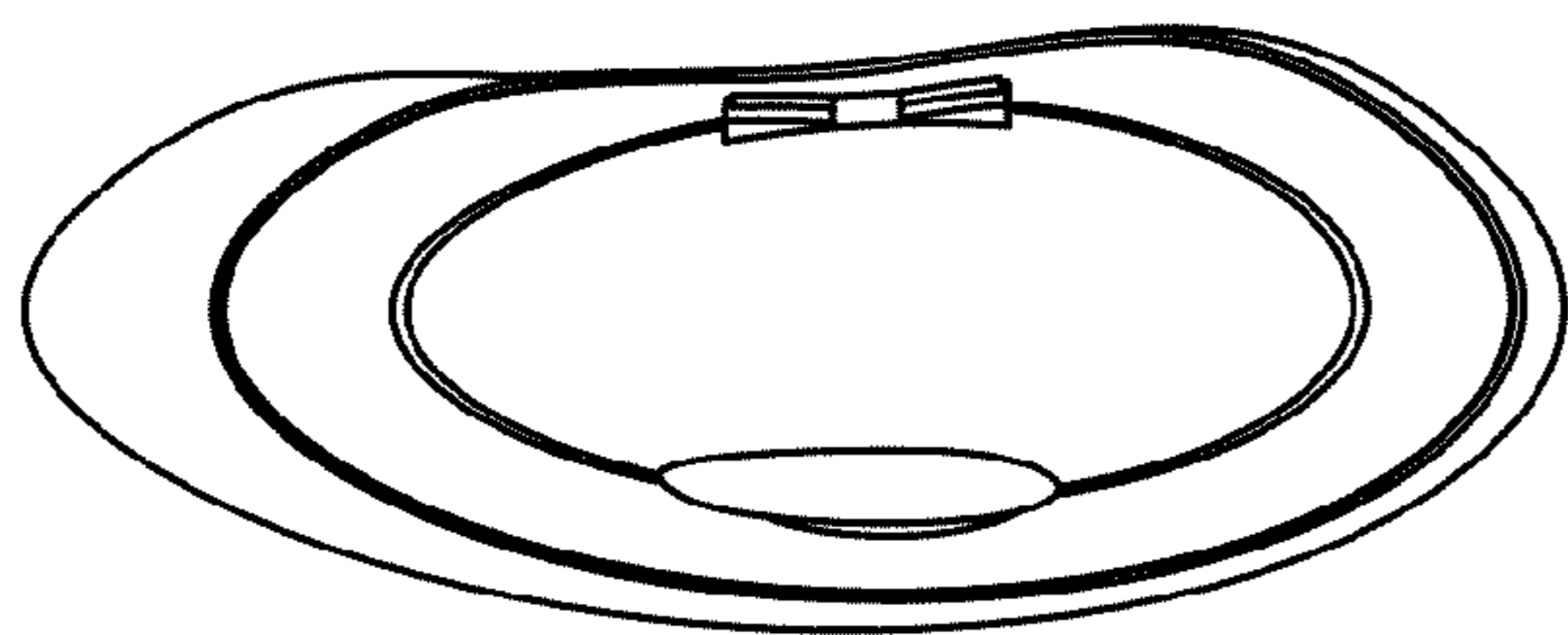

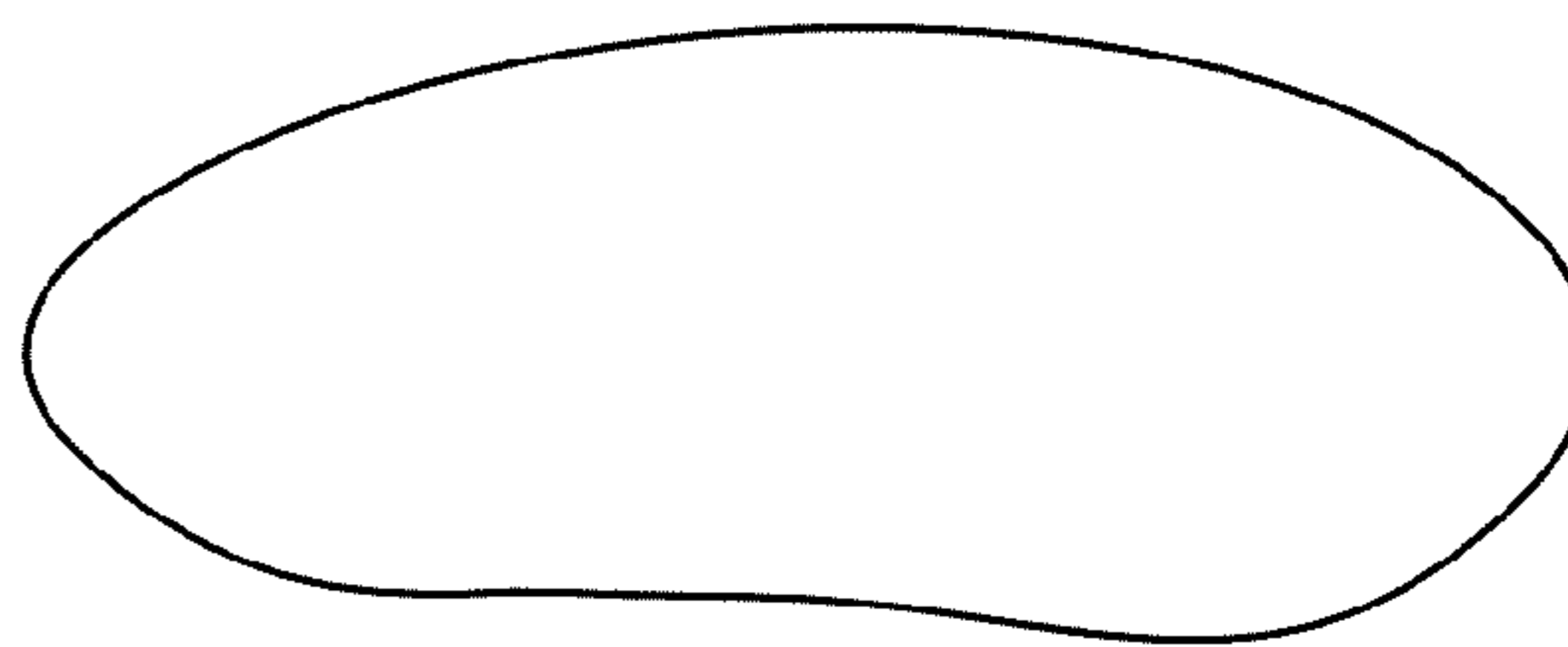
