FIG. 1 is a top view a wristband with writeable and erasable surface in accordance with this invention.

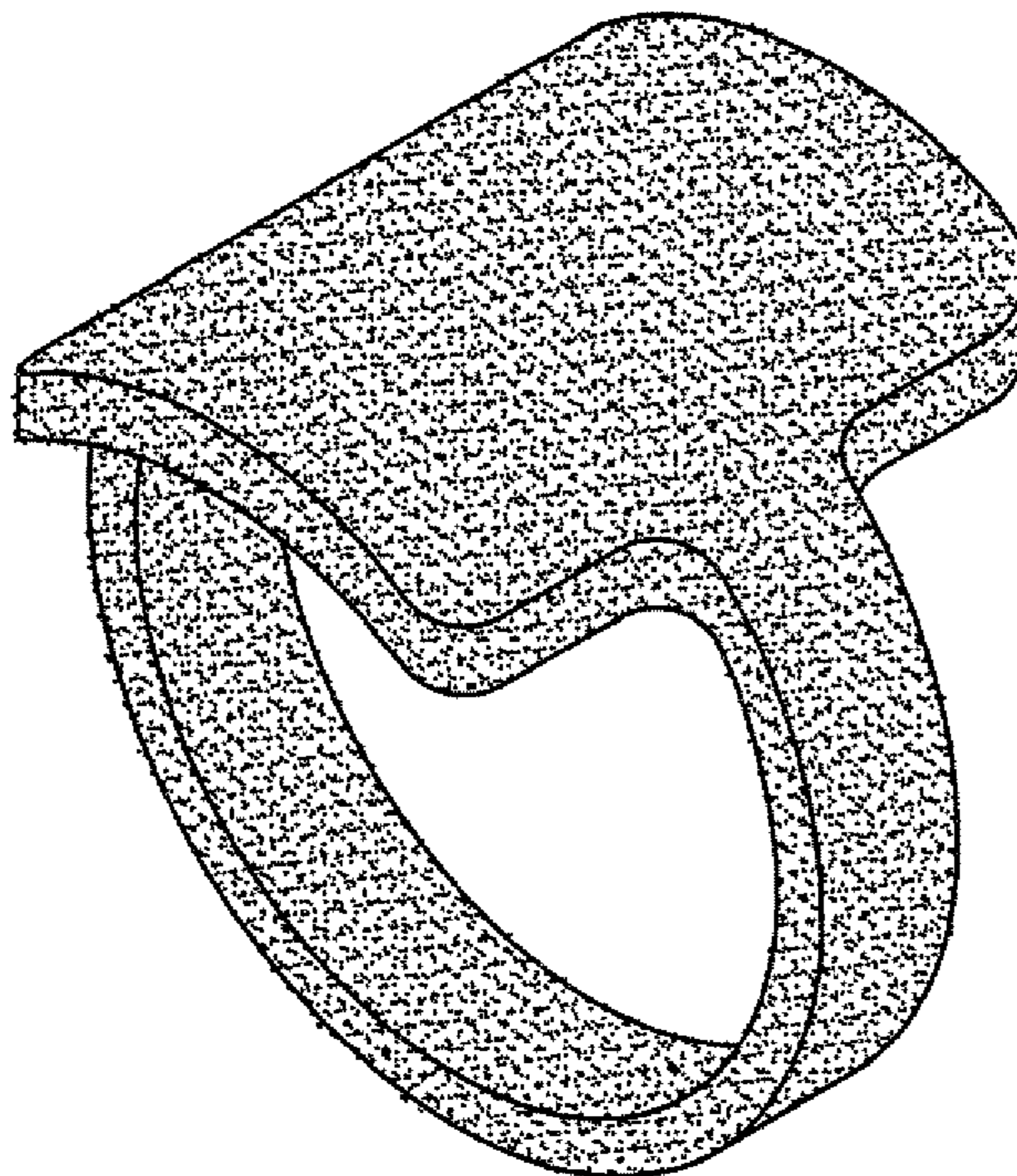
FIG. 2 is a side view of the wristband with writeable and erasable surface of FIG. 1.

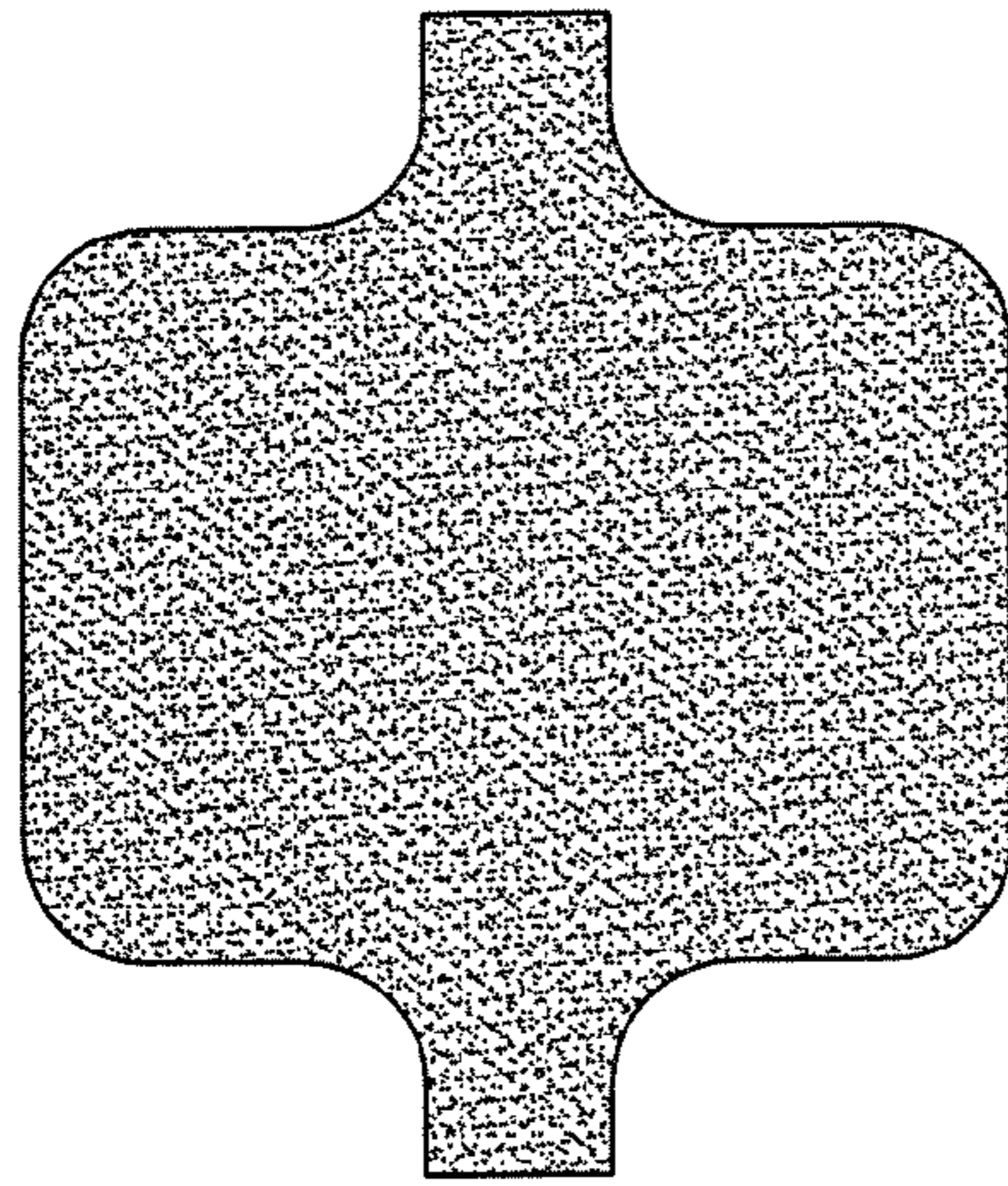

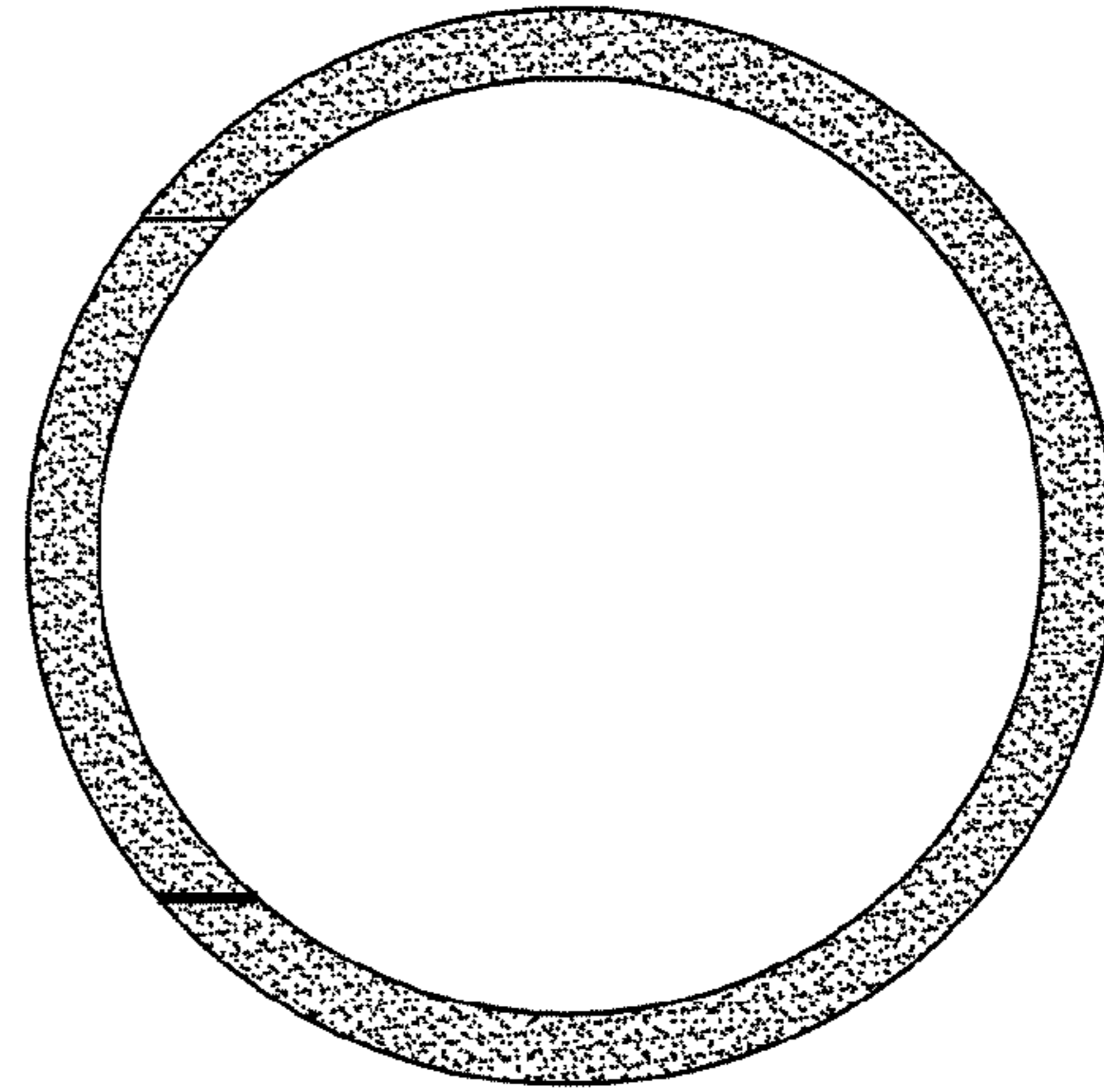

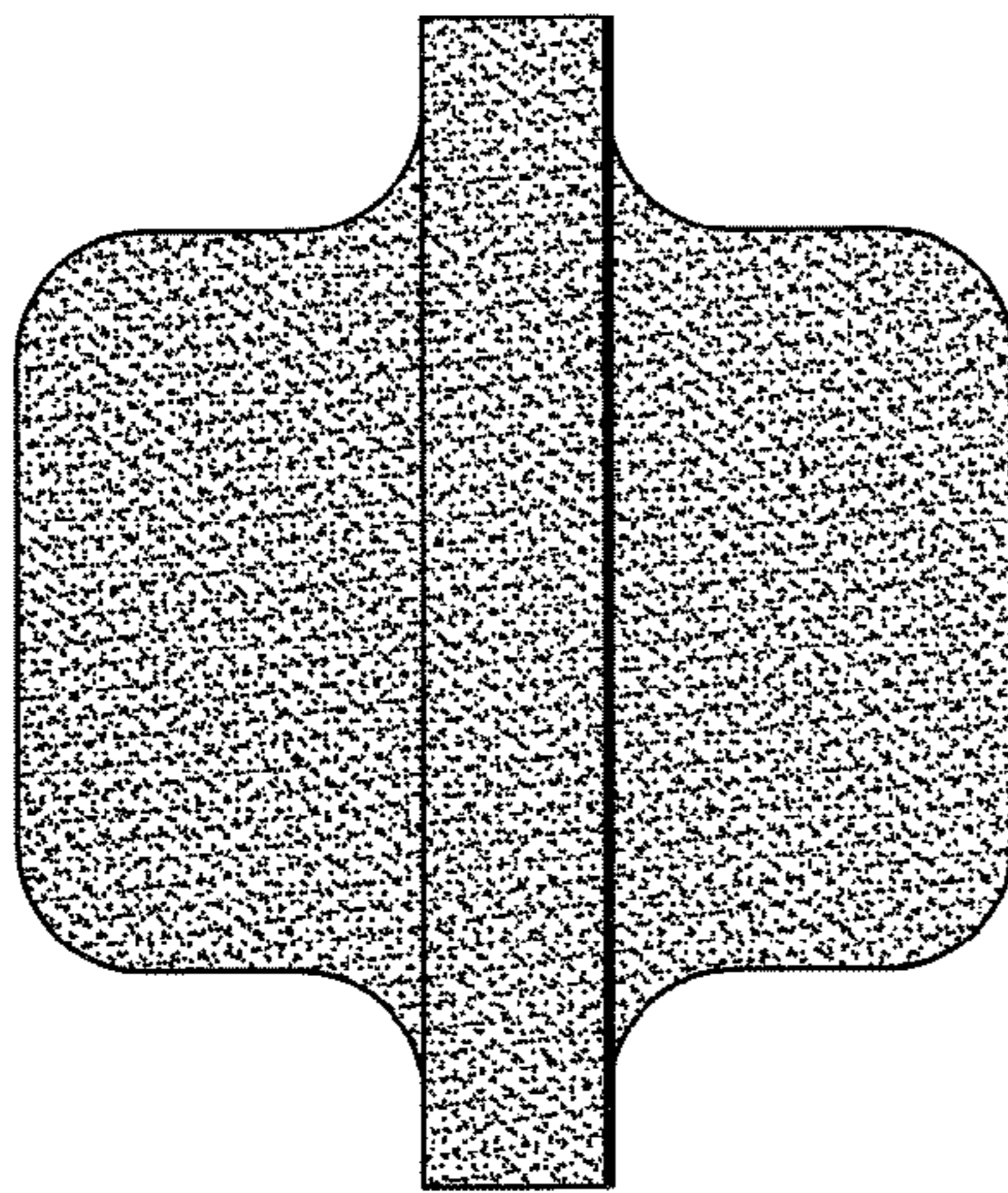

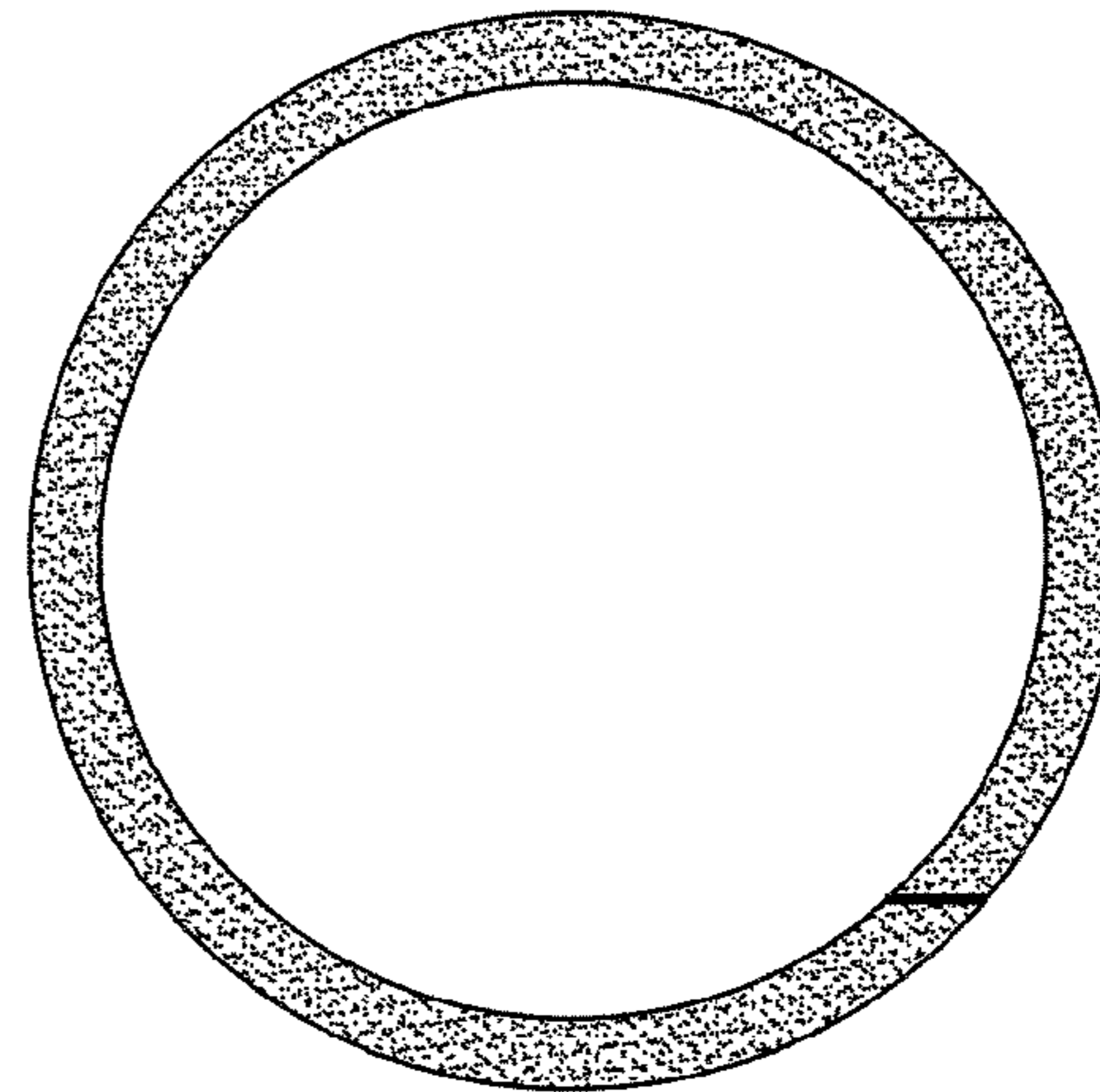

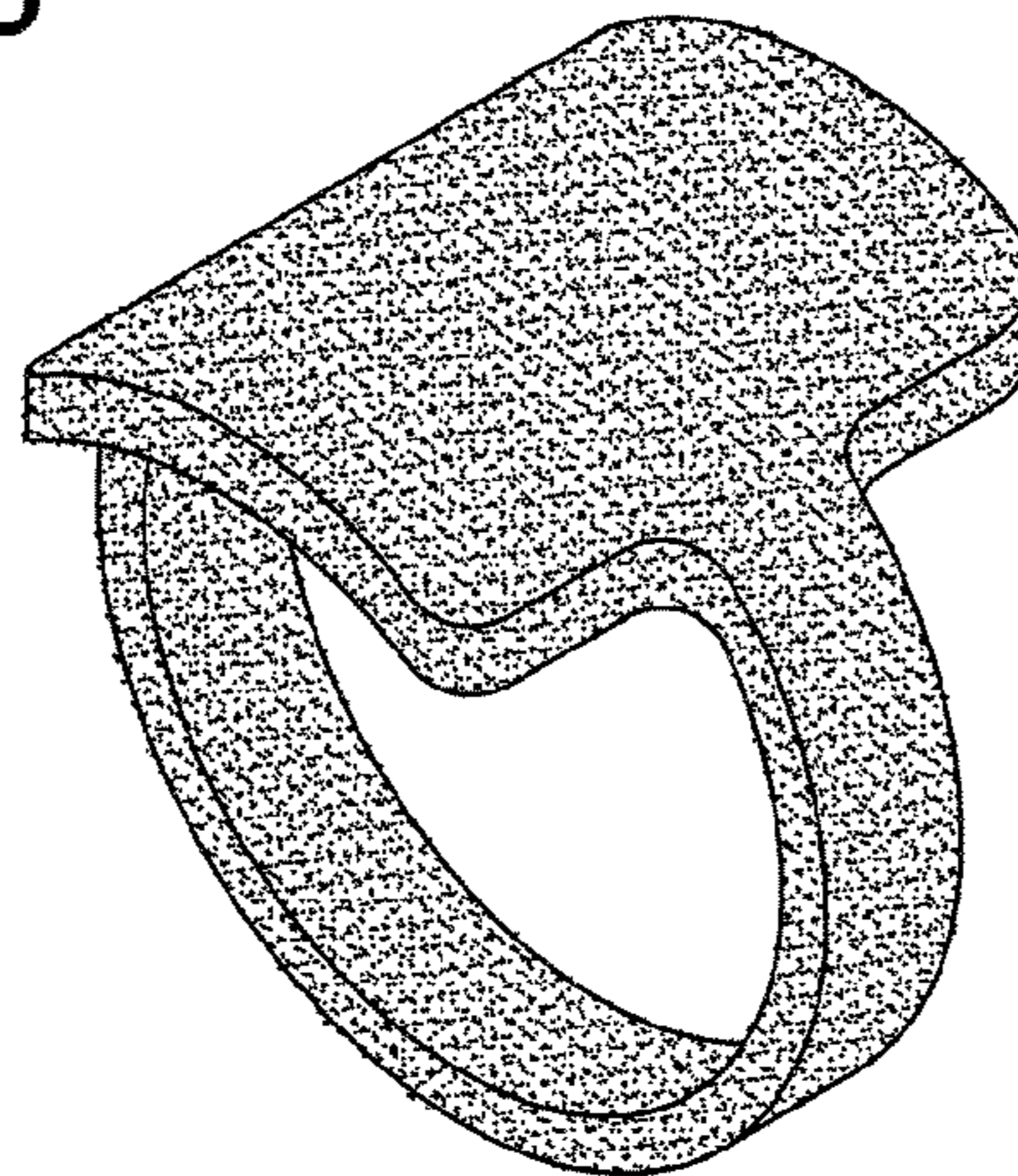
