(57) **CLAIM**

The ornamental design for a drape for use with a tree, a plant, and/or a decorative ornament, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the drape for use with a tree, a plant, and/or a decorative ornament showing my design thereof;

FIG. 2 is a back view thereof;

FIG. 3 is a side view thereof;

FIG. 4 is a bottom view thereof;

FIG. 5 is a top view thereof;

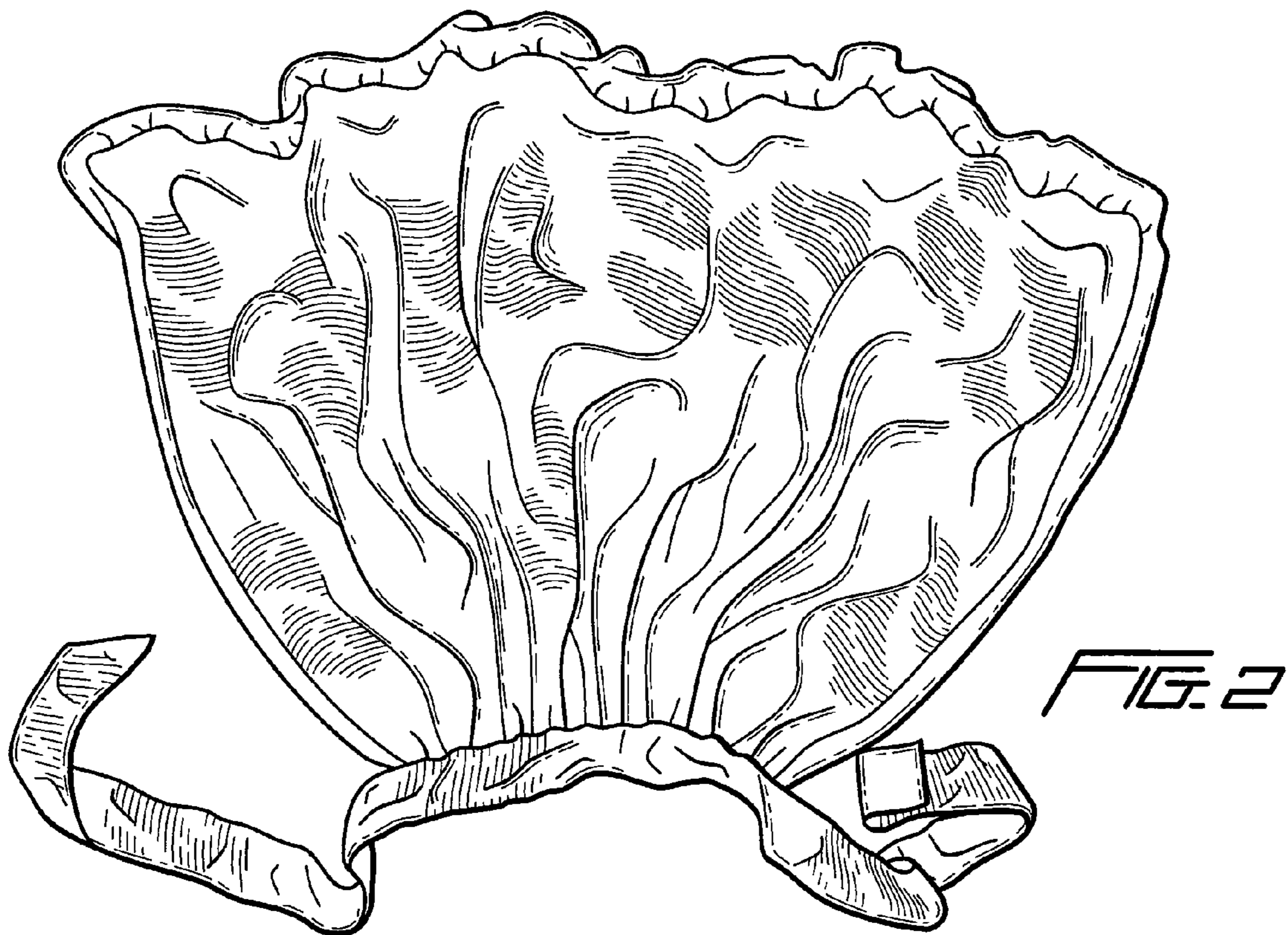
FIG. 6 is a back view of the drape for use with a tree, a plant, and/or a decorative ornament of FIG. 1, used with a tree or a plant; and,

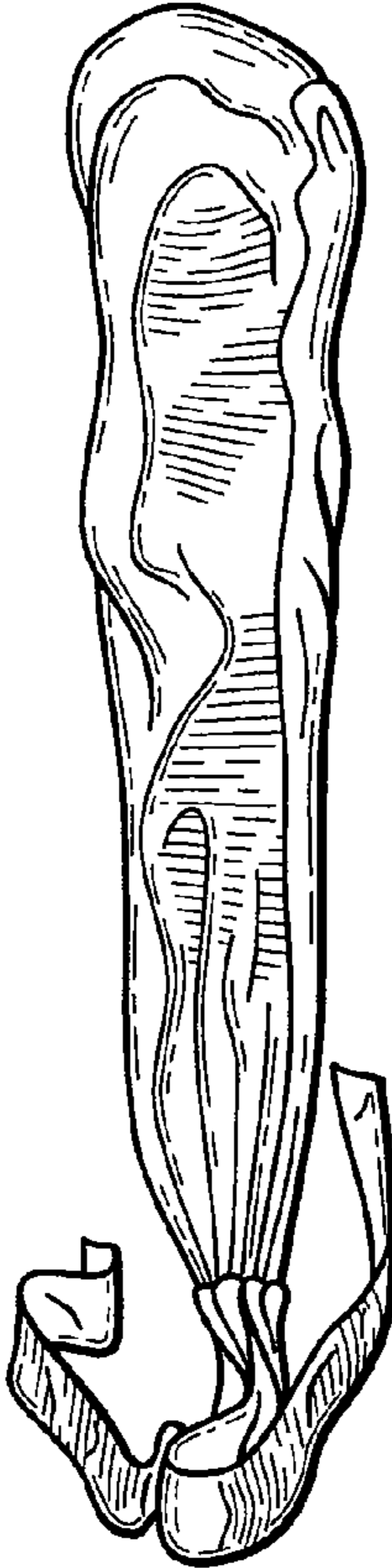

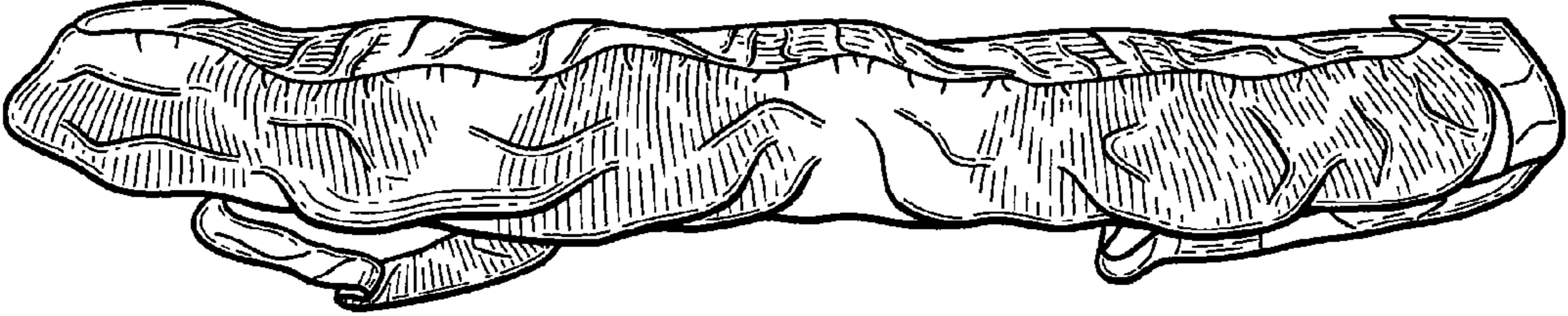

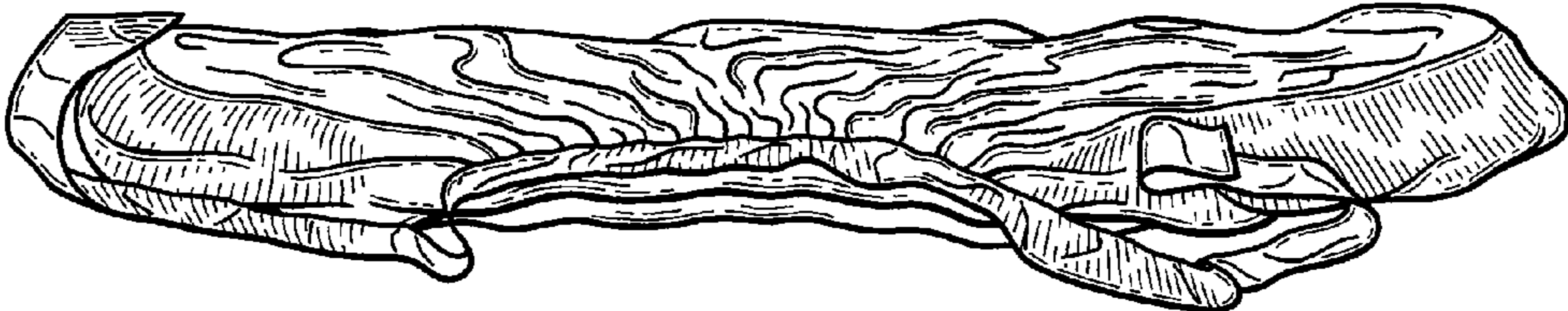

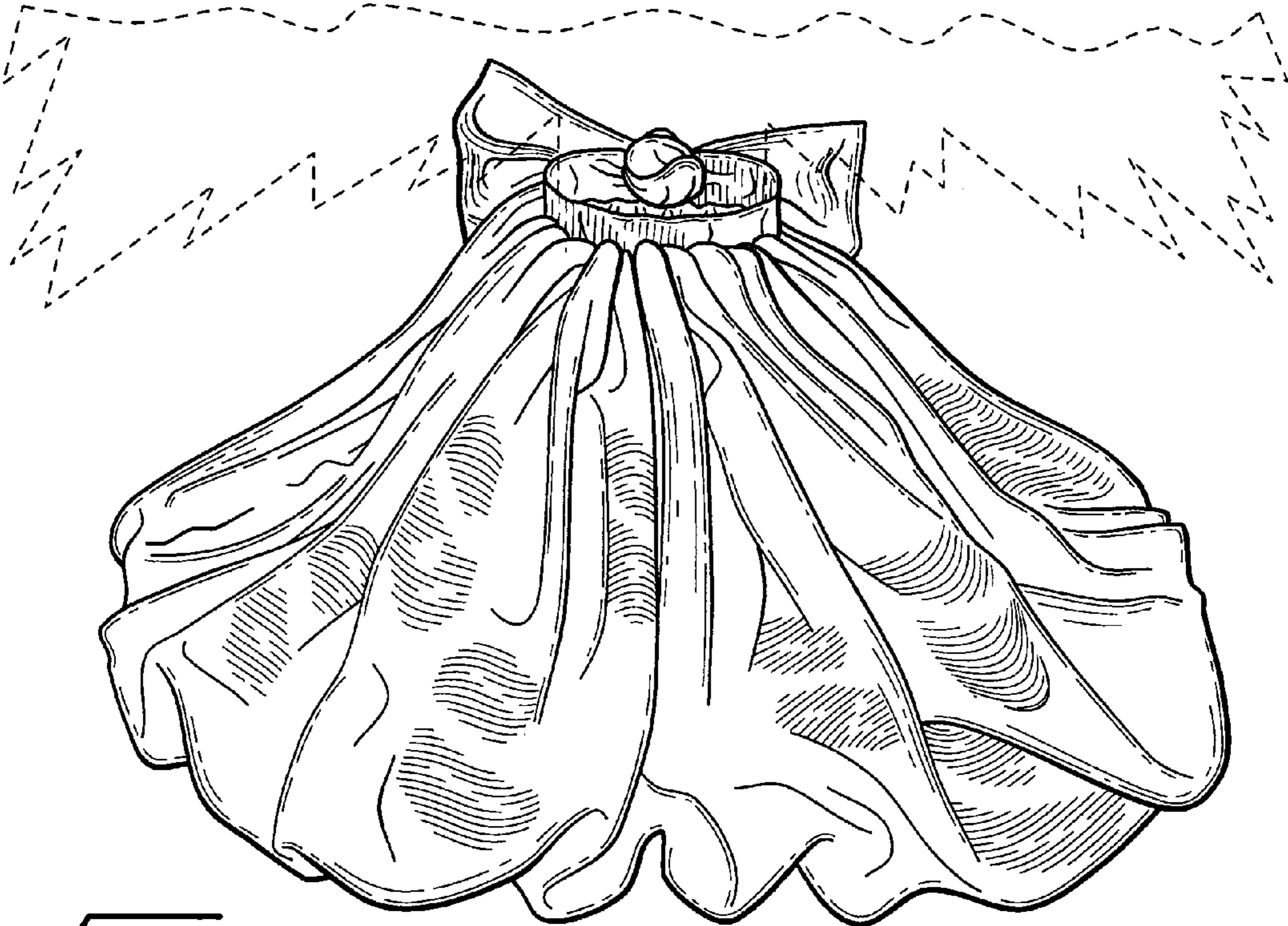

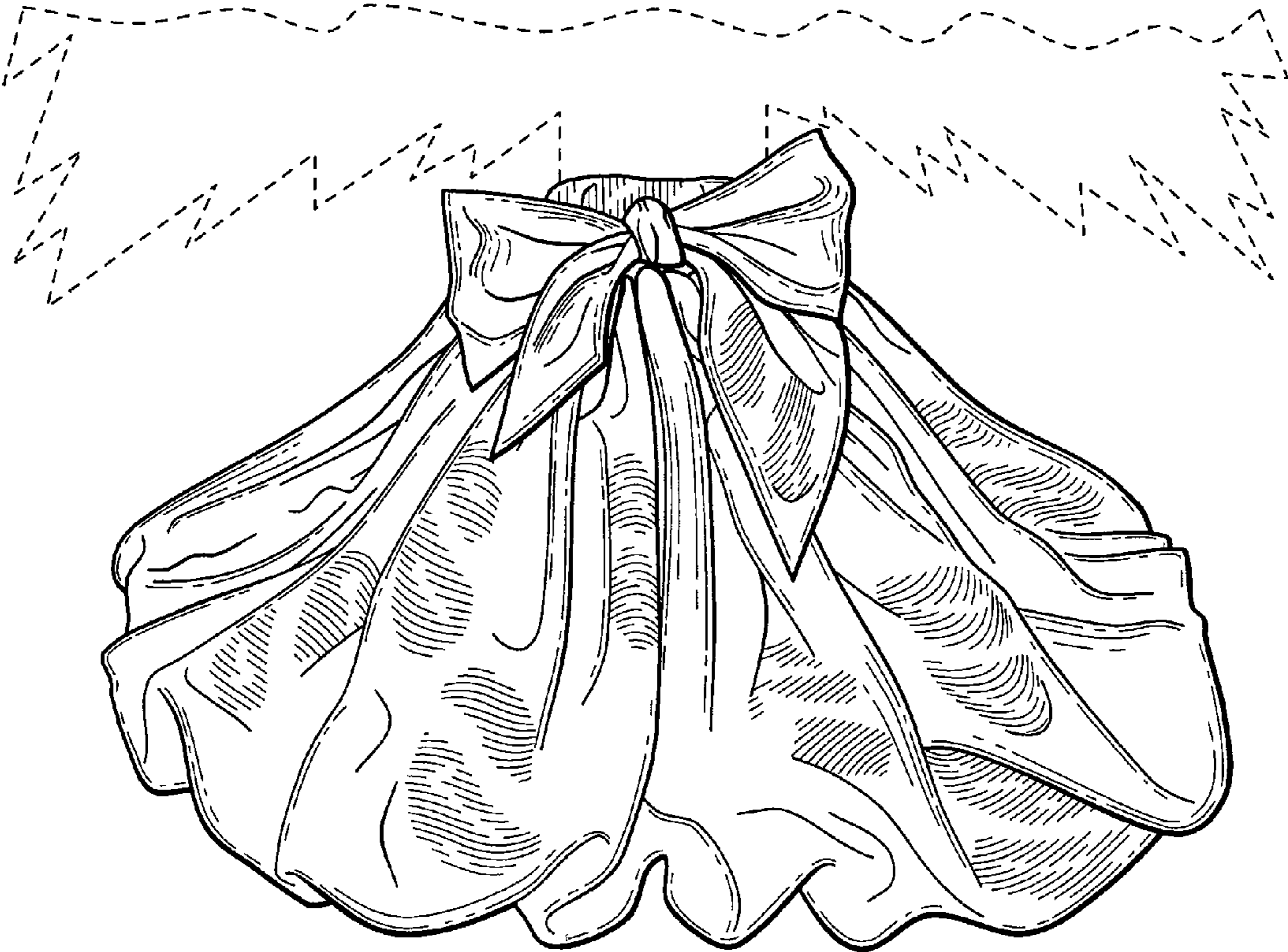
