DESCRIPTION

FIG. 1 is a perspective view of my new design for a tone wheel for automobiles;

FIG. 5 is a right side view of the tone wheel for automobiles of FIG. 1;

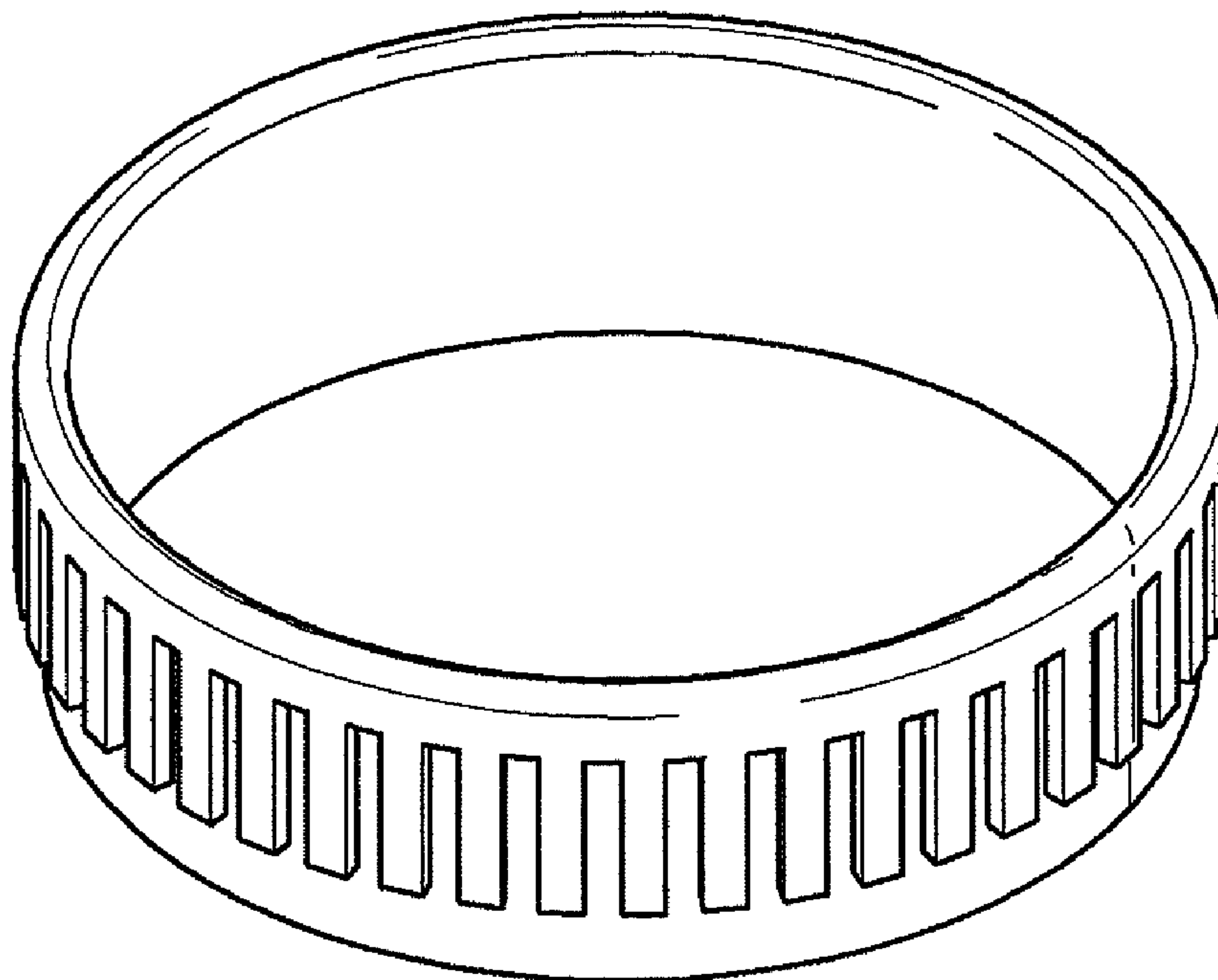
FIG. 6 is a top view of the tone wheel for automobiles of FIG. 1;

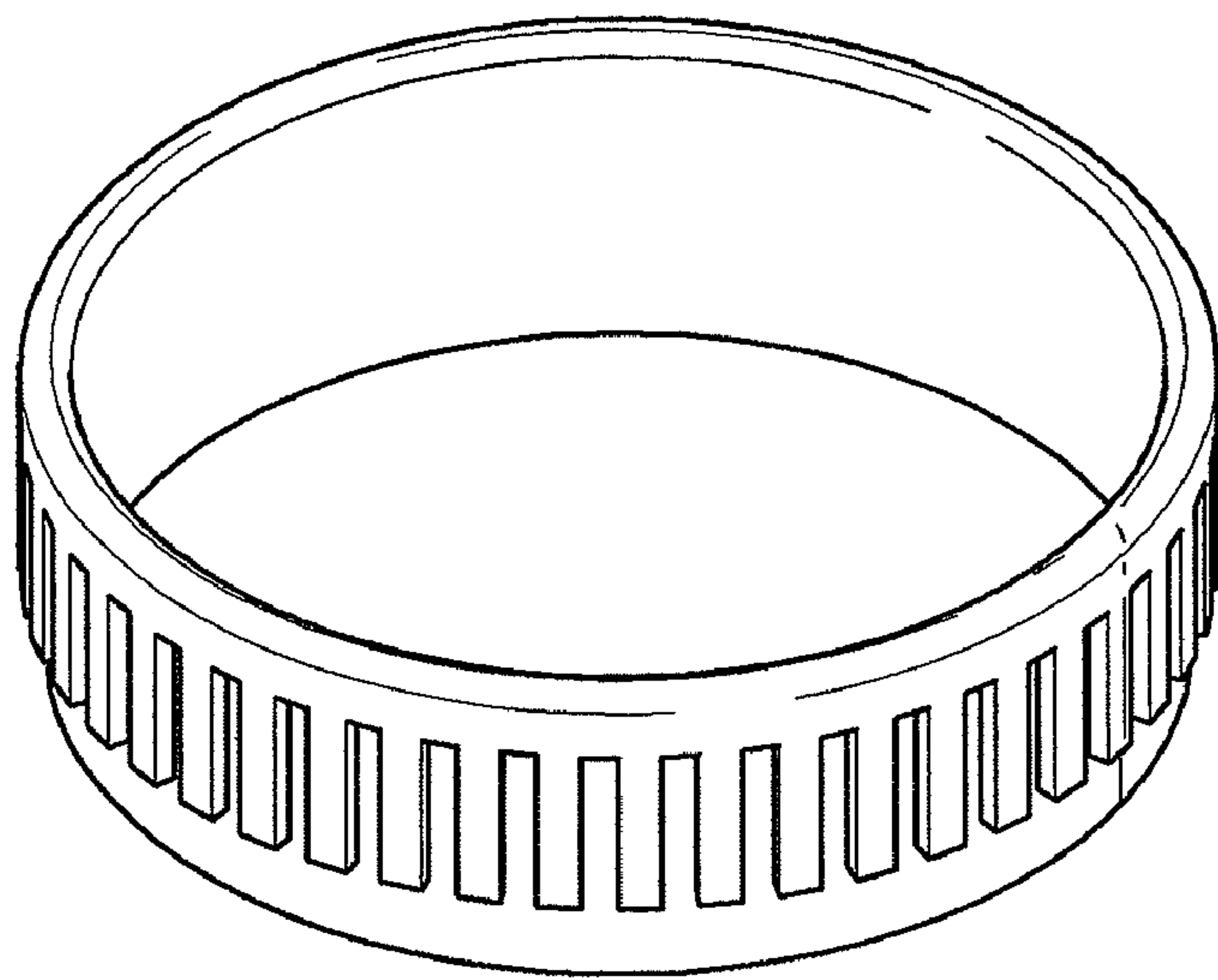

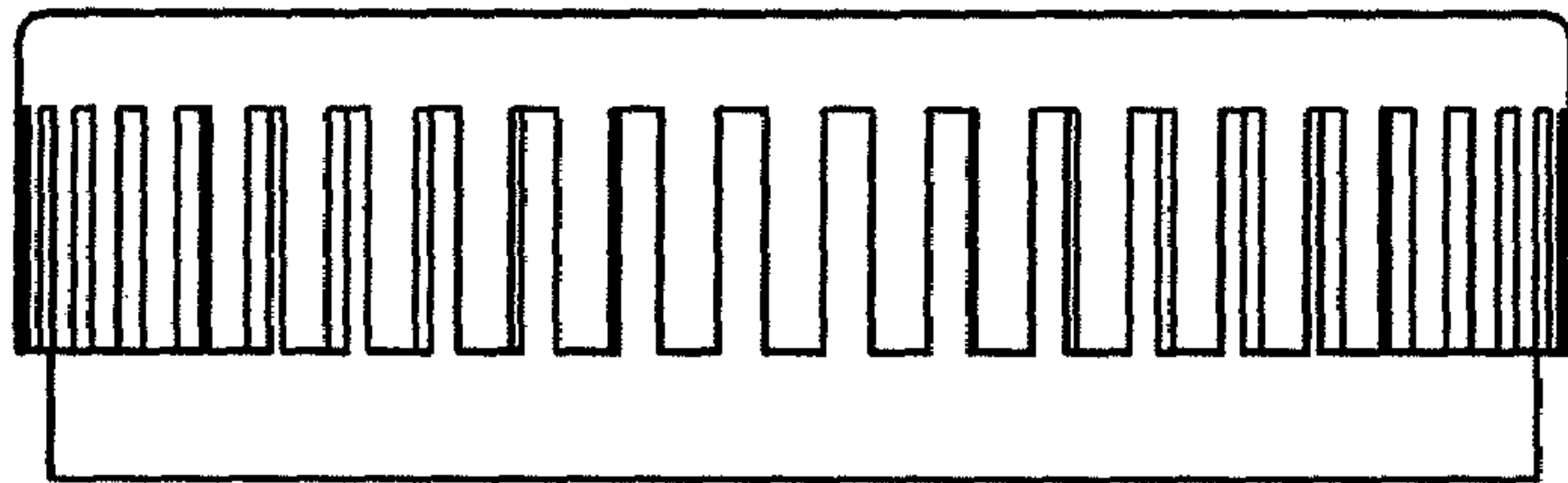

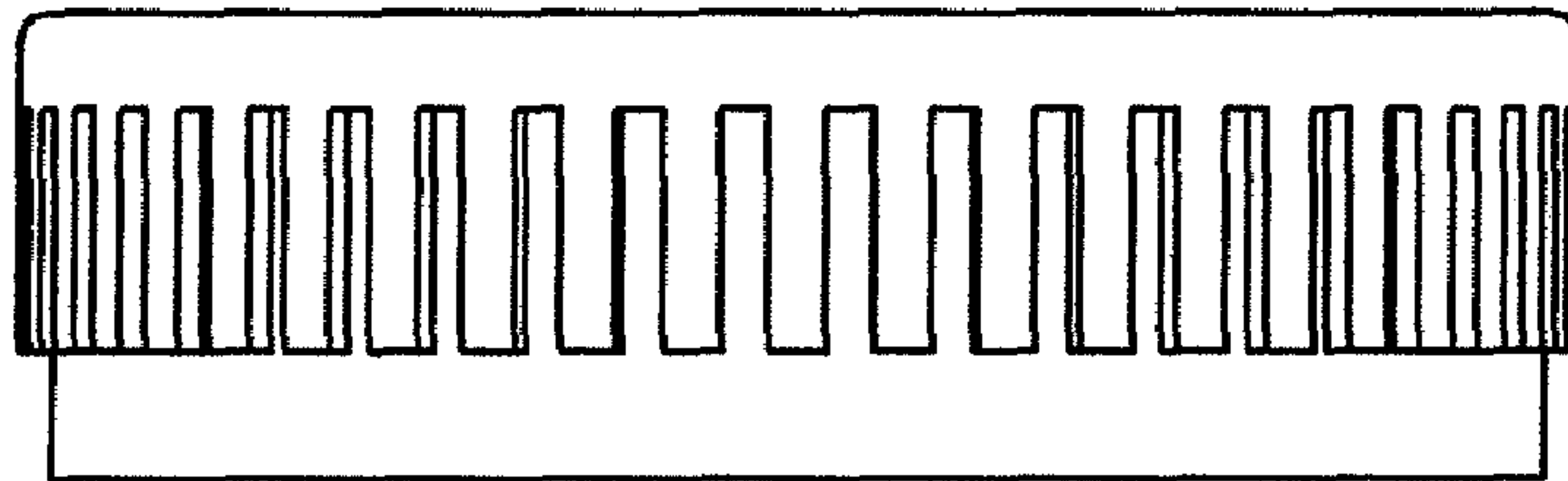

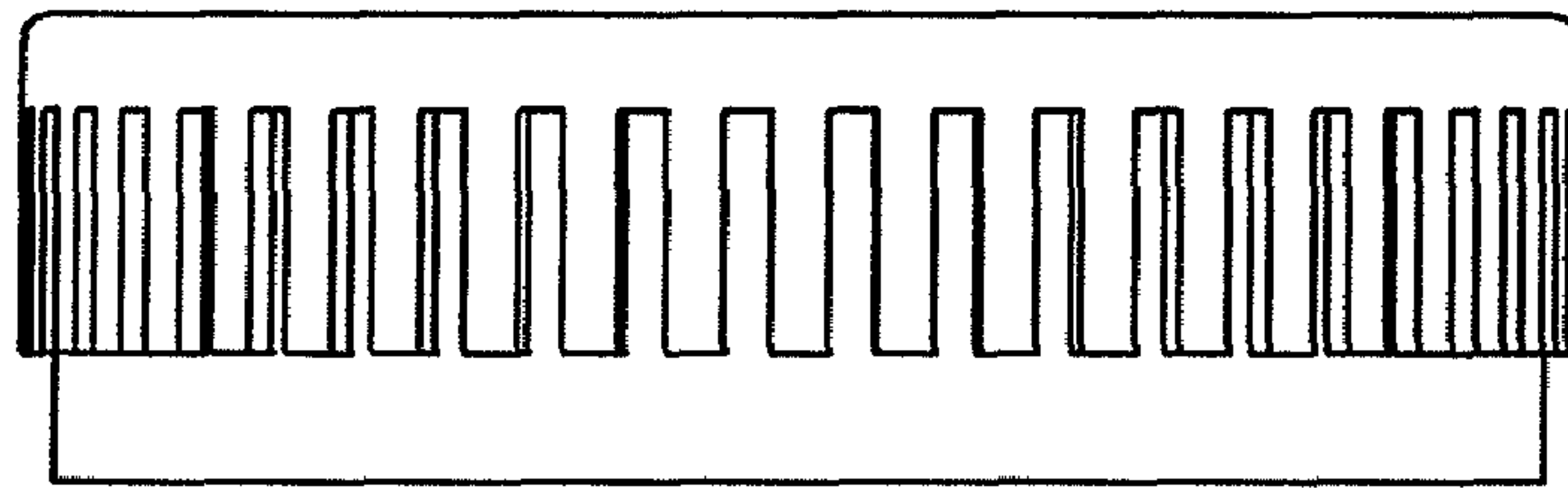

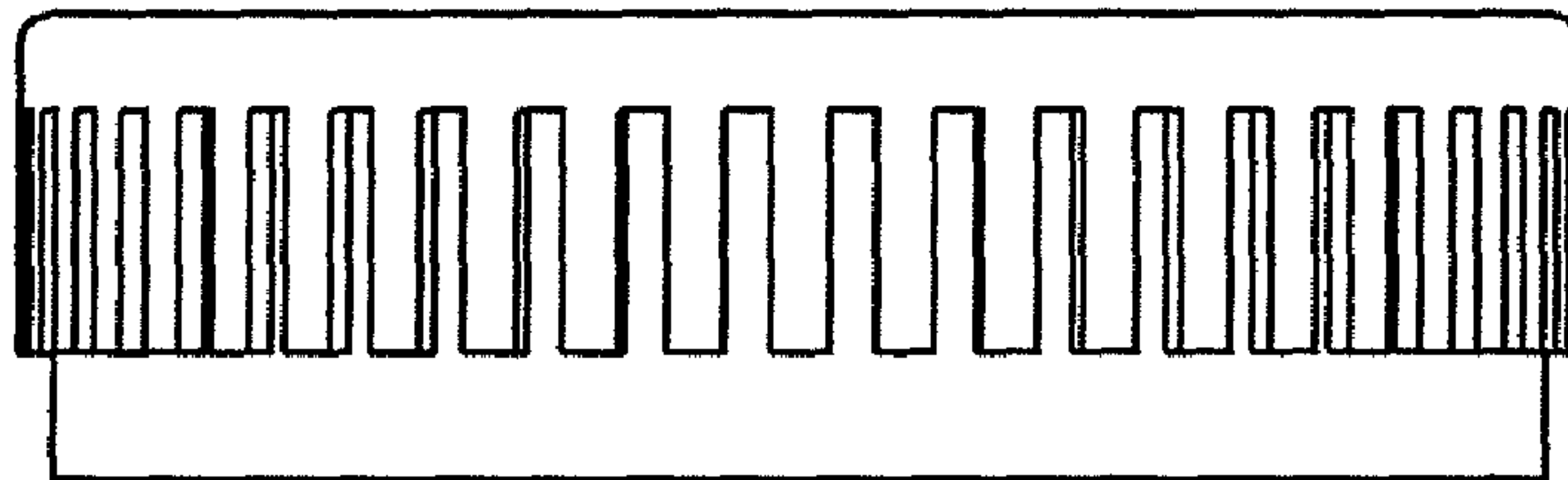

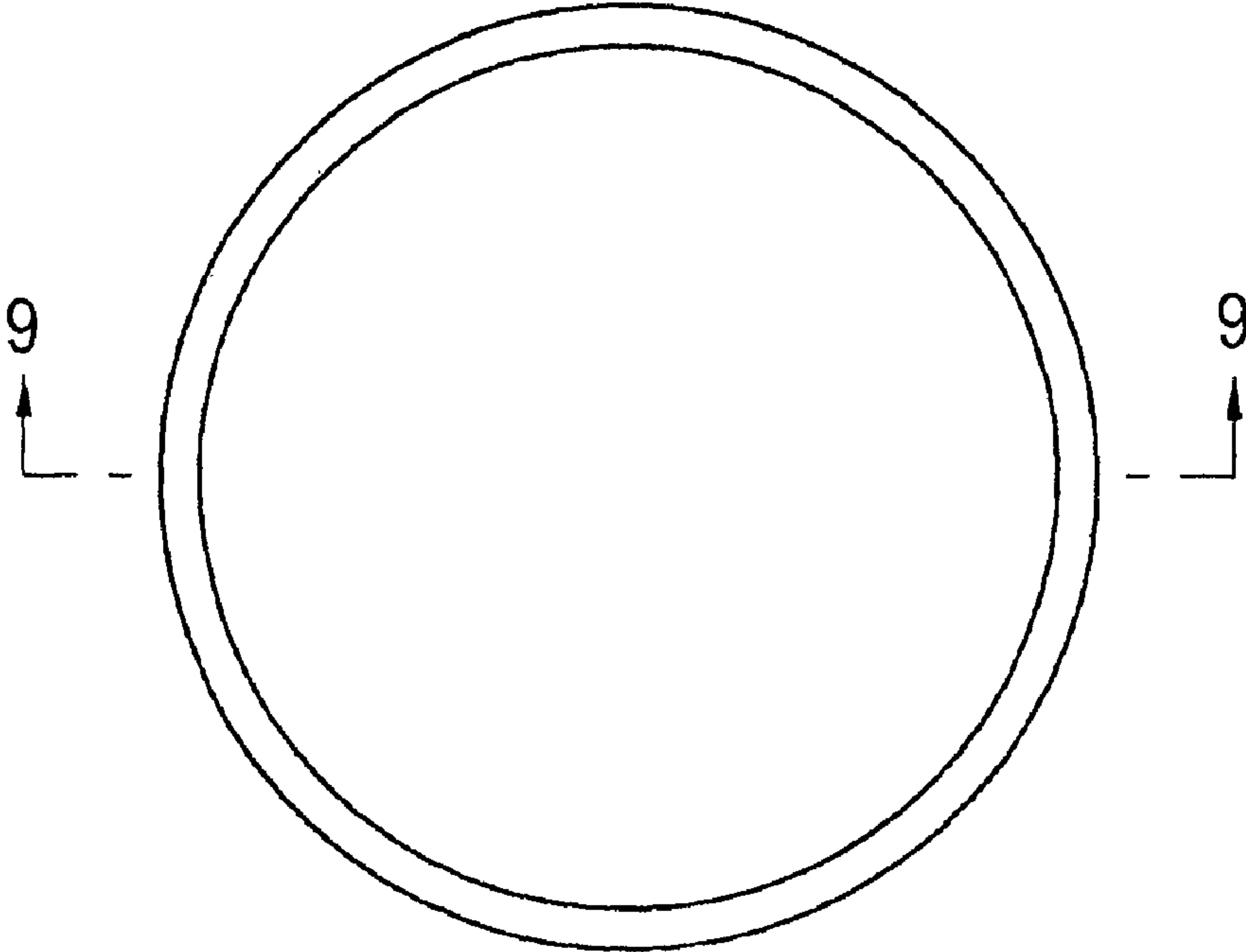

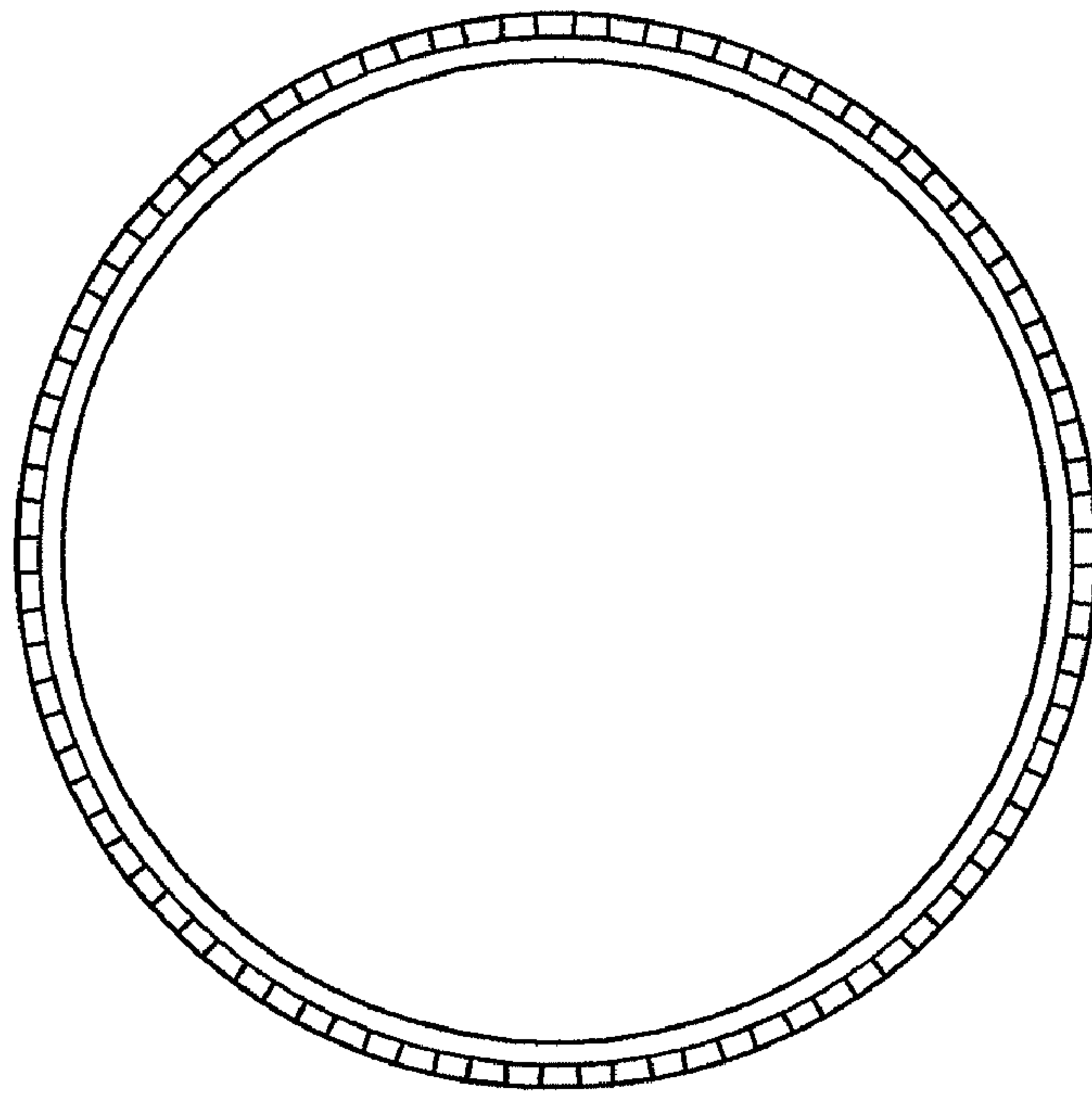

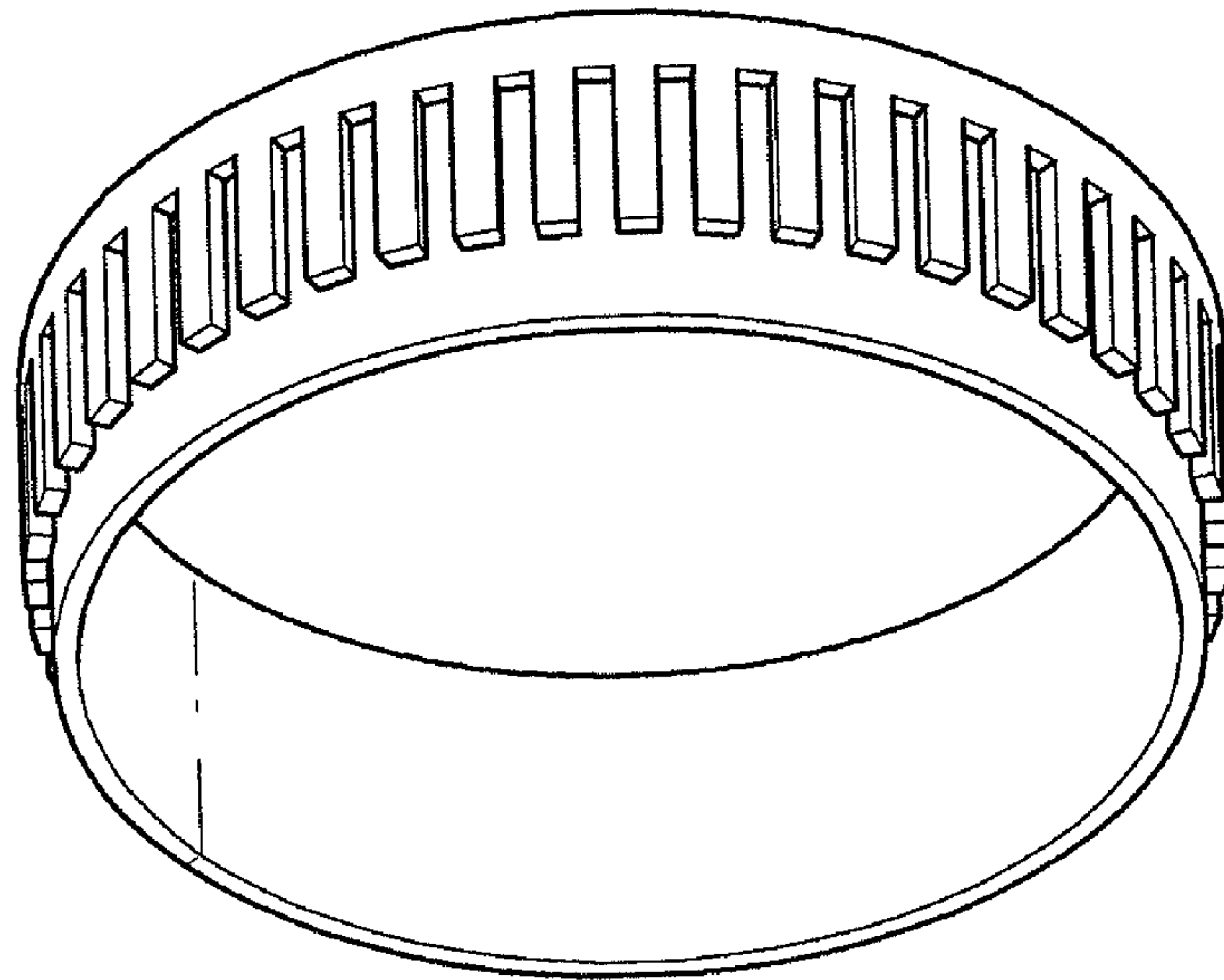

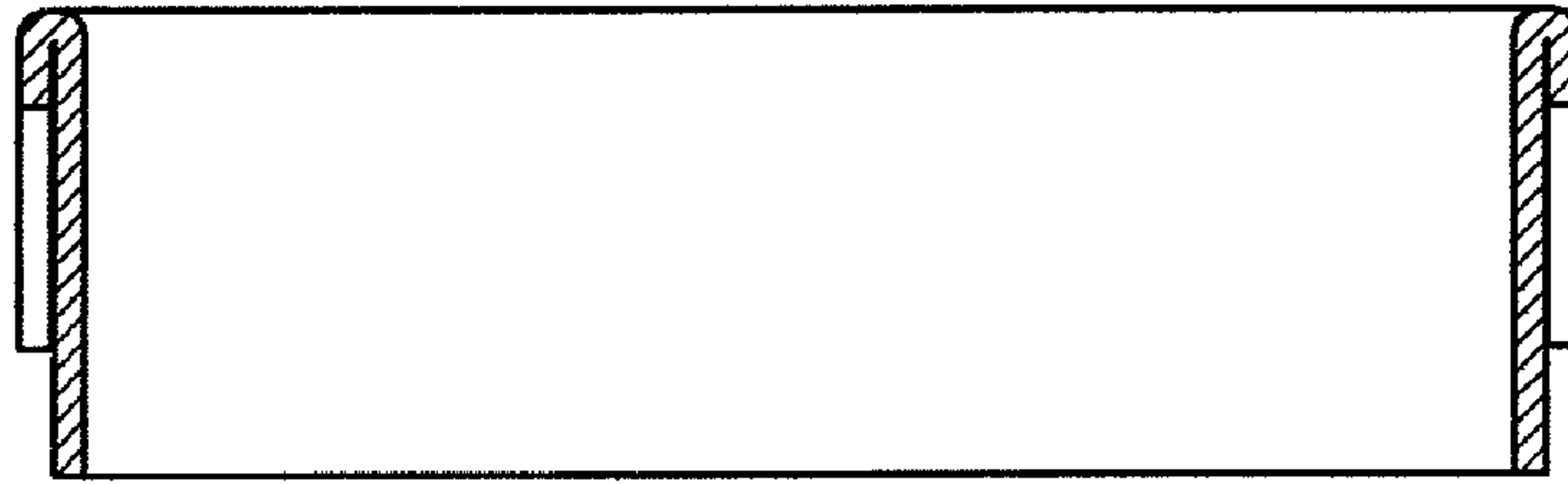
