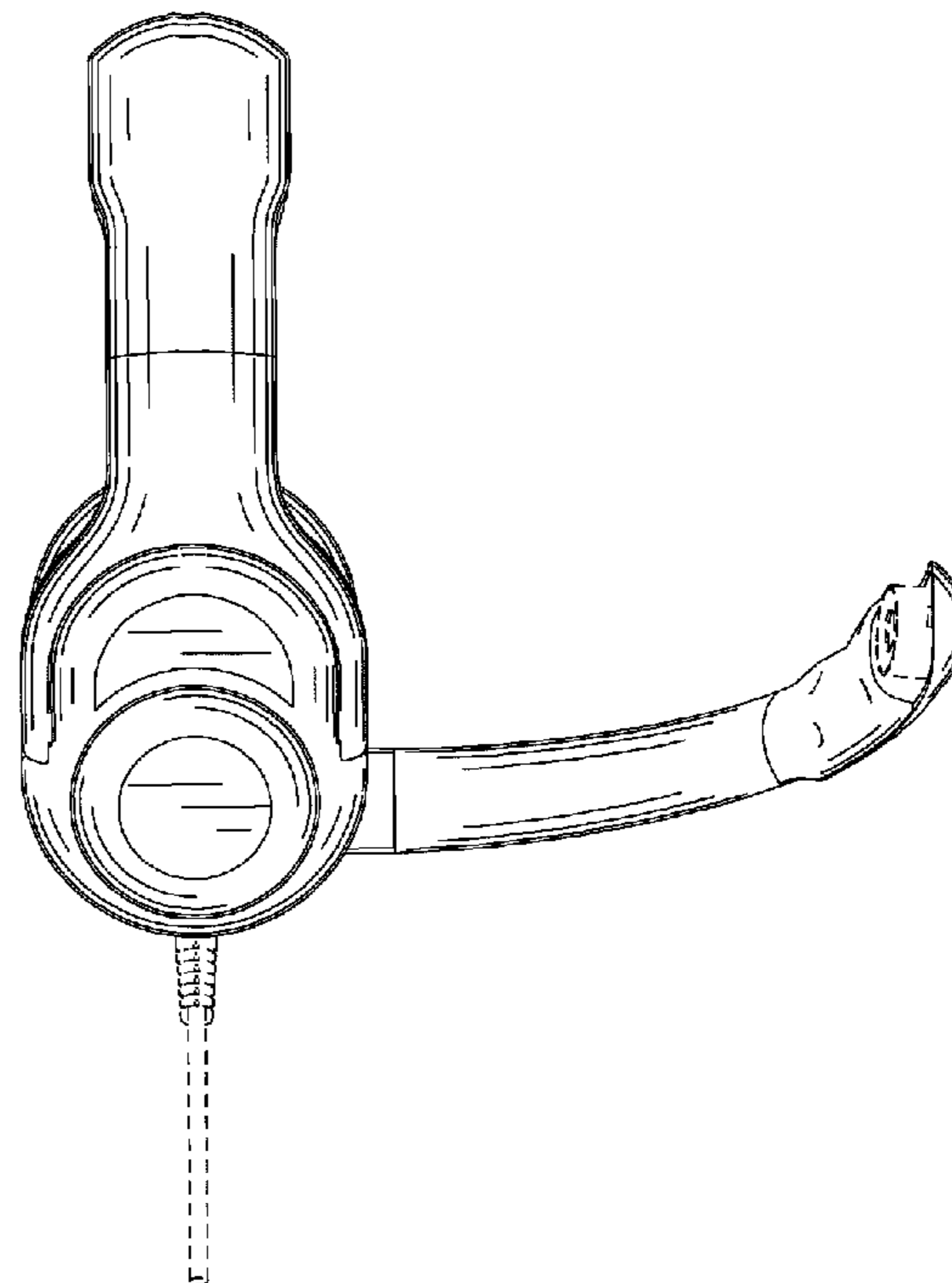
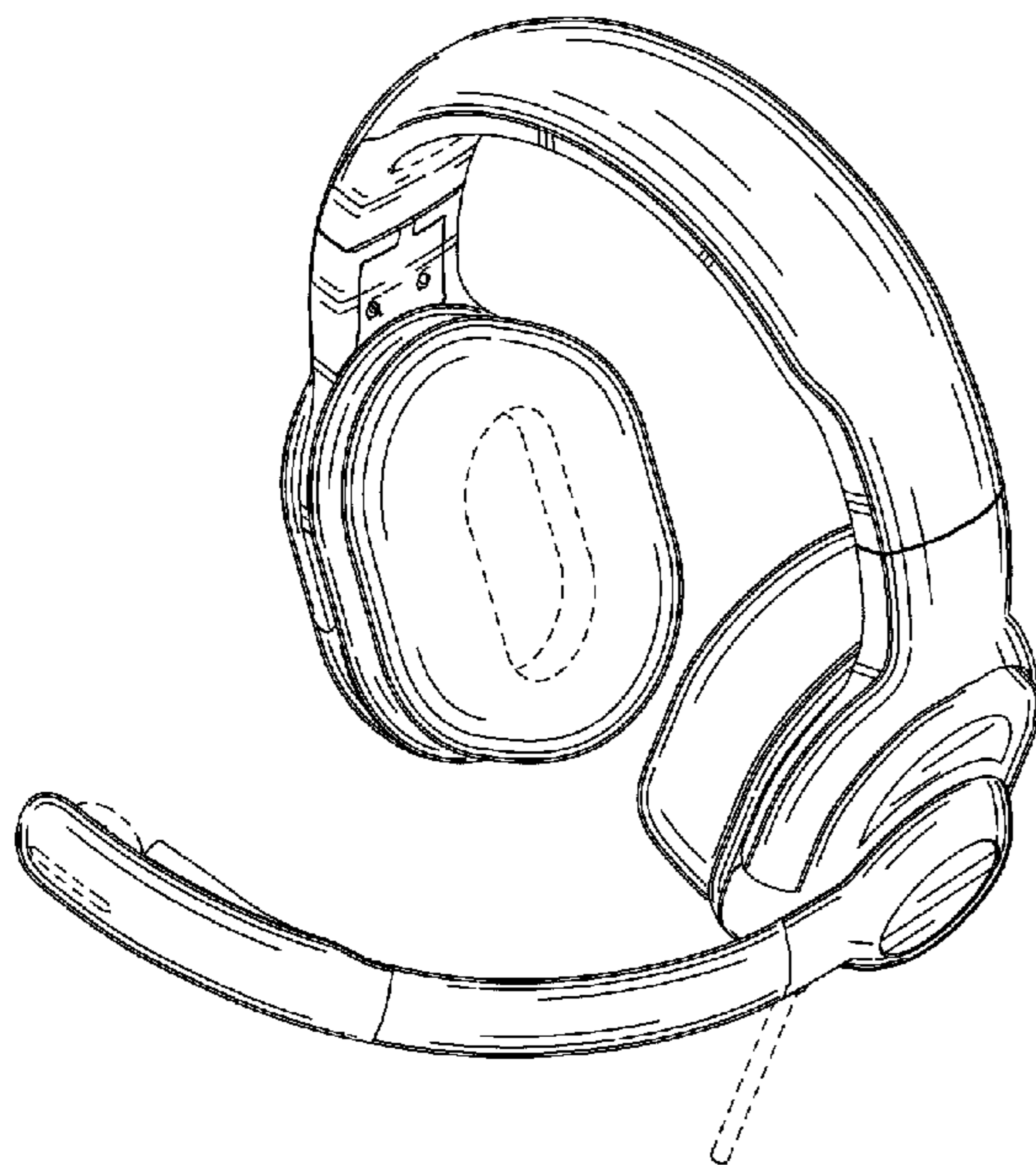
The ornamental design for a communication headset, as shown and described.

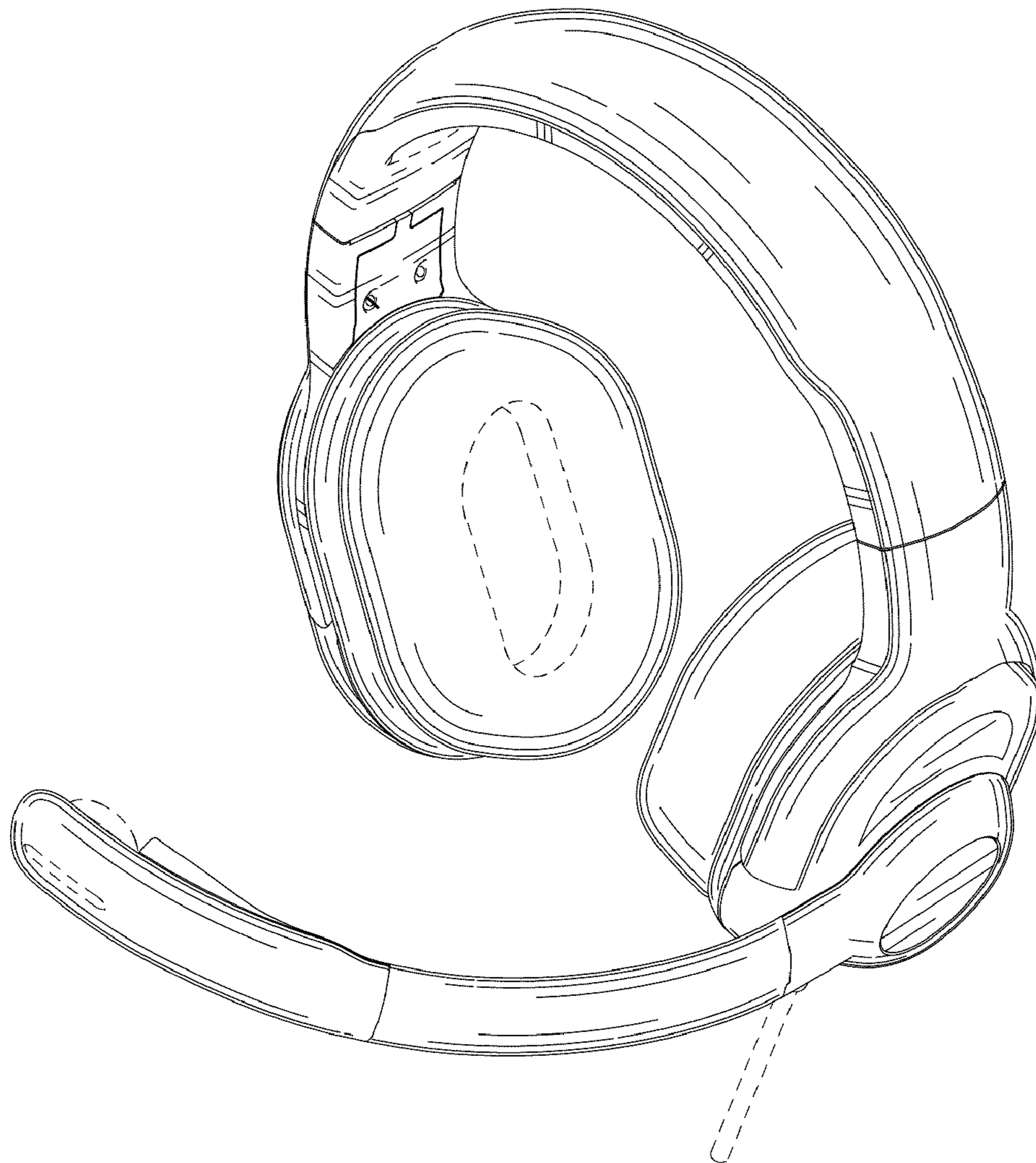

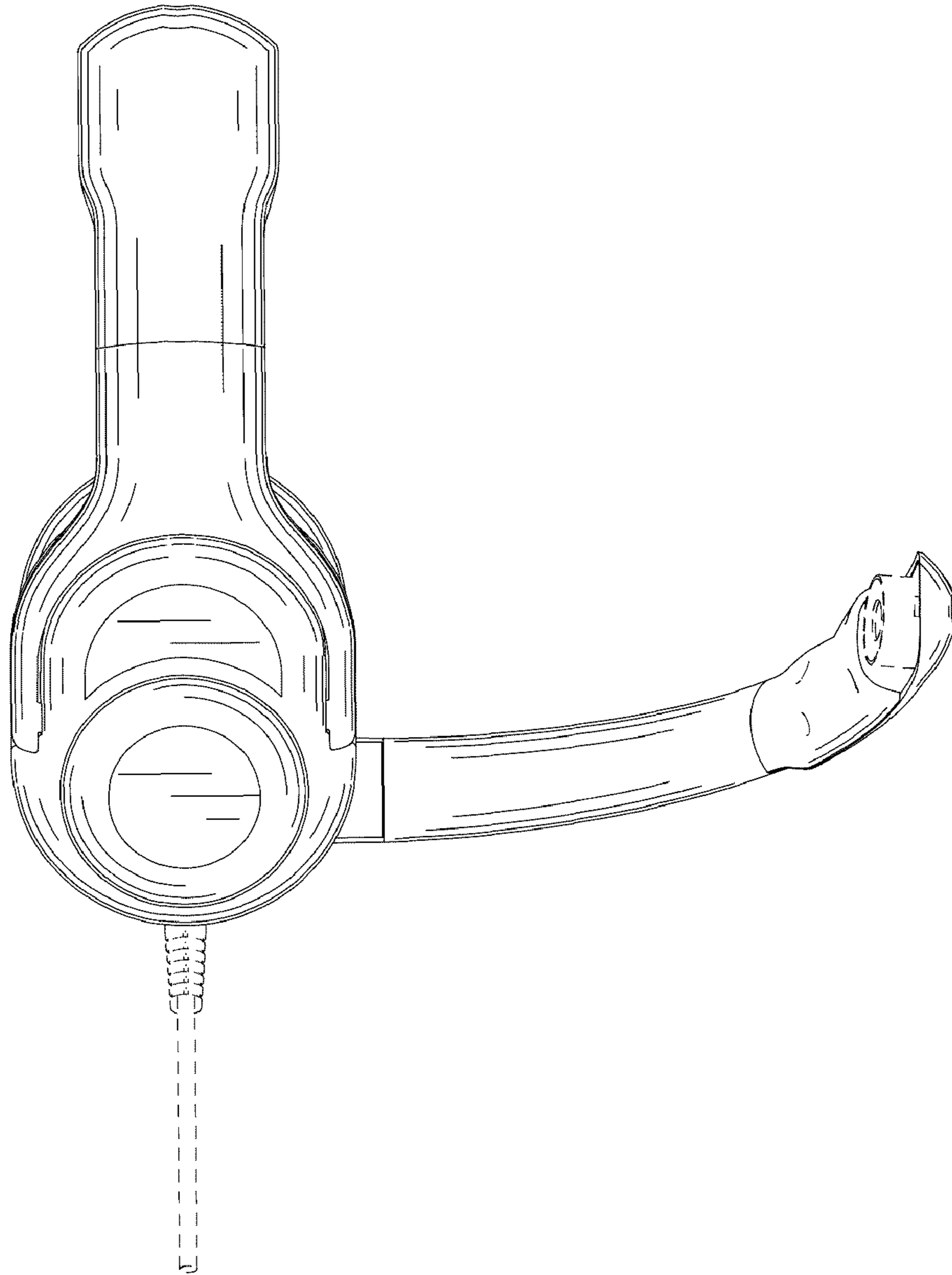

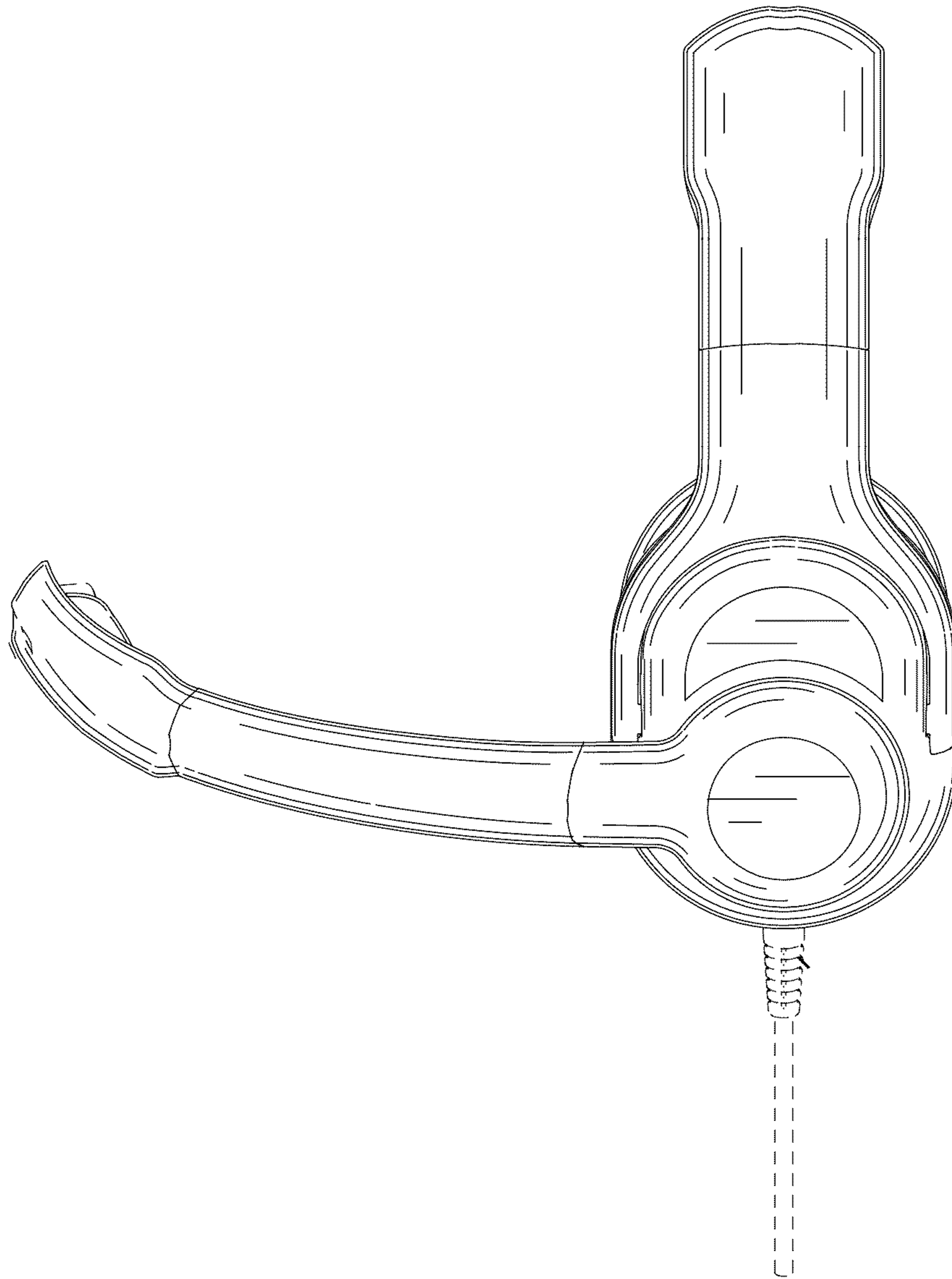

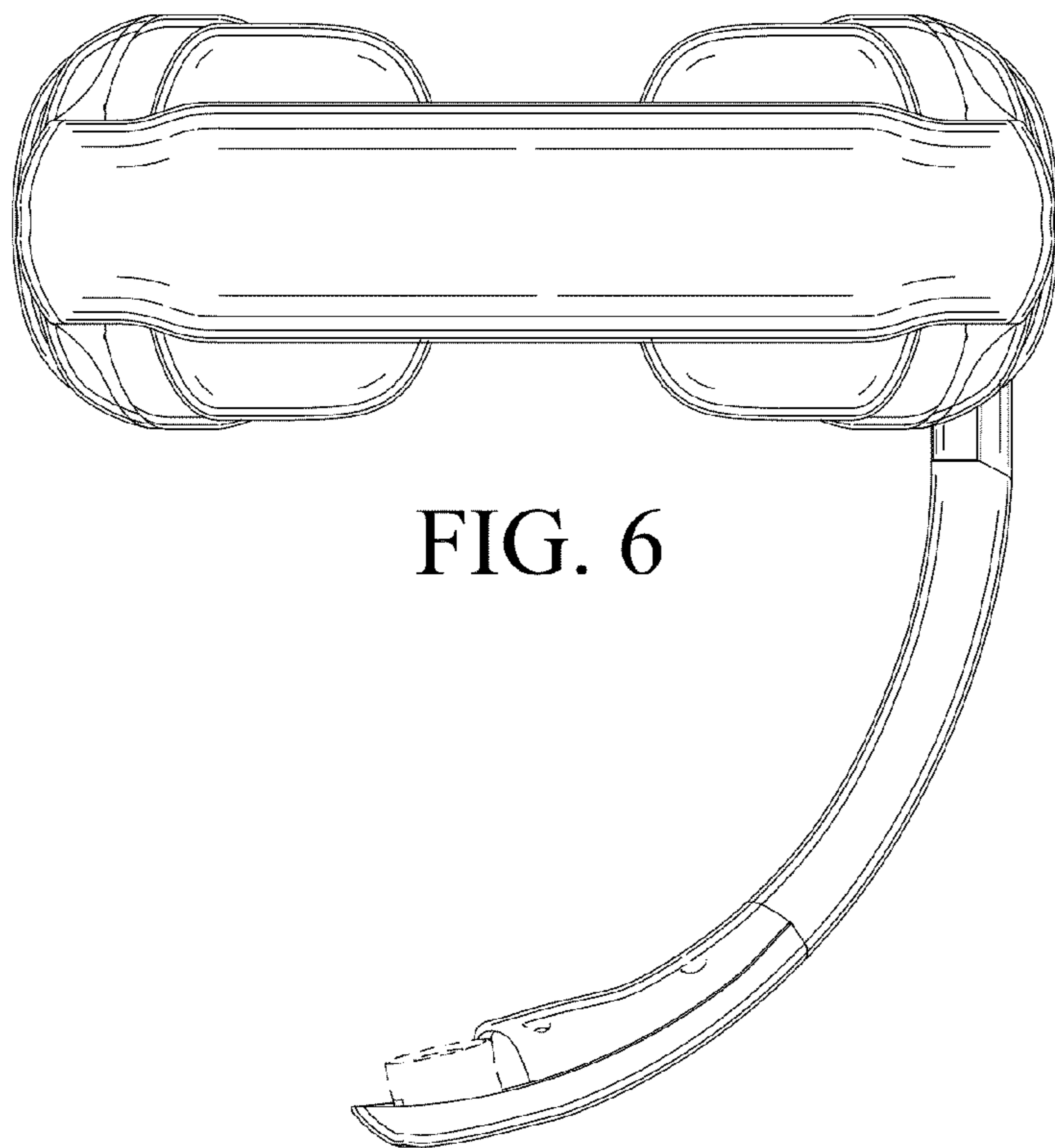

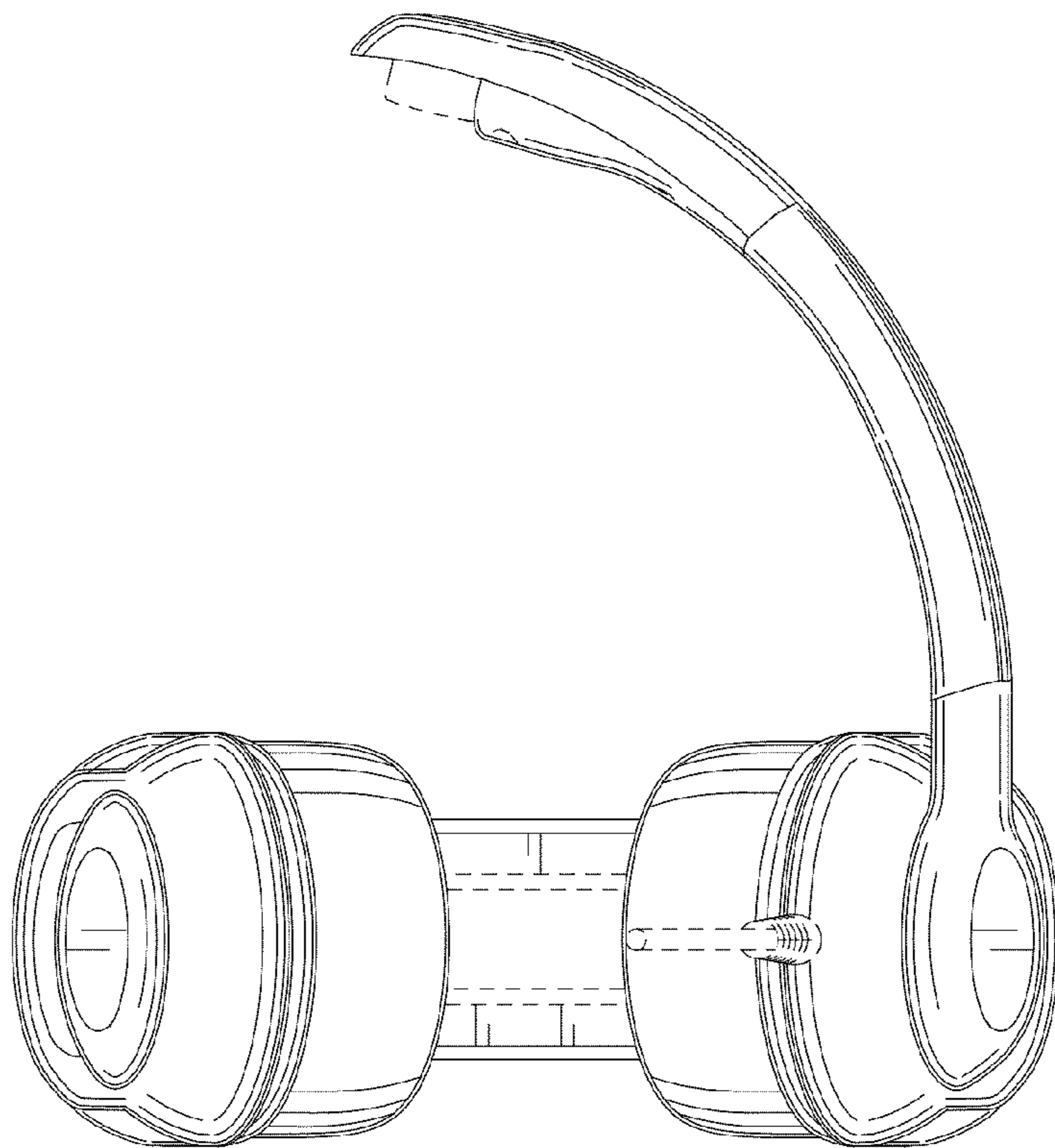
