DESCRIPTION

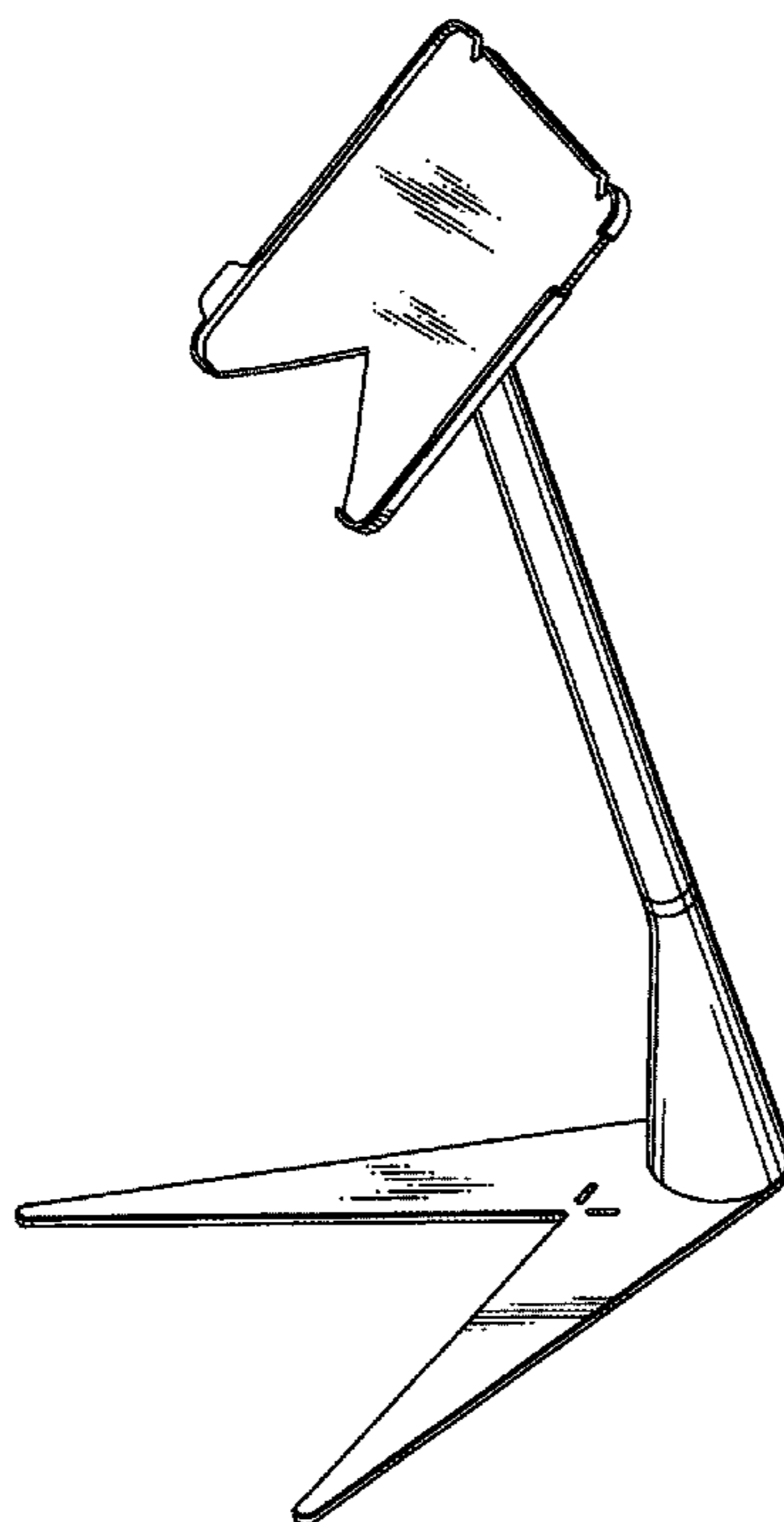
FIG. 1 is a perspective view of a holder for a flat computer in accordance with my design;

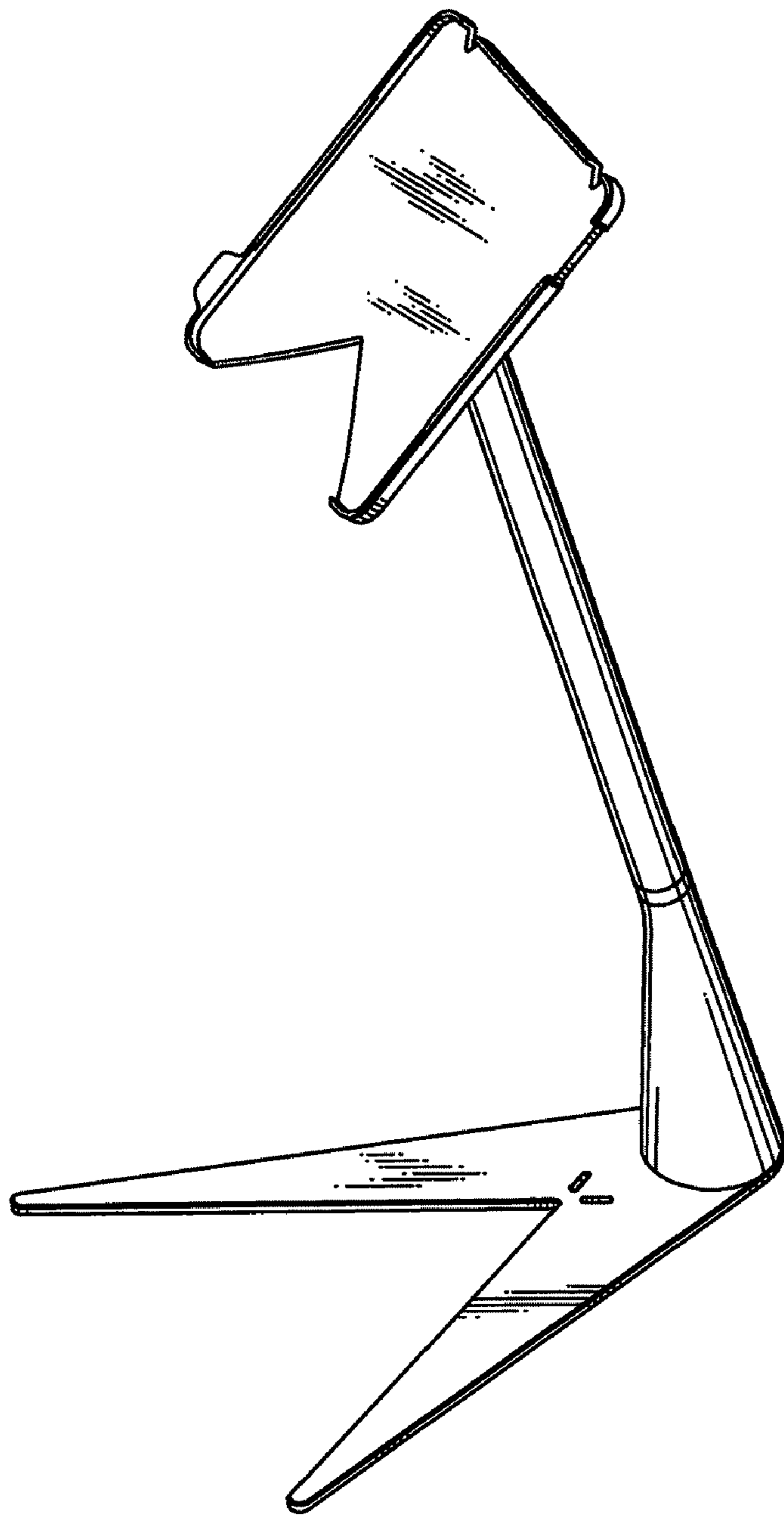

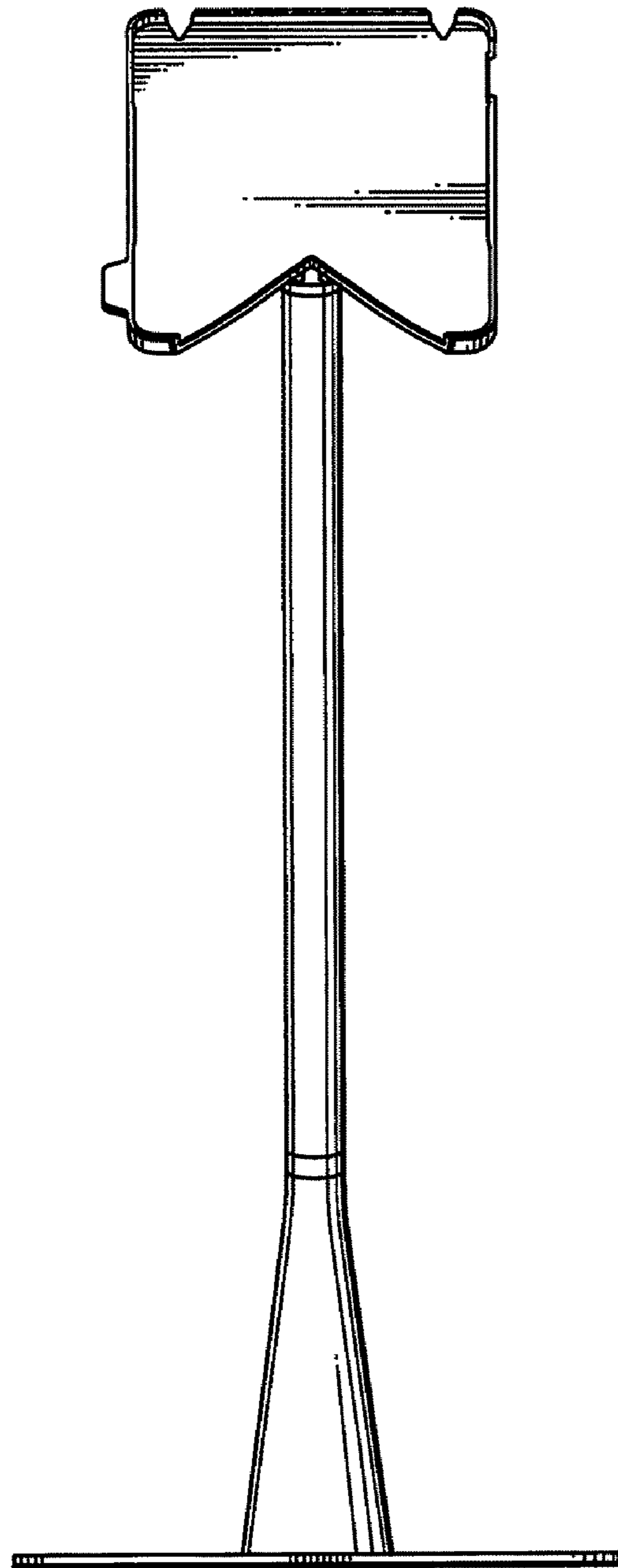

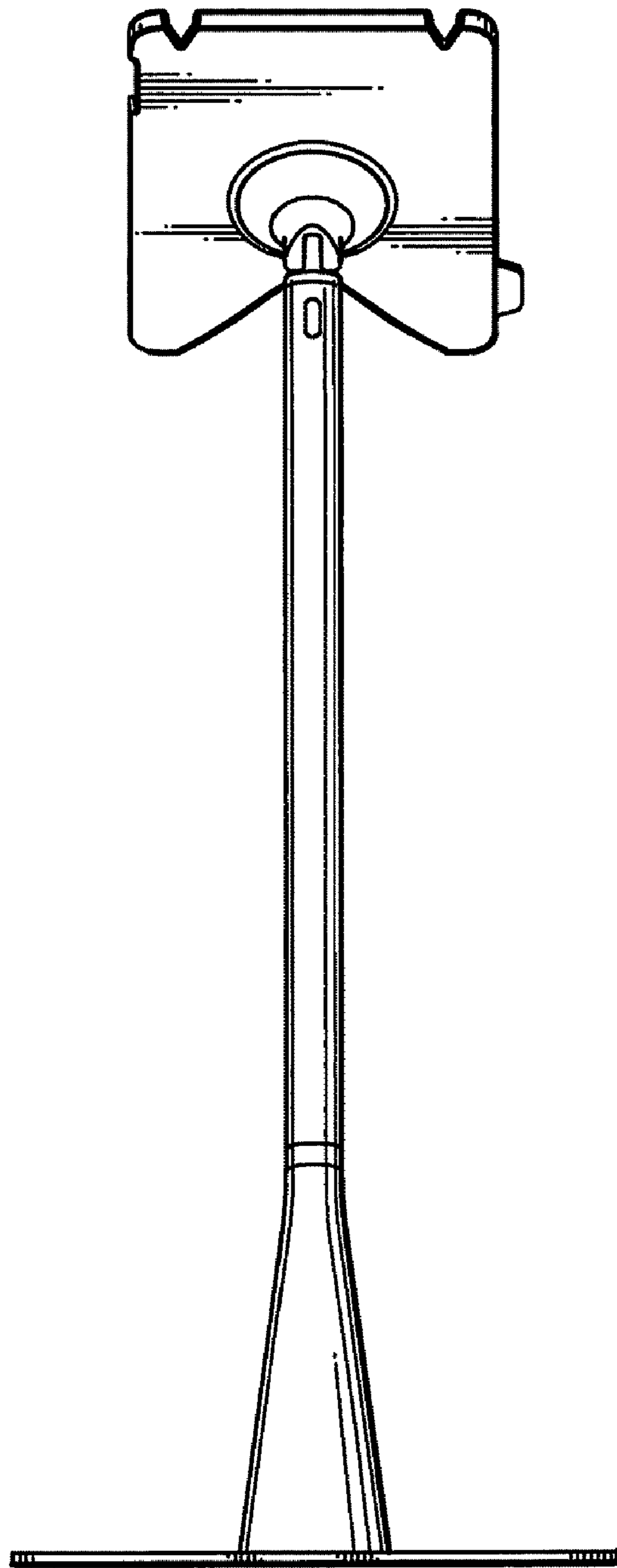

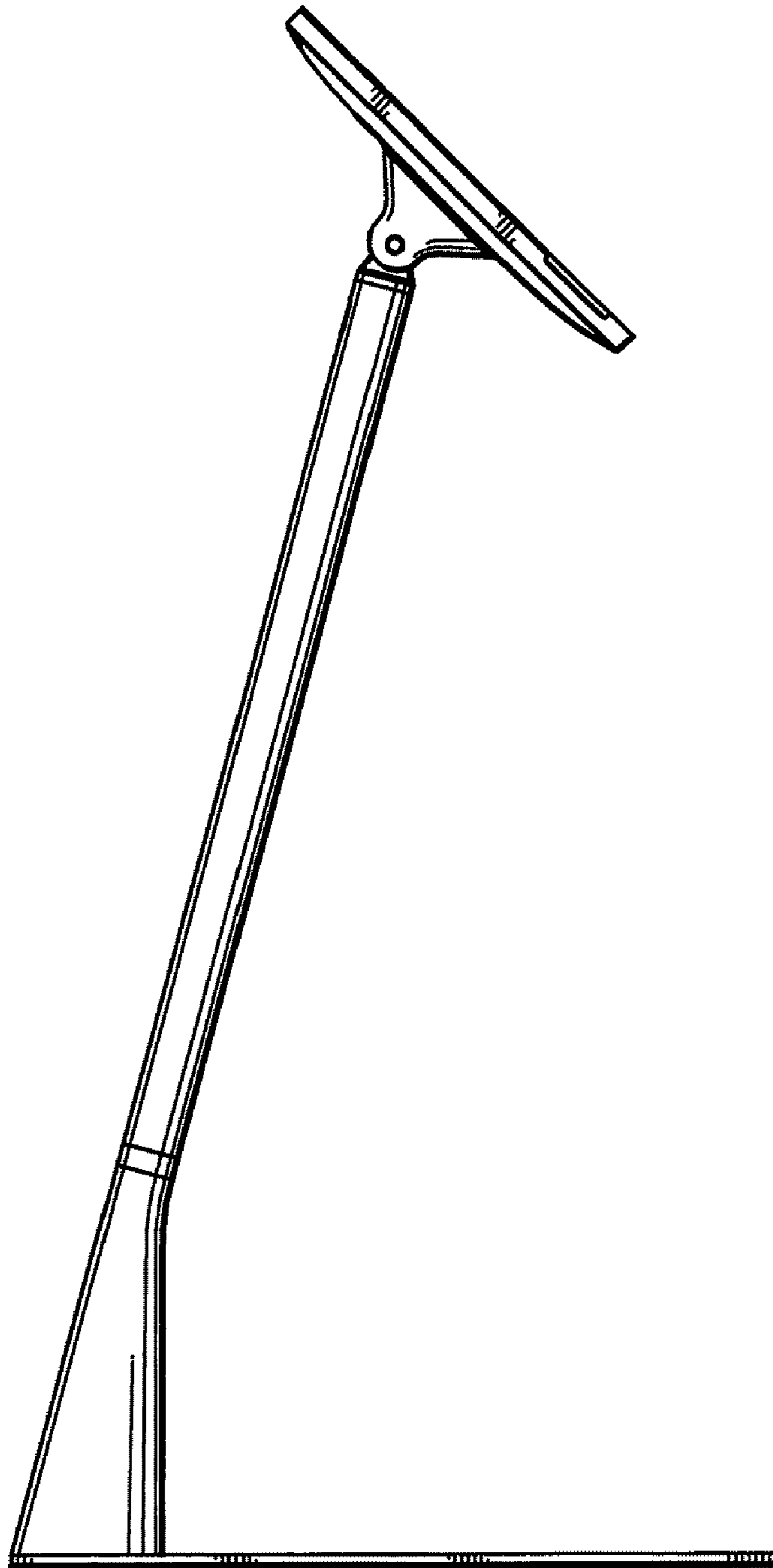

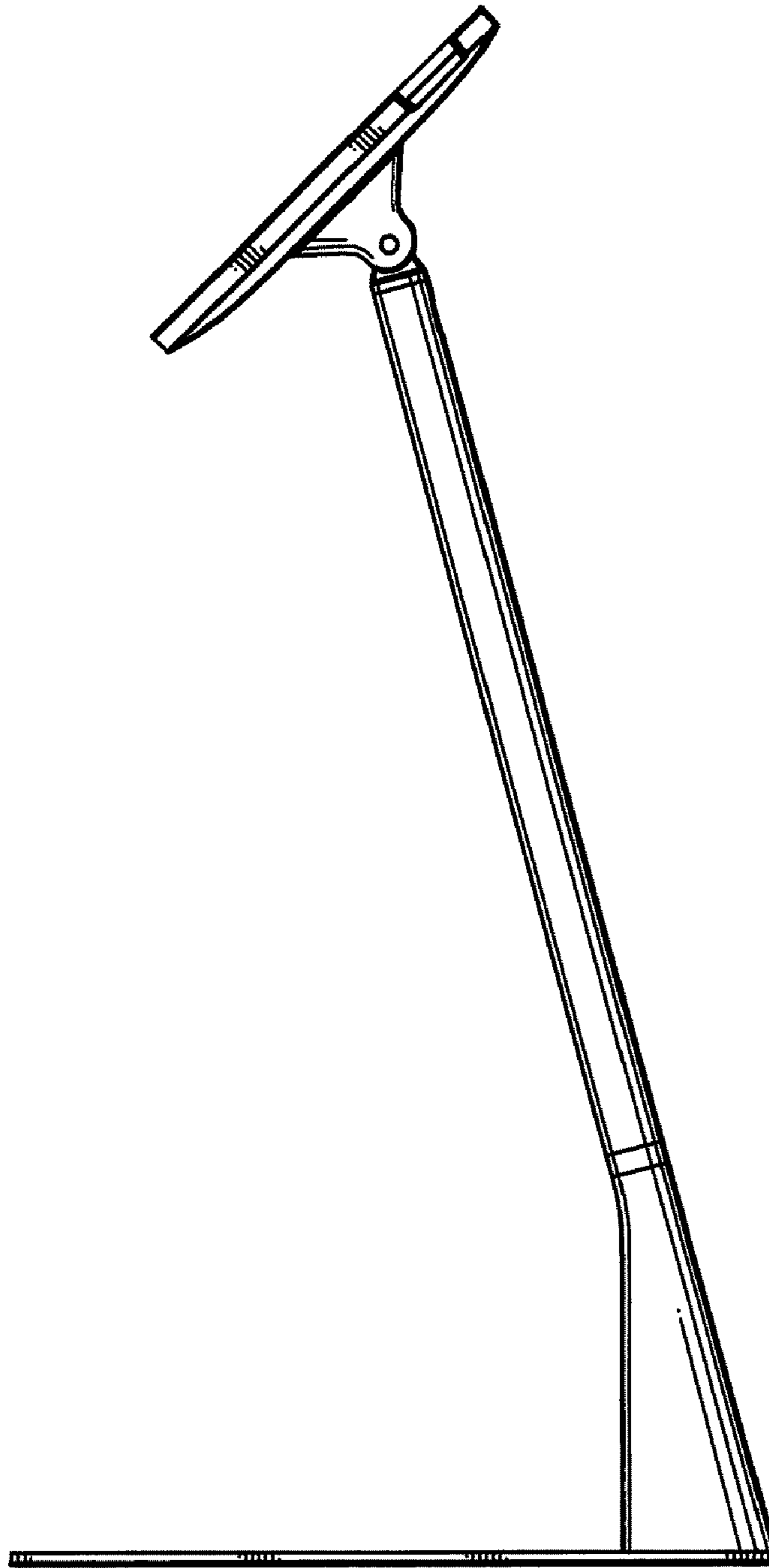

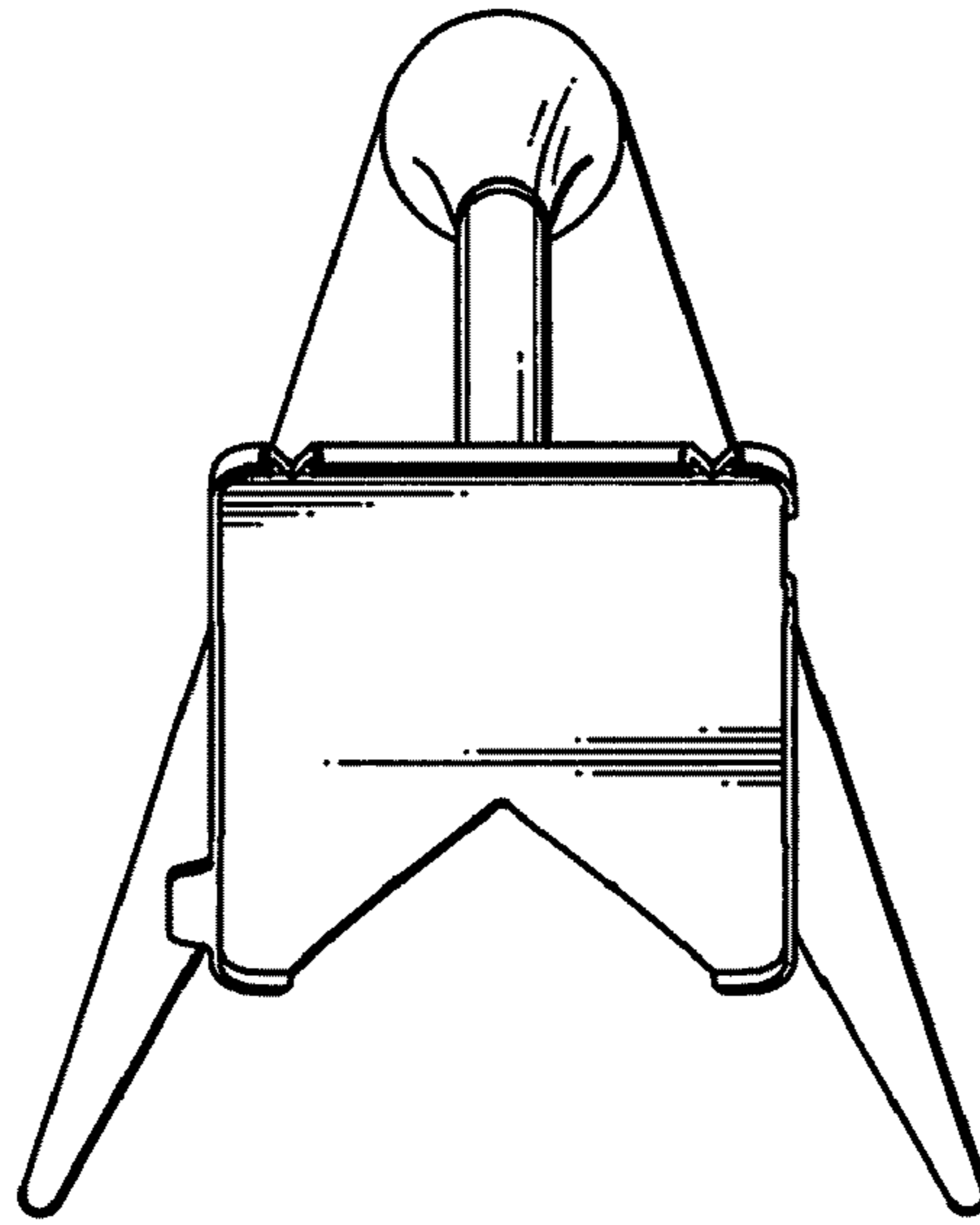

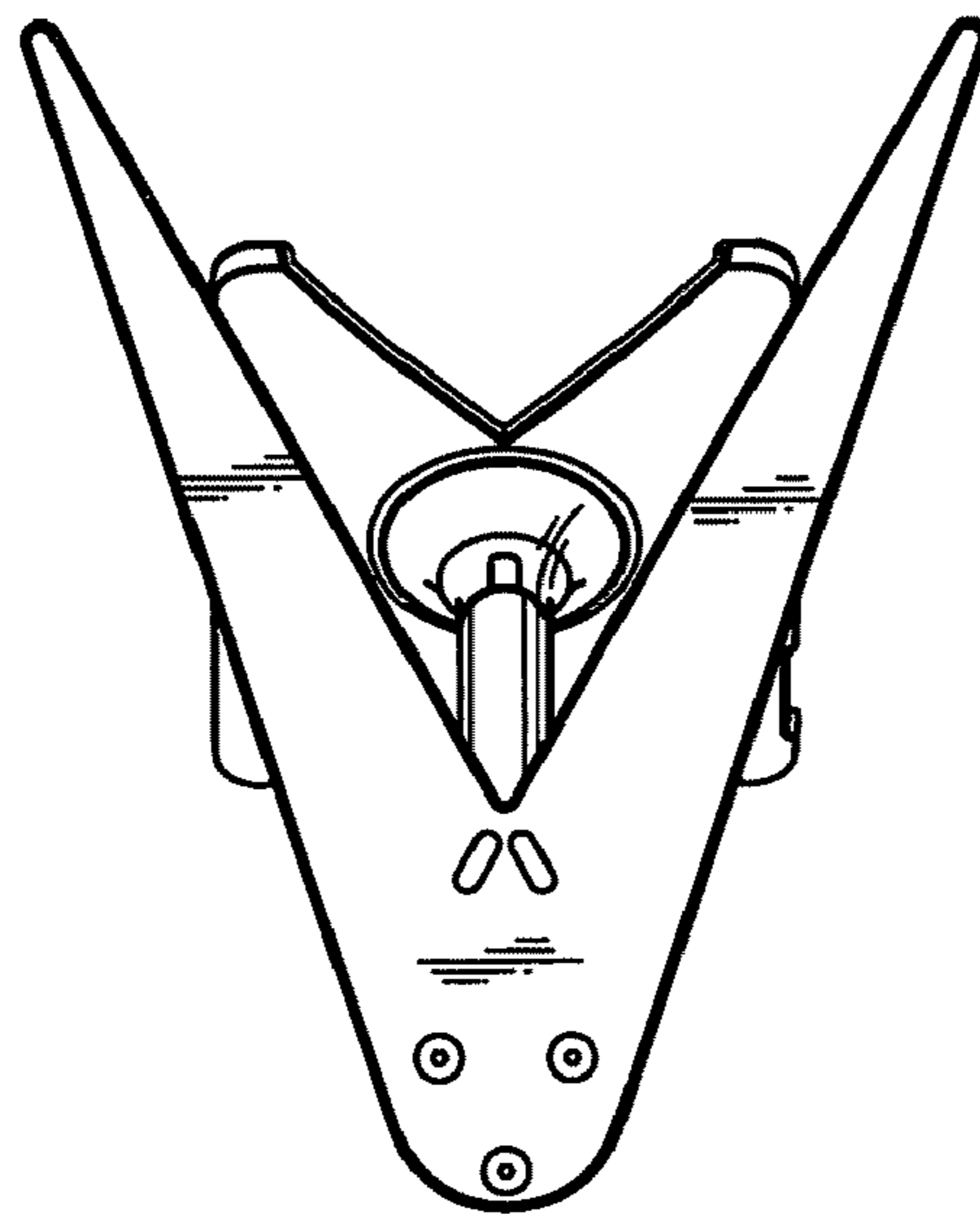

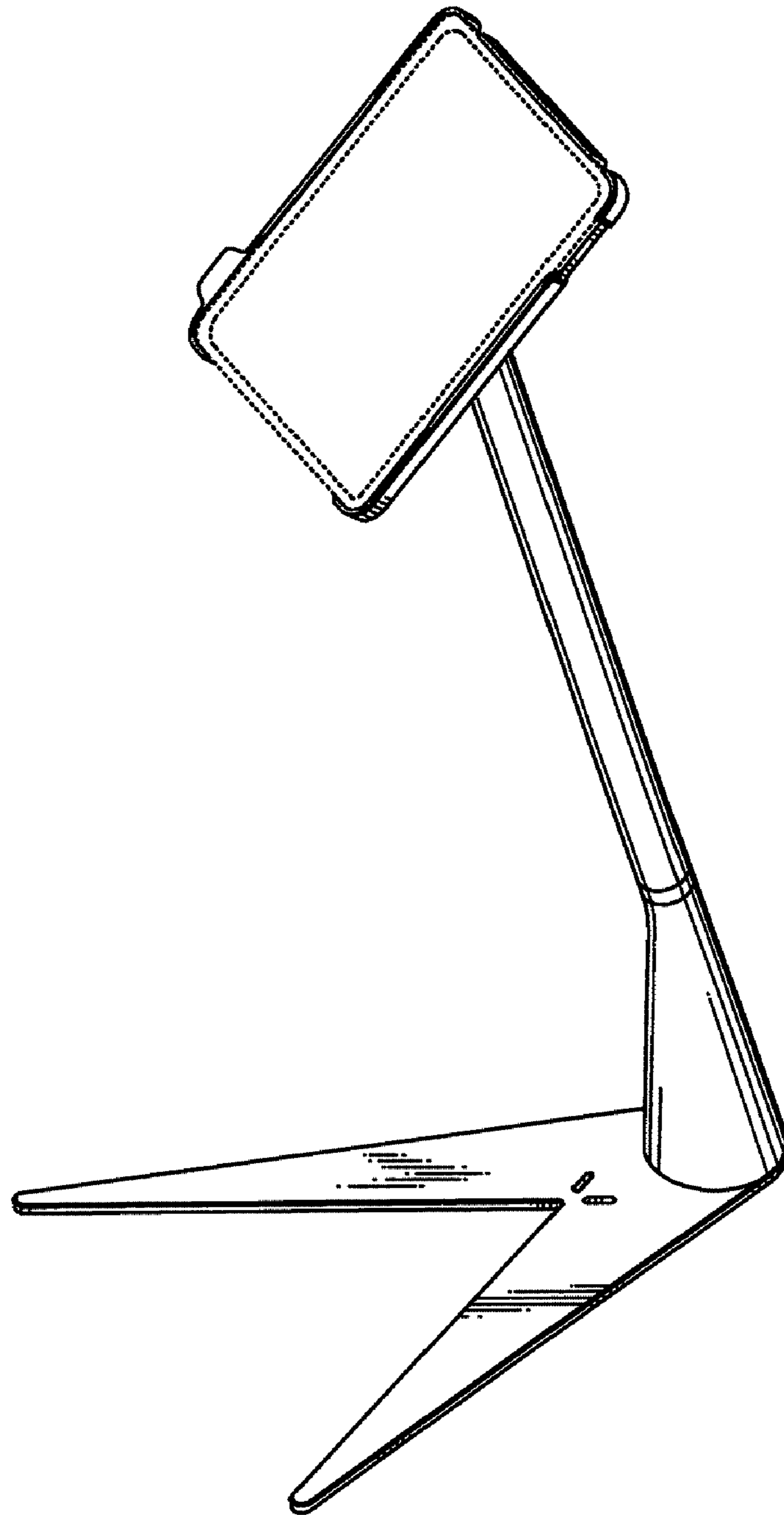

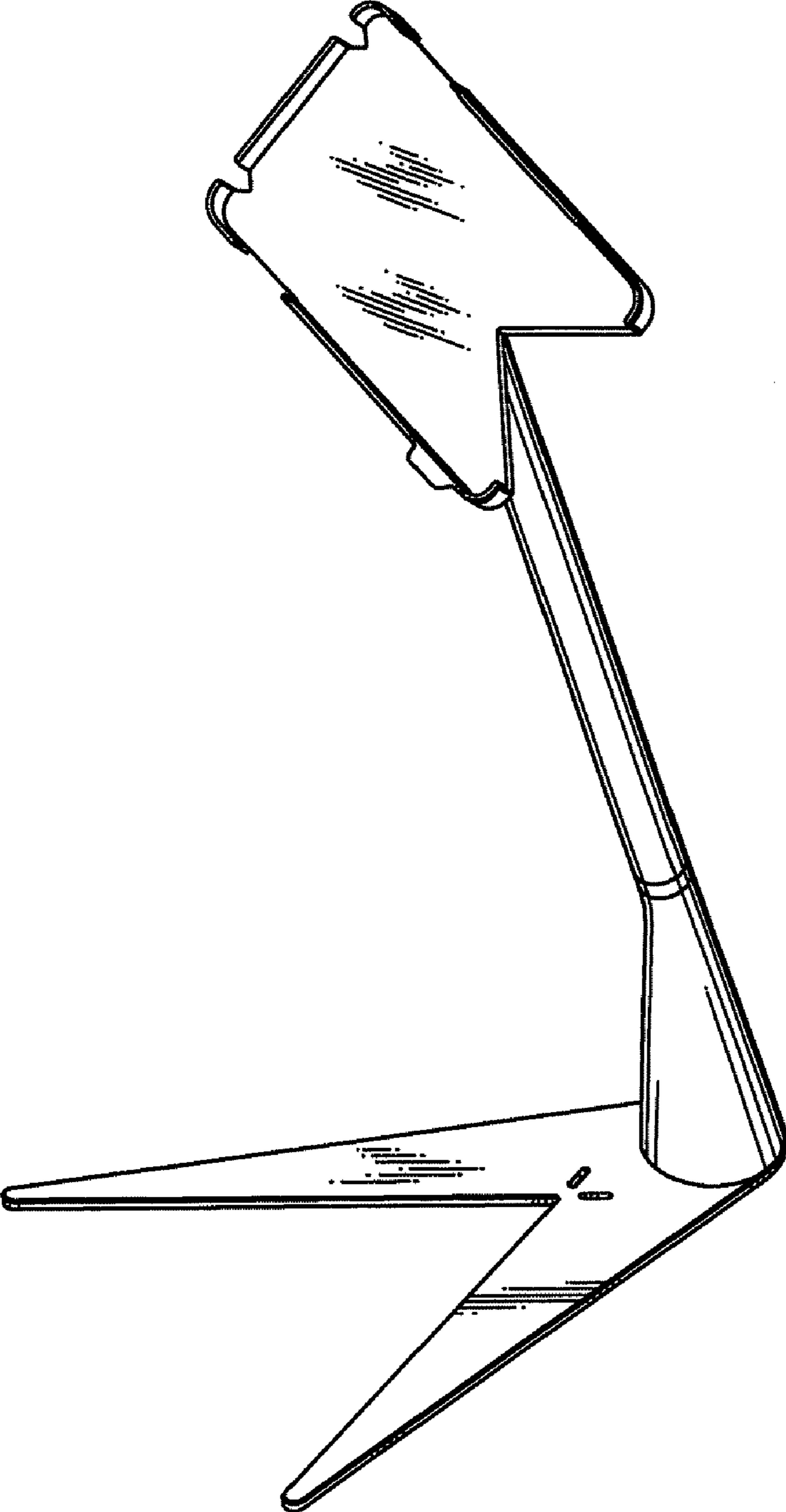
