(57) **CLAIM**

The ornamental design for an animatronic toy, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an animatronic toy showing my new design, with the arms and legs apart;

FIG. 2 is a rear perspective view of the animatronic toy of FIG. 1, shown with the arms and legs apart;

FIG. 3 is a front elevational view of the animatronic toy of FIG. 1, shown with the arms and legs together;

FIG. 4 is a right side elevational view of the animatronic toy of FIG. 1, shown with the arms and legs together, the left side being a mirror image thereof;

FIG. 5 is a front perspective view of the animatronic toy of FIG. 1; the broken line showing of the sleeve and arm is for illustrative purposes only, and forms no part of the claimed design;

FIG. 6 is a top plan view of the animatronic toy of FIG. 1; the broken line showing of the sleeve and arm is for illustrative purposes only, and forms no part of the claimed design; and,

FIG. 7 is a bottom plan view of the animatronic toy of FIG. 1; the broken line showing of the sleeve and arm is for illustrative purposes only, and forms no part of the claimed design.

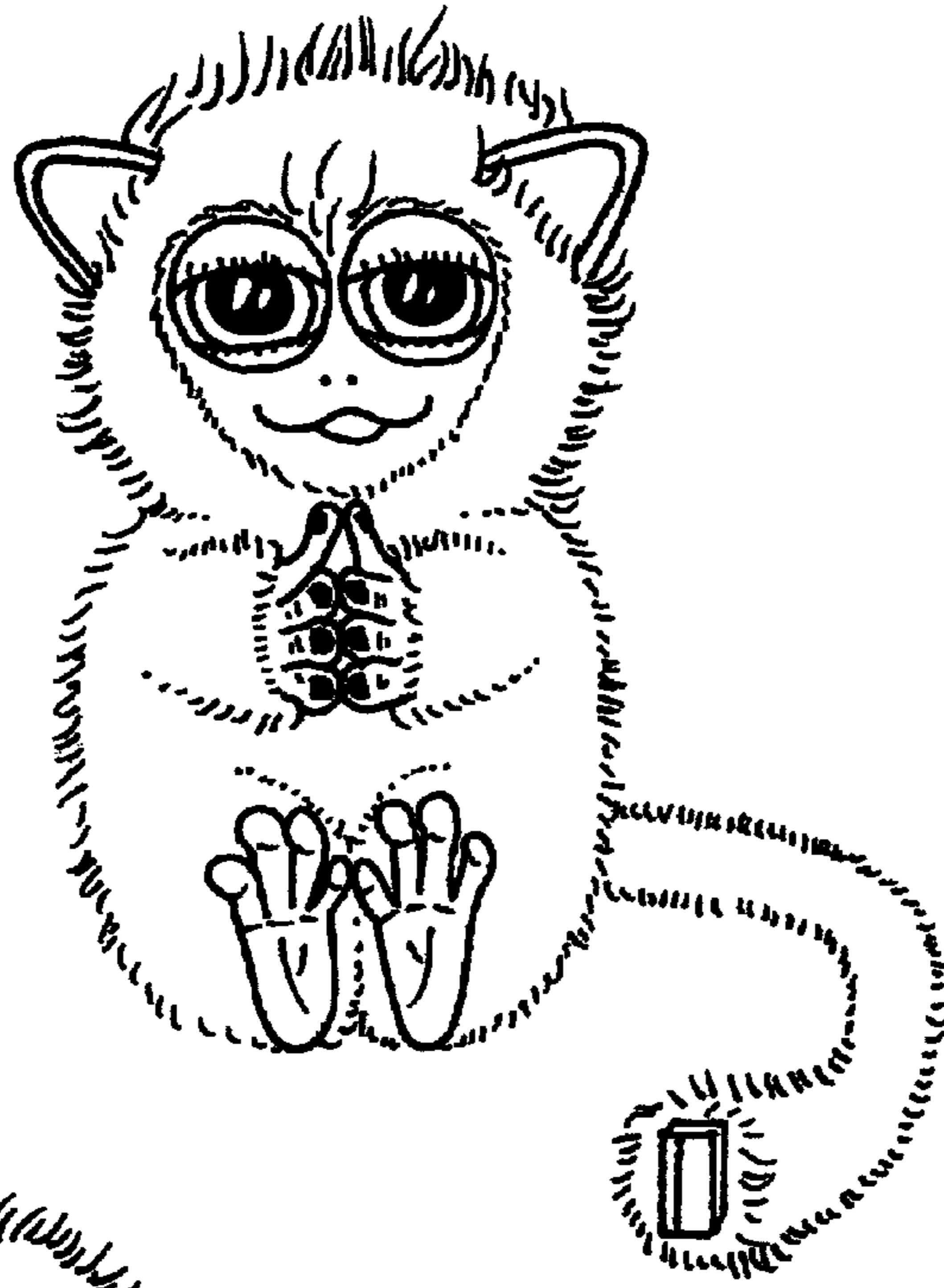
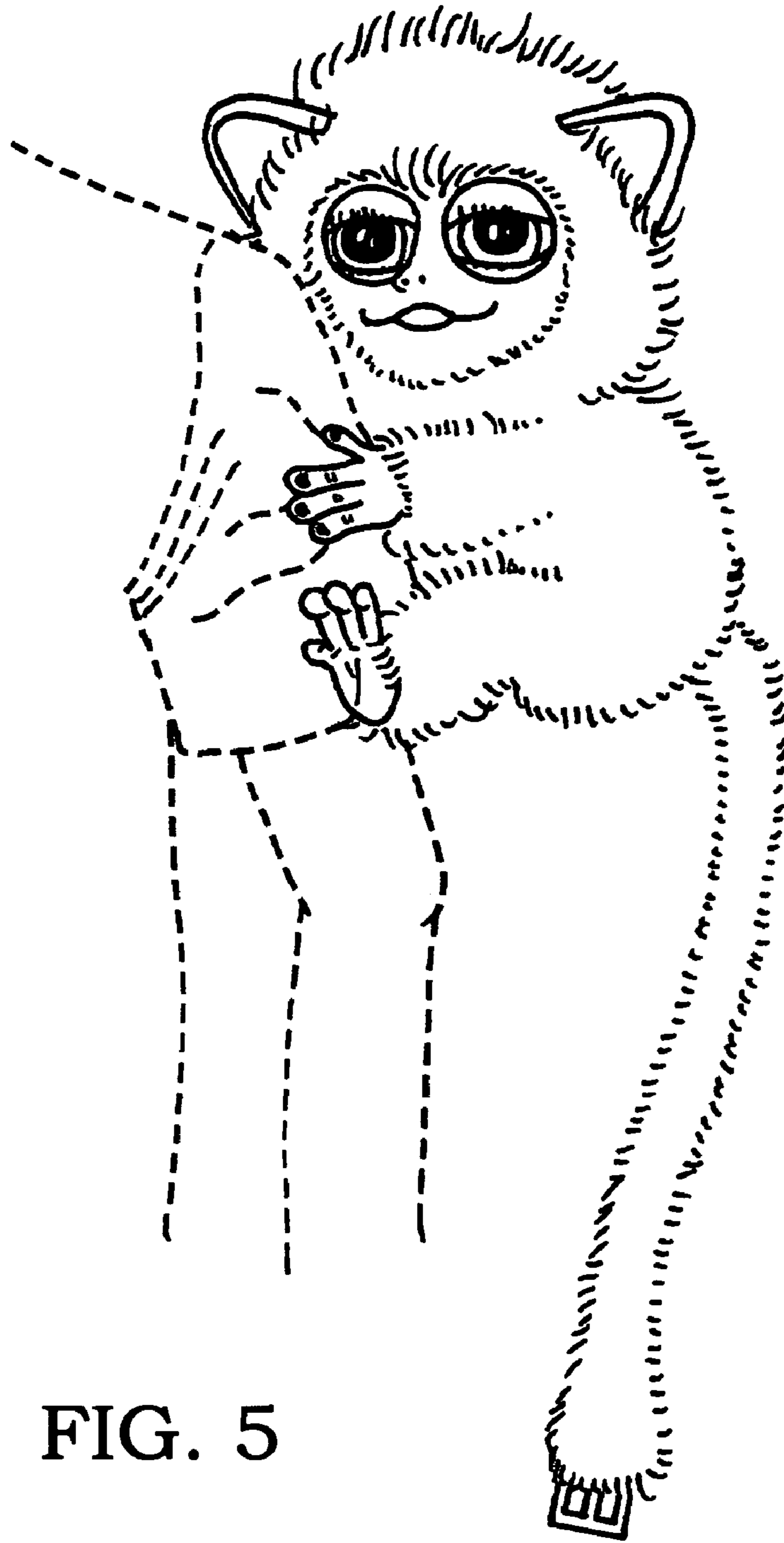

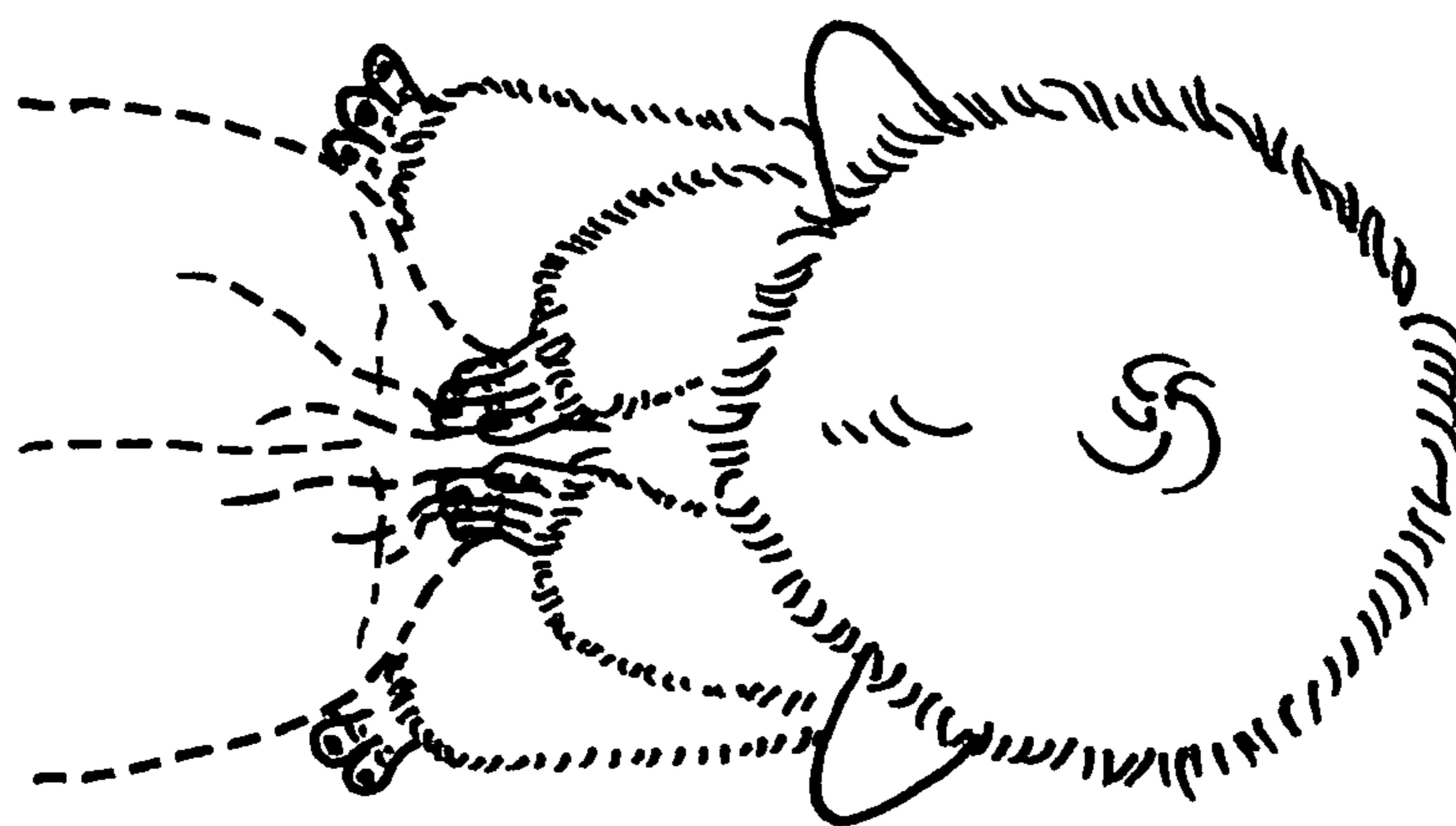

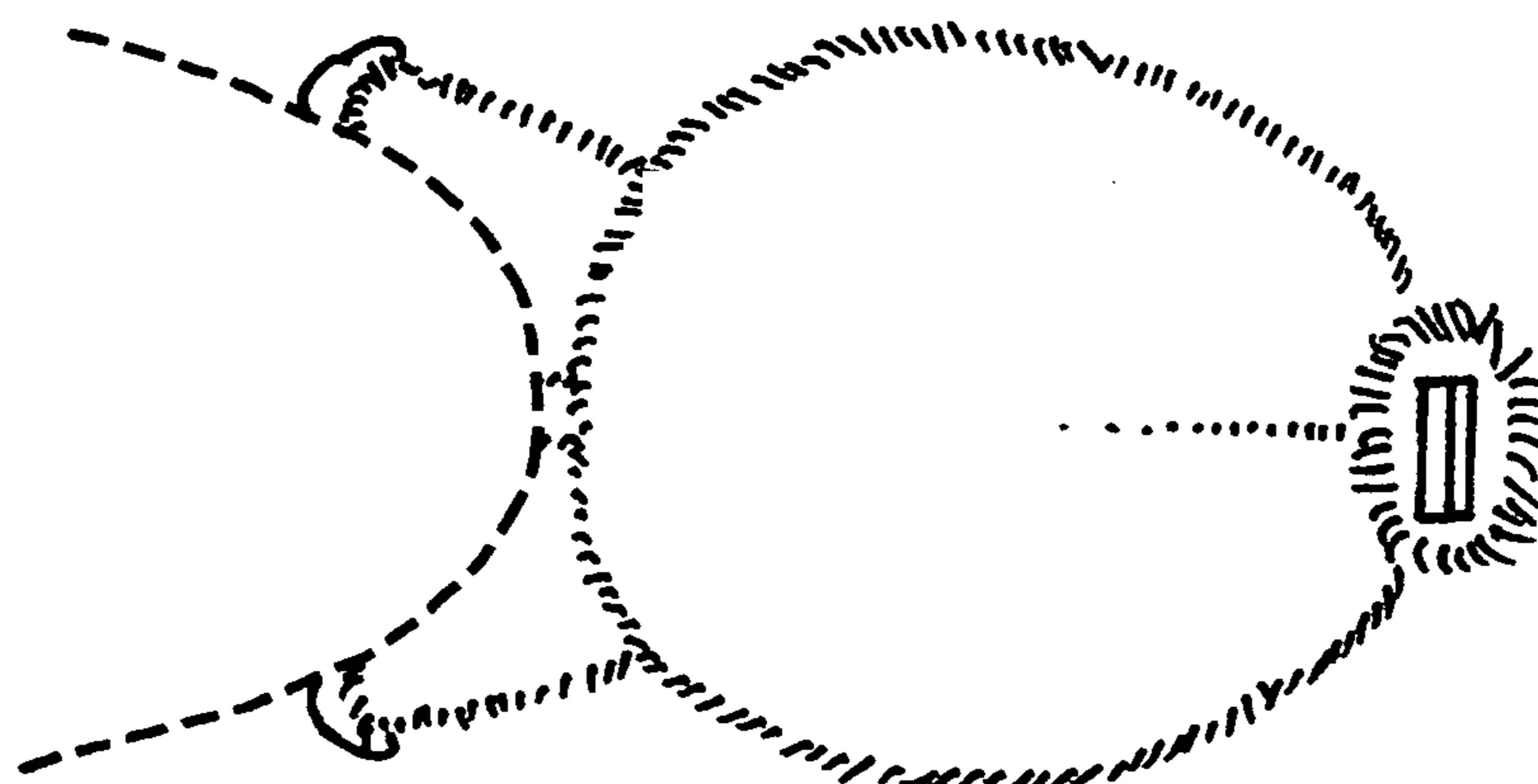
