(57) CLAIM

The ornamental design for a lamp, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of the ornamental design for a lamp, the design being rotationally symmetric;

FIG. 2 is a top plan view of the first embodiment;

FIG. 3 is a bottom plan view of the first embodiment;

FIG. 4 is a perspective view of the first embodiment, as seen from the front, top side;

FIG. 5 is a front elevational view of a second embodiment of the ornamental design for a lamp, the back elevational view being mirror symmetric;

FIG. 6 is a left side elevational view of the second embodiment;

FIG. 7 is a right side elevational view of the second embodiment;


FIG. 8 is a top plan view of the second embodiment;

















