(57) **CLAIM**

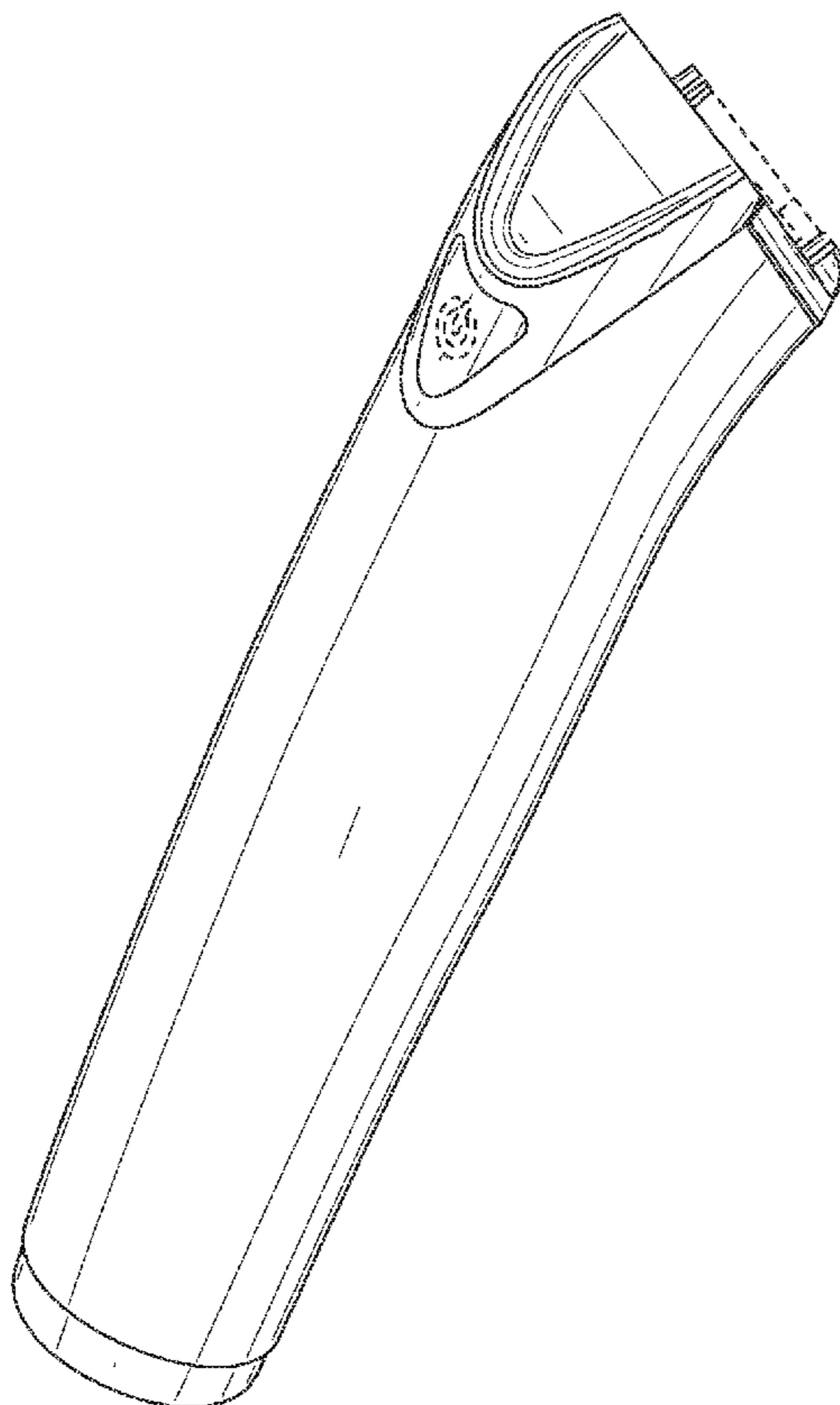
The ornamental design for a hair trimmer, as shown and described.

DESCRIPTION

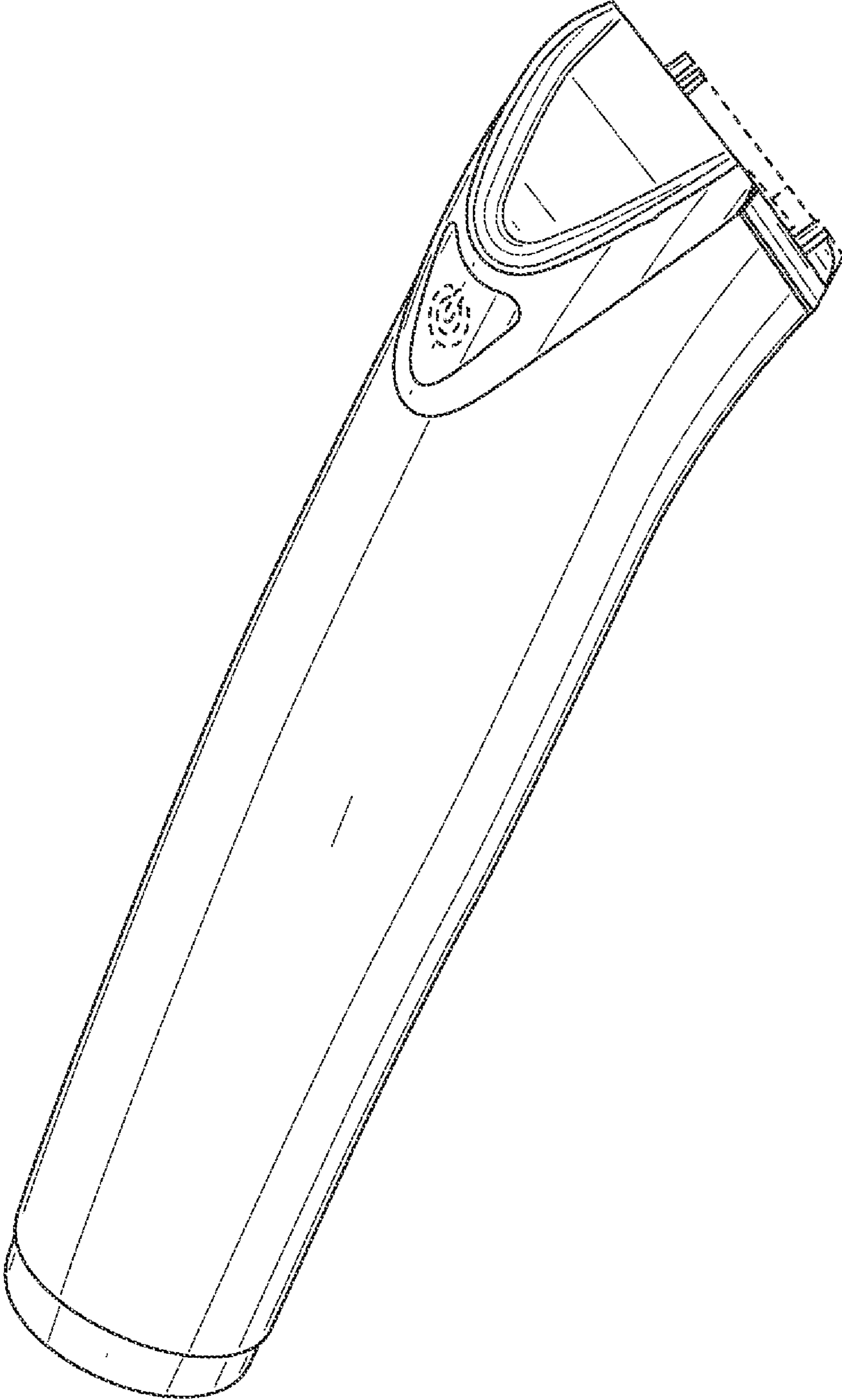

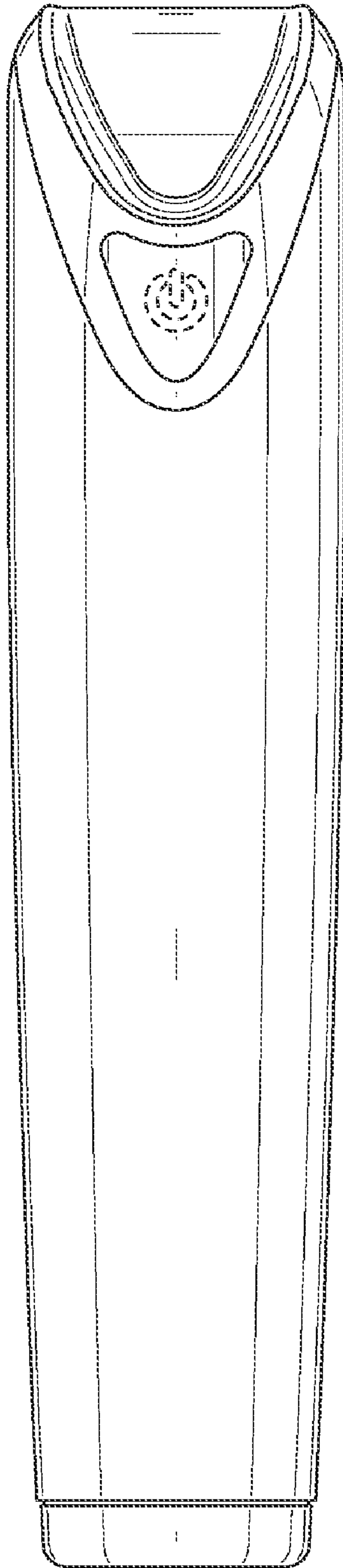

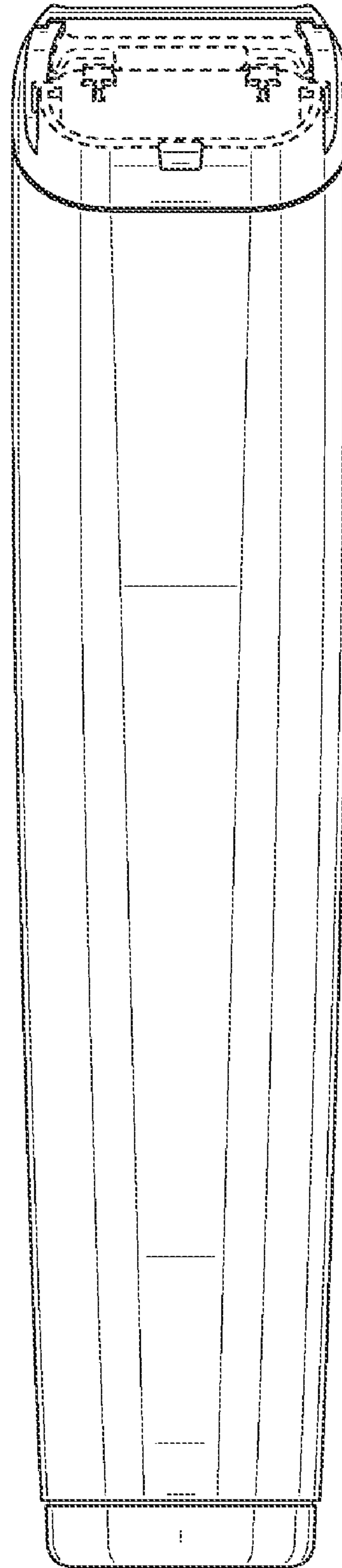

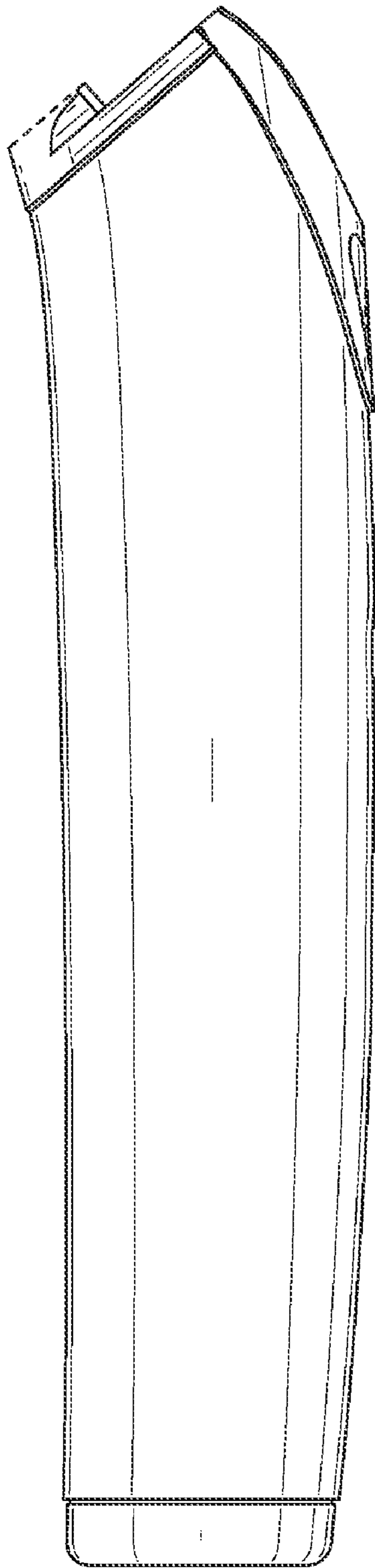

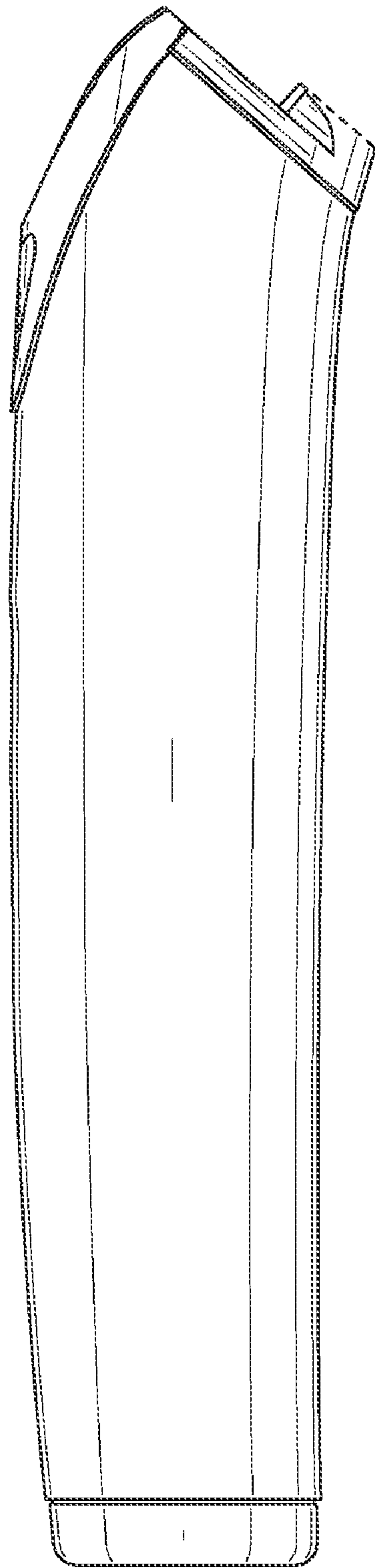

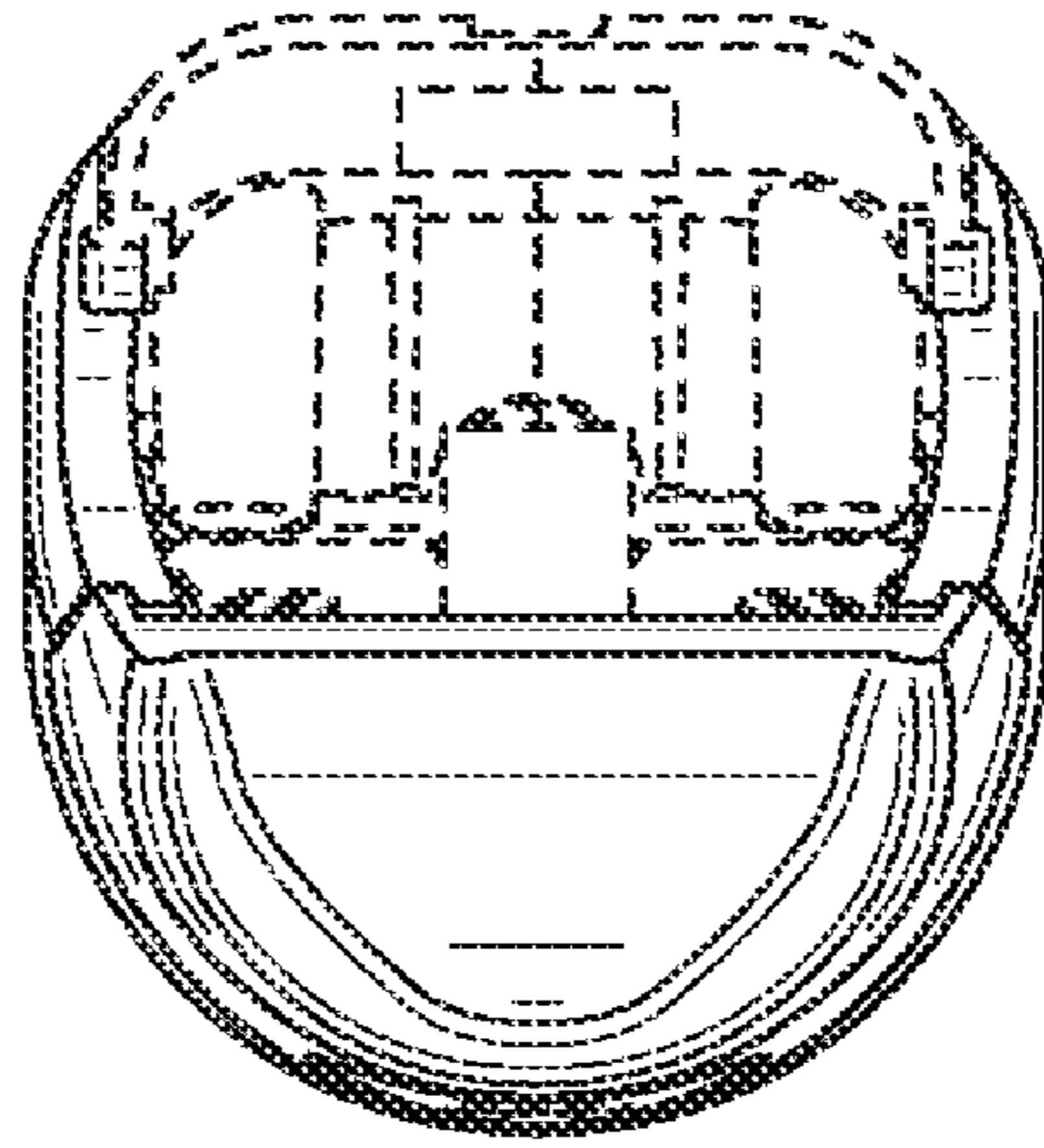

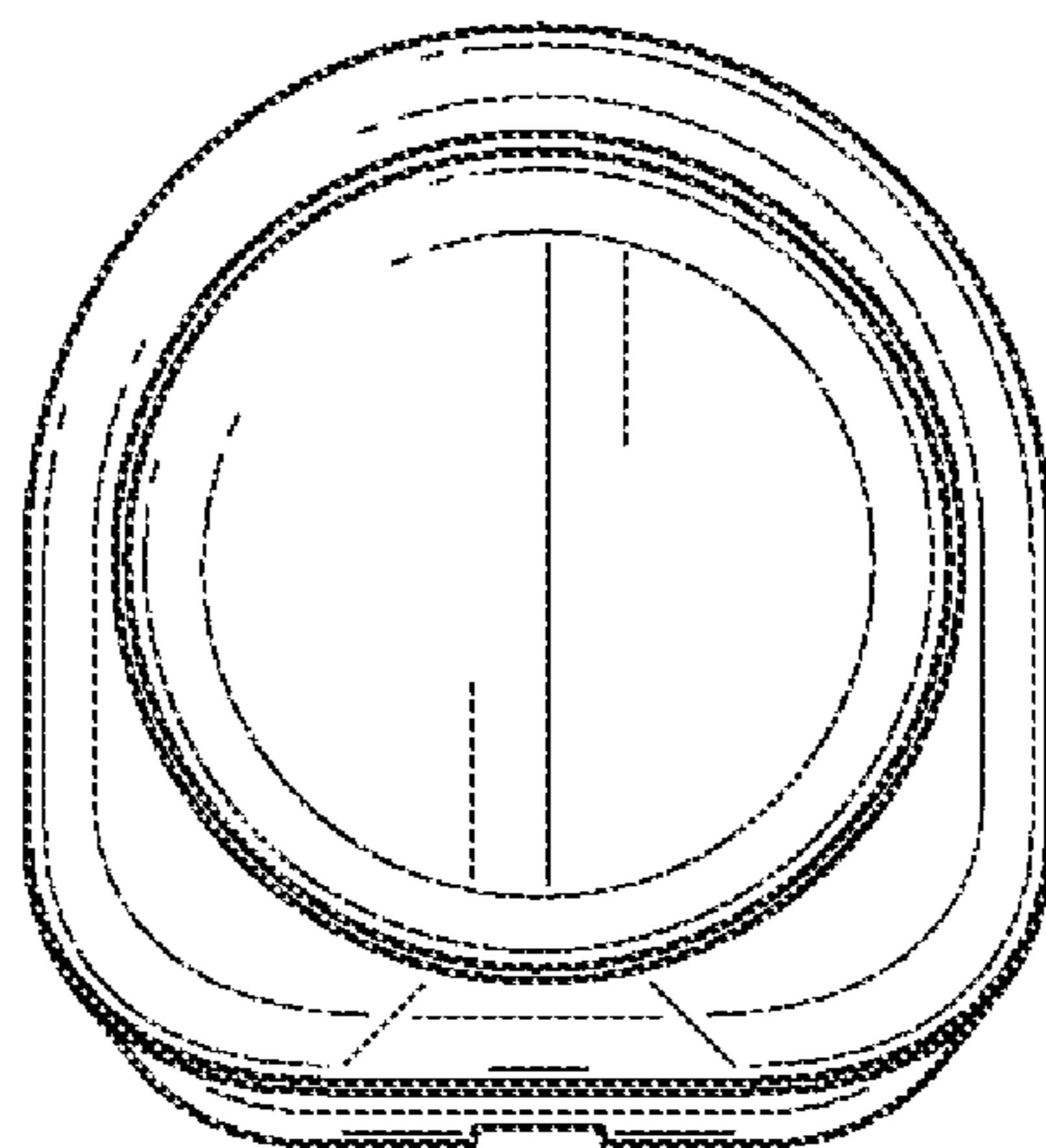
