(57) **CLAIM**

I claim the ornamental design for a base for bird feeder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the base for bird feeder; FIG. 2 is a side elevational view thereof as seen from the right hand side of FIG. 1, with the other side being a mirror image thereof;

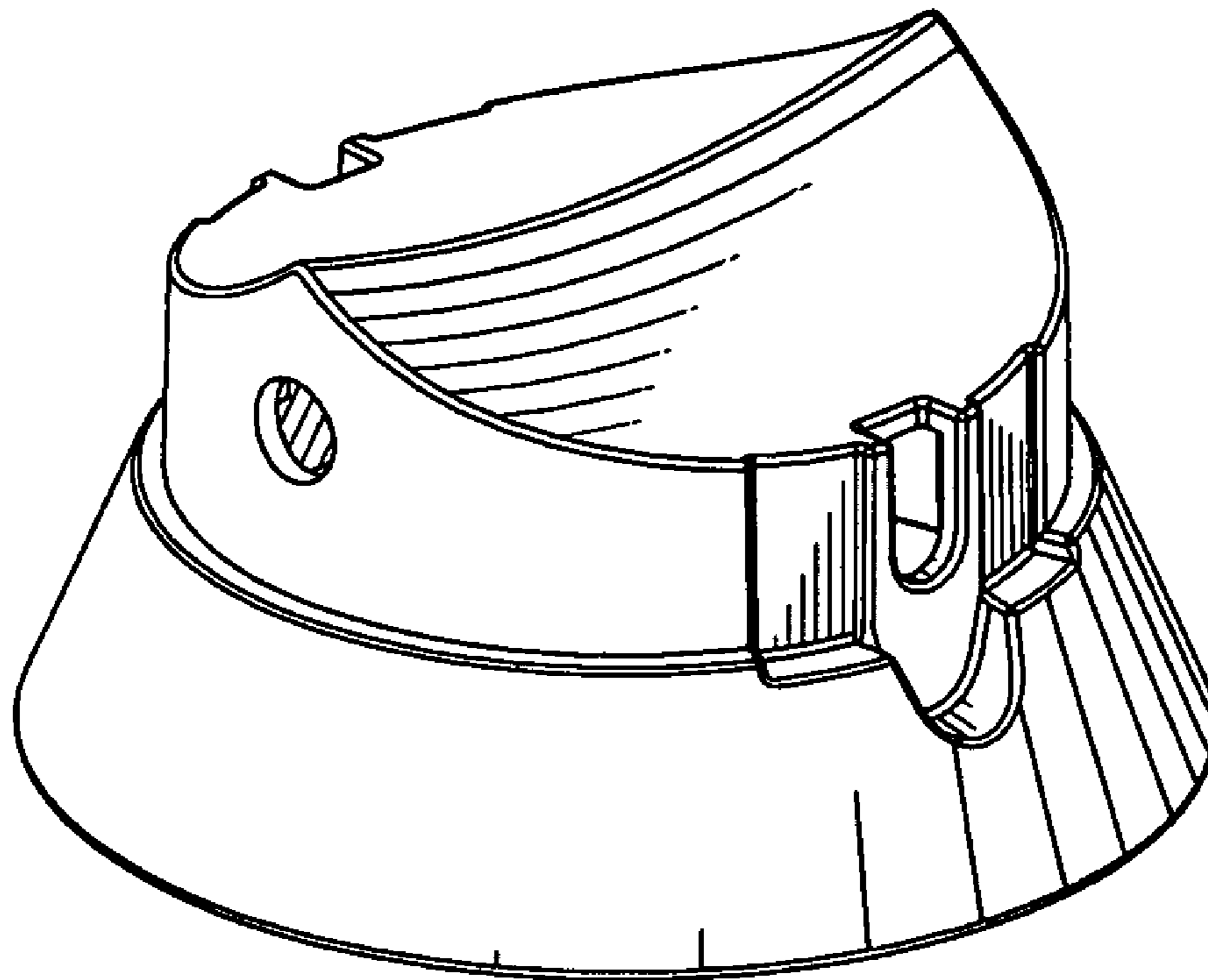
FIG. 3 is an end elevational view as seen from the left hand side of FIG. 1 with the other end being a mirror image thereof;

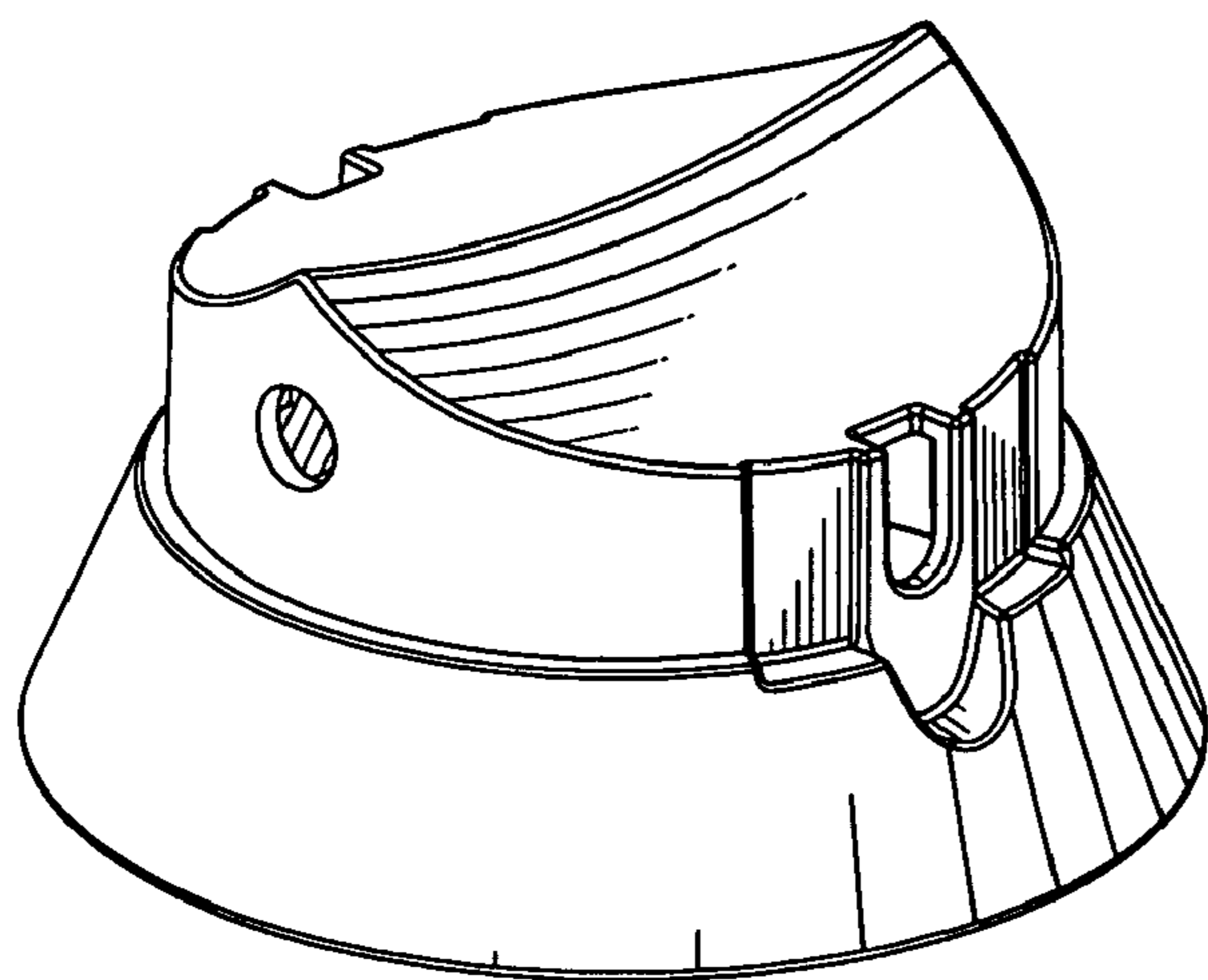

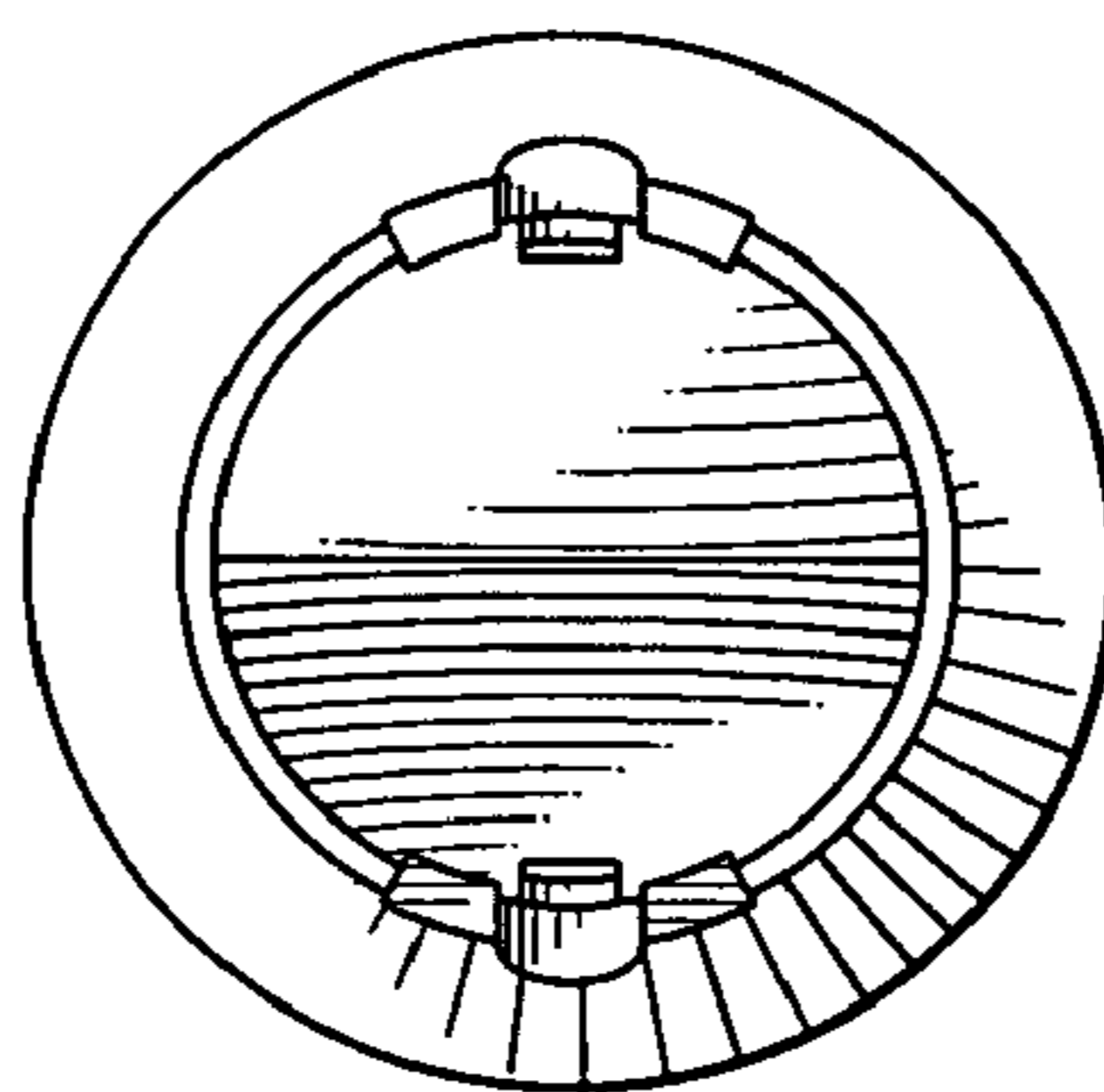

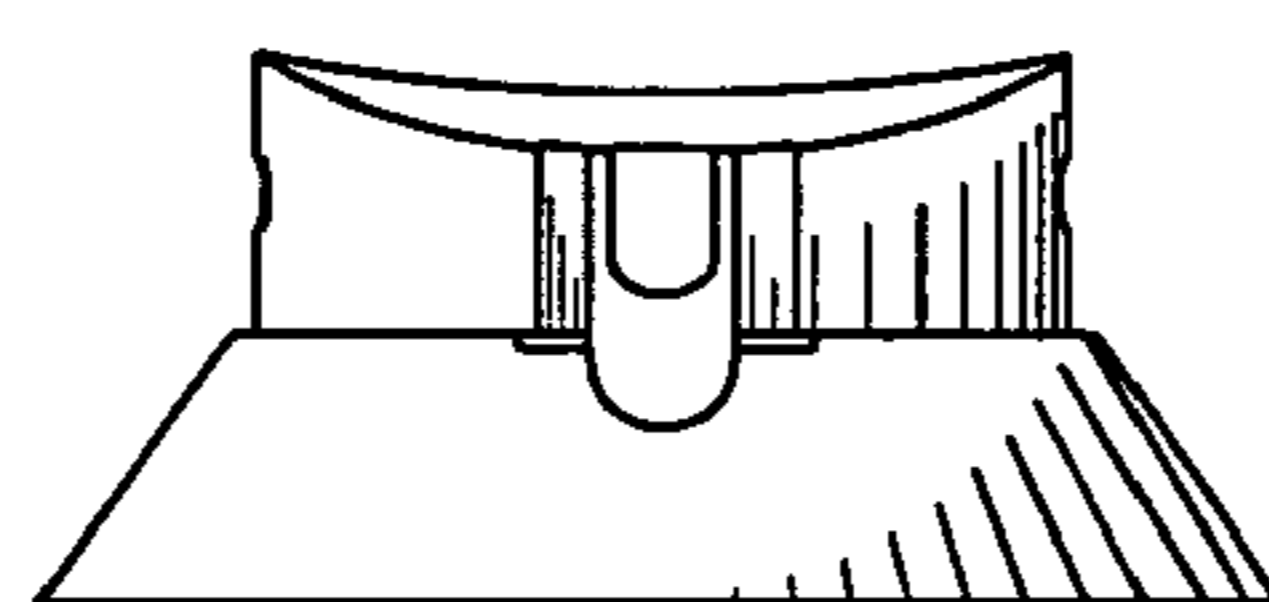

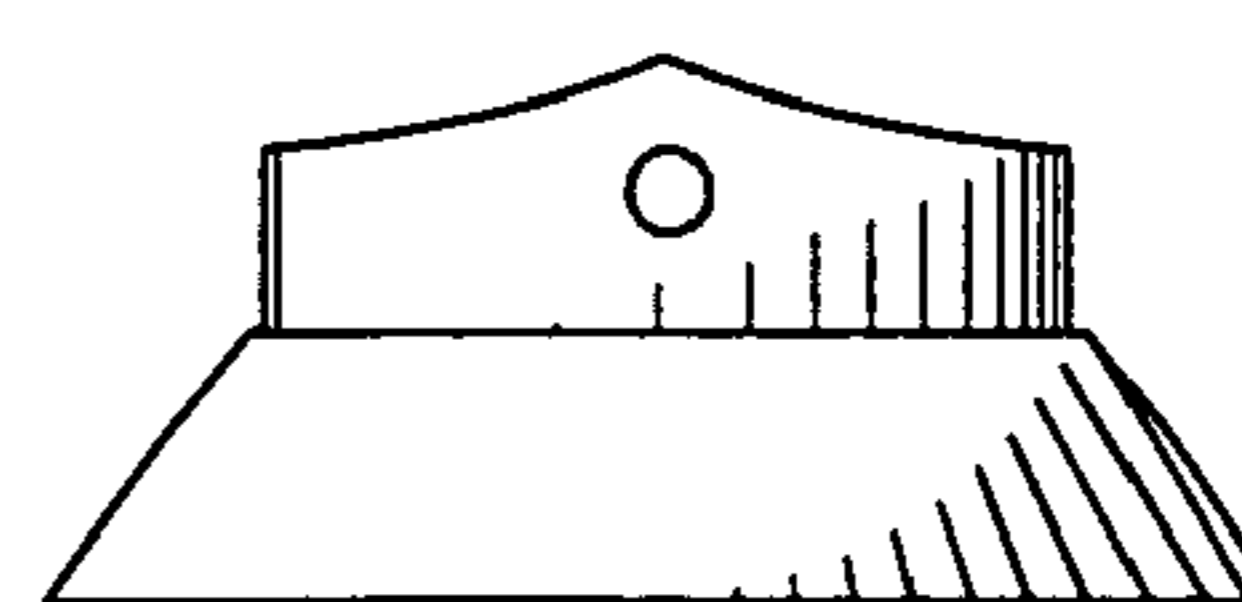

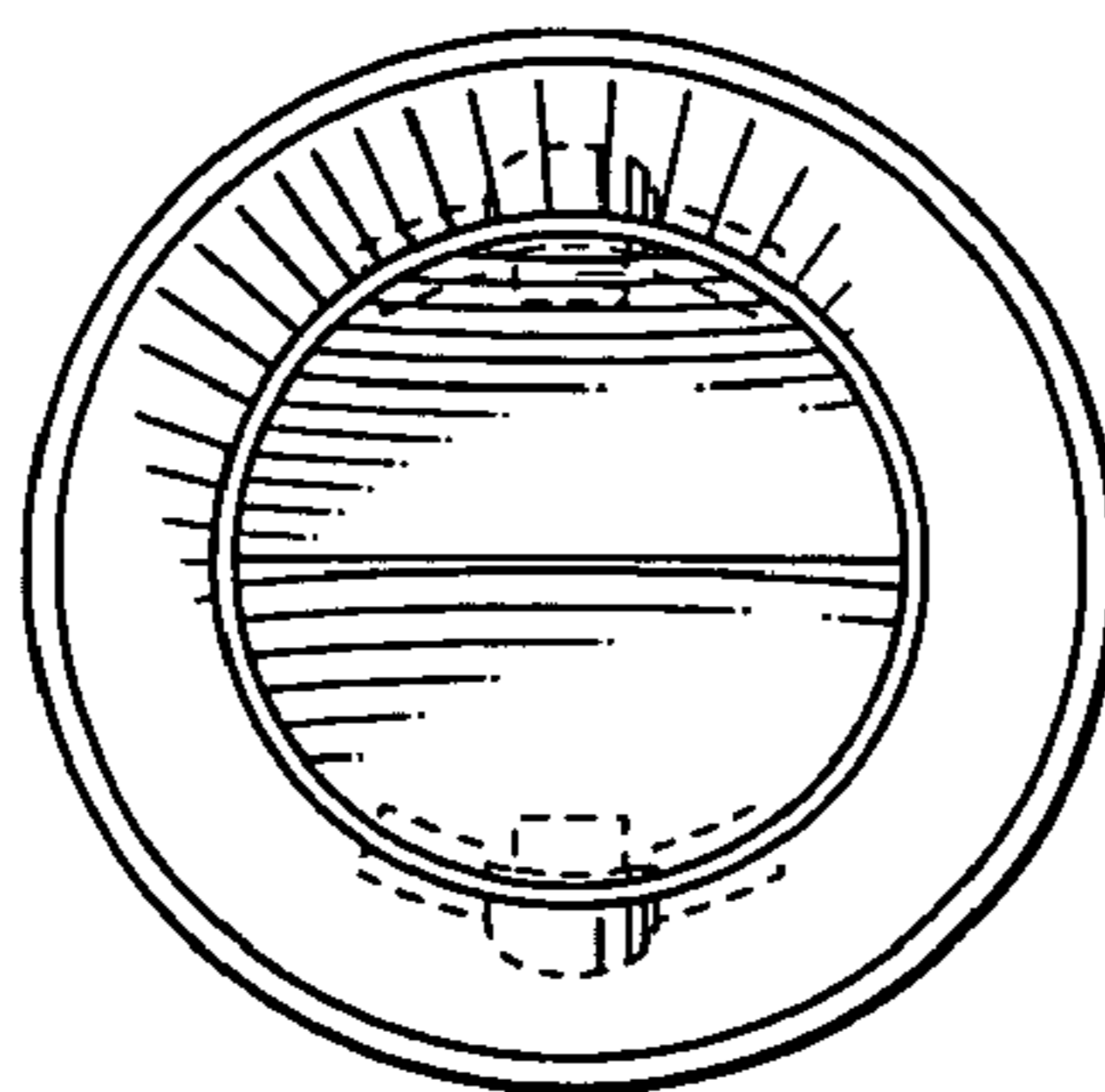
