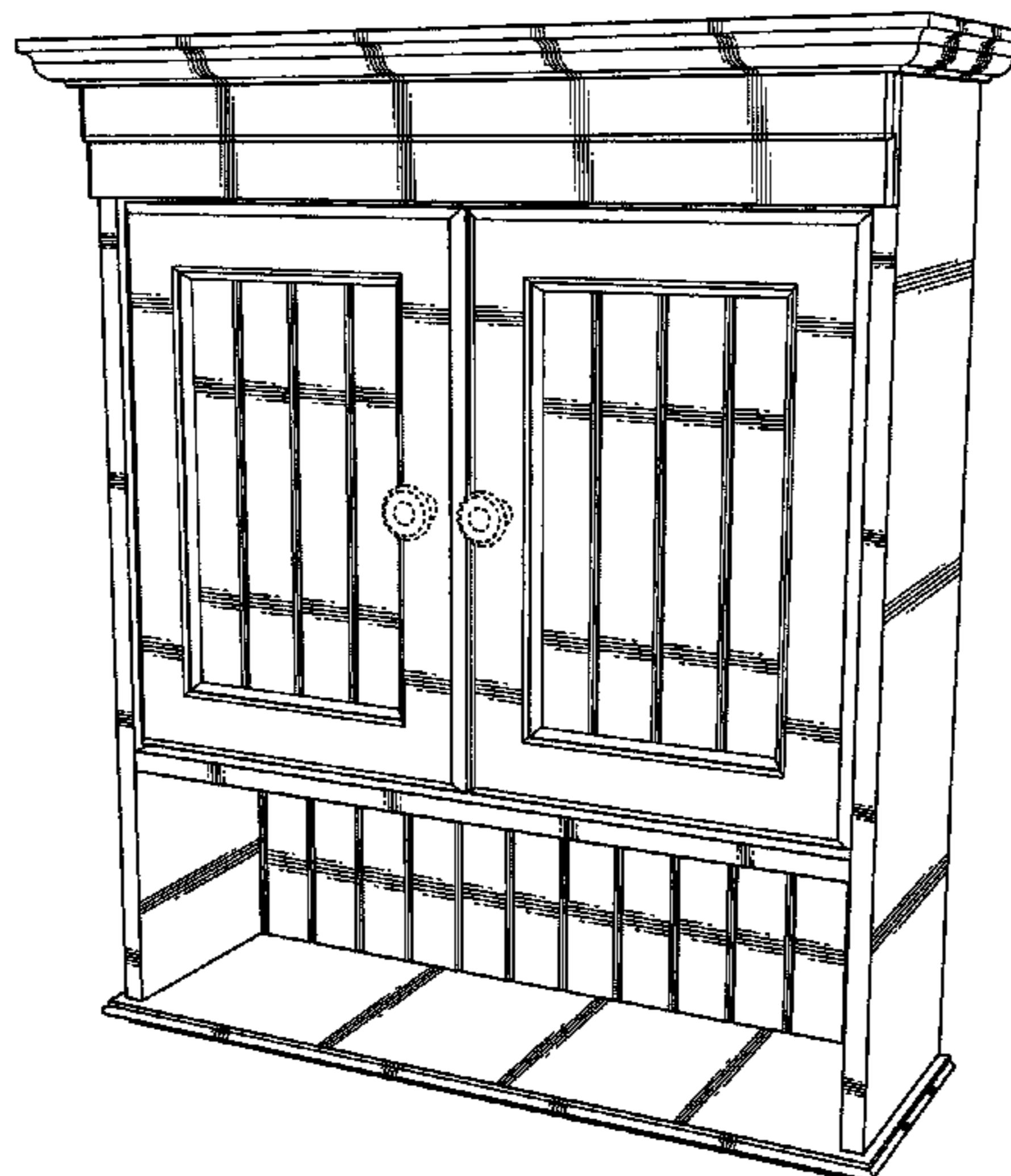
(57) **CLAIM**

The ornamental design for a cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the cabinet in accordance with our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a top plan view thereof; and,
FIG. 4 is a left side elevational view thereof, a right side elevational view being a mirror image thereof.

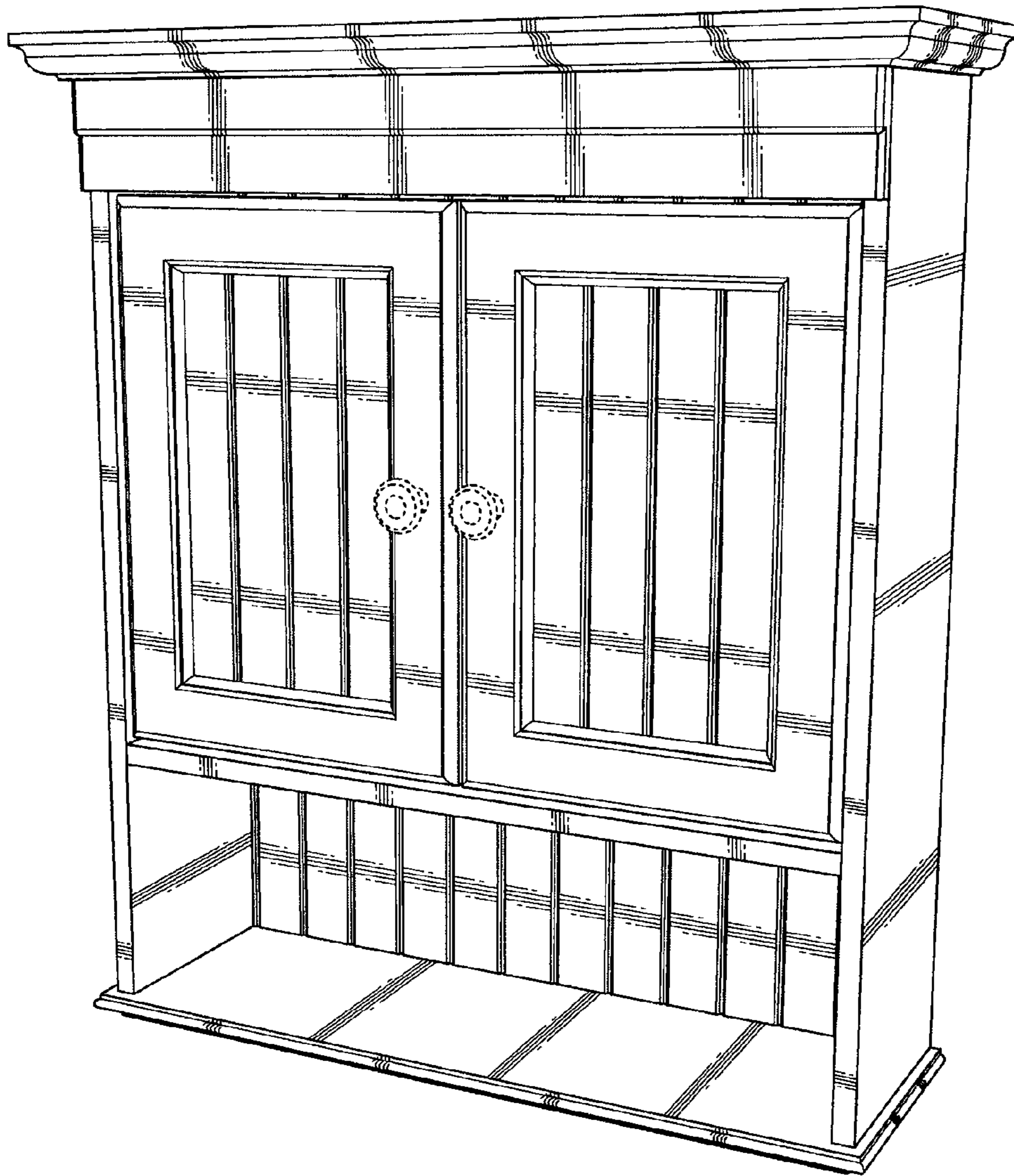

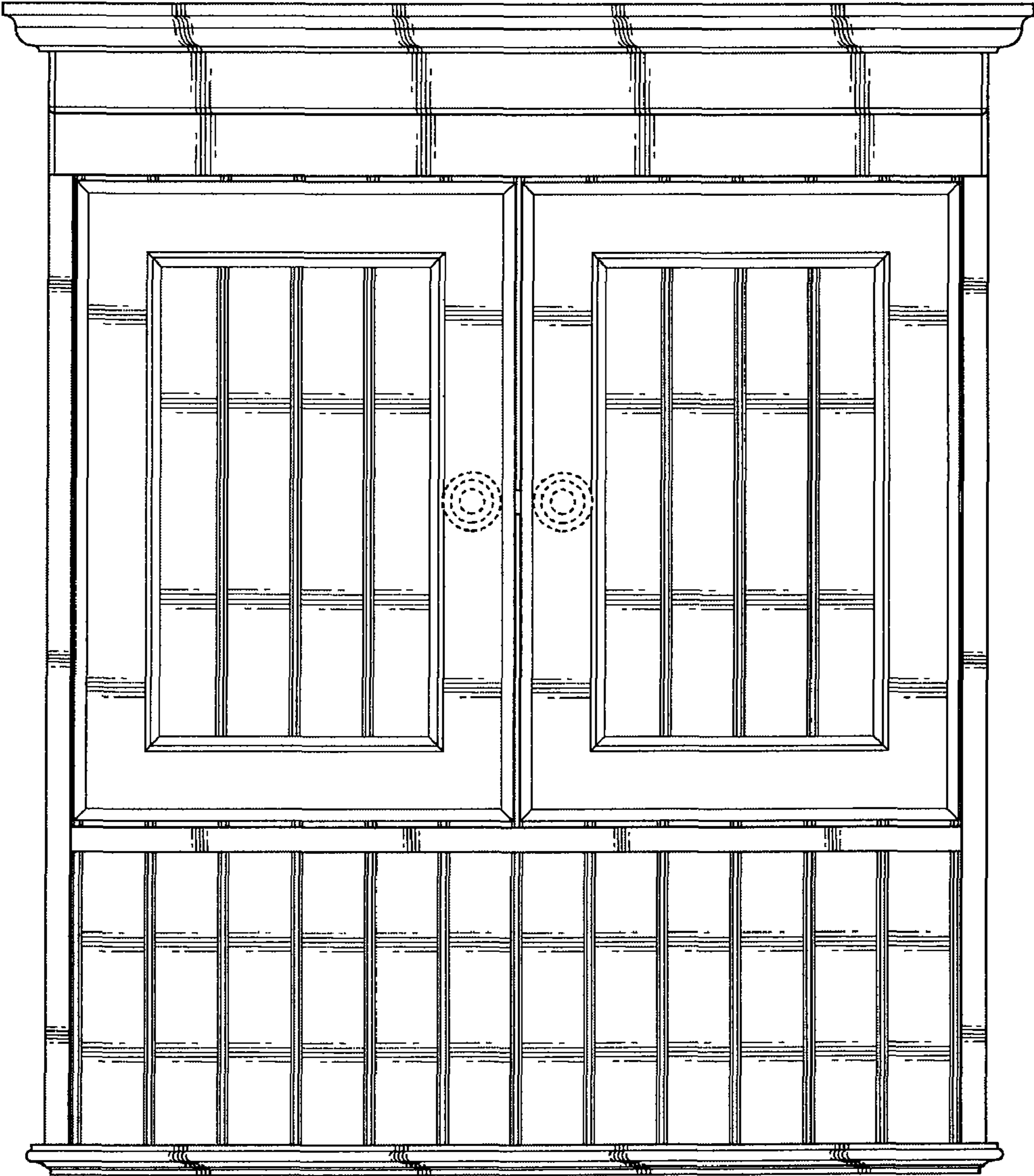

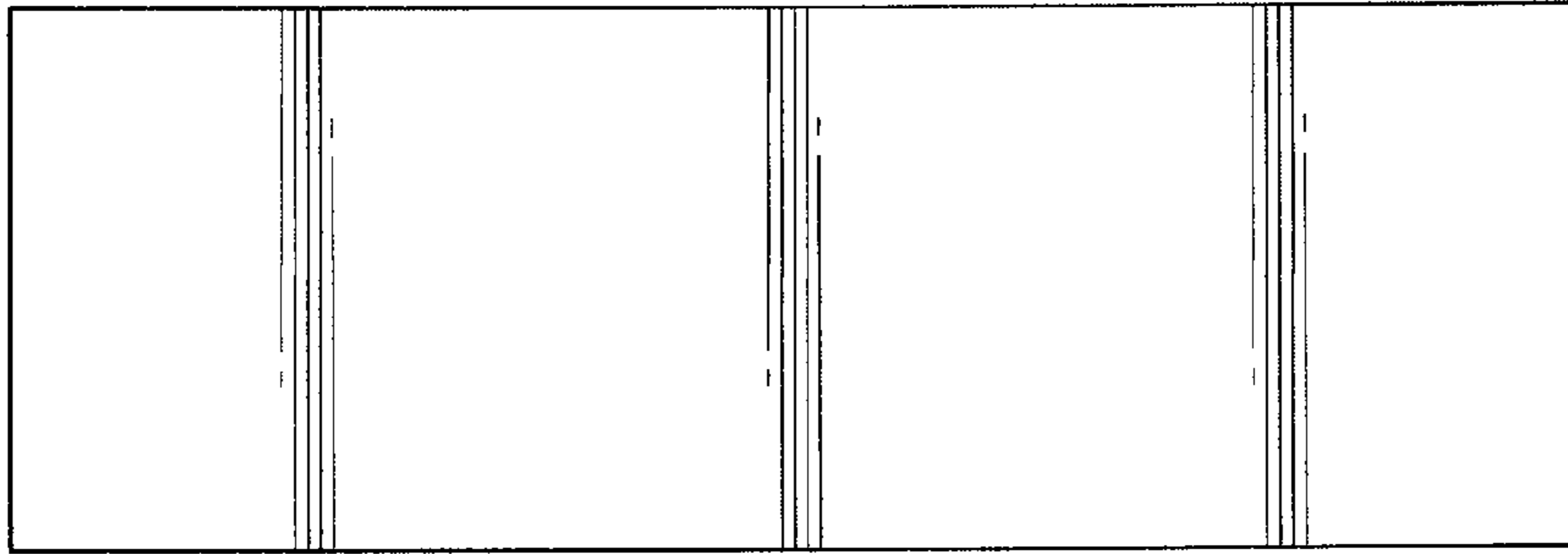

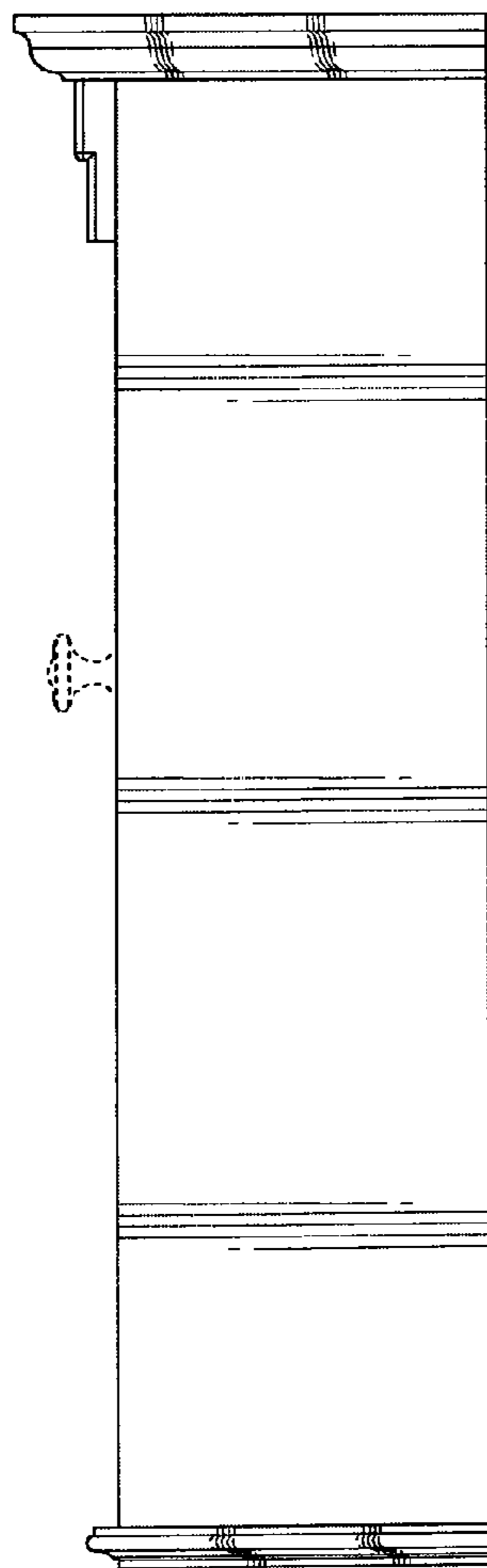
