The ornamental design for a water dispenser appliance, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of a water dispenser appliance showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; and, FIG. 5 is a right side elevational view thereof, the left side being a mirror image thereof.

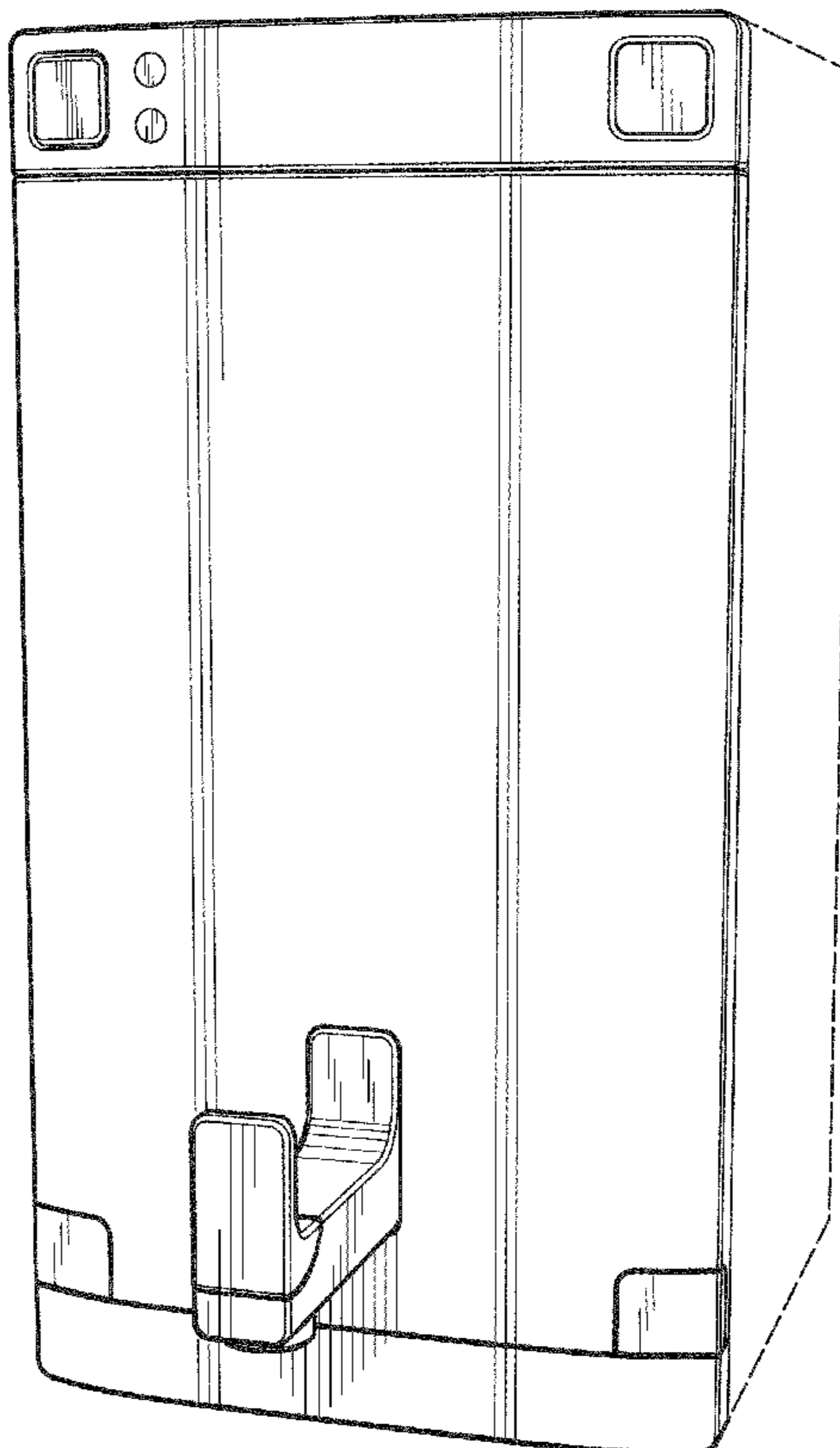

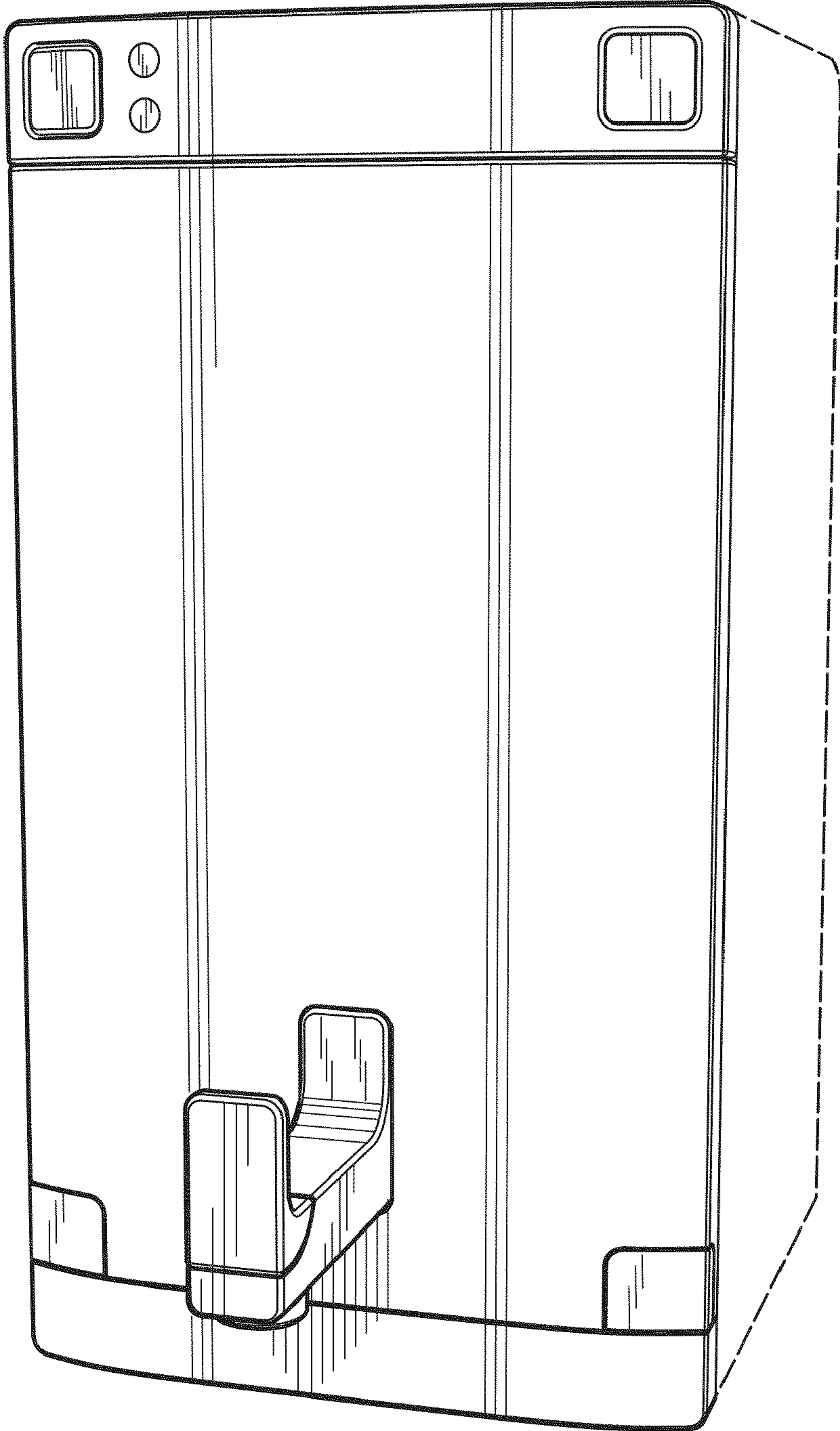

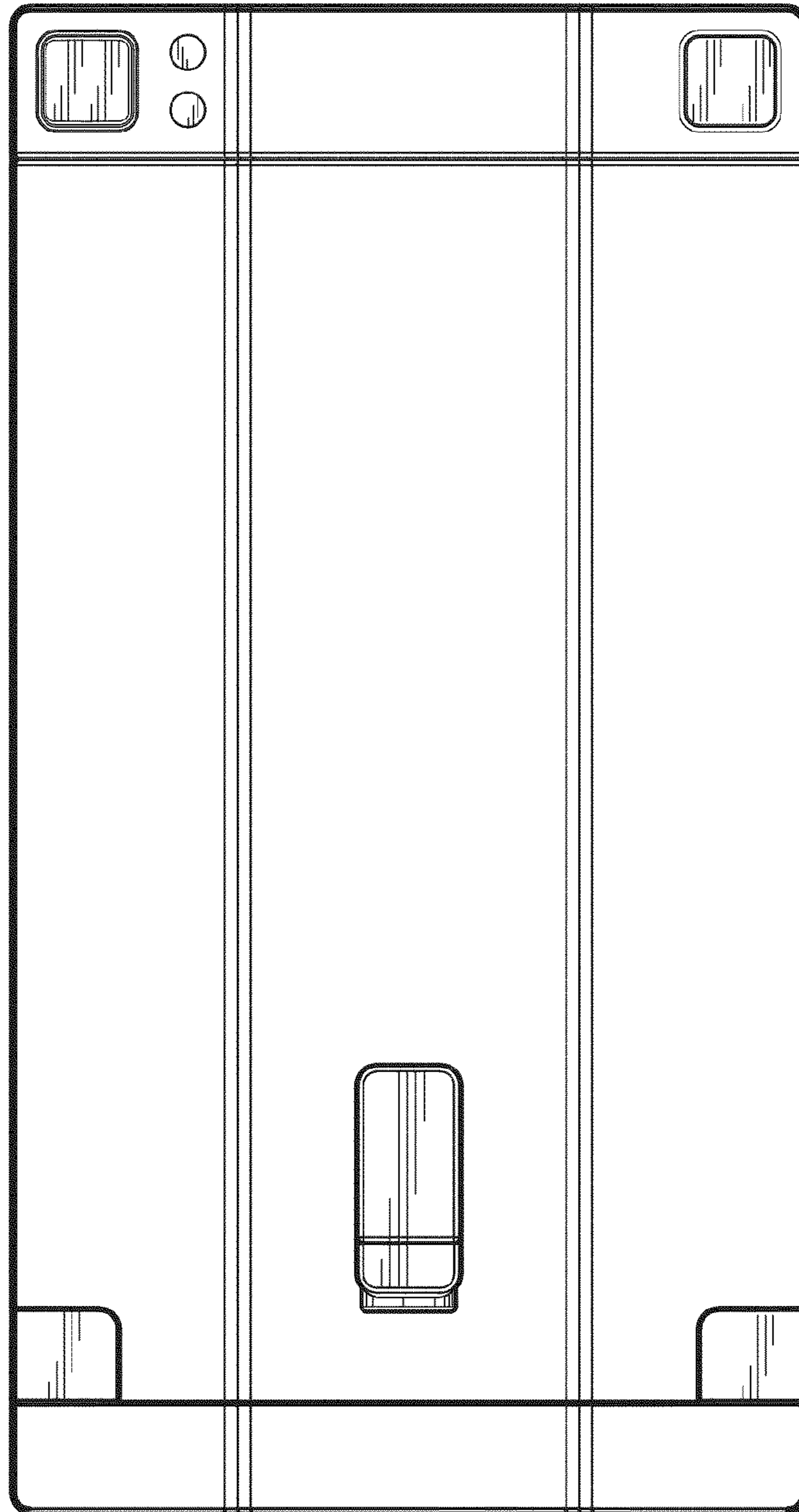

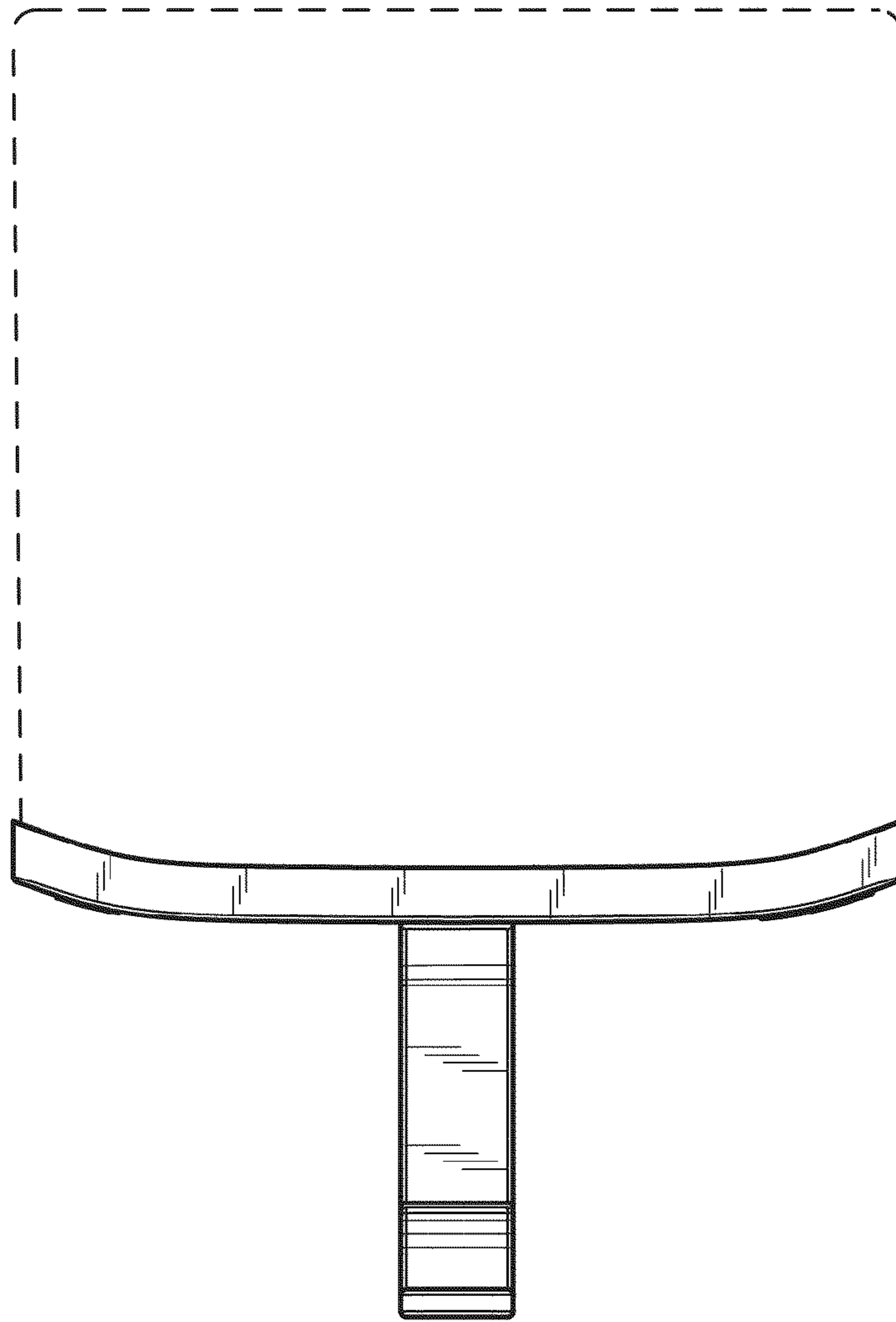

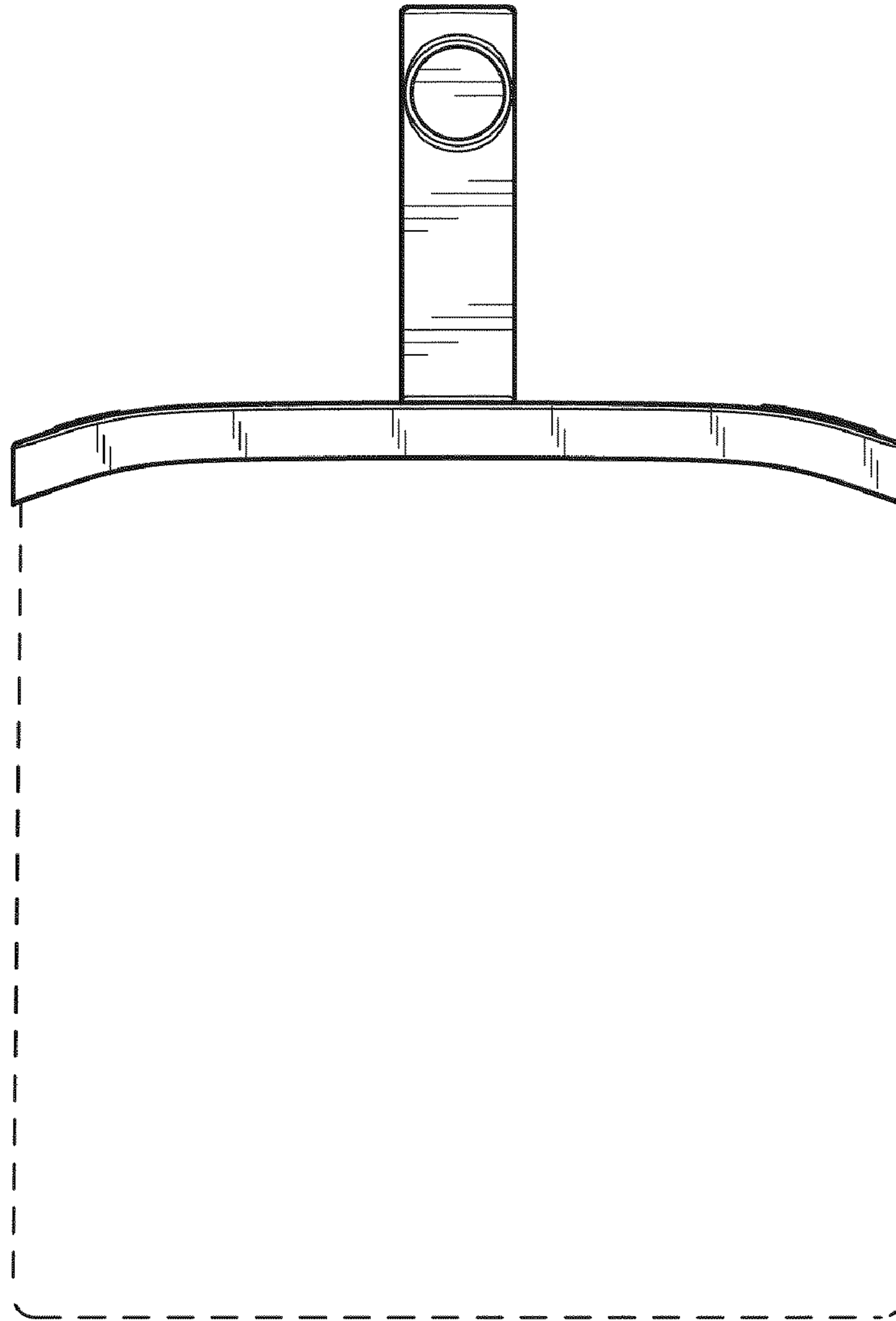

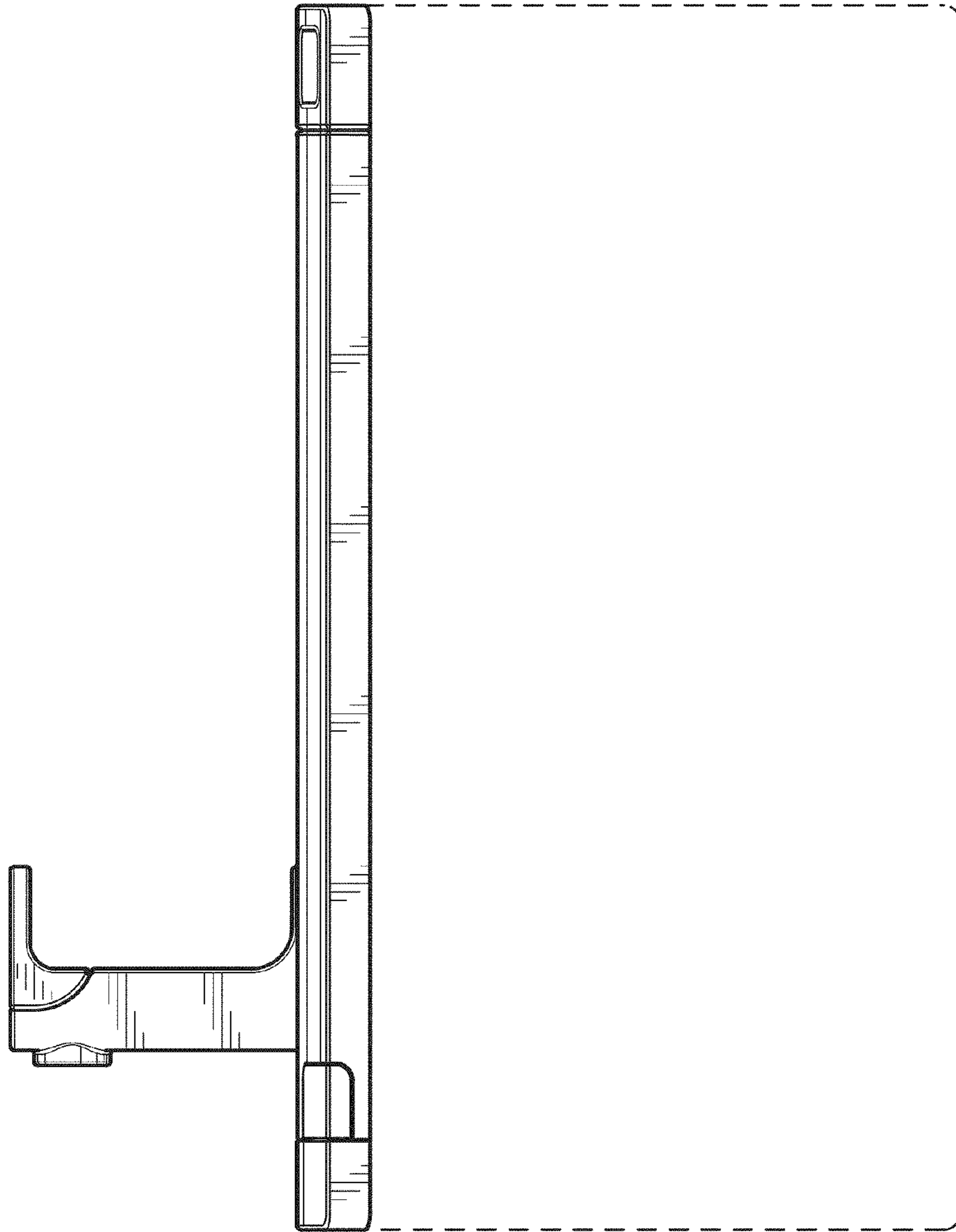
