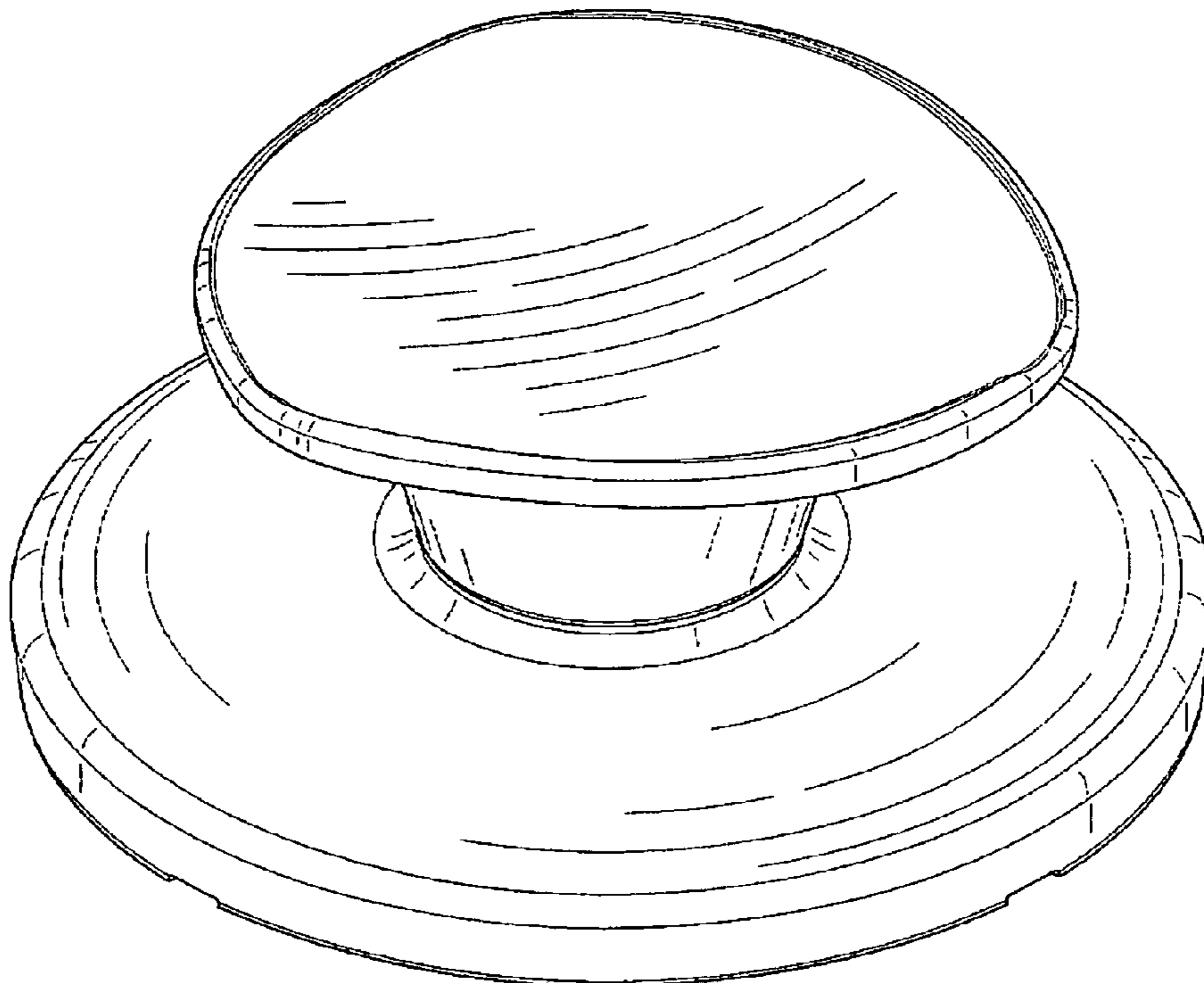
(57) **CLAIM**

I claim, the ornamental design for a knob for cooking utensils and apparatus, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a knob for cooking utensils and apparatus, showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken lines represent portions of the knob for cooking utensils and apparatus that form no part of the claim.

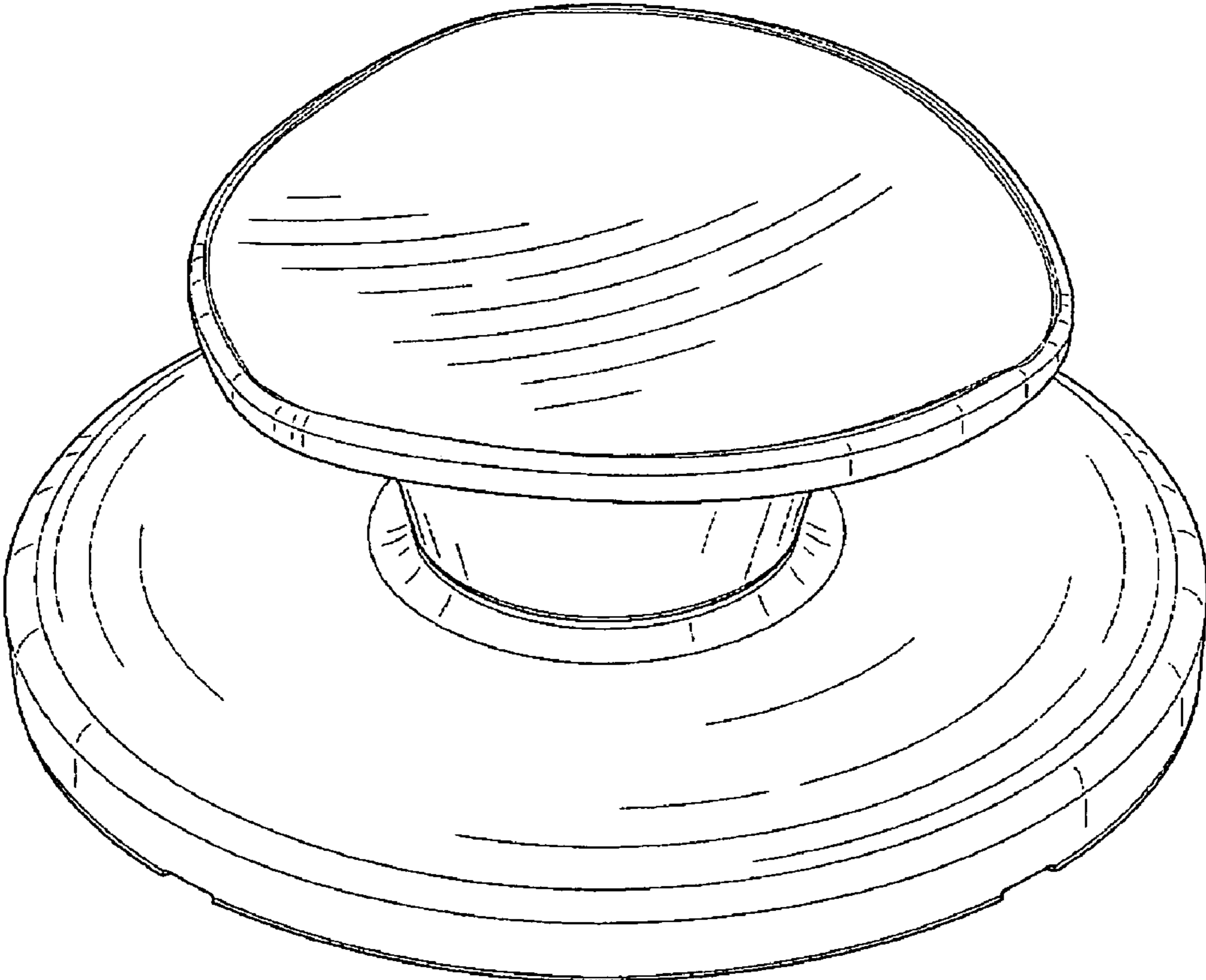

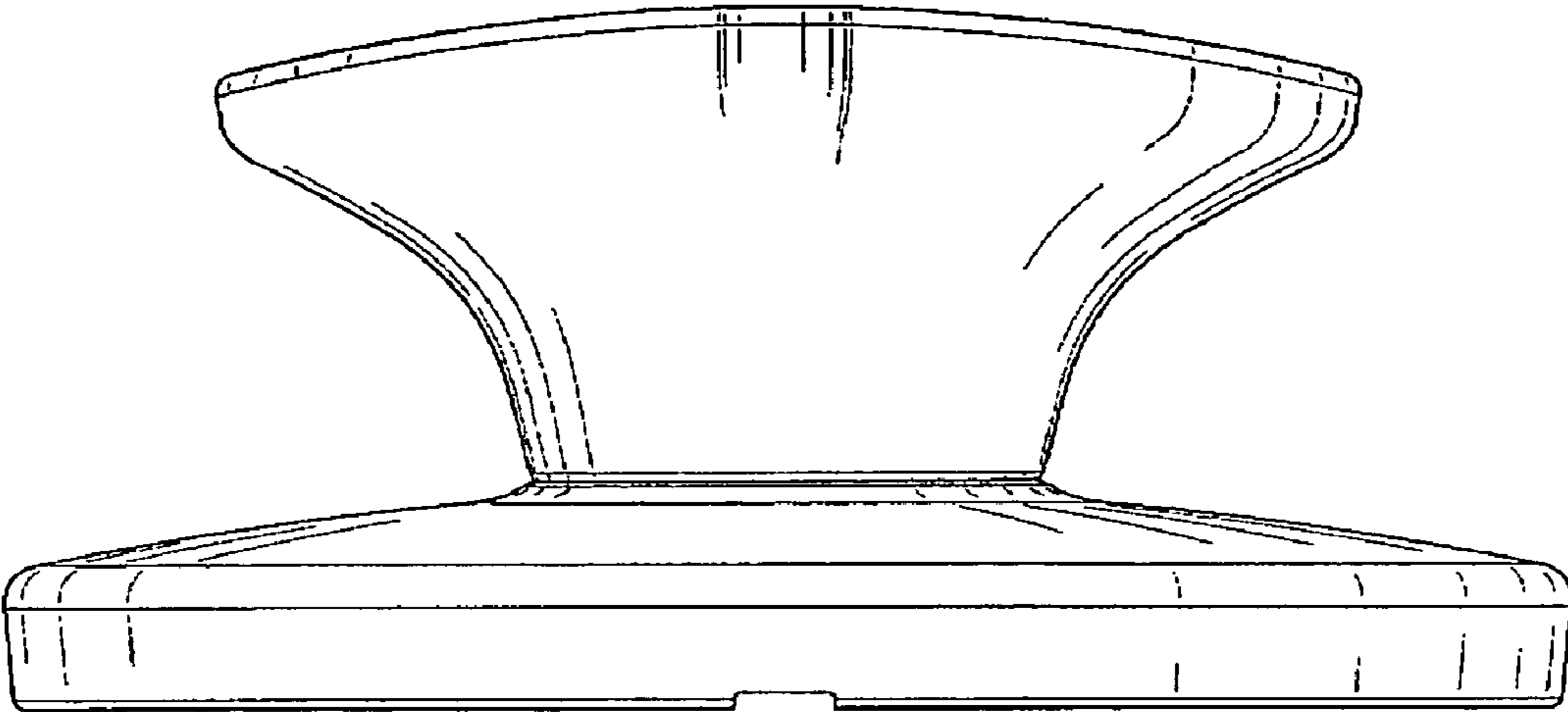

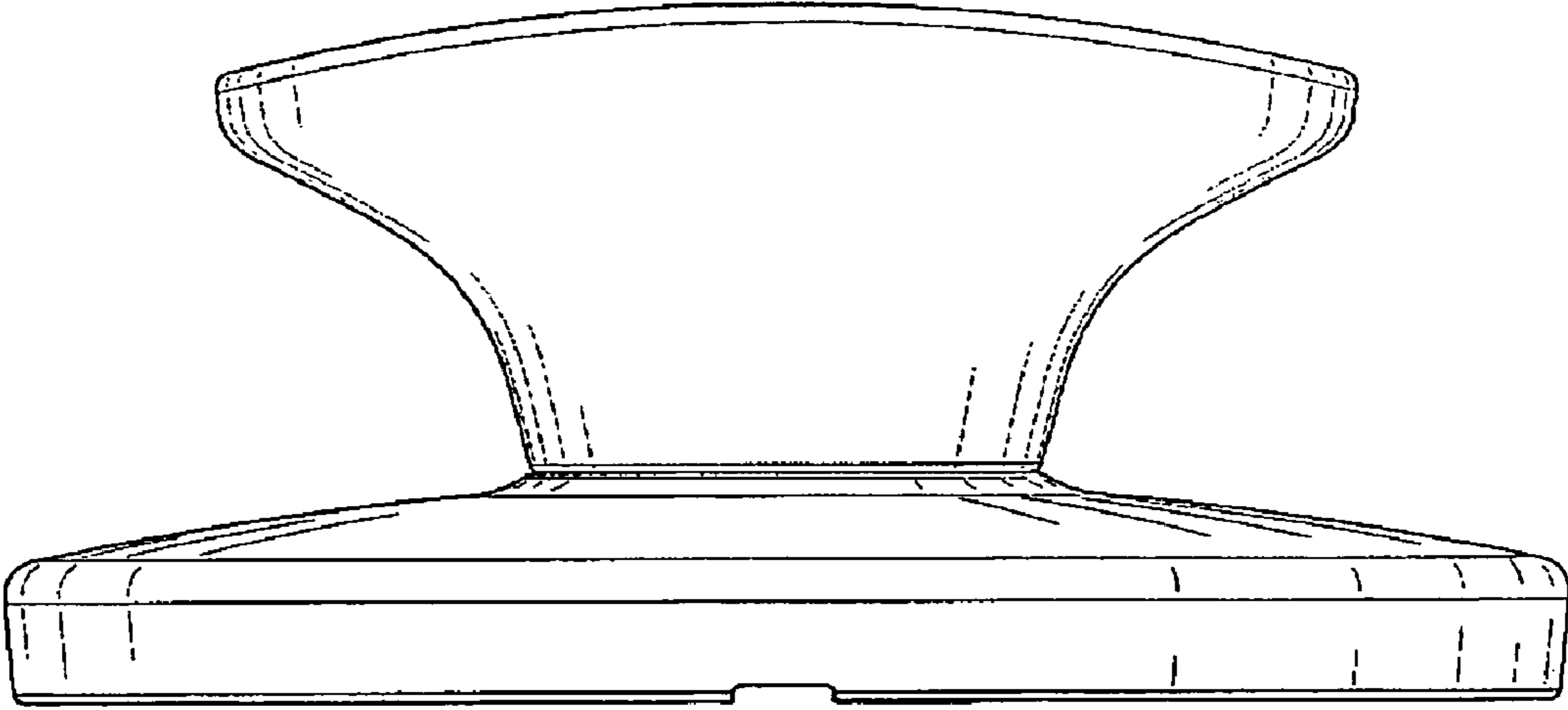

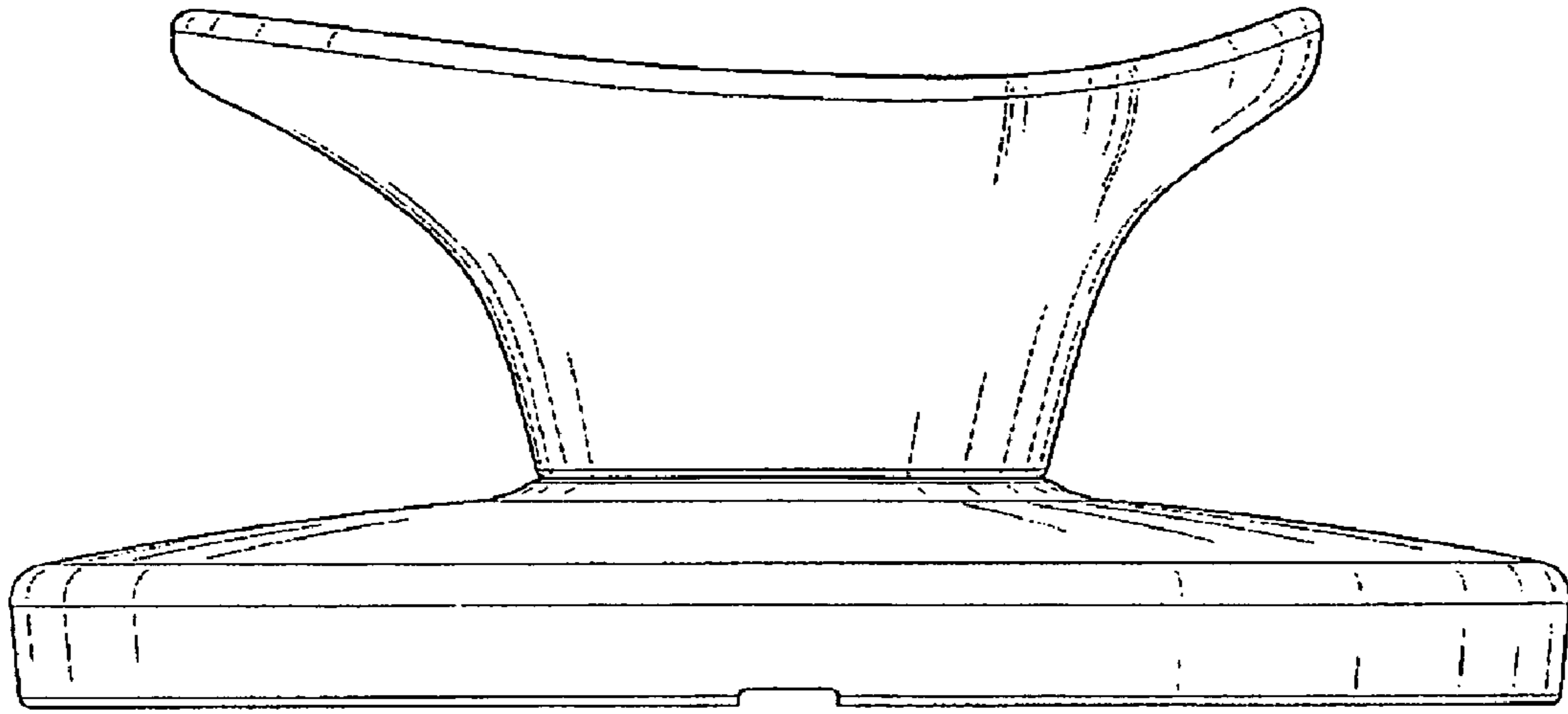

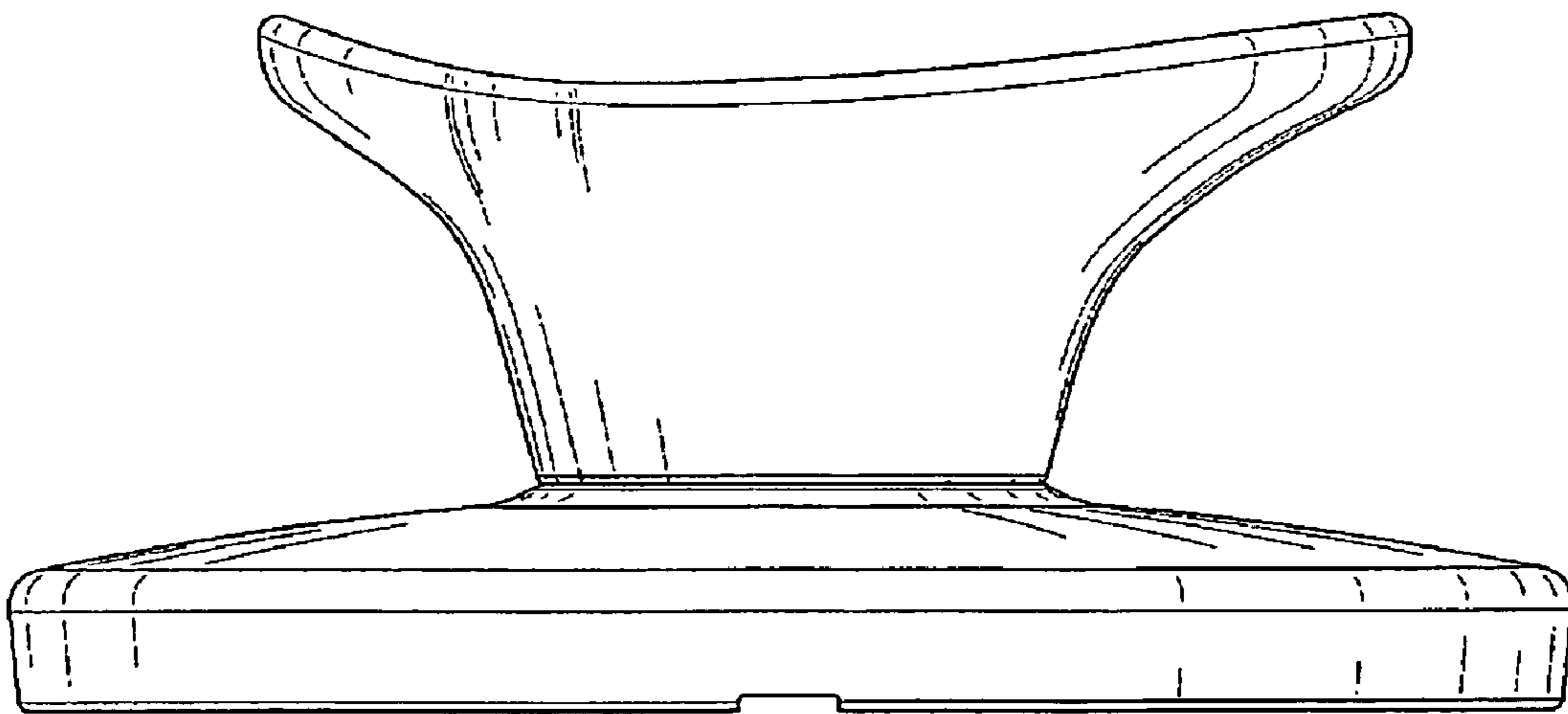

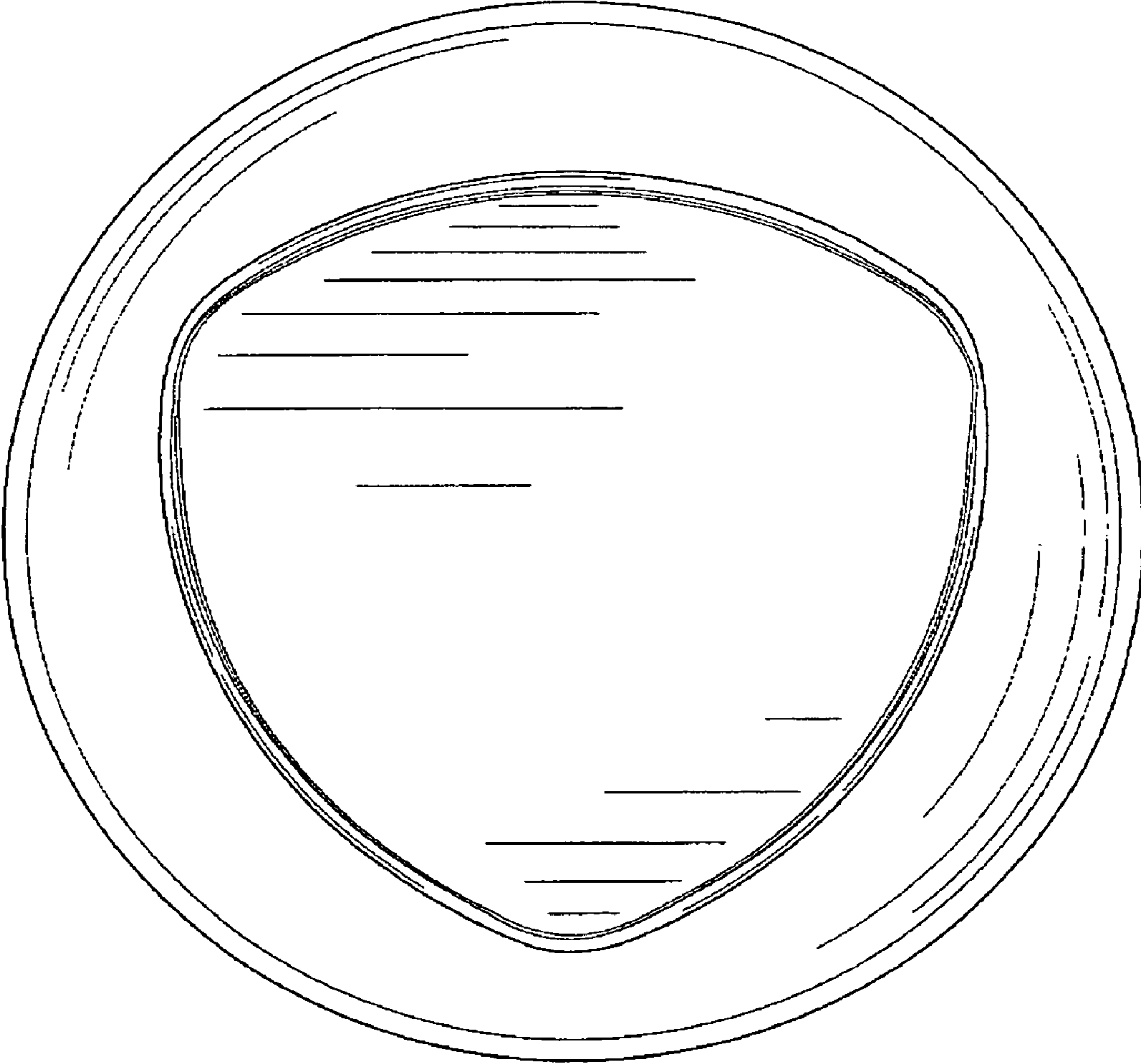

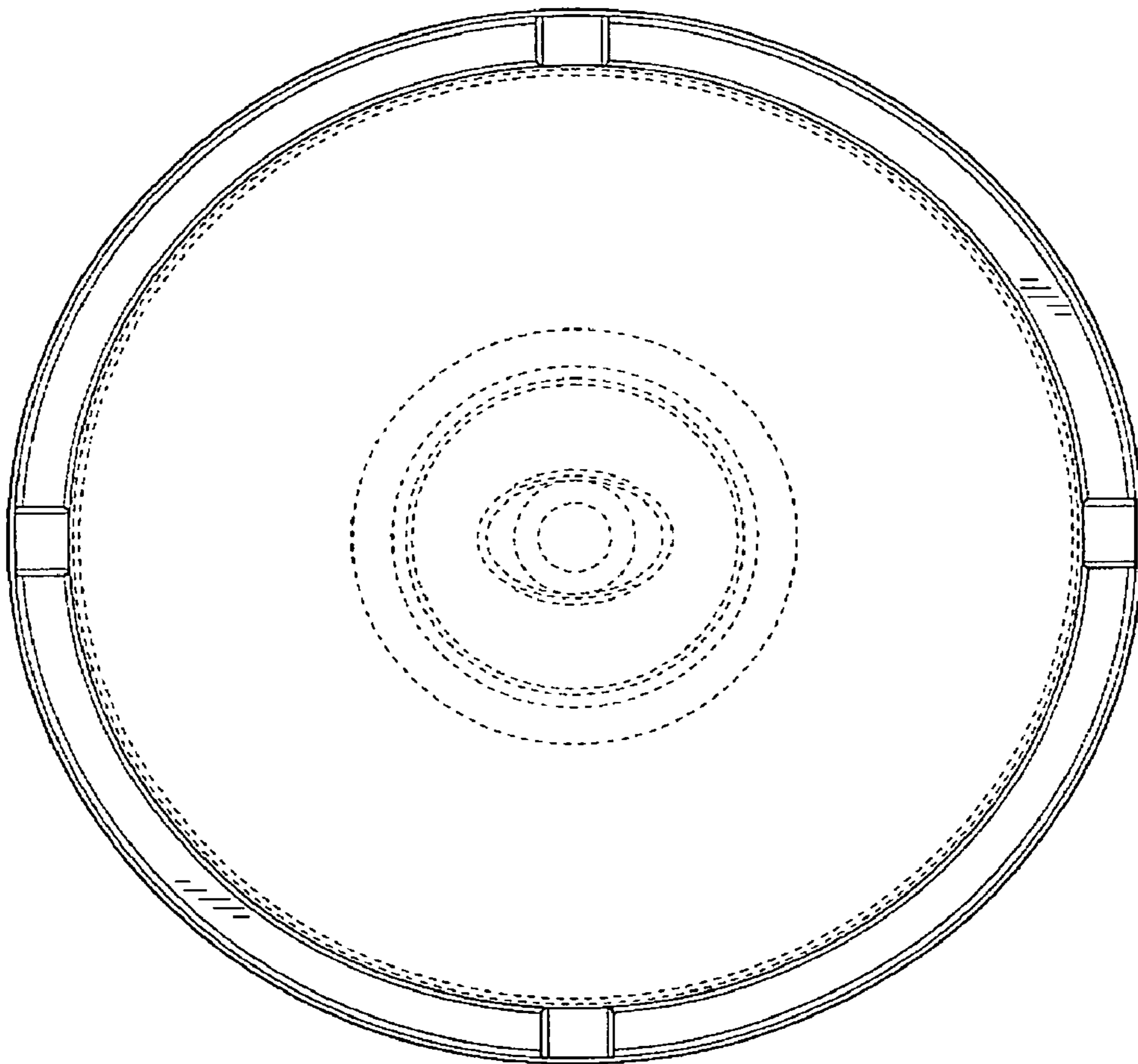
