**DESCRIPTION**

FIG. 1 is a right elevational view of a bottle according to a first embodiment of the present design;

FIG. 9 is a left side elevational view of the bottle of FIG. 7;

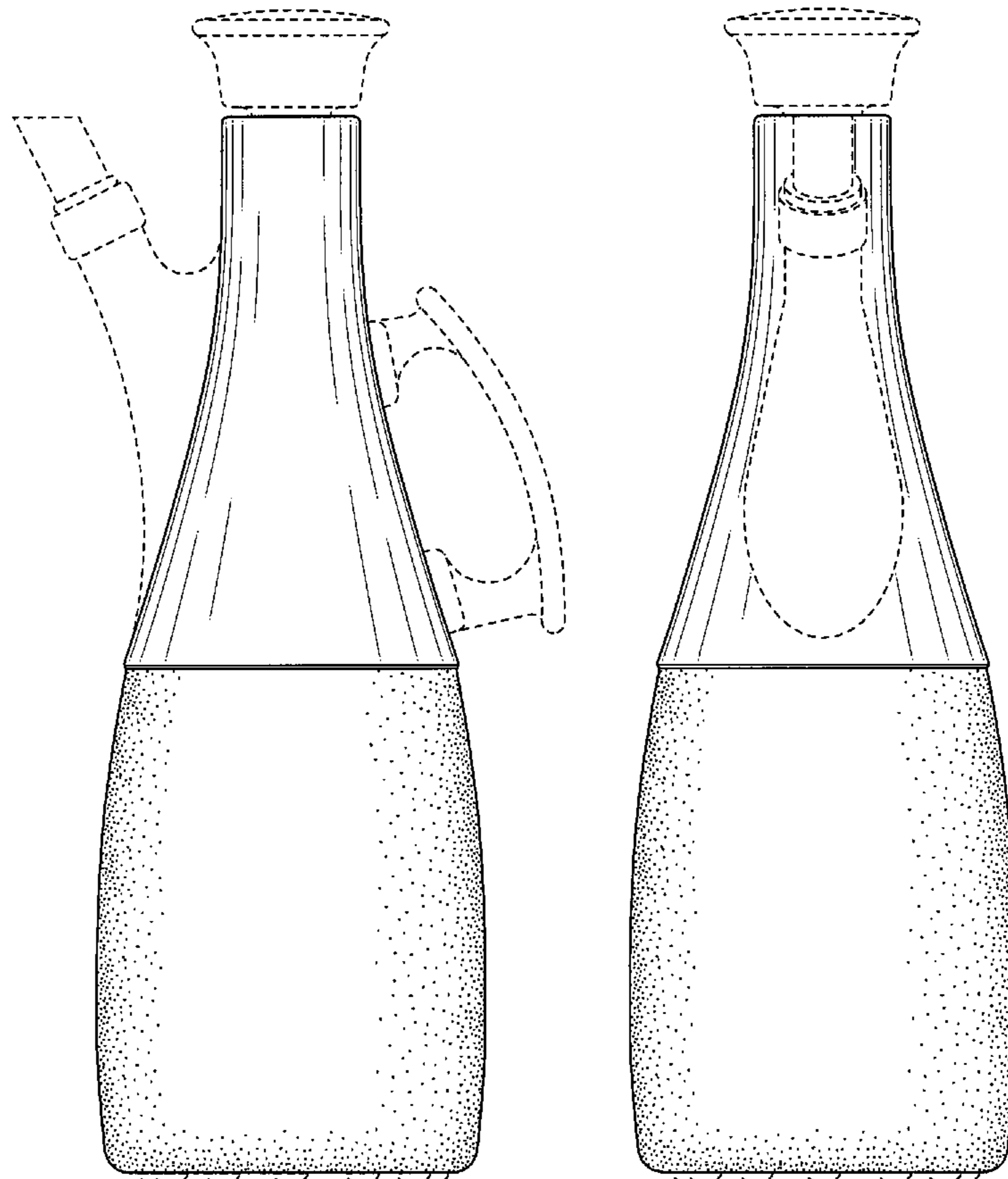
FIG. 10 is a rear side elevational view of the bottle of FIG. 7;

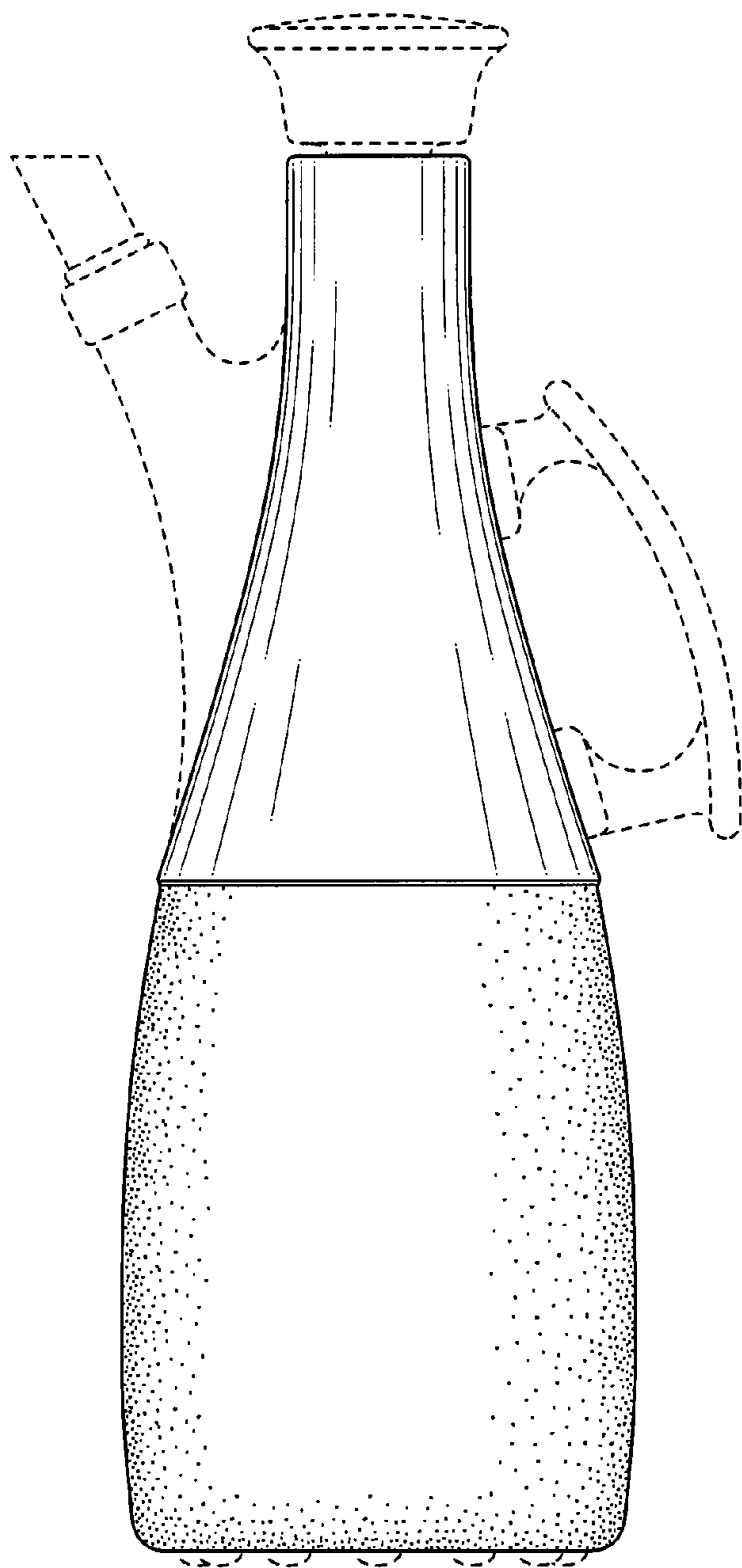
FIG. 11 is a top view of the bottle of FIG. 7; and,

FIG. 12 is a bottom view of the bottle of FIG. 7.

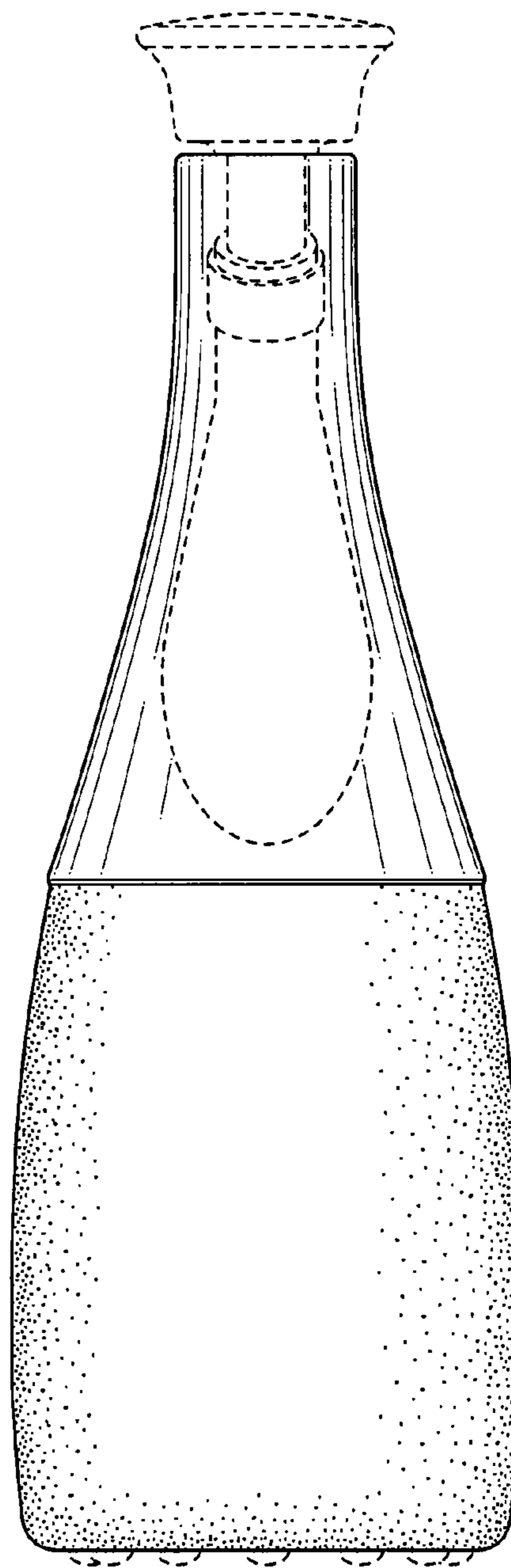

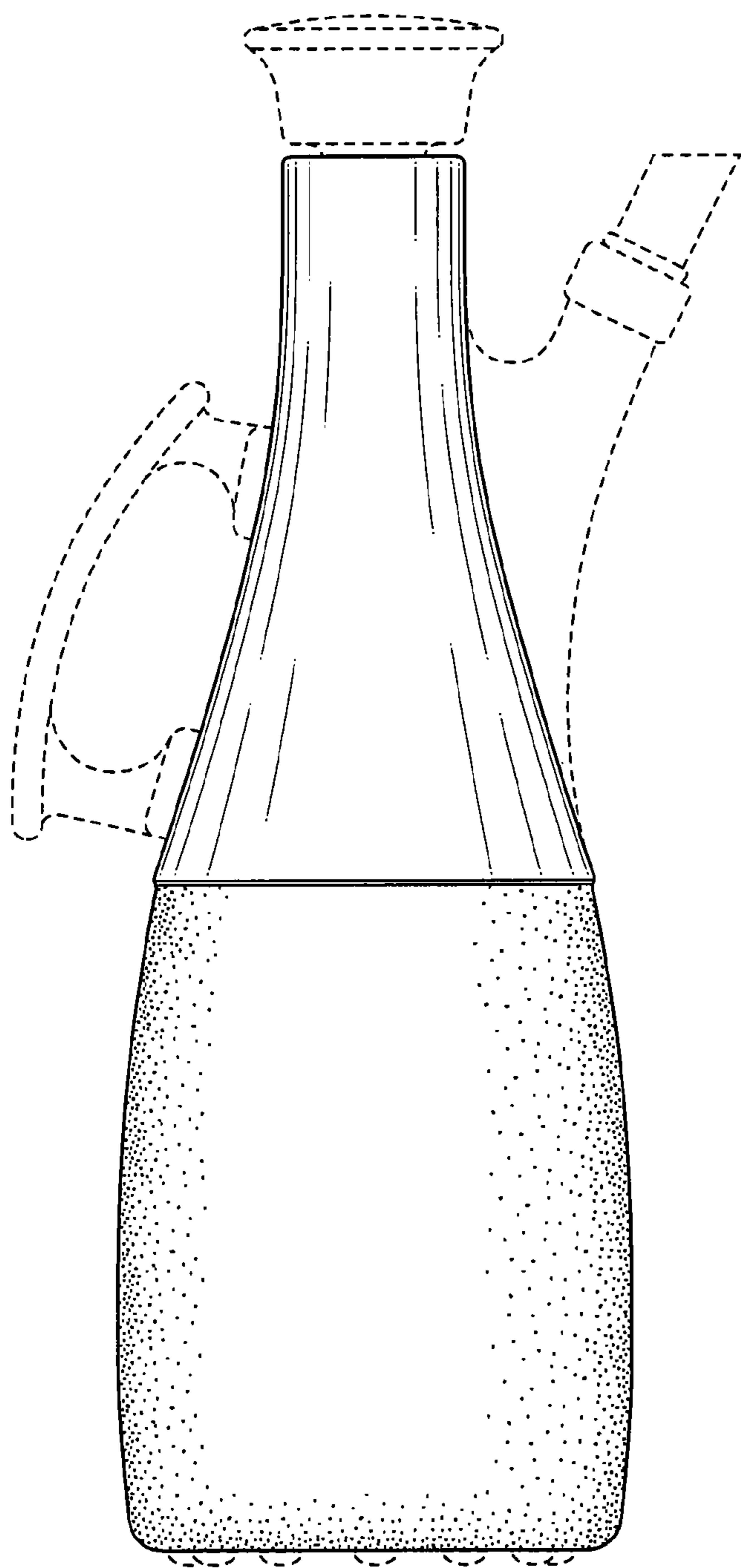




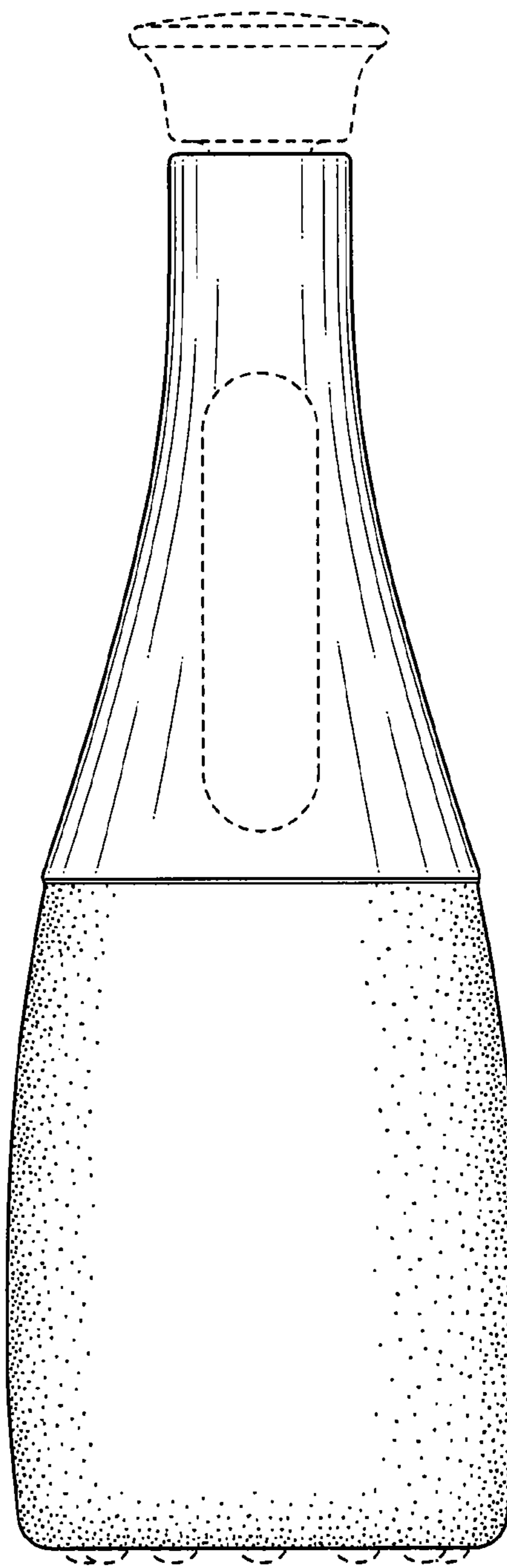

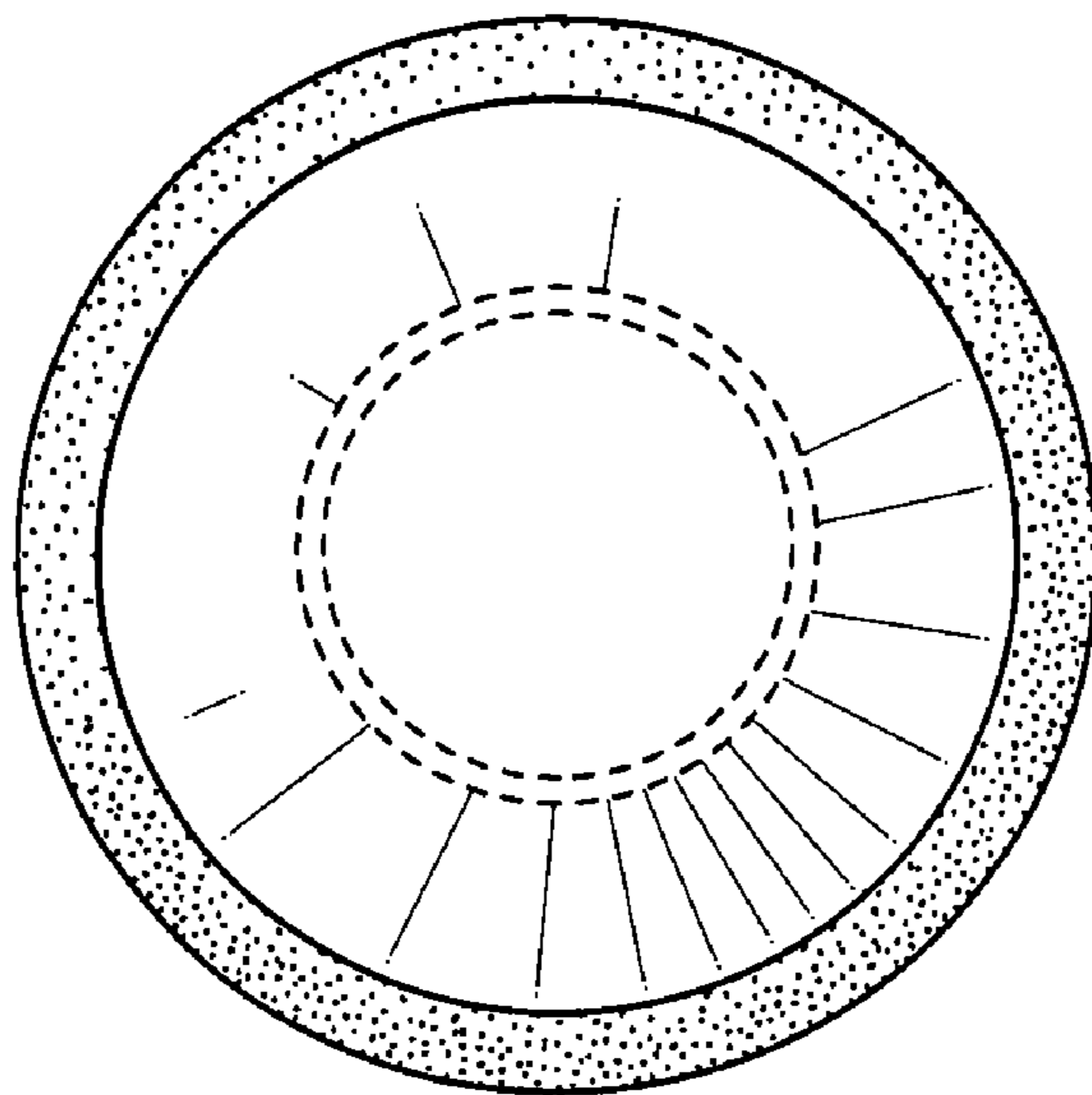

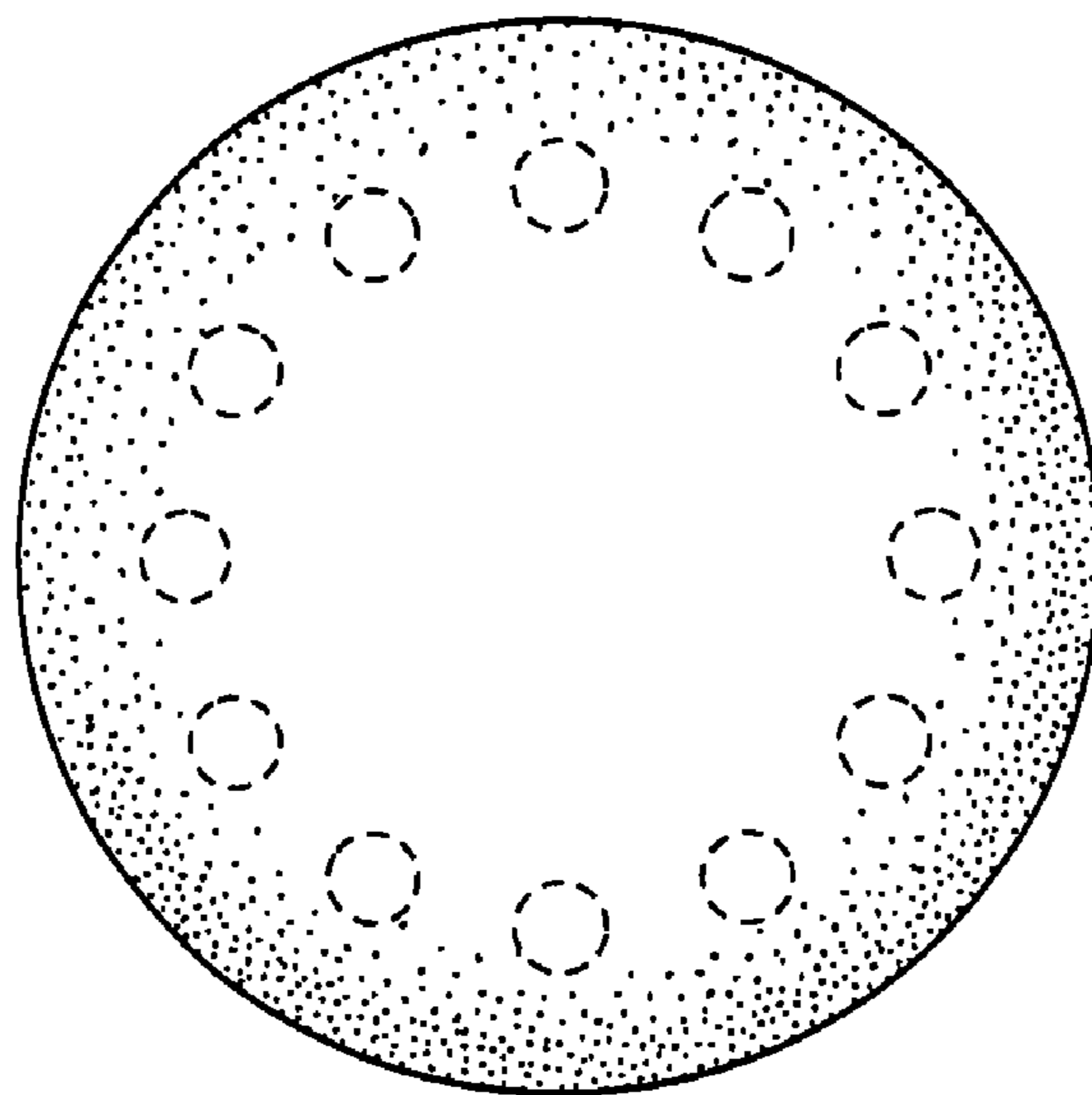

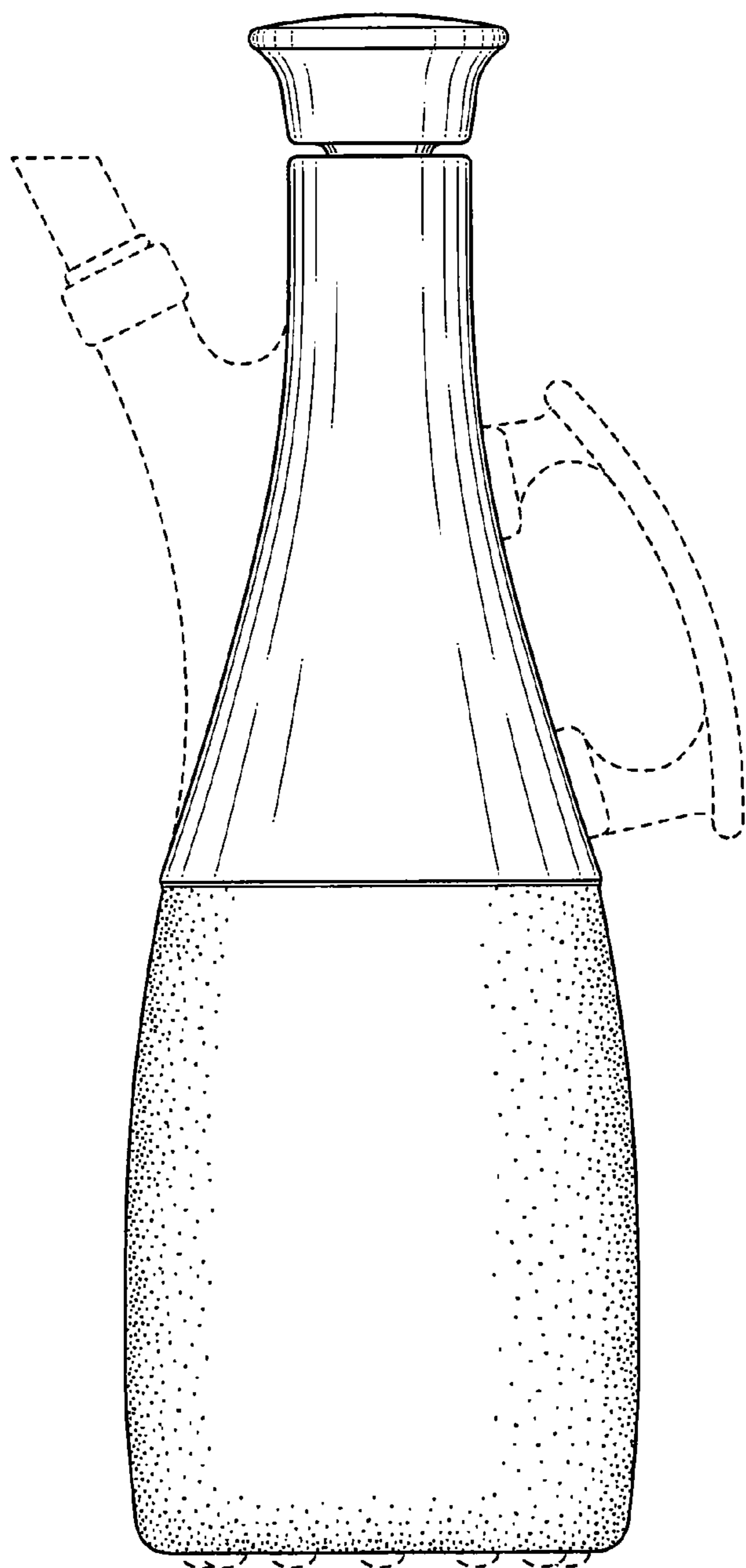

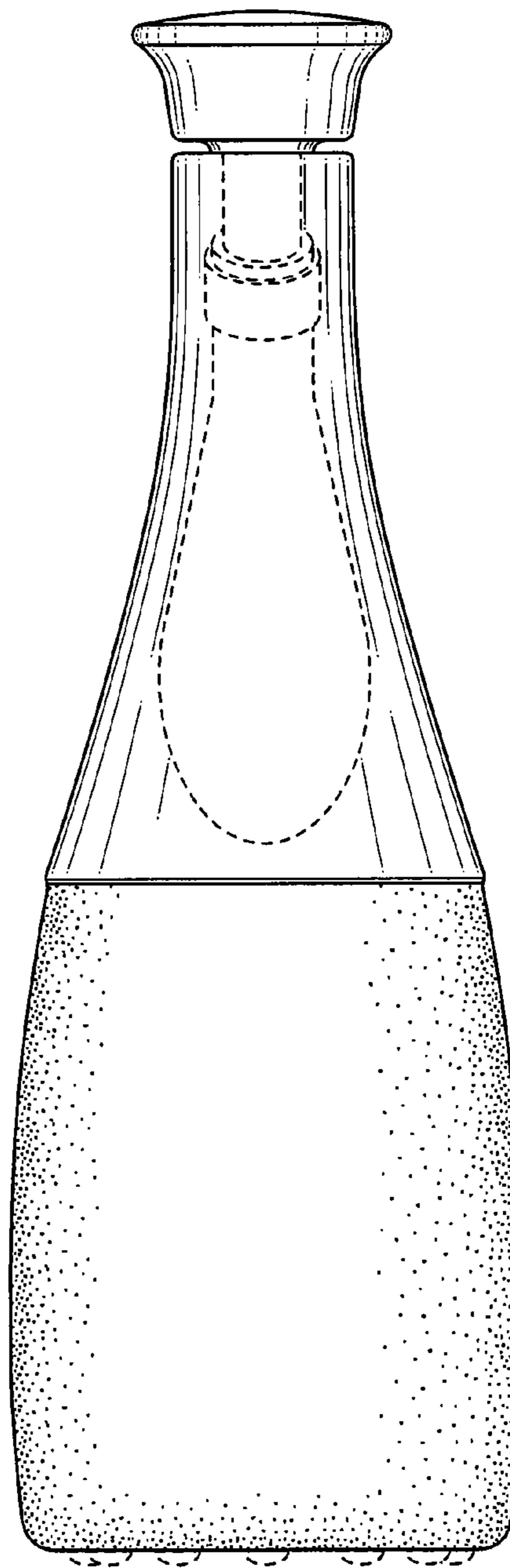

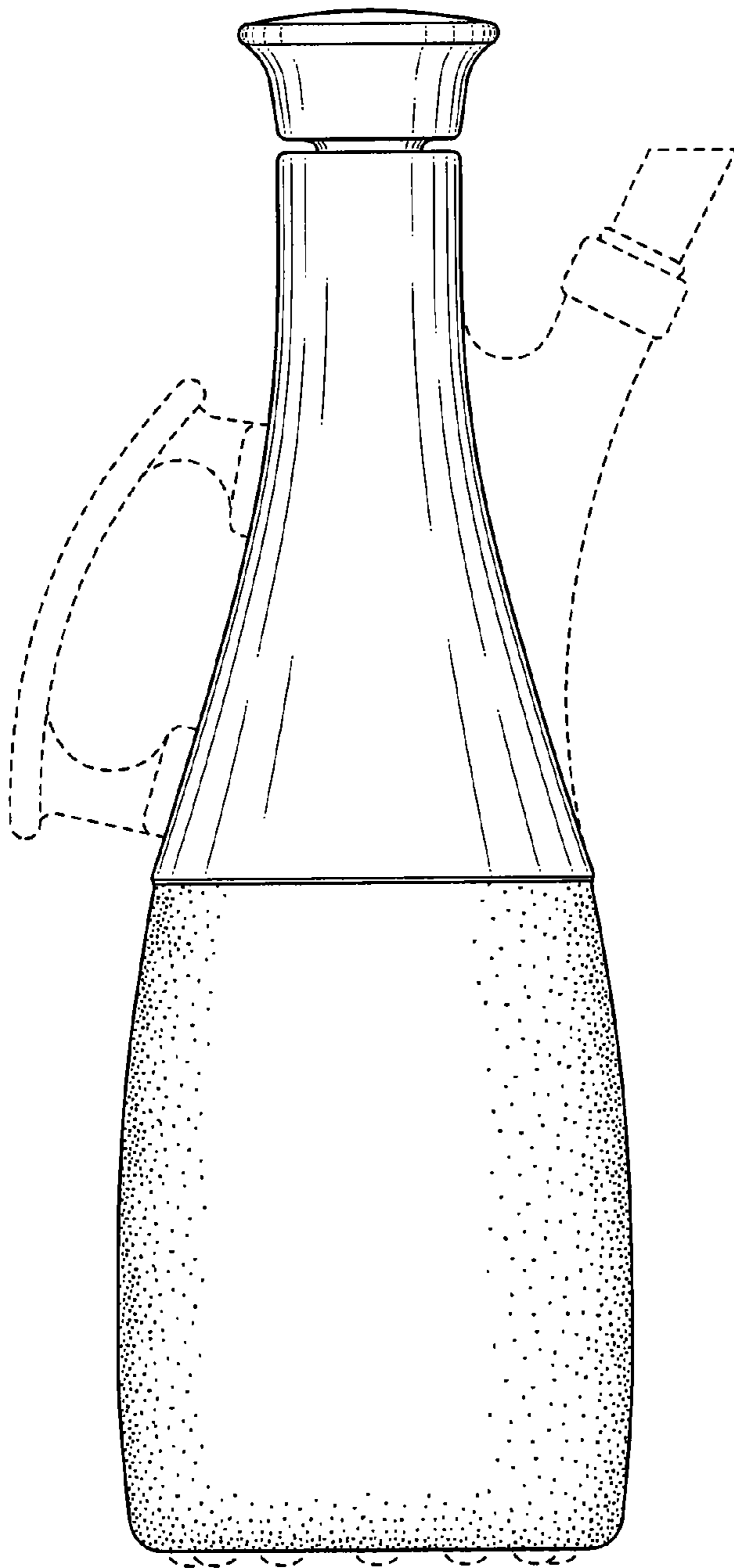

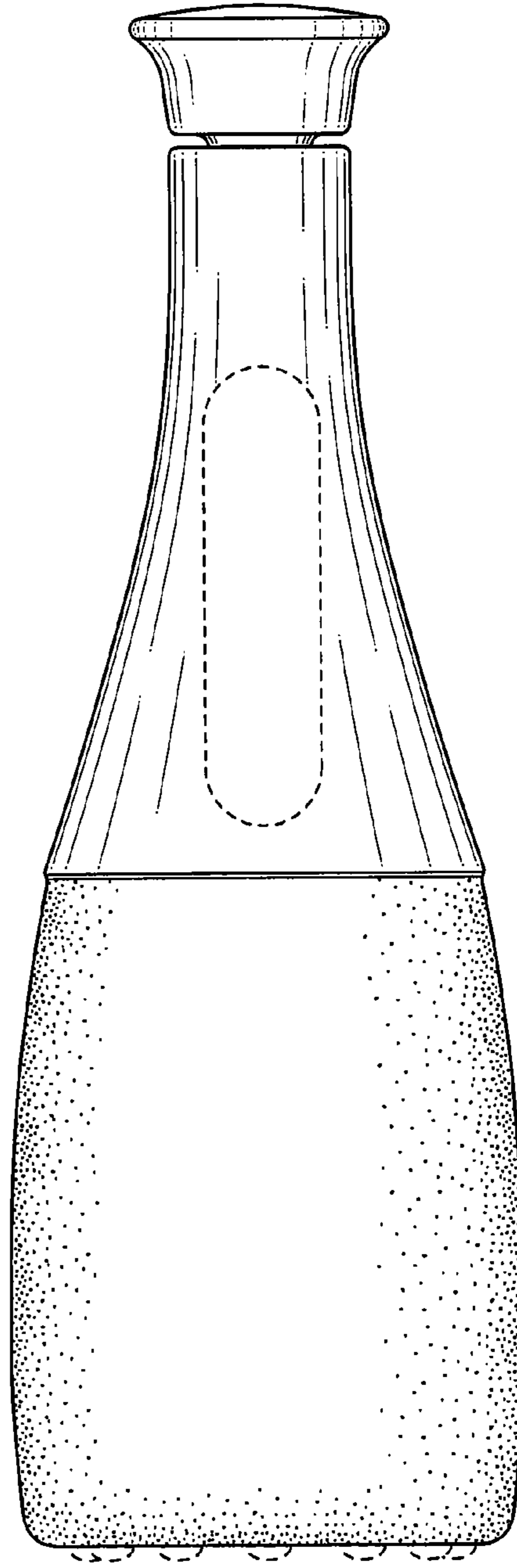

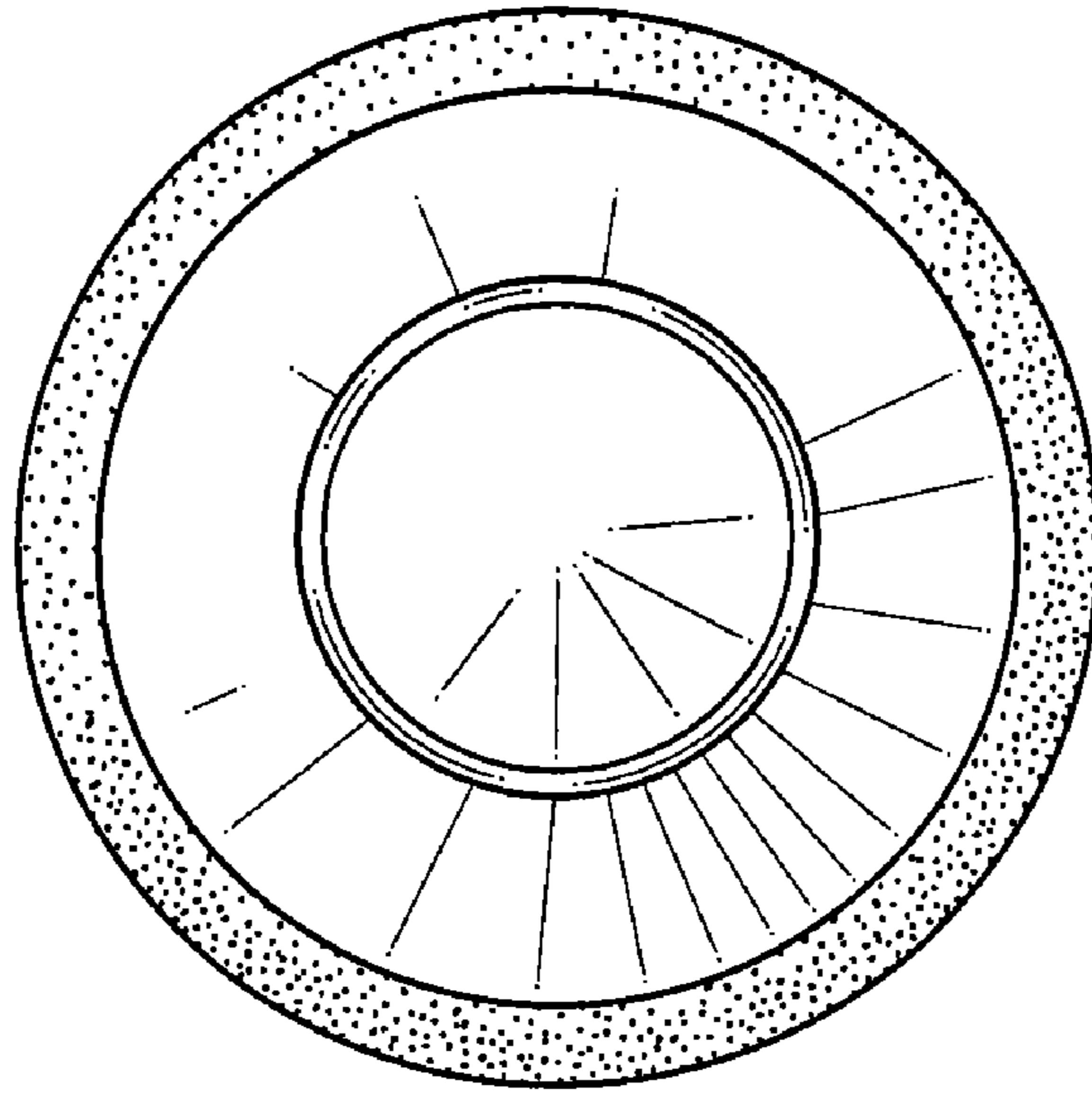

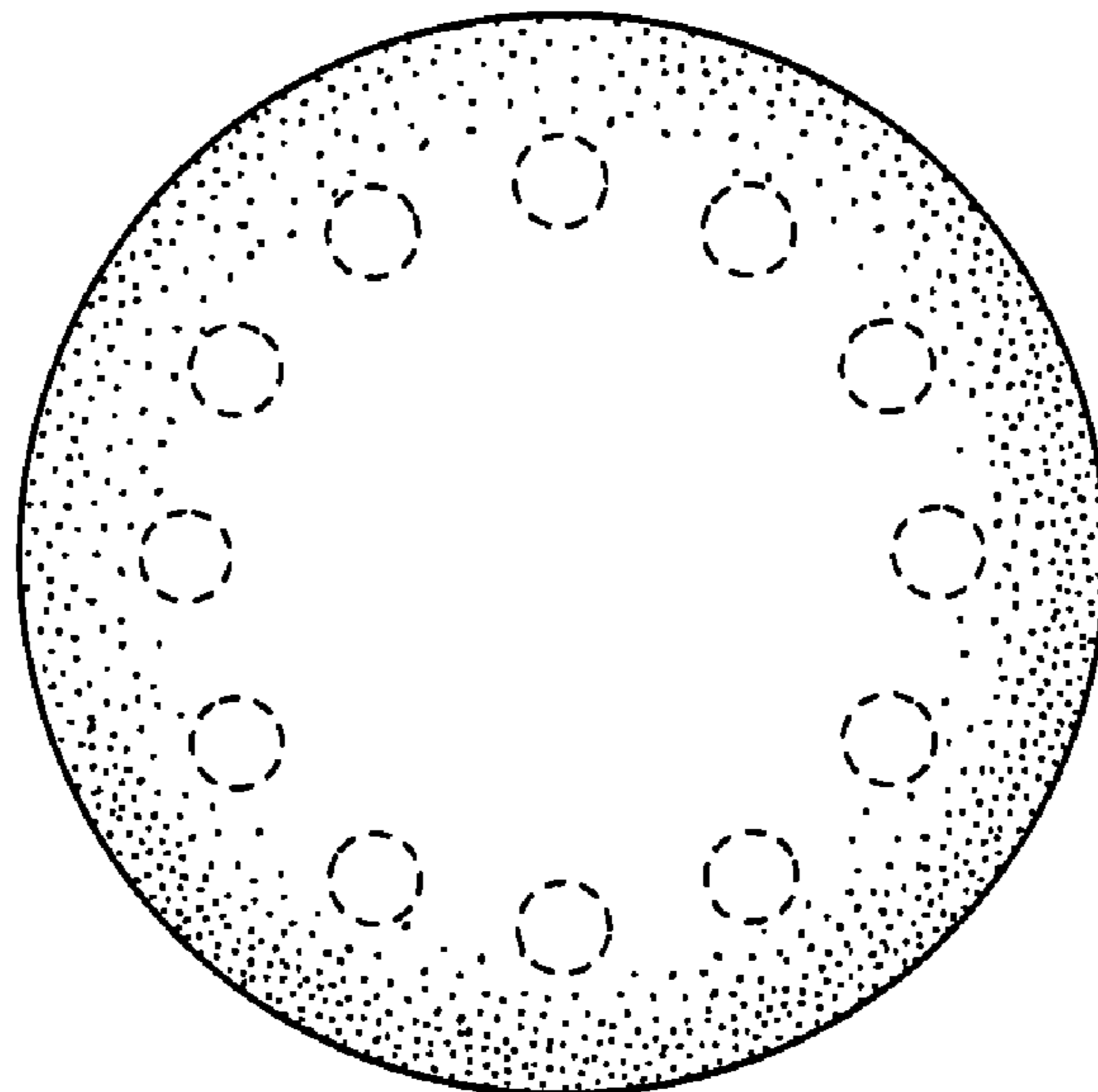
