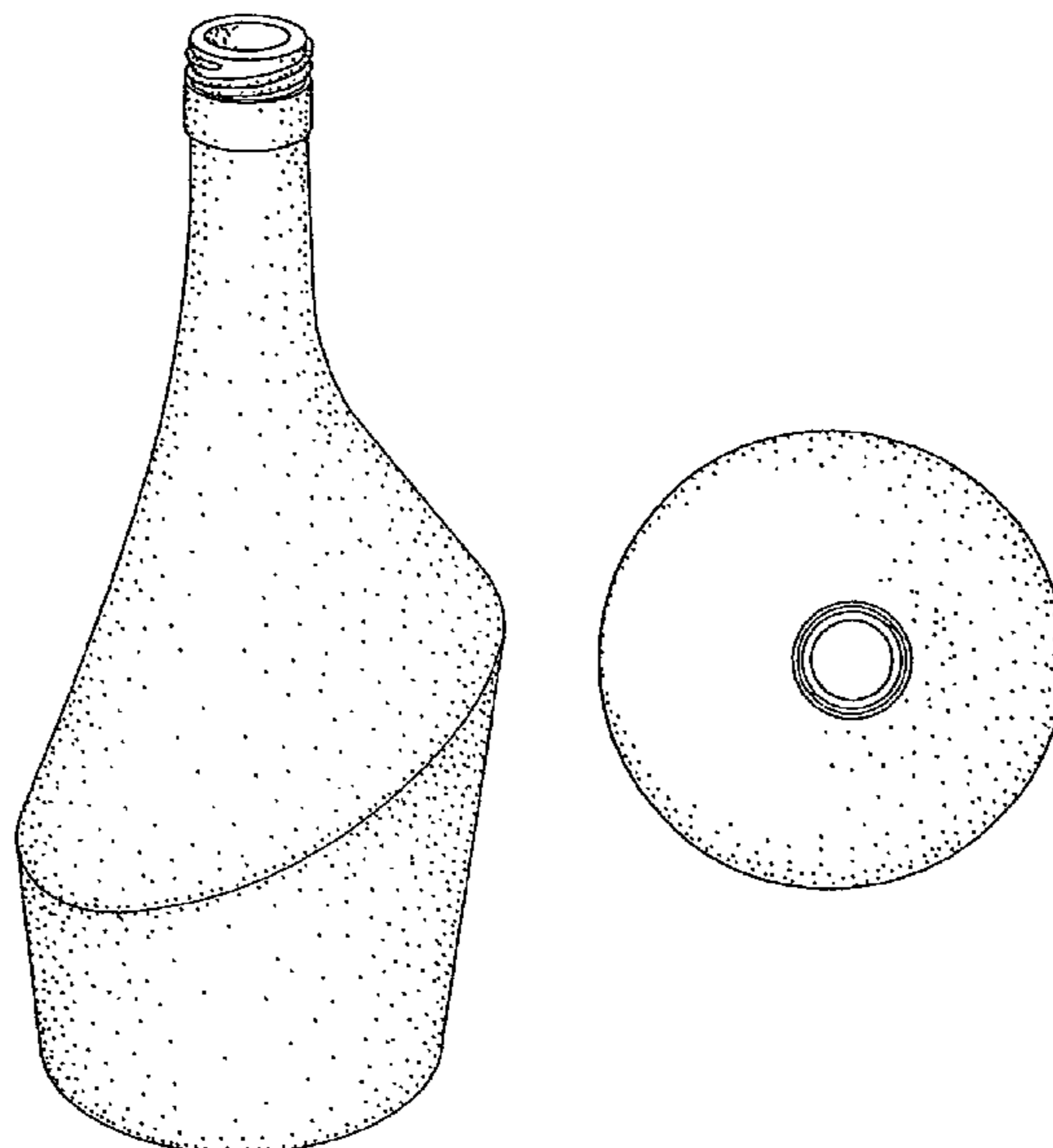
(57) **CLAIM**

The ornamental design for a liquor bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, rear, and right side perspective view of a liquor bottle showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a right side elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a right side elevational view thereof; and,
 FIG. 6 is a front elevational view thereof.
 The broken lines shown on the rear lower sidewall are included for the purpose of illustrating environmental structure and form no part of the claimed design.

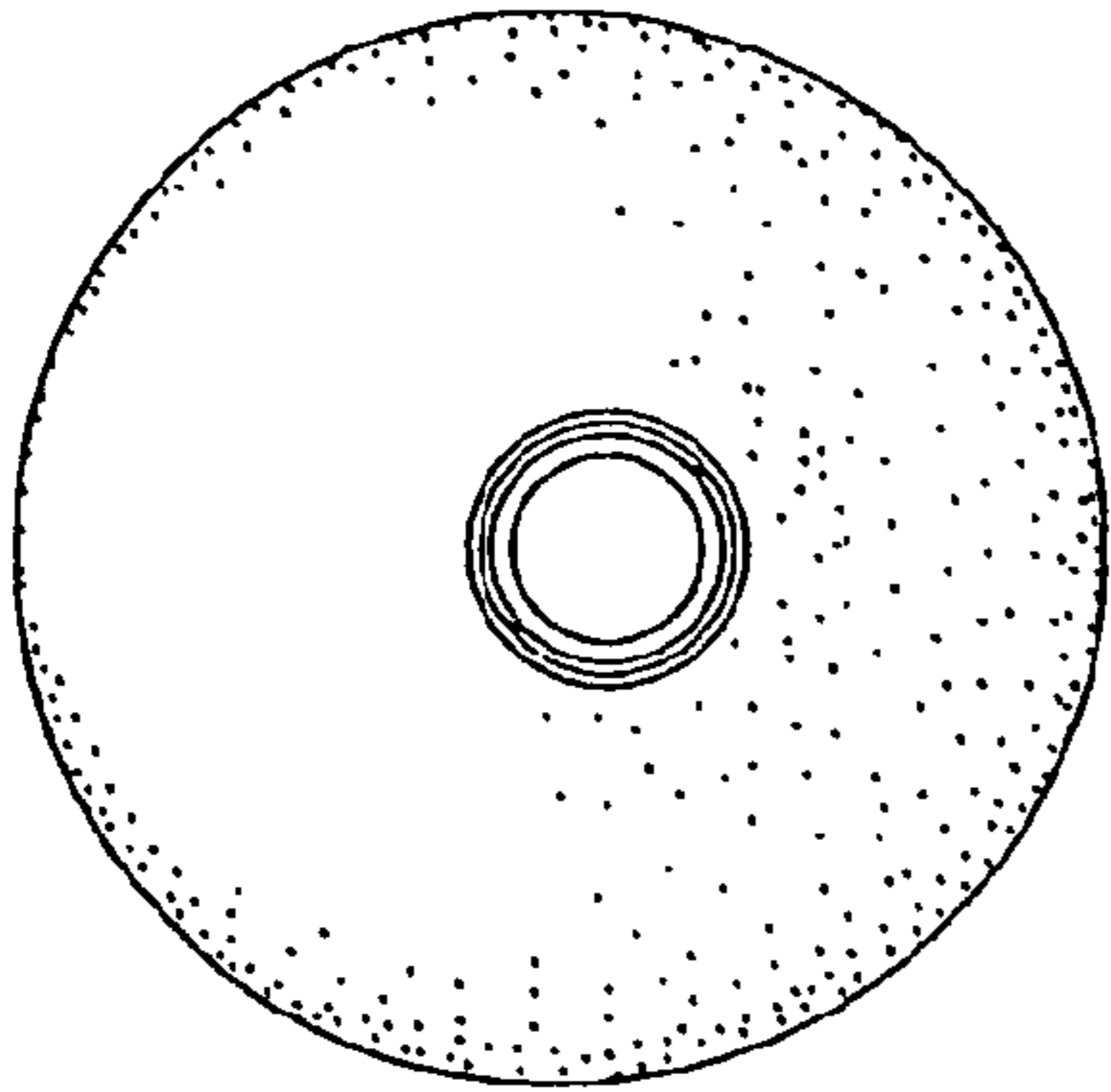

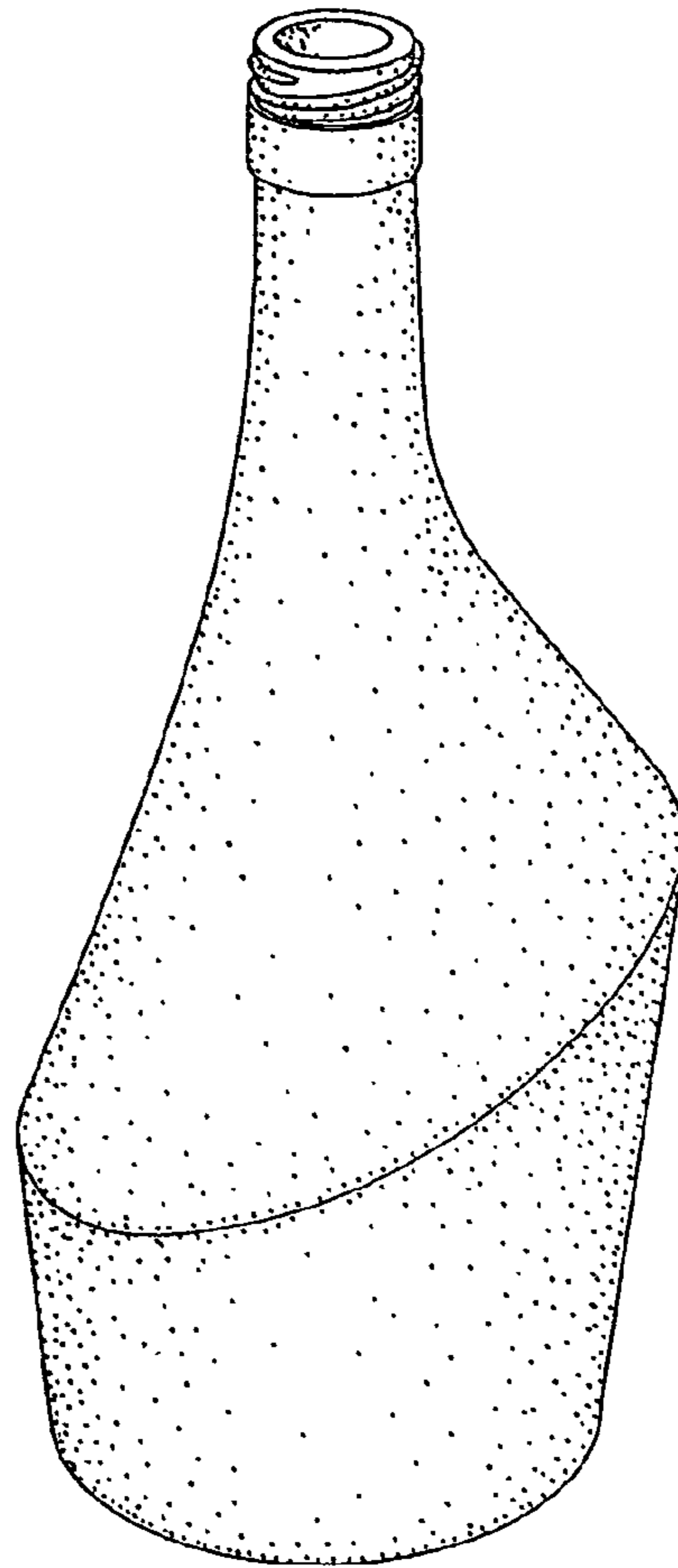

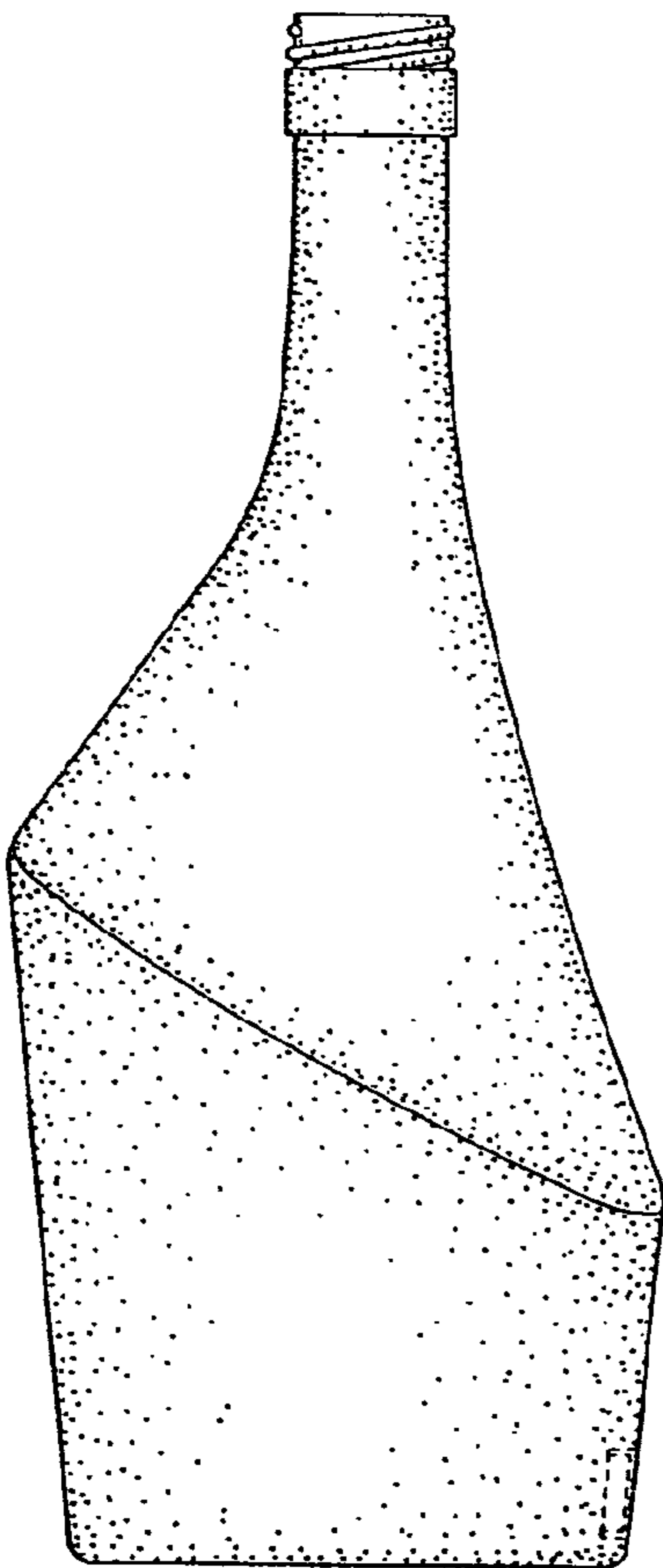

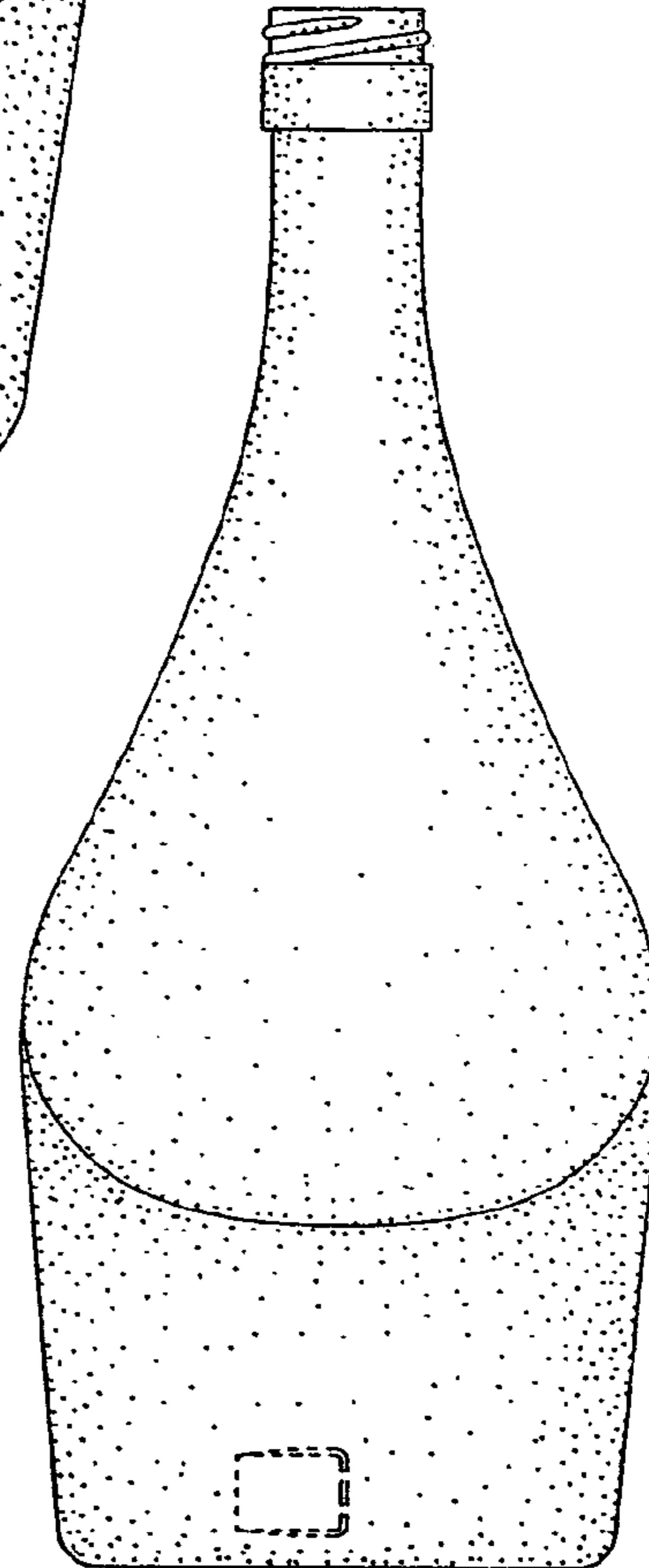

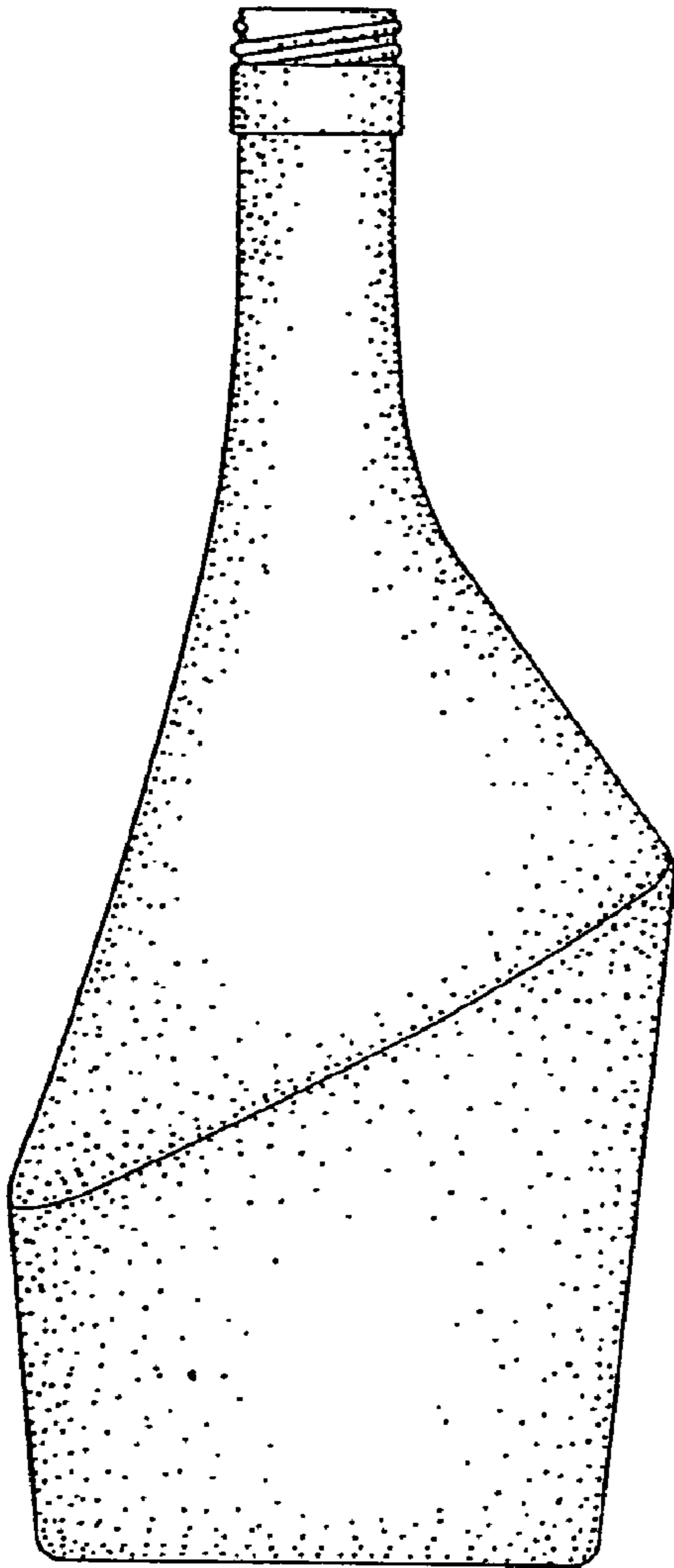

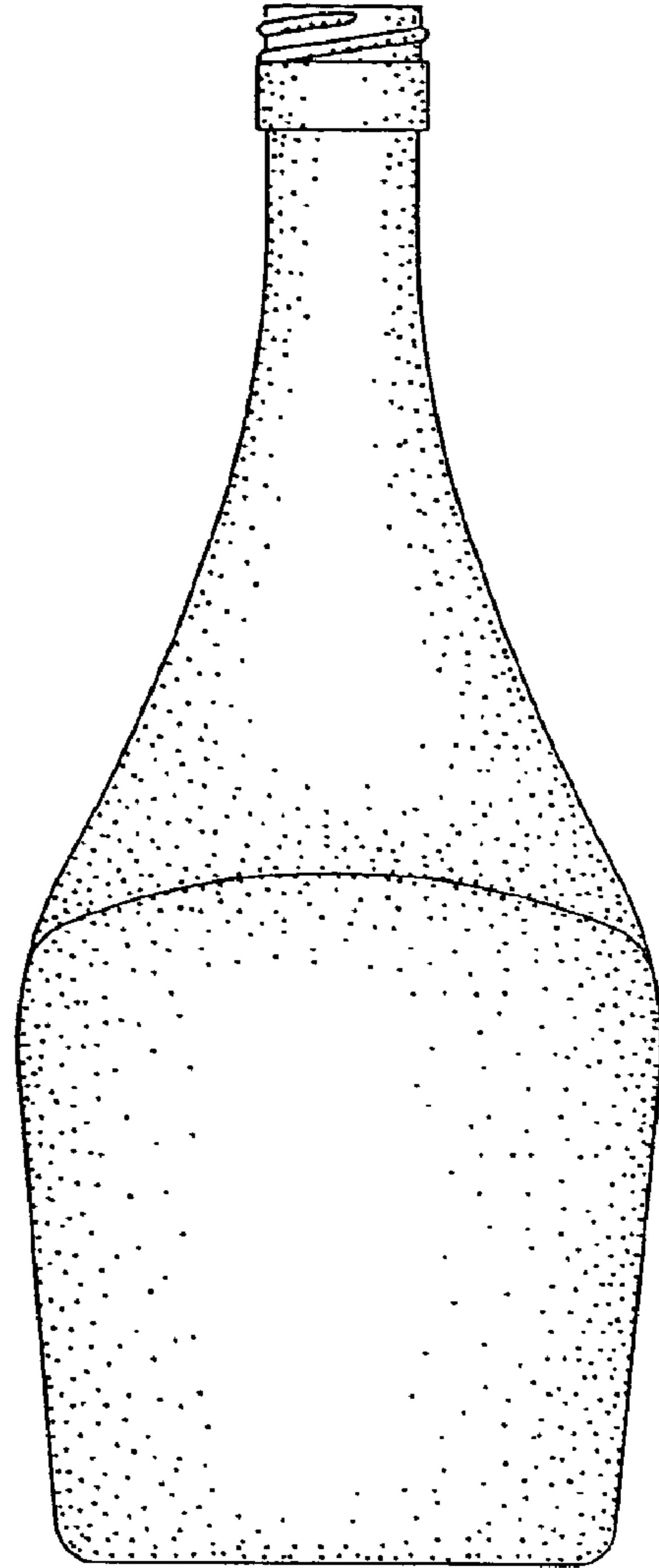
