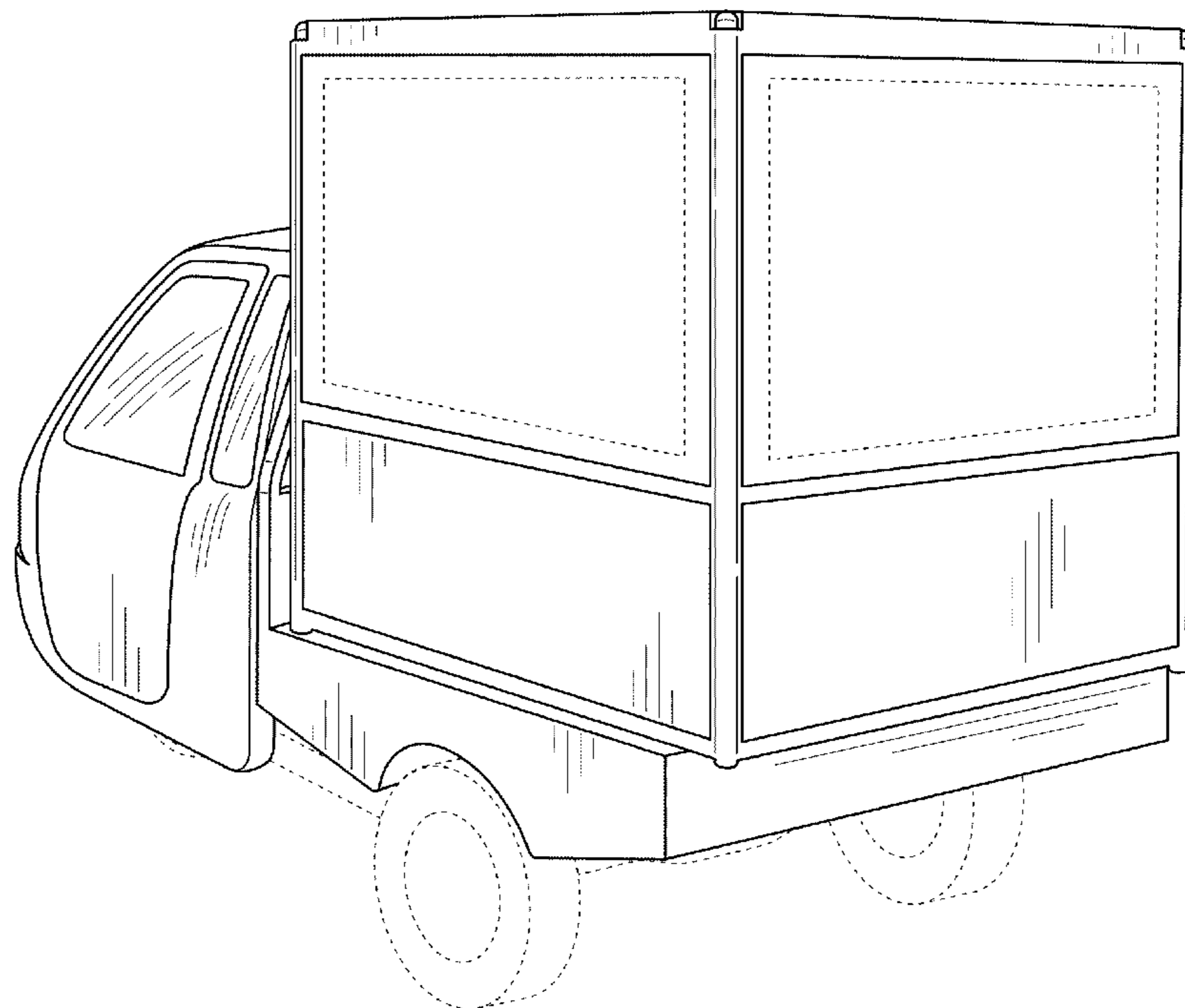

I claim the ornamental design for a promotional vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the promotional vehicle of the present invention having panels in a closed position;
 FIG. 2 is a front view of the promotional vehicle, having panels in a closed position;
 FIG. 3 is a rear view of the promotional vehicle, having panels in a closed position;
 FIG. 4 is a left side view of the promotional vehicle having panels in an open position;
 FIG. 5 is a right side view of the promotional vehicle having panels in an open position;
 FIG. 6 is a top view of the promotional vehicle having panels in a closed position; and,
 FIG. 7 is a perspective view of the promotional vehicle, having panels in an open position.

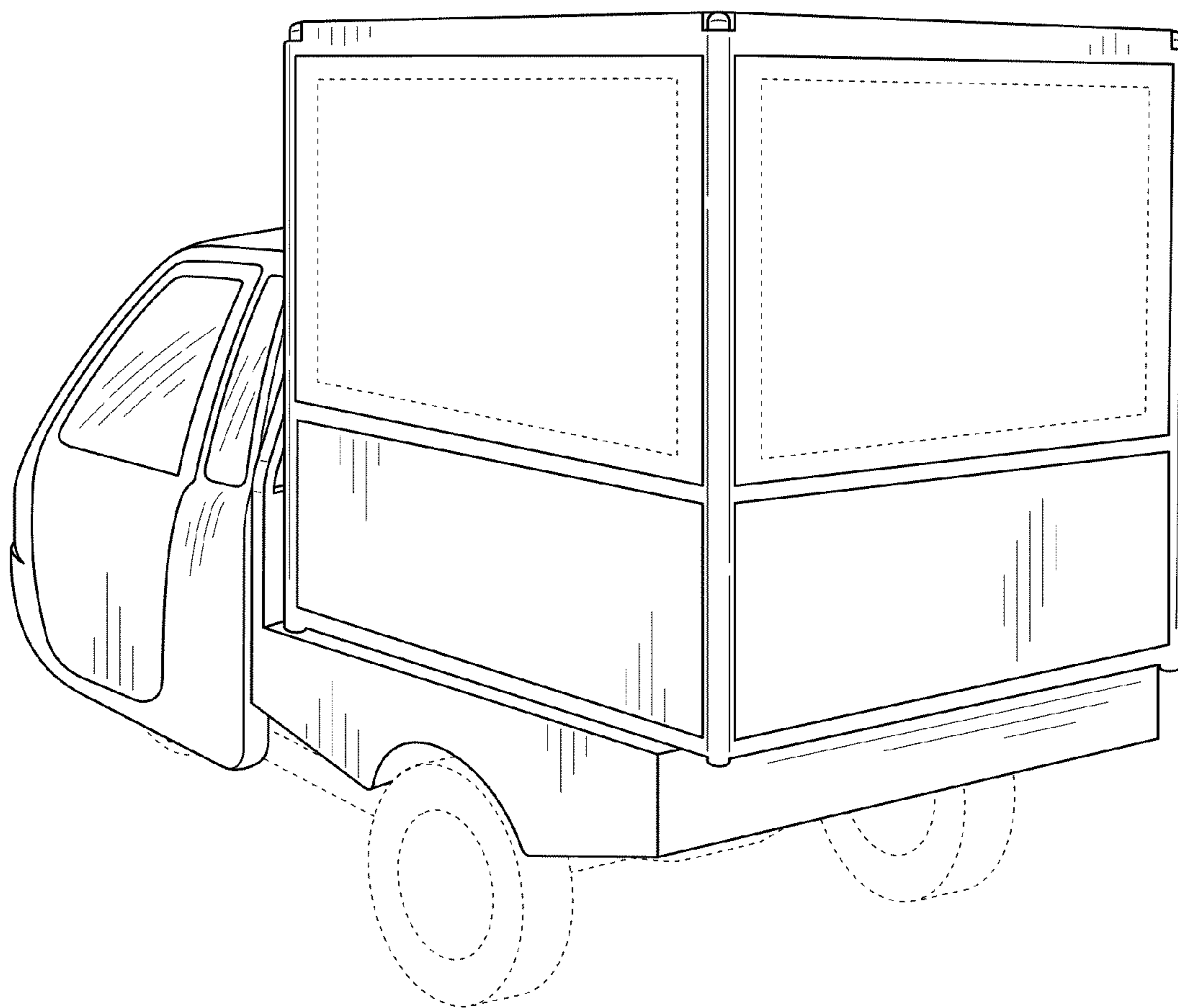

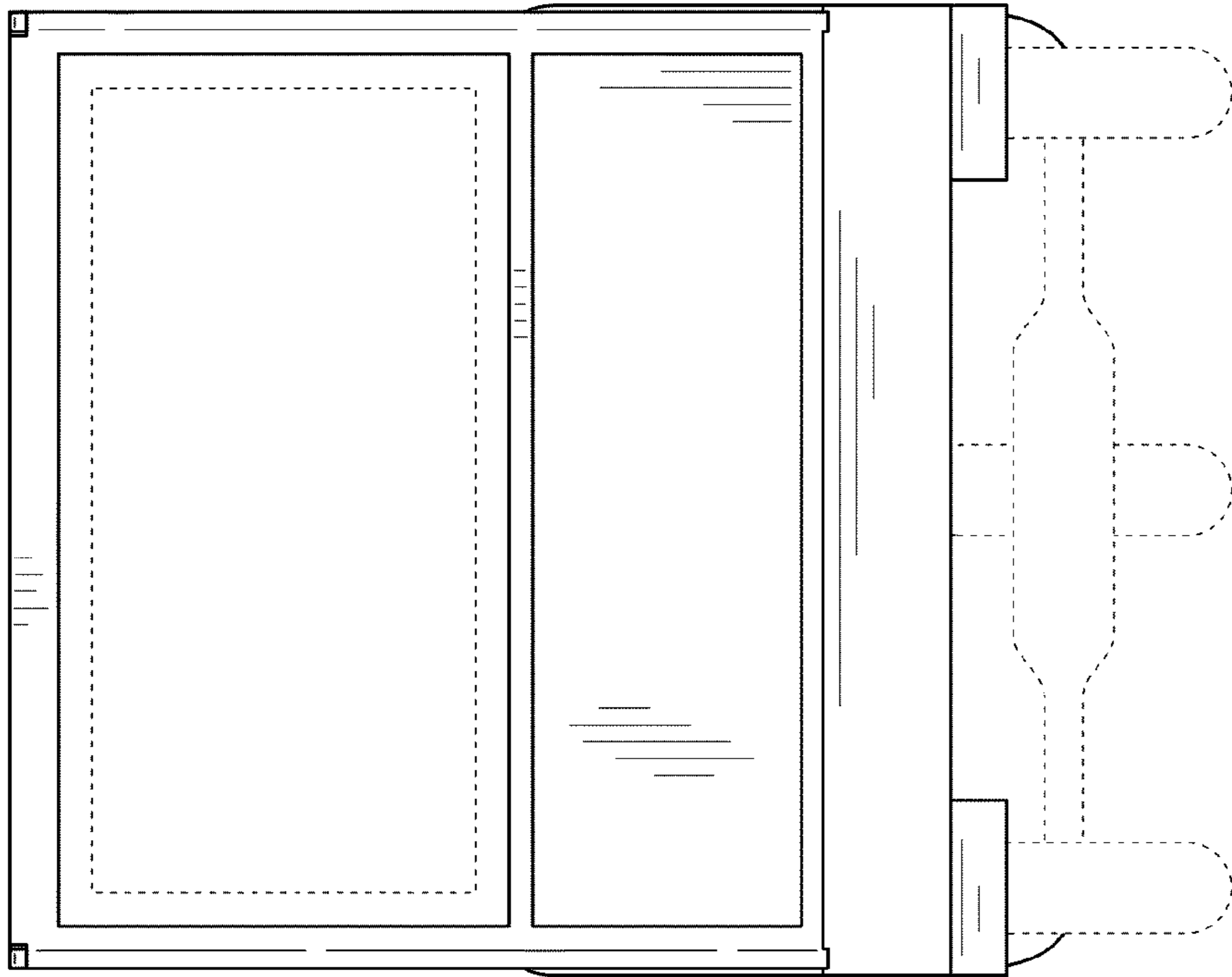

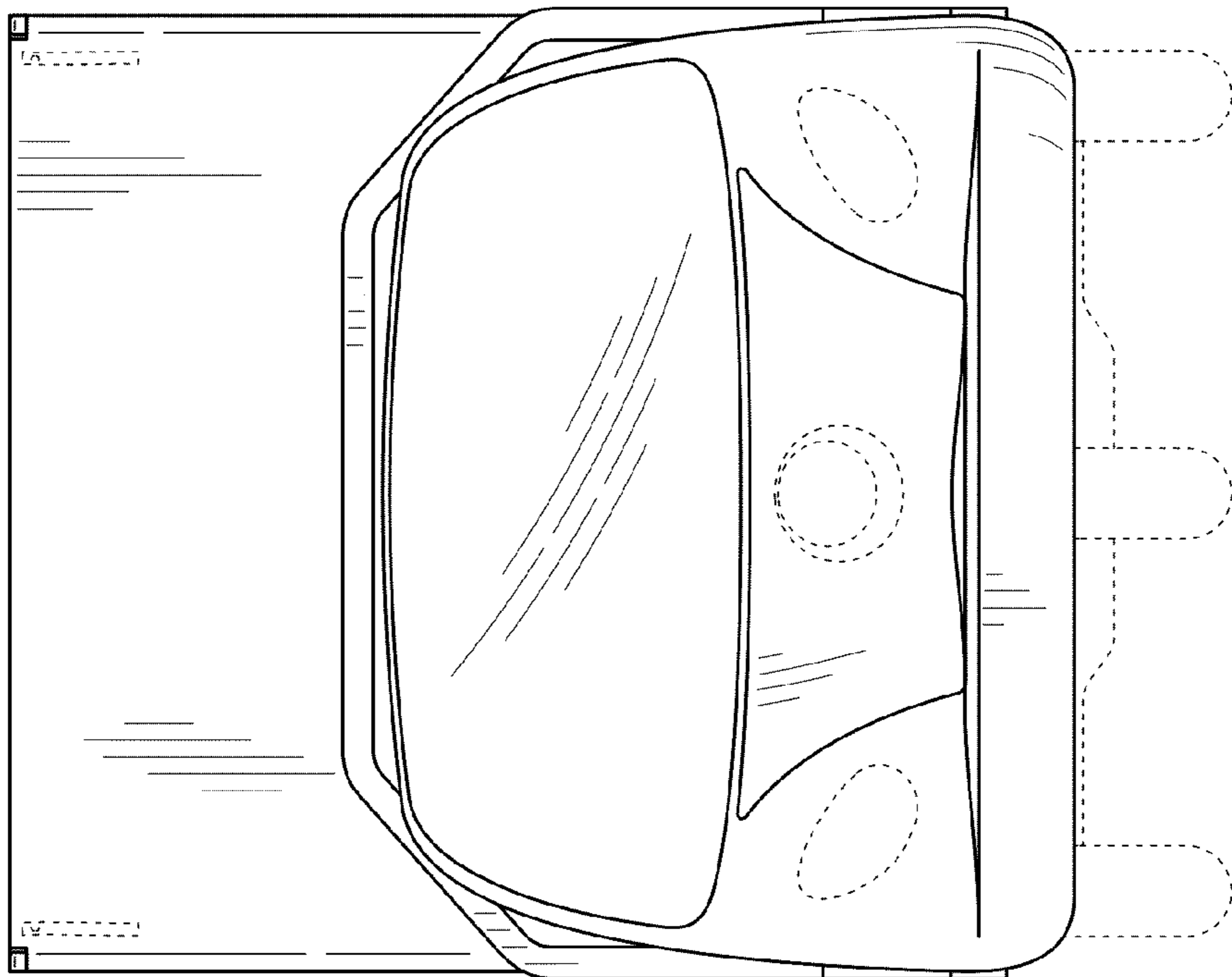

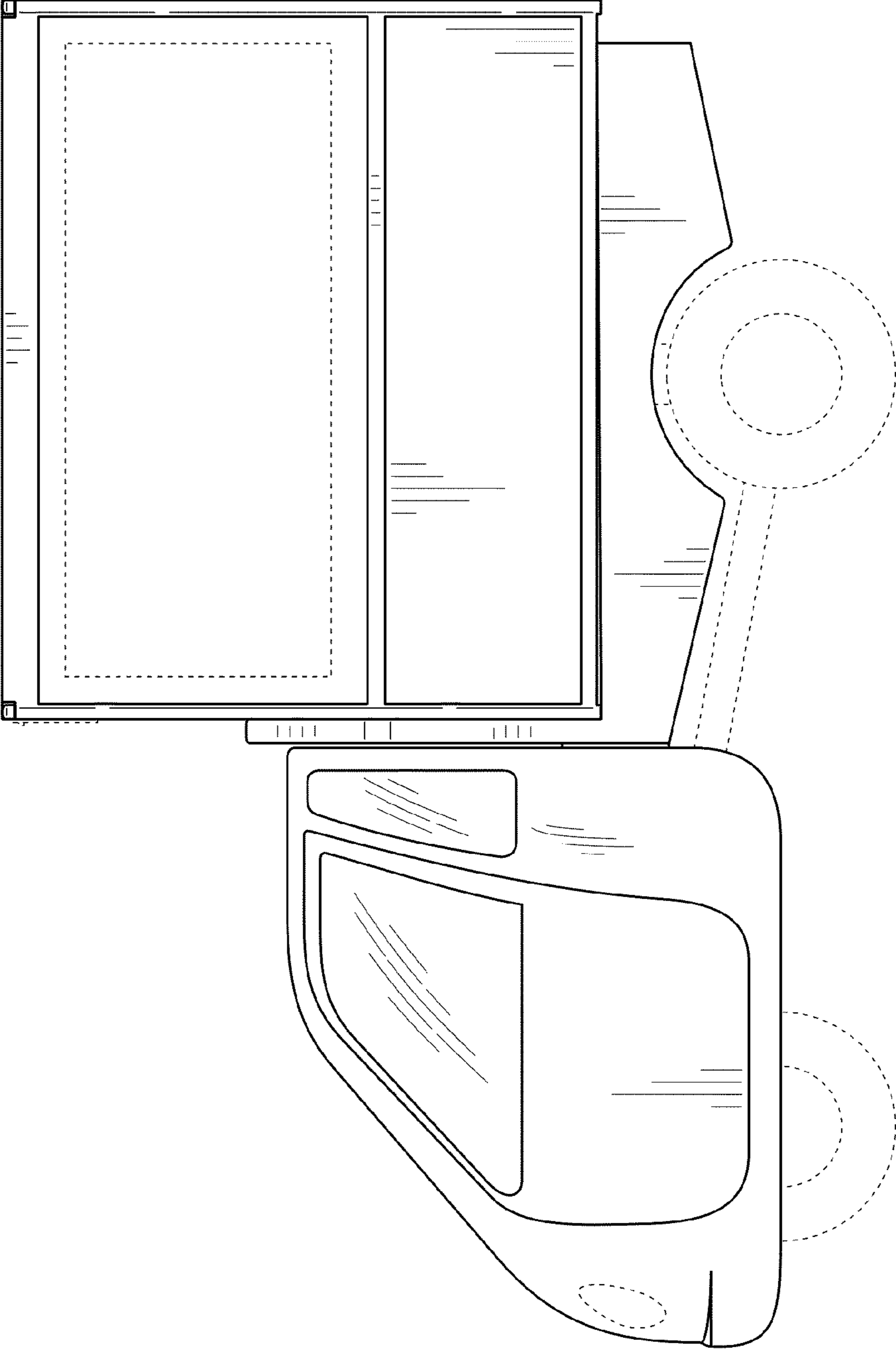

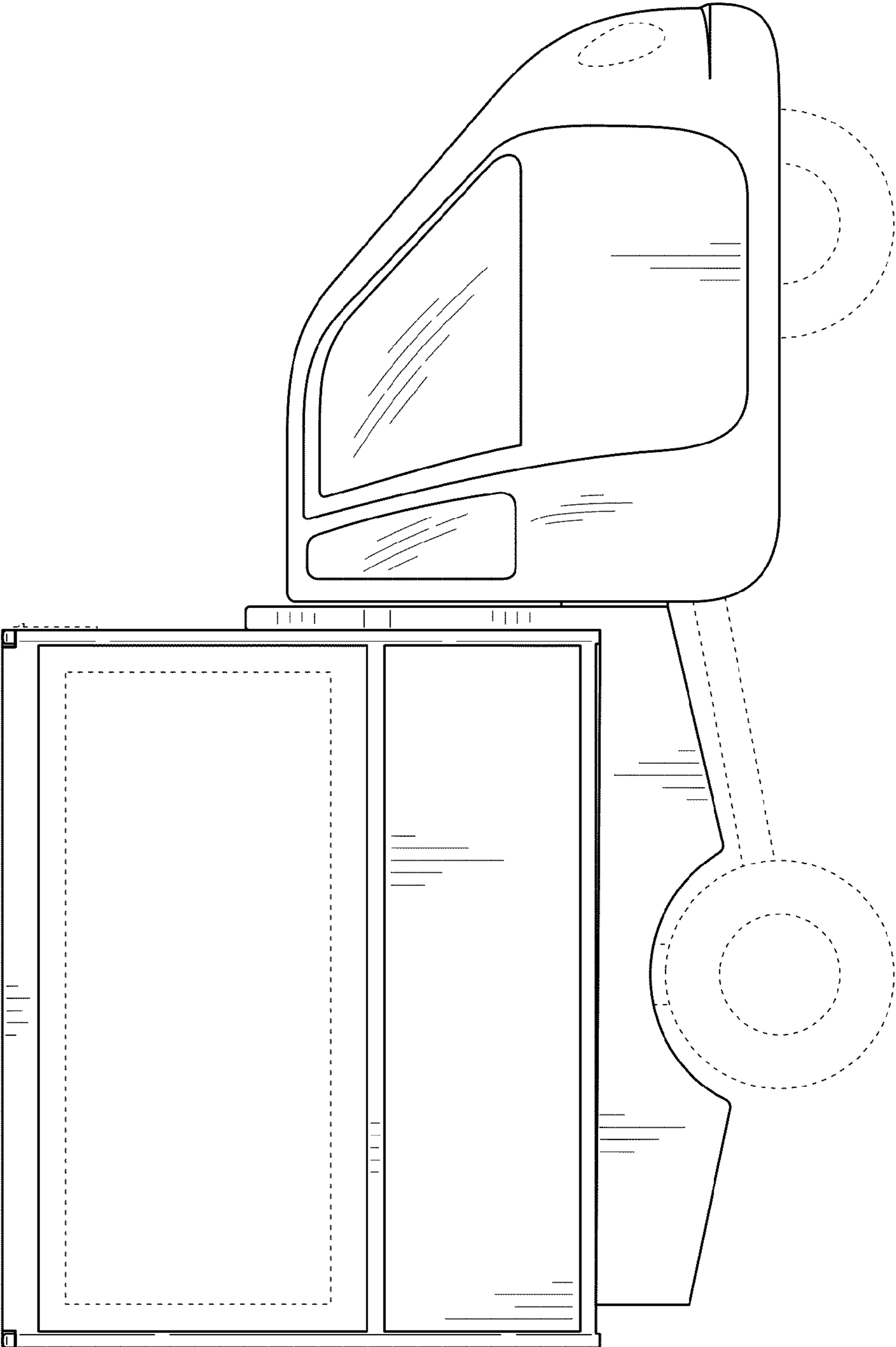

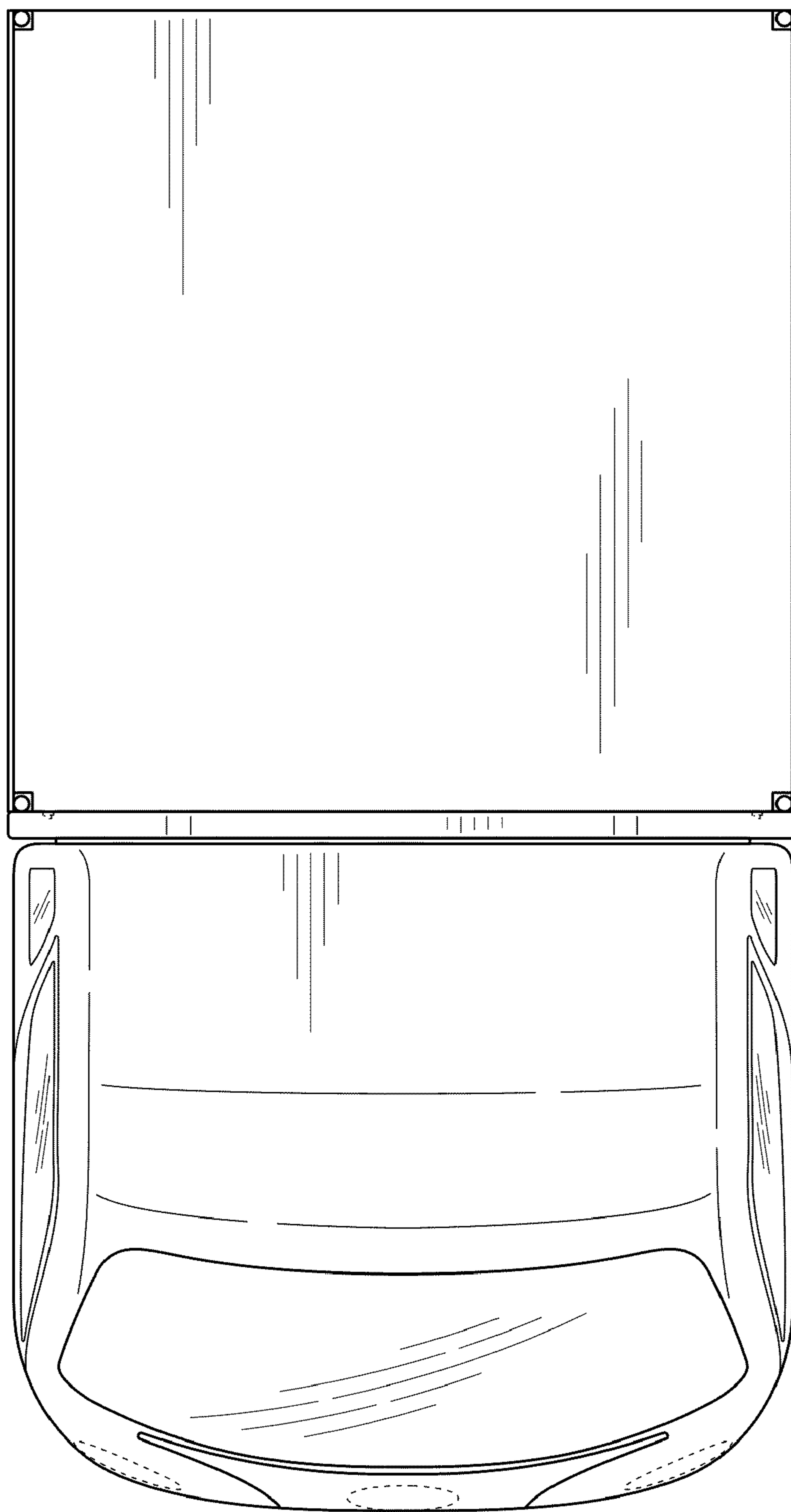

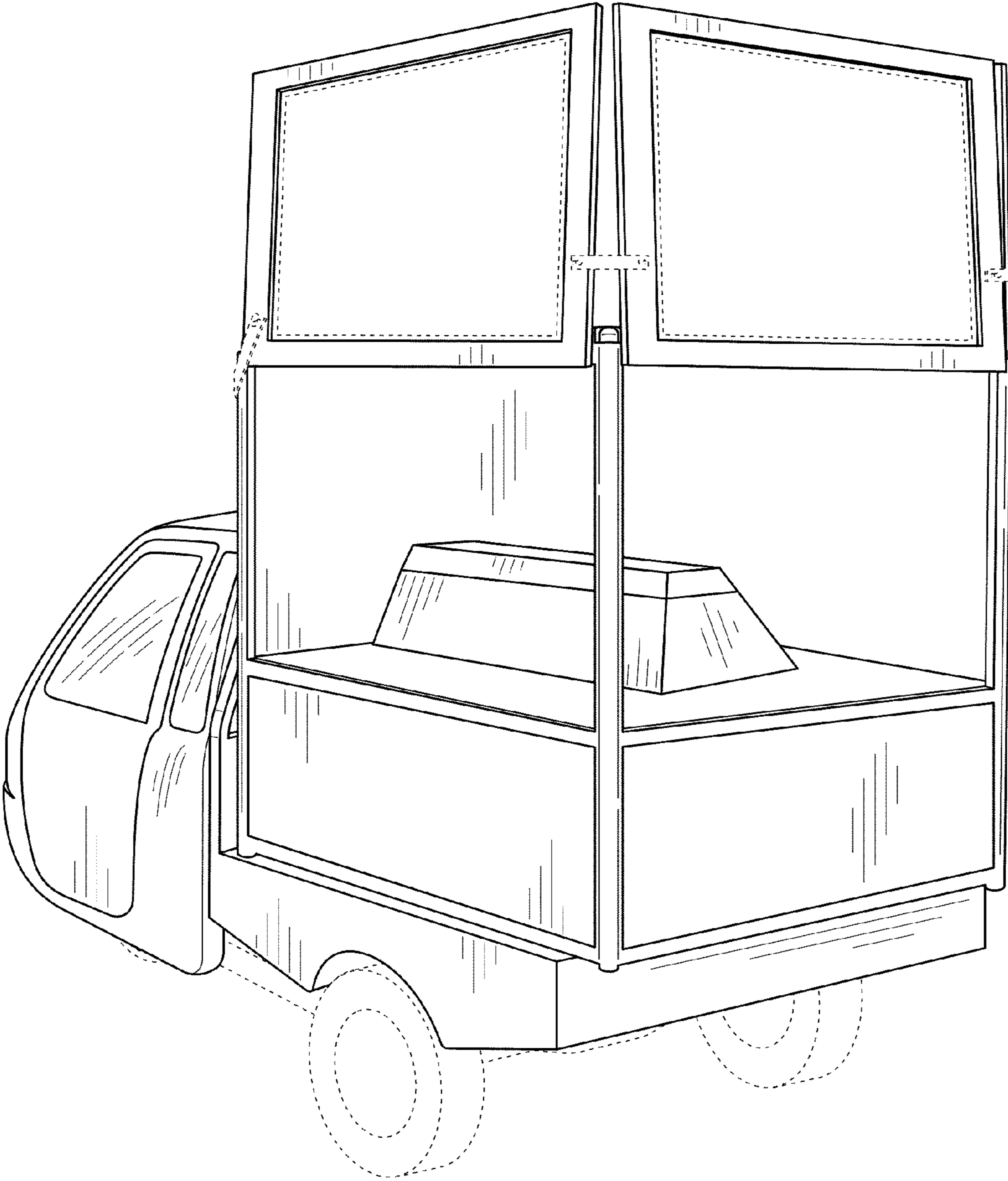
