DESCRIPTION

FIG. 1 is a perspective view of the plug;

FIG. 6 is a rear view thereof;
FIG. 7 is a bottom view thereof;

FIG. 9 is a sectional view thereof, but shown with environ-
ment in broken lines.
The environment and portions of the plug shown in broken
lines form no part of the claimed design.

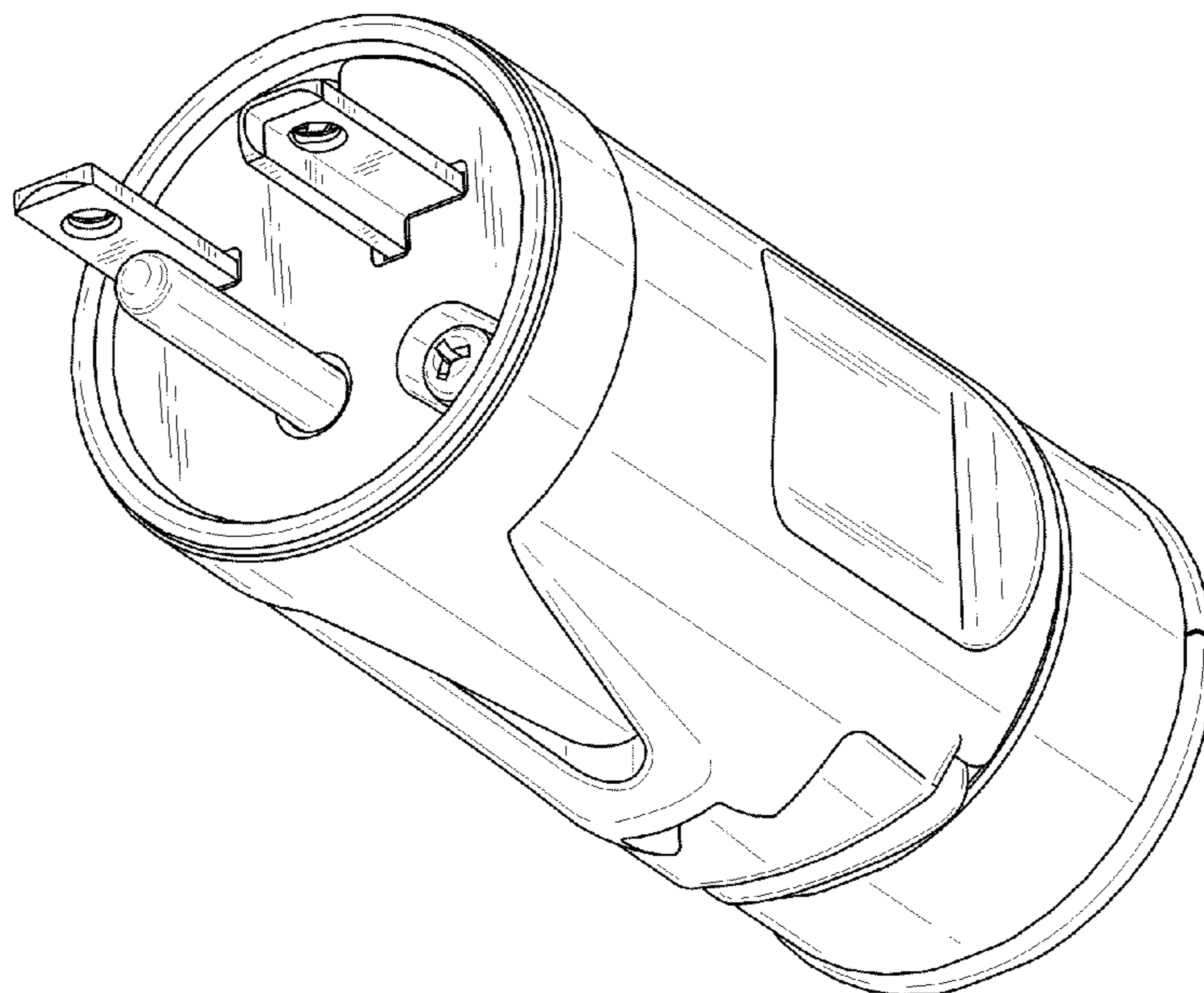

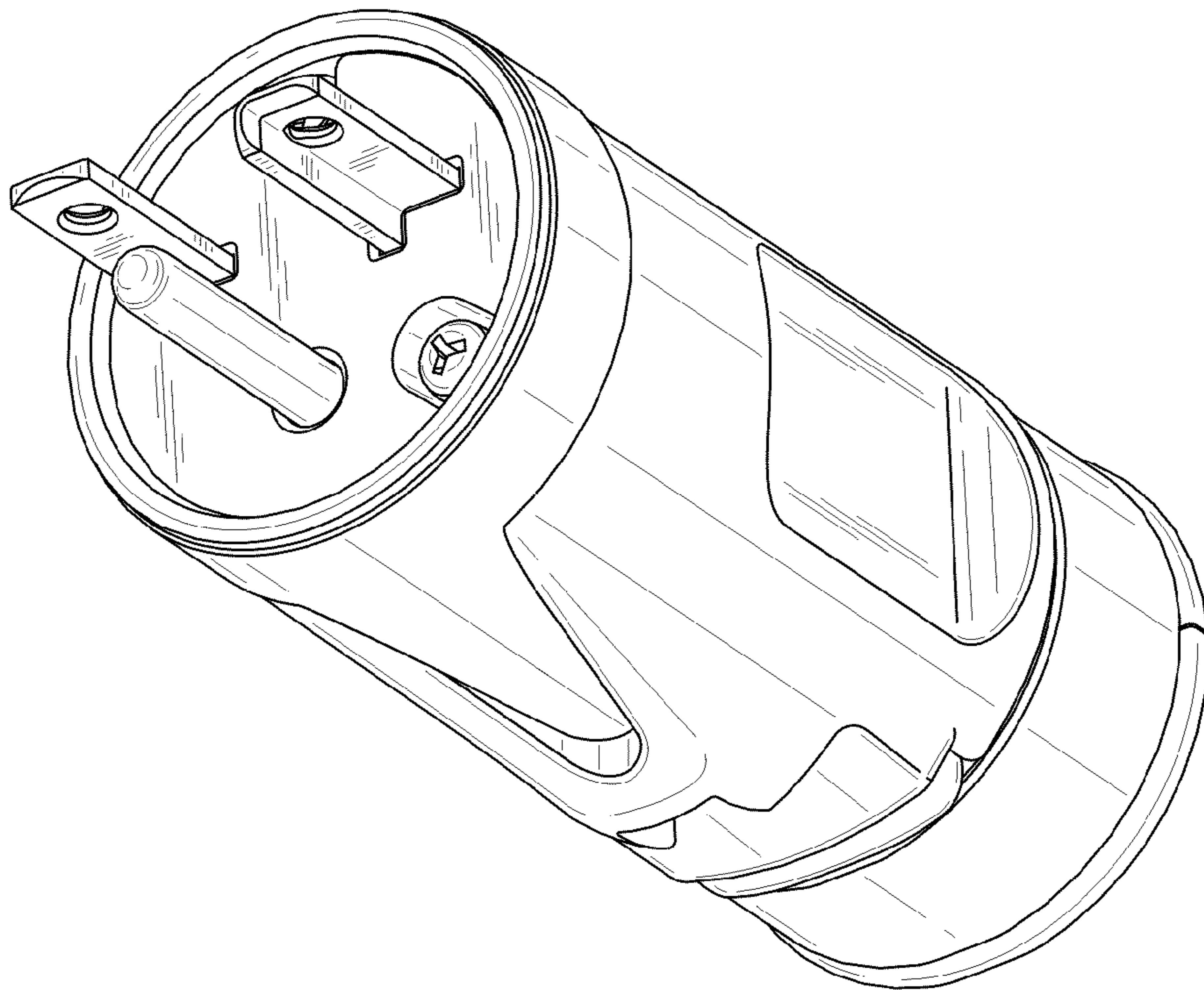

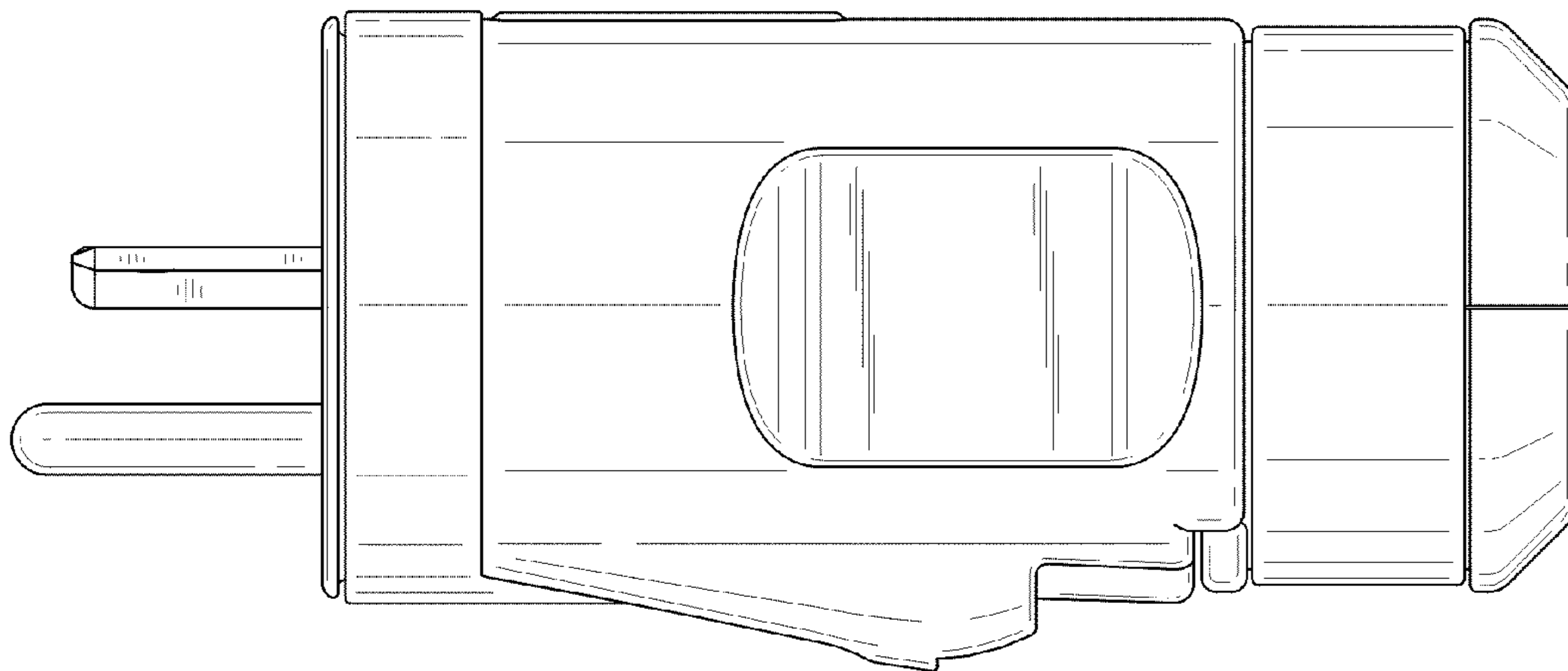

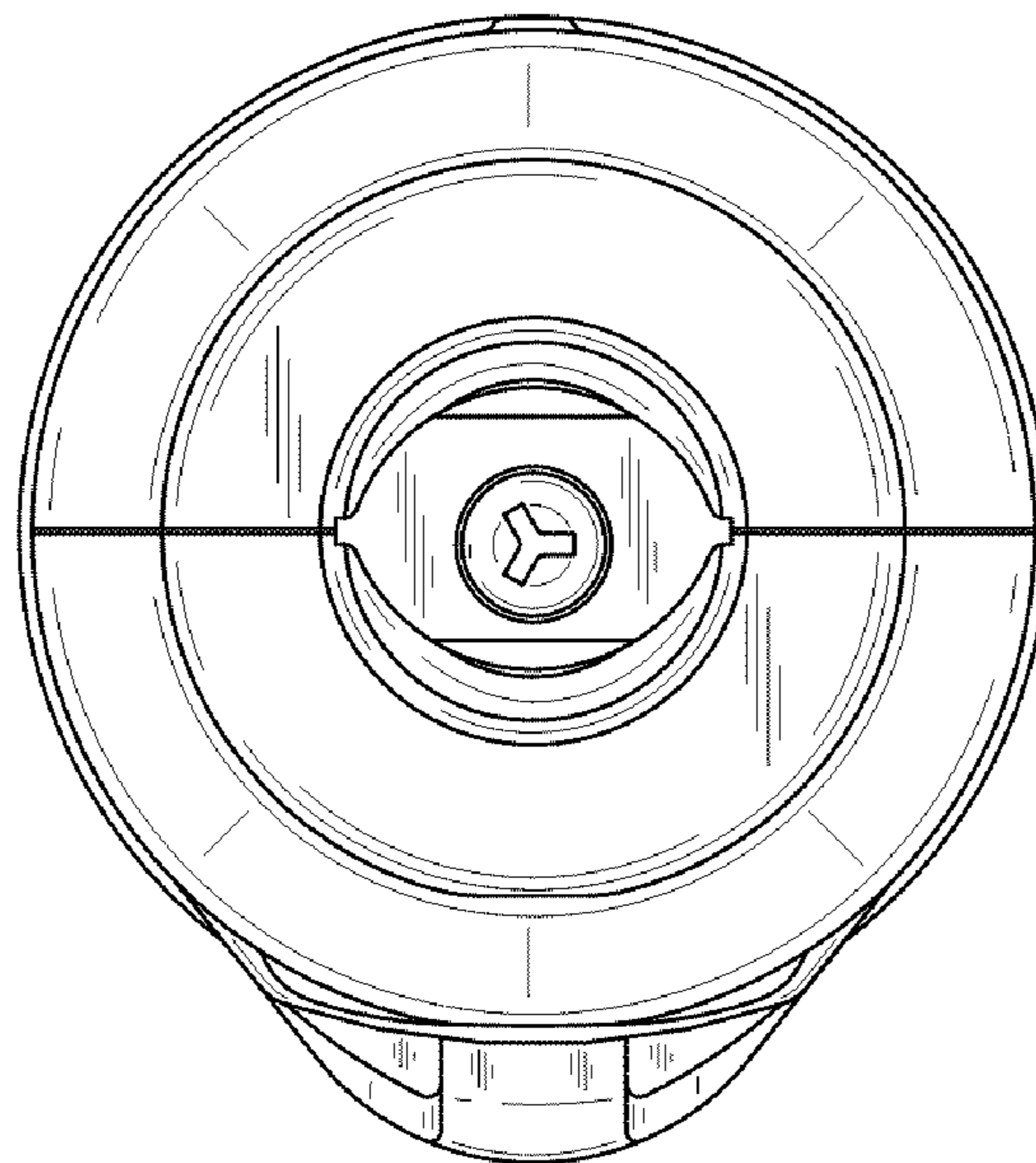

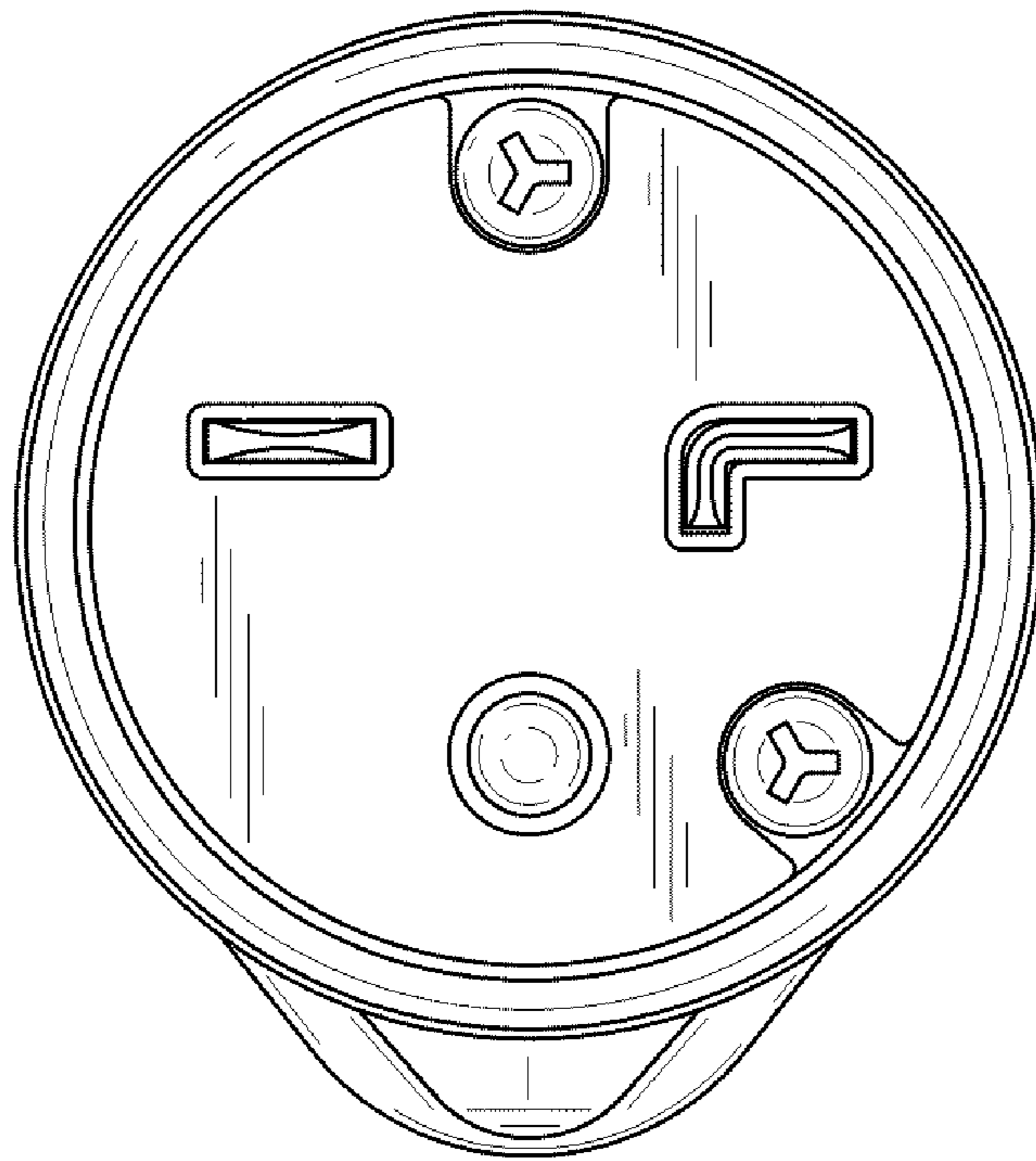

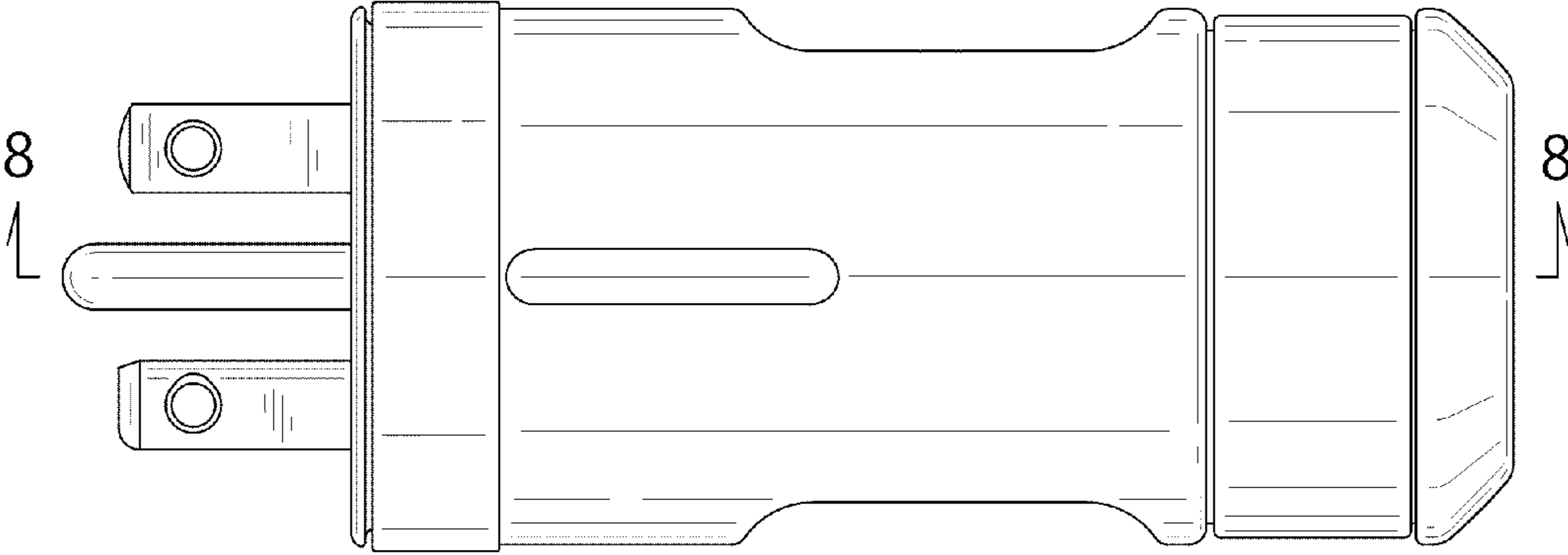

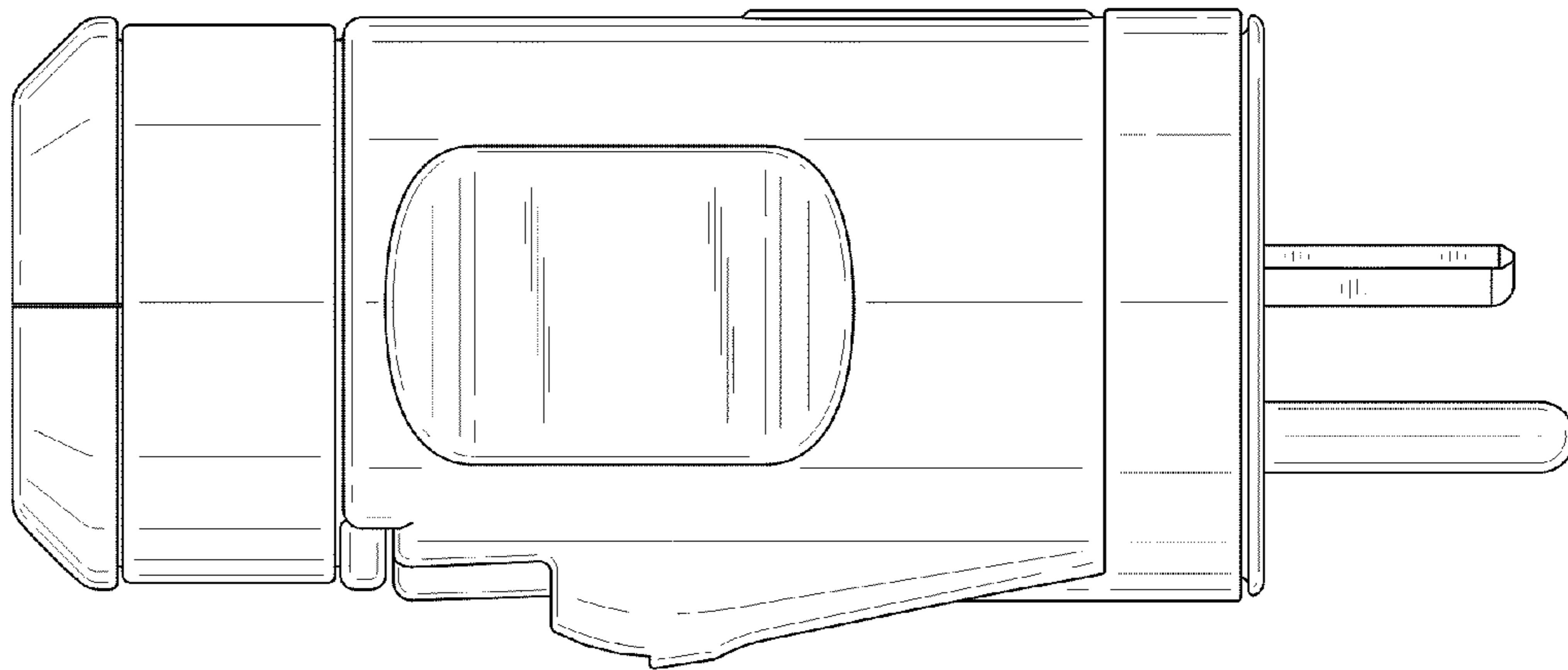

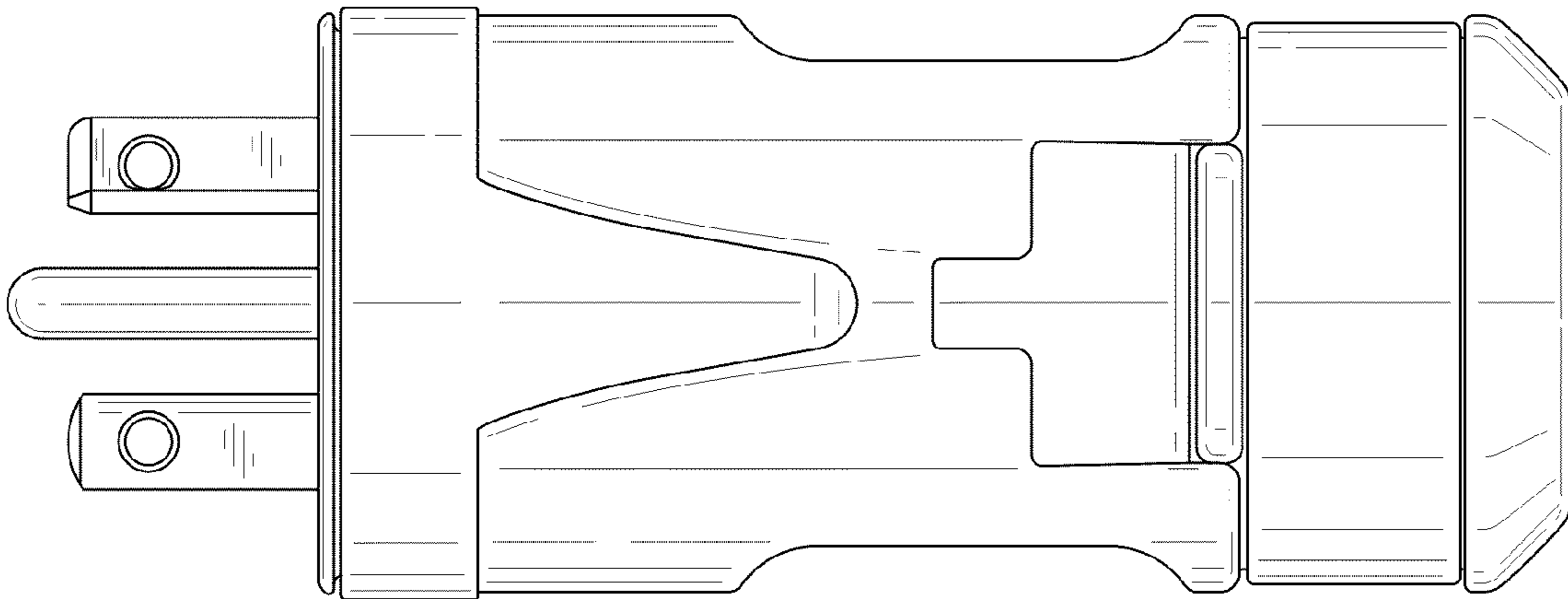

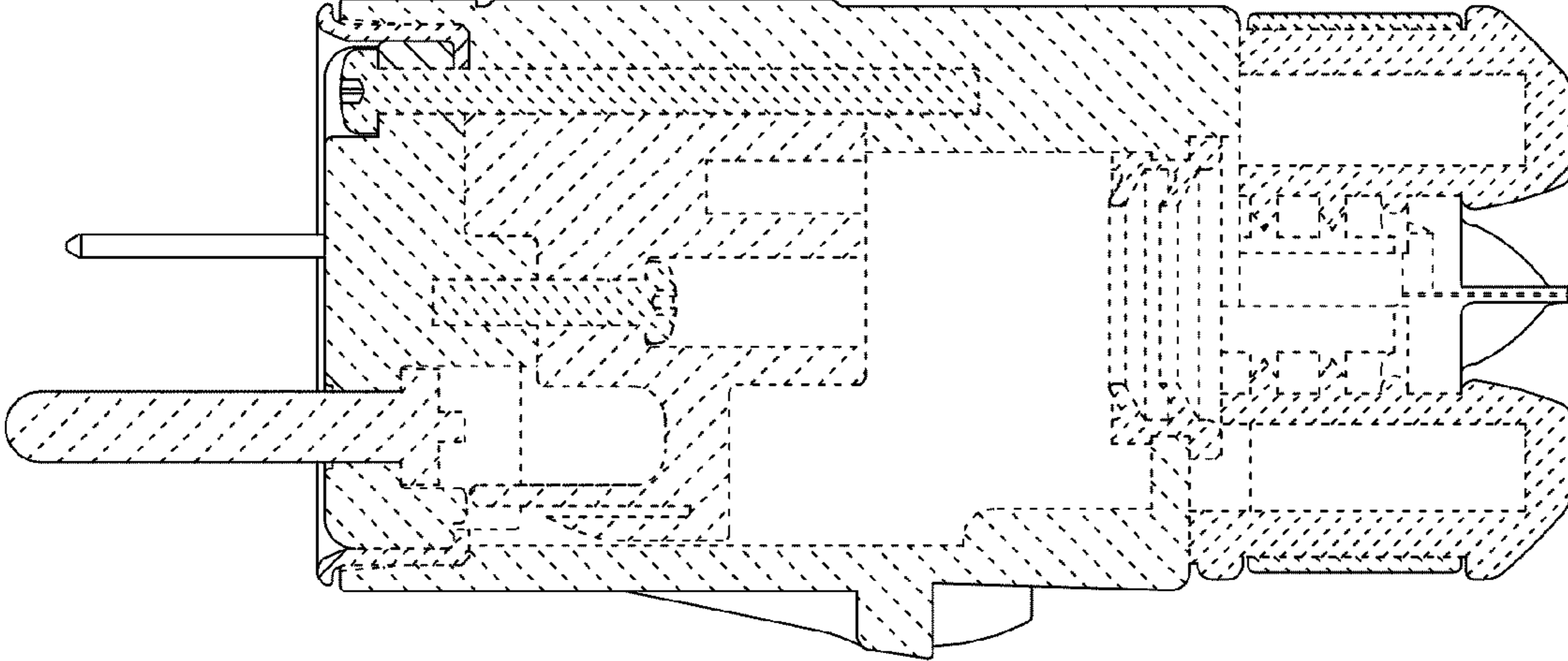
